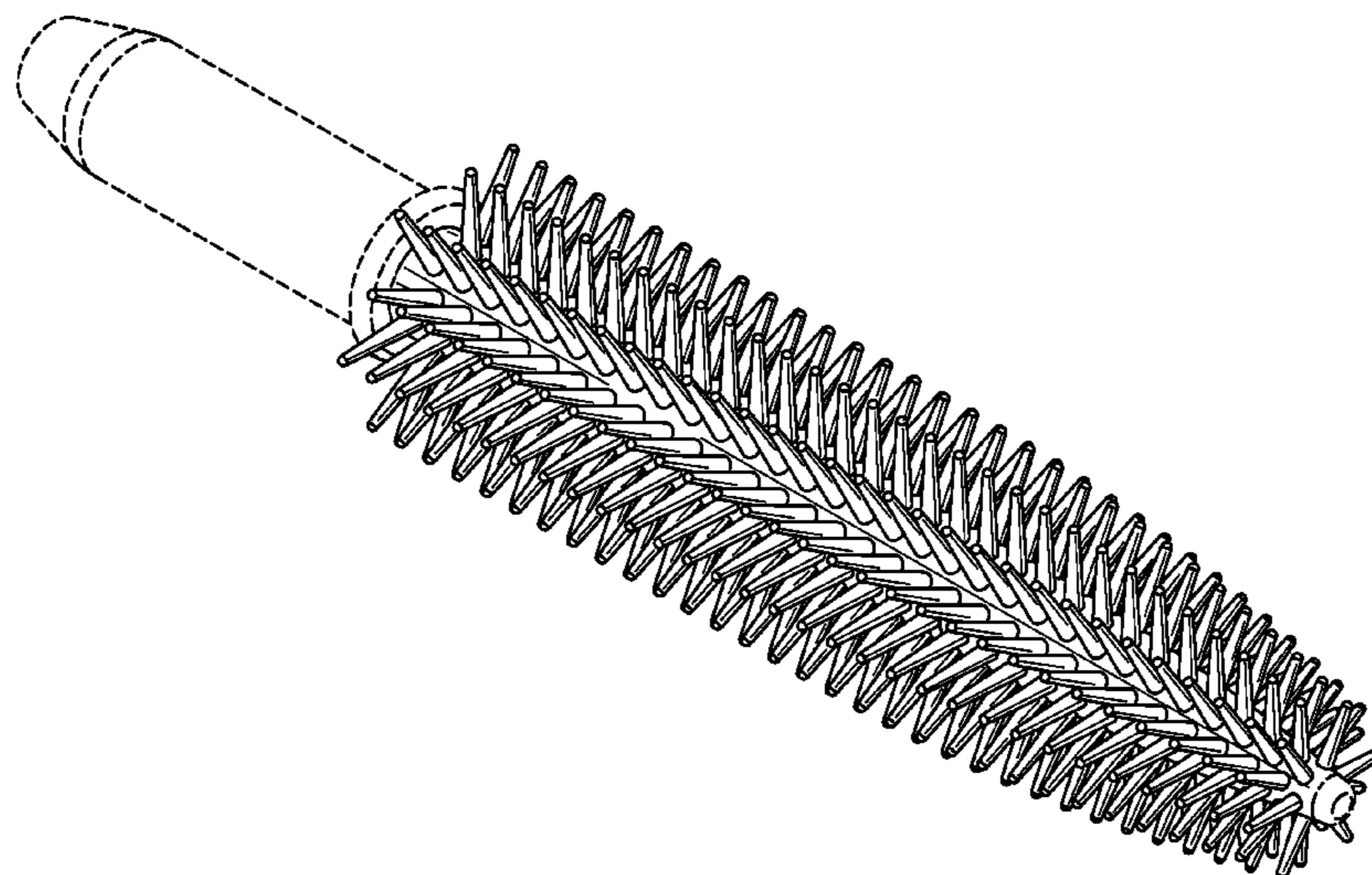
FIG. 1 is an isometric view of a mascara brush, showing my new design;

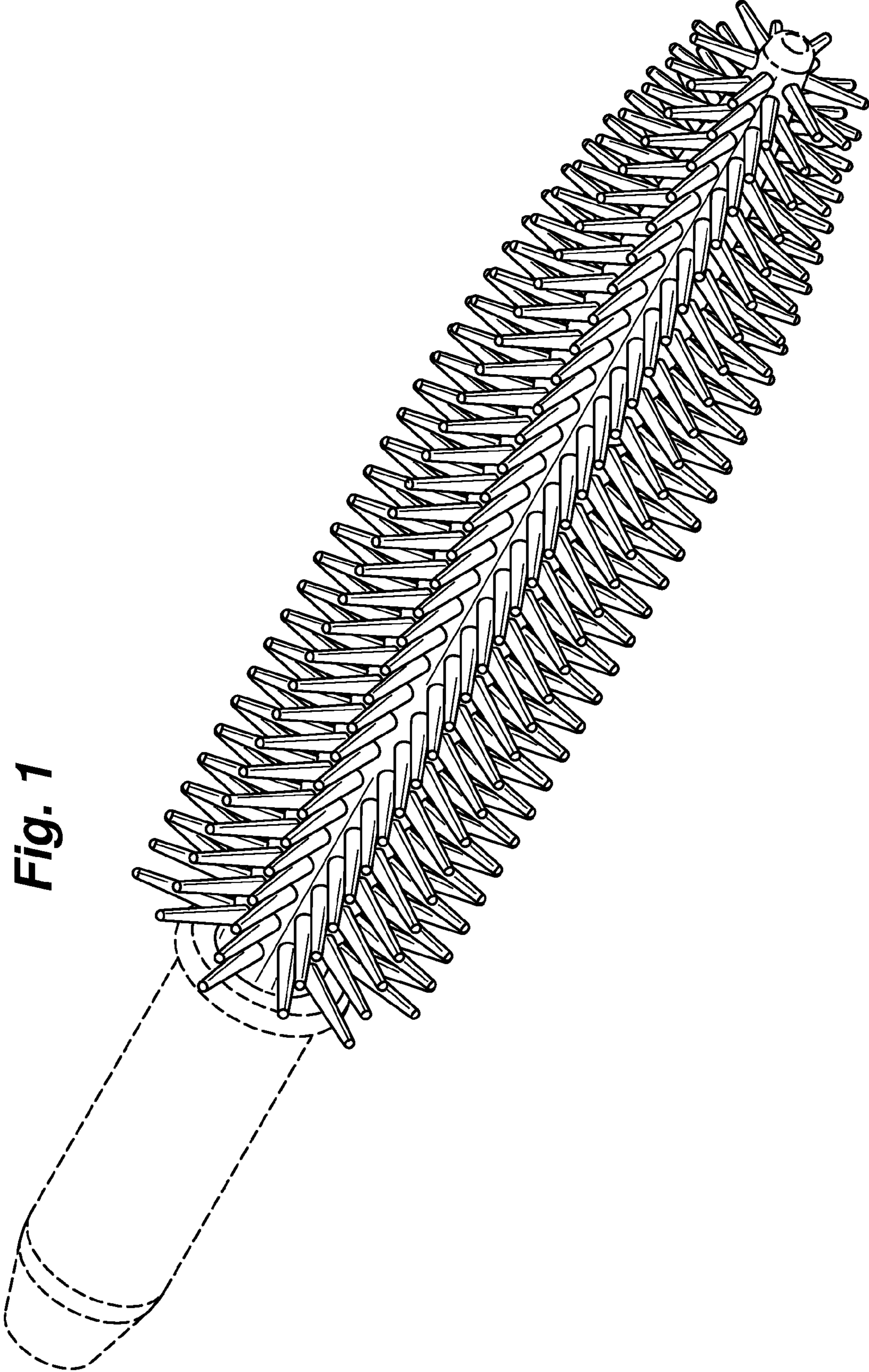

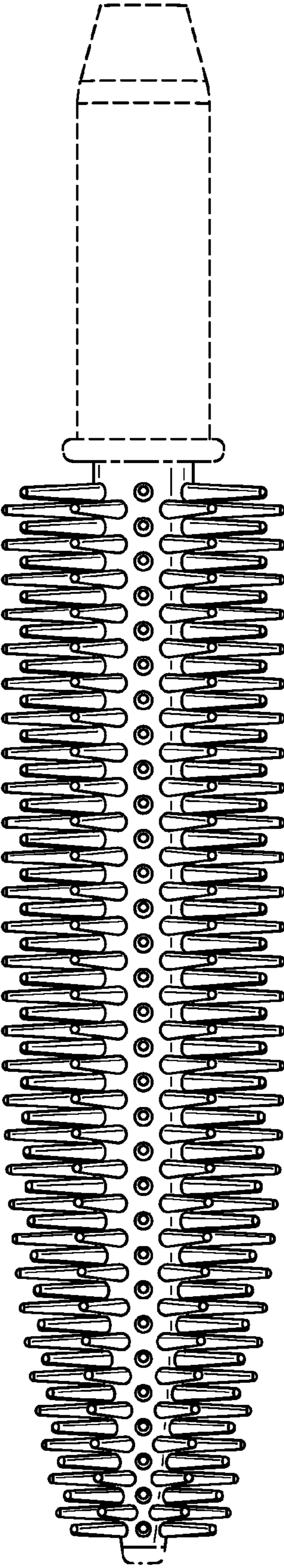

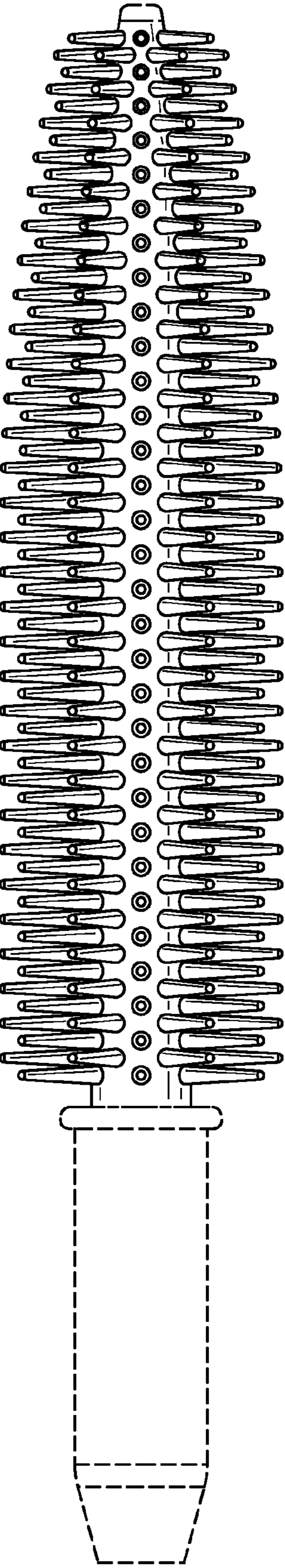

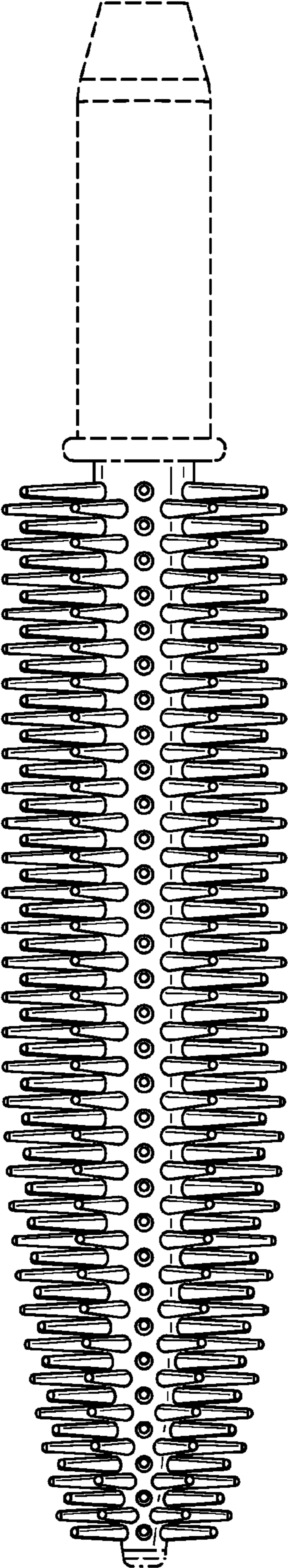

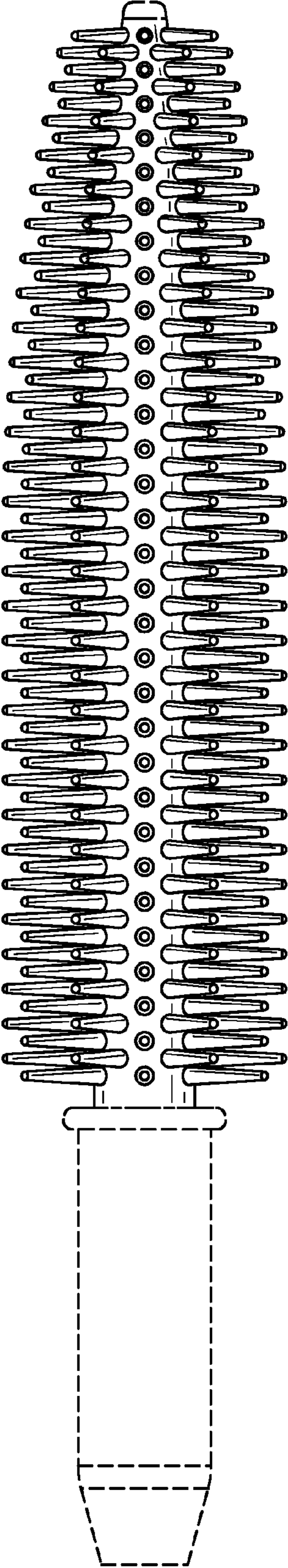

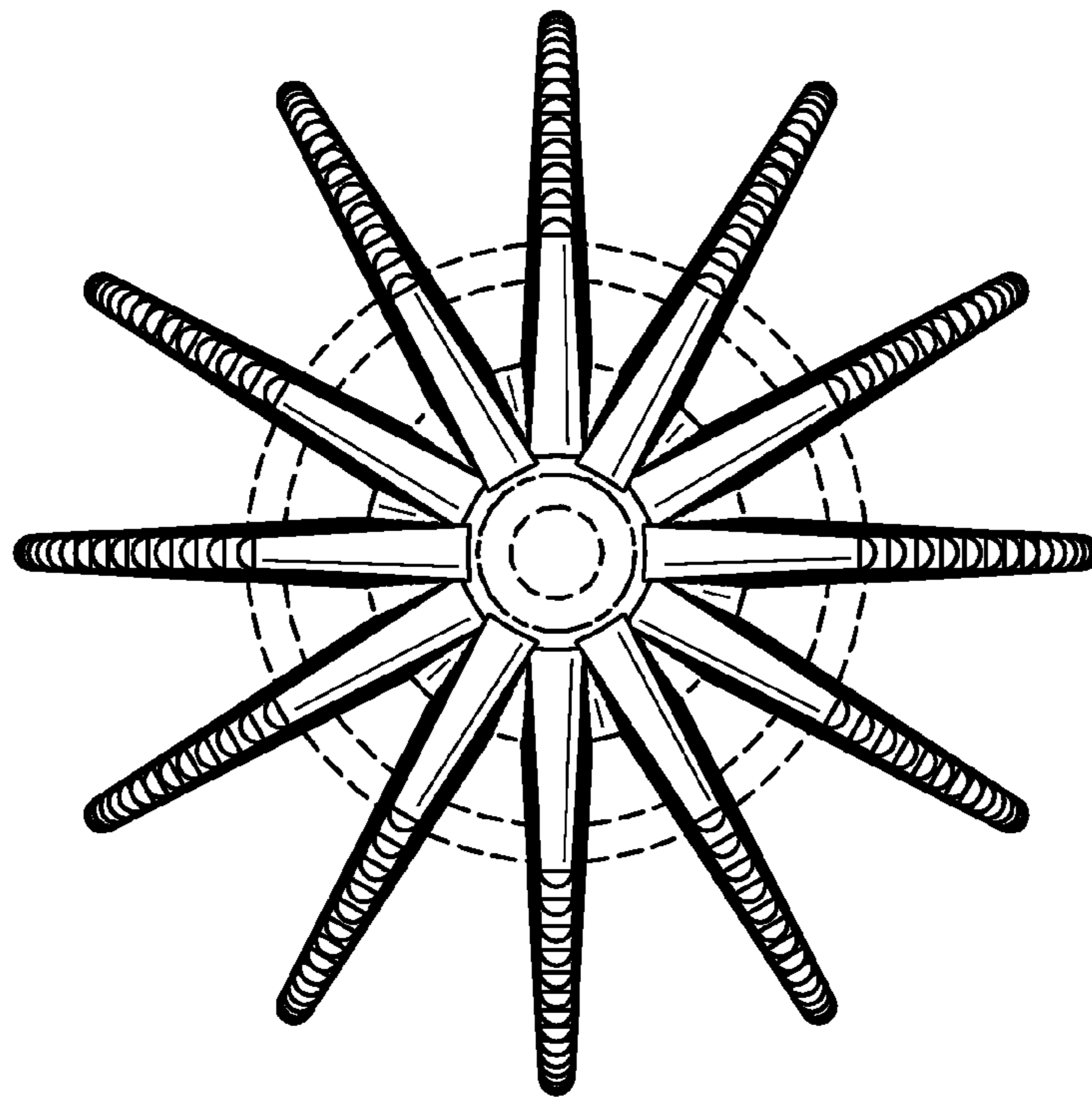
