FIG. 9 is a side elevational view thereof;

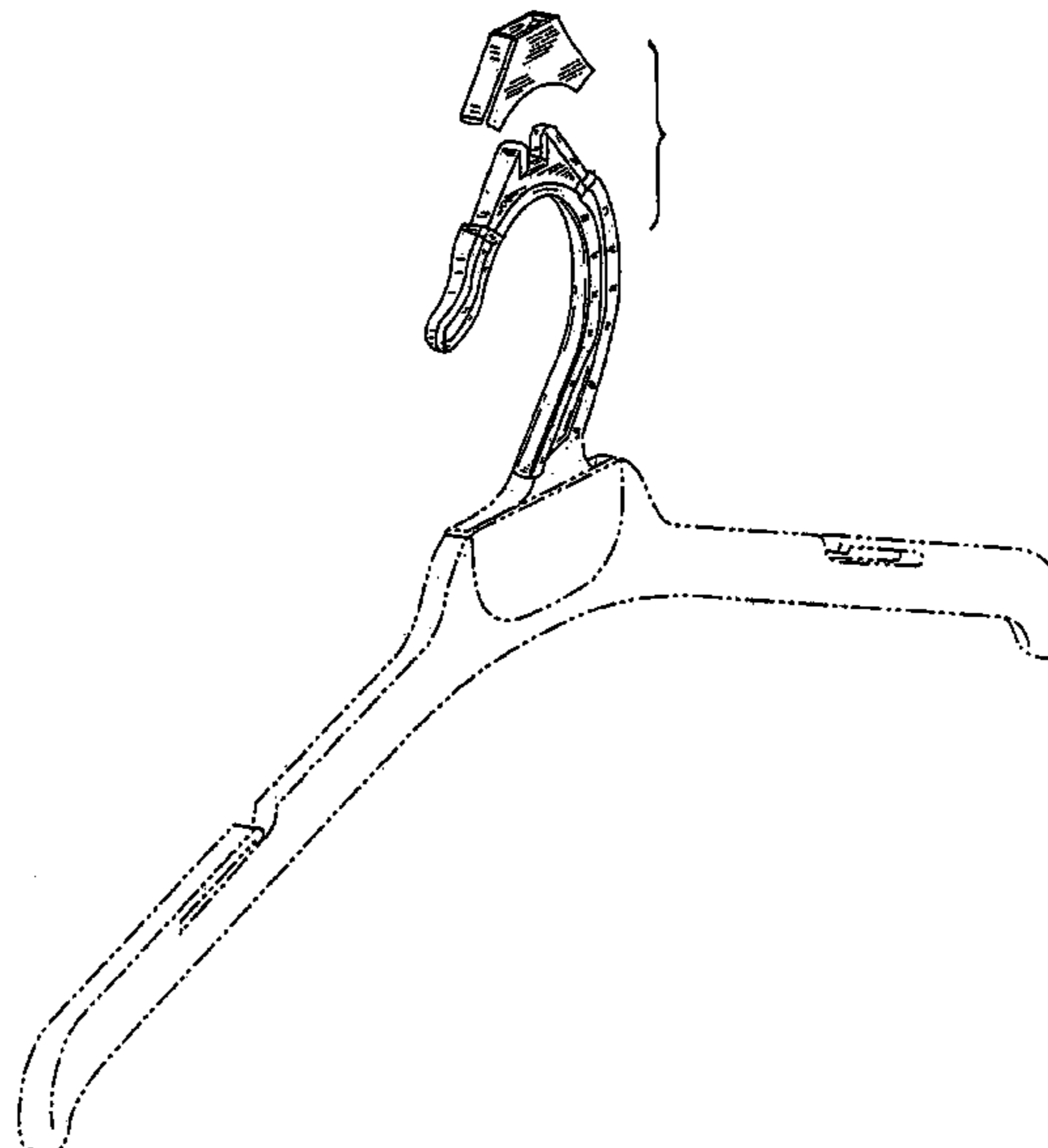
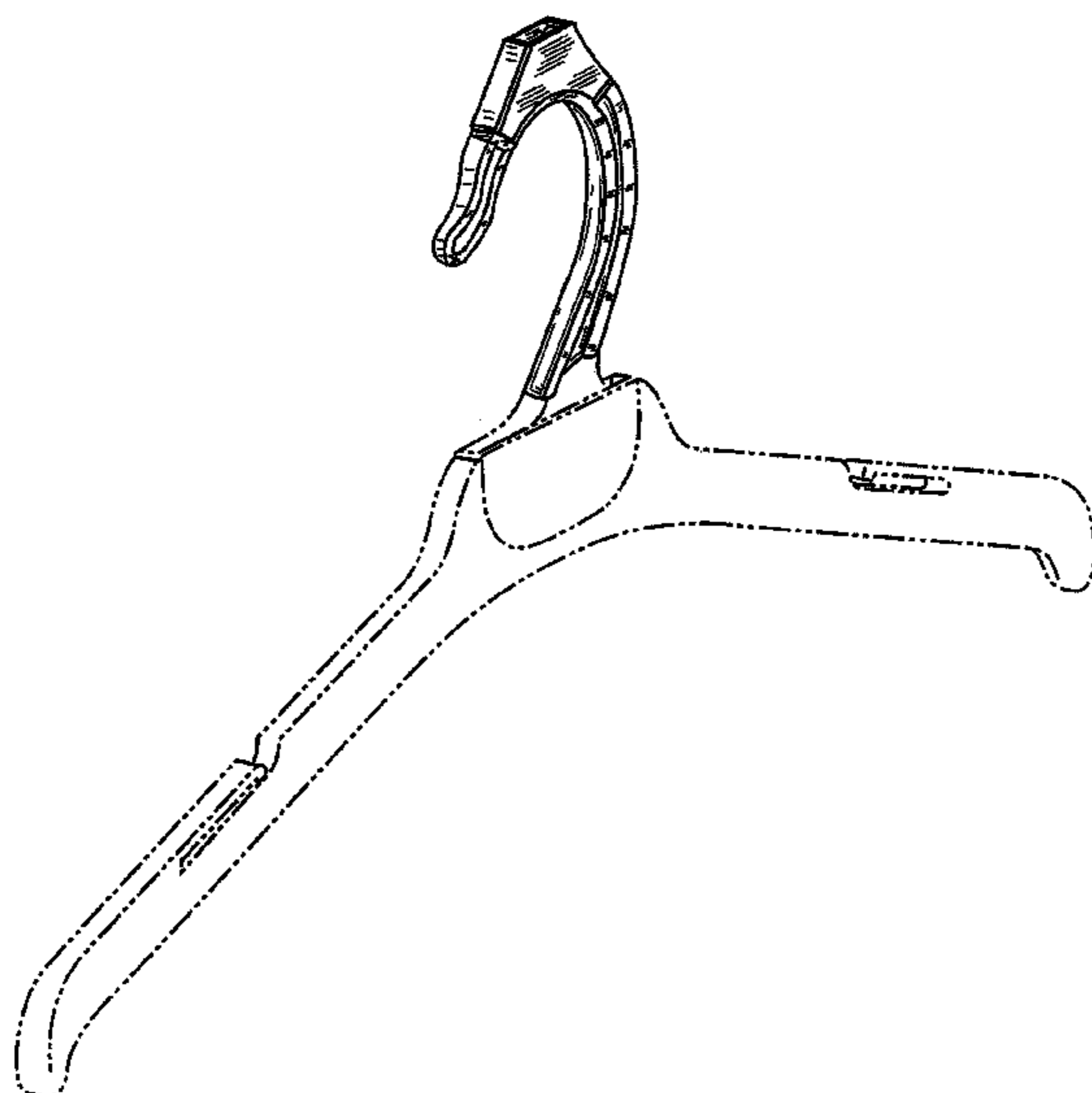
FIG. 10 is a top plan view thereof;

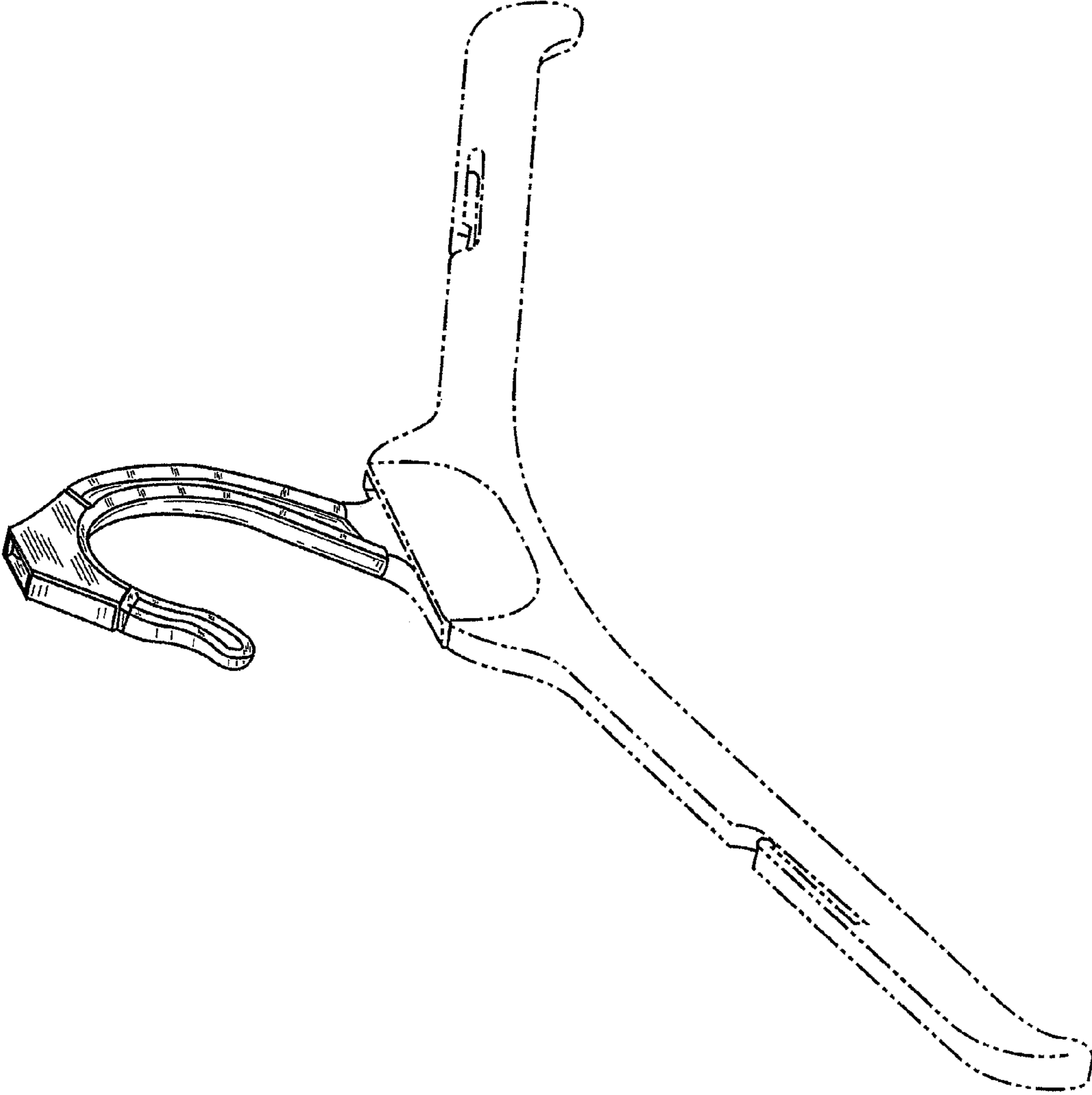

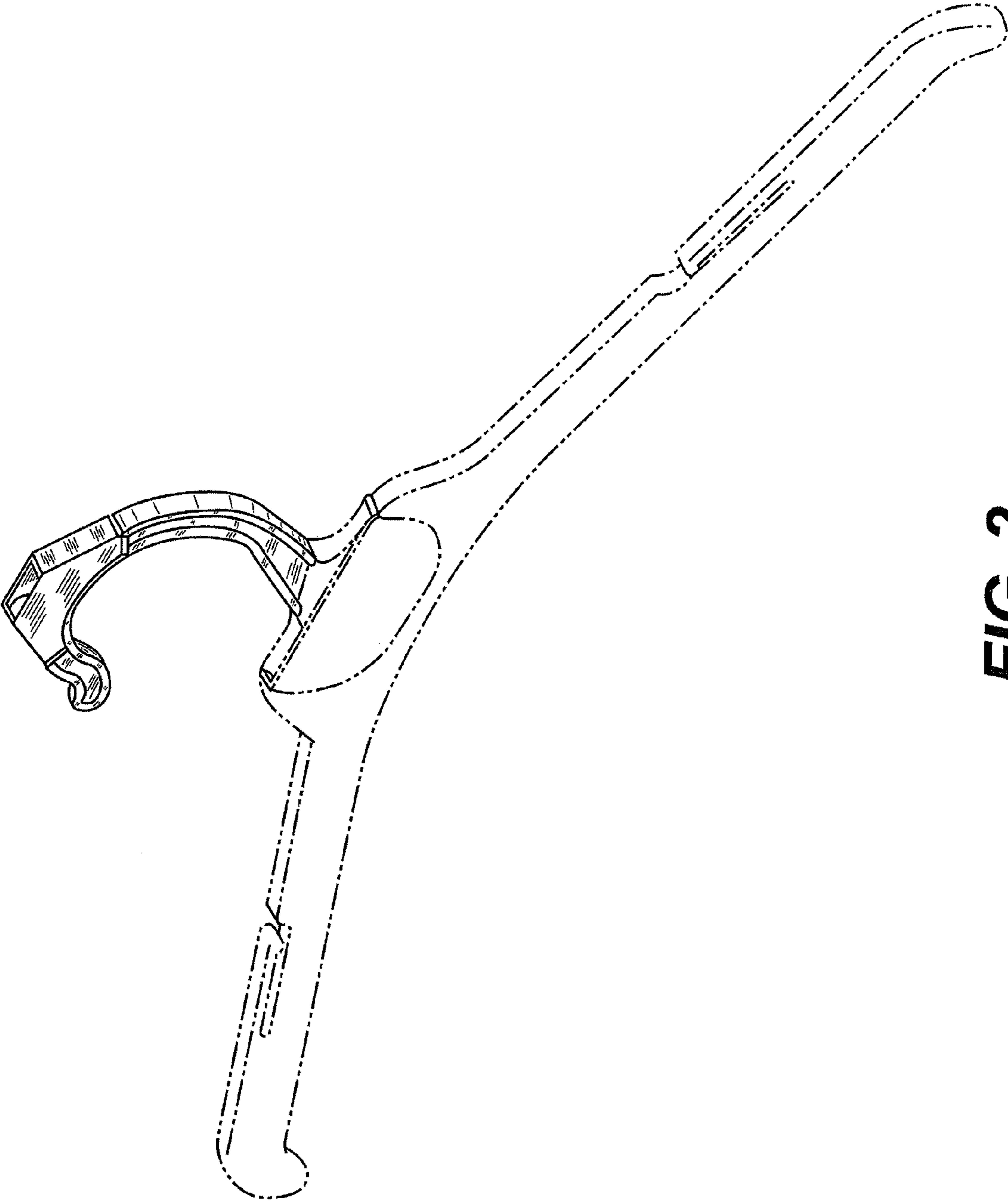

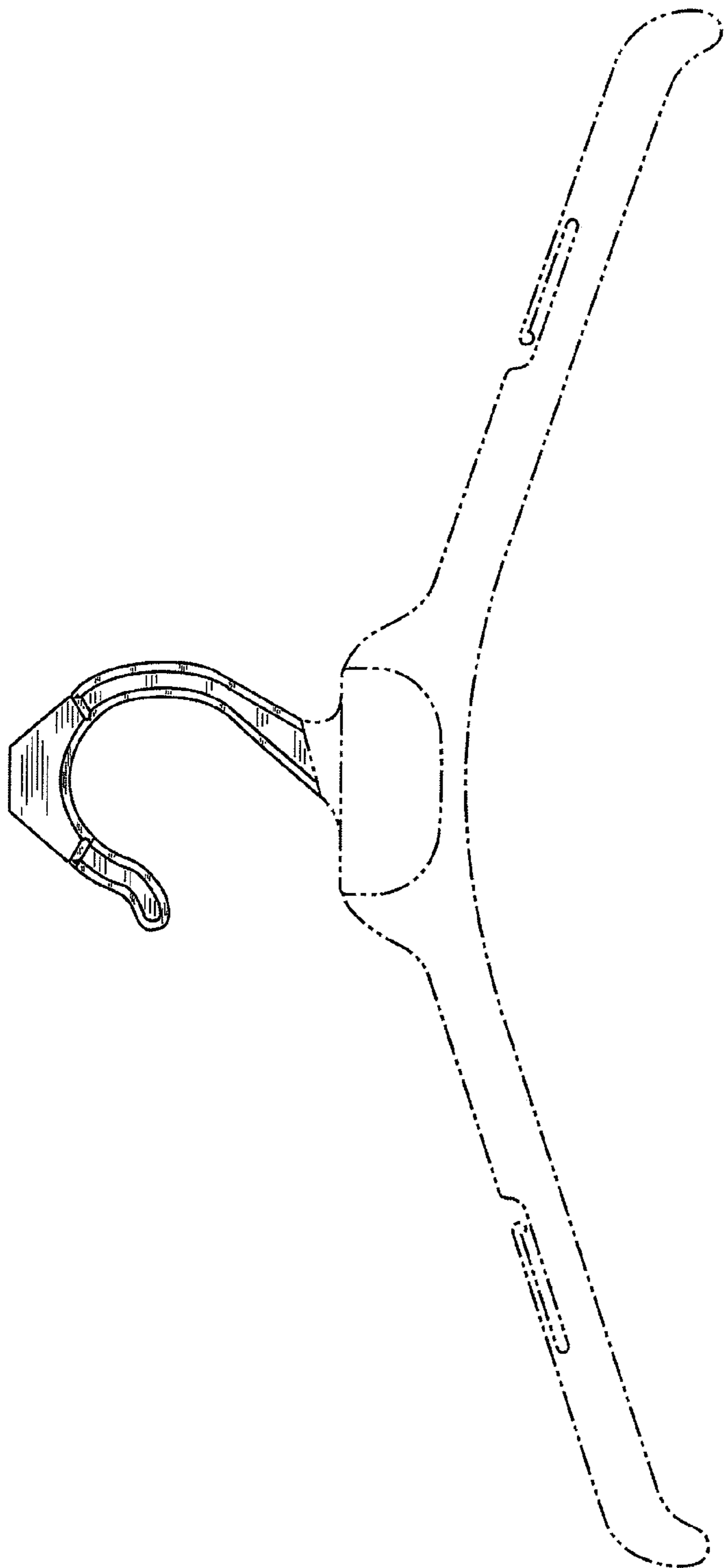

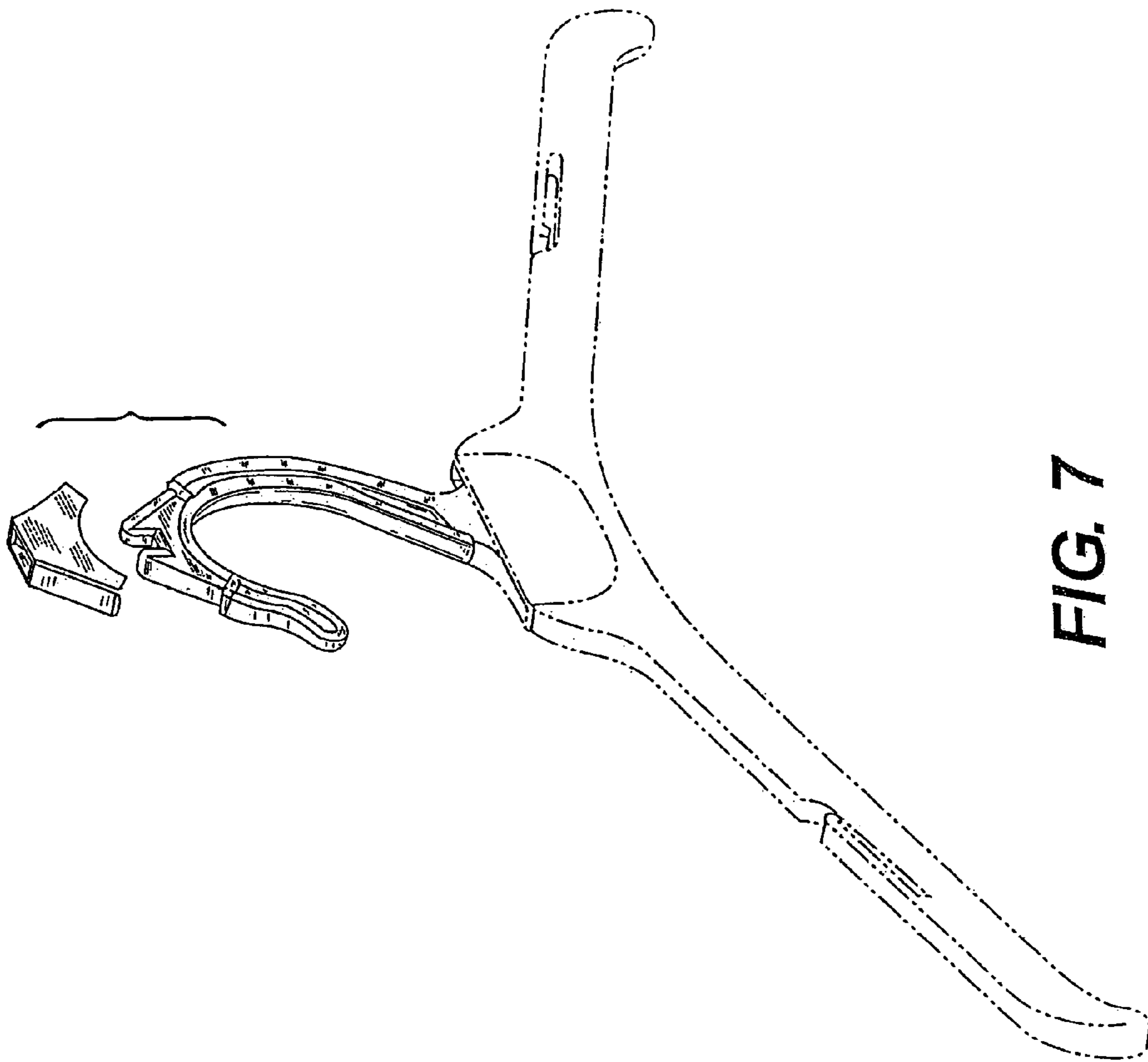

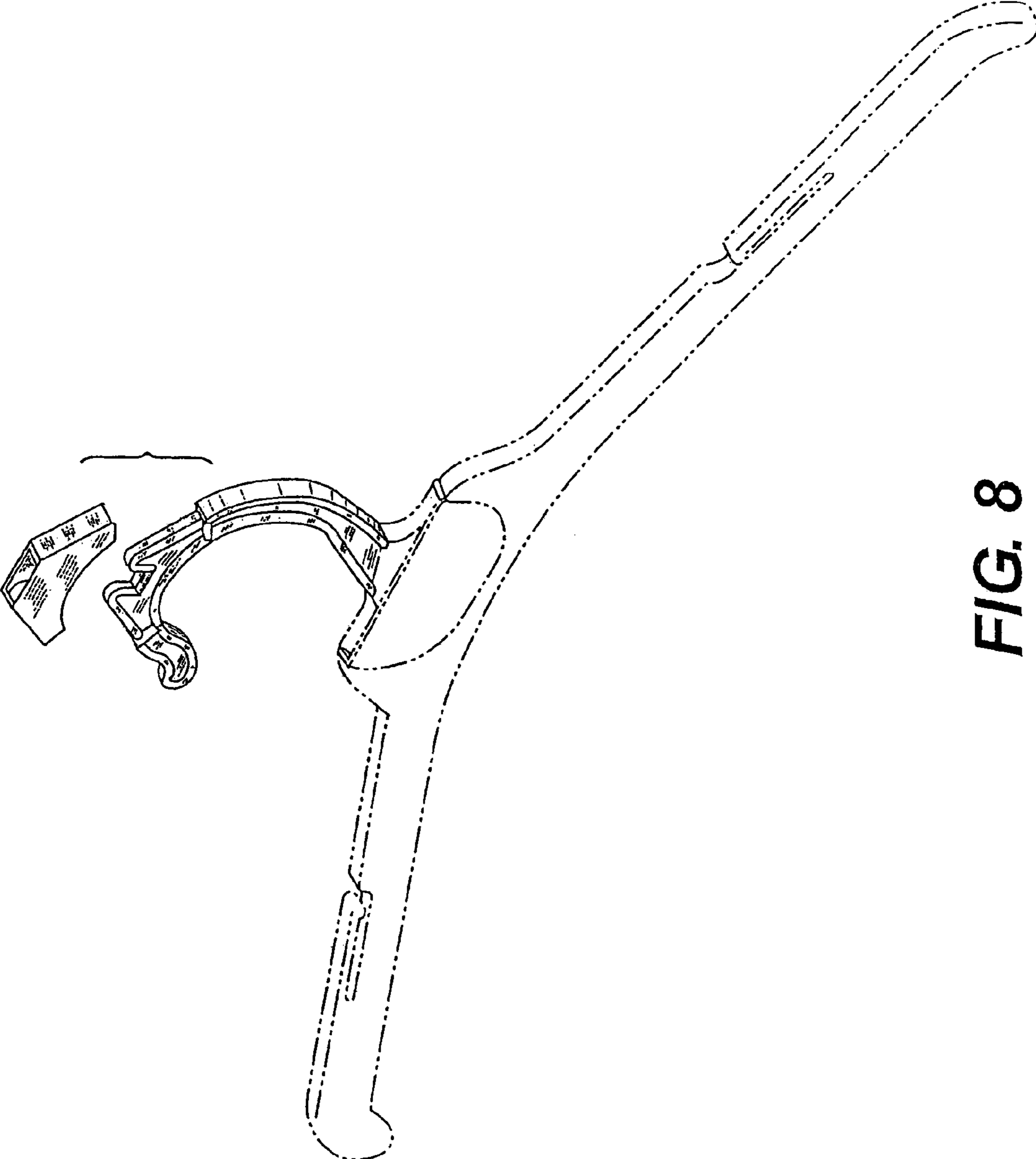

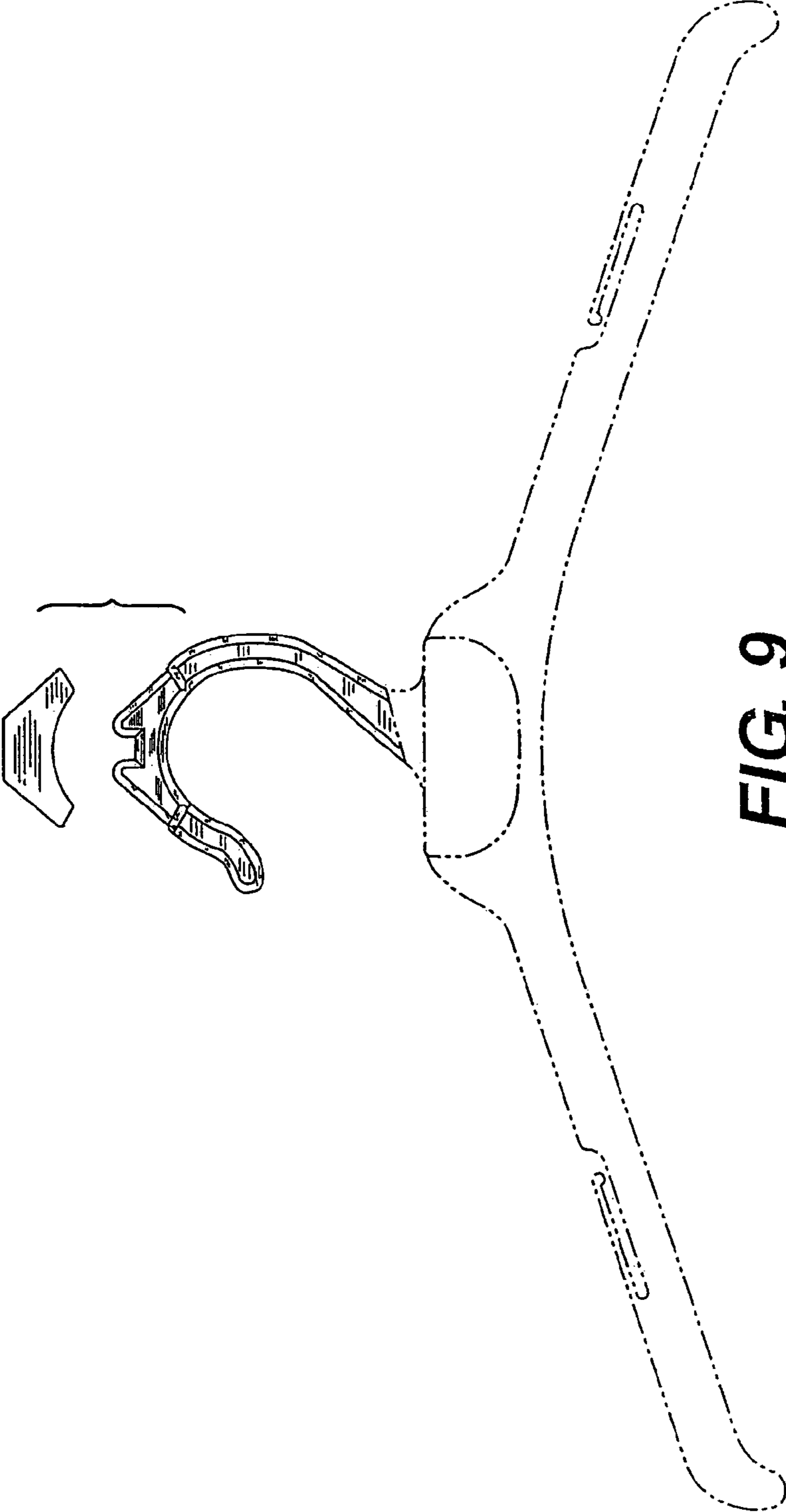

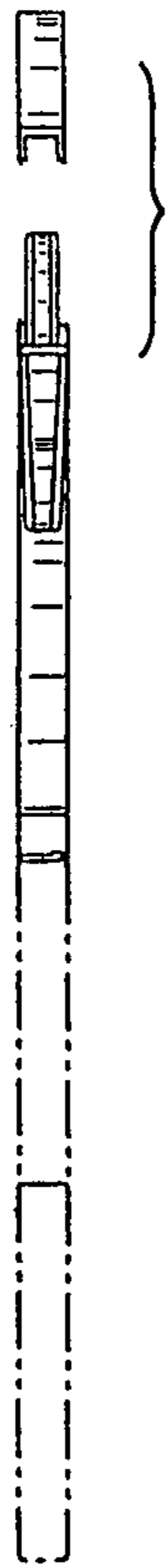

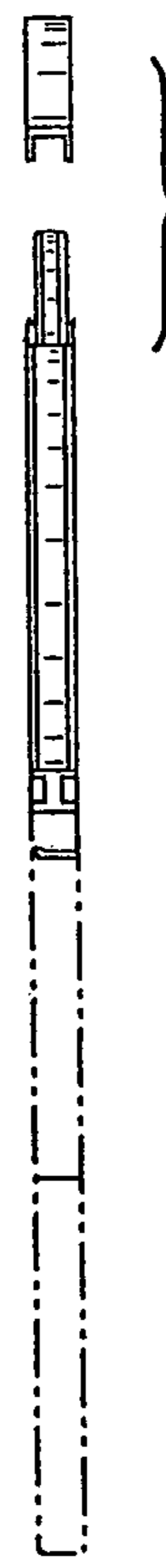
