FIG. 6 is a front perspective view of the chair of FIG. 1 without the cushion;

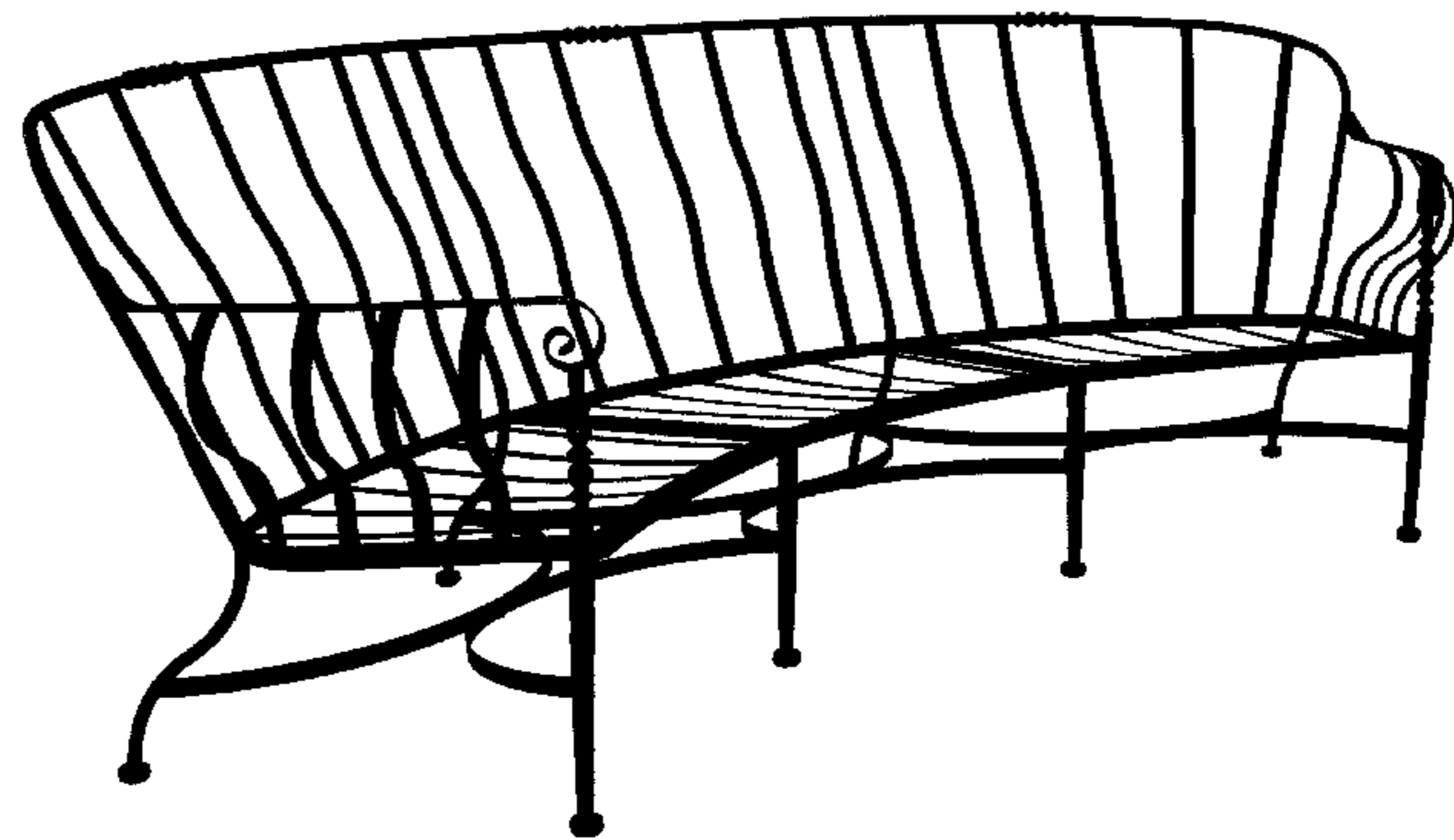
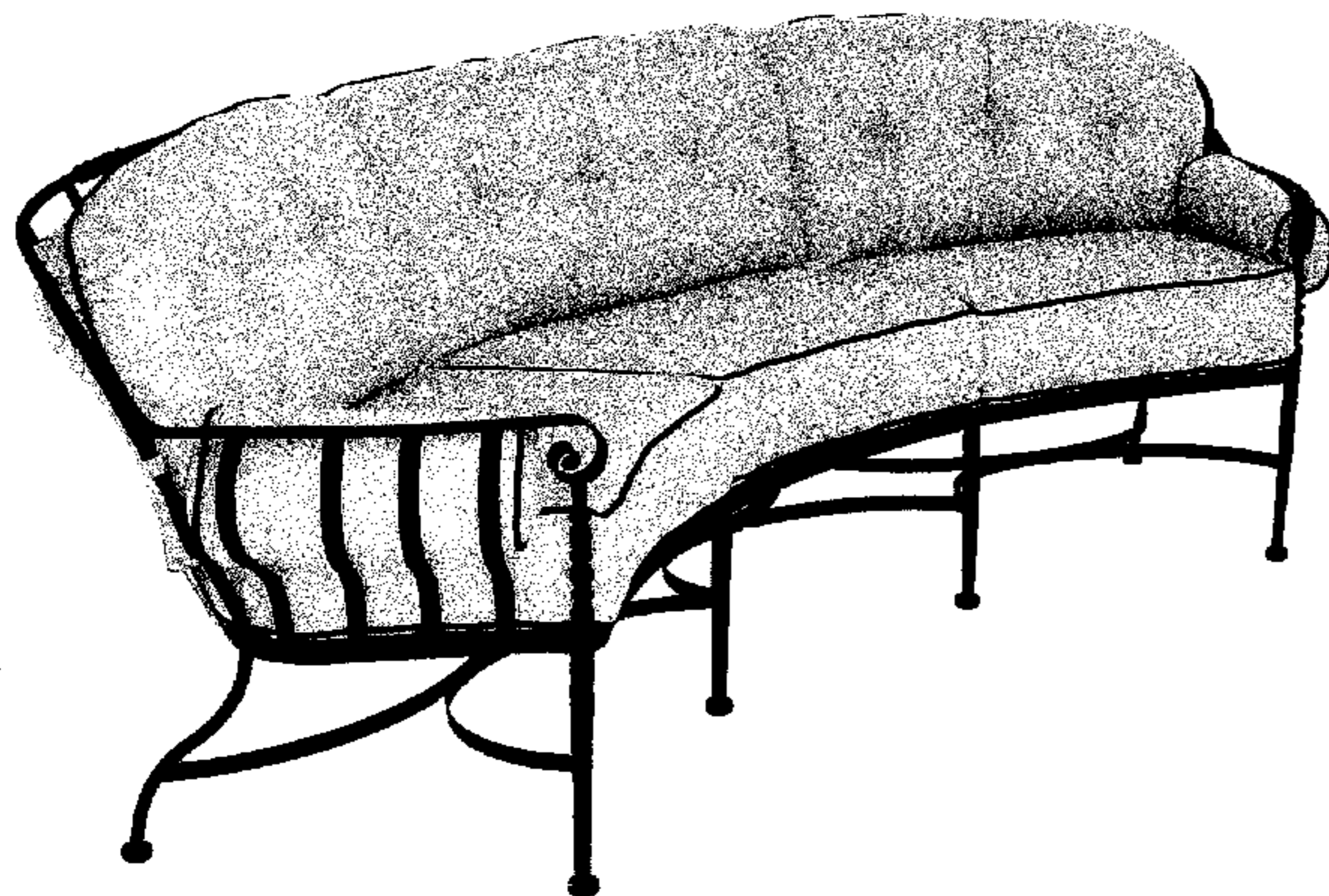
FIG. 7 is a side perspective view of the chair of FIG. 6;

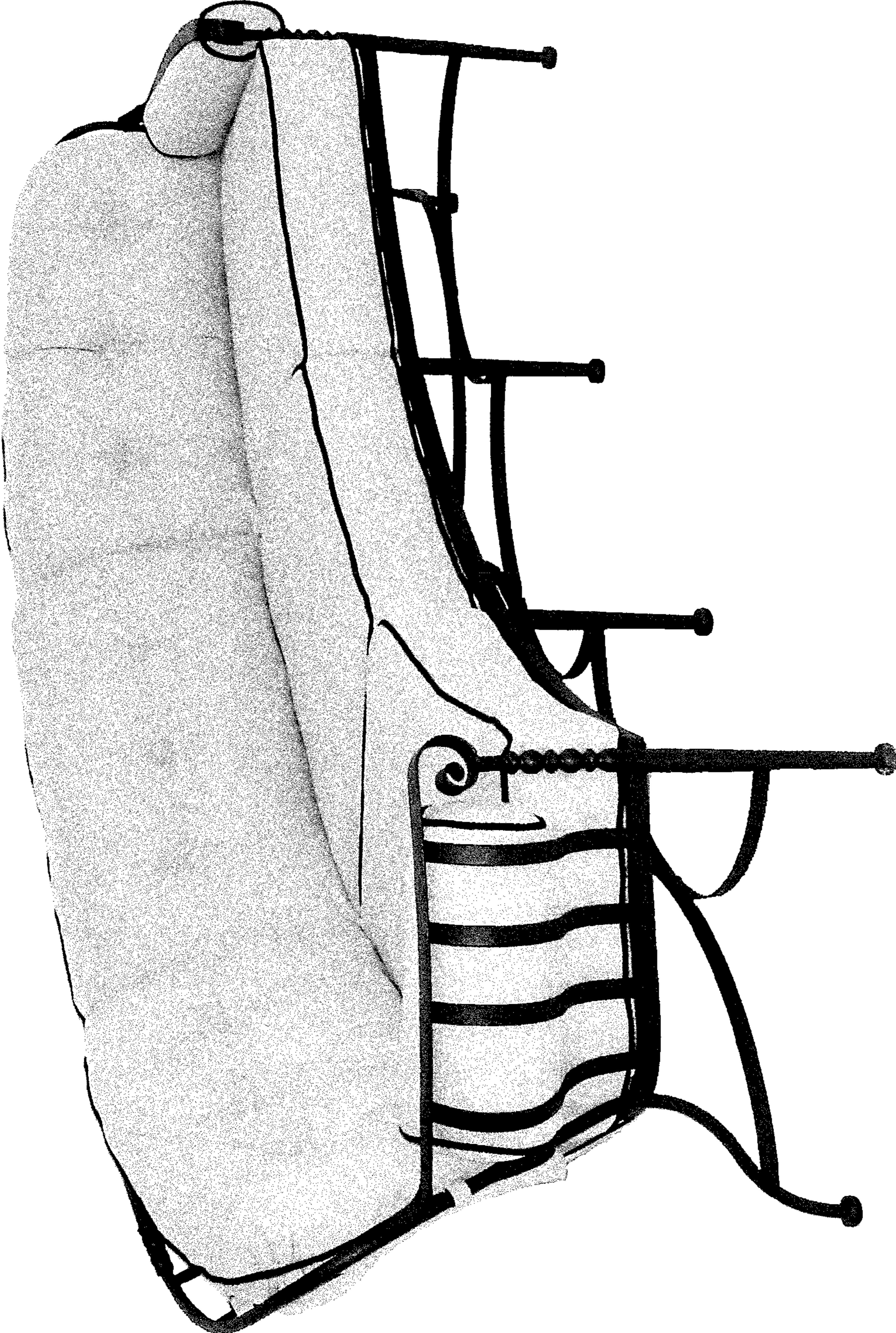

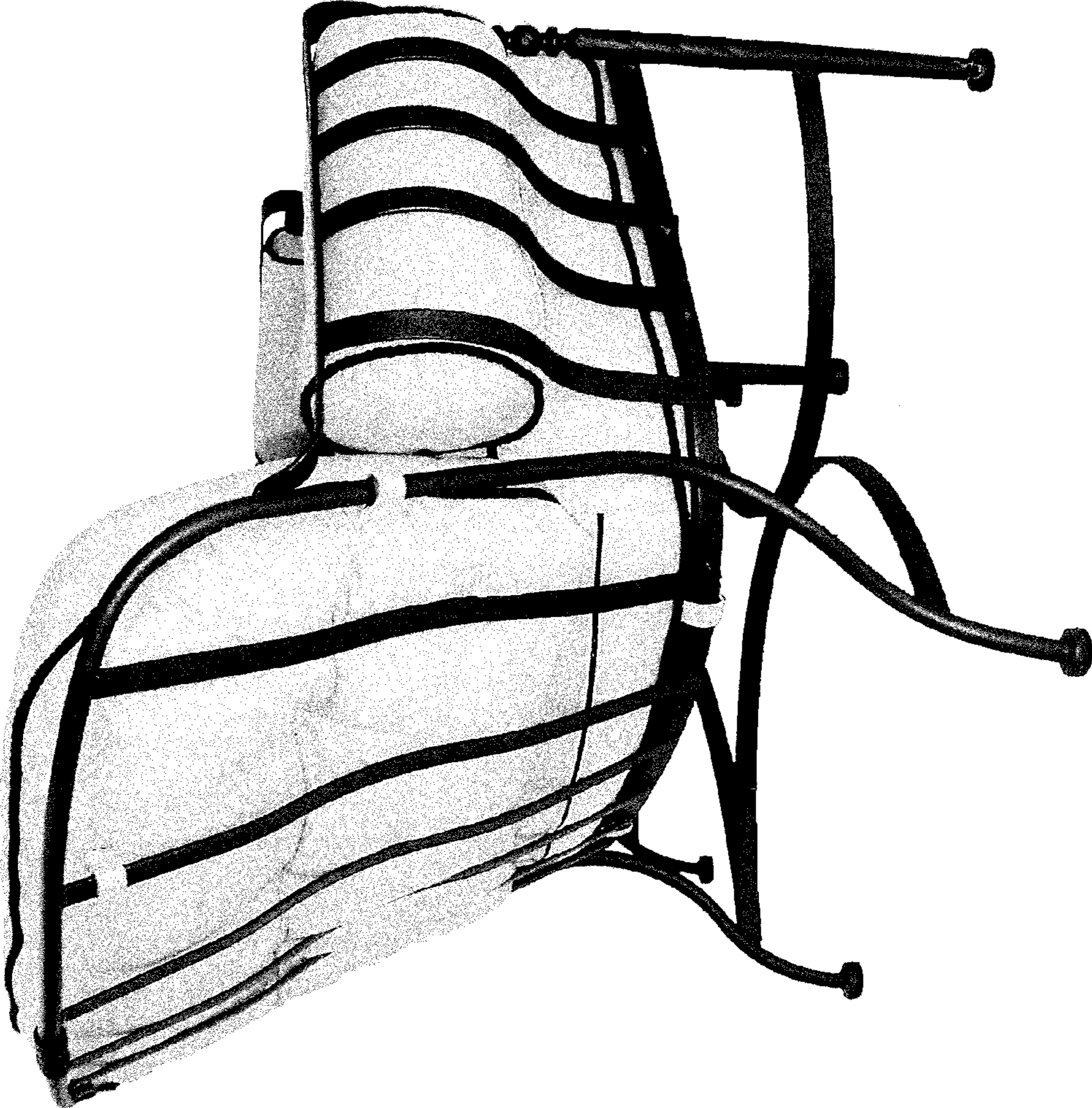

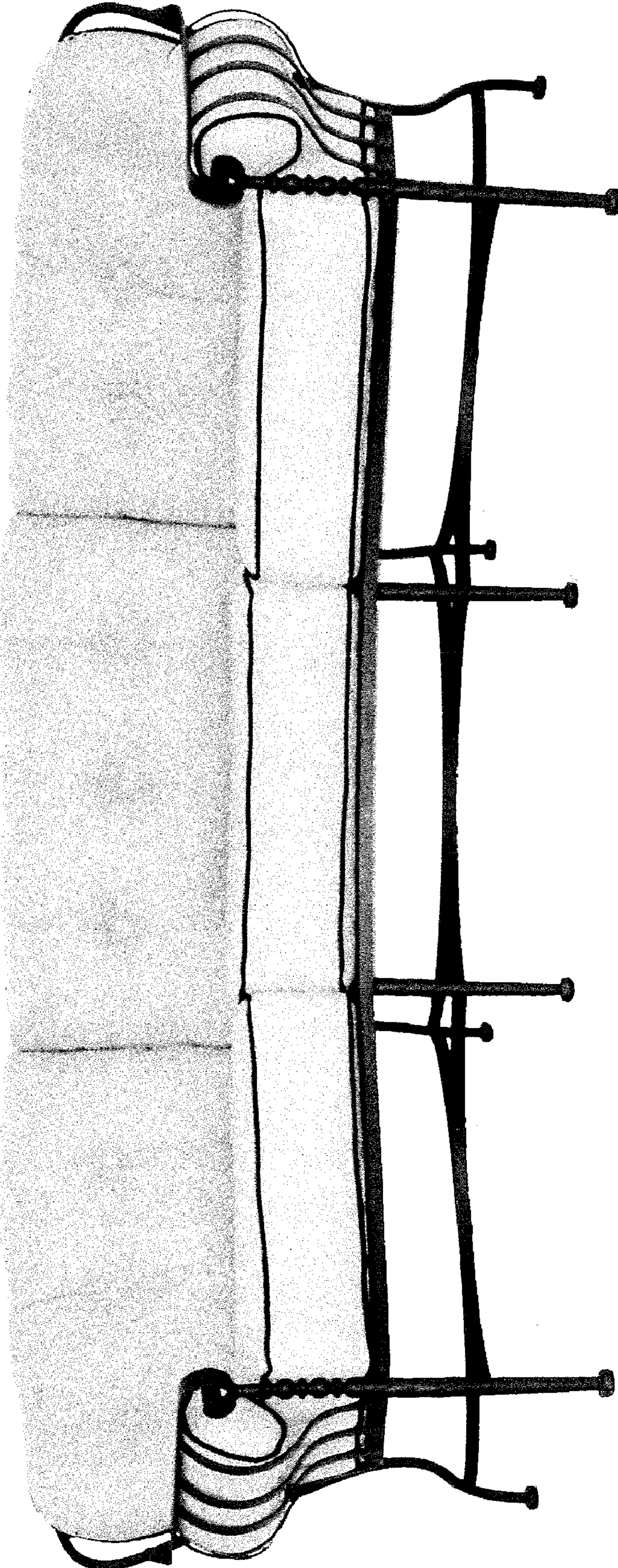

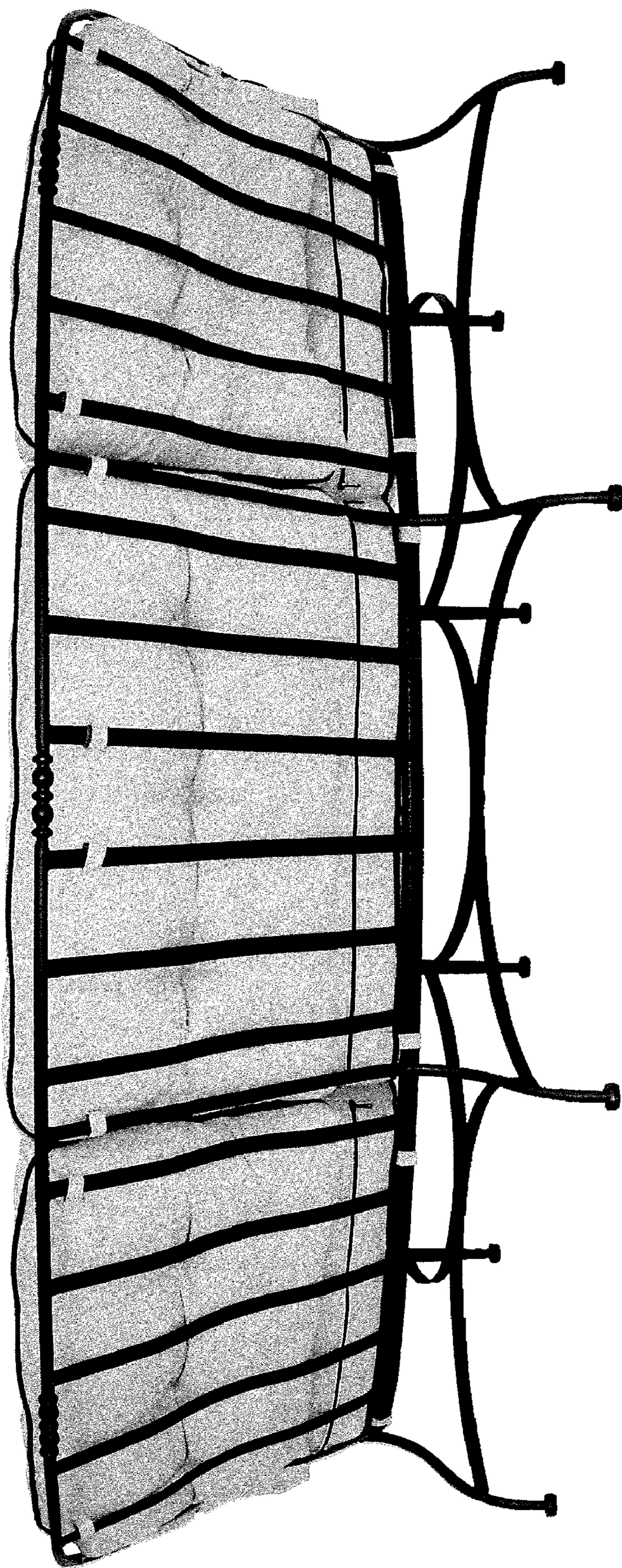

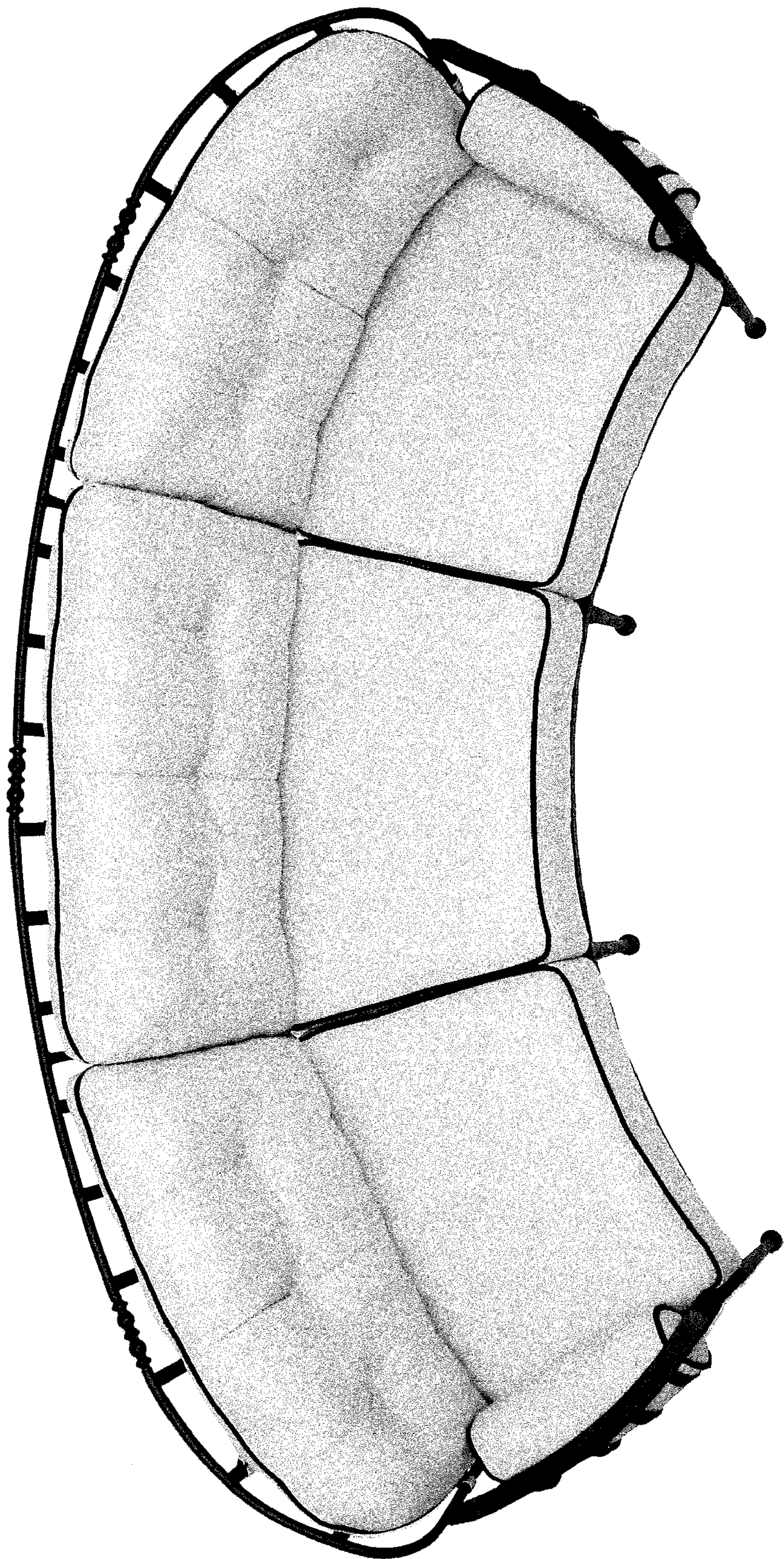

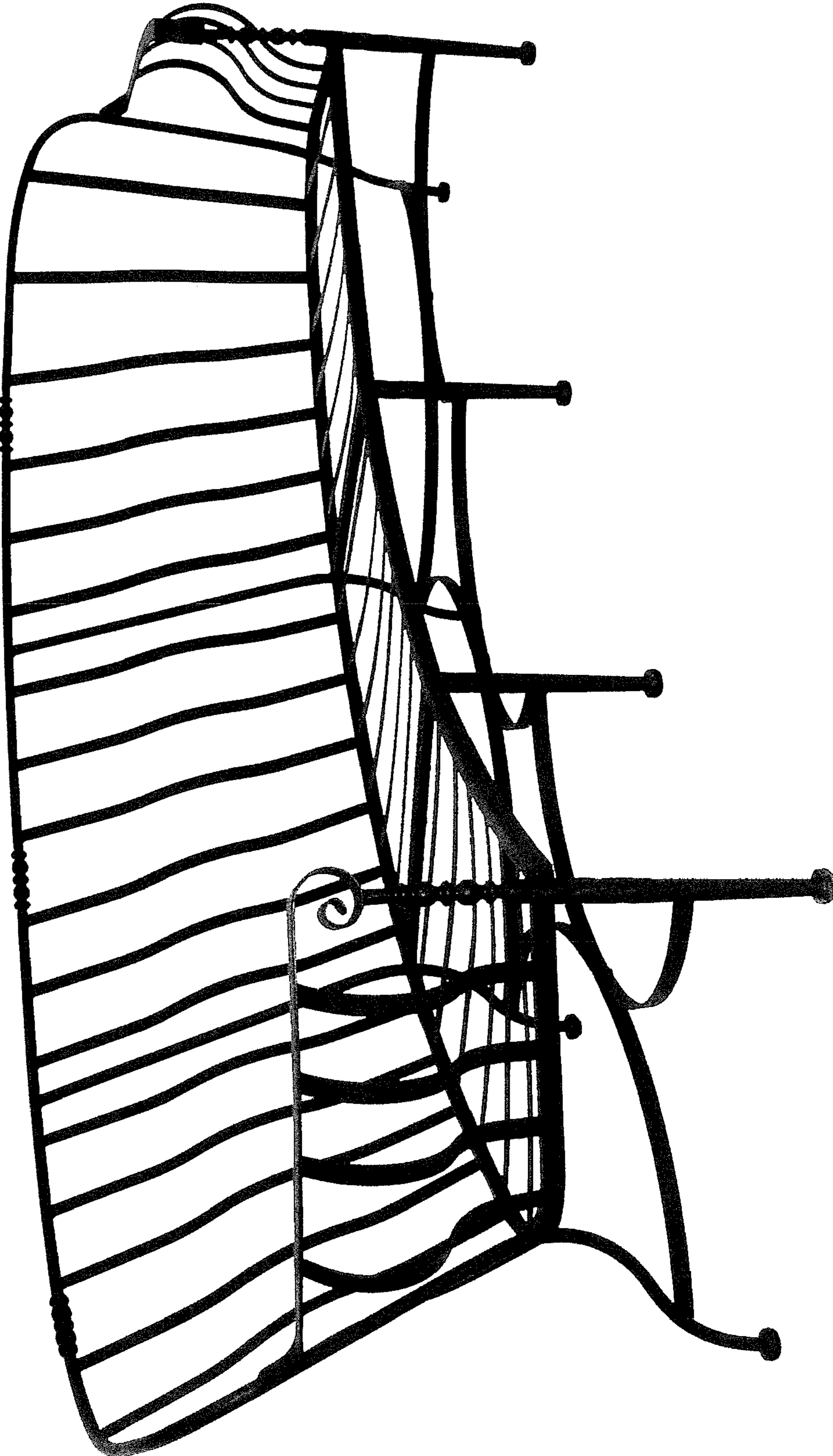

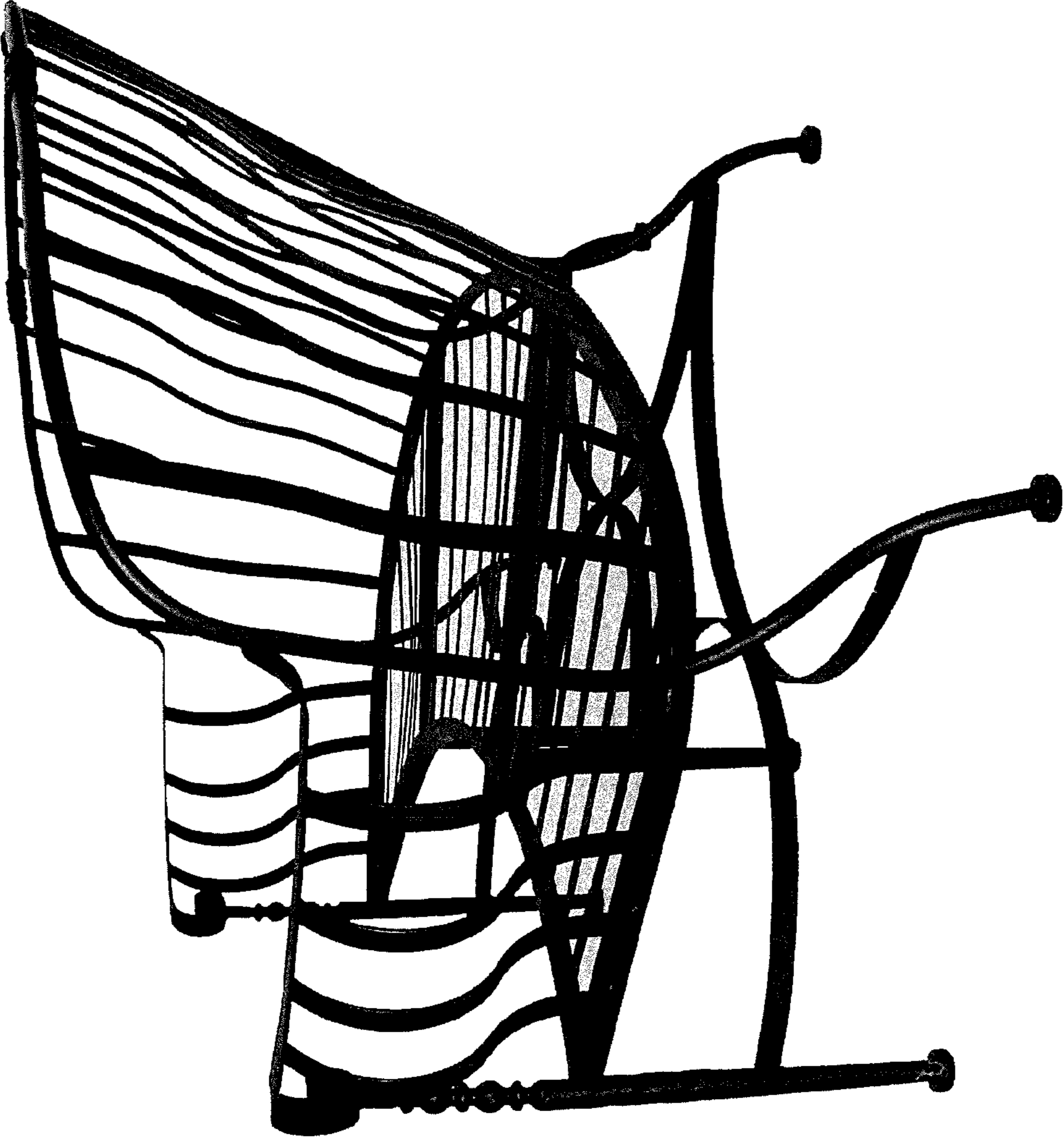

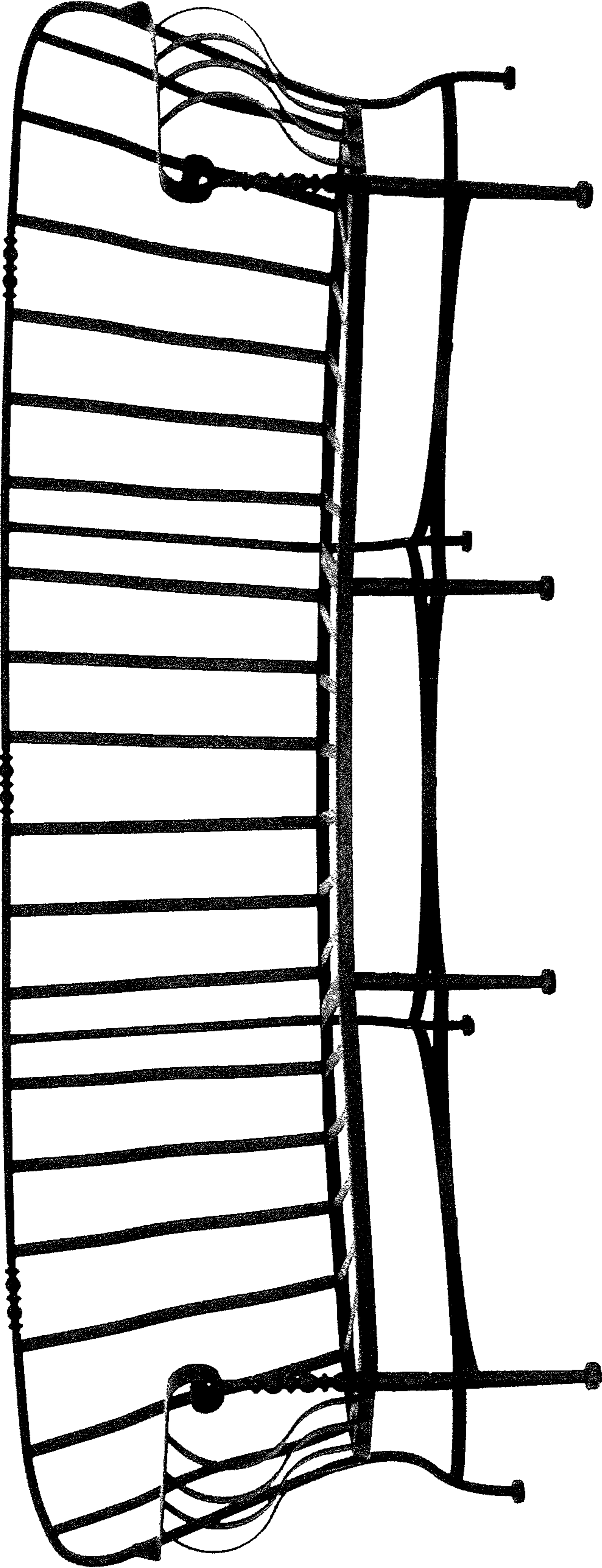

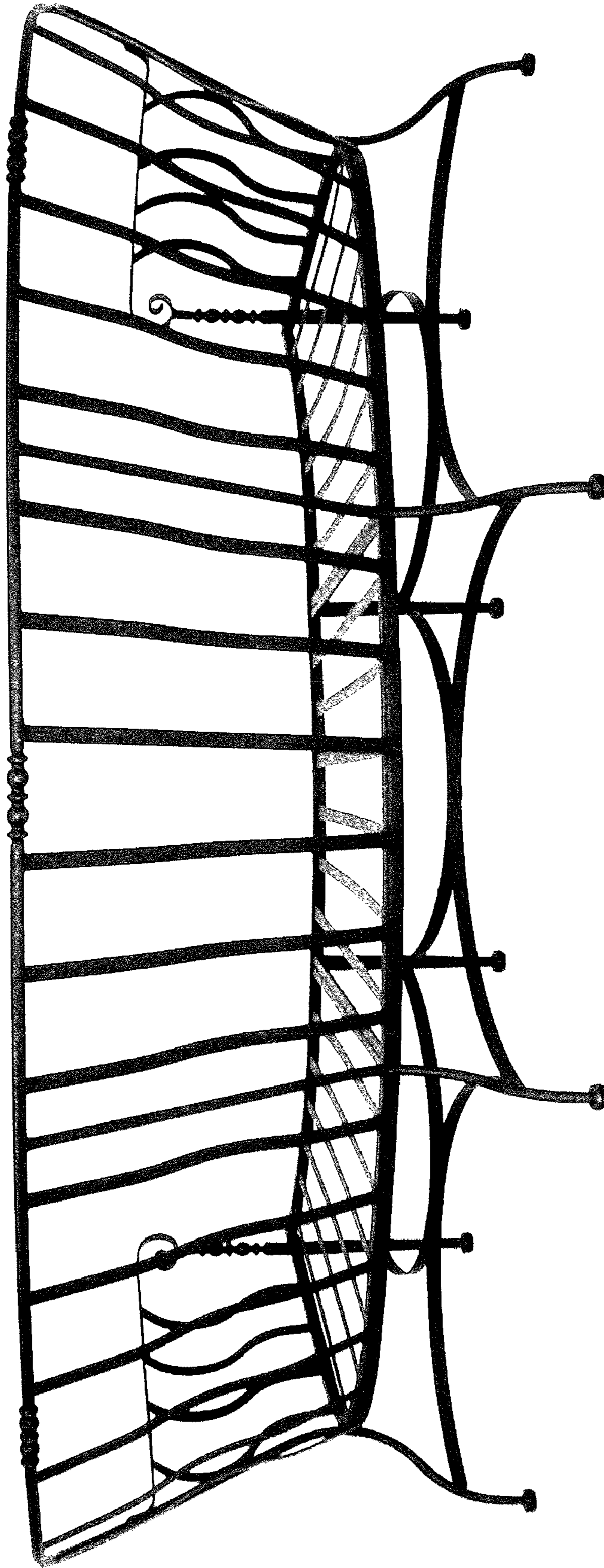

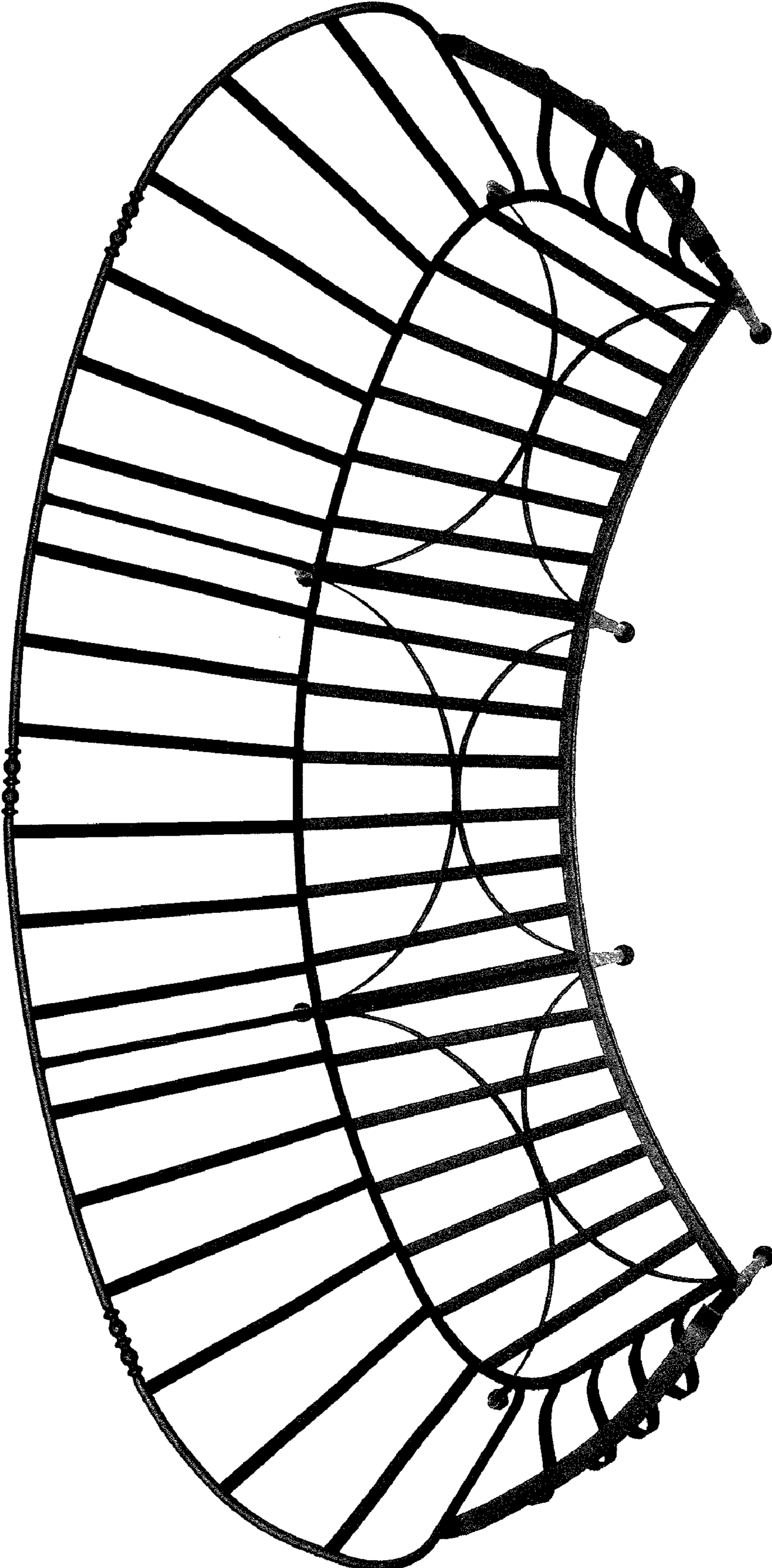
