DESCRIPTION

FIG. 1 is a perspective view of a tool for carrying sheet material, showing my new design;

FIG. 2 is a rear elevational view, thereof;

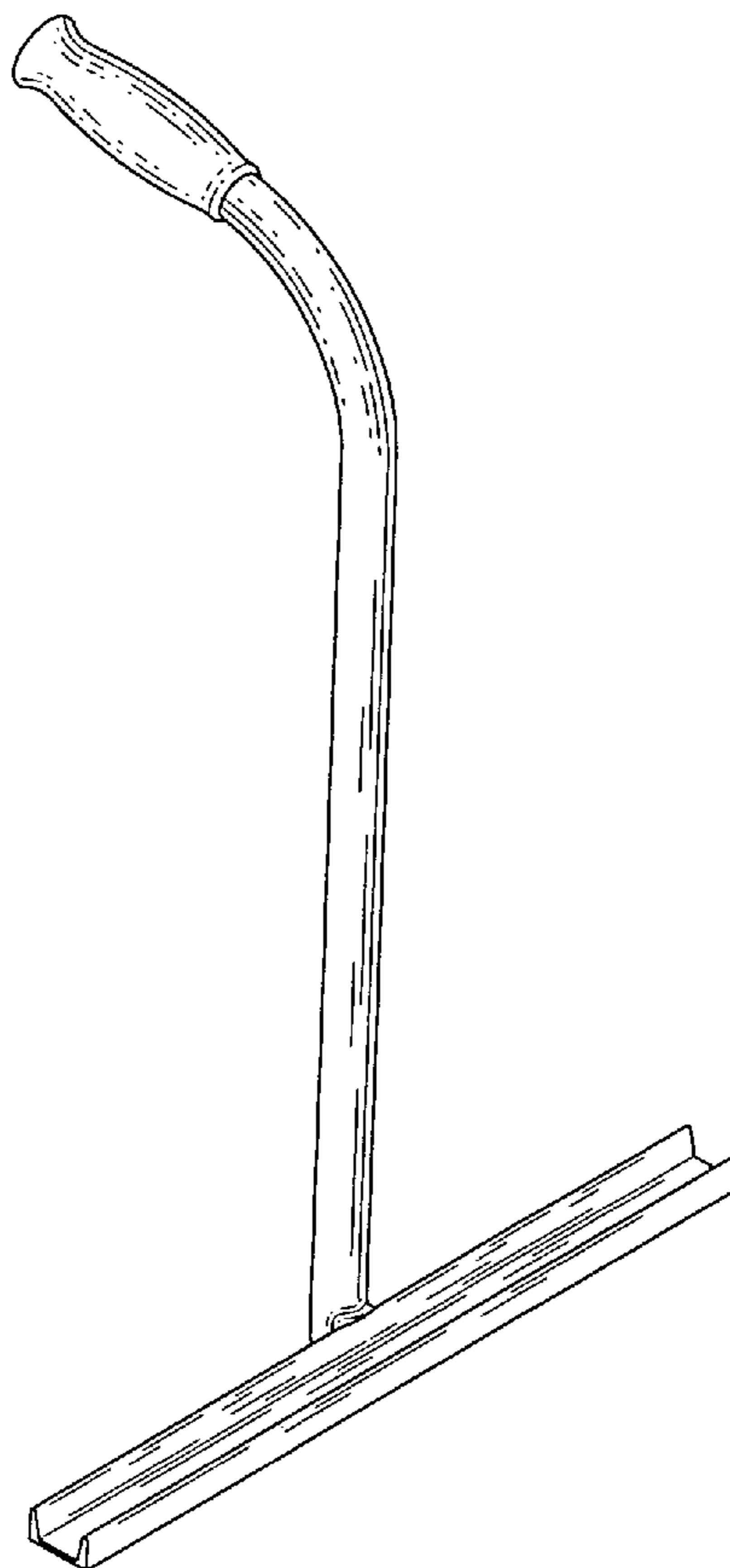
FIG. 3 is a top plan view, thereof;

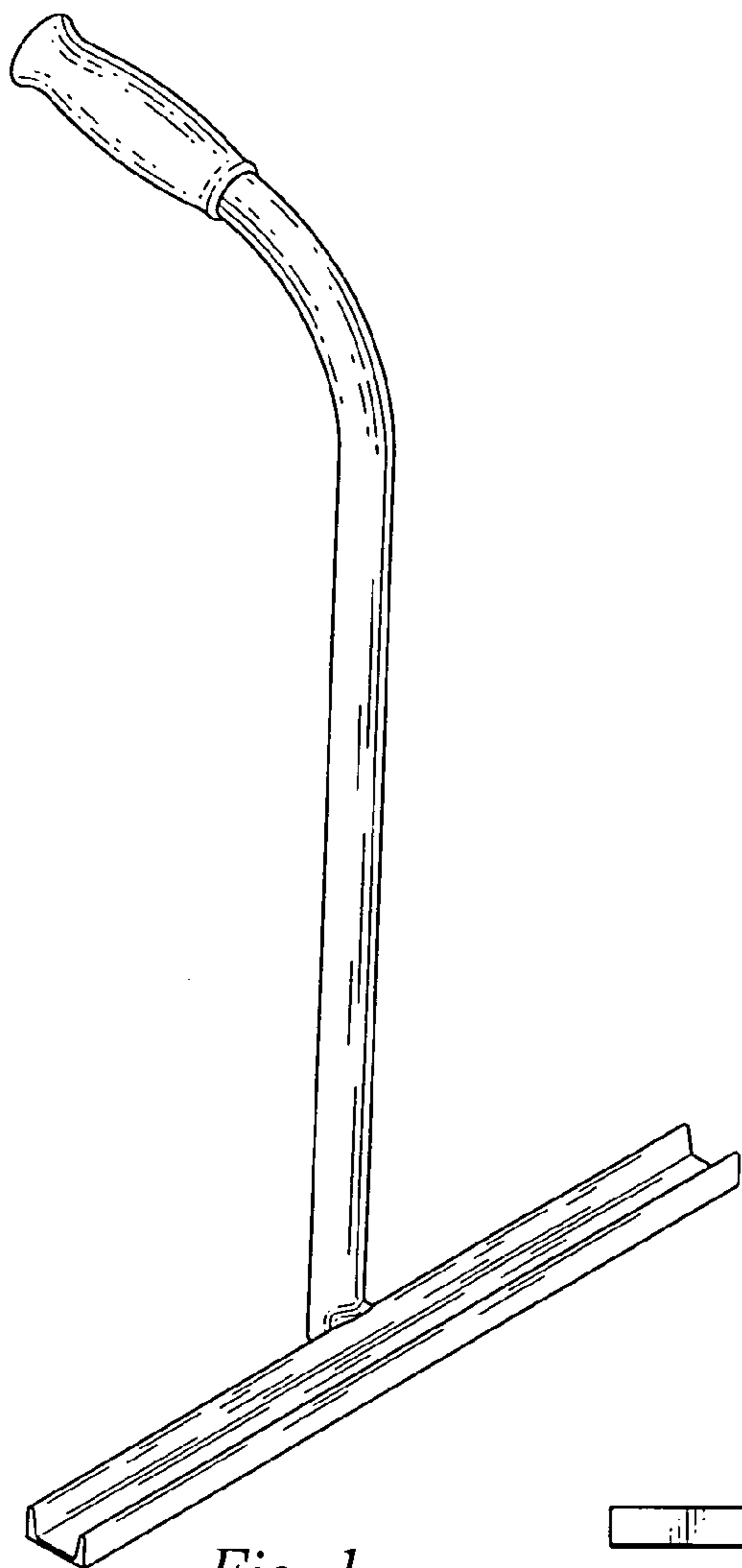

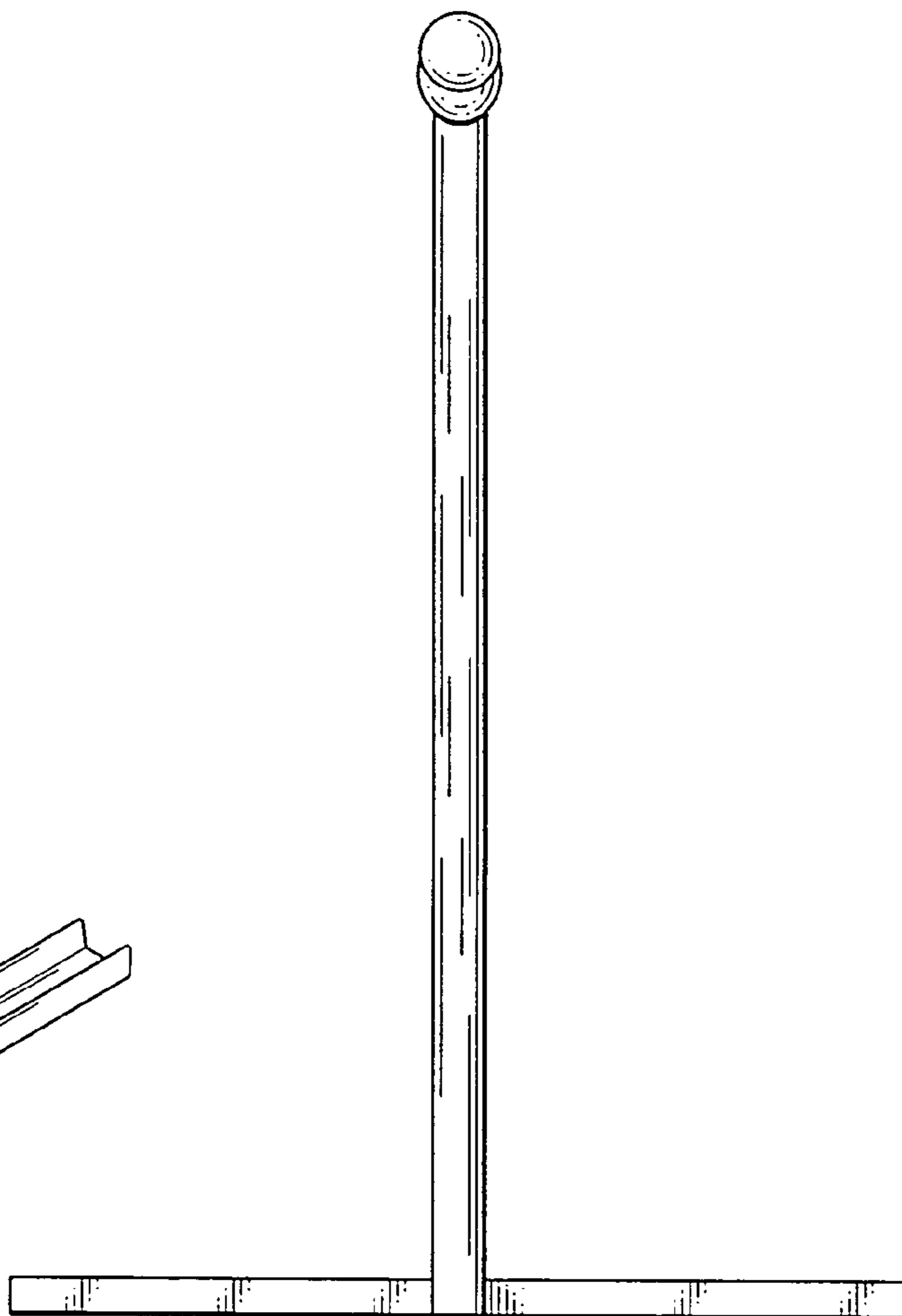

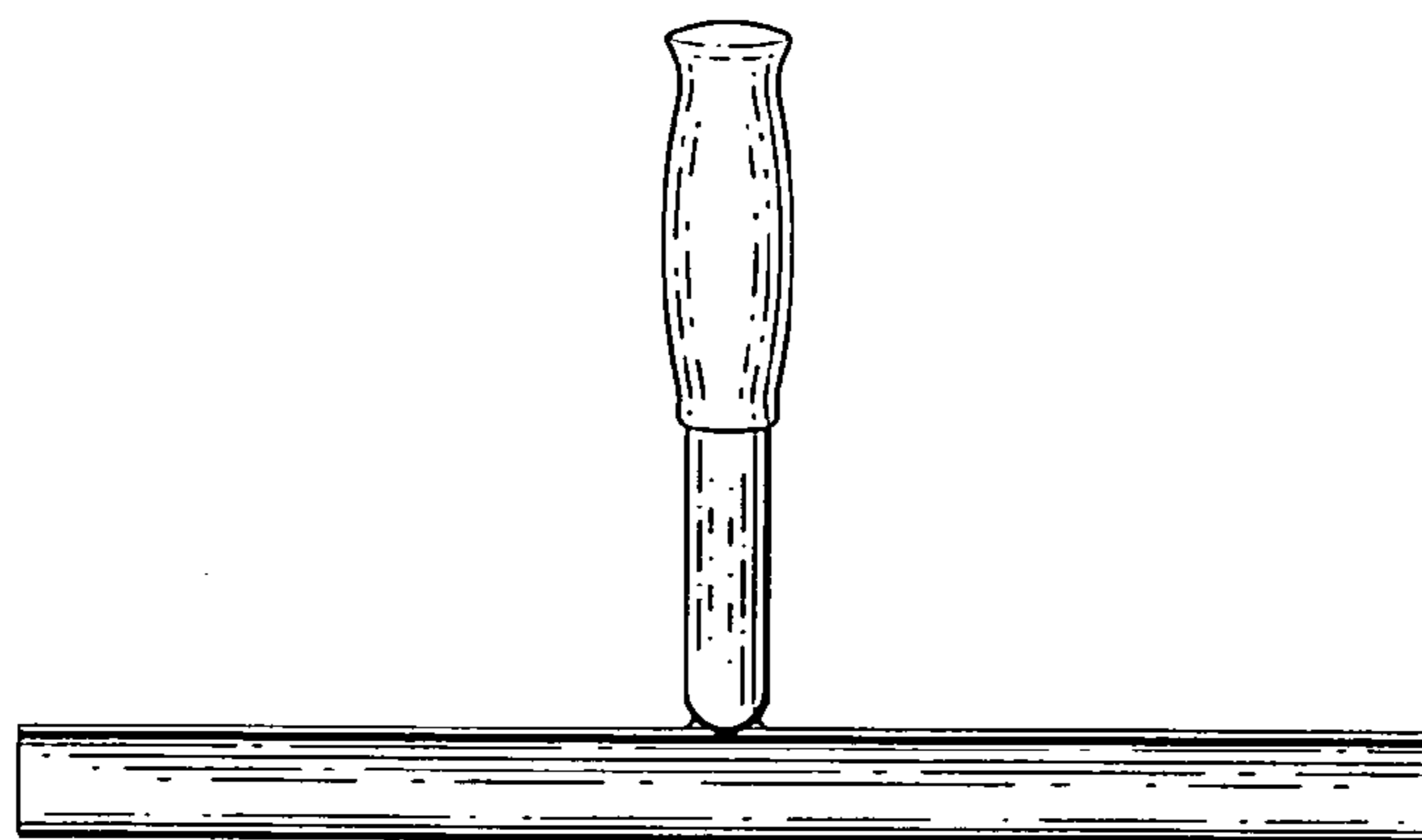

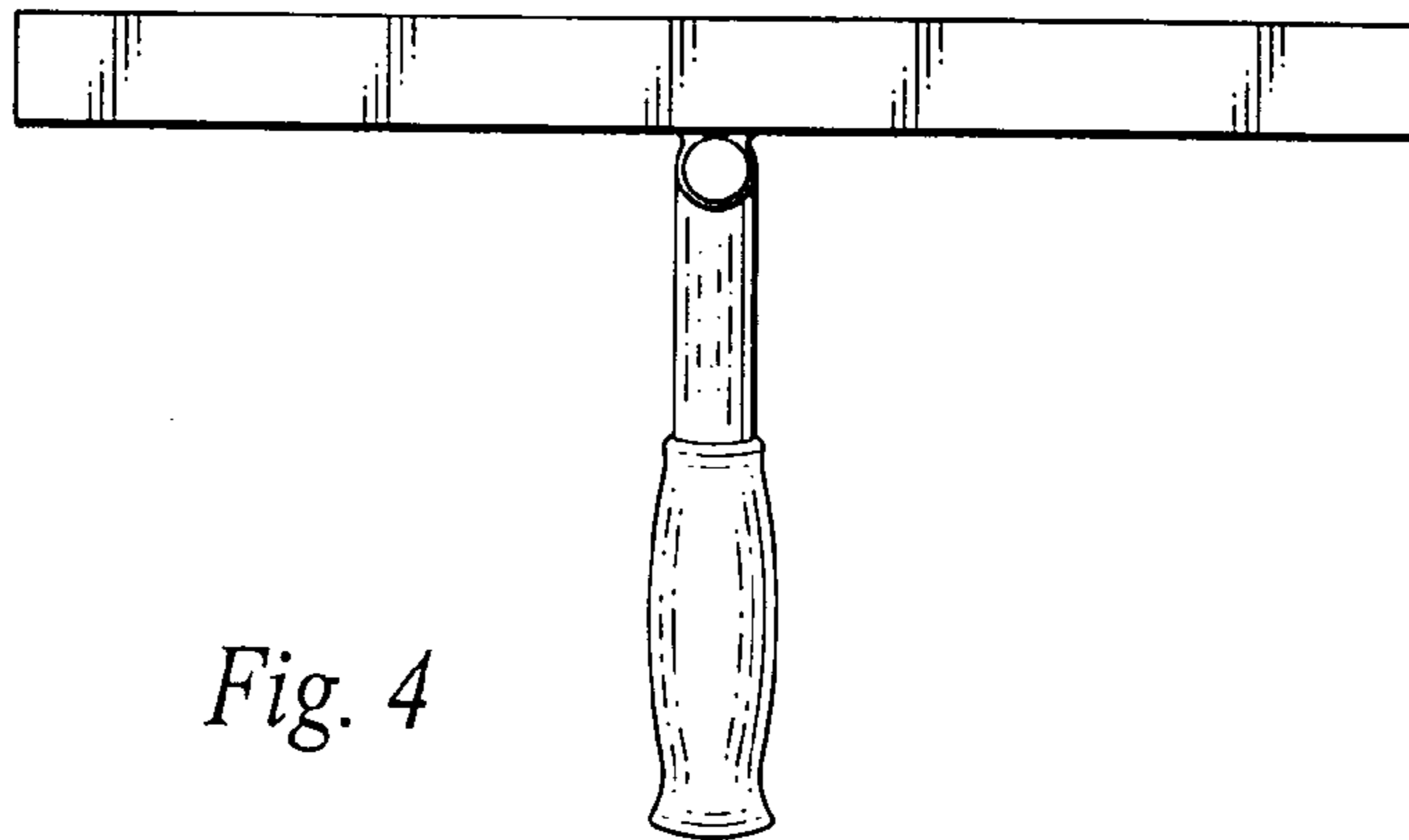

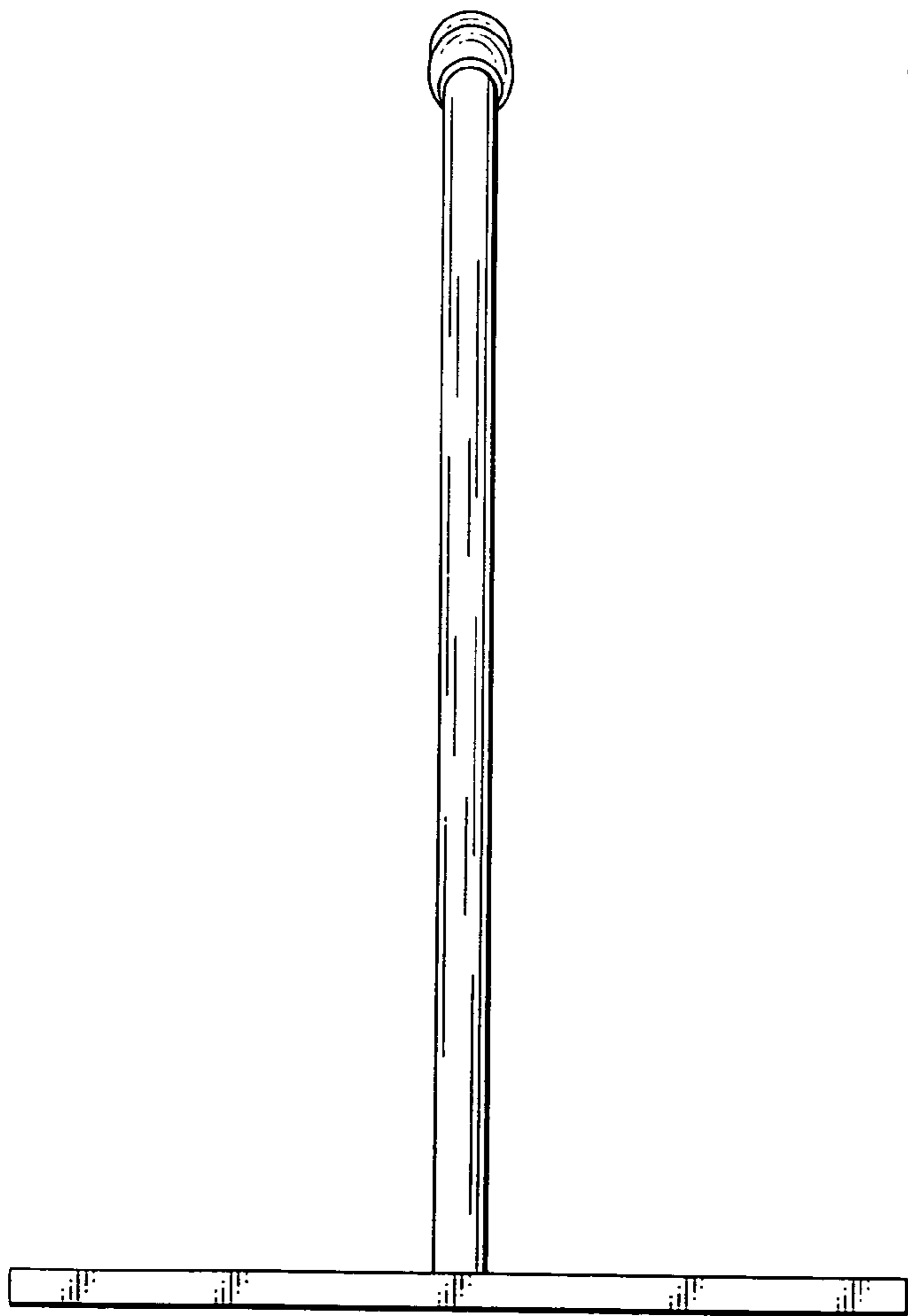

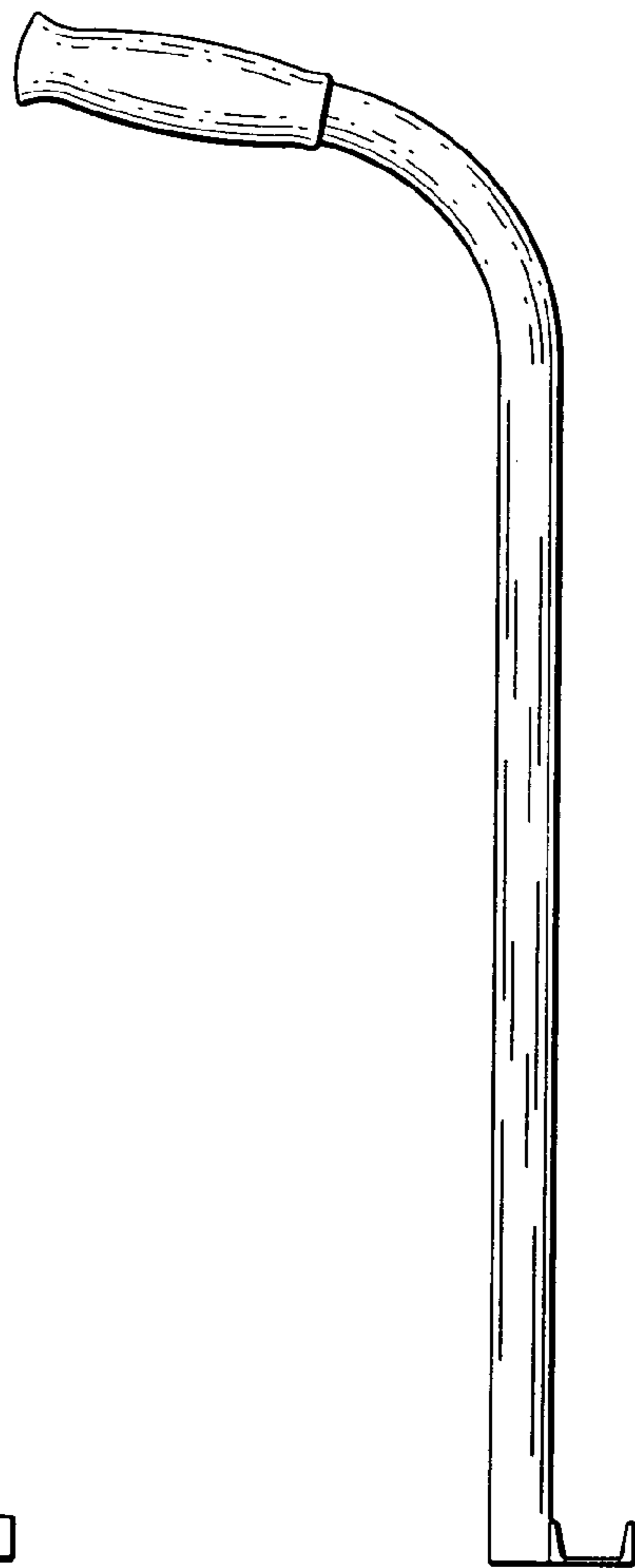
