The ornamental design for a deadbolt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a deadbolt showing a new design;

FIG. 4 is a top view thereof;

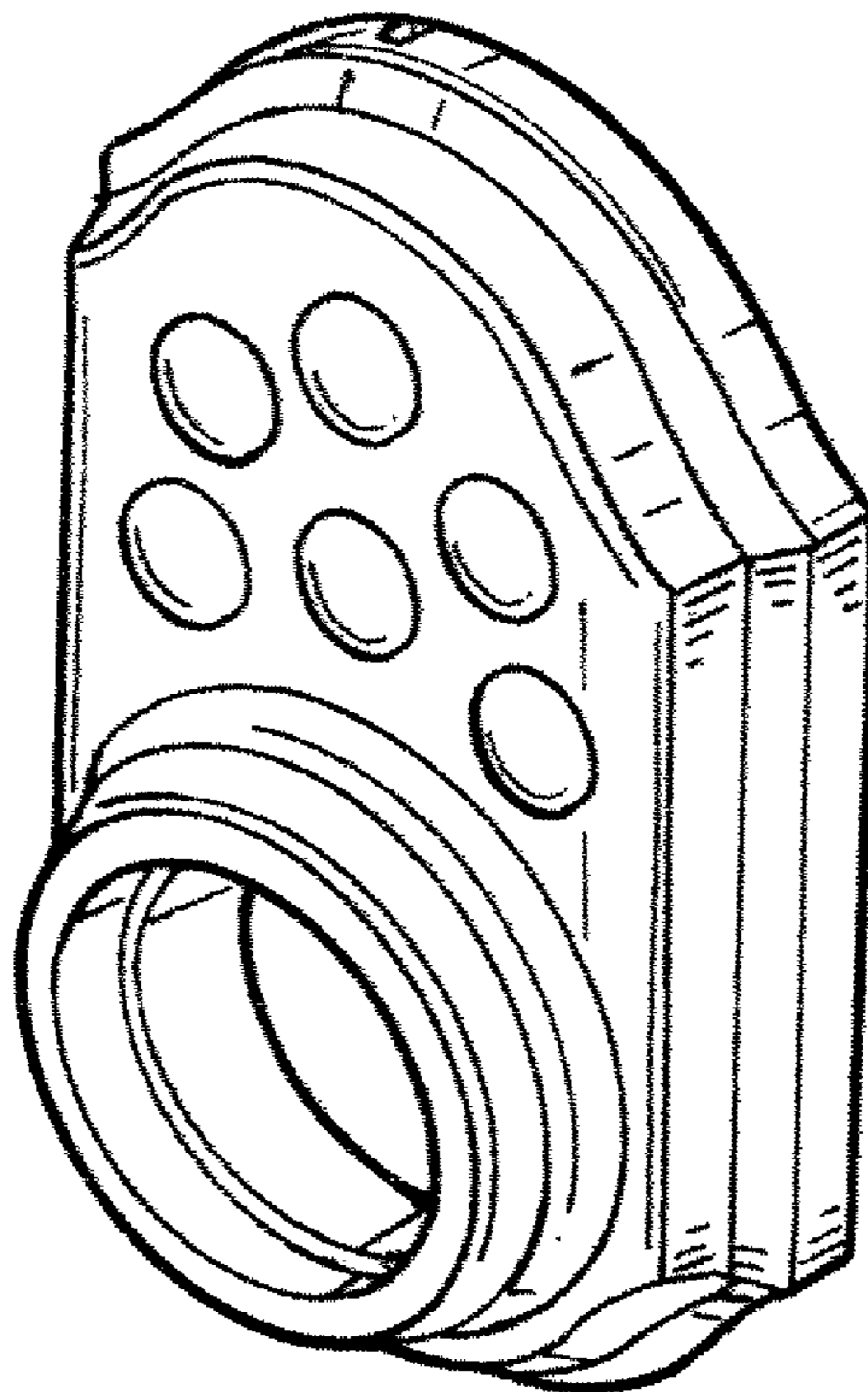
FIG. 5 is a bottom view thereof;

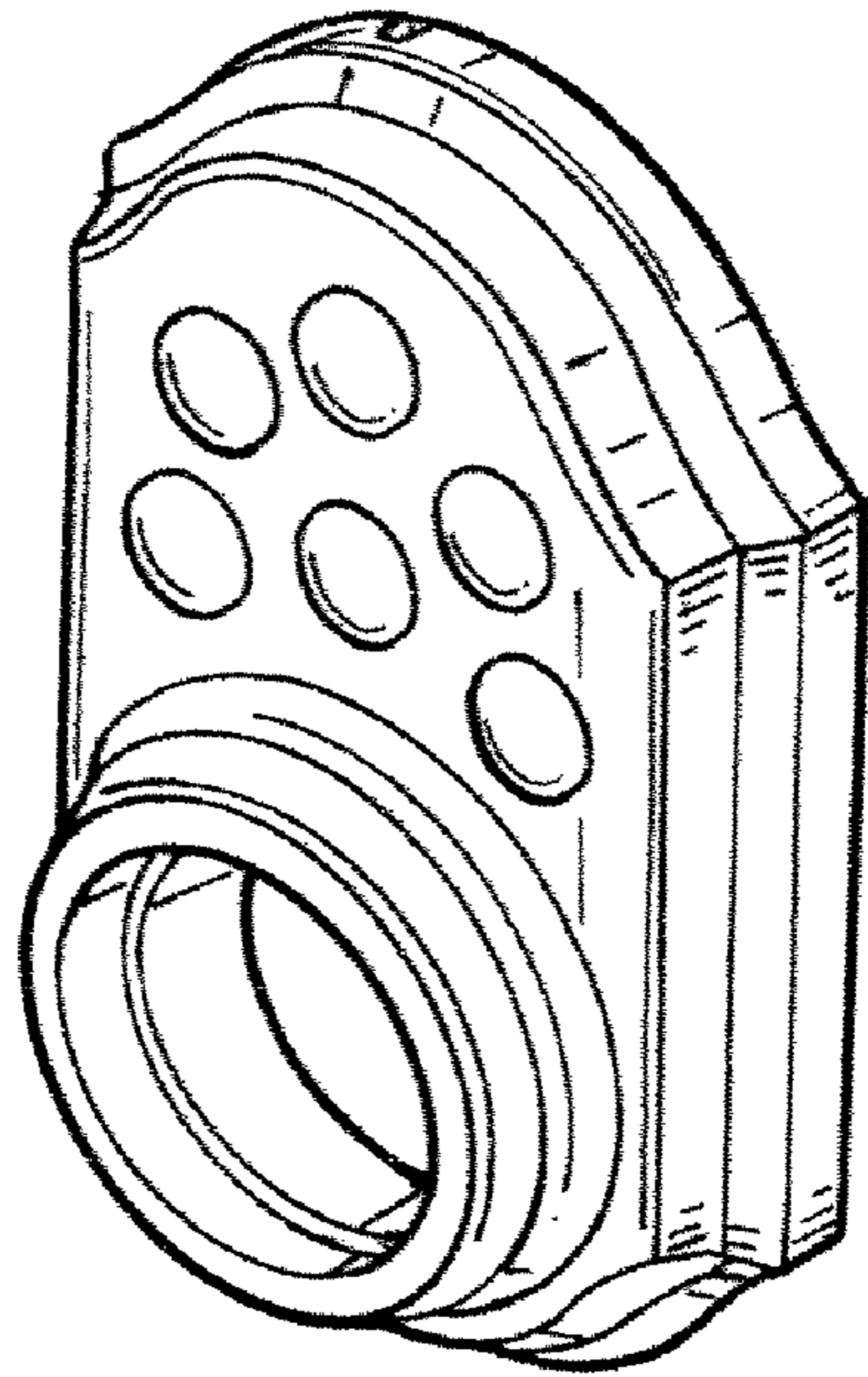

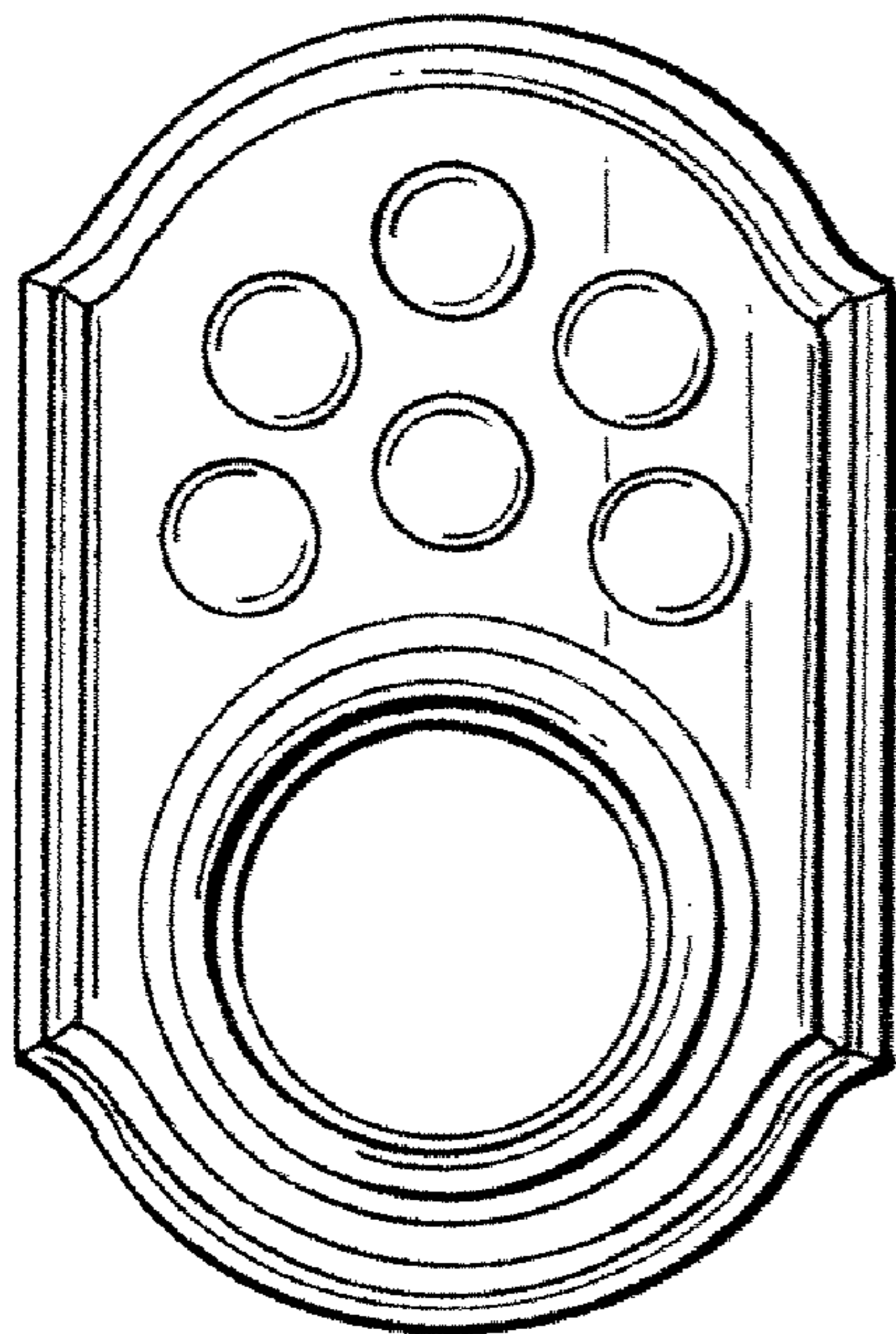

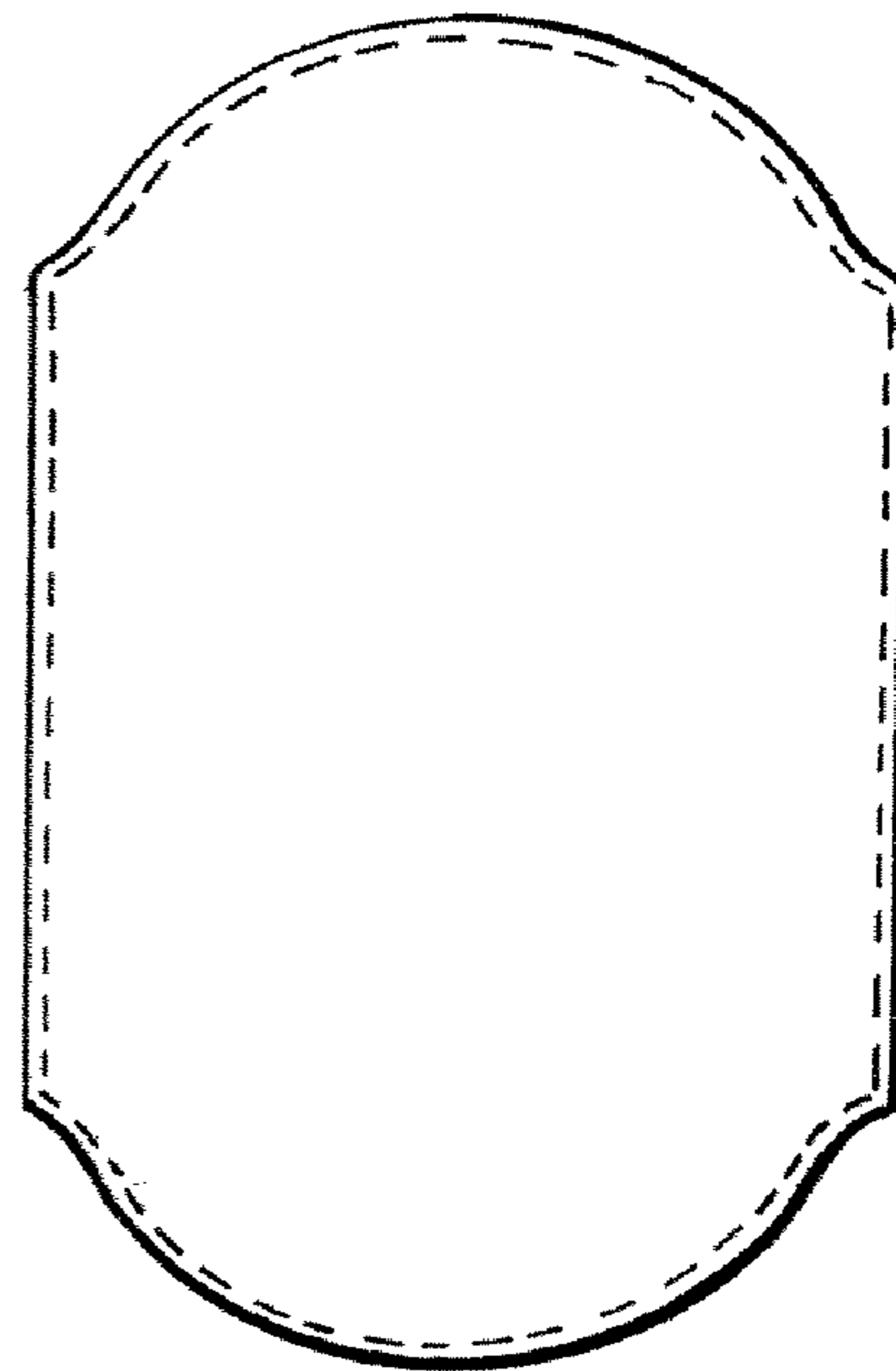

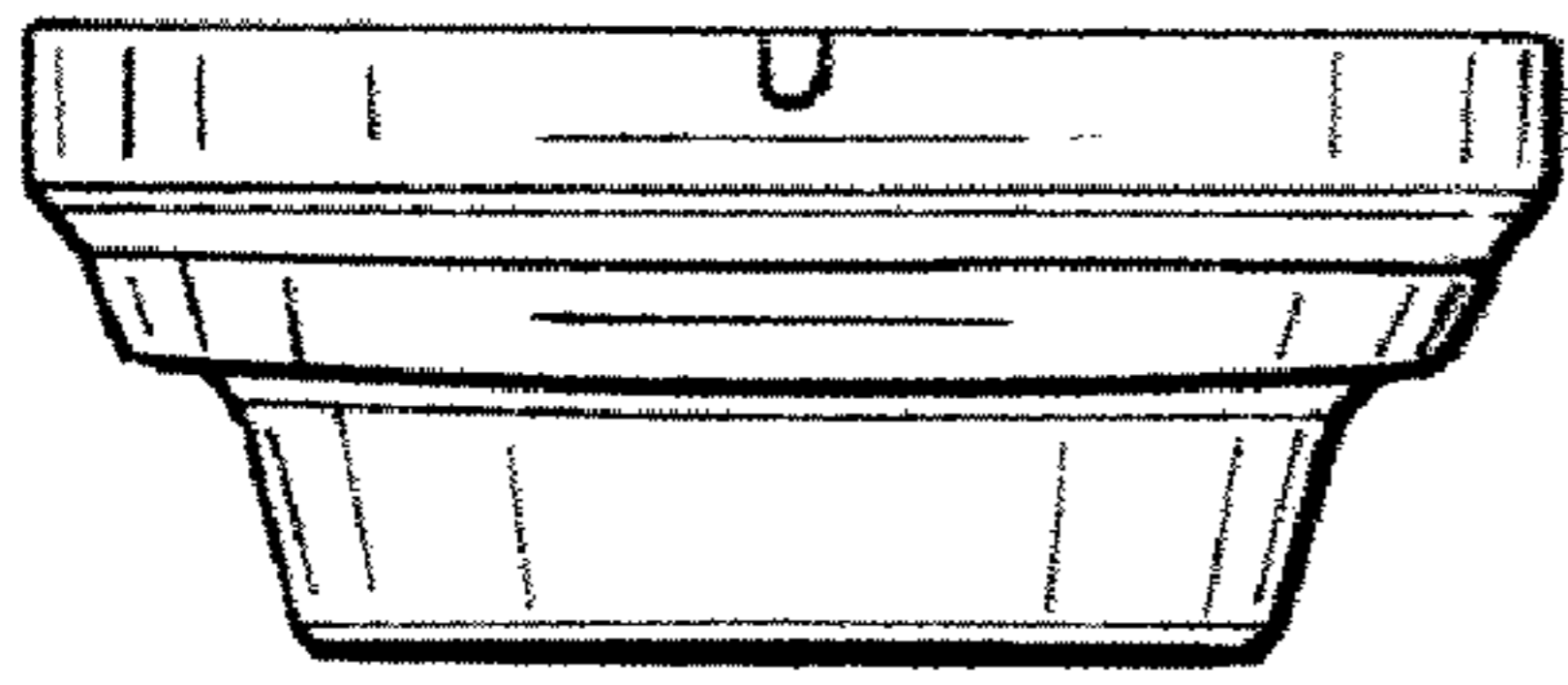

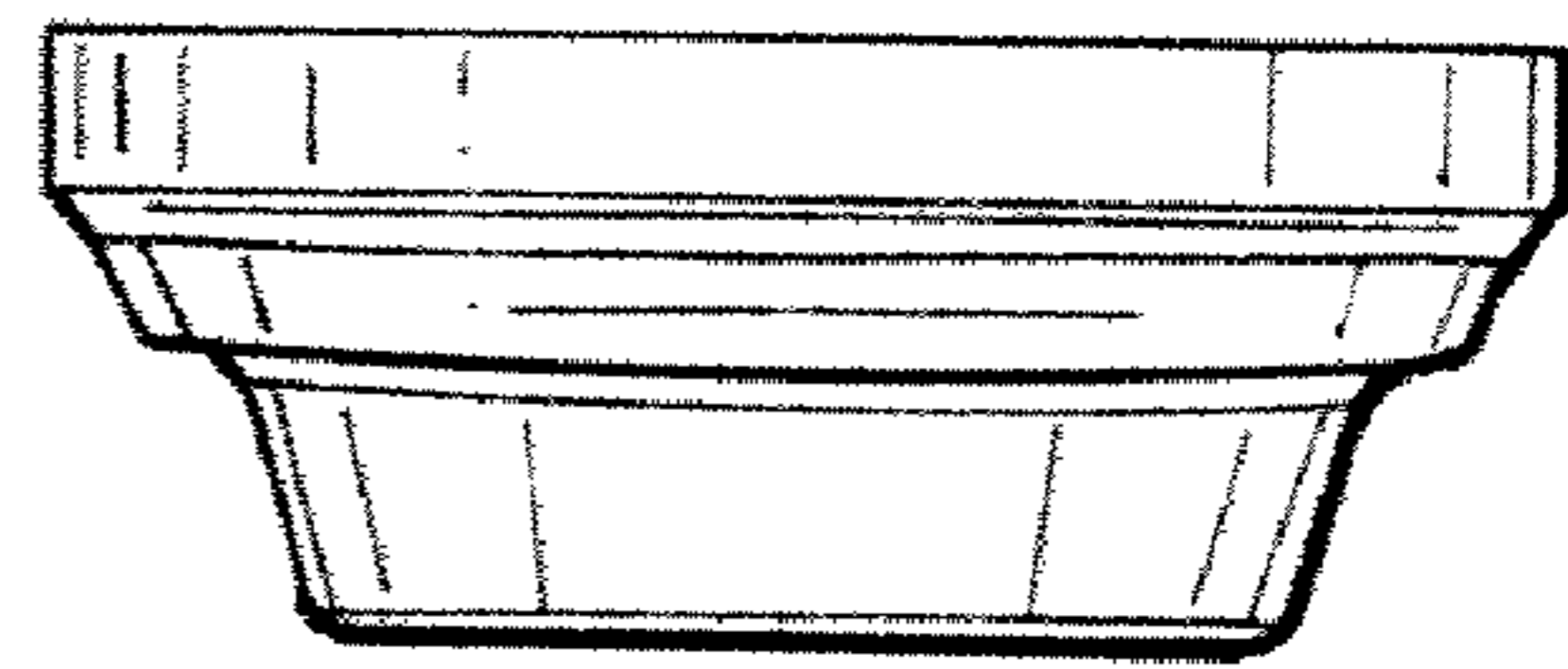

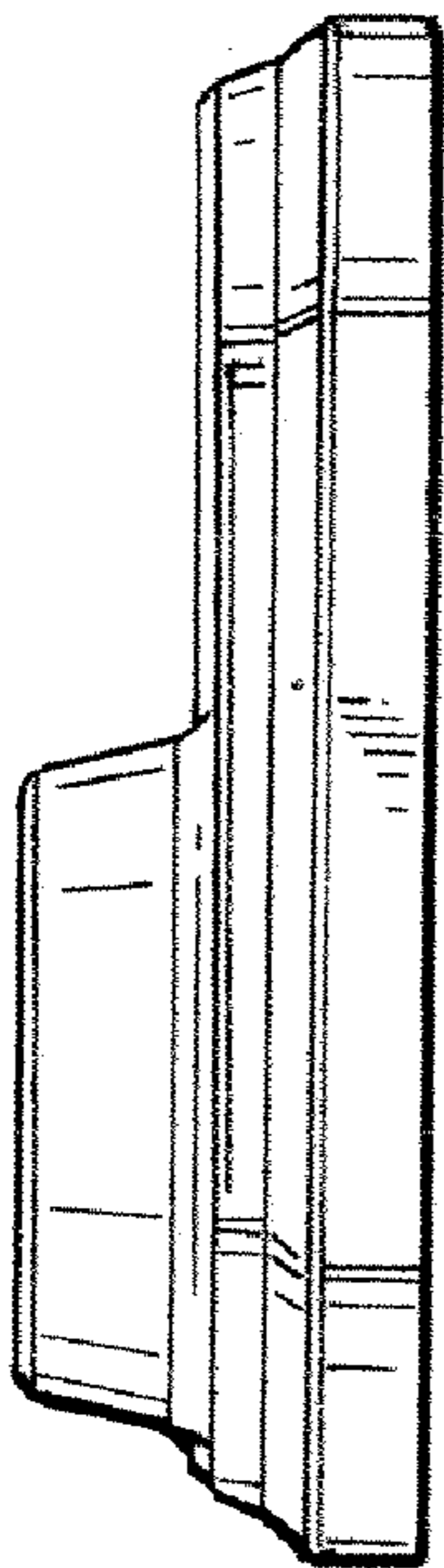

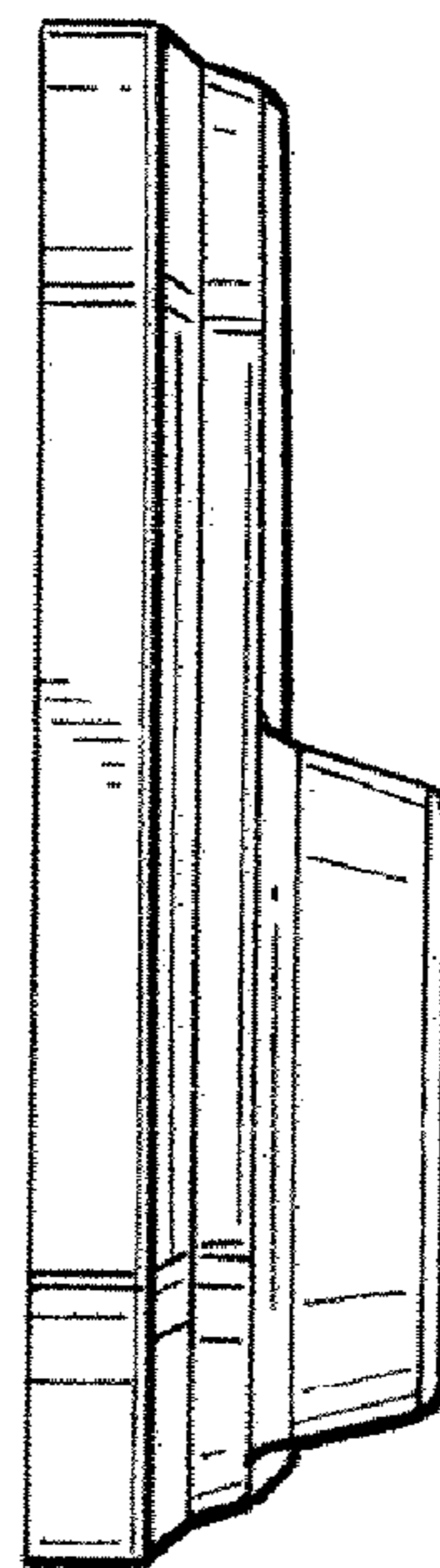
