(57) **CLAIM**

The ornamental design for biasable lock with pocket, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a biasable lock with pocket showing our new design, shown in it's environmental use and the broken lines are for illustrative purpose only and form no part of the claimed design;

FIG. 2 is an enlarged perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a left side elevational view thereof;

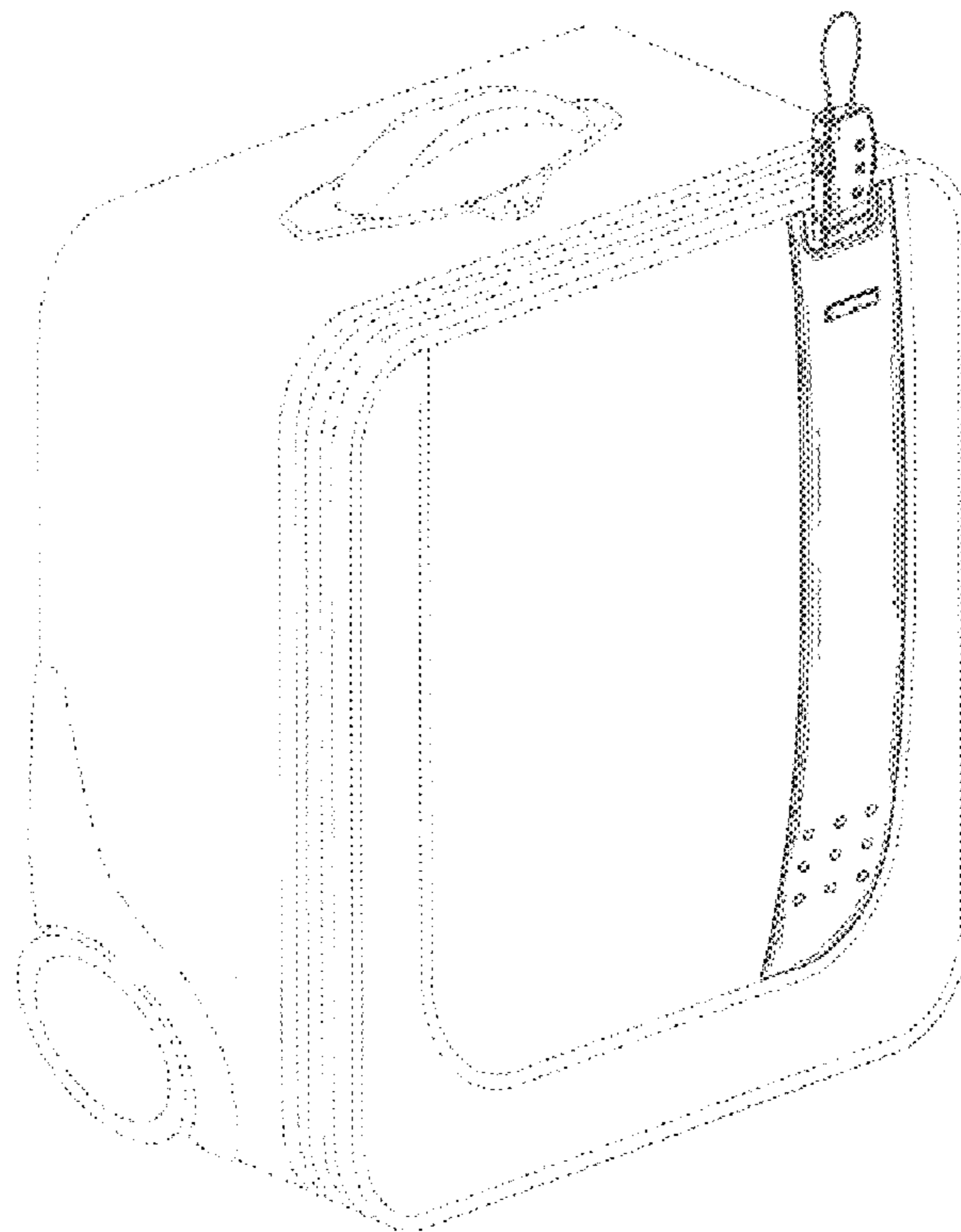
FIG. 7 is a front elevational view thereof, with the lock inside the pocket;

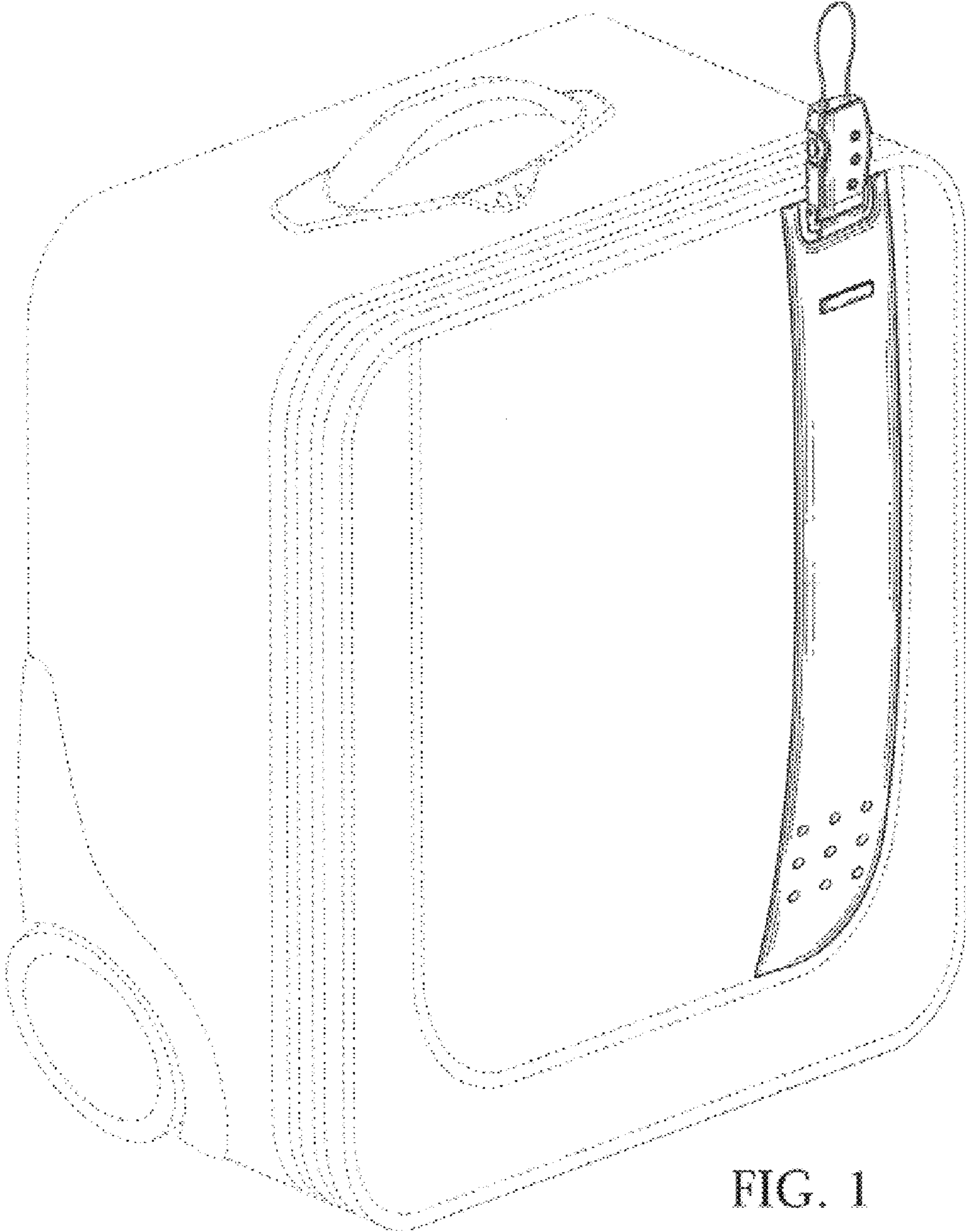

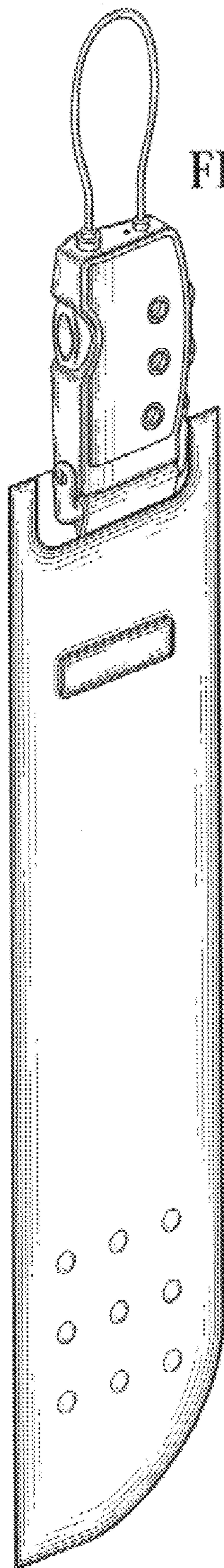

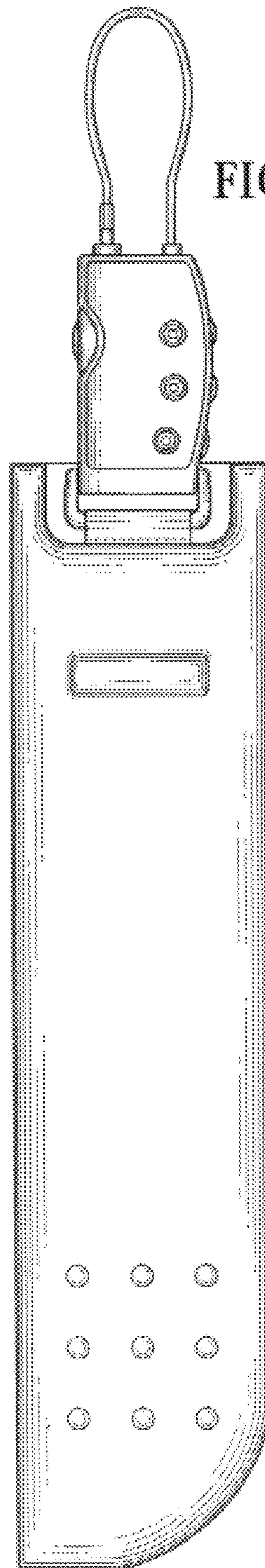

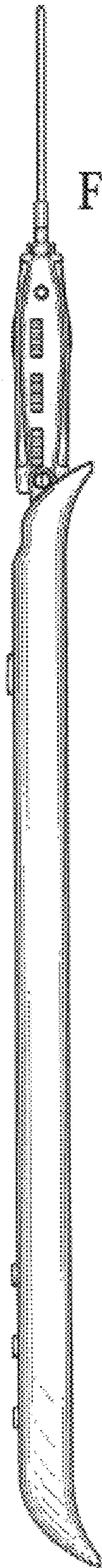

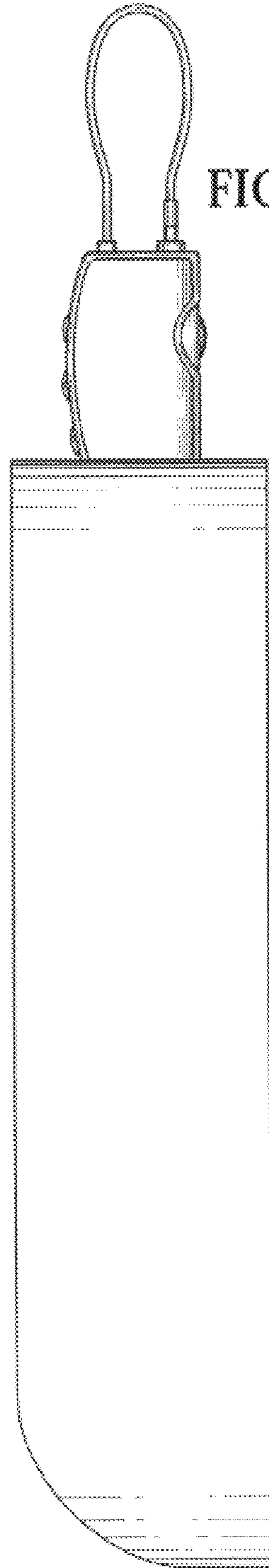

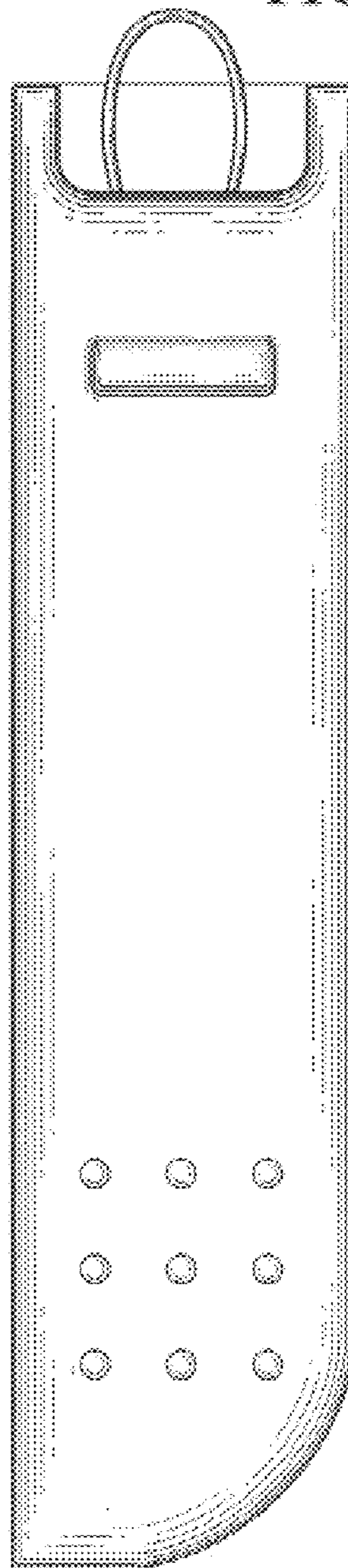

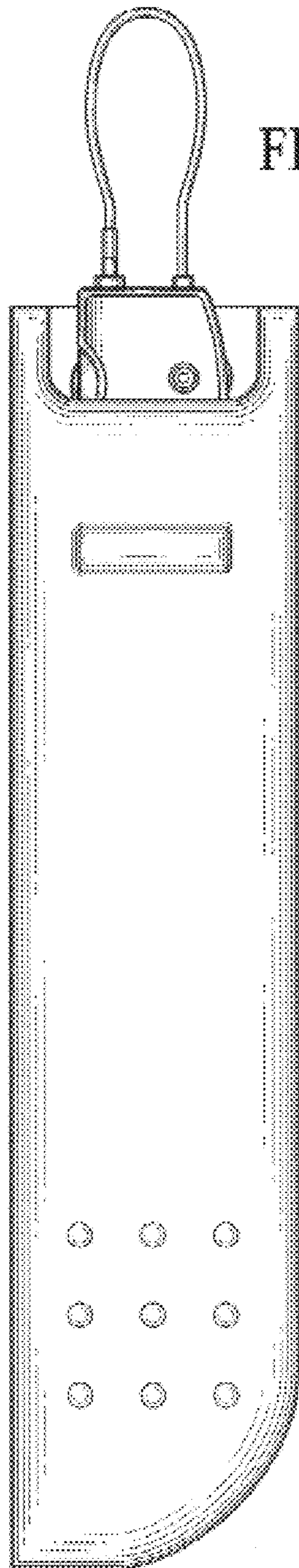

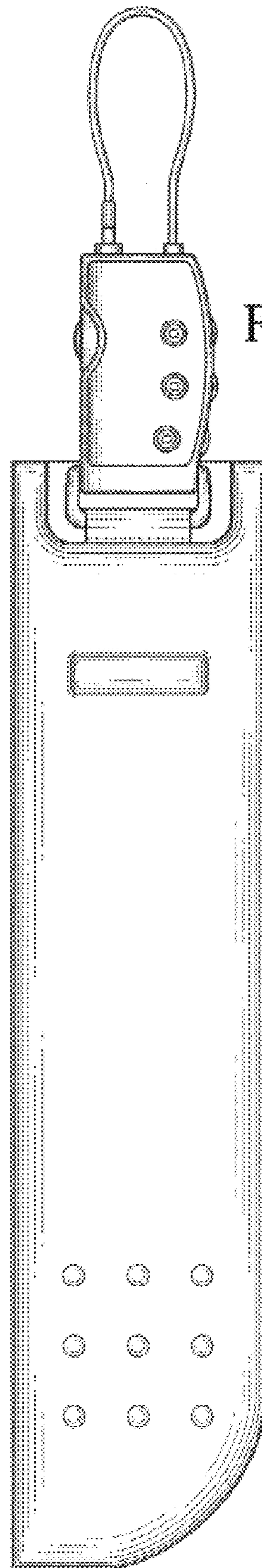

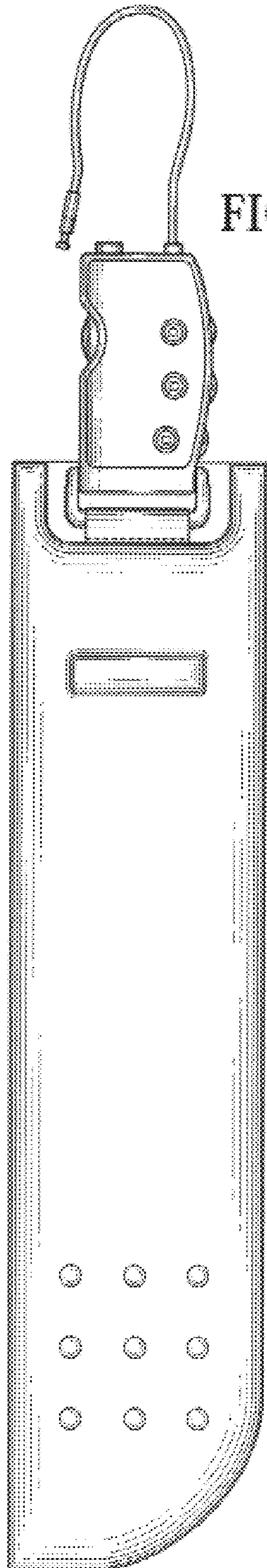
