FIG. 7 is a view of the embodiment depicted in FIG. 1 with the cap open and the top of the tube exposed.

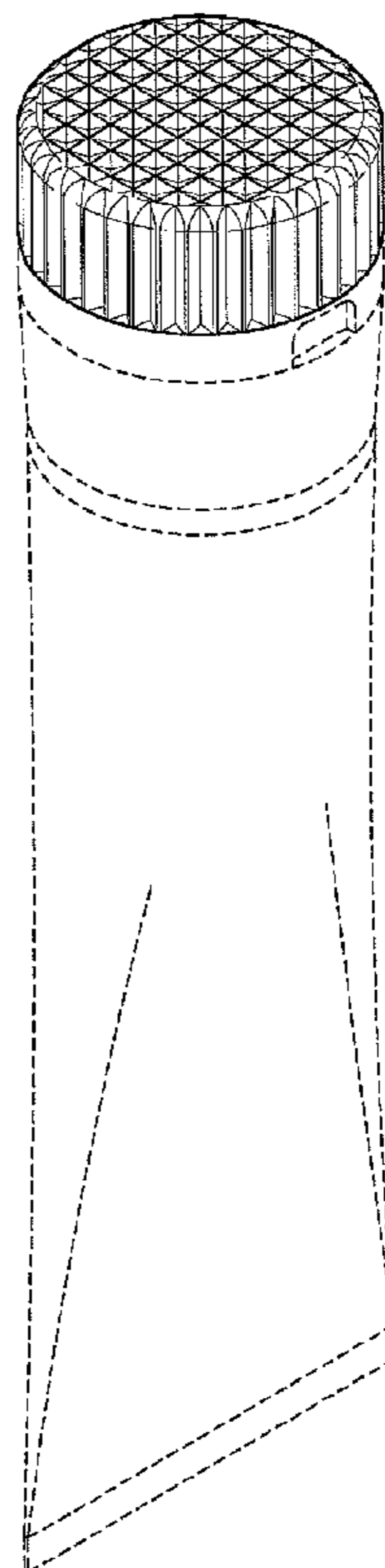
Shown in phantom lines are portions of the exterior of the tube, portions of the top surface of the tube, and portions of the underside of the cap which form no part of the claimed designs.

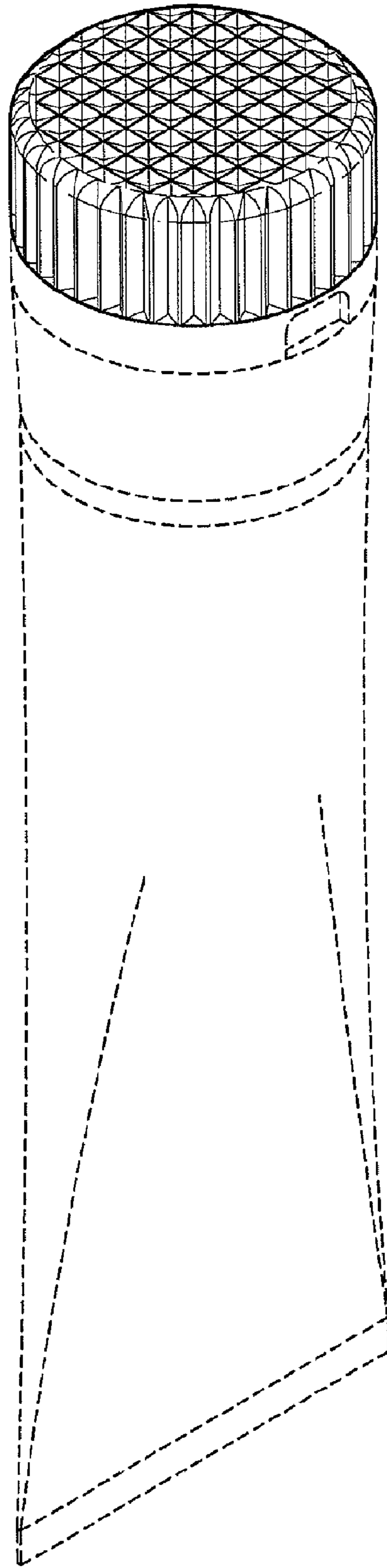

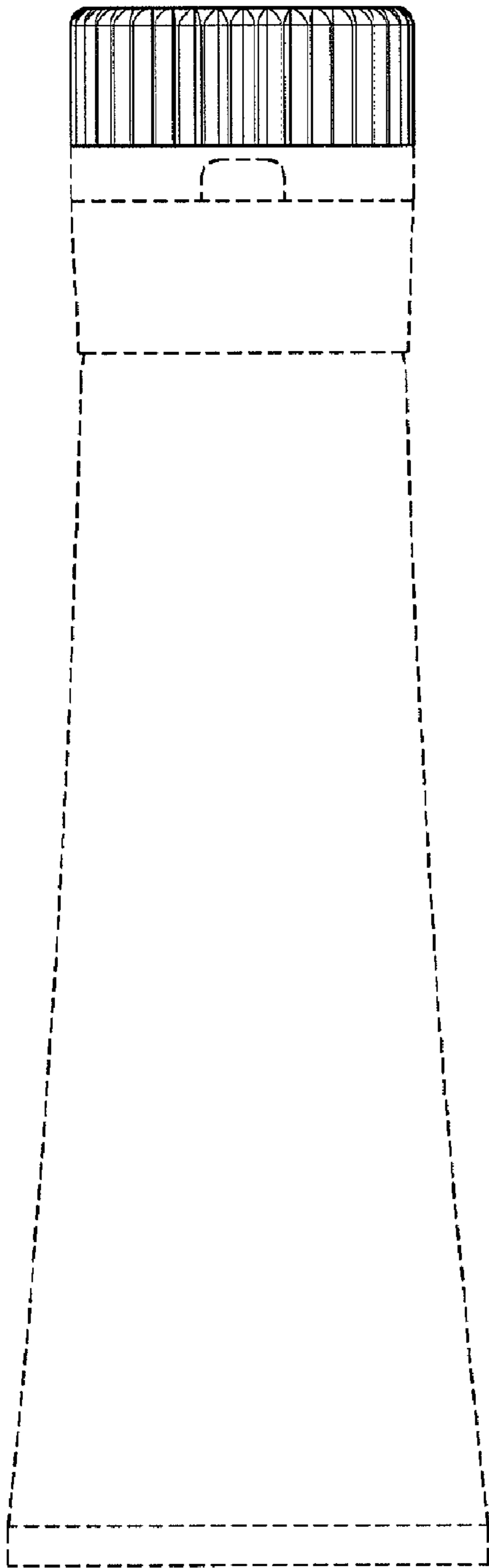

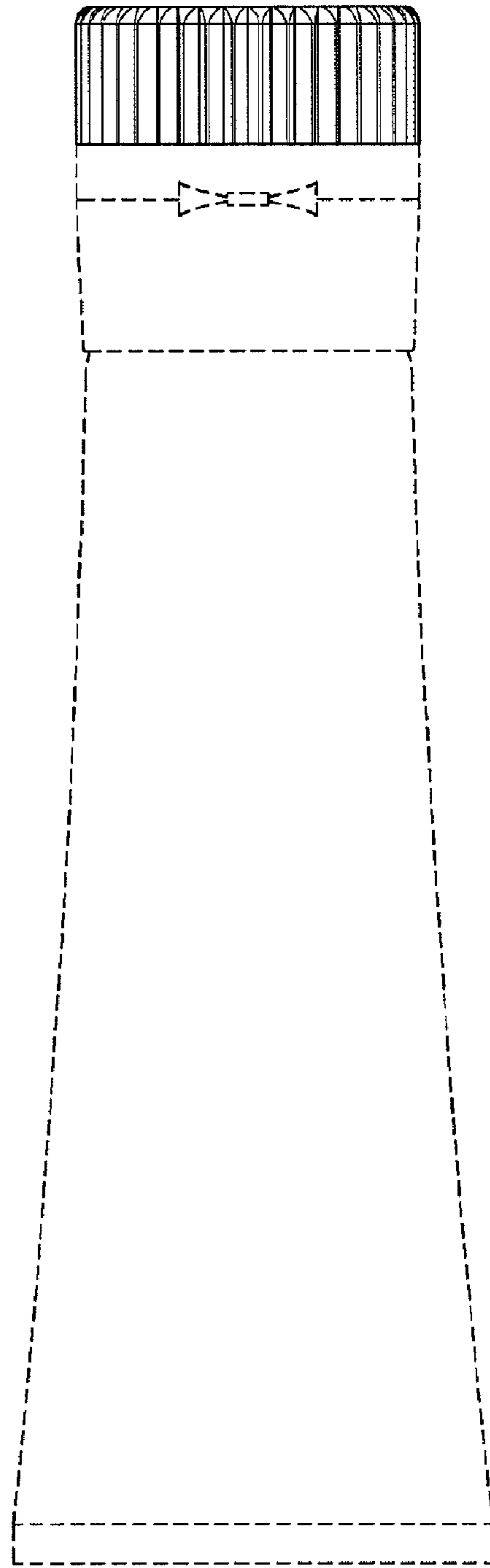

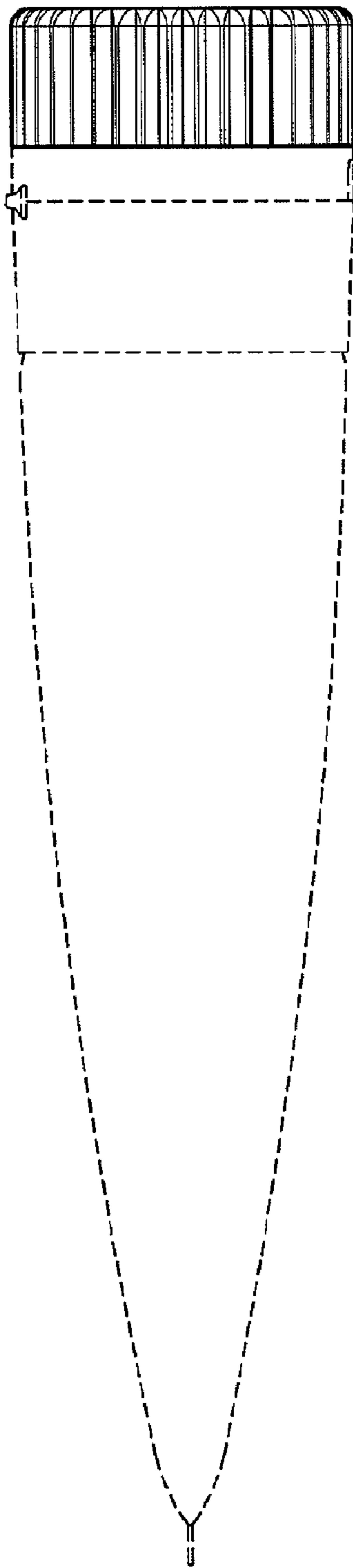

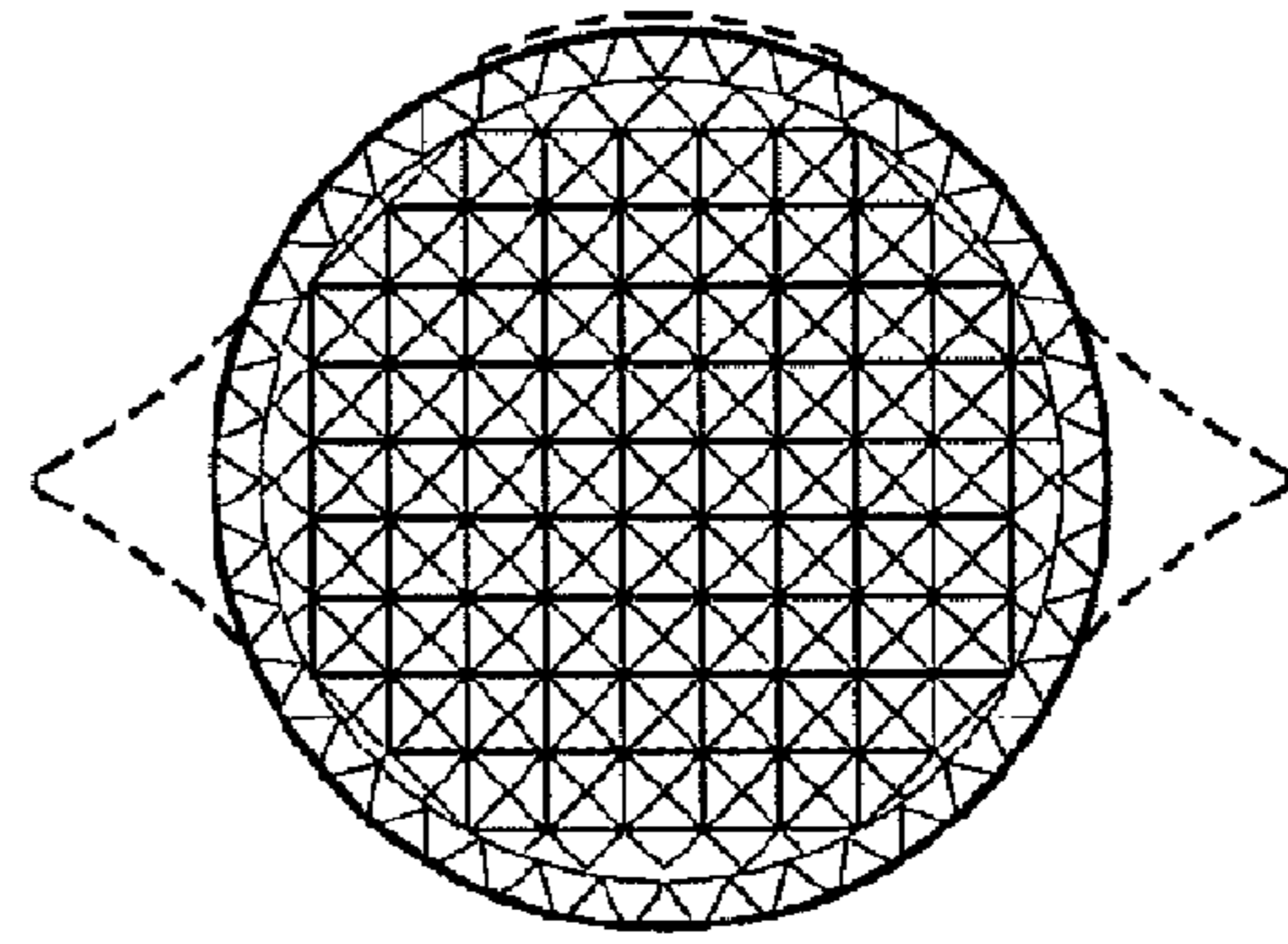

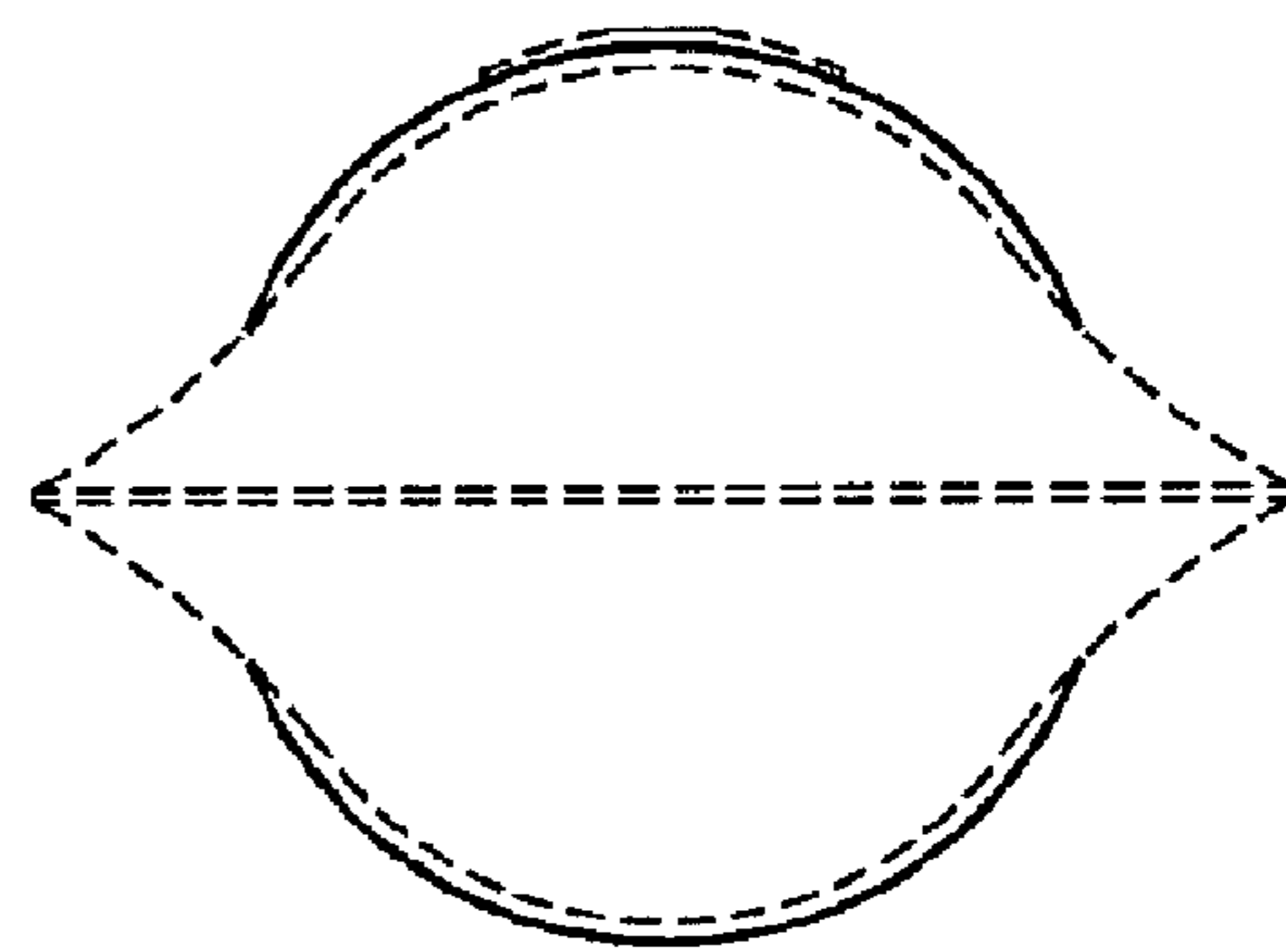

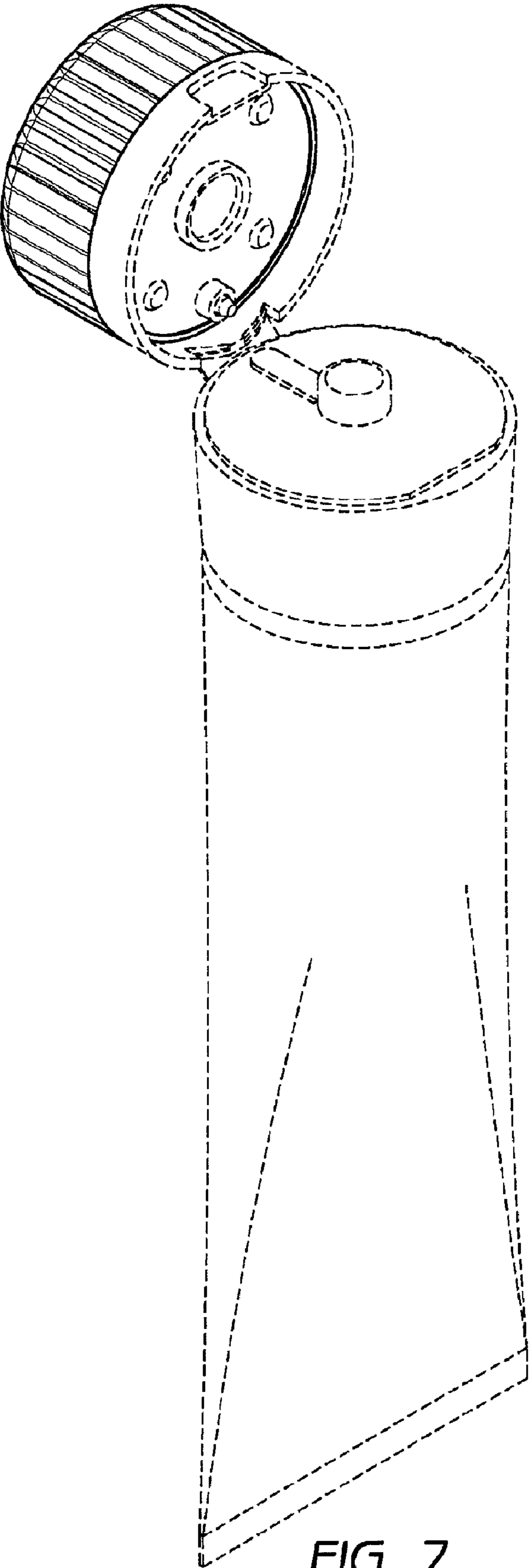
