FIG. 6 is a top plan view thereof.

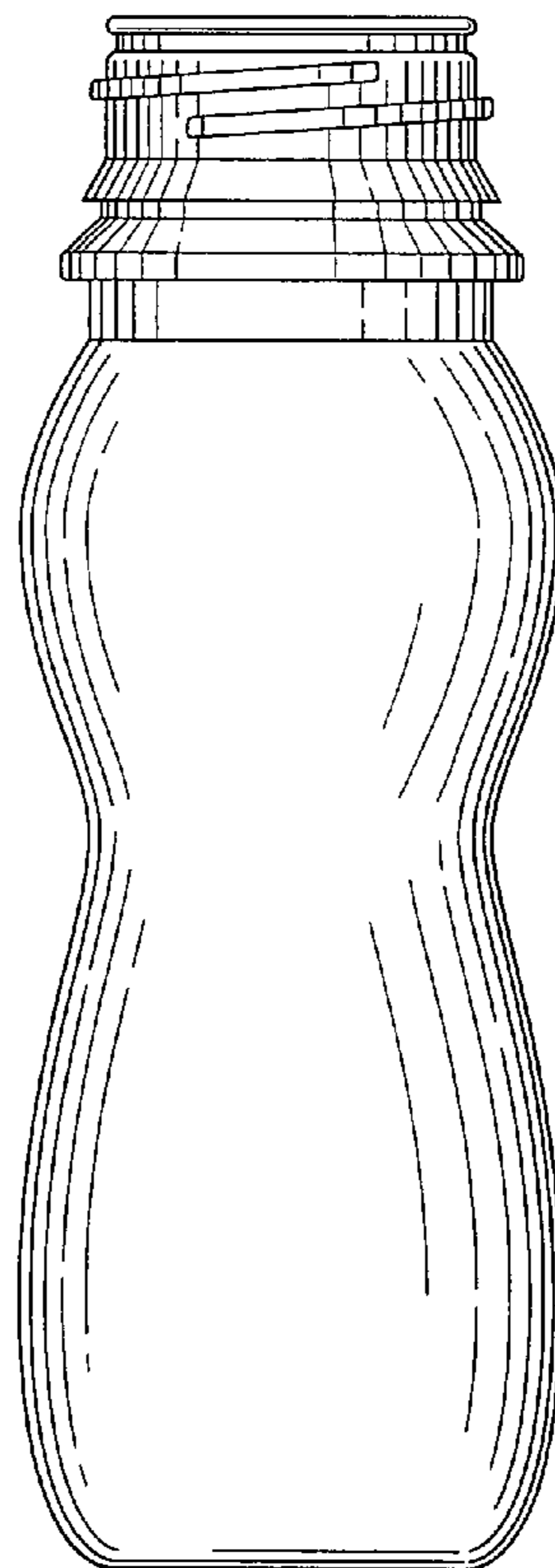
The bottom view of the bottle without cap forms no part of the claimed design.

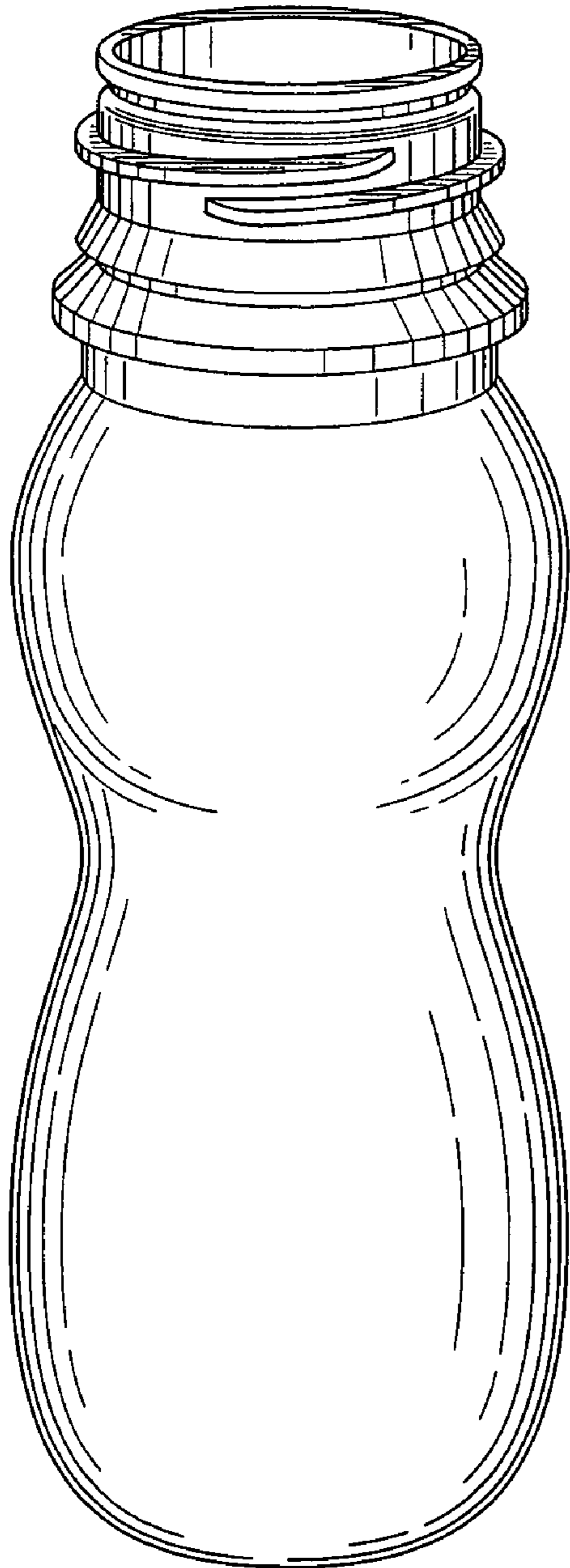

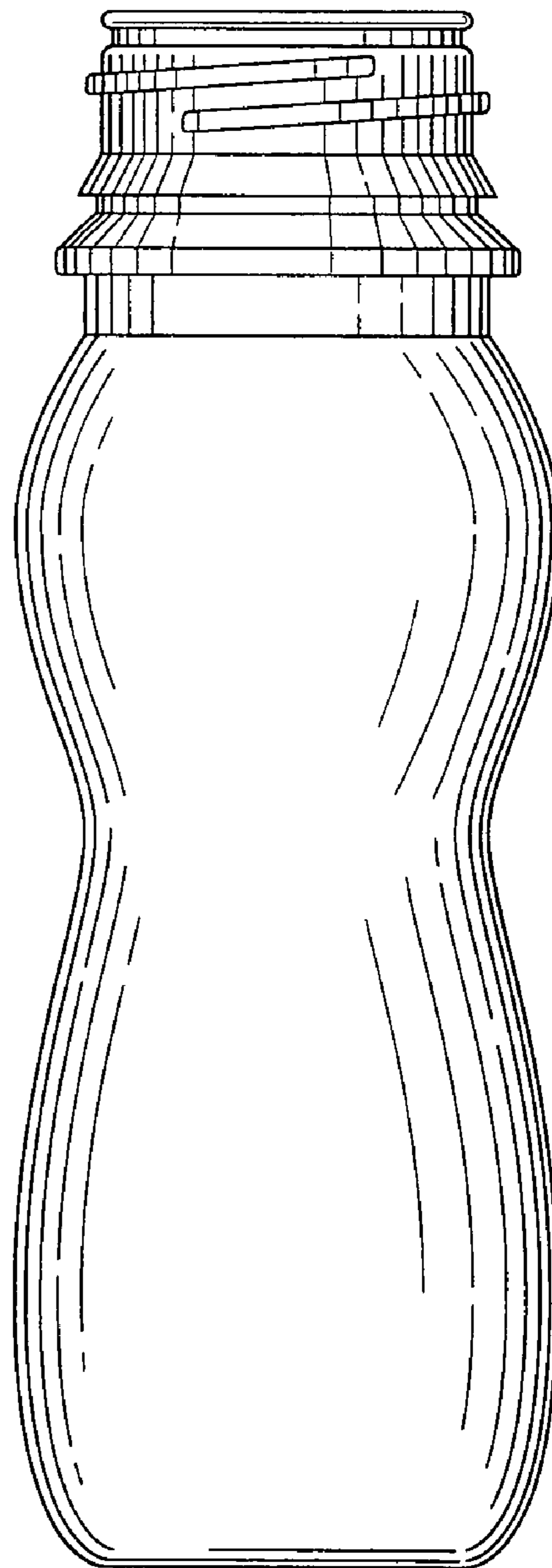

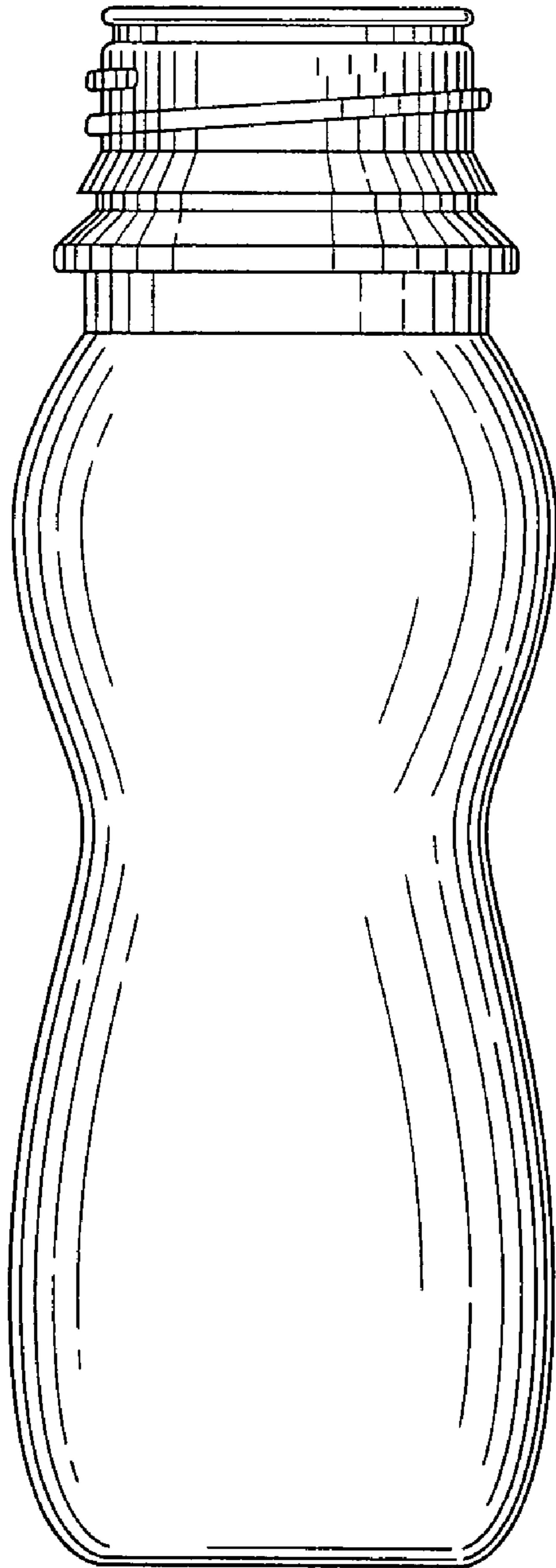

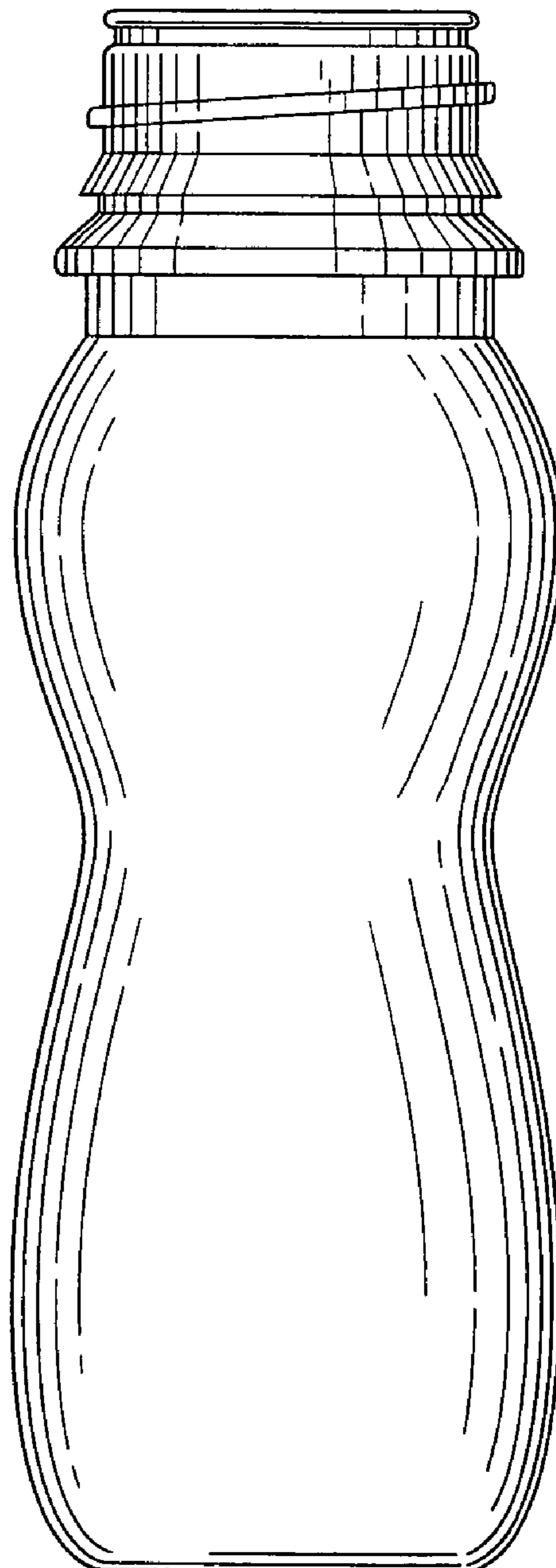

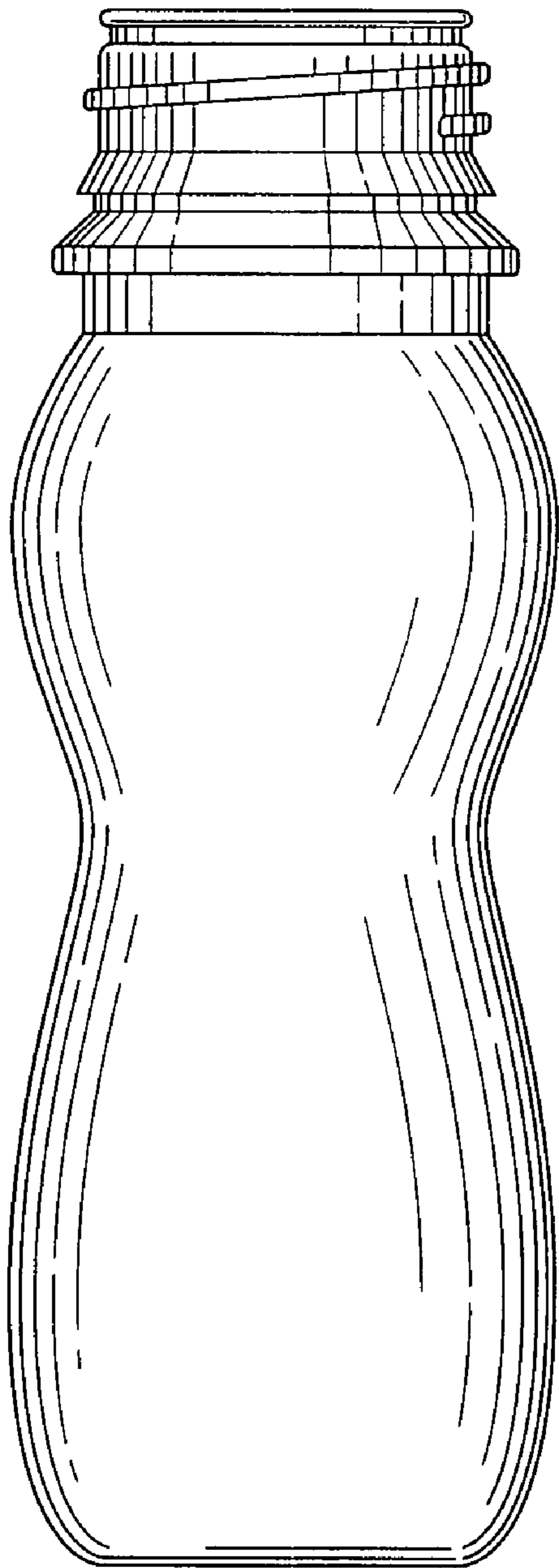
