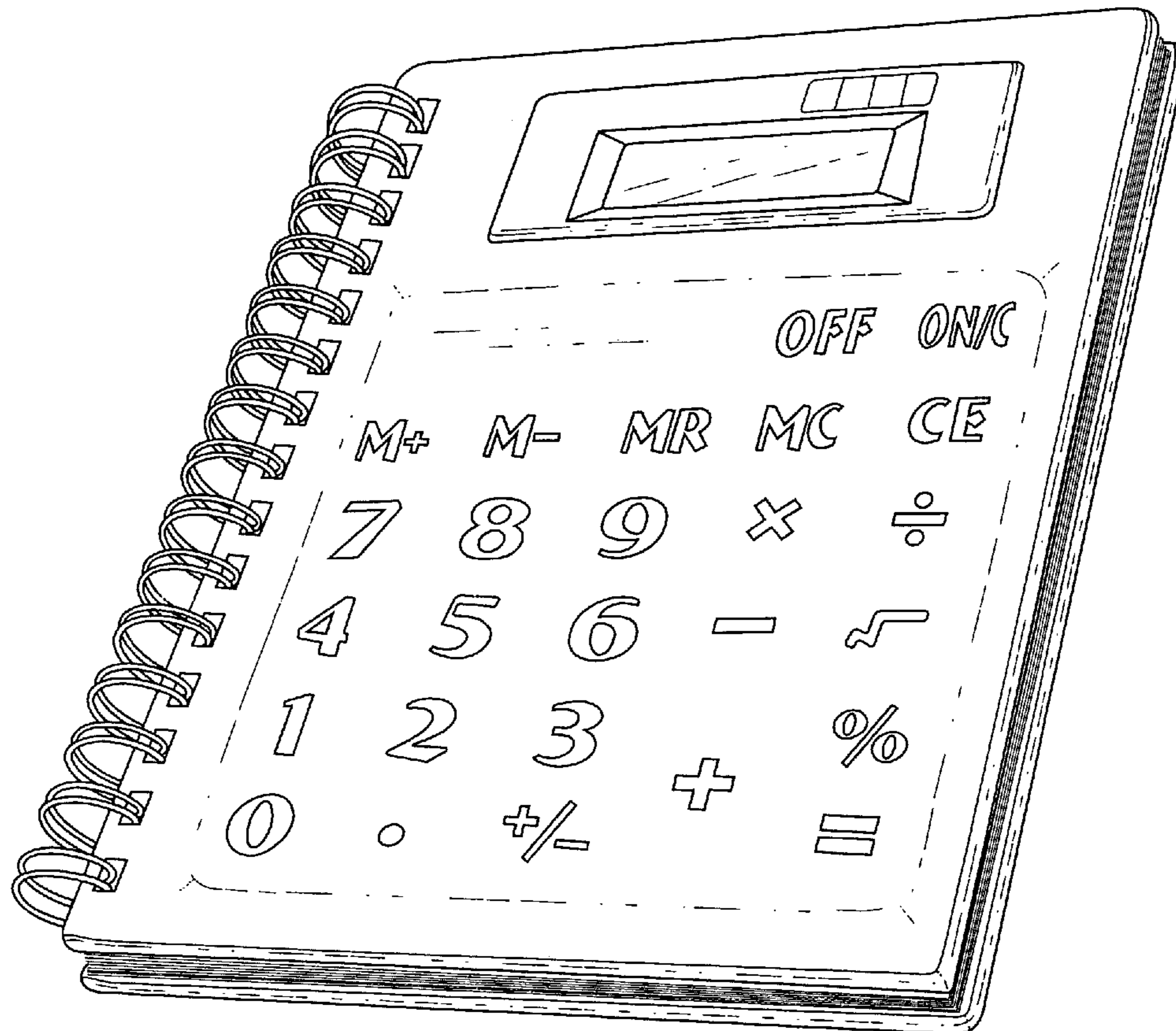

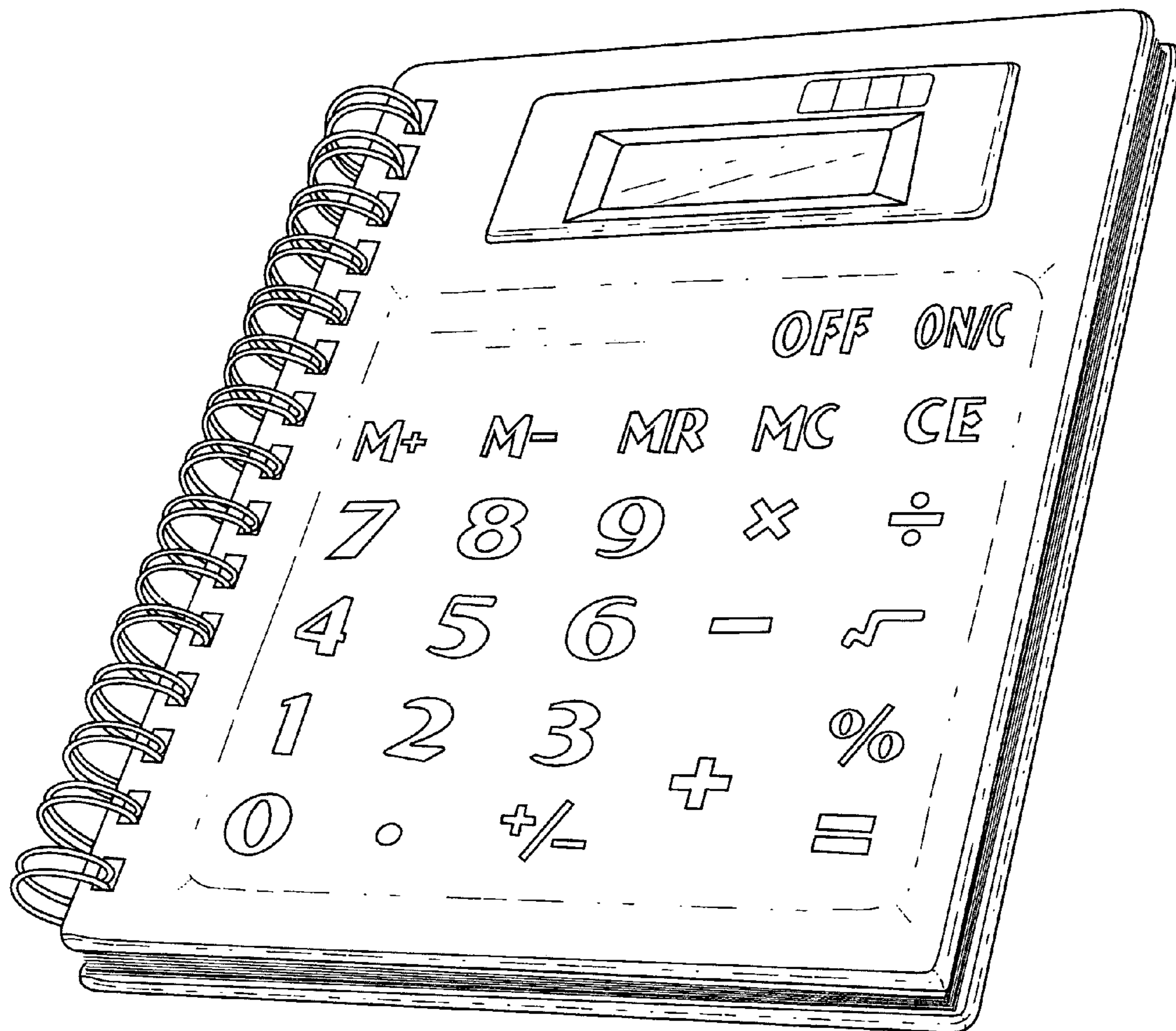
The ornamental design for a calculator notebook, as shown and described.

**DESCRIPTION**

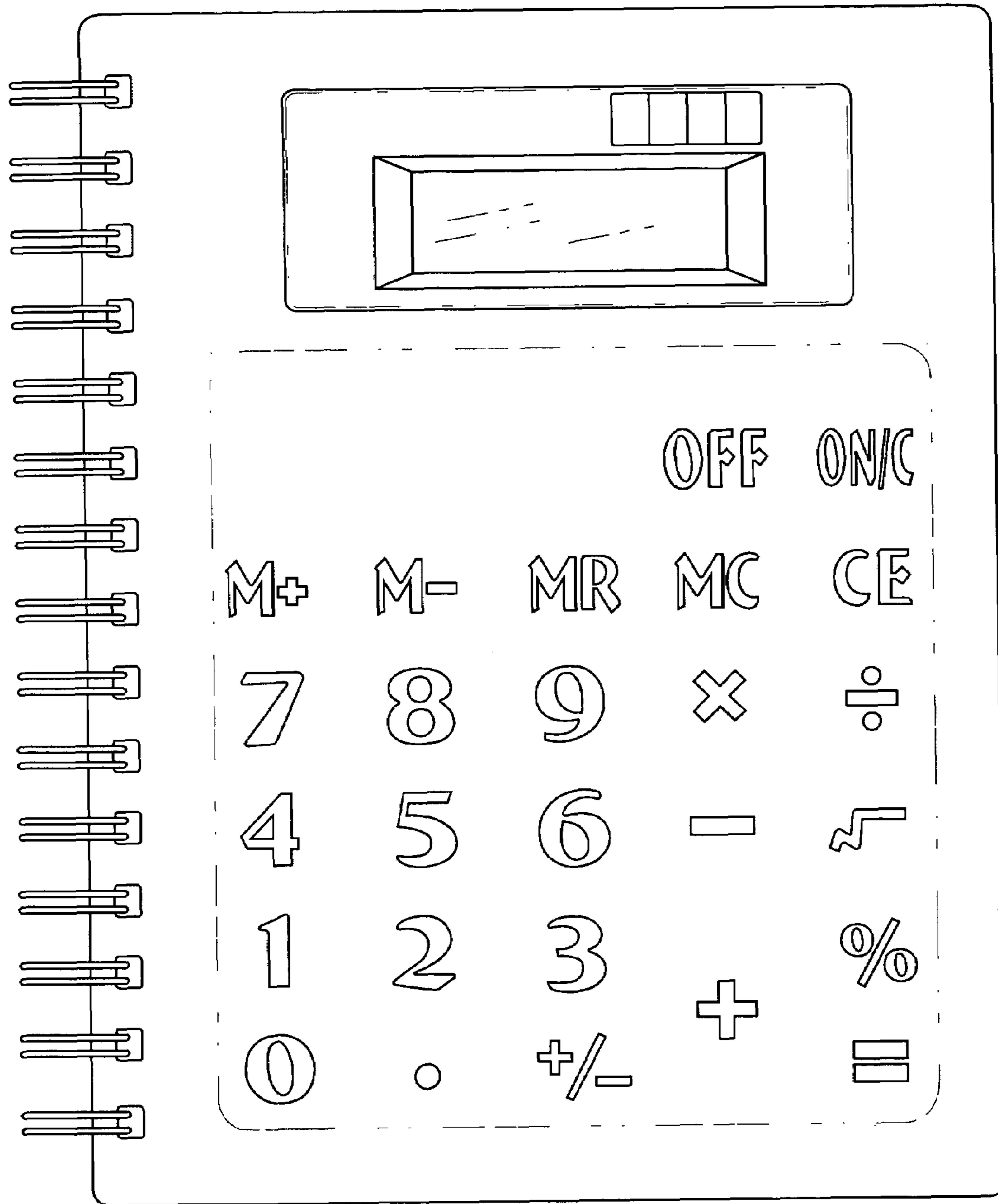
FIG. 1 is a perspective view of a calculator notebook;

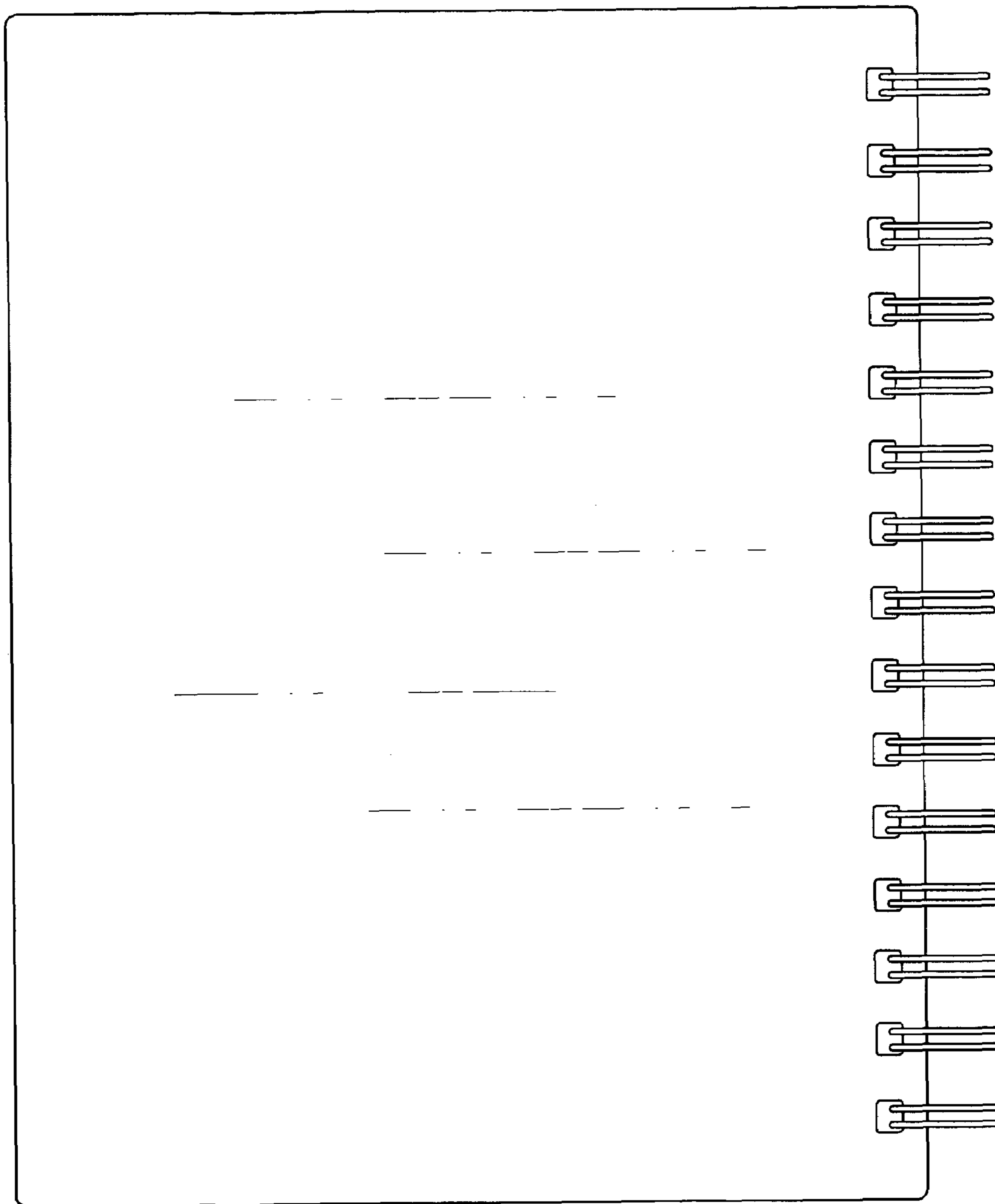




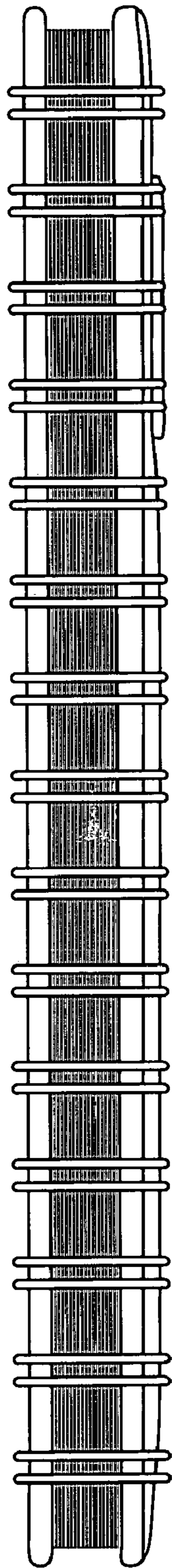

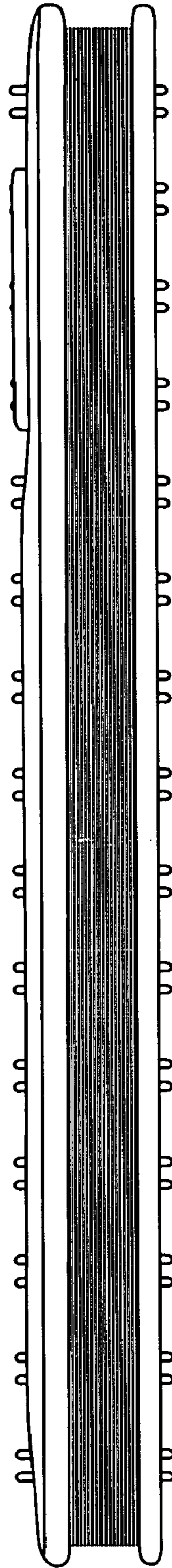

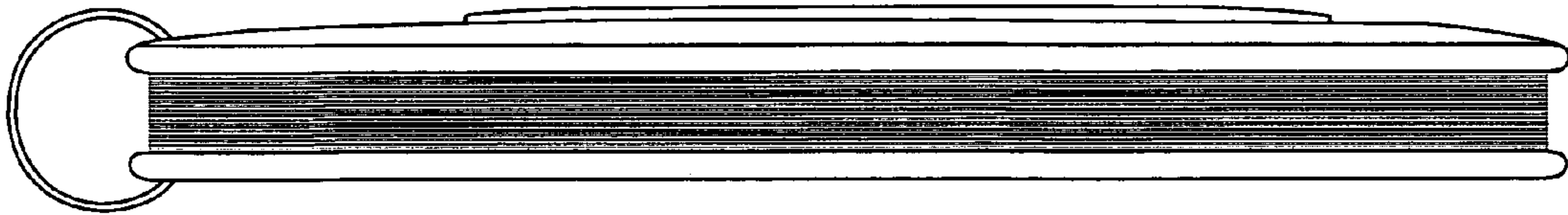

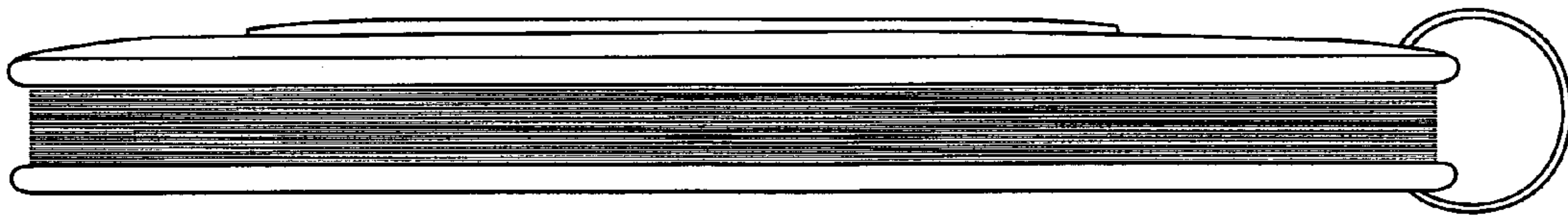
