(57) **CLAIM**

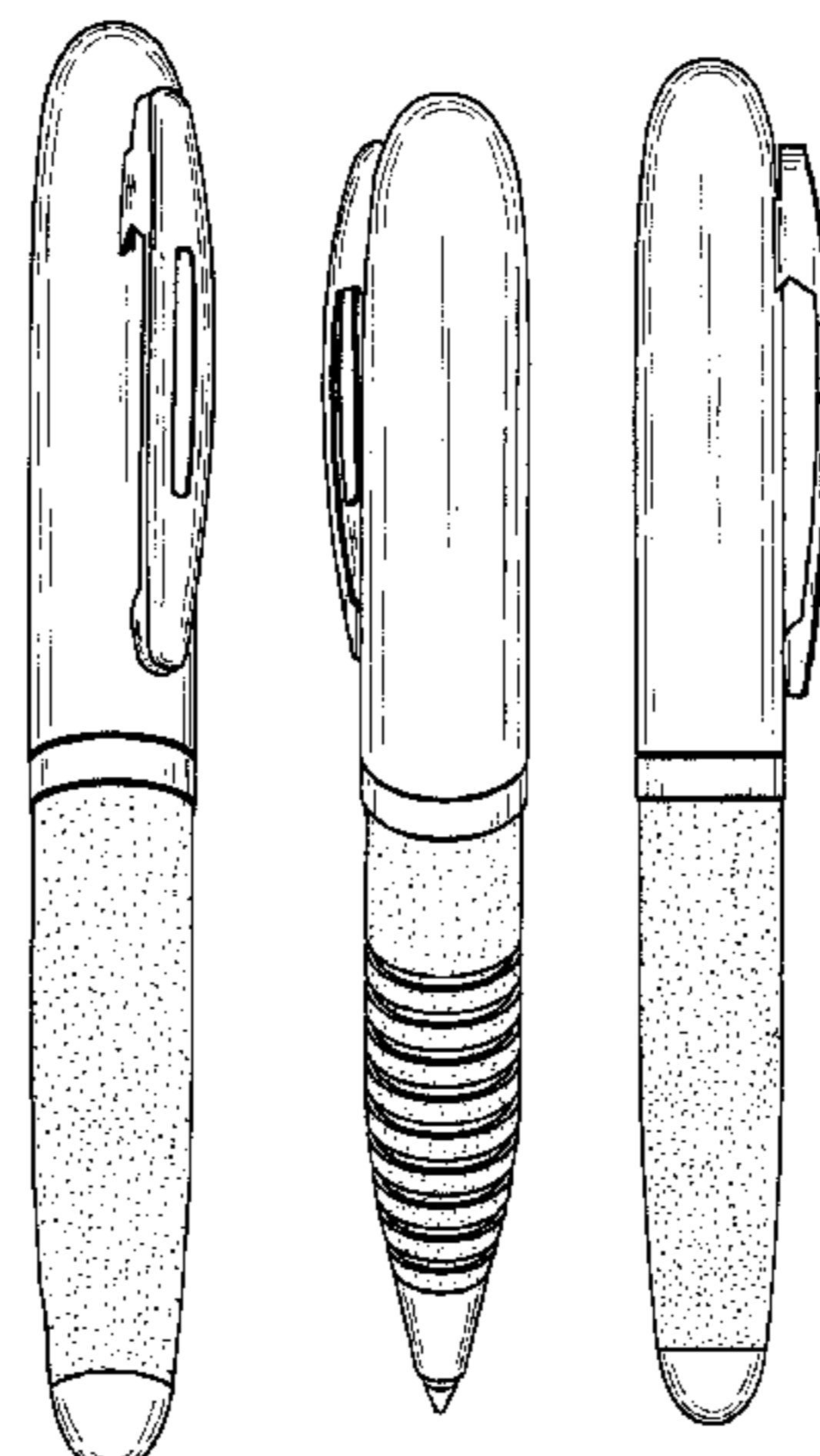
The ornamental design for a pen, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a pen showing our new design;
 FIG. 2 is rear right perspective view of the pen shown in FIG. 1 with the pen cap removed and placed on the opposite end of the pen;
 FIG. 3 left side elevation view of the pen shown in FIG. 1;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a front elevation view thereof;
 FIG. 6 is a right side elevation view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a rear elevation view thereof; and,
 FIG. 9 is an exploded front left perspective view thereof.
 The stippled shading shown on a portion of the pen in FIGS. 1–6, 8, and 9 represents a surface texture.

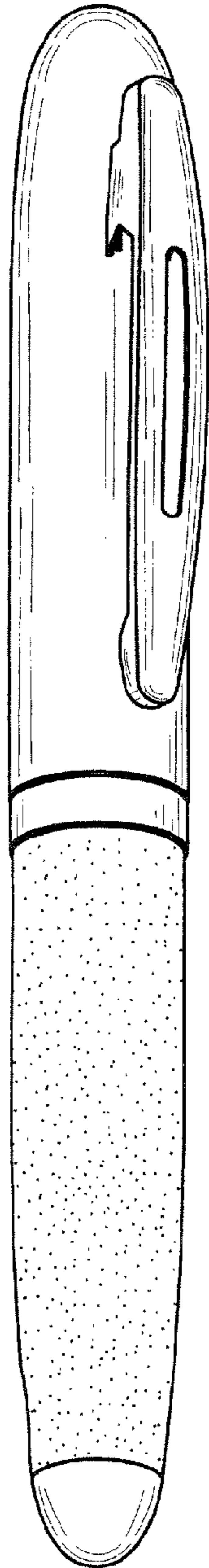

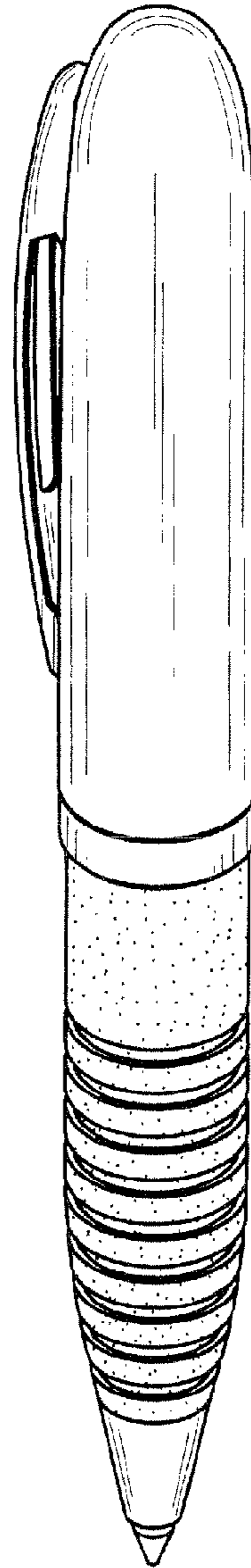

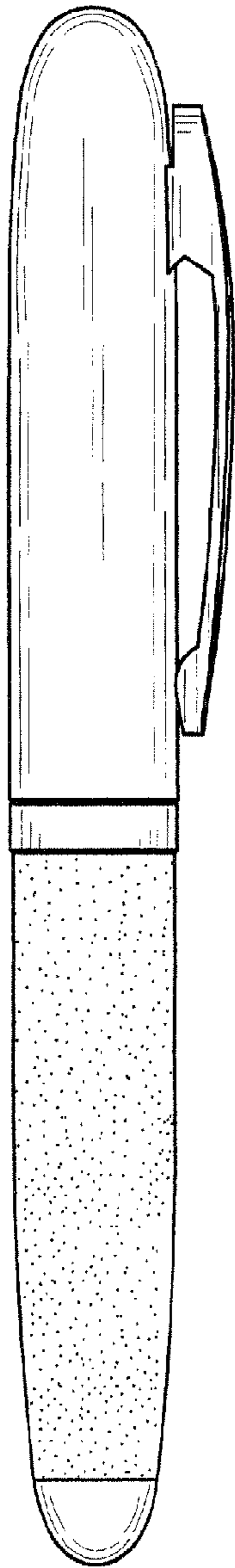

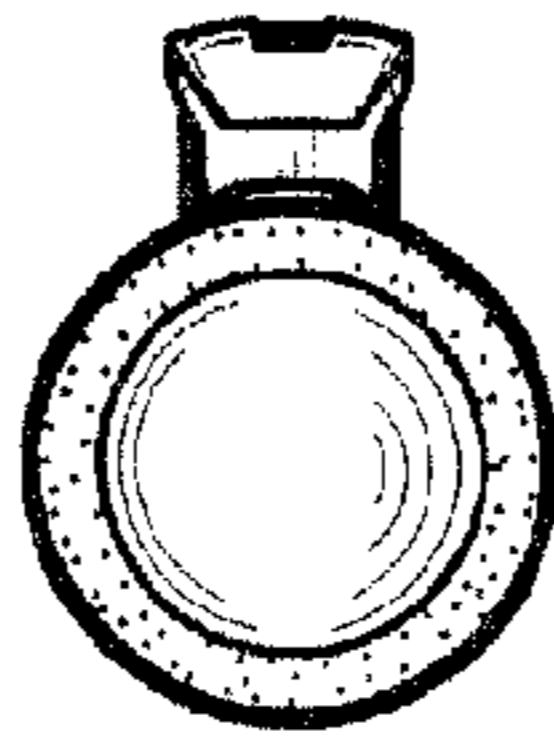
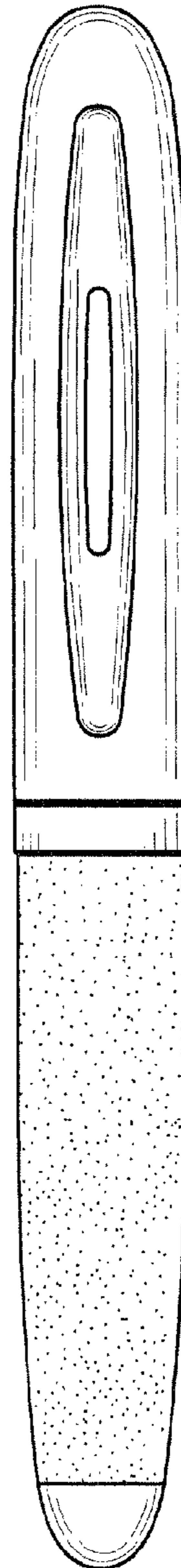

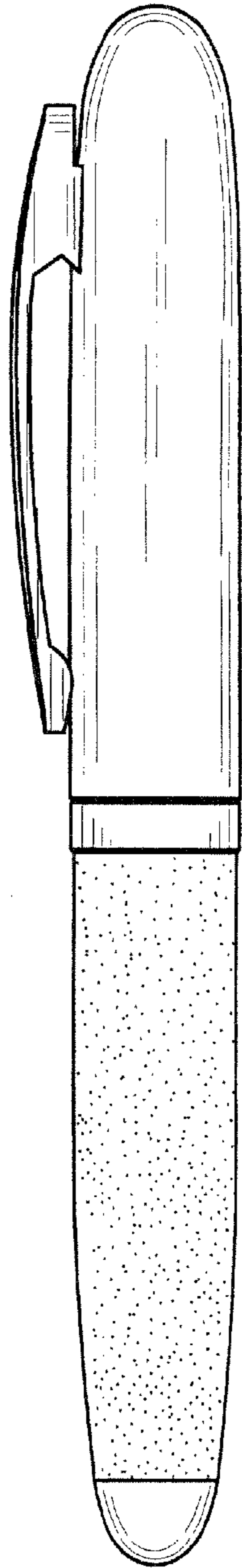

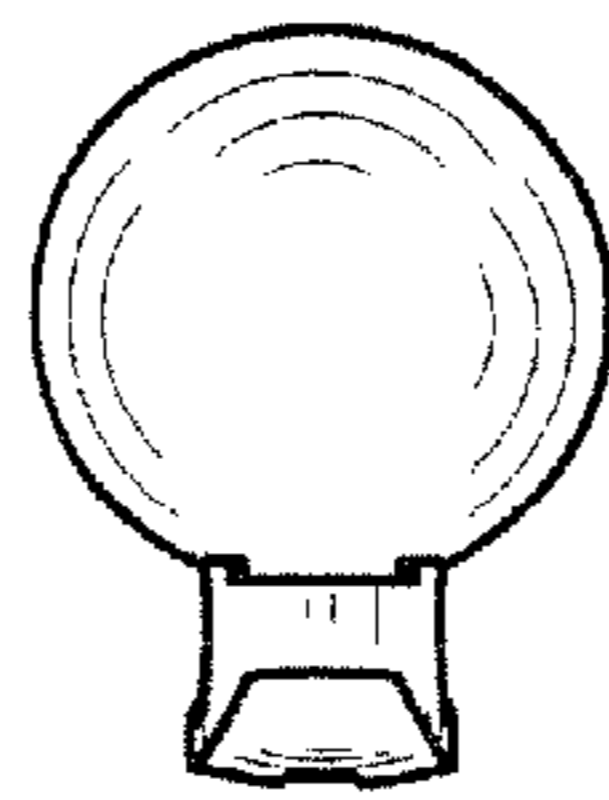

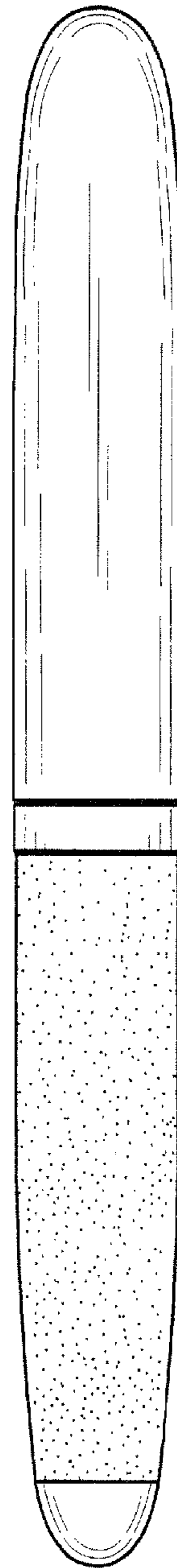

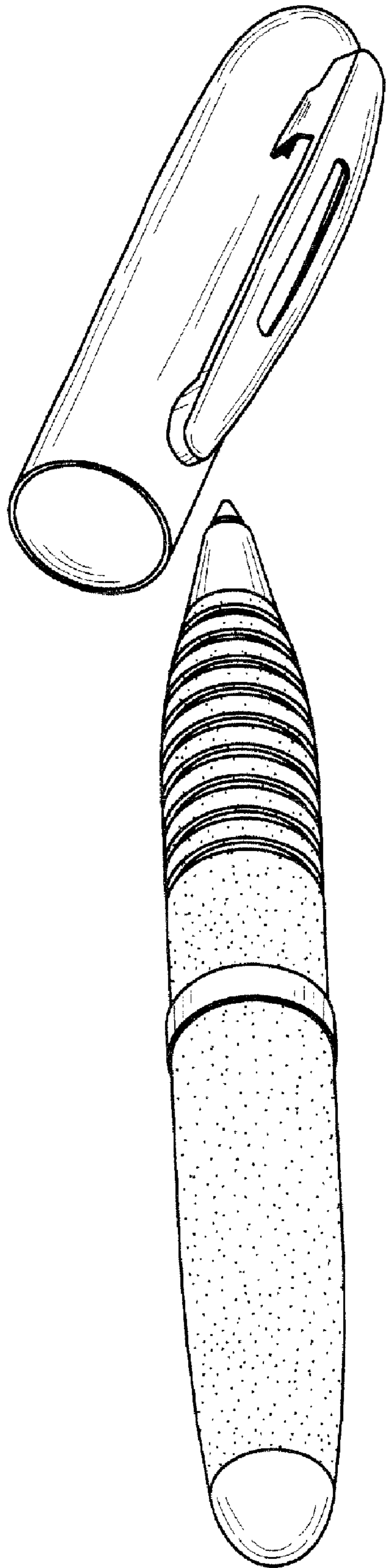
