The ornamental design for a light fixture, substantially as shown and described.

**DESCRIPTION**

FIG. 9 is a right side view thereof;

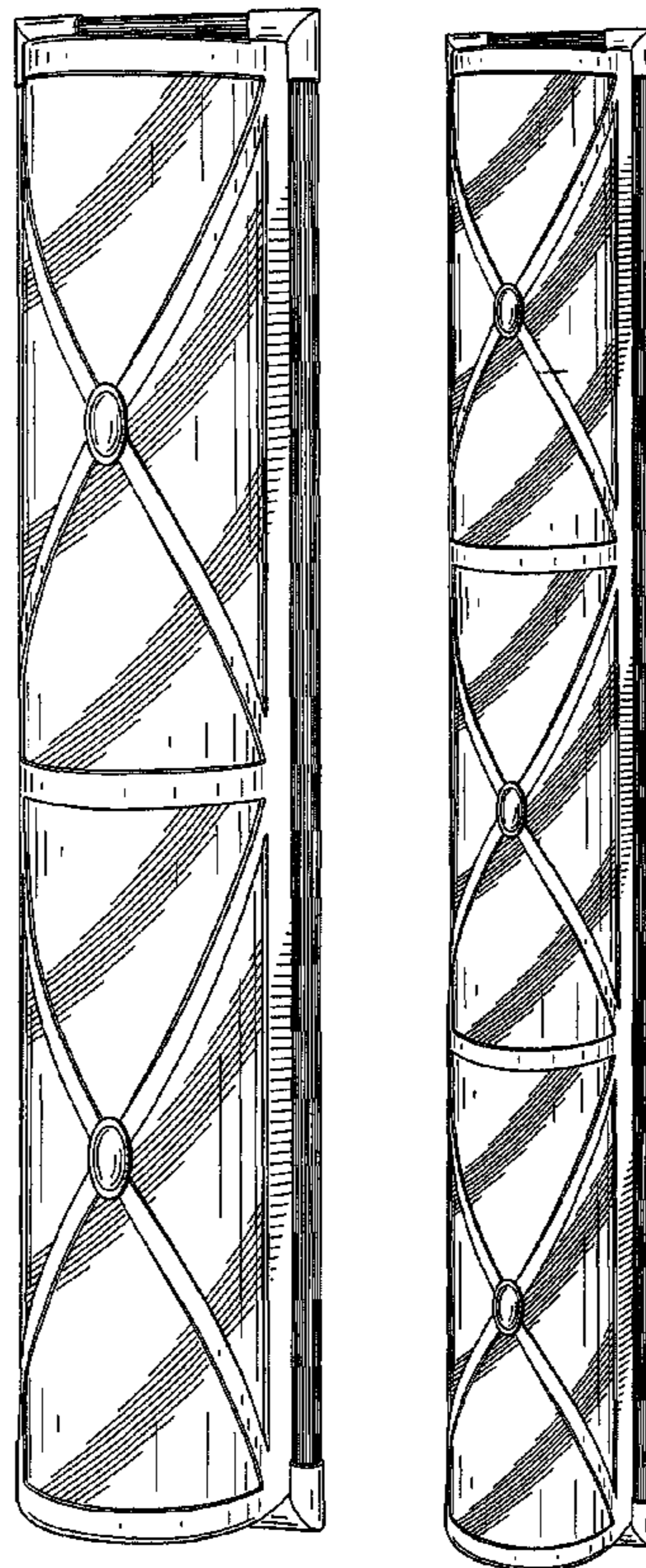
FIG. 10 is a left side view thereof;

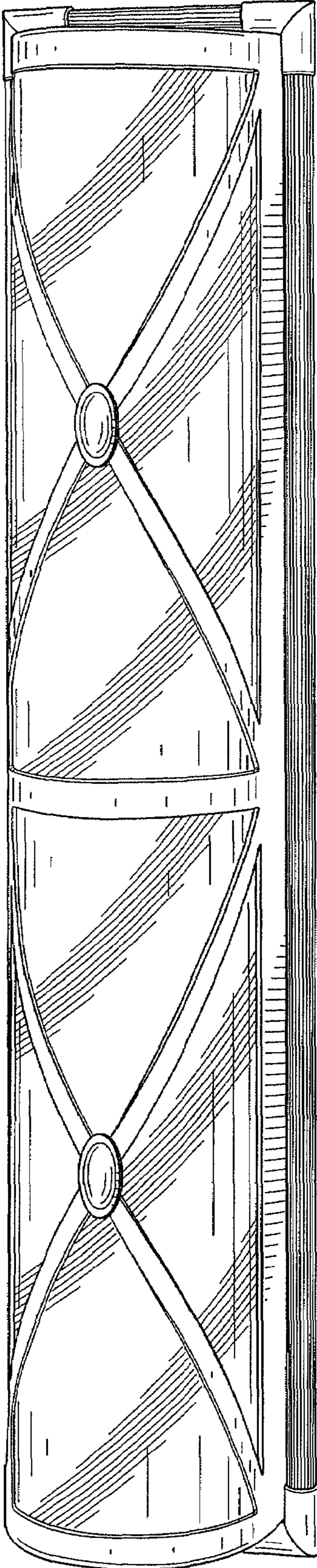

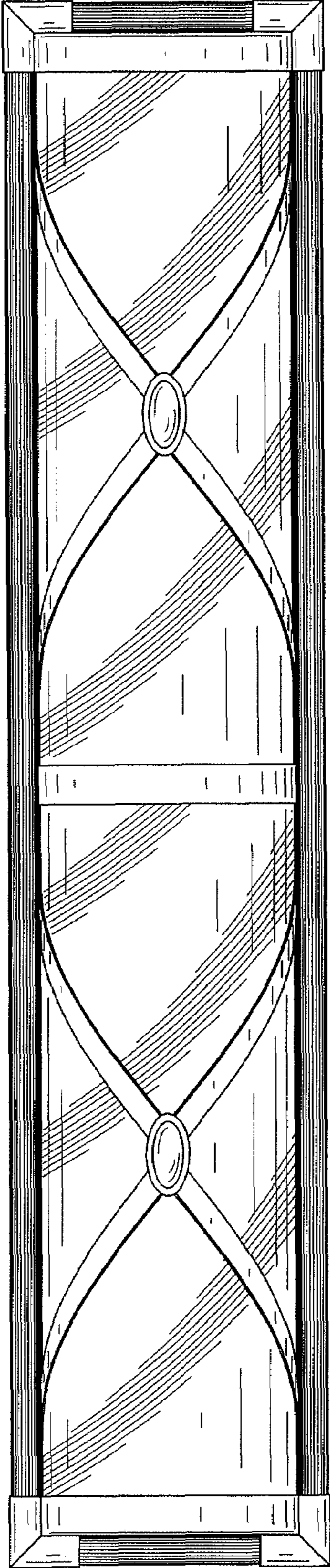

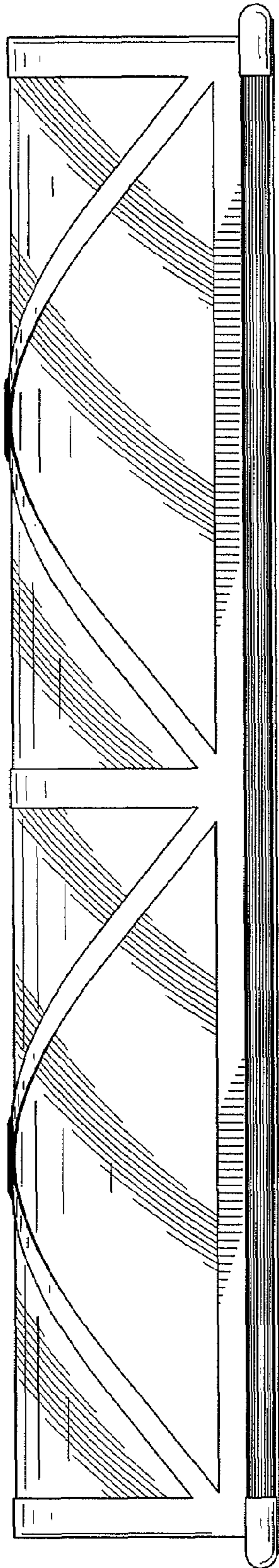

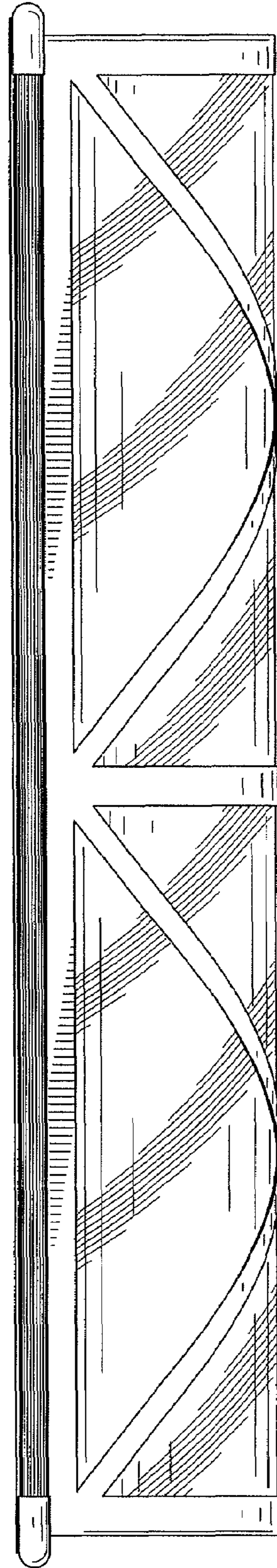
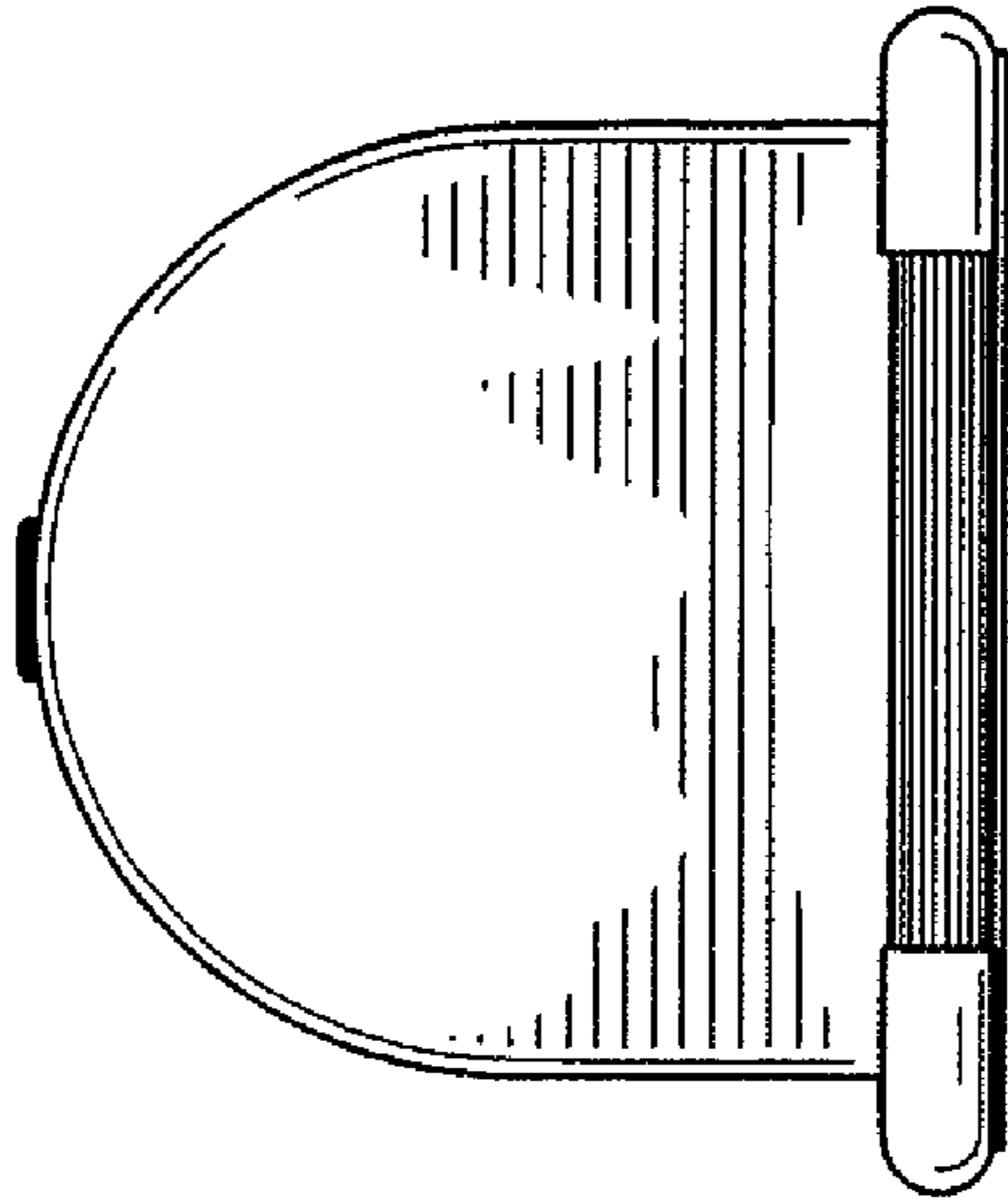
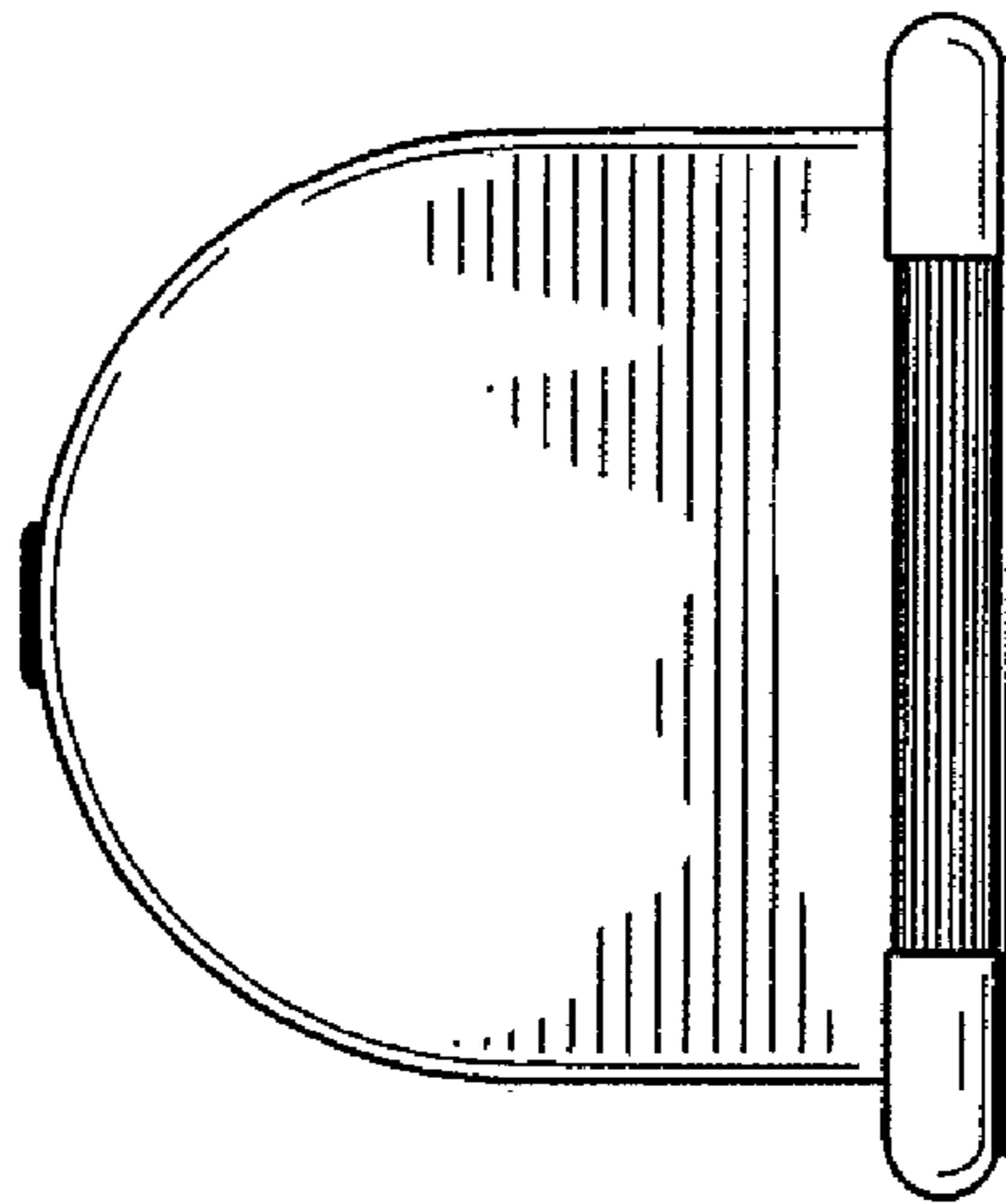

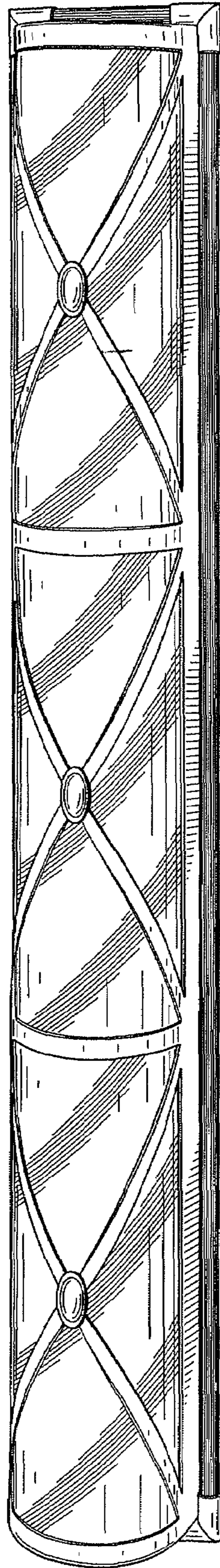

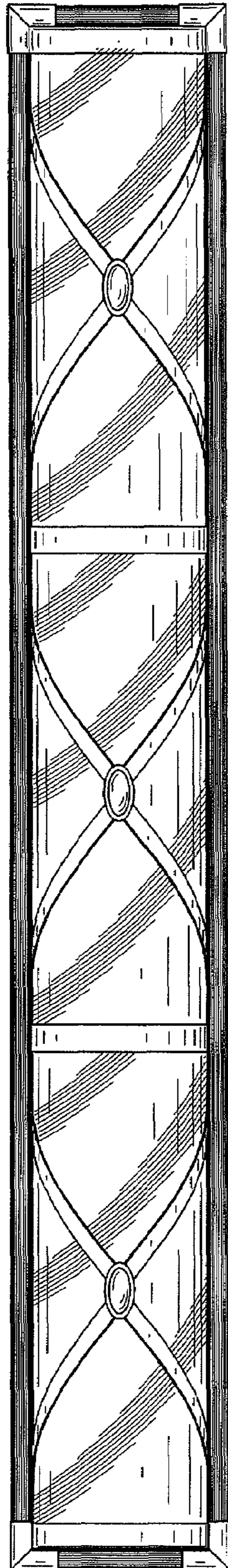

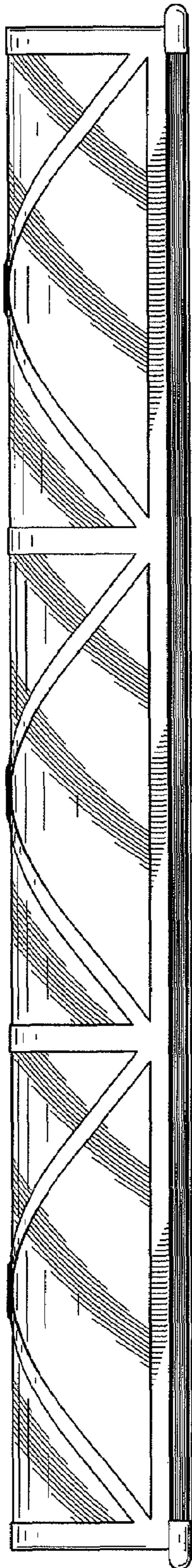

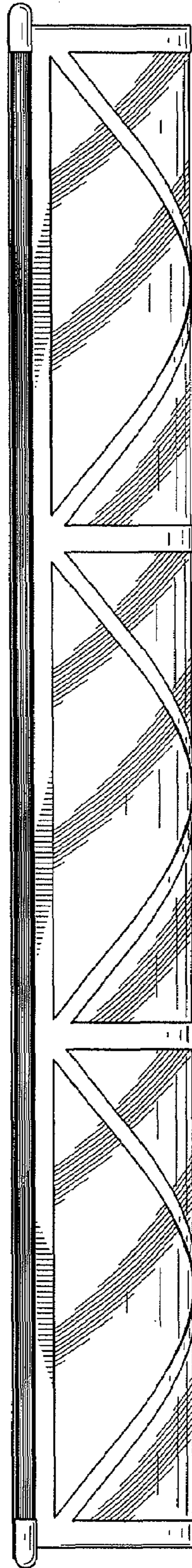
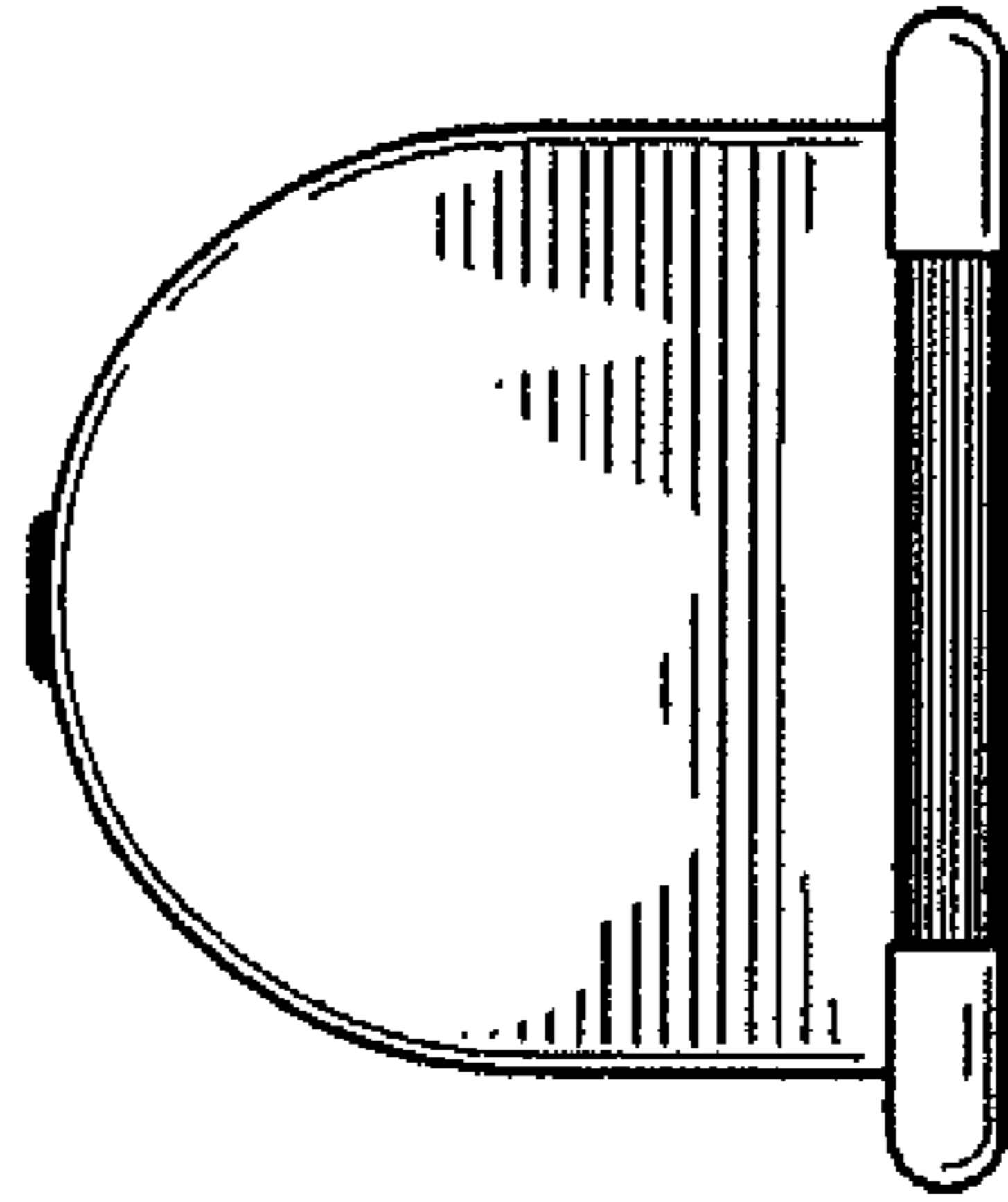
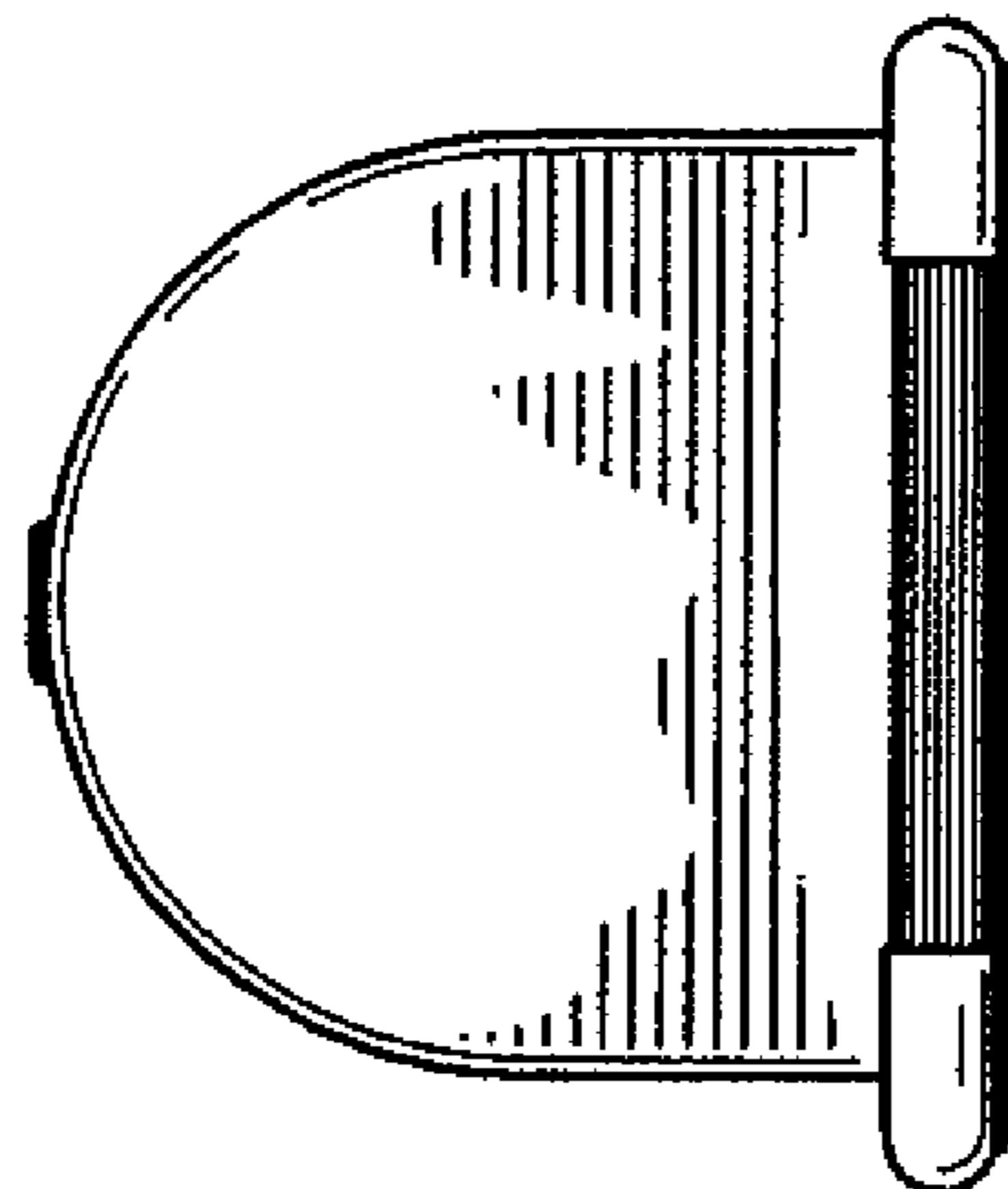
