FIG. 3 is a rear side elevation view thereof;

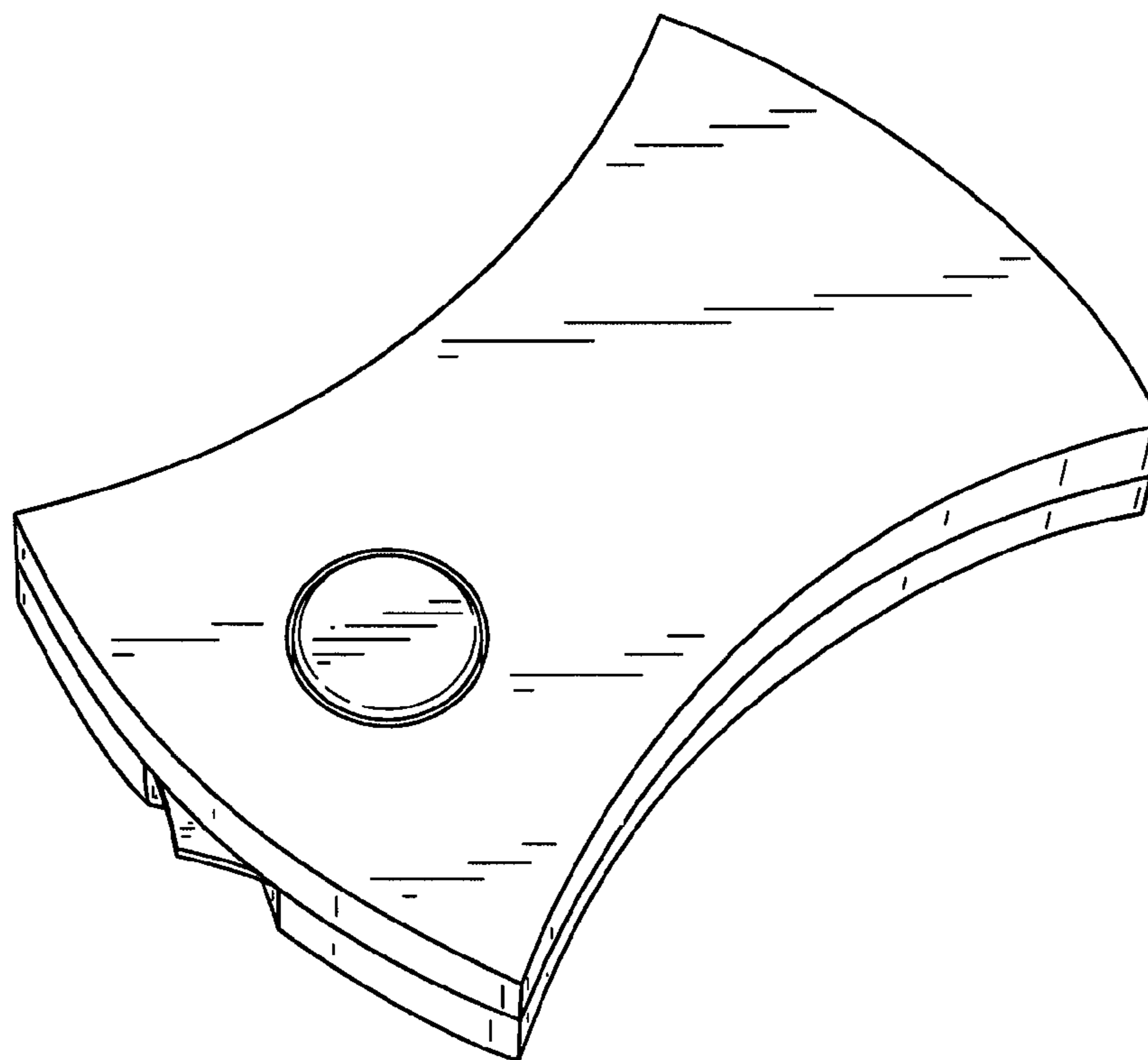
FIG. 4 is a right side elevation view thereof;

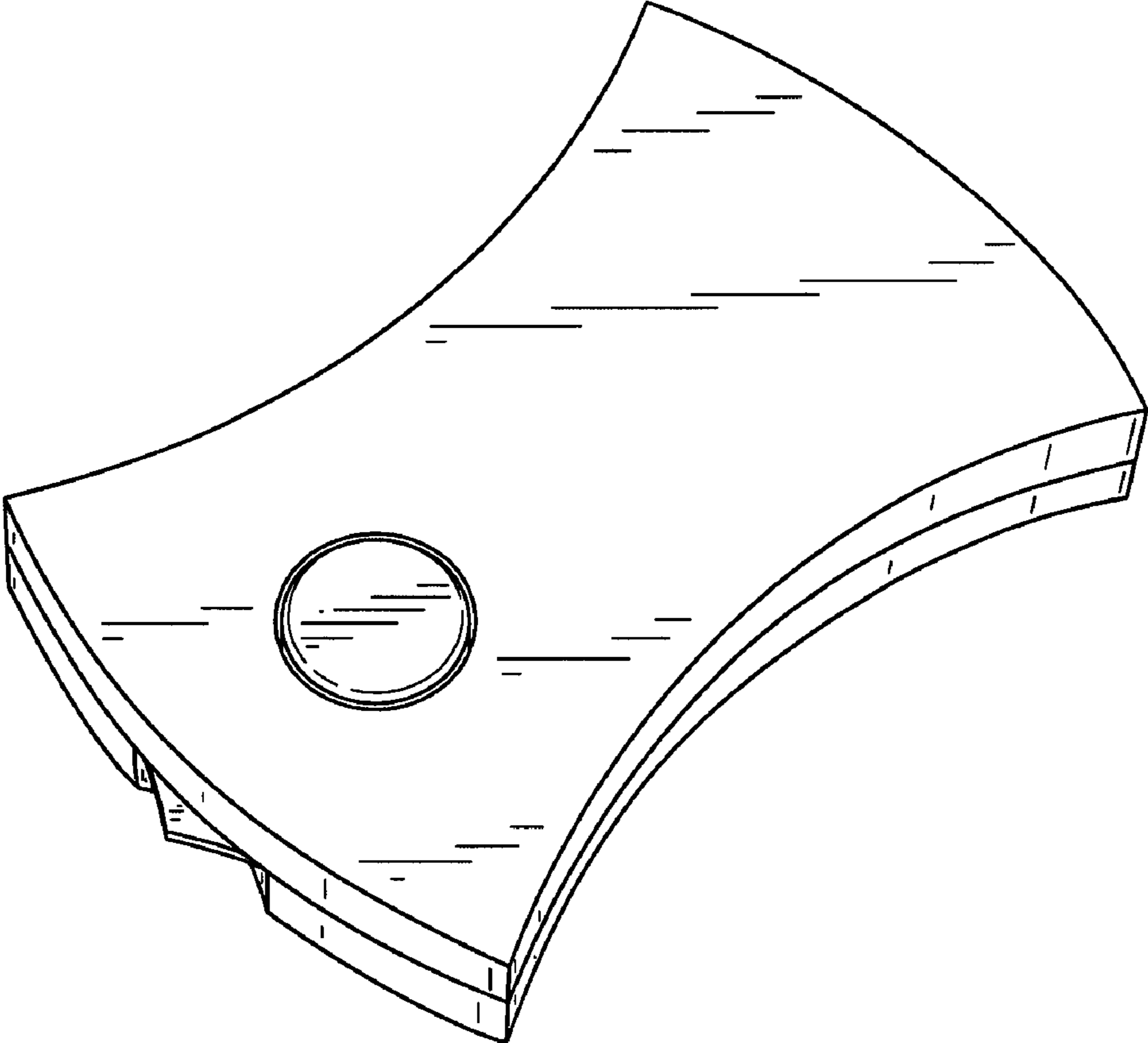

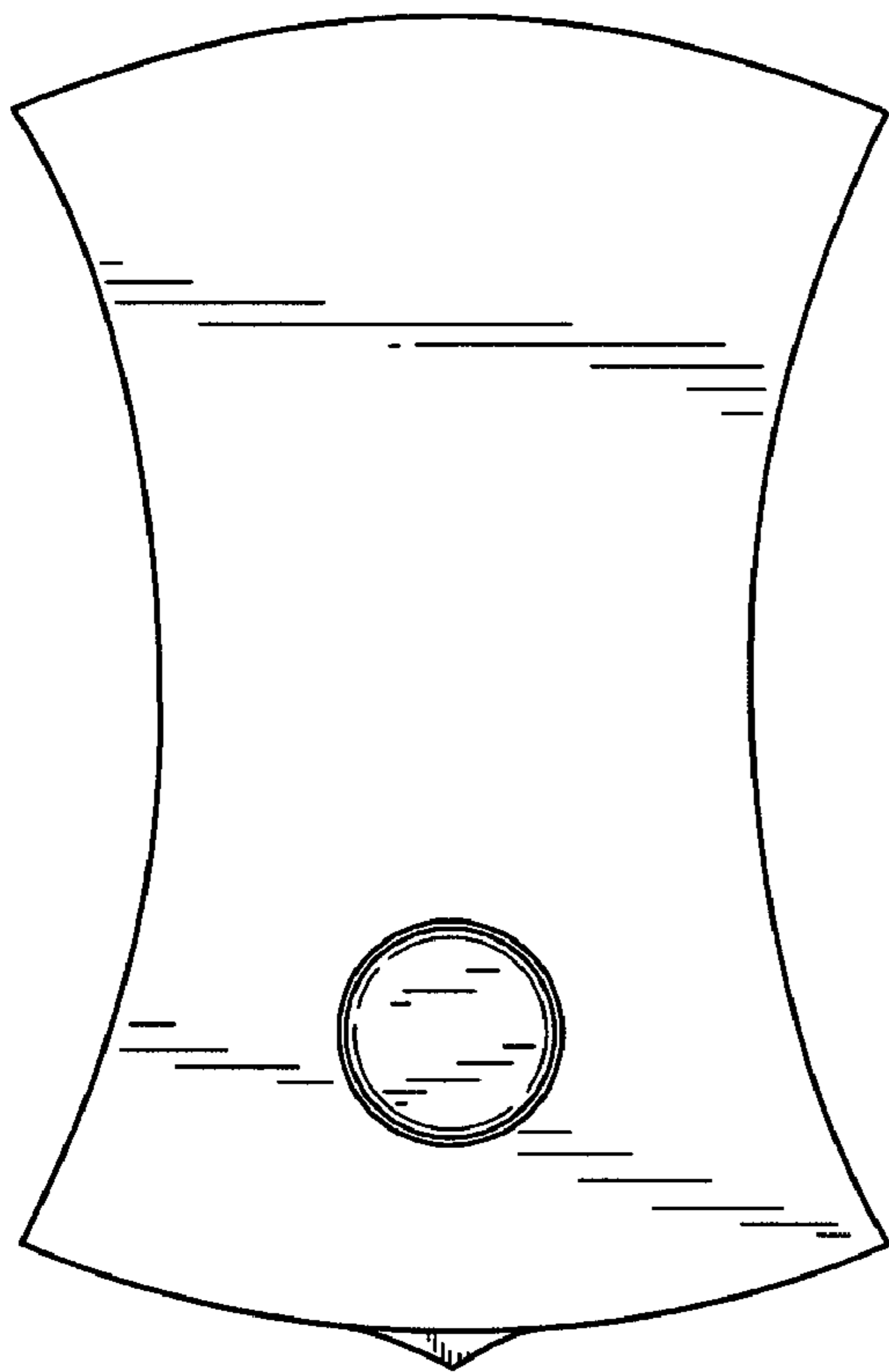

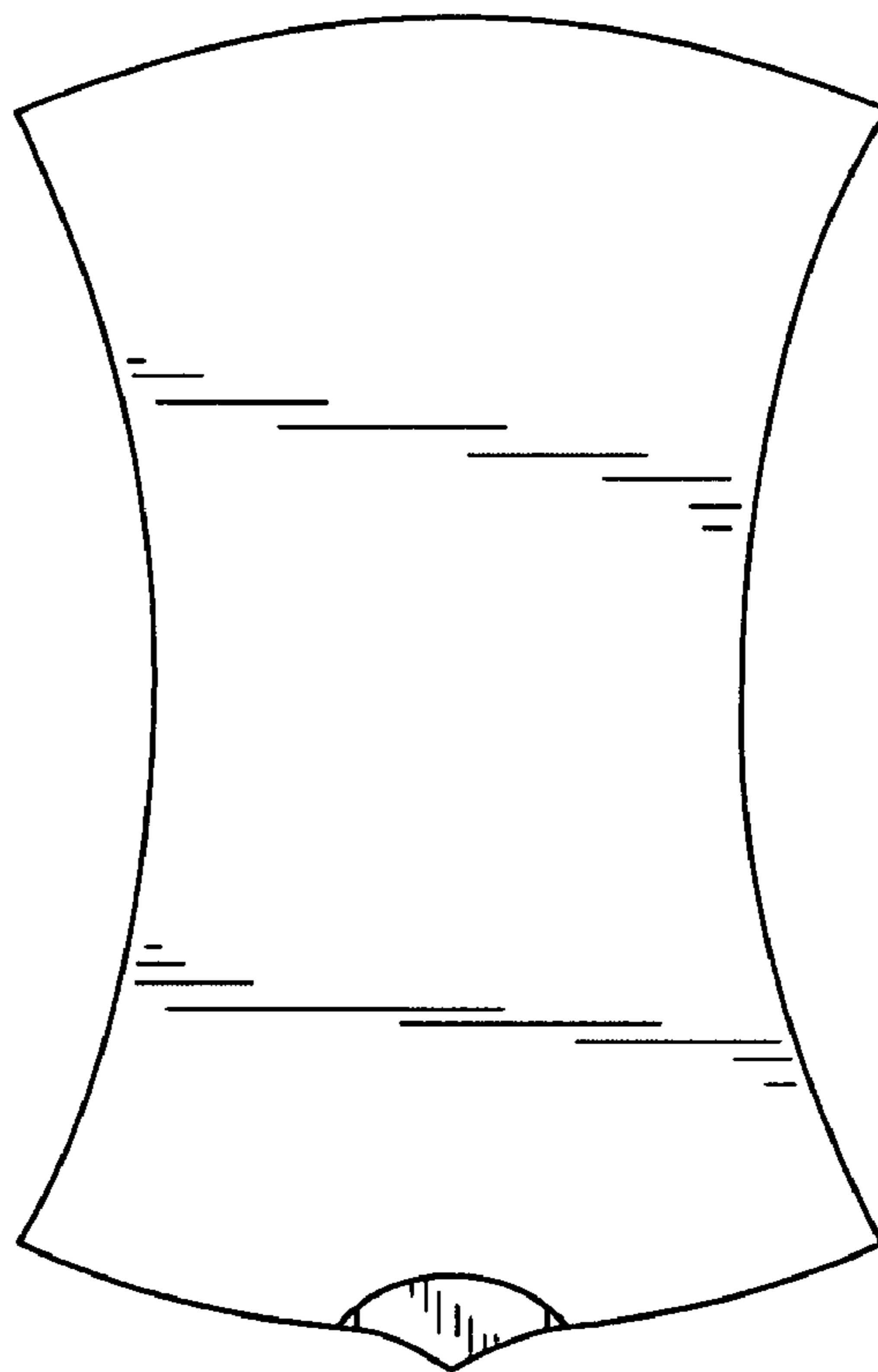

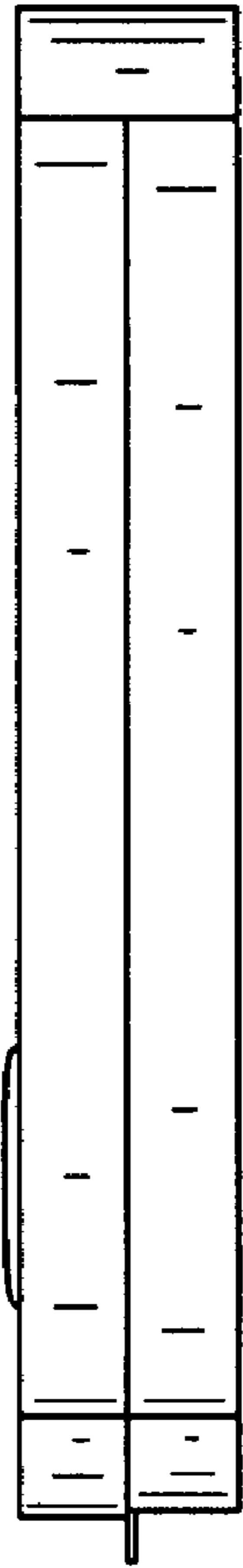

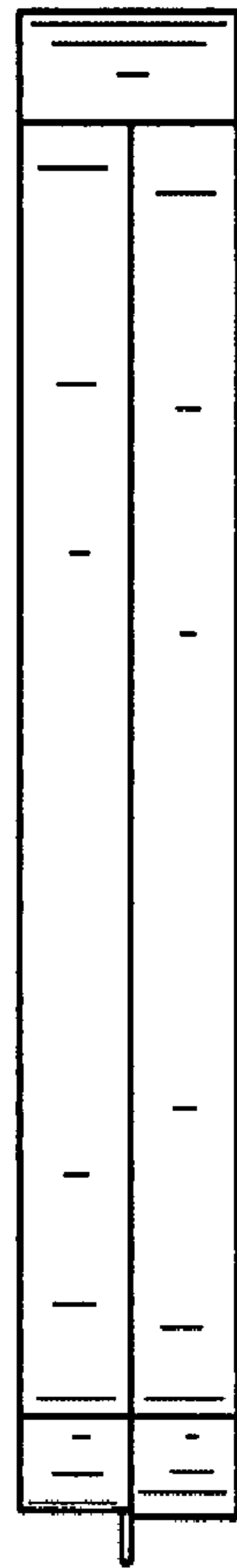

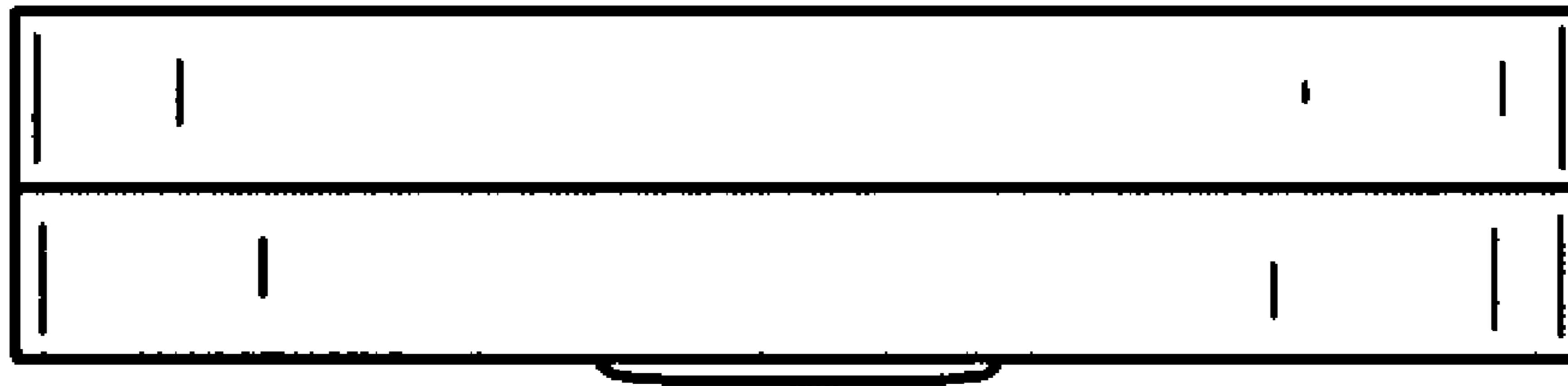

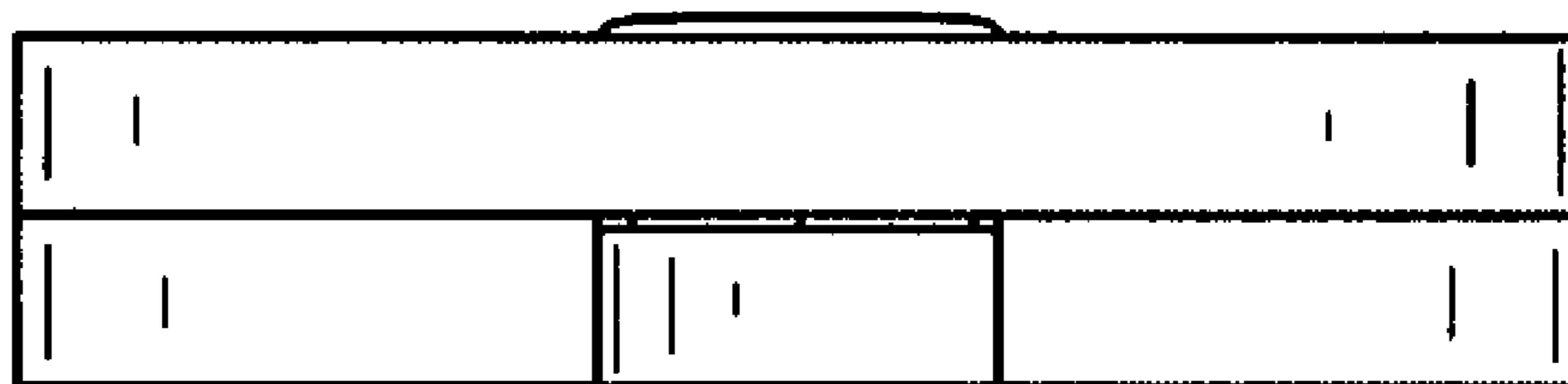
