(57) **CLAIM**

The ornamental design for a swimming costume, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a swimming costume showing the new design;

FIG. 2 is a front view of the swimming costume shown in FIG. 1;

FIG. 3 is a rear view of the swimming costume shown in FIG. 1;

FIG. 4 is a left side view of the swimming costume shown in FIG. 1;

FIG. 5 is a right side view of the swimming costume shown in FIG. 1;

FIG. 6 is a top view of the swimming costume shown in FIG. 1;

FIG. 7 is a bottom view of the swimming costume shown in FIG. 1;

FIG. 8 is a front perspective view of an alternative embodiment of the swimming costume shown in FIG. 1;

FIG. 9 is a front view of the alternative embodiment of the swimming costume shown in FIG. 8;

FIG. 10 is a rear view of the alternative embodiment of the swimming costume shown in FIG. 8;

FIG. 11 is a left side view of the alternative embodiment of the swimming costume shown in FIG. 8;

FIG. 12 is a right side view of the alternative embodiment of the swimming costume shown in FIG. 8;

FIG. 13 is a top view of the alternative embodiment of the swimming costume shown in FIG. 8; and,

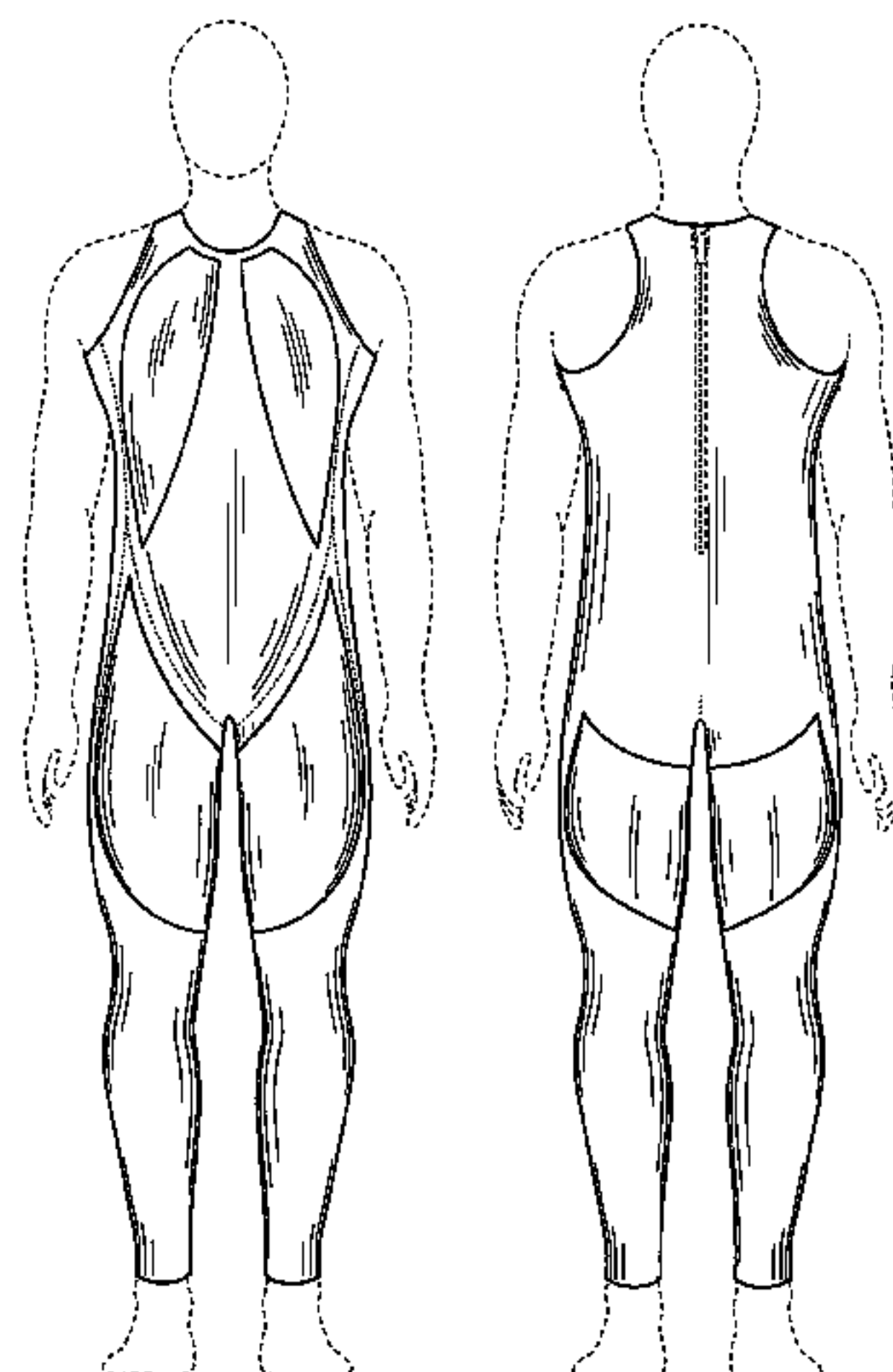
FIG. 14 is a bottom view of the alternative embodiment of the swimming costume shown in FIG. 8.

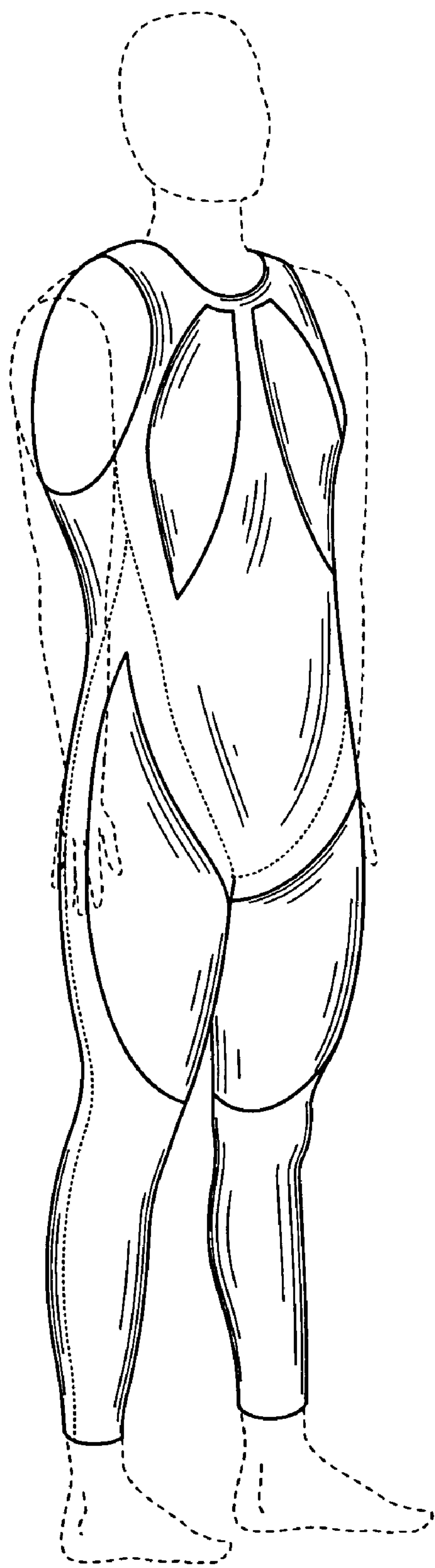

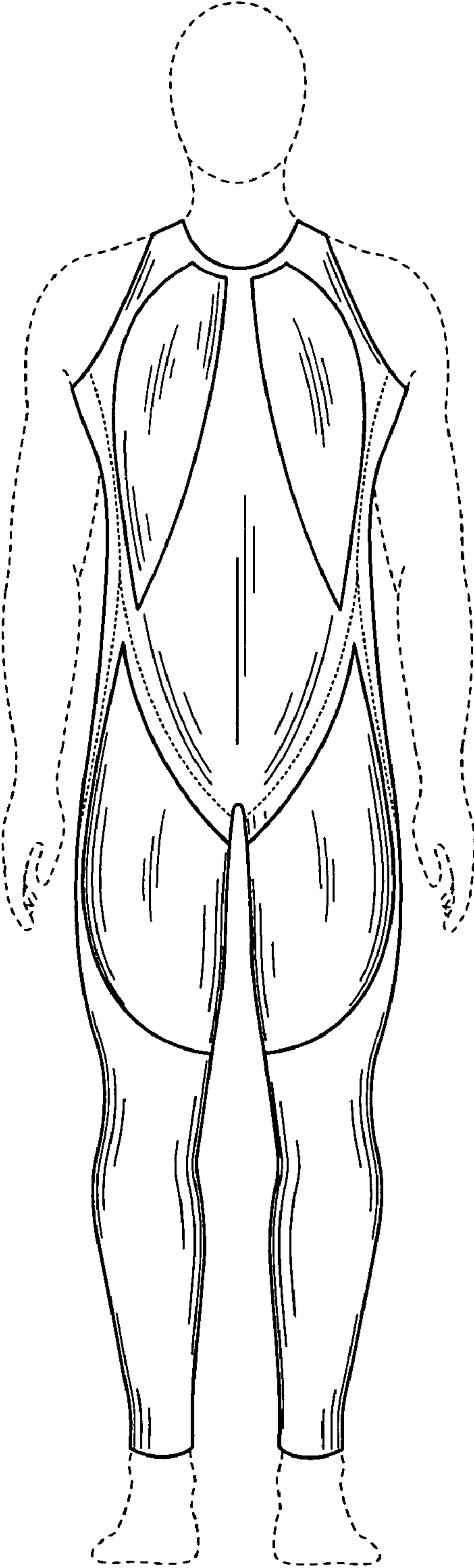

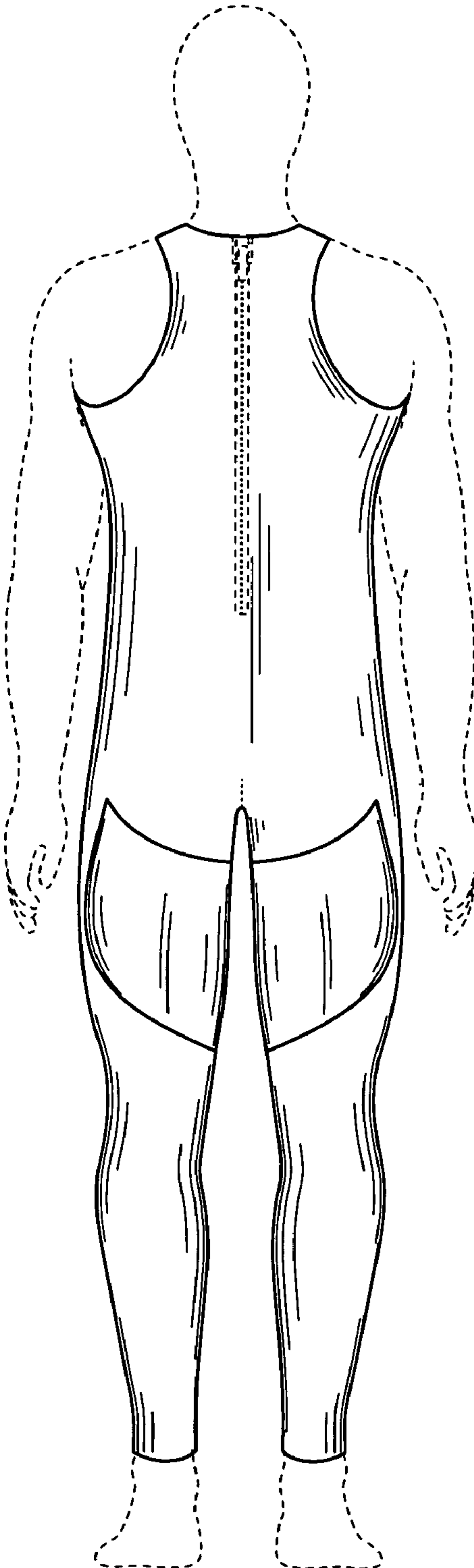

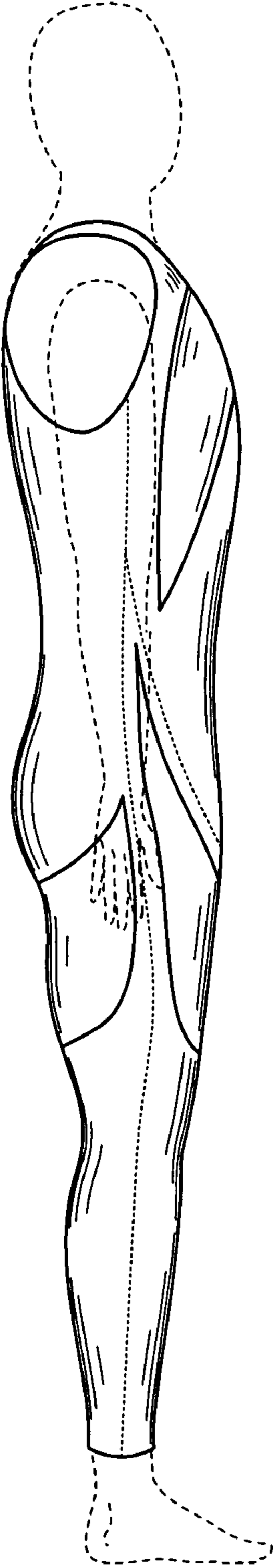

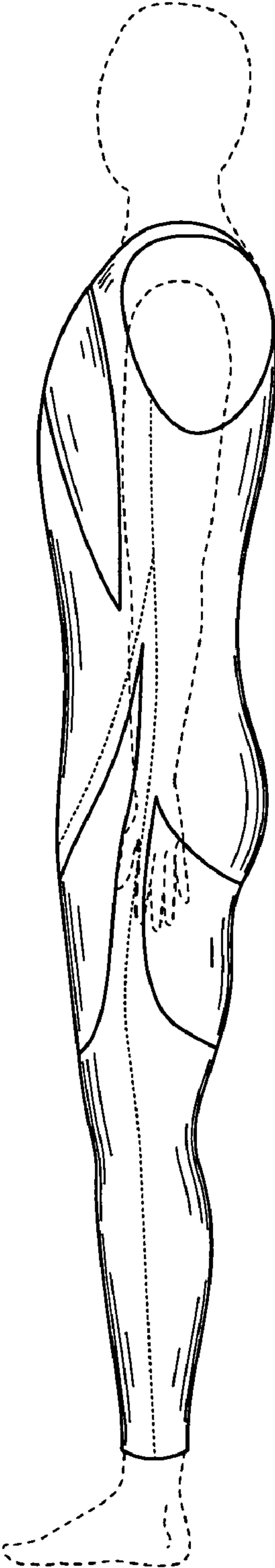
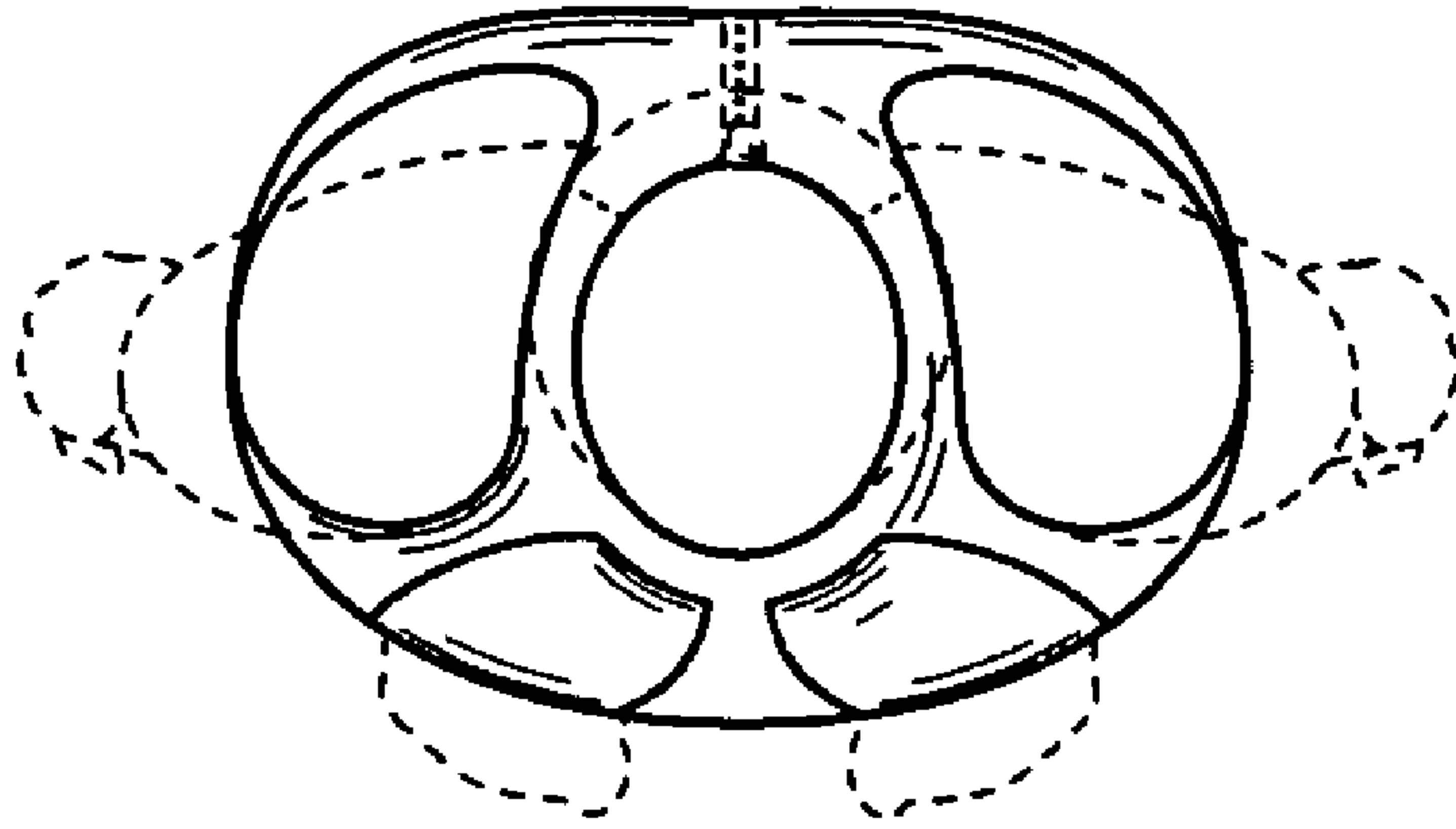
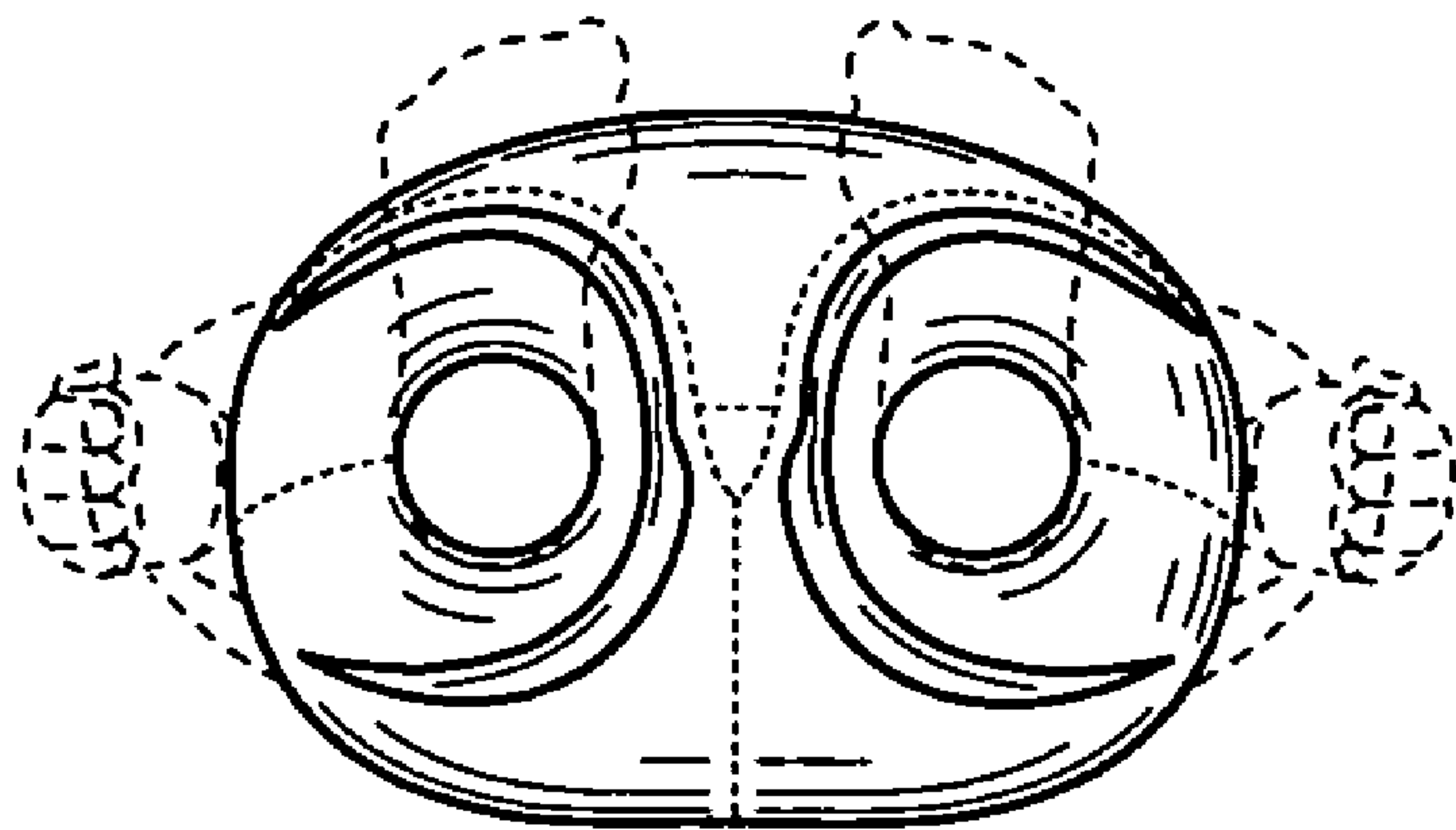

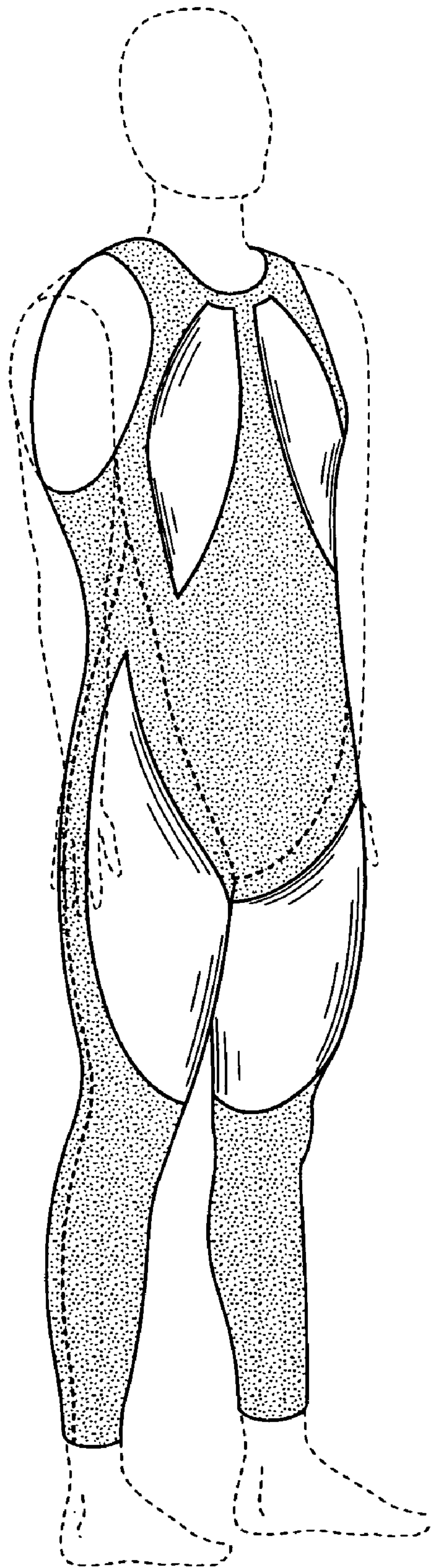

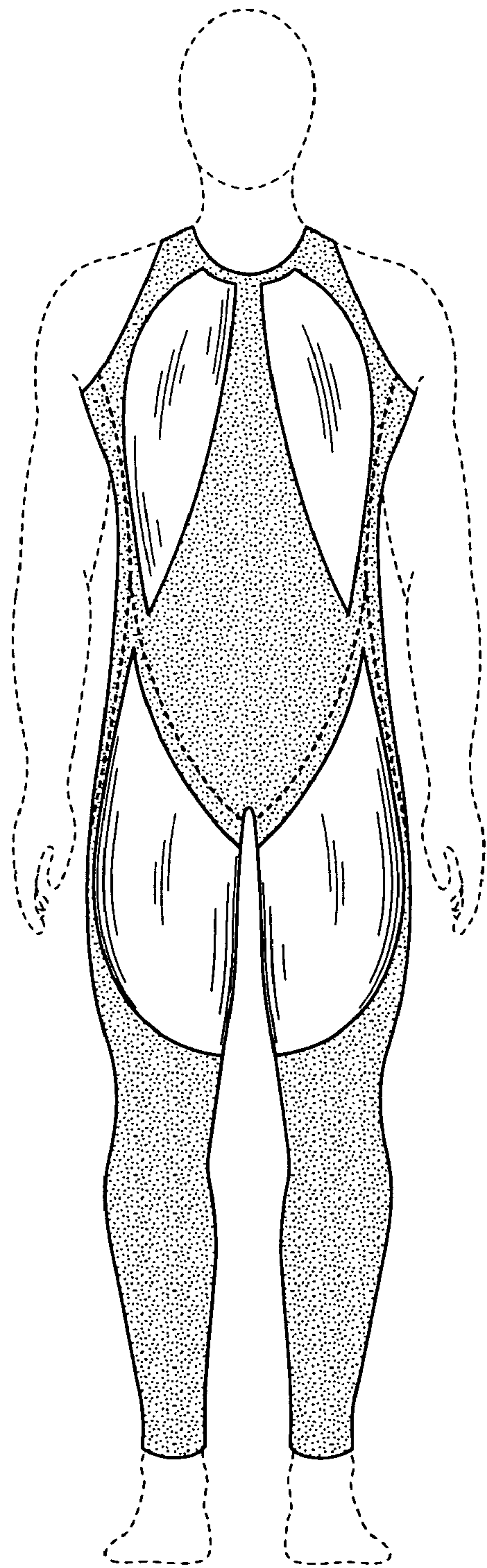

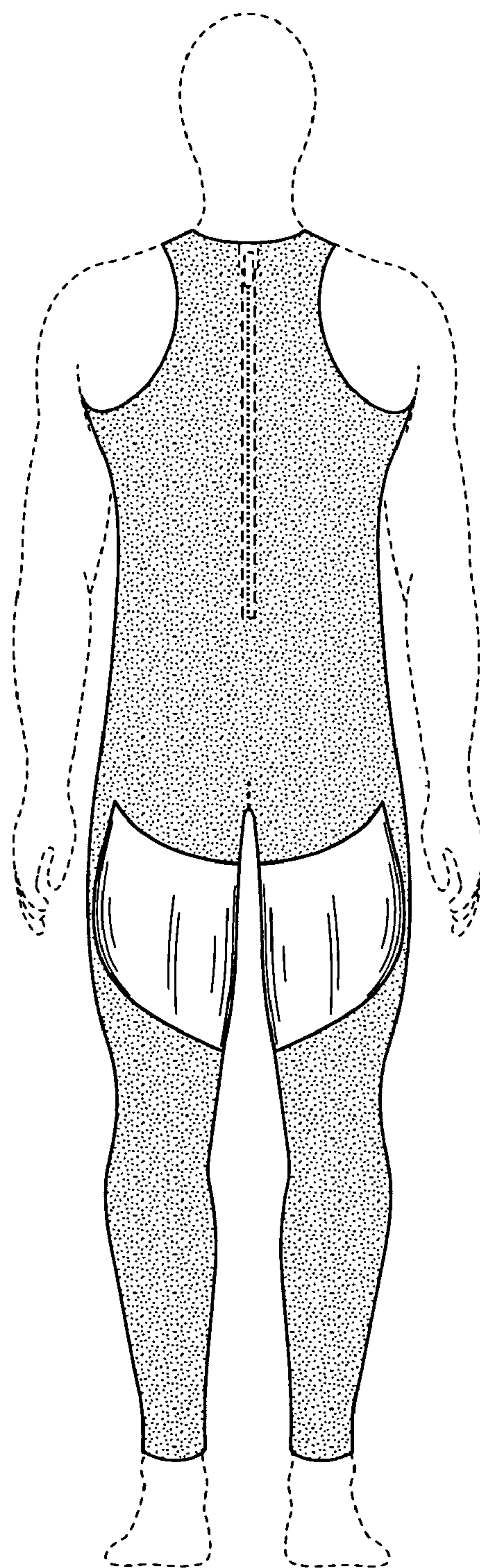

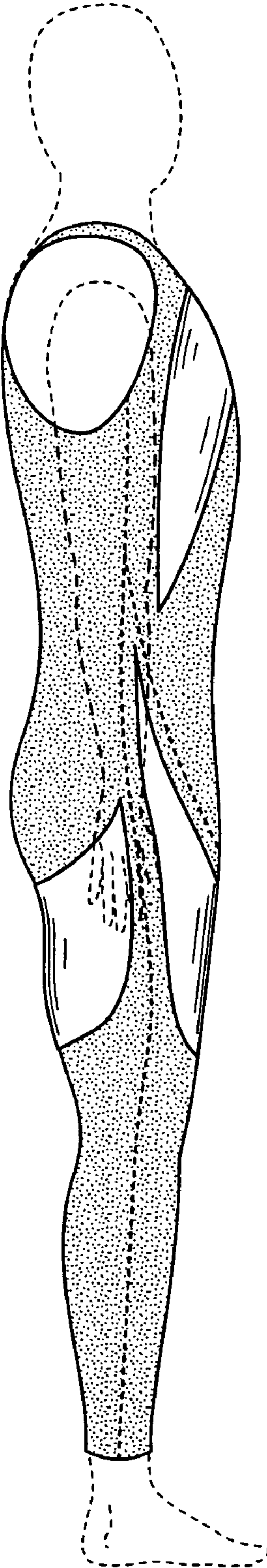

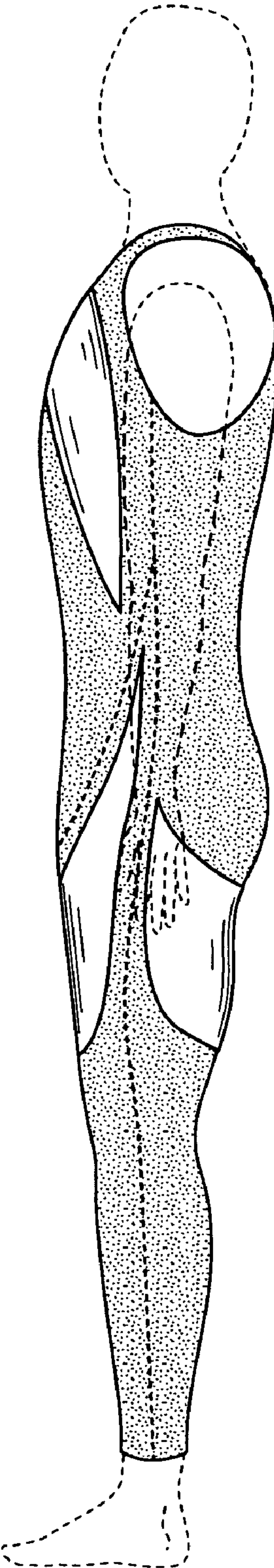
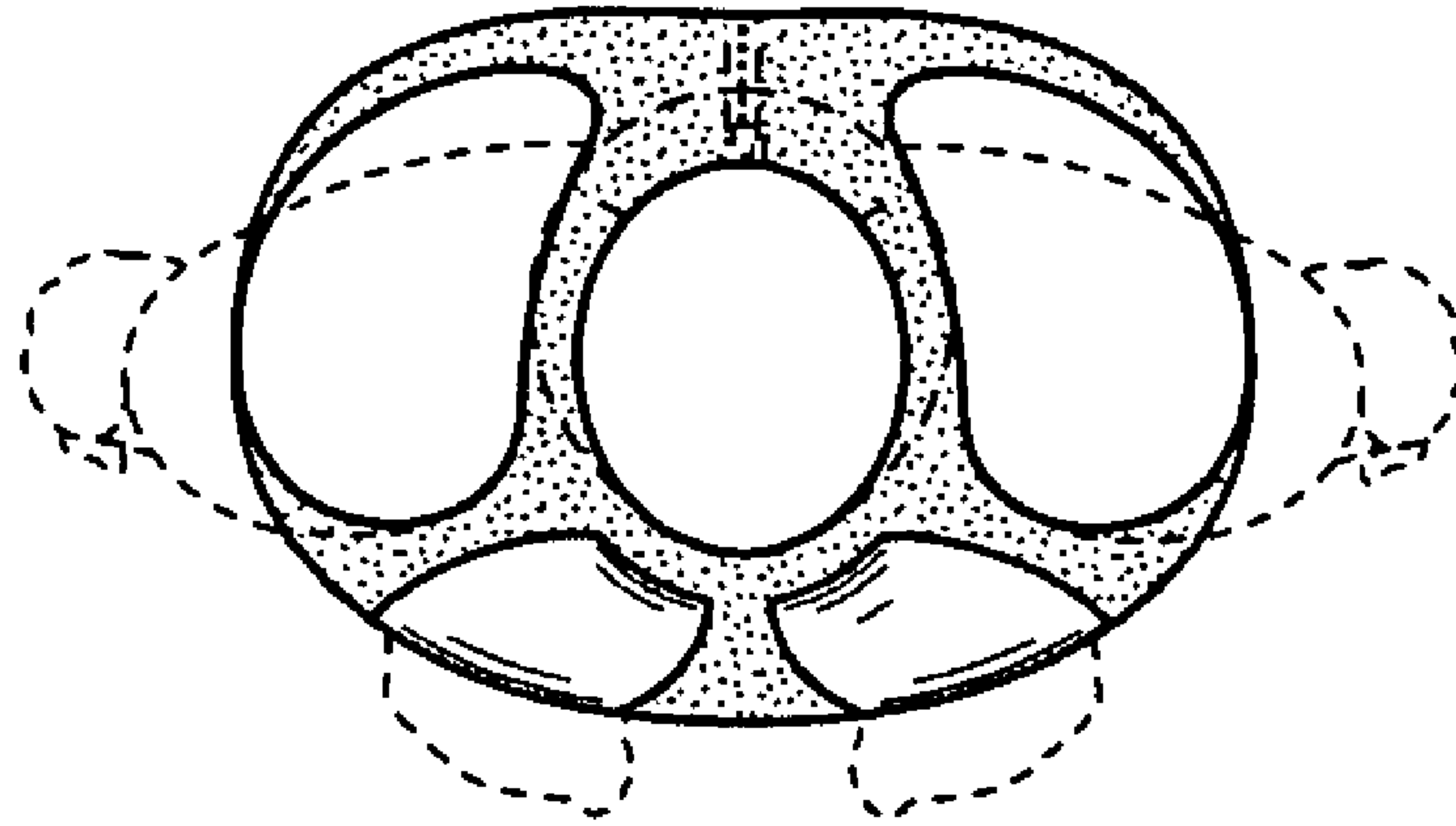
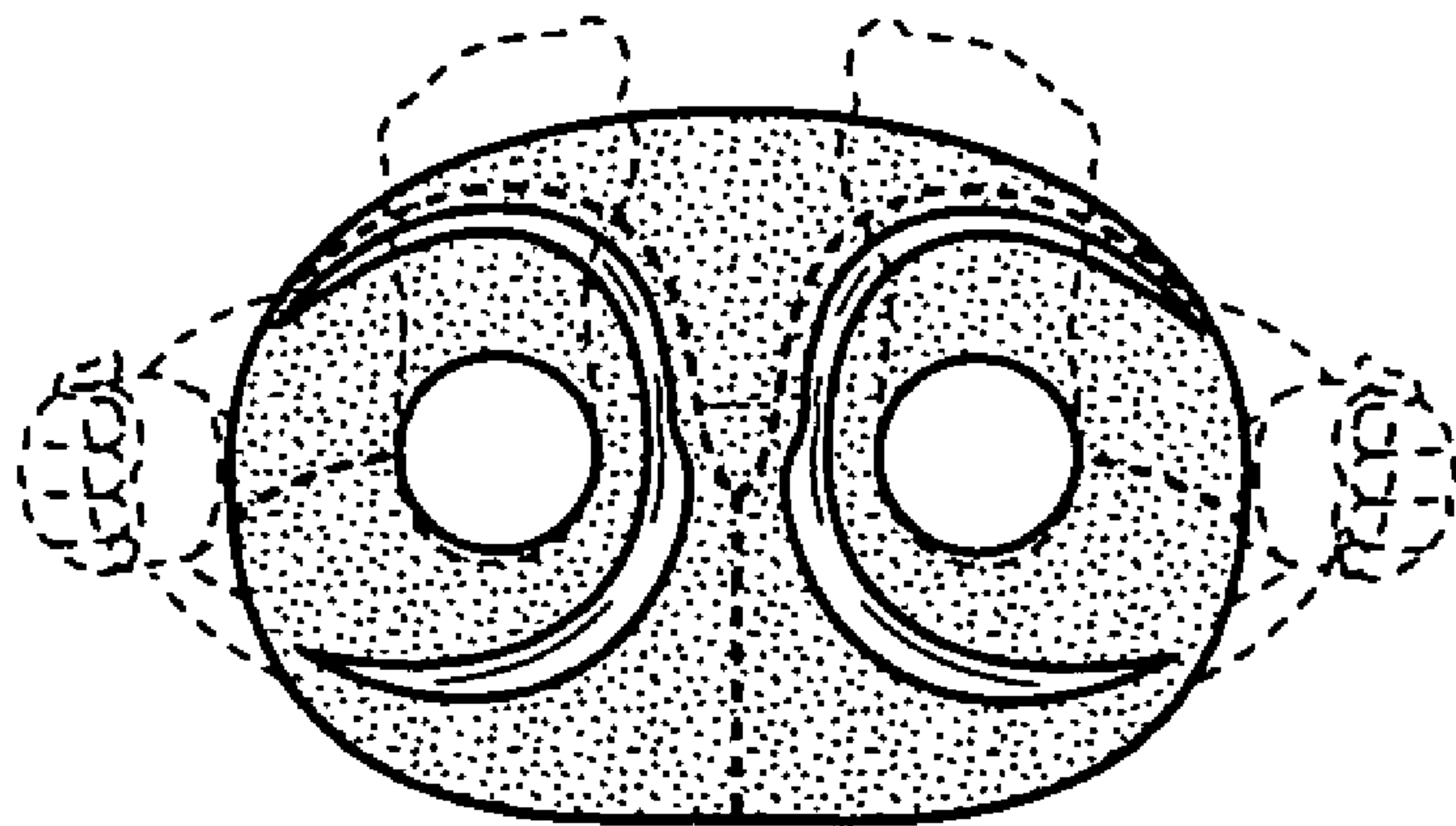
