FIG. 1 is a top view showing the design of the container carrier.

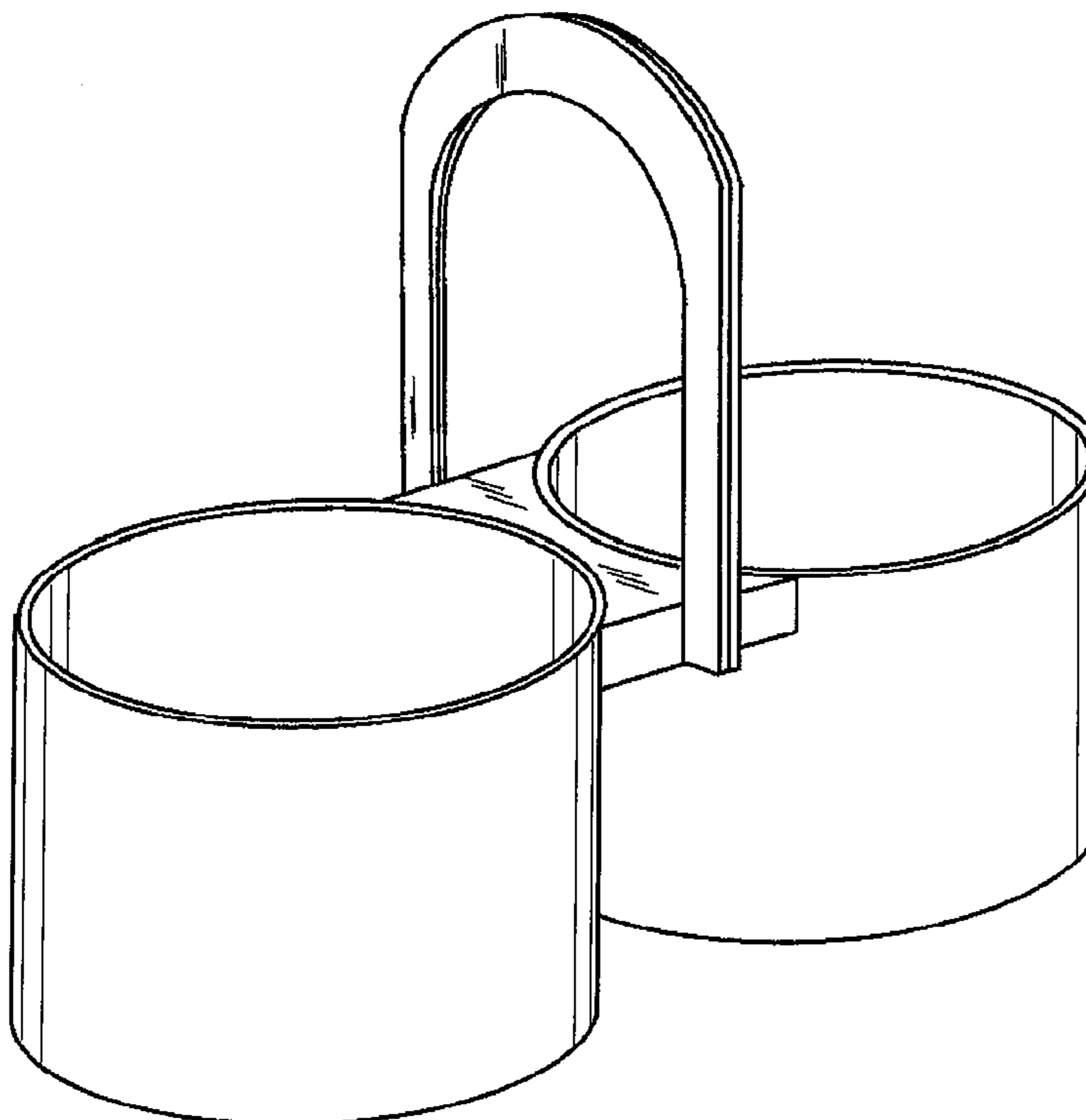
FIG. 2 is a side view showing the design of the container carrier.

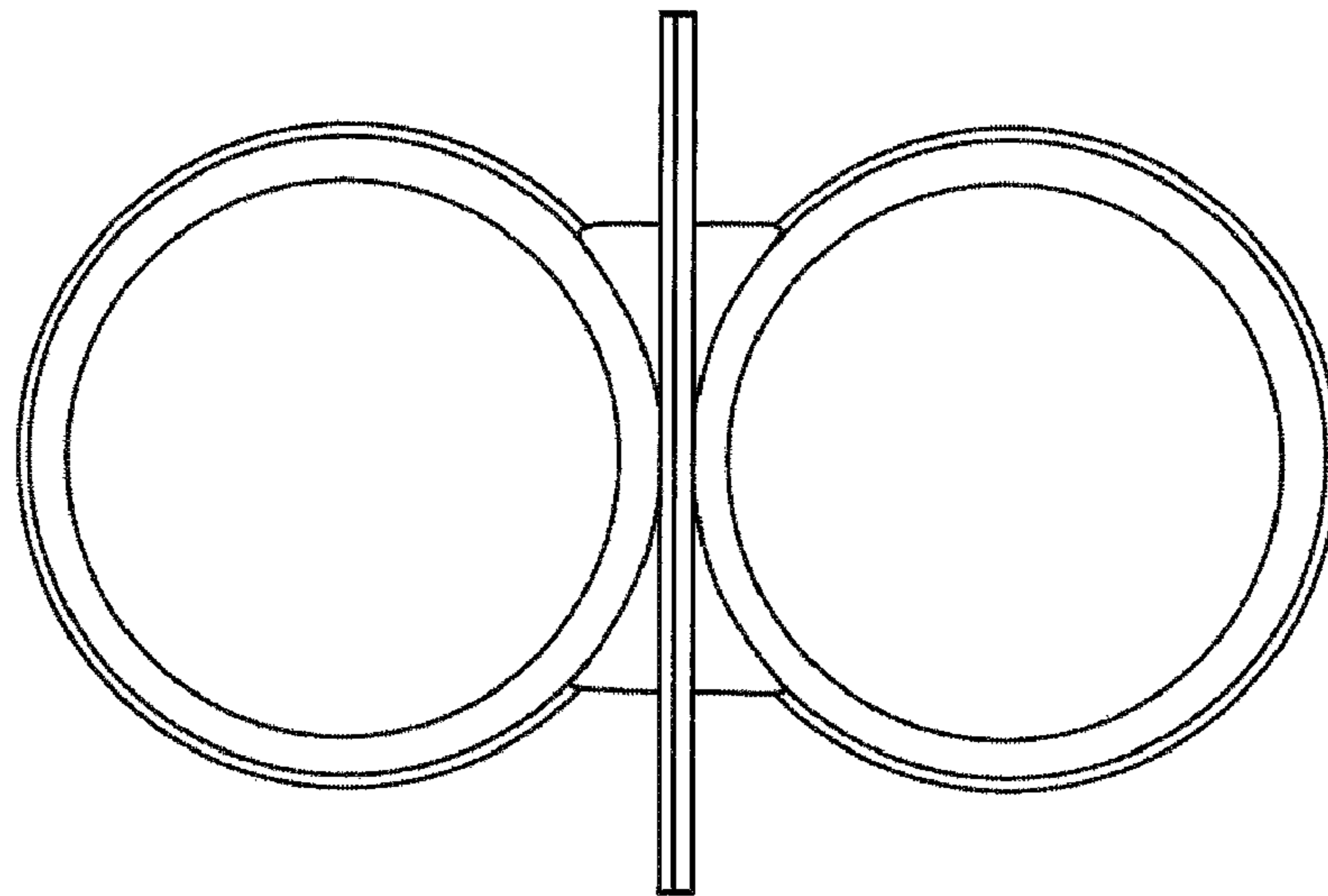

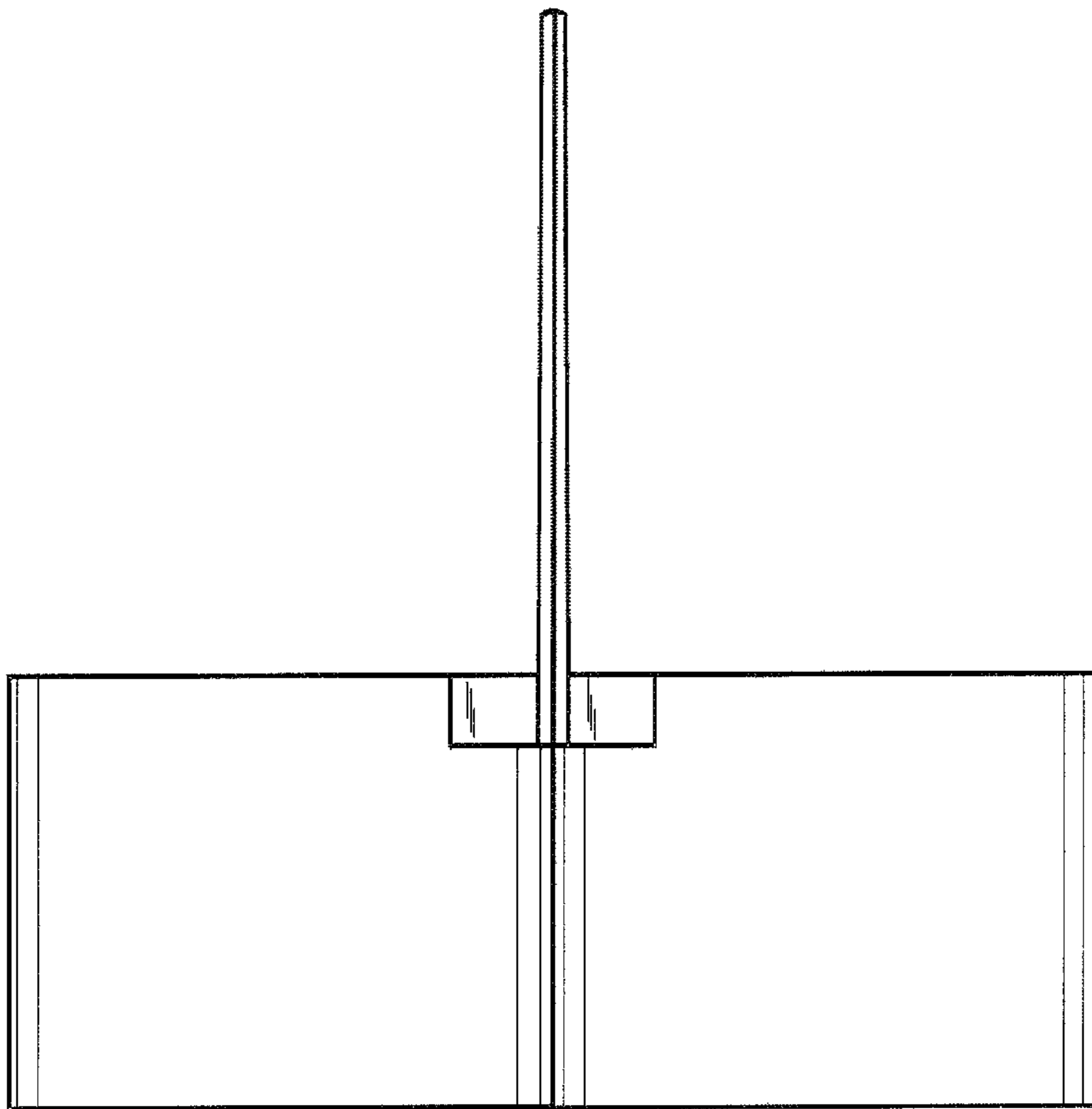

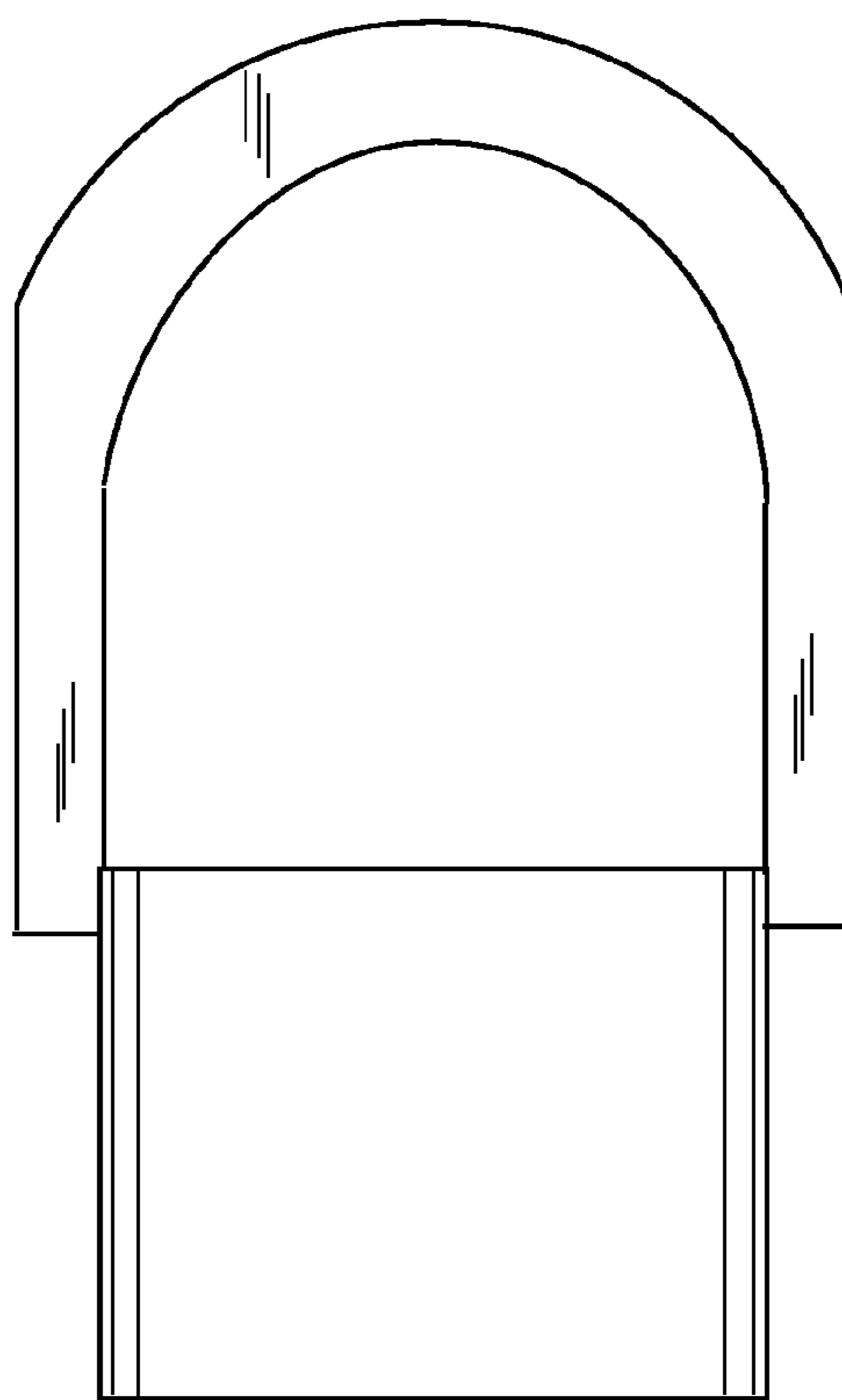

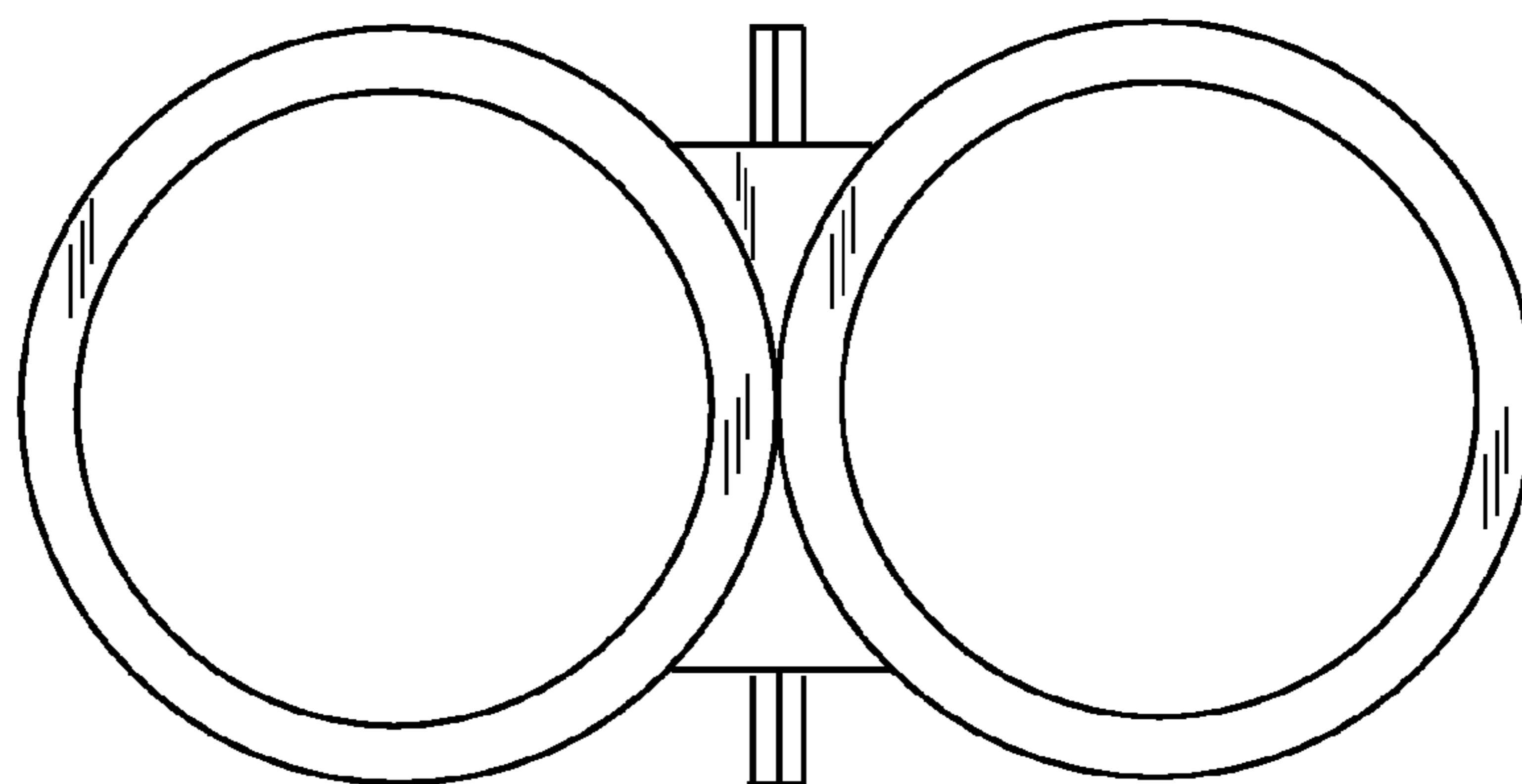

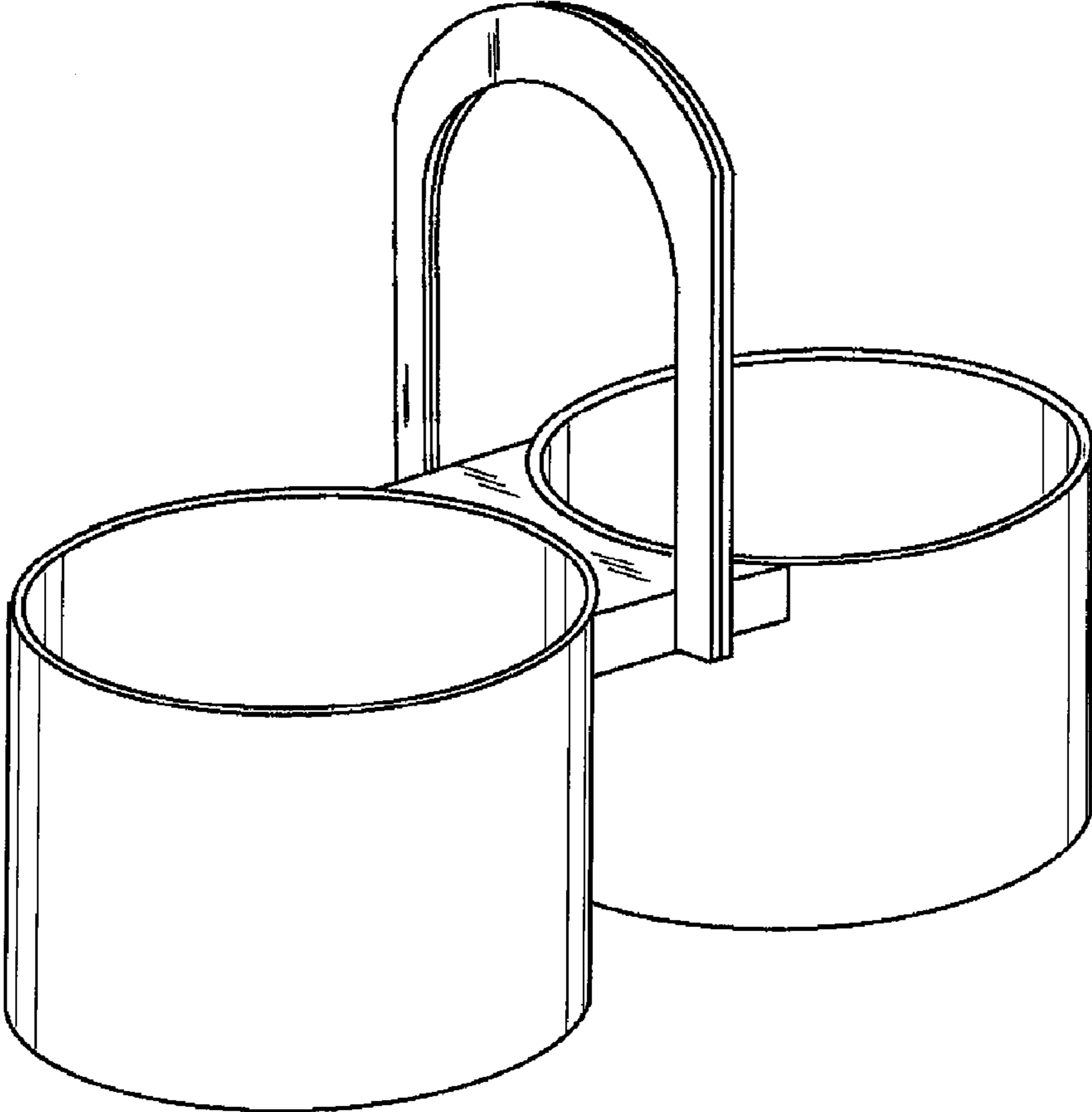
