The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a toothbrush showing my new design;

FIG. 2 is a bottom plan view thereof on an enlarged scale;

FIG. 3 is a top plan view thereof on an enlarged scale;

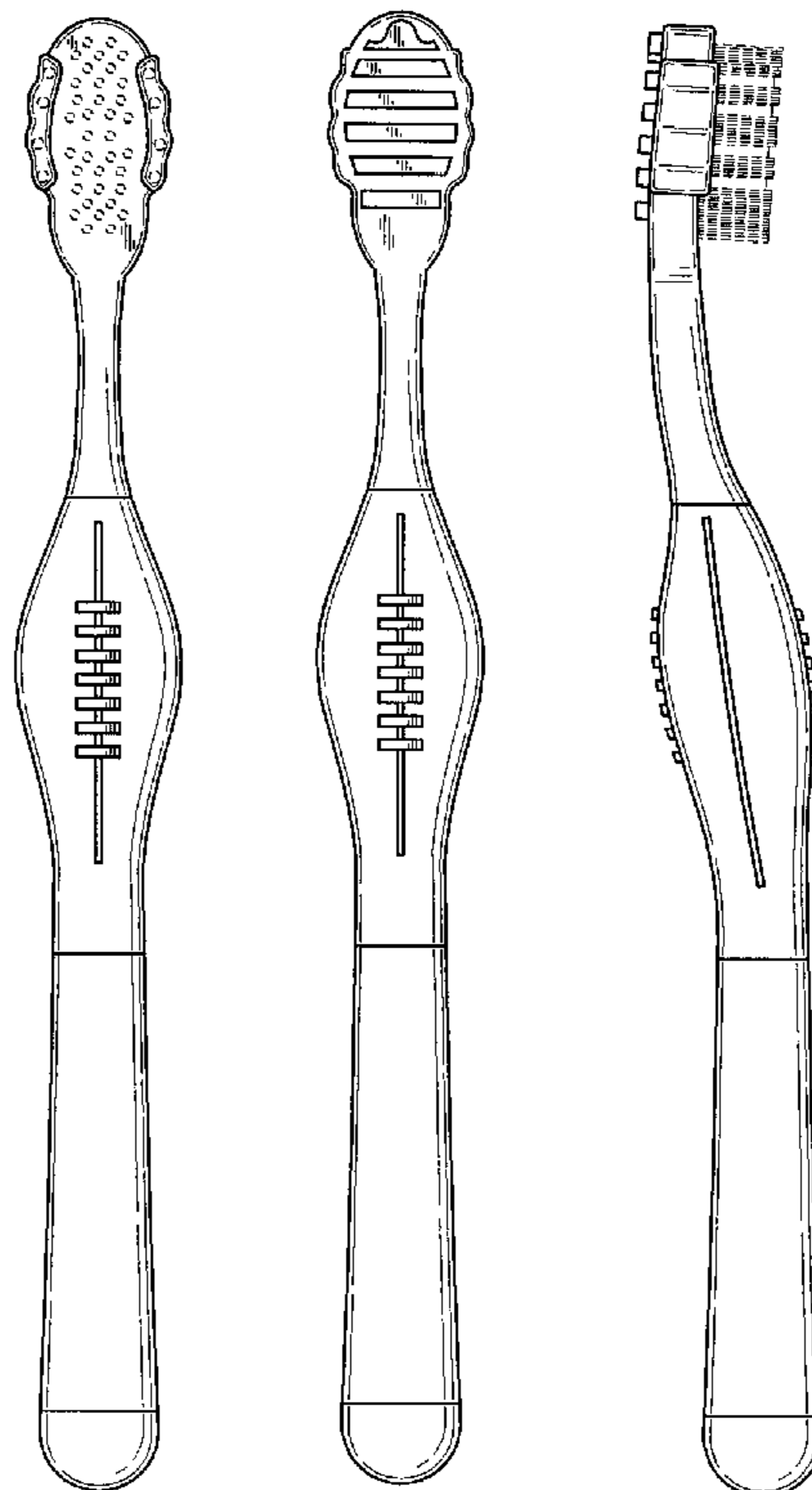
FIG. 4 is a rear elevation view thereof;

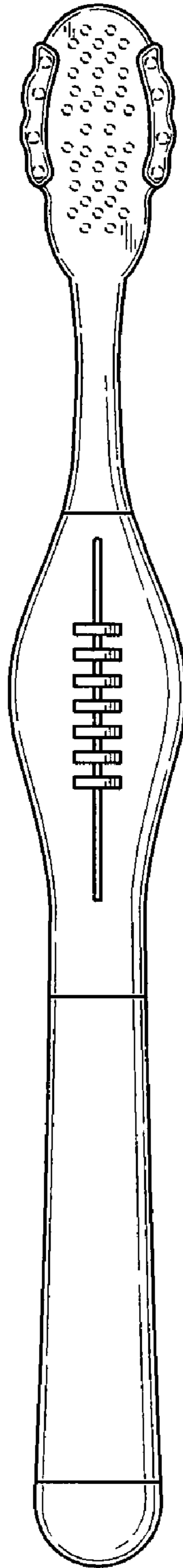

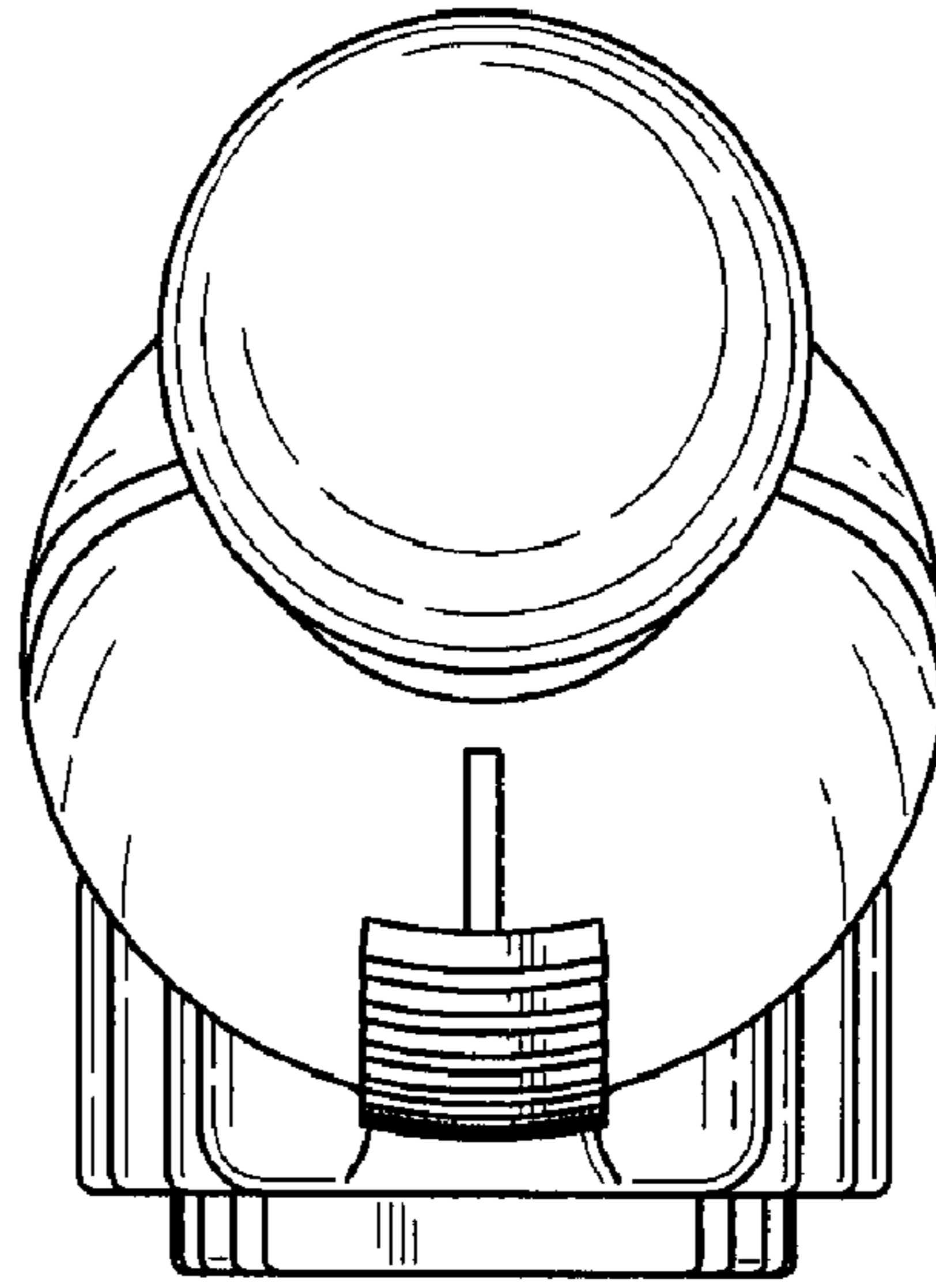

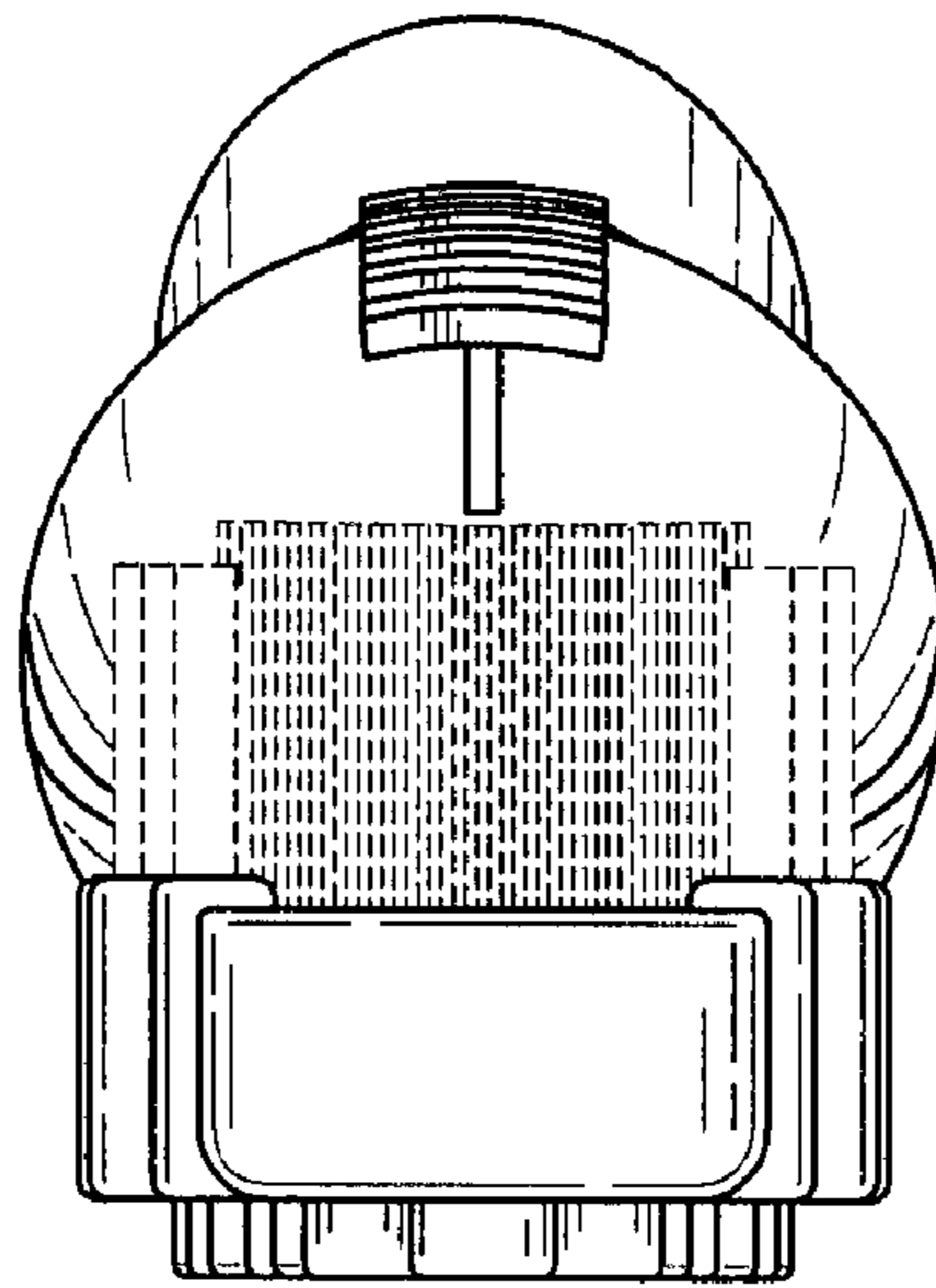

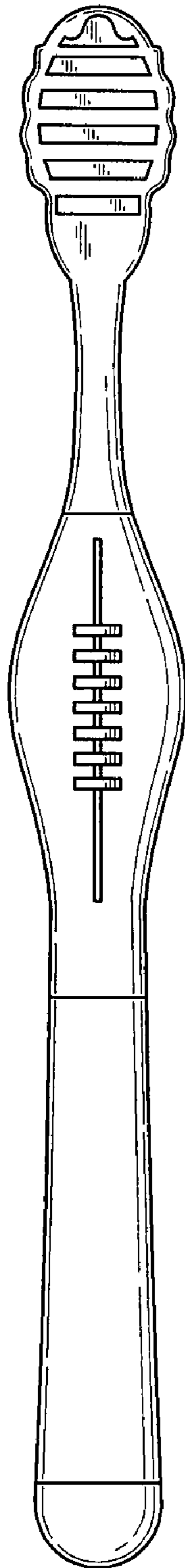

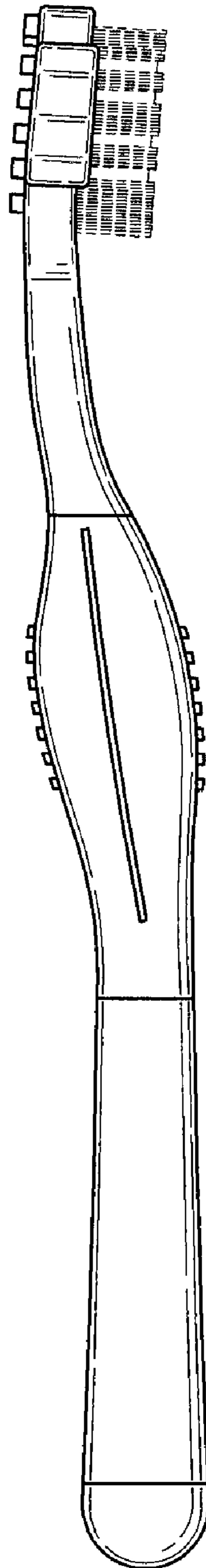

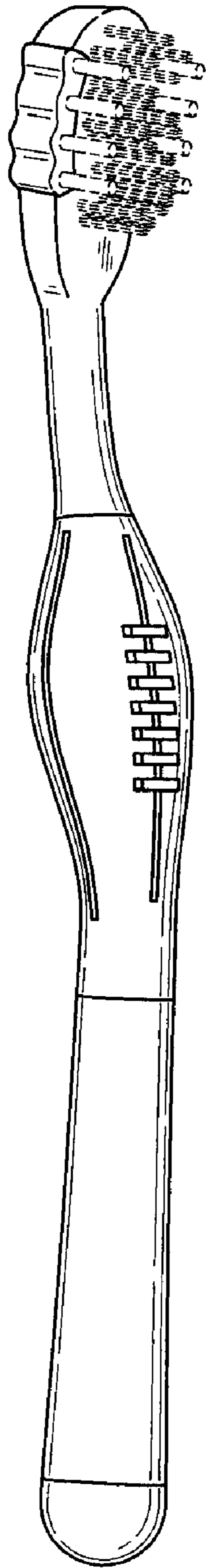
