(57) **CLAIM**

An ornamental design for an oven as shown and described. Portions of the oven shown in broken lines form no part of the claimed design.

DESCRIPTION

FIG. 1 is a perspective of a first embodiment of an oven incorporating the design of this invention;

FIG. 2 is a front view of the oven of FIG. 1;

FIG. 3 is a right side elevation of the oven;

FIG. 4 is left side elevation of the oven;

FIG. 5 is a top view of the oven;

FIG. 6 is a bottom view of the oven;

FIG. 7 is a perspective of a second embodiment of an oven incorporating the design of this invention;

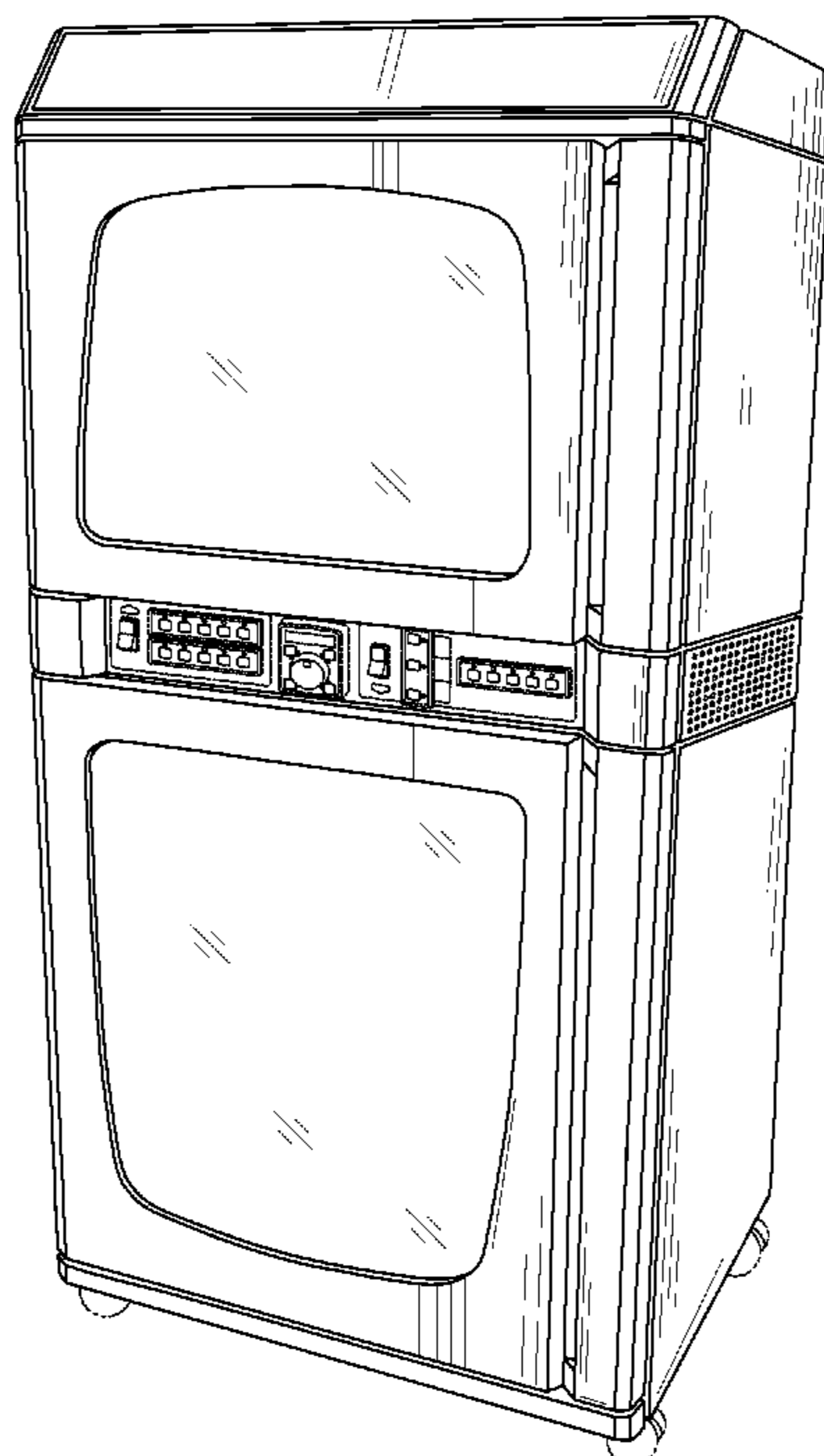

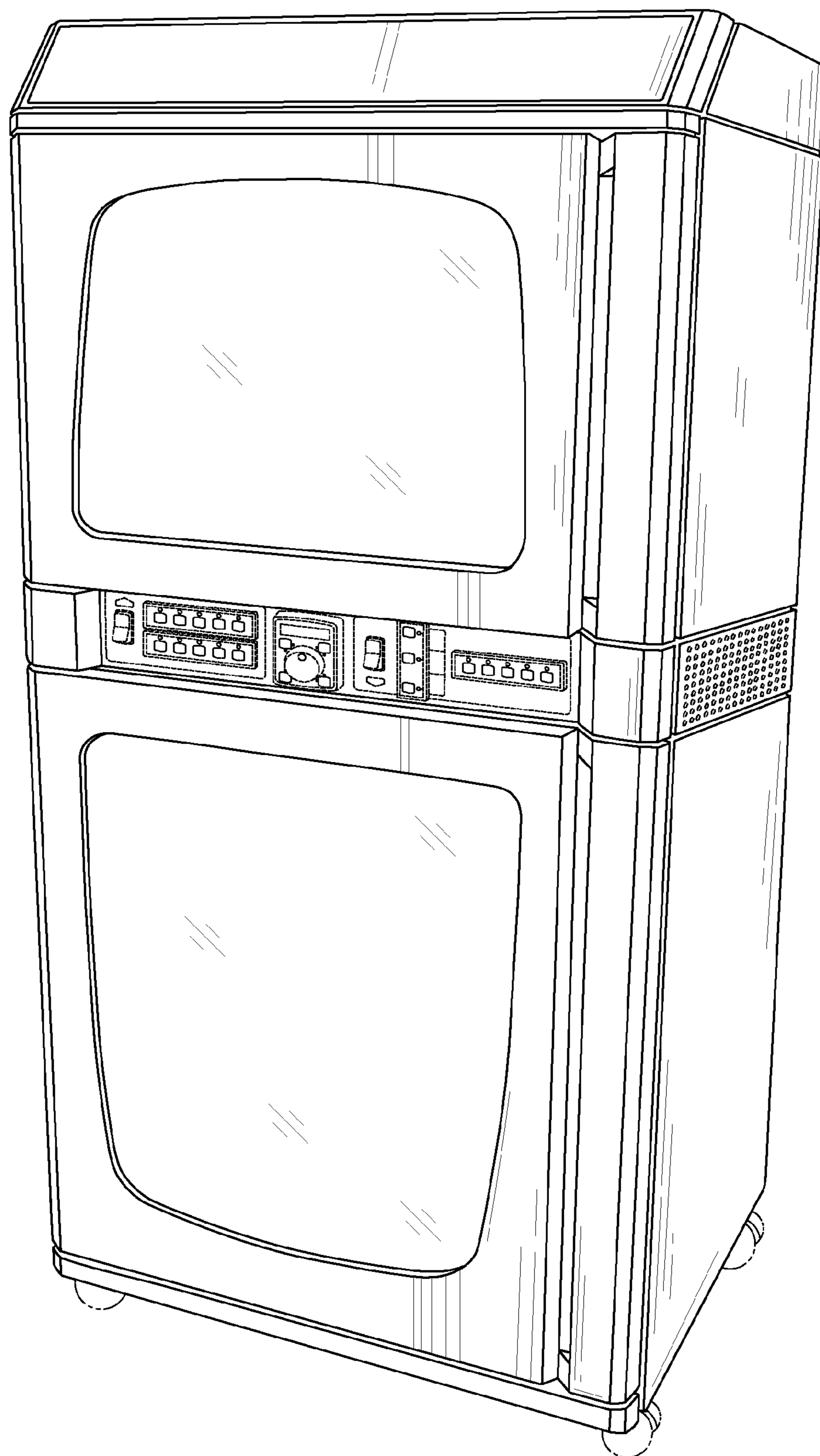

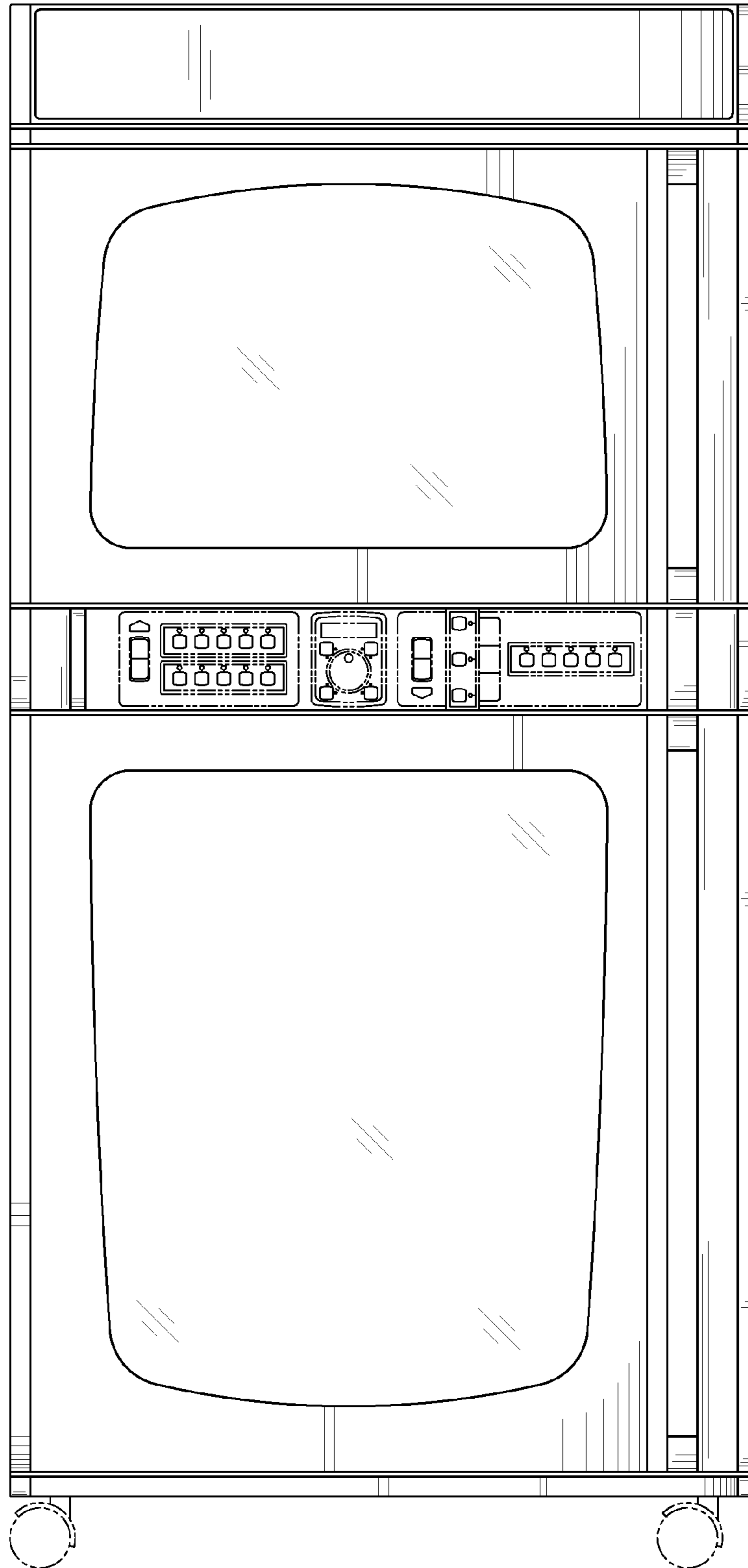

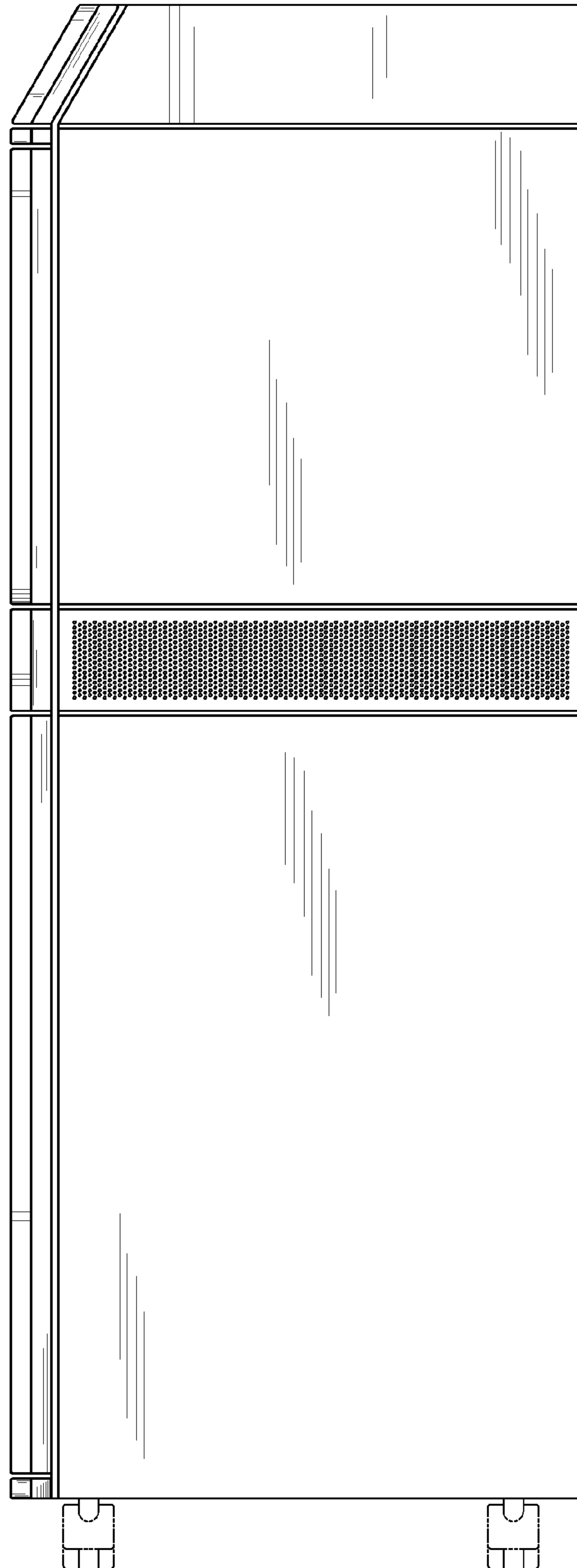

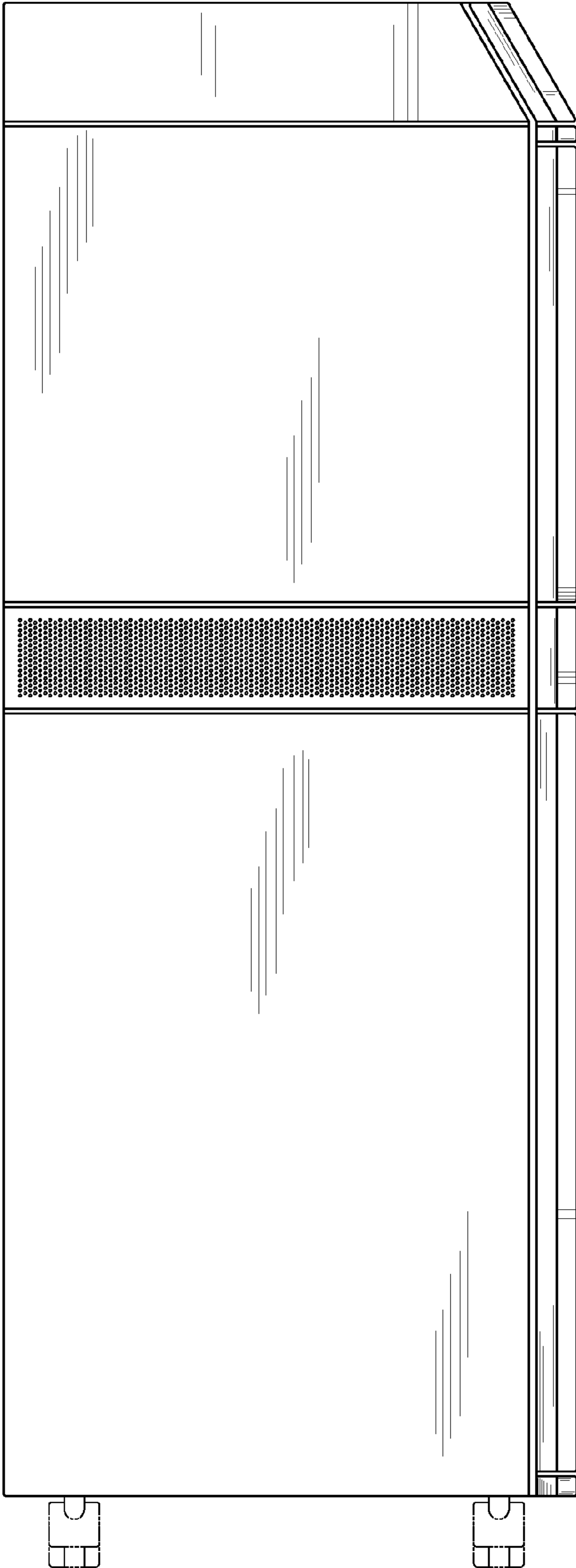

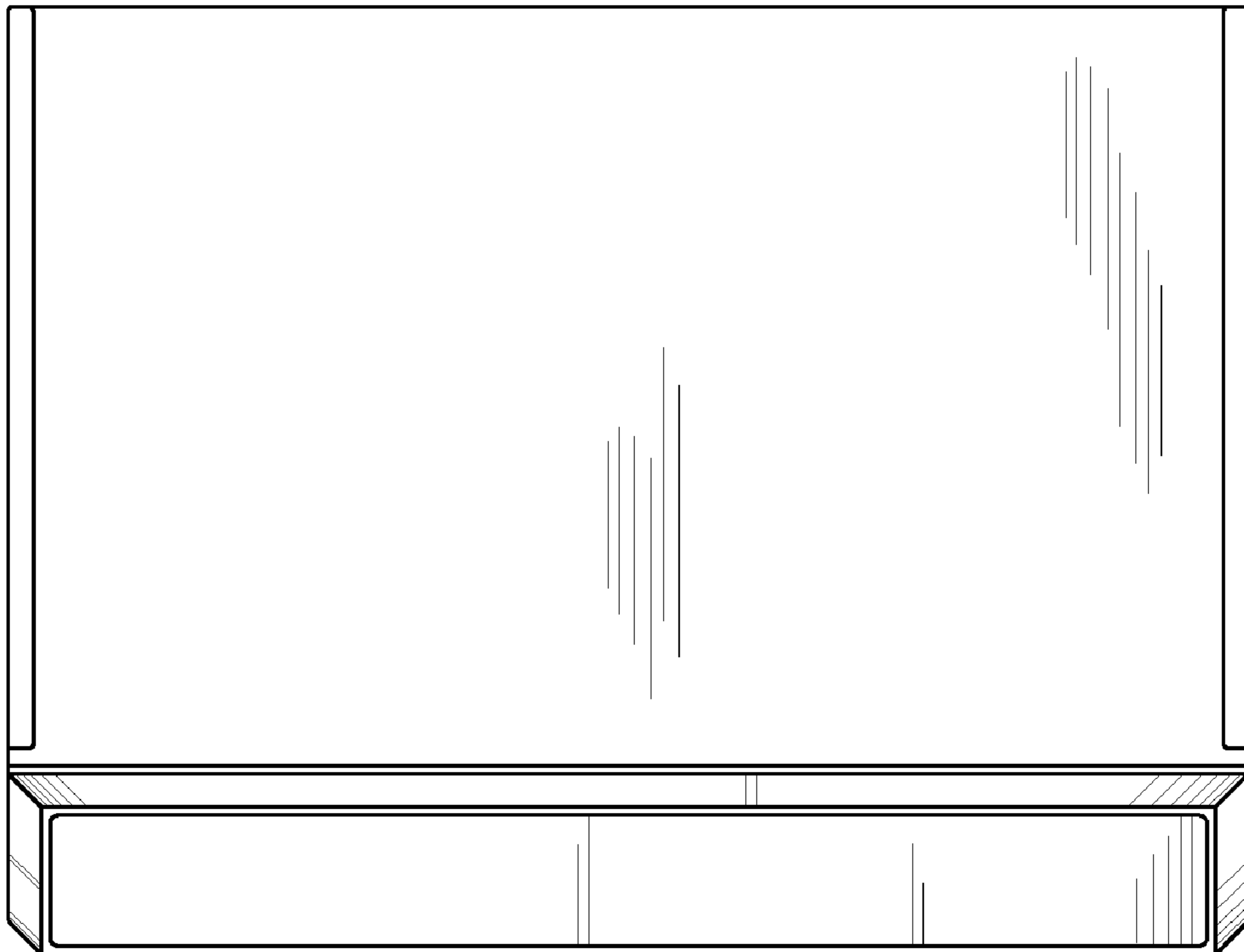

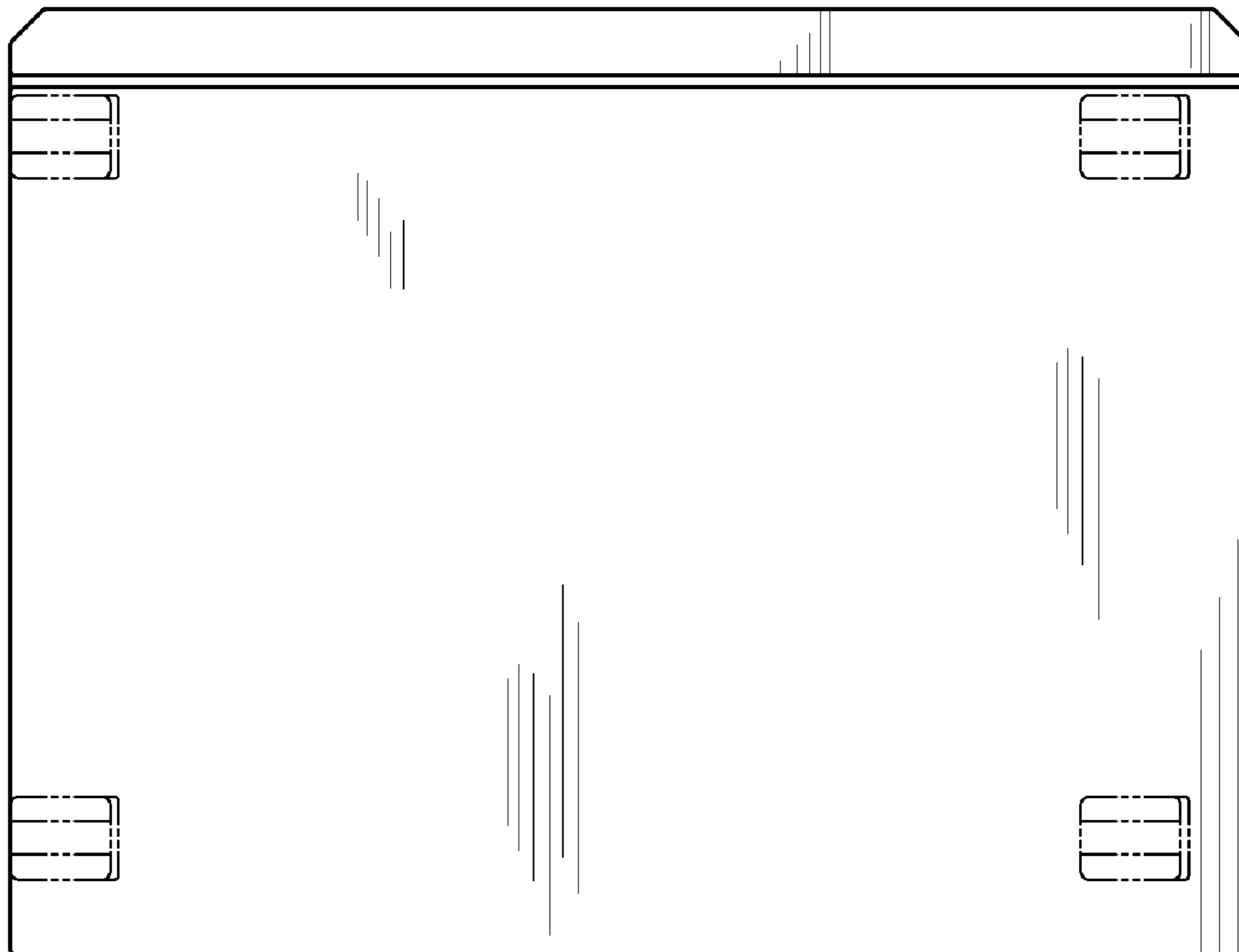

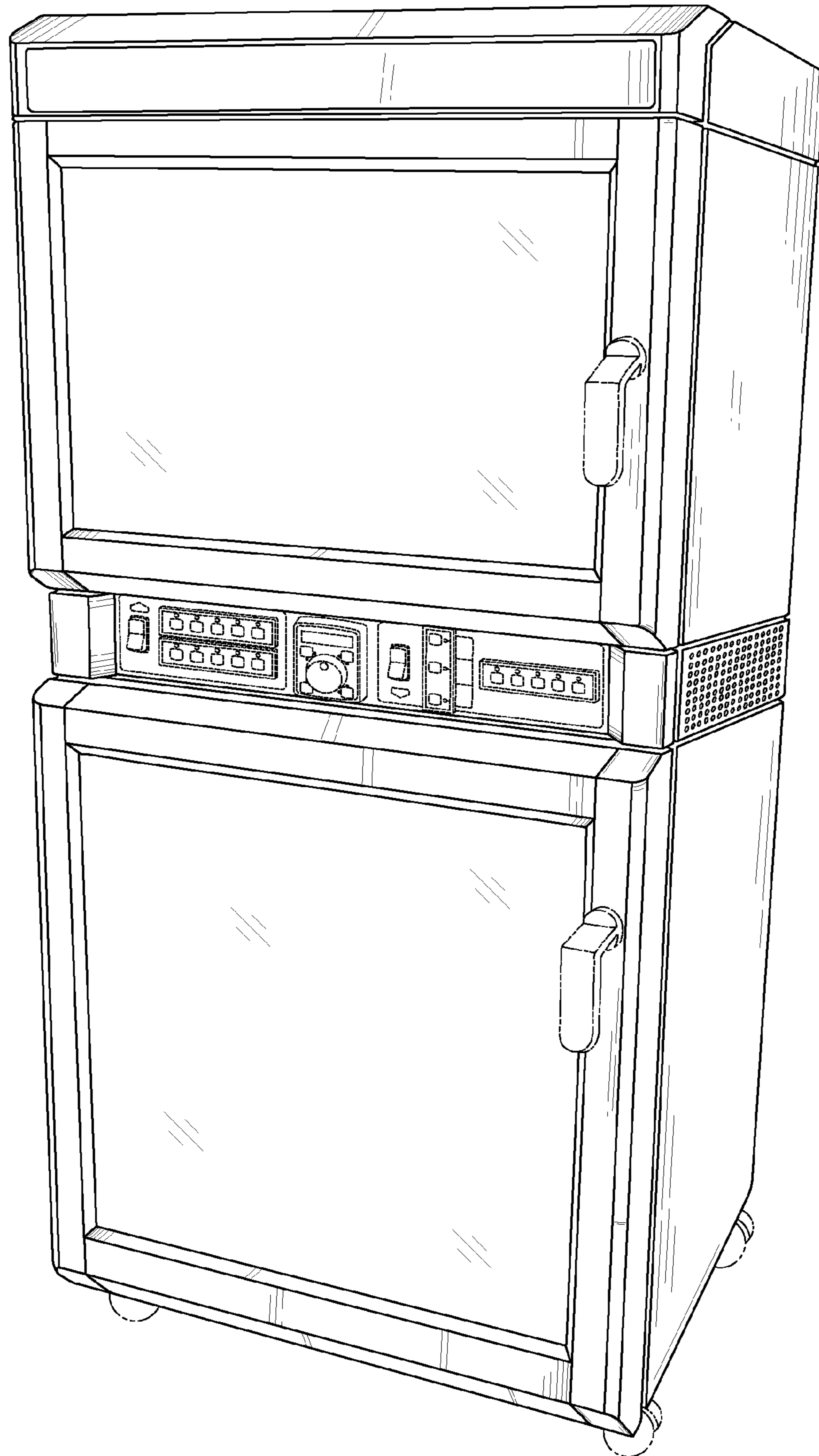

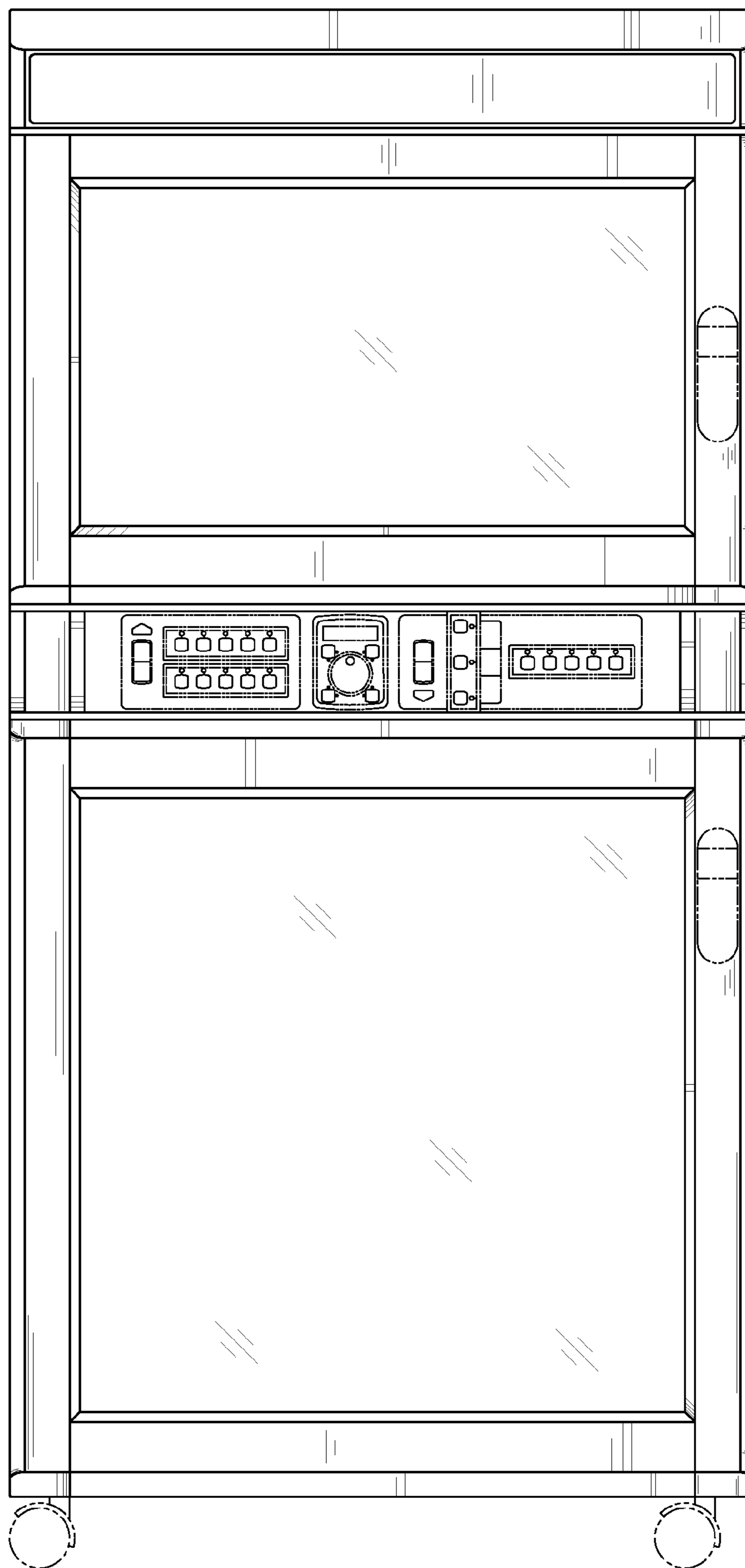

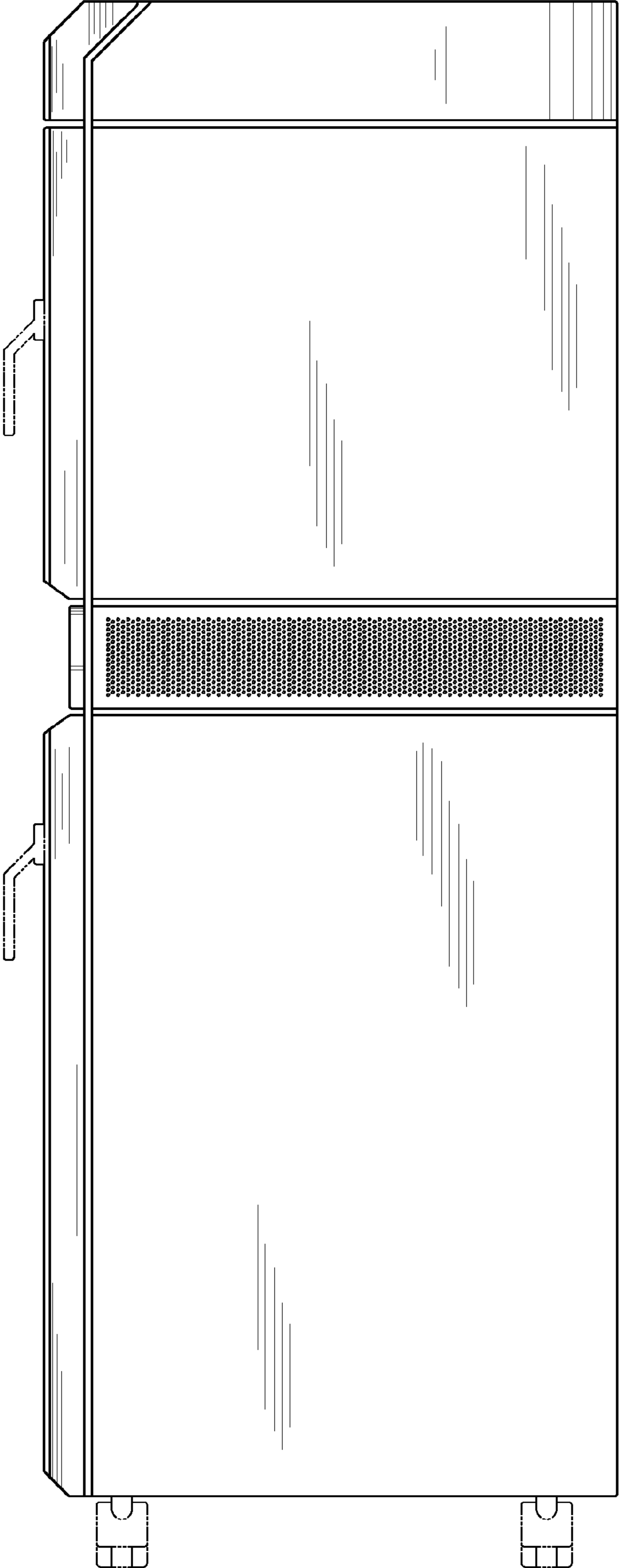

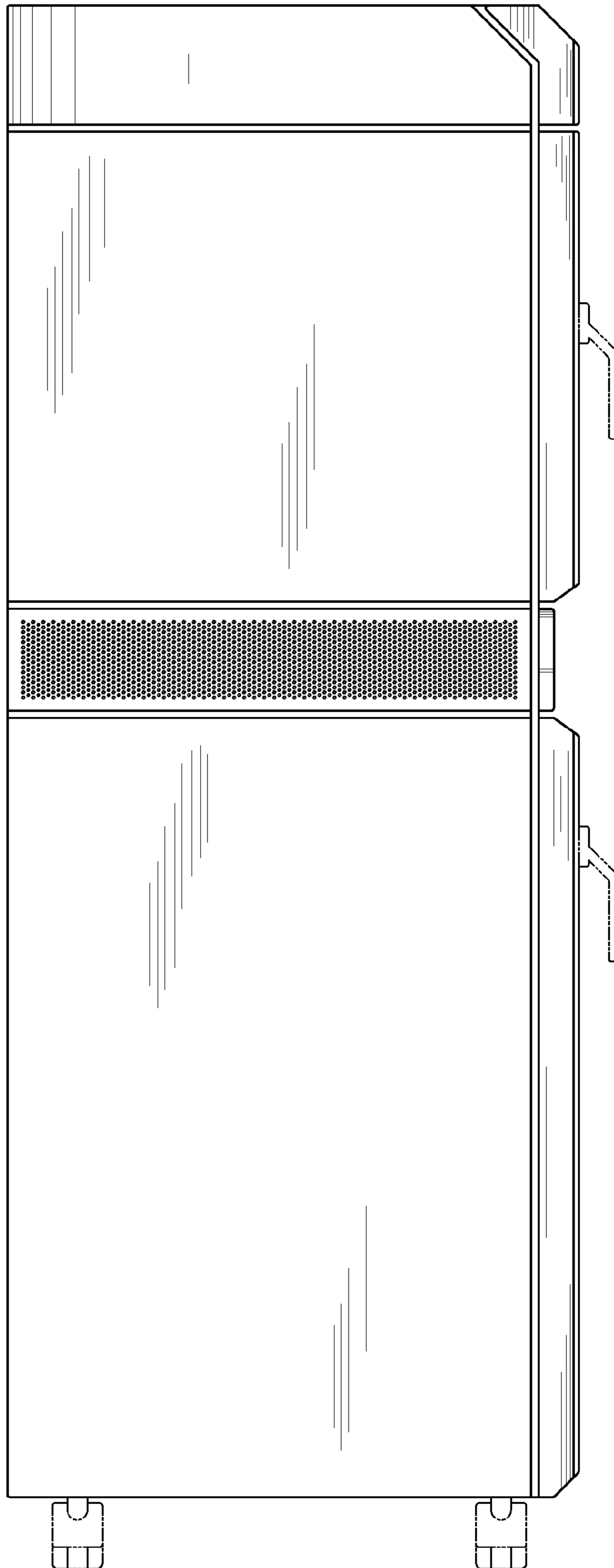

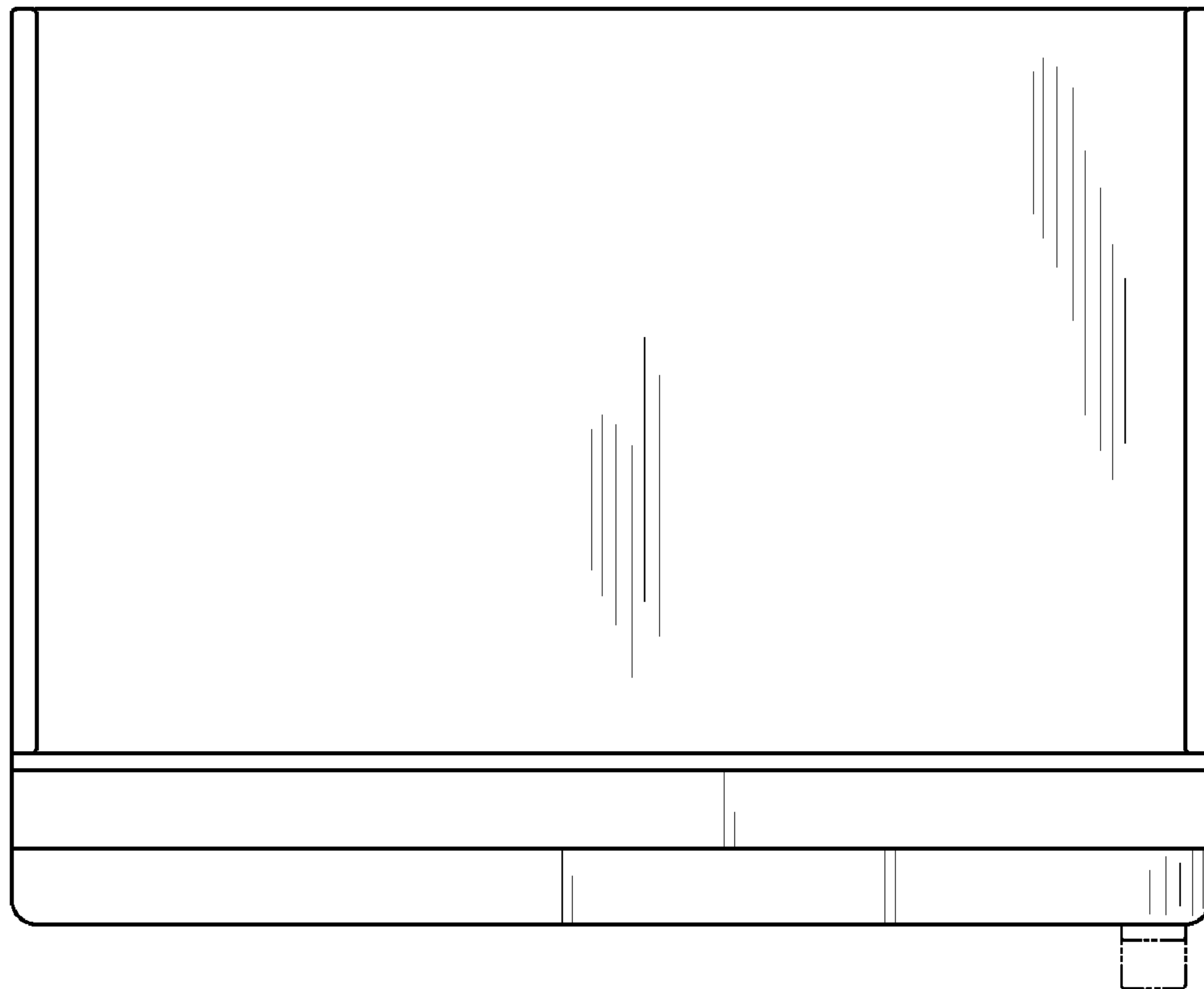
