(57) **CLAIM**

The ornamental design for a power head with contour for cutting attachment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the power head with contour for cutting attachment;

FIG. 2 is a right side view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a rear view thereof;

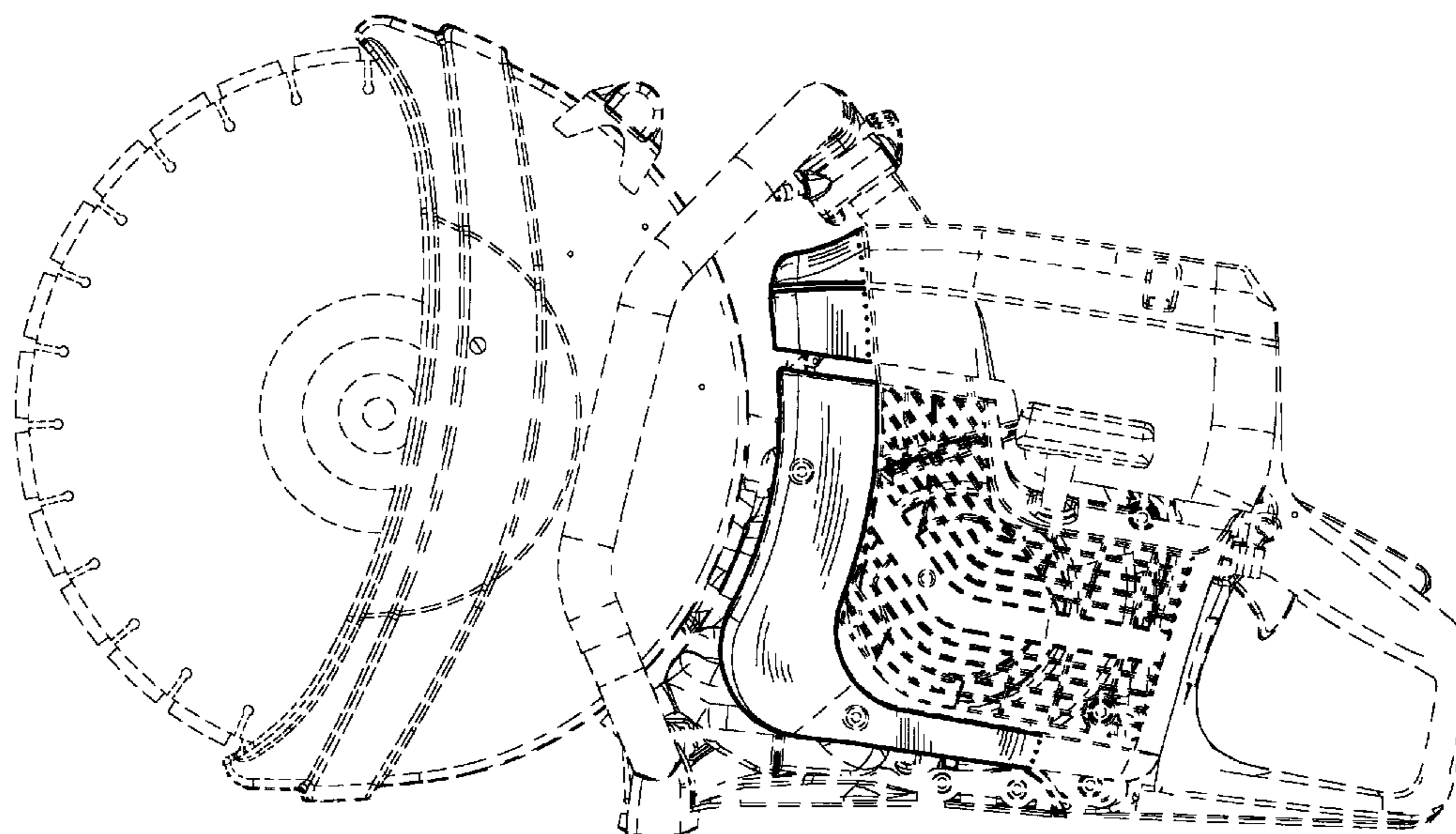
FIG. 5 is a front view thereof;

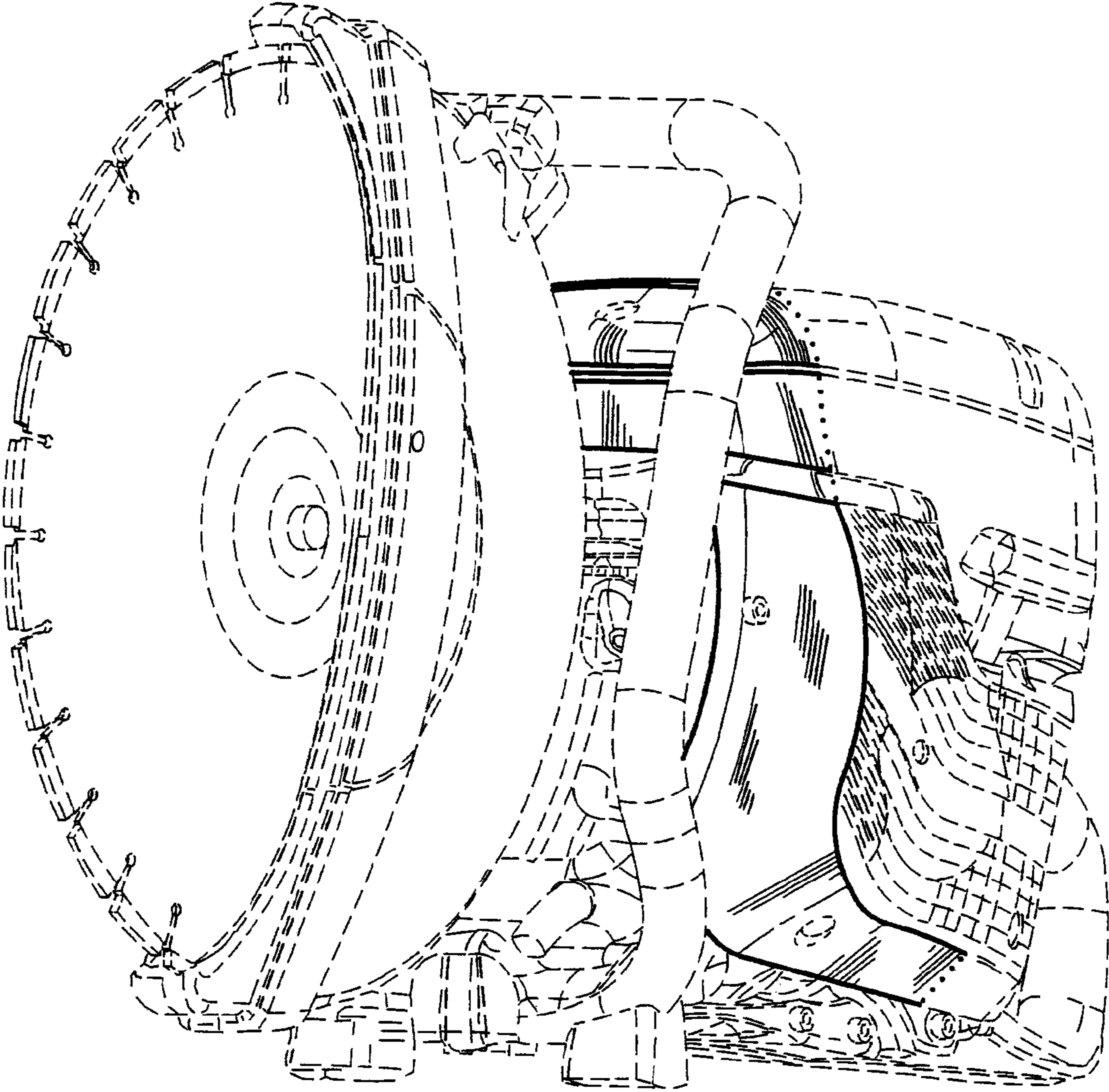

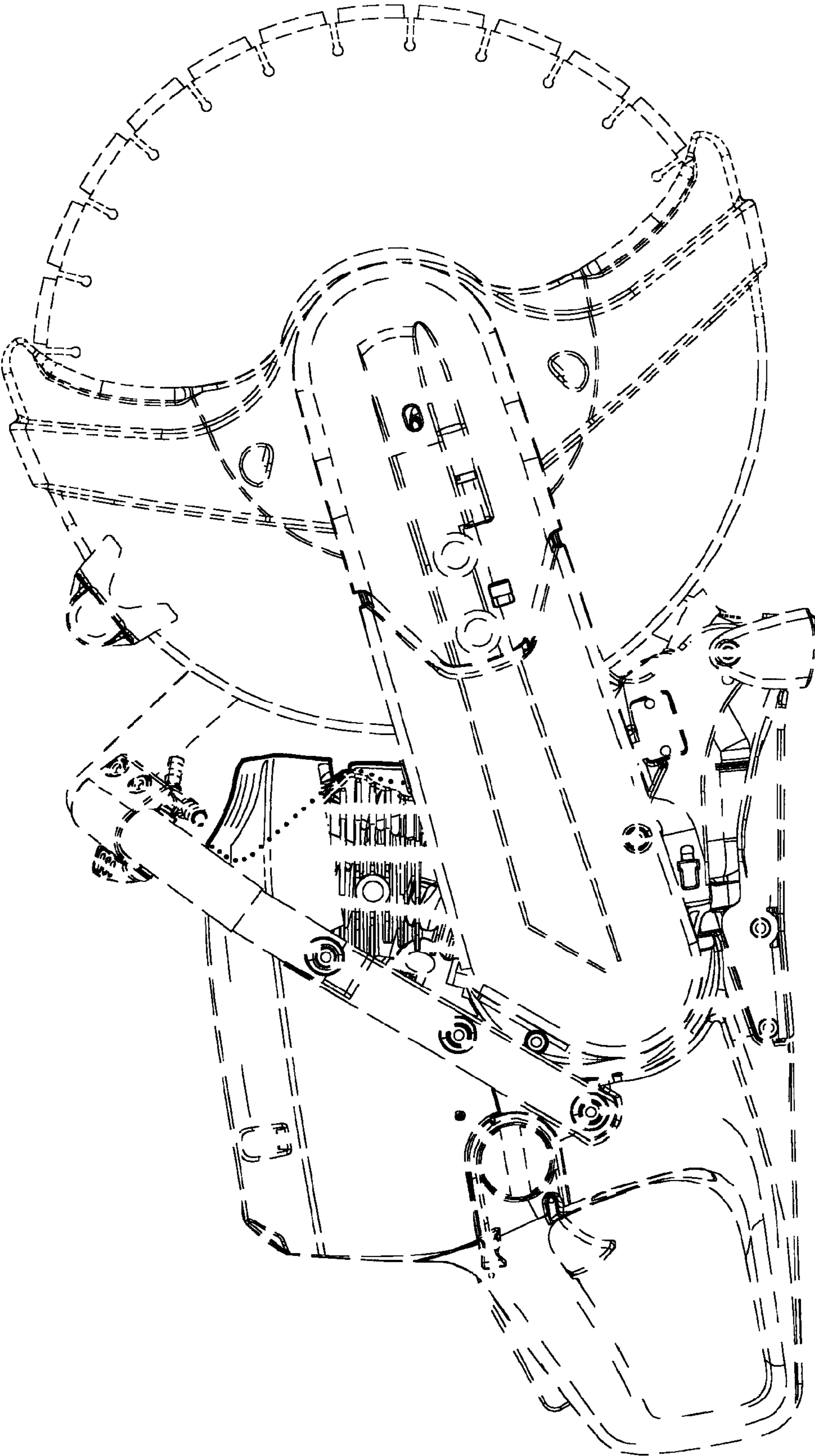

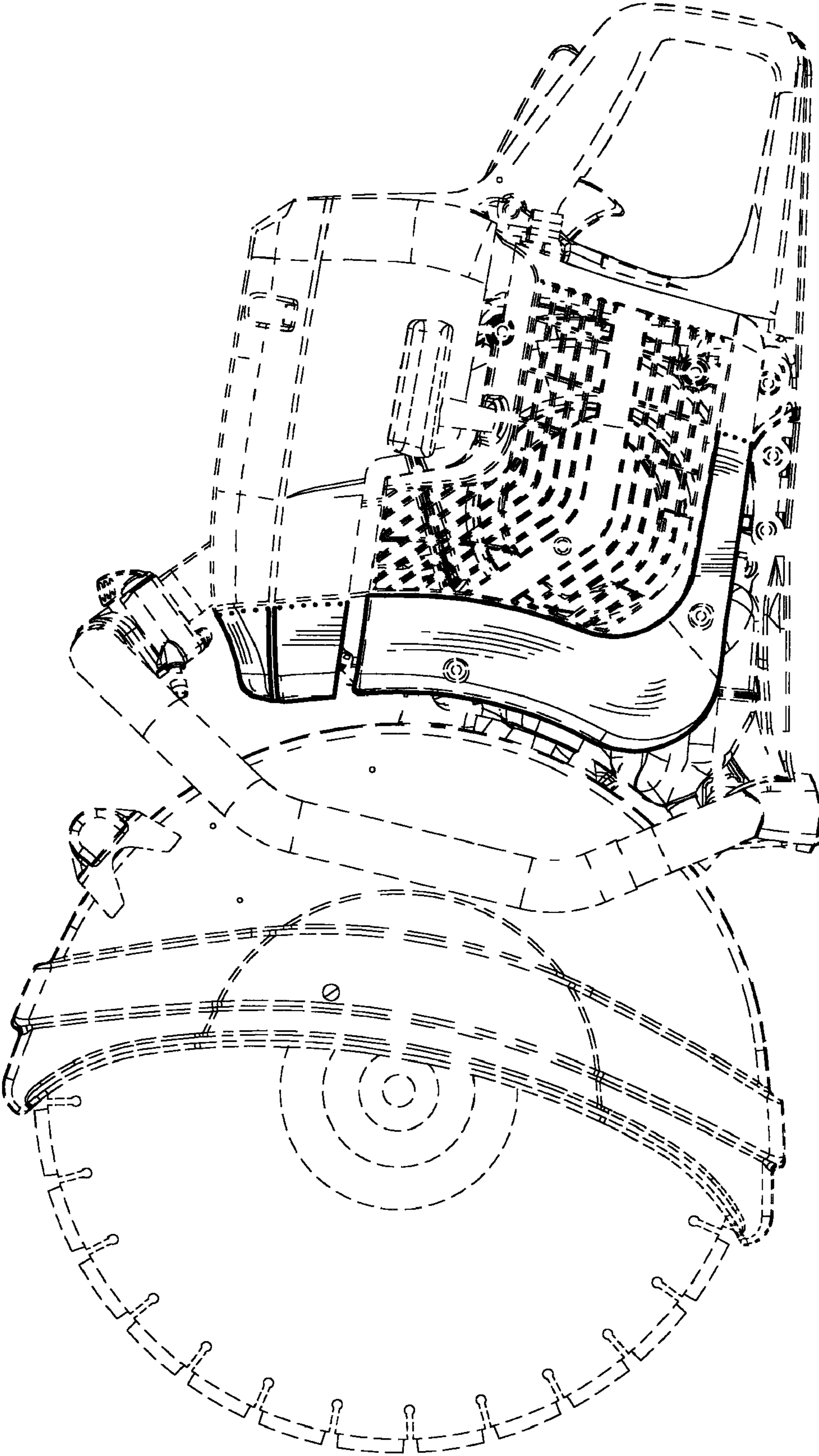

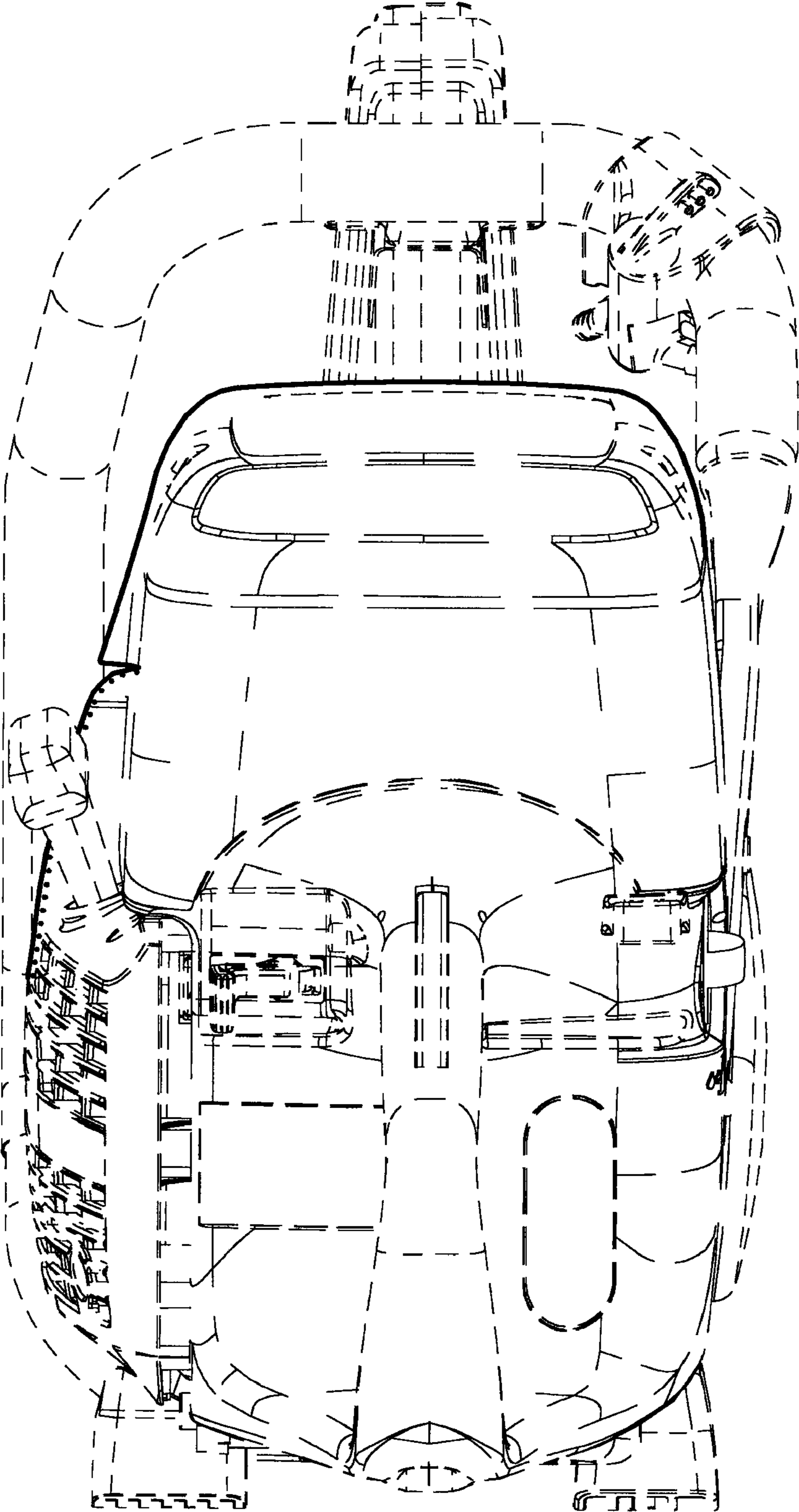

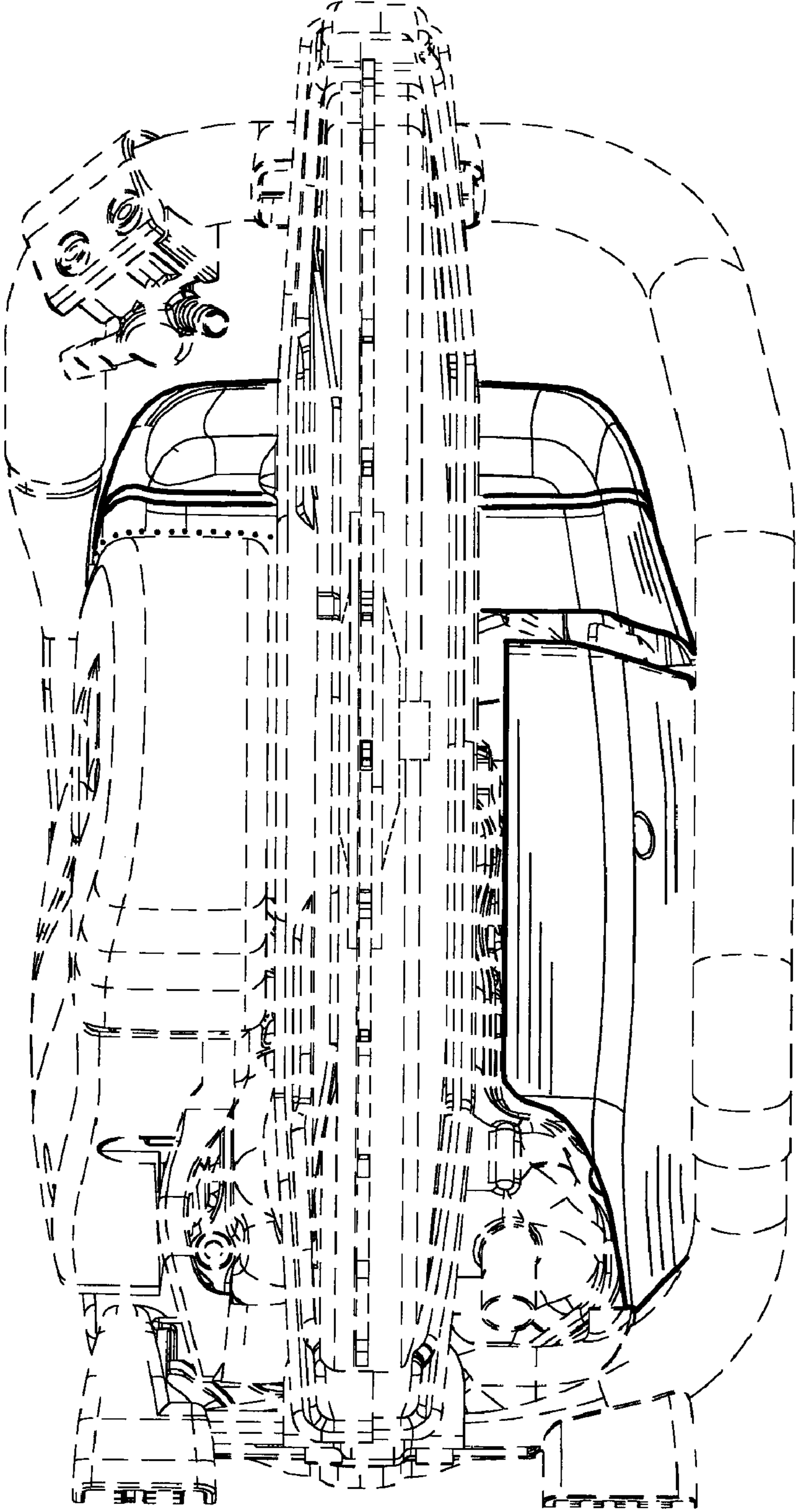

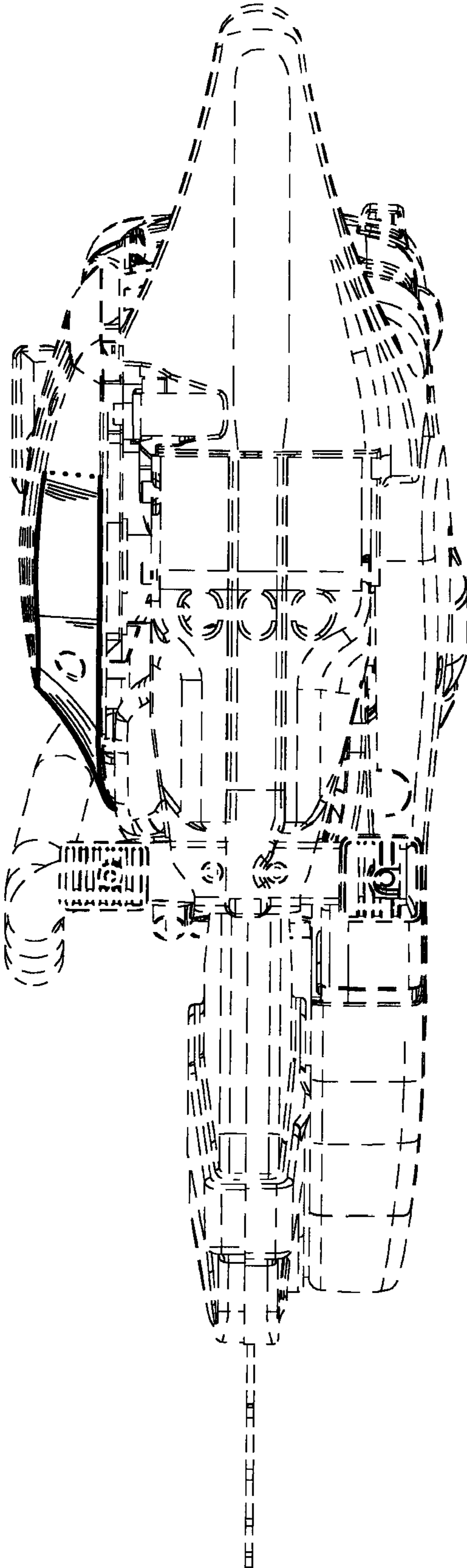

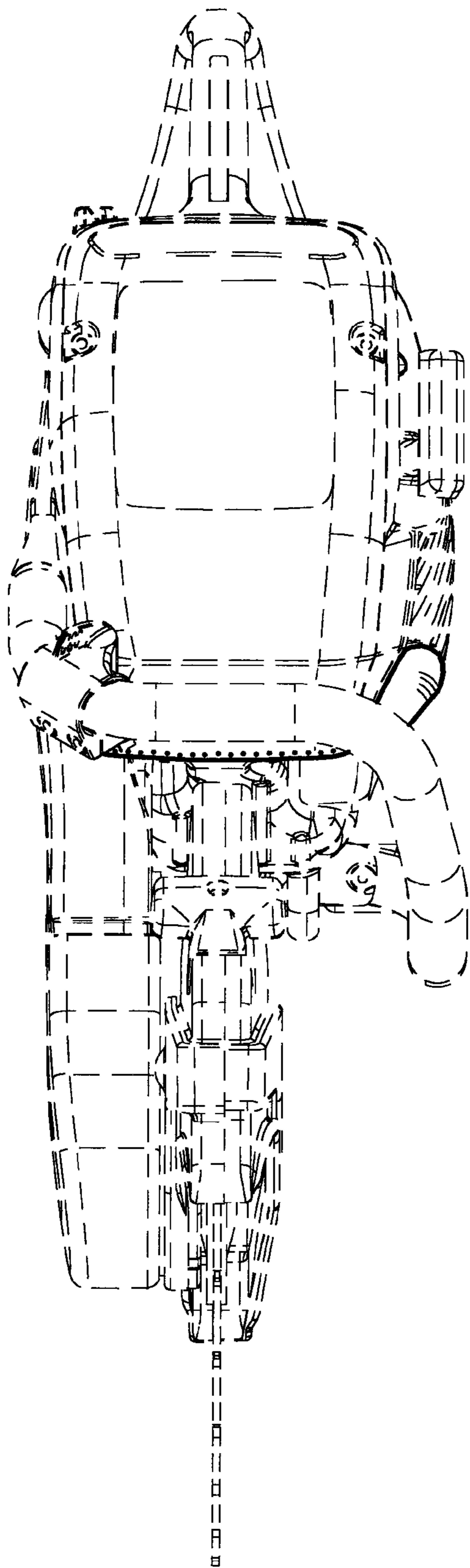
