The ornamental design for a wireless remote housing, as shown and described.

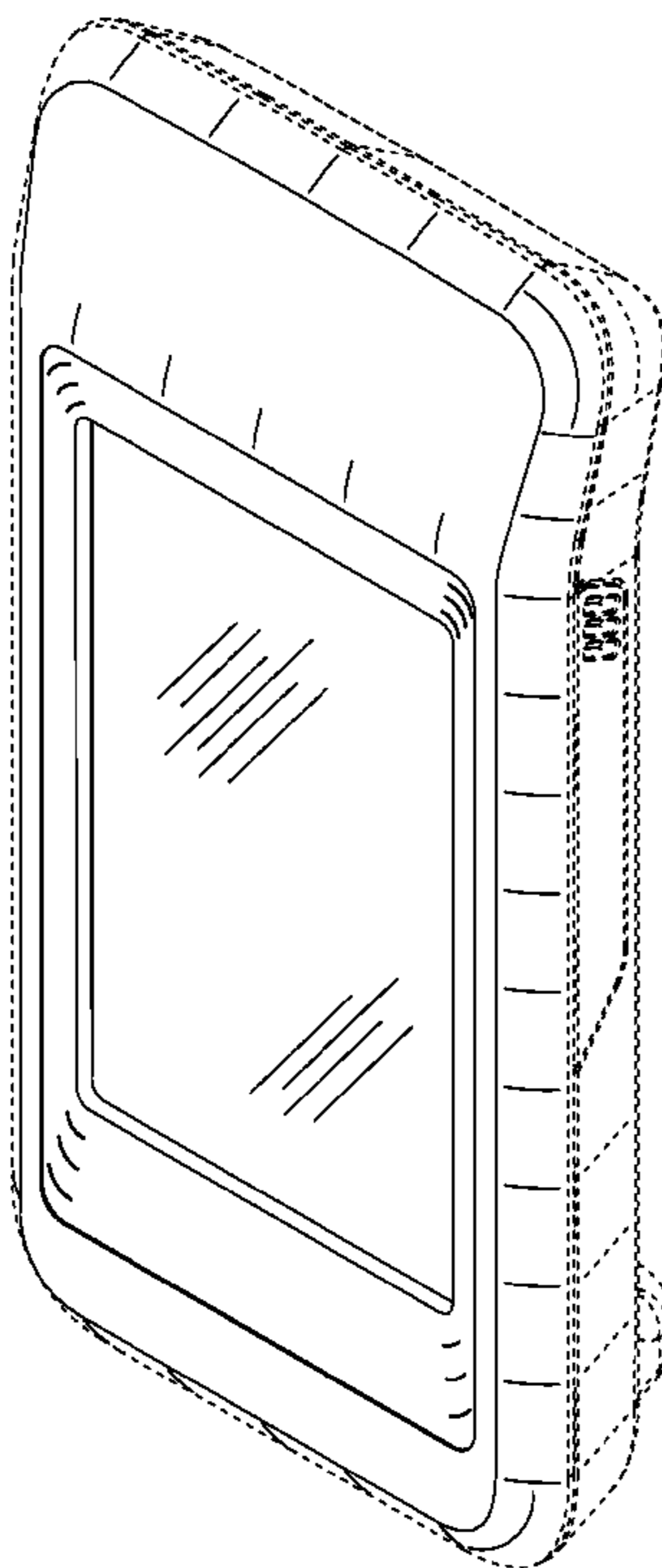
DESCRIPTION

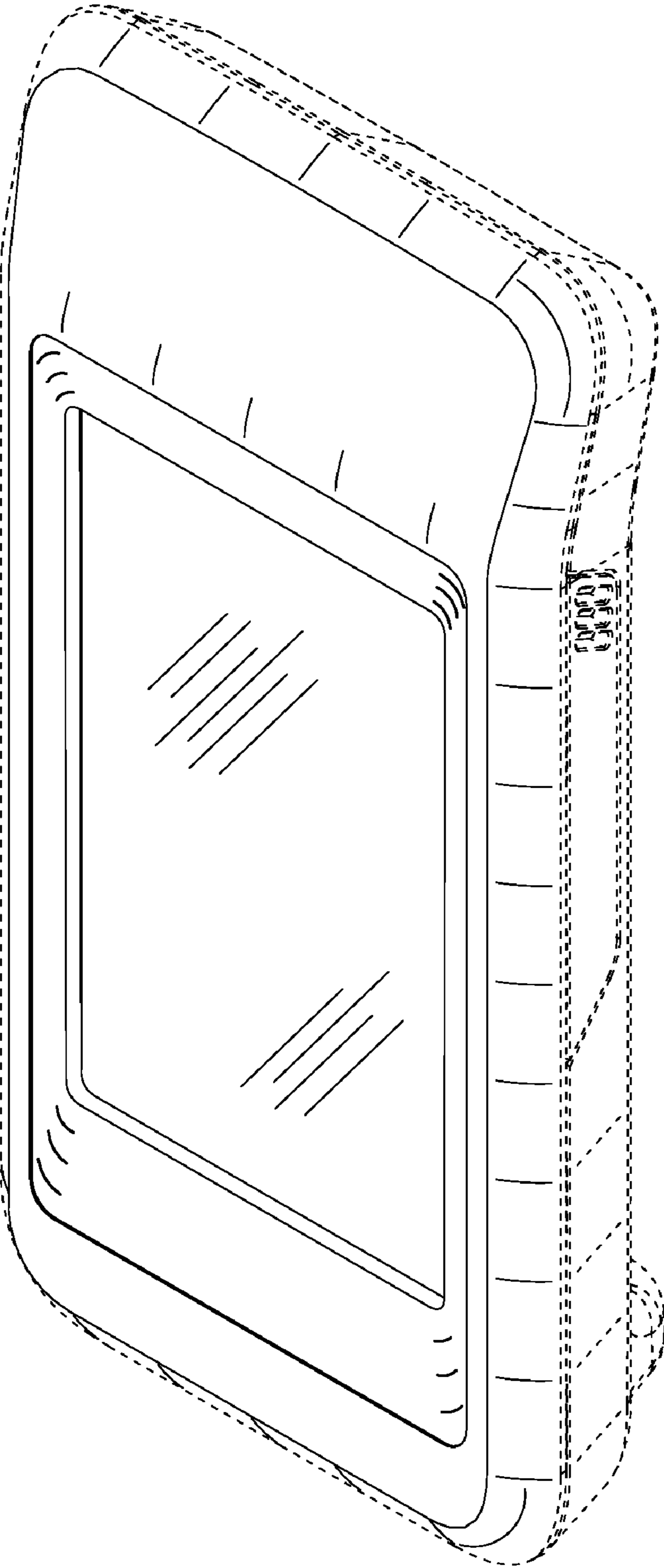

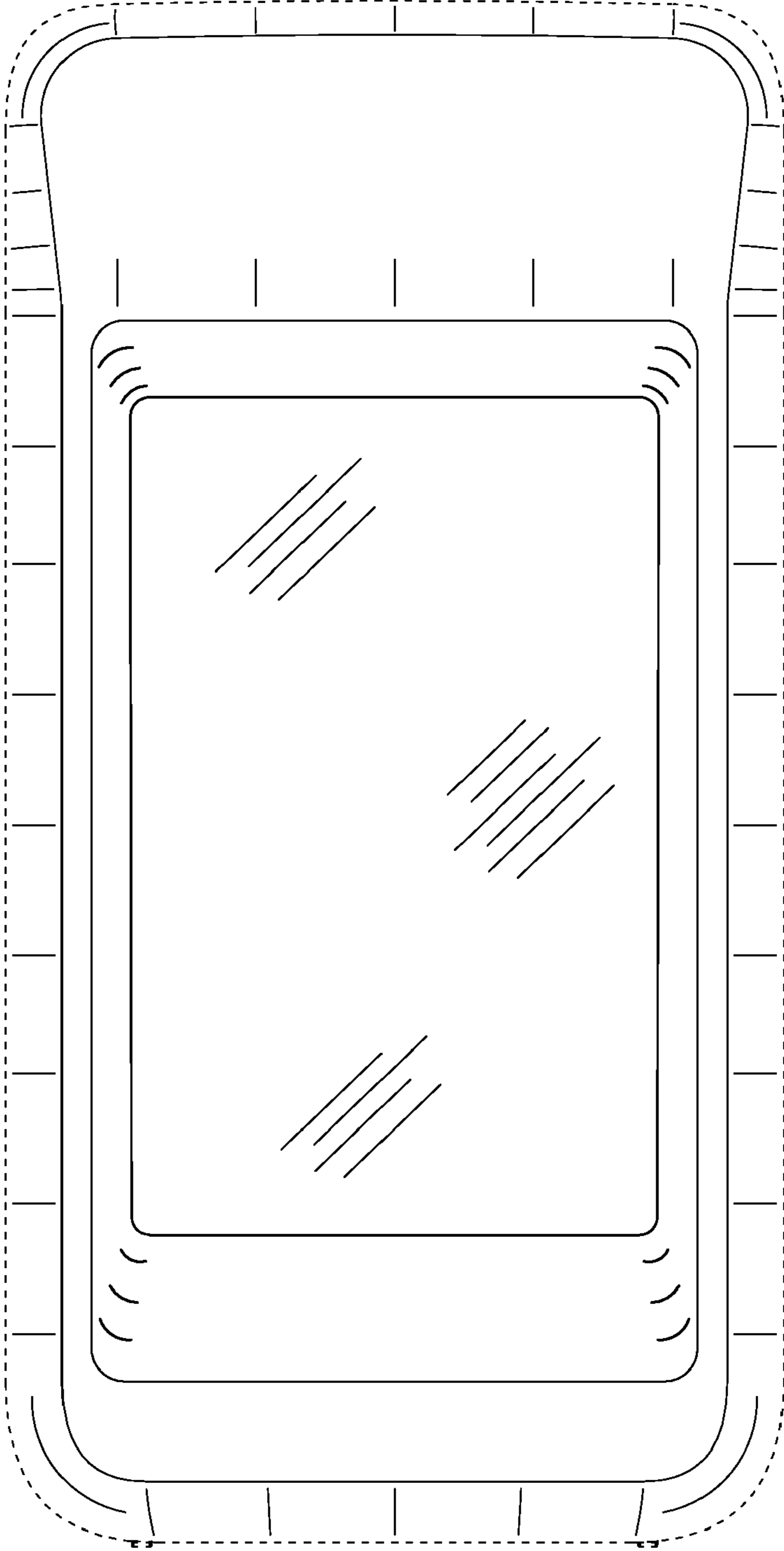

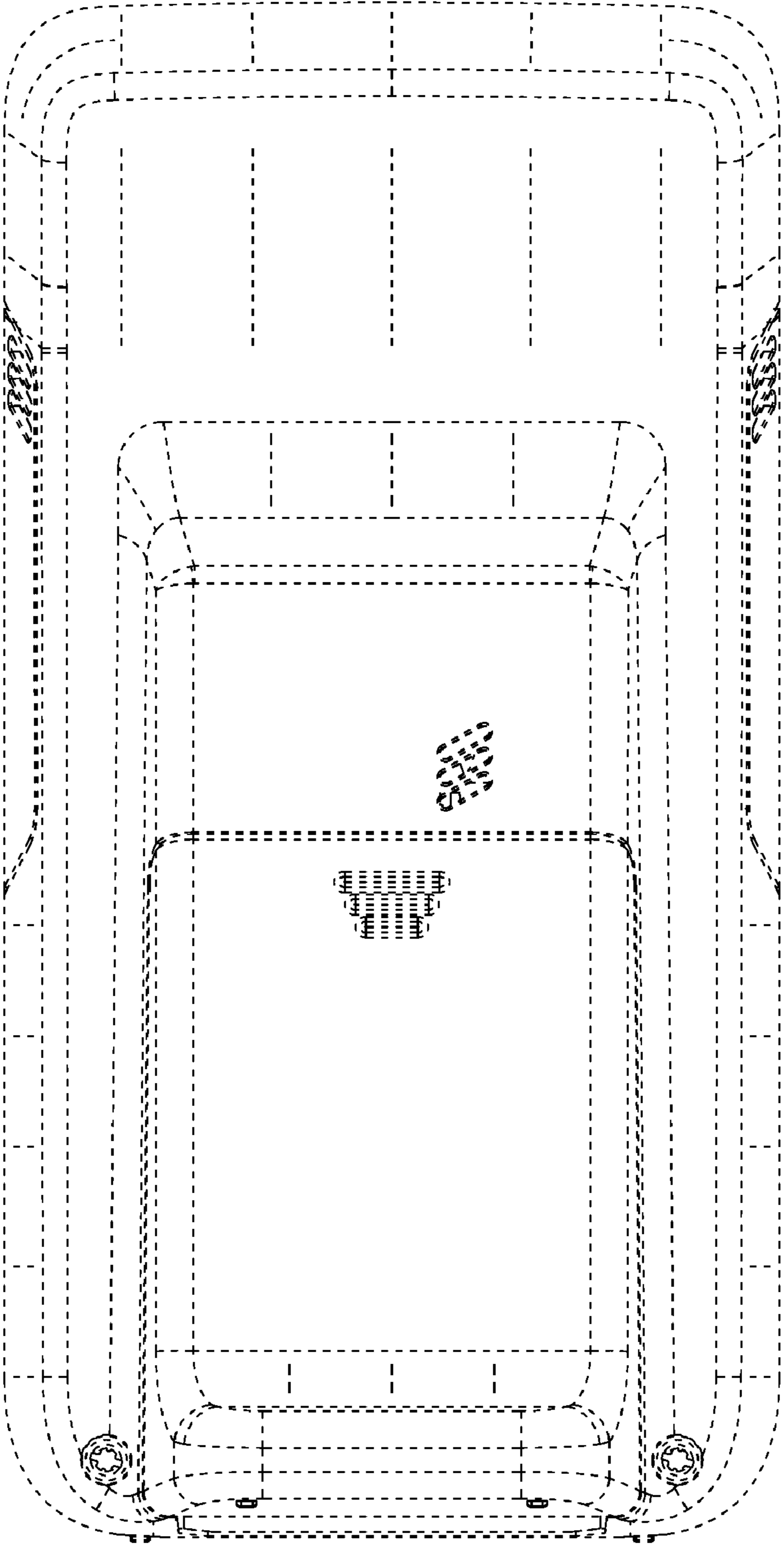

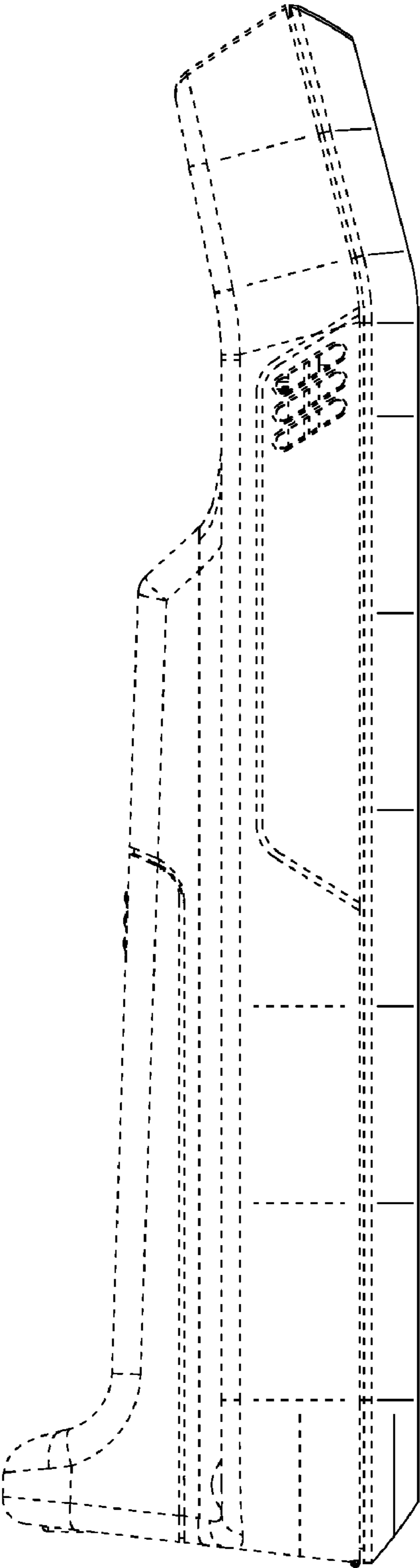

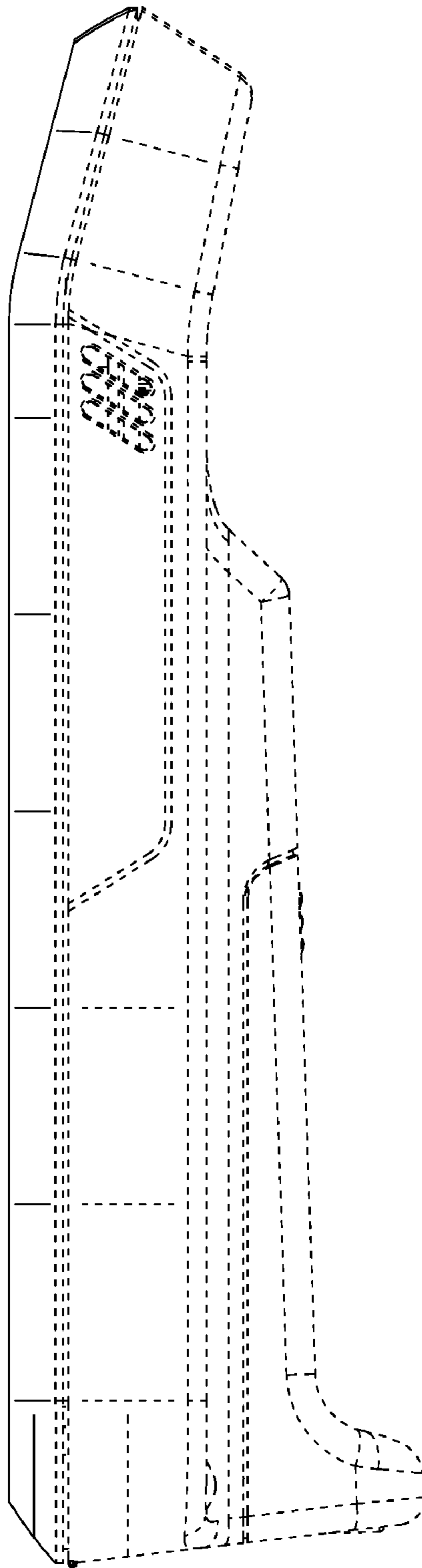

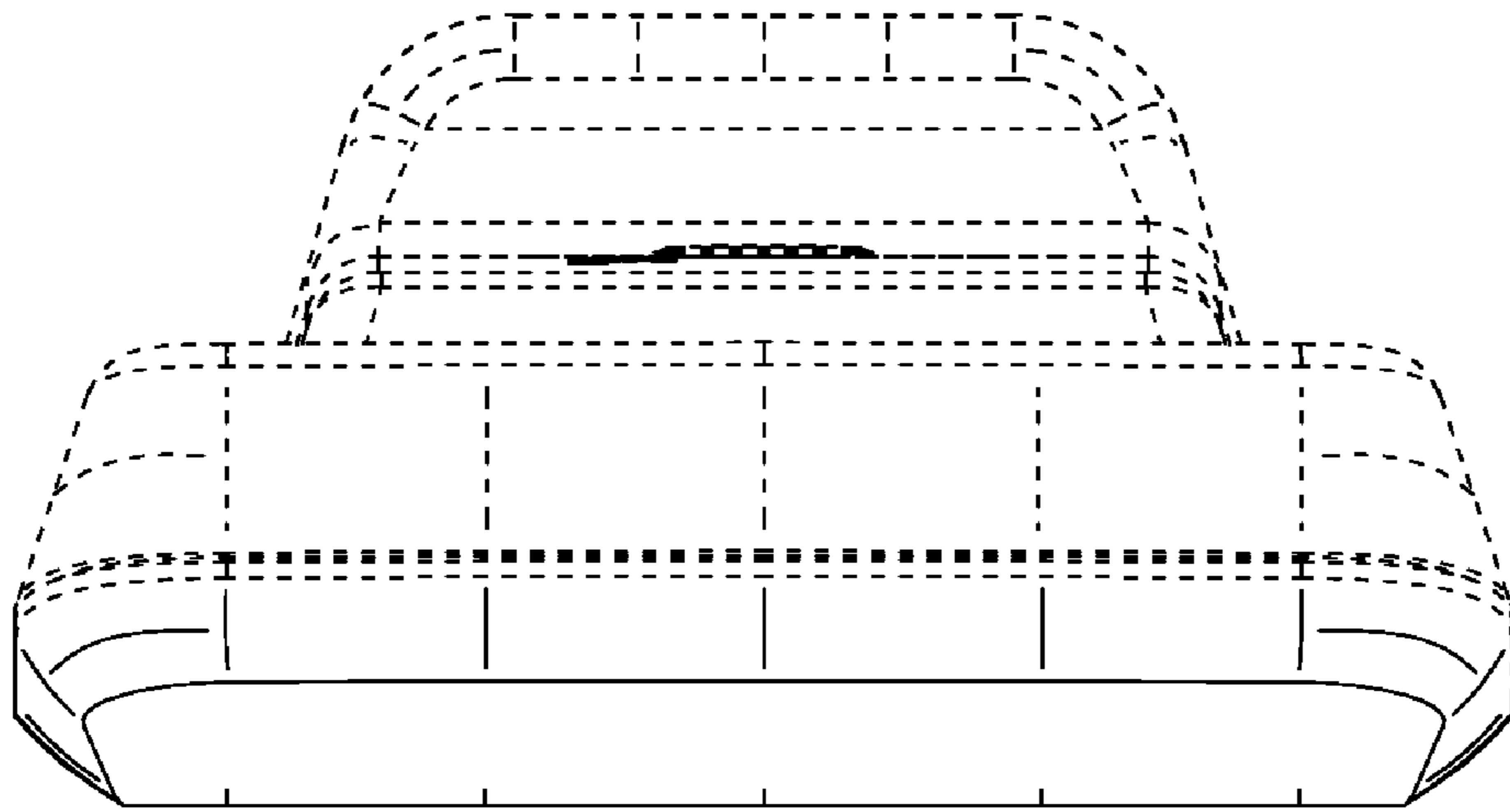

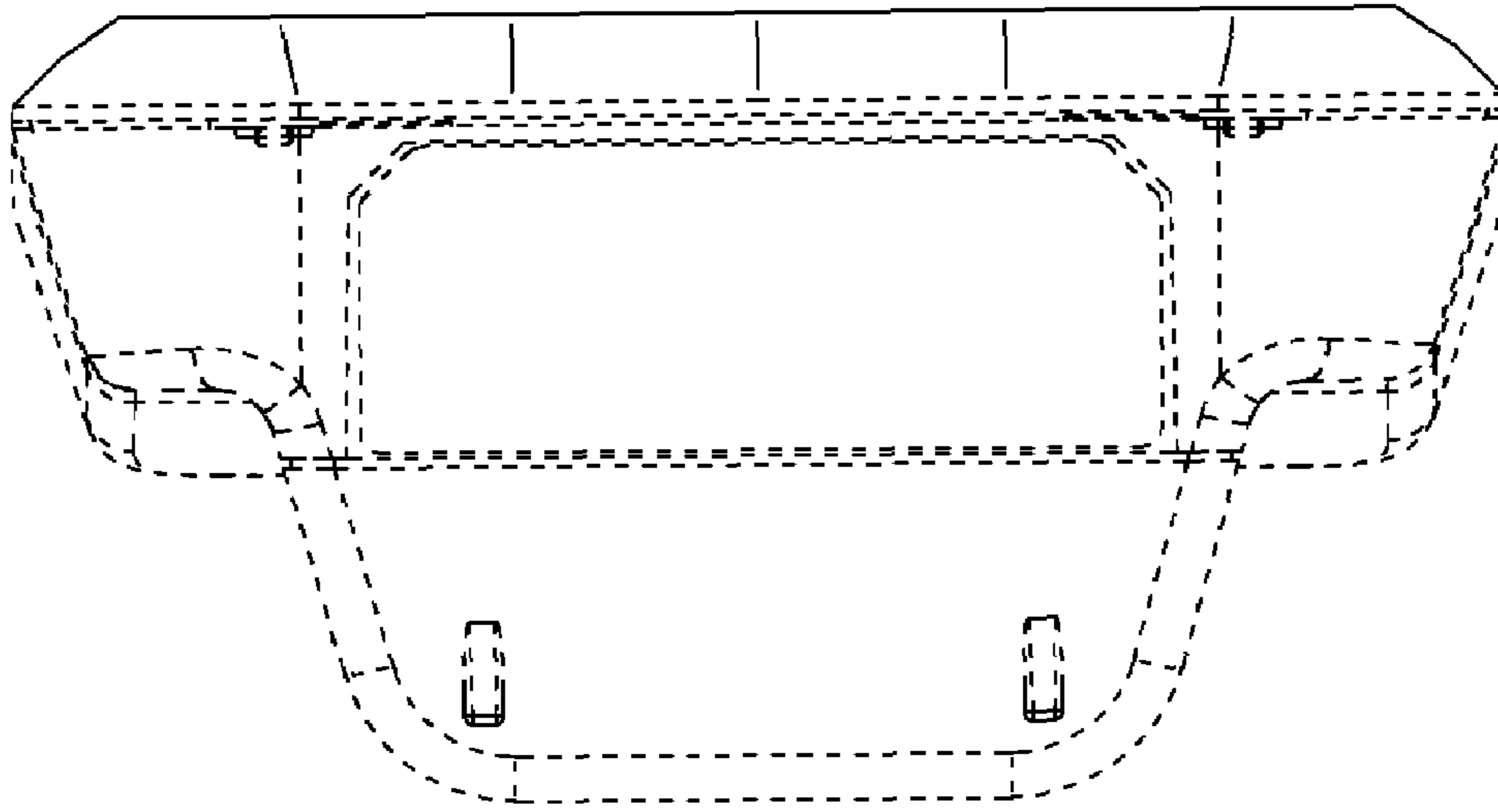
