(57) **CLAIM**

The ornamental design for a balance, as shown and described above.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of the balance;

FIG. 2 is a left side elevation view of the FIG. 1 embodiment, the right side view being a mirror image thereof;

FIG. 3 is a front elevation view of the FIG. 1 embodiment;

FIG. 4 is a rear elevation view of the FIG. 1 embodiment;

FIG. 5 is a top plan view of the FIG. 1 embodiment;

FIG. 6 is a bottom plan view of the FIG. 1 embodiment;

FIG. 7 is a front perspective view of a second embodiment of the balance;

FIG. 8 is a left side elevation view of the FIG. 7 embodiment, the right side view being a mirror image thereof;

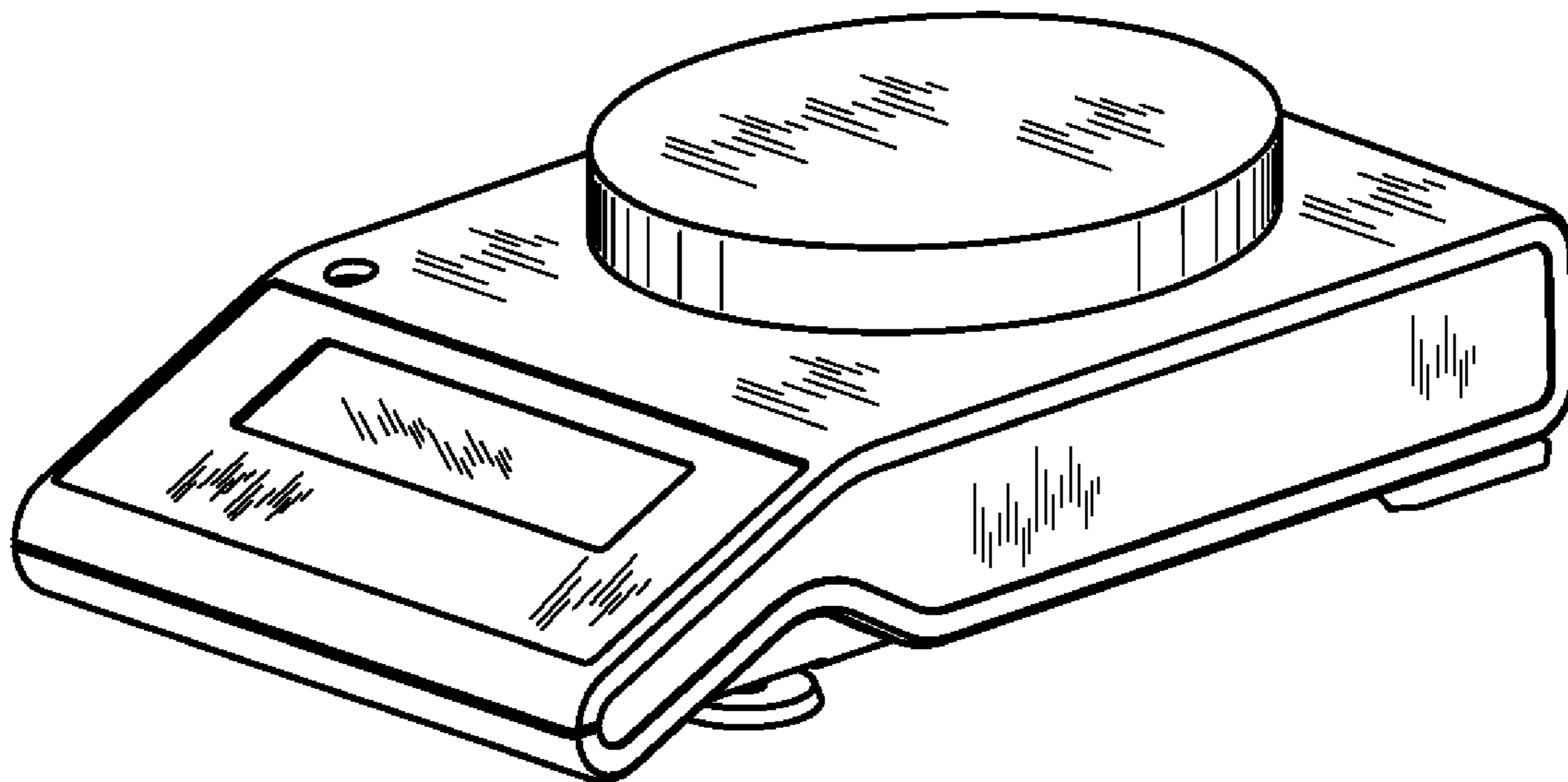
FIG. 9 is a front elevation view of the FIG. 7 embodiment;

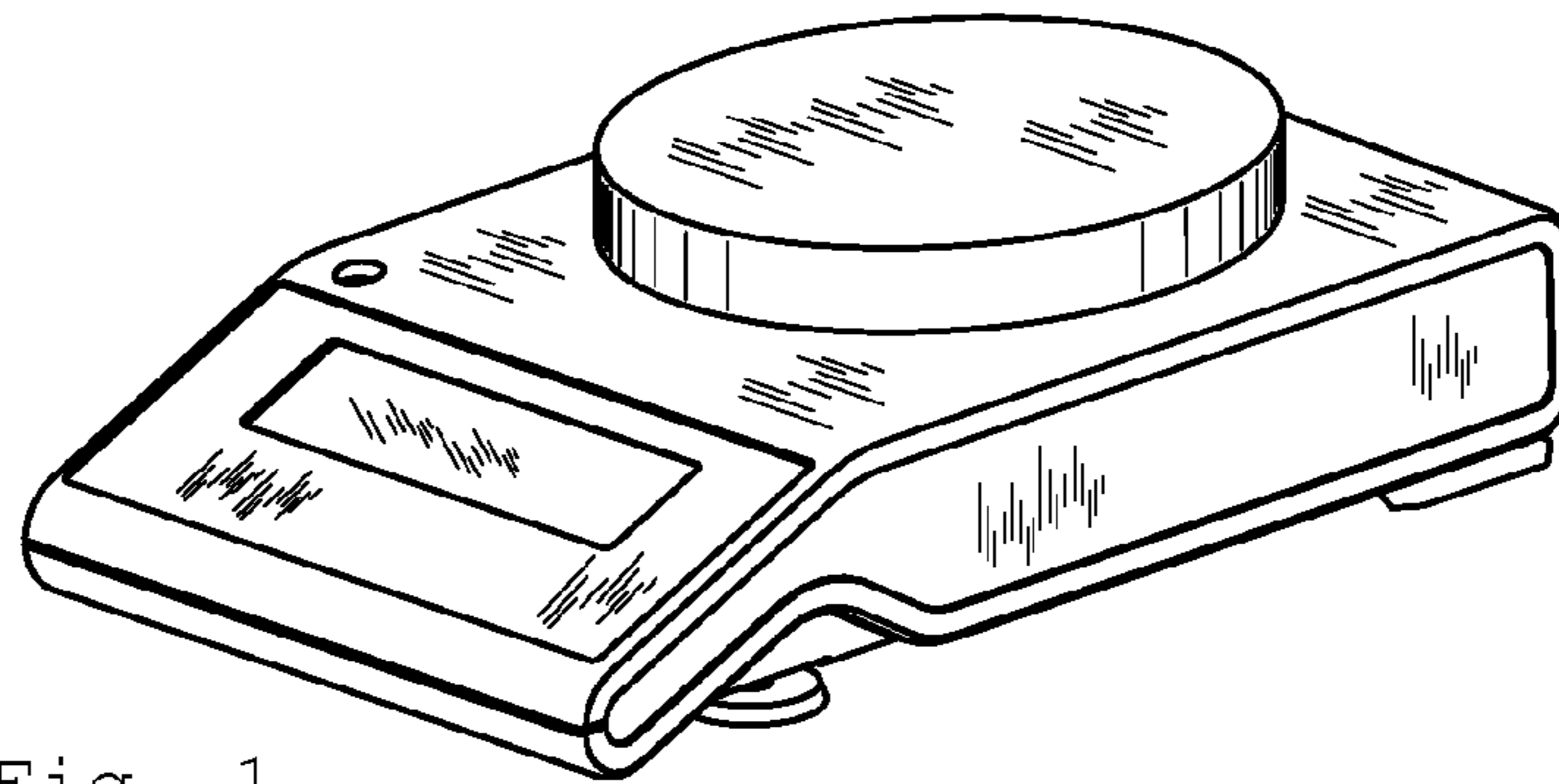

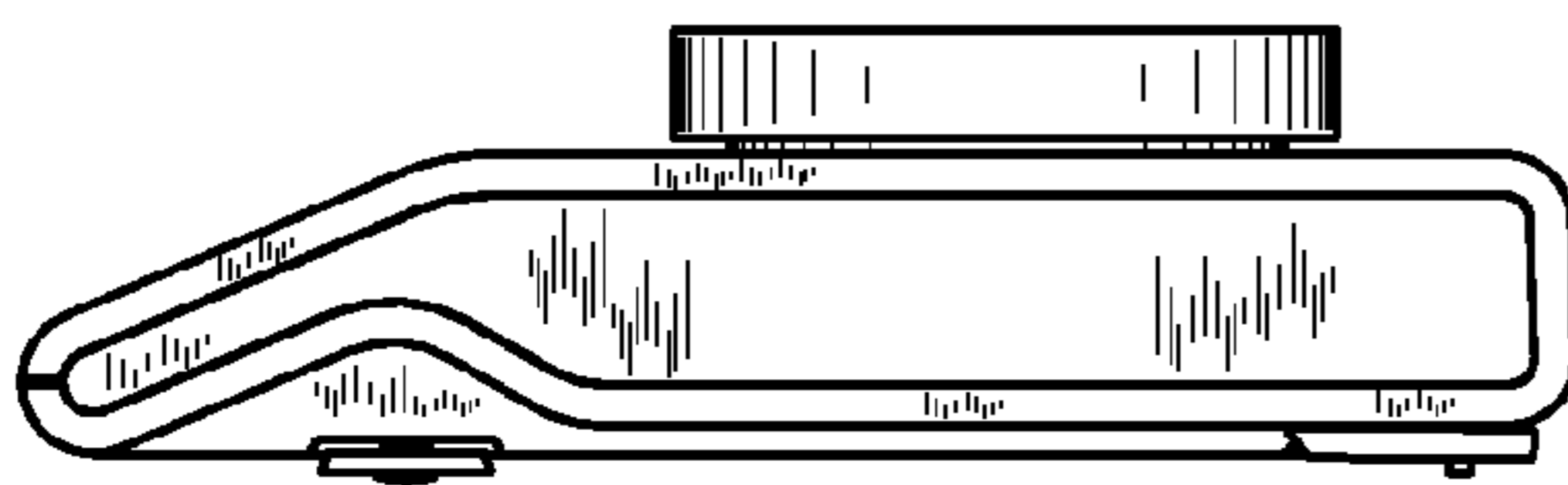

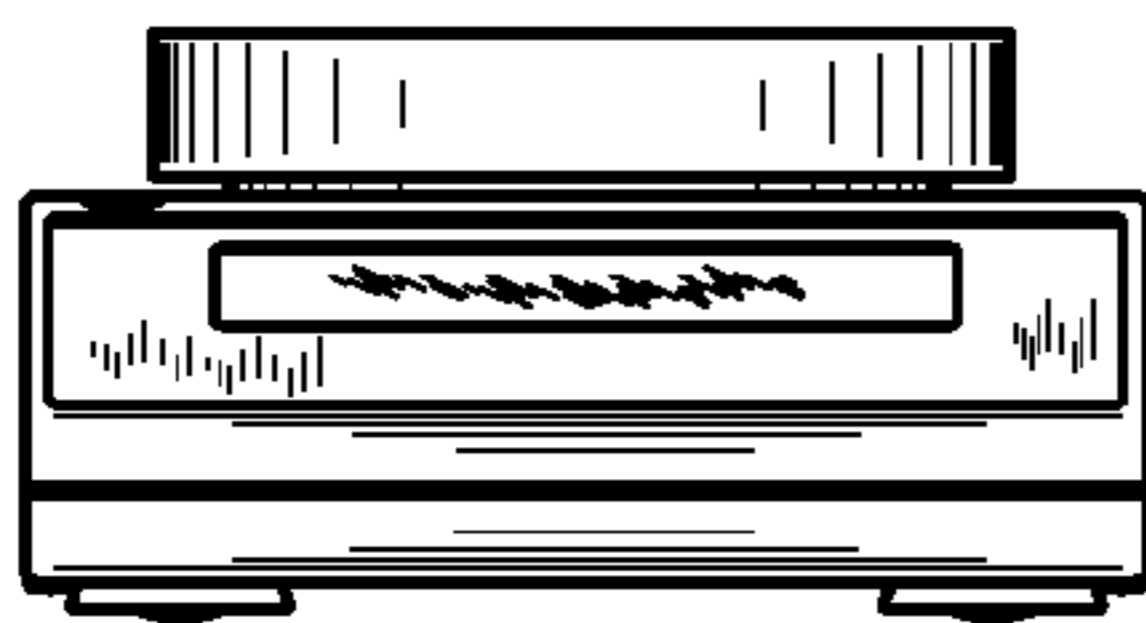

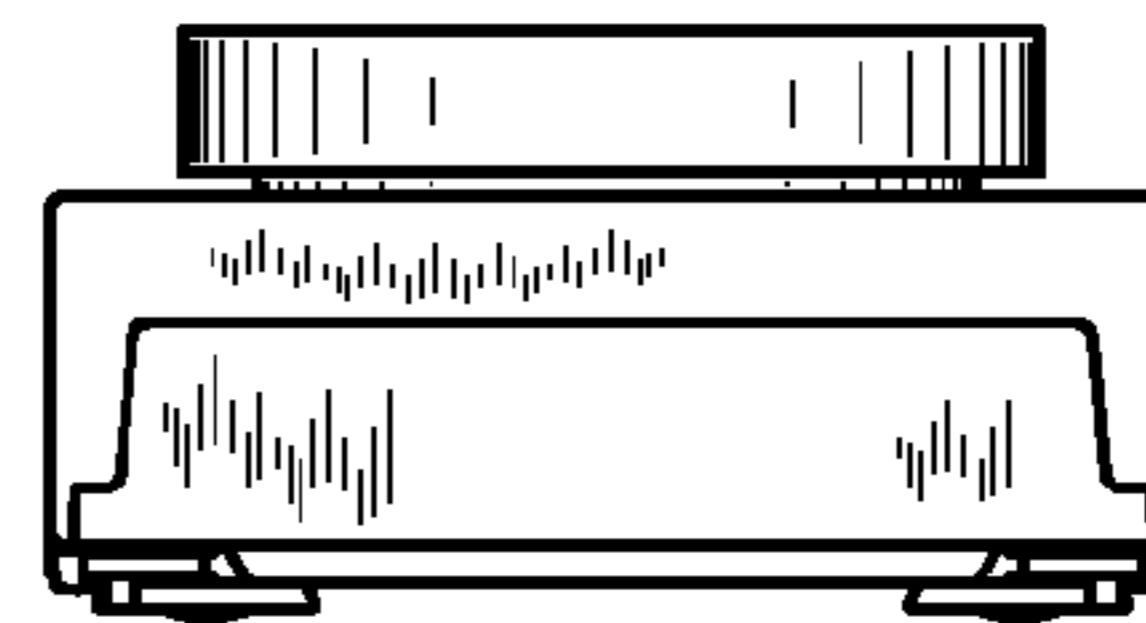

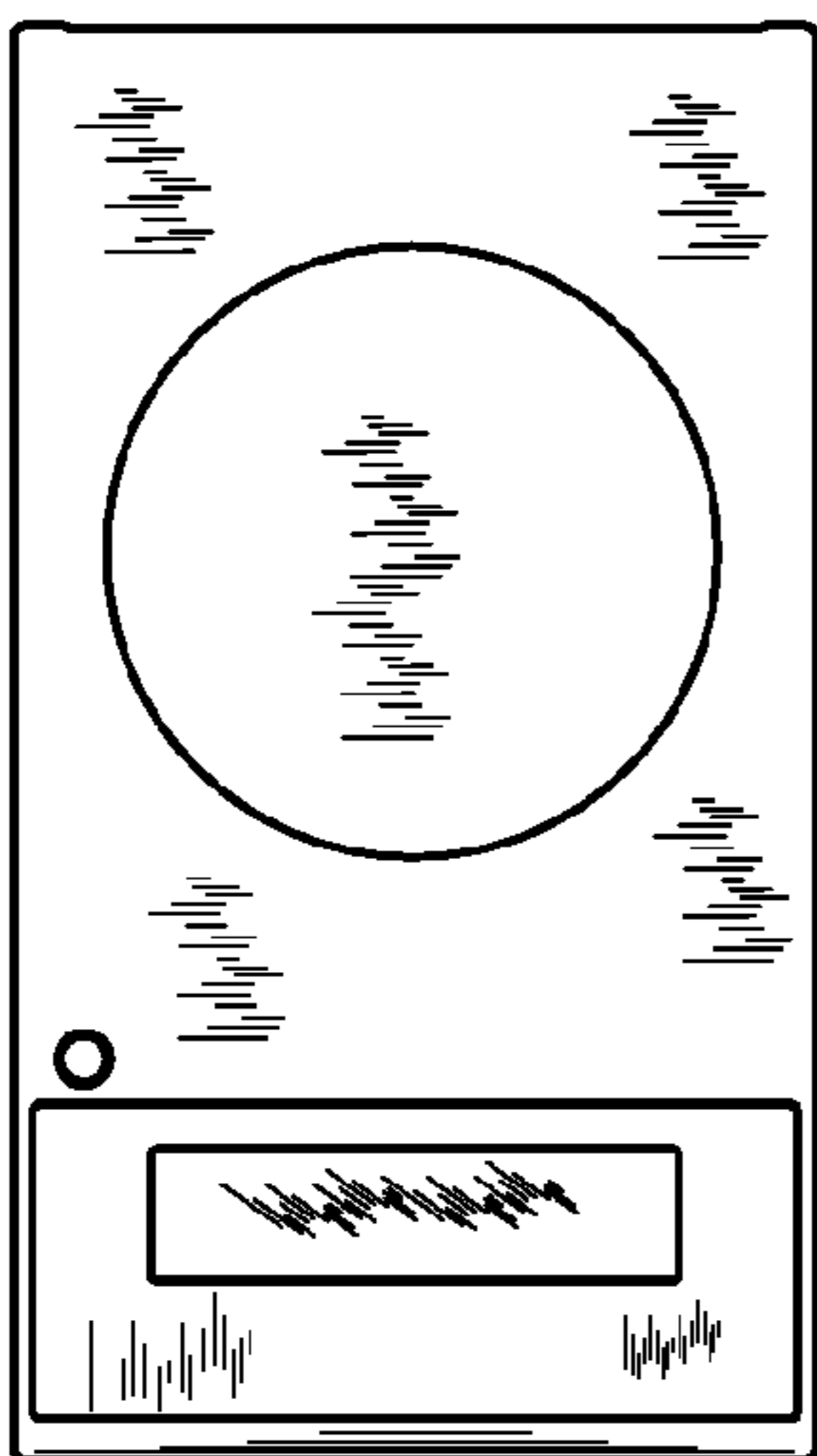

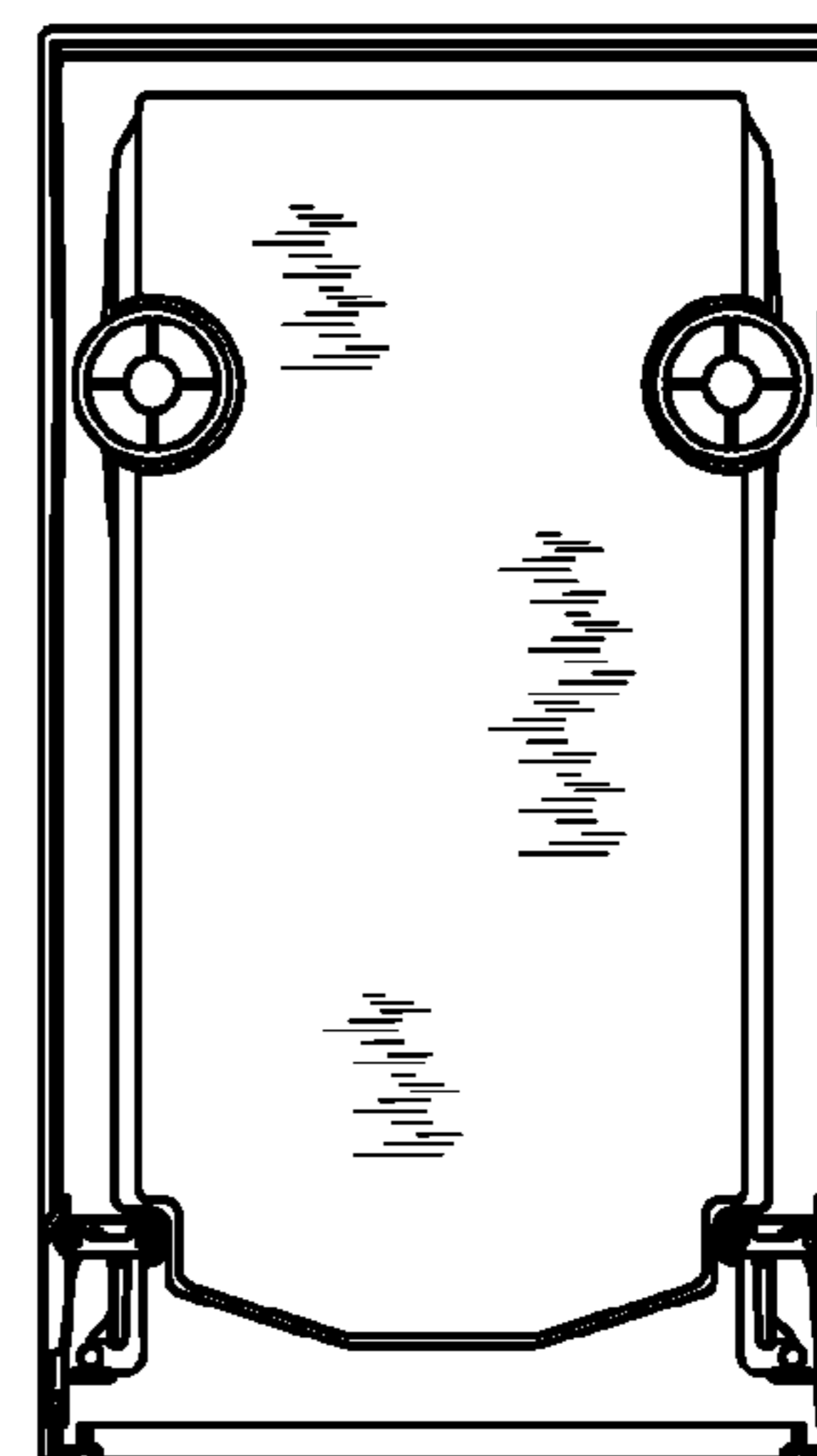

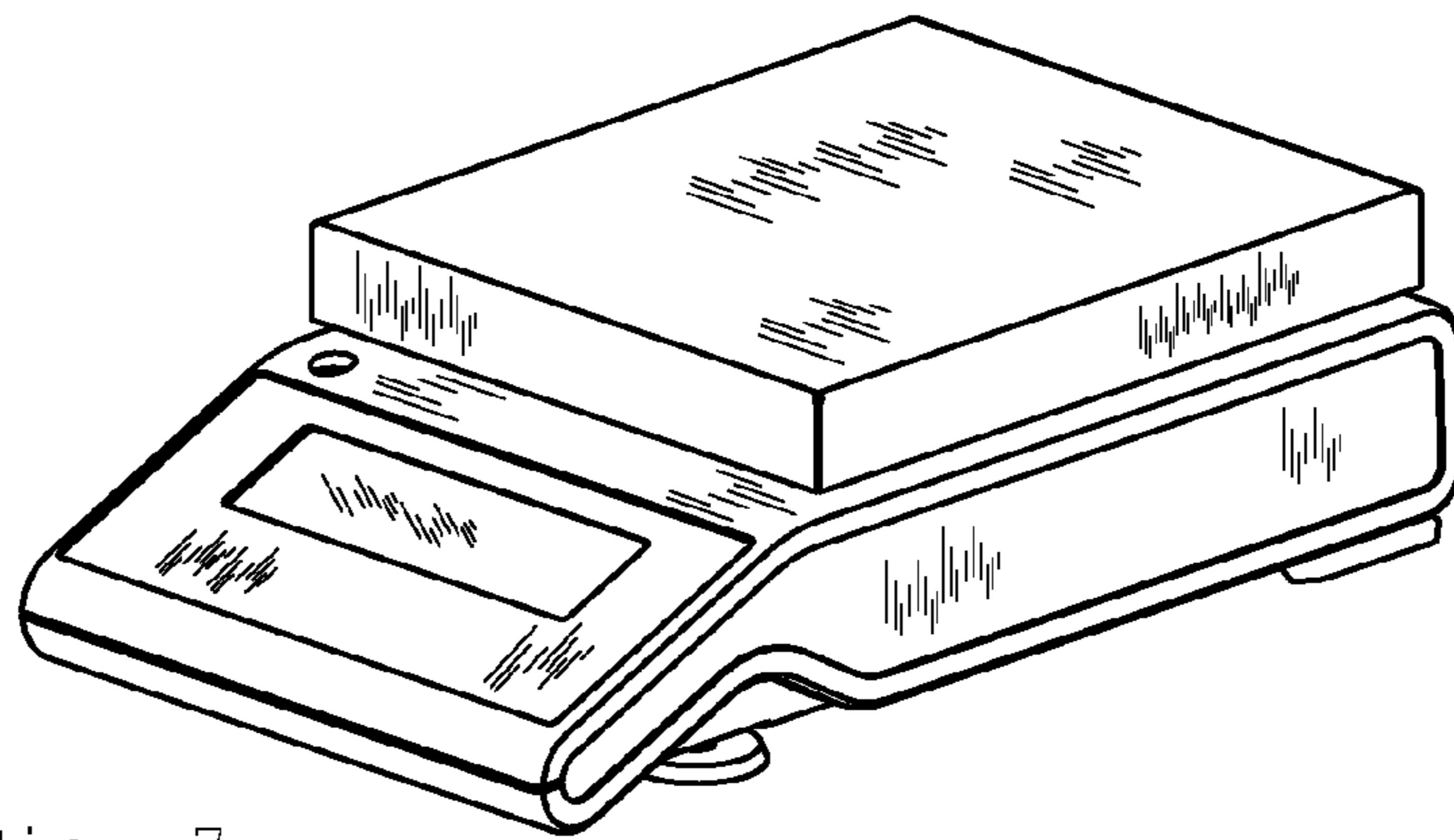

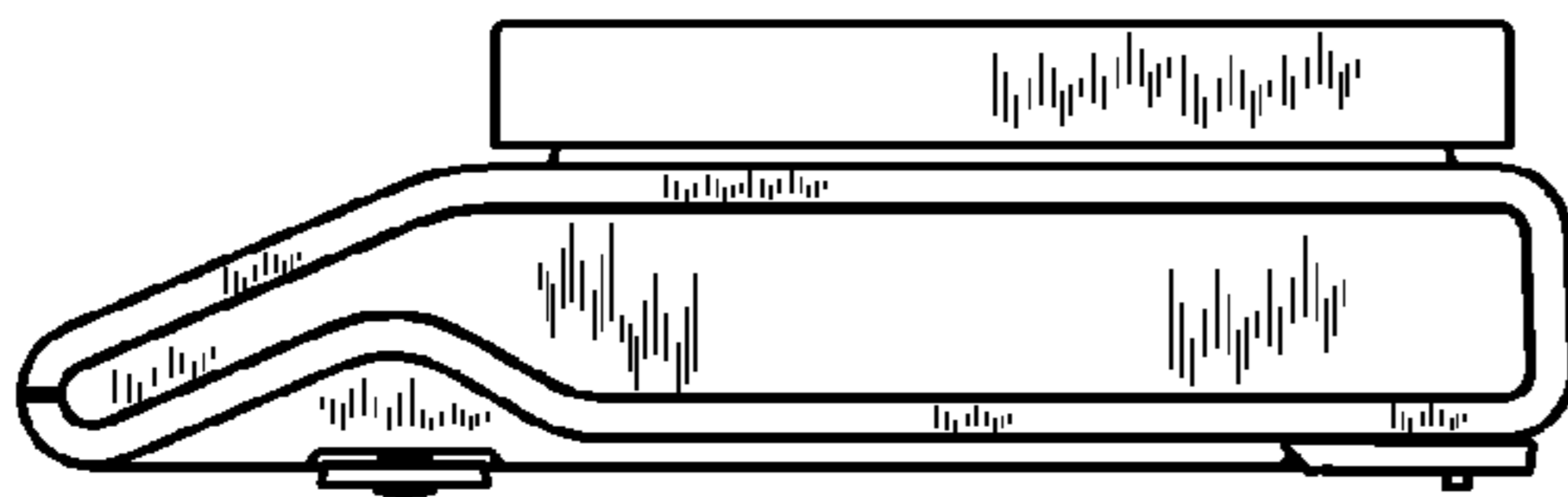

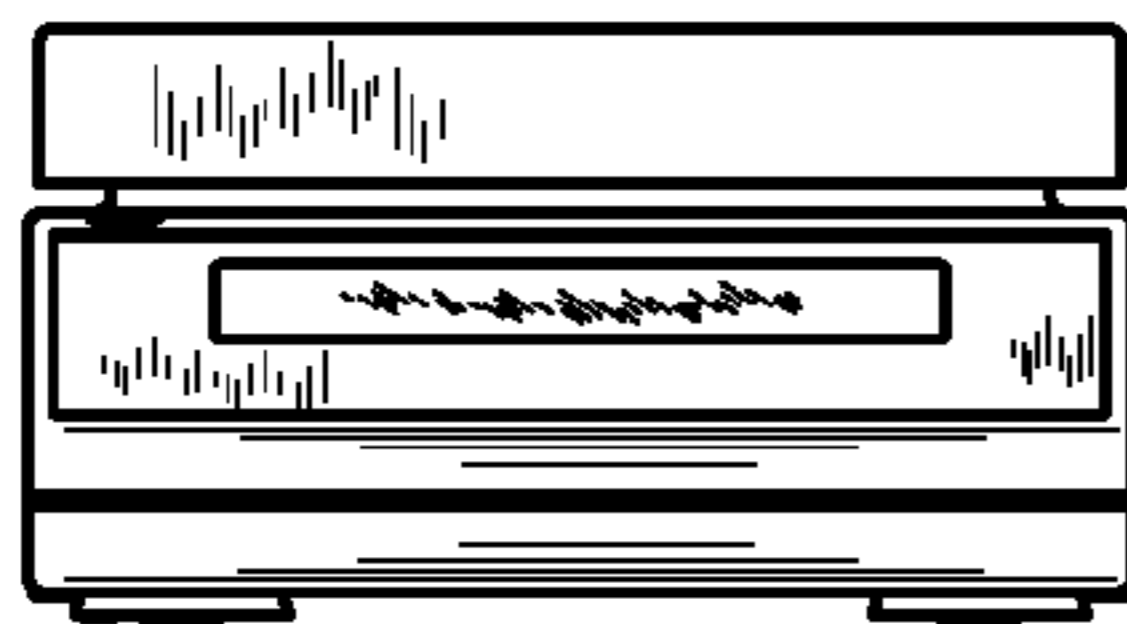

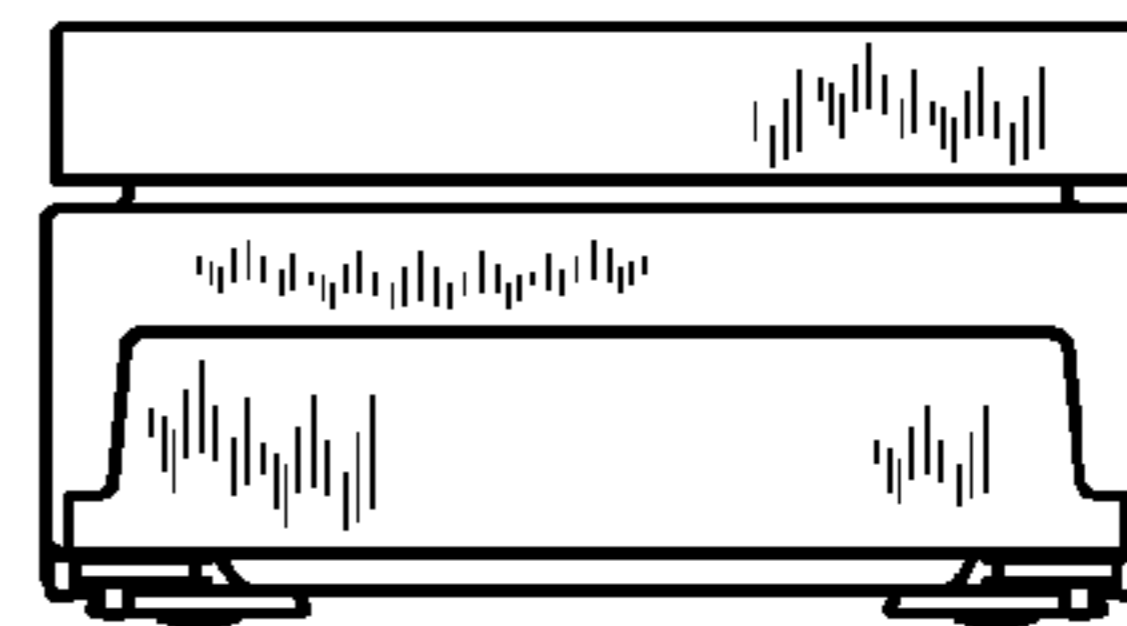

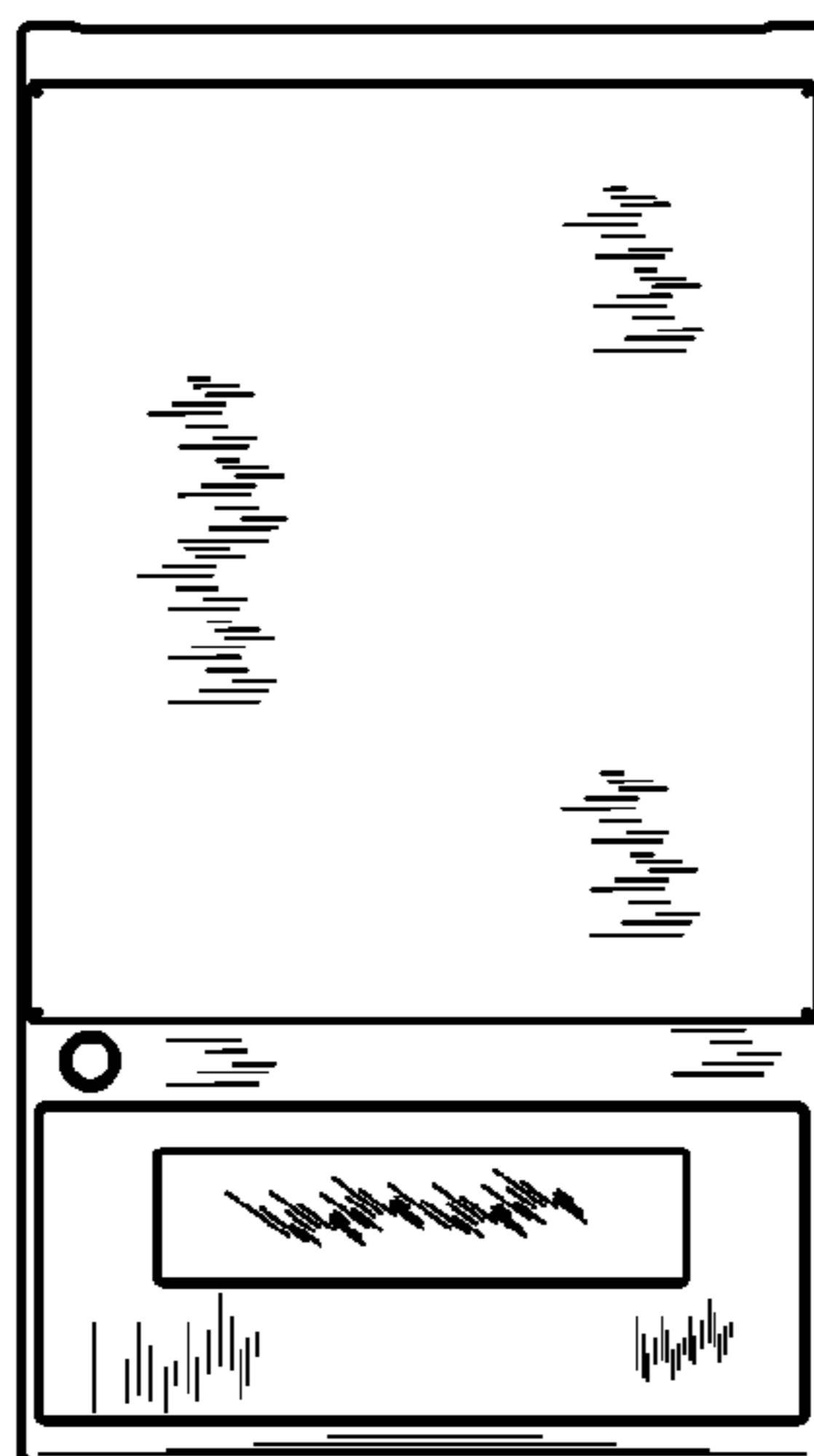

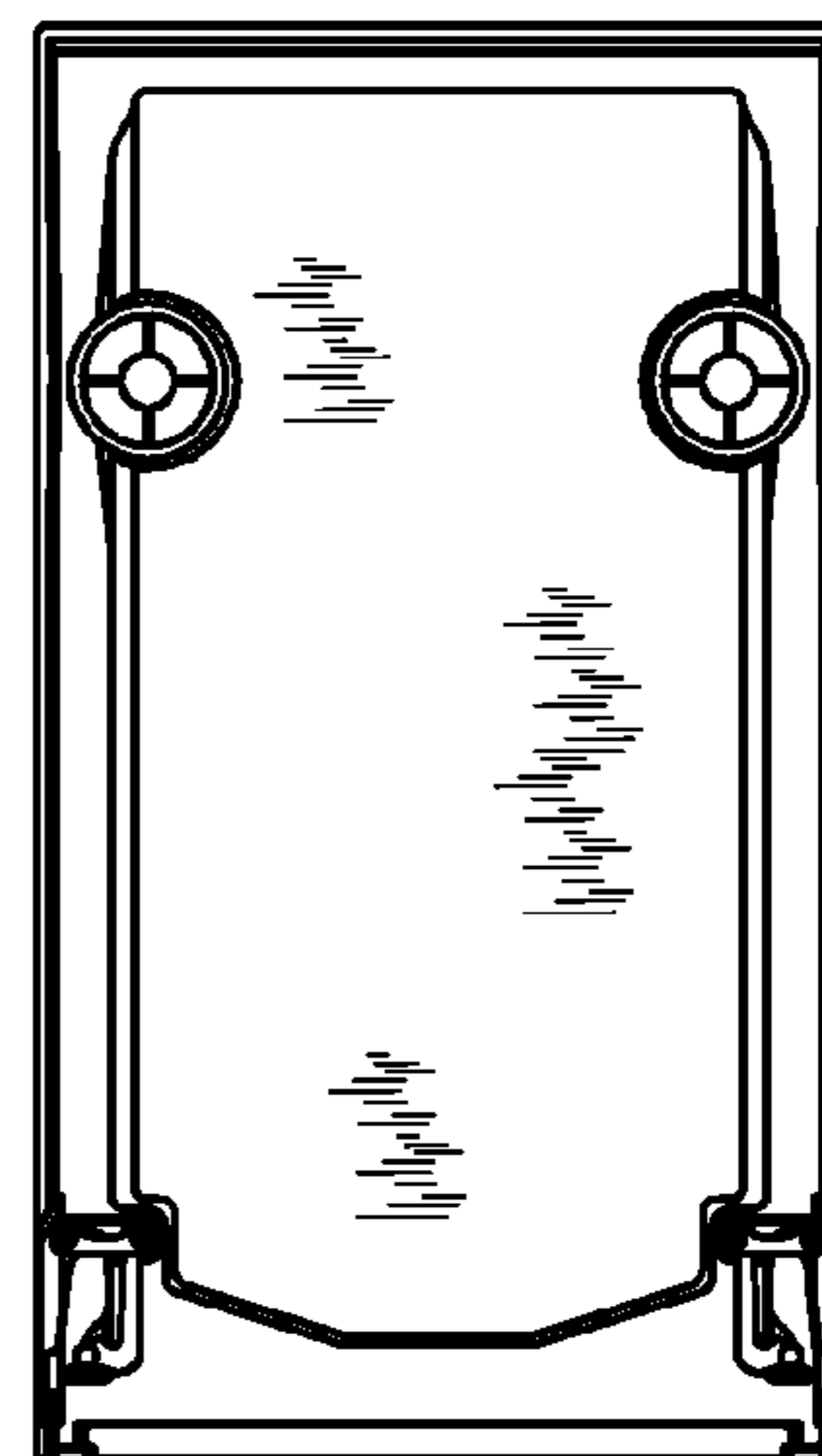
