The ornamental design for an automotive wheel, as shown and described.

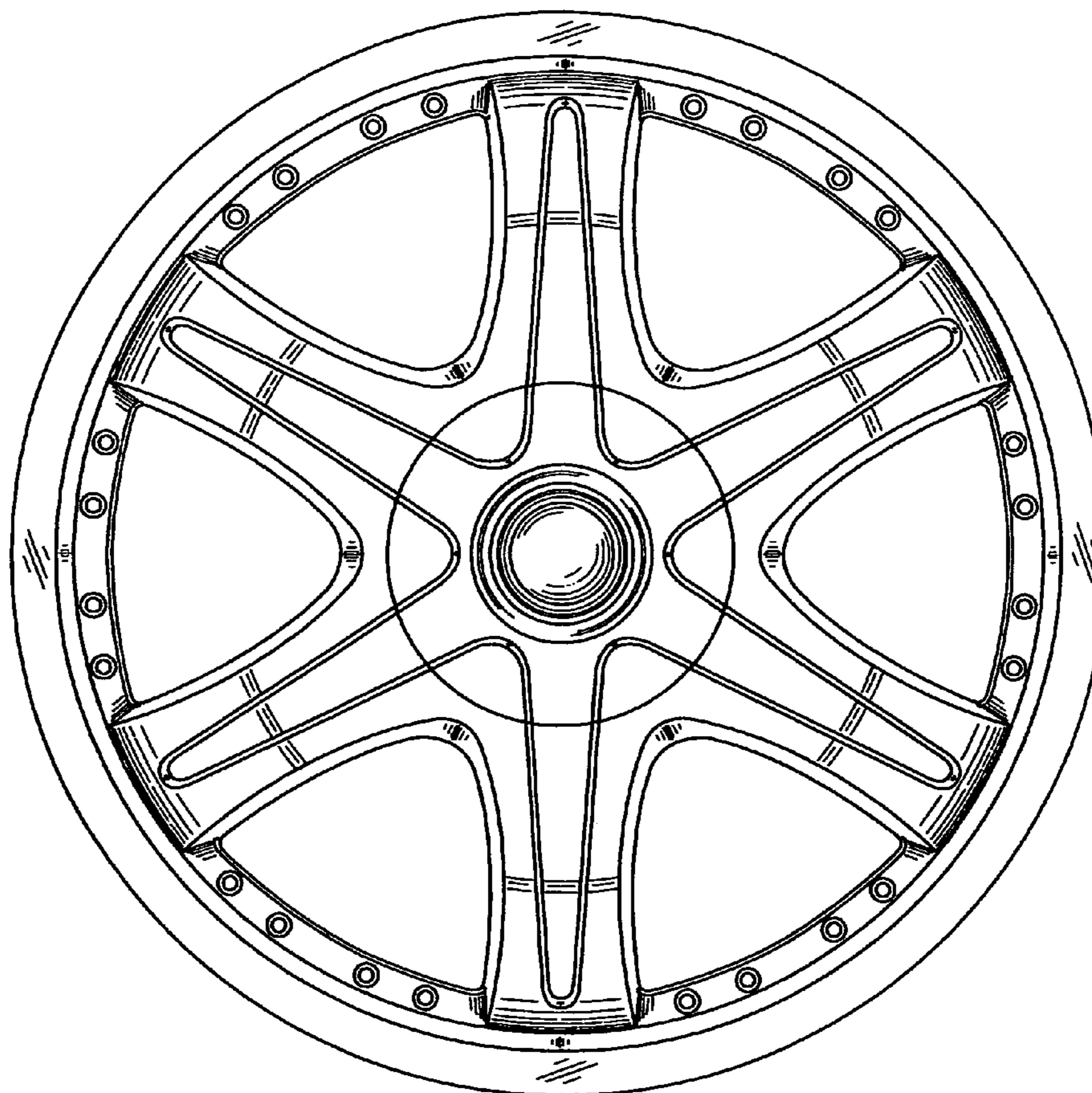
DESCRIPTION

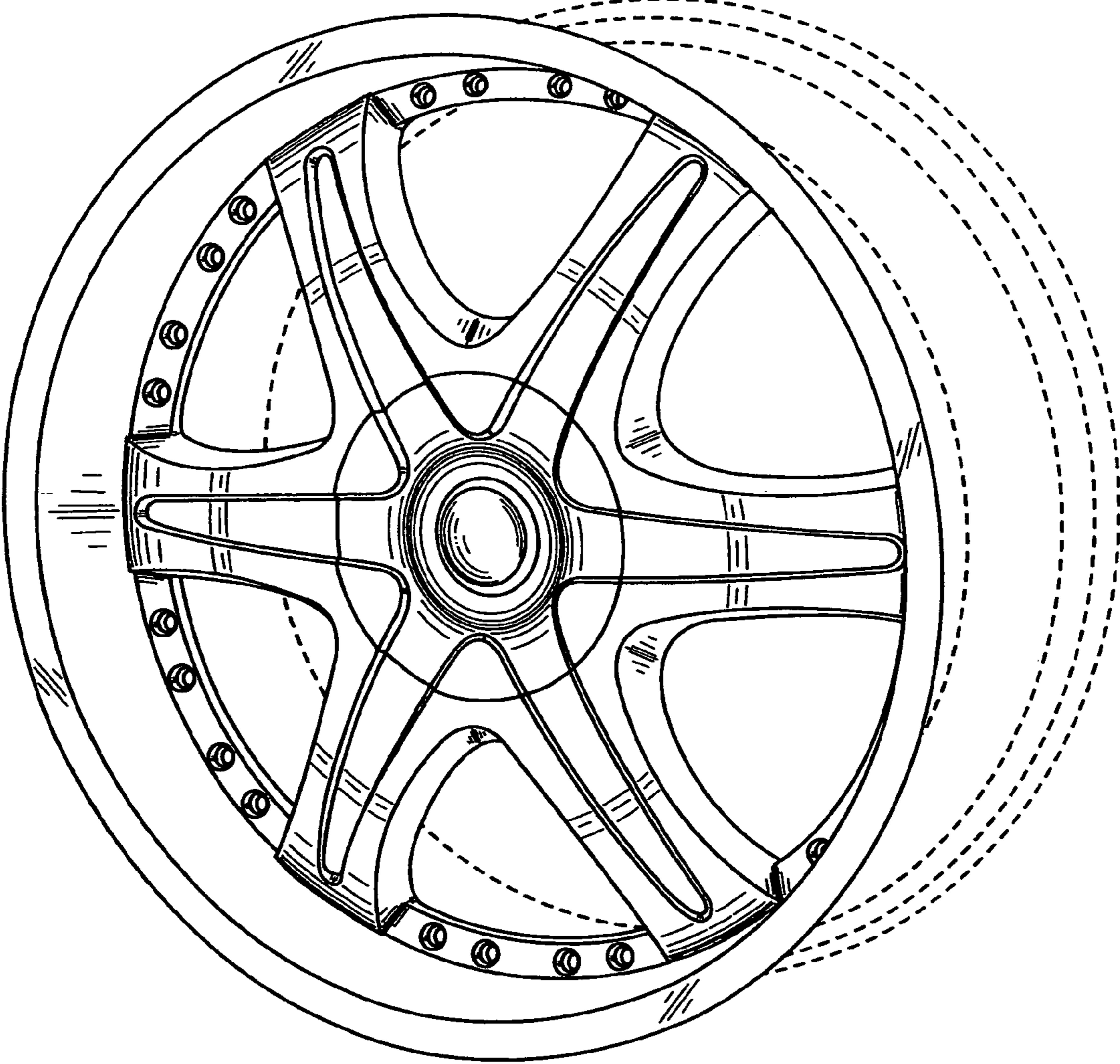

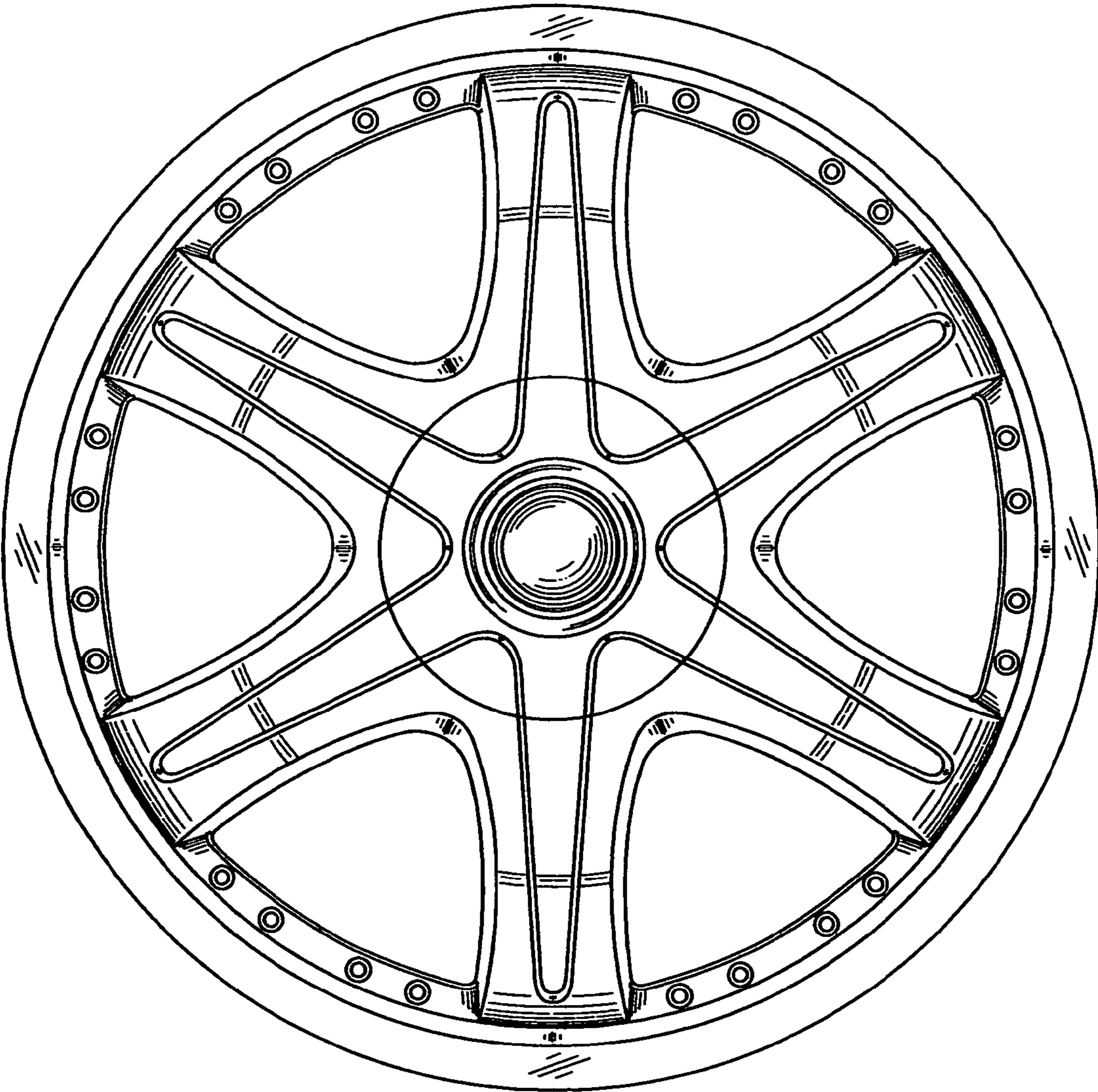
