FIG. 6 is a rear elevational view of the moldable fabric kayak ornamental design.

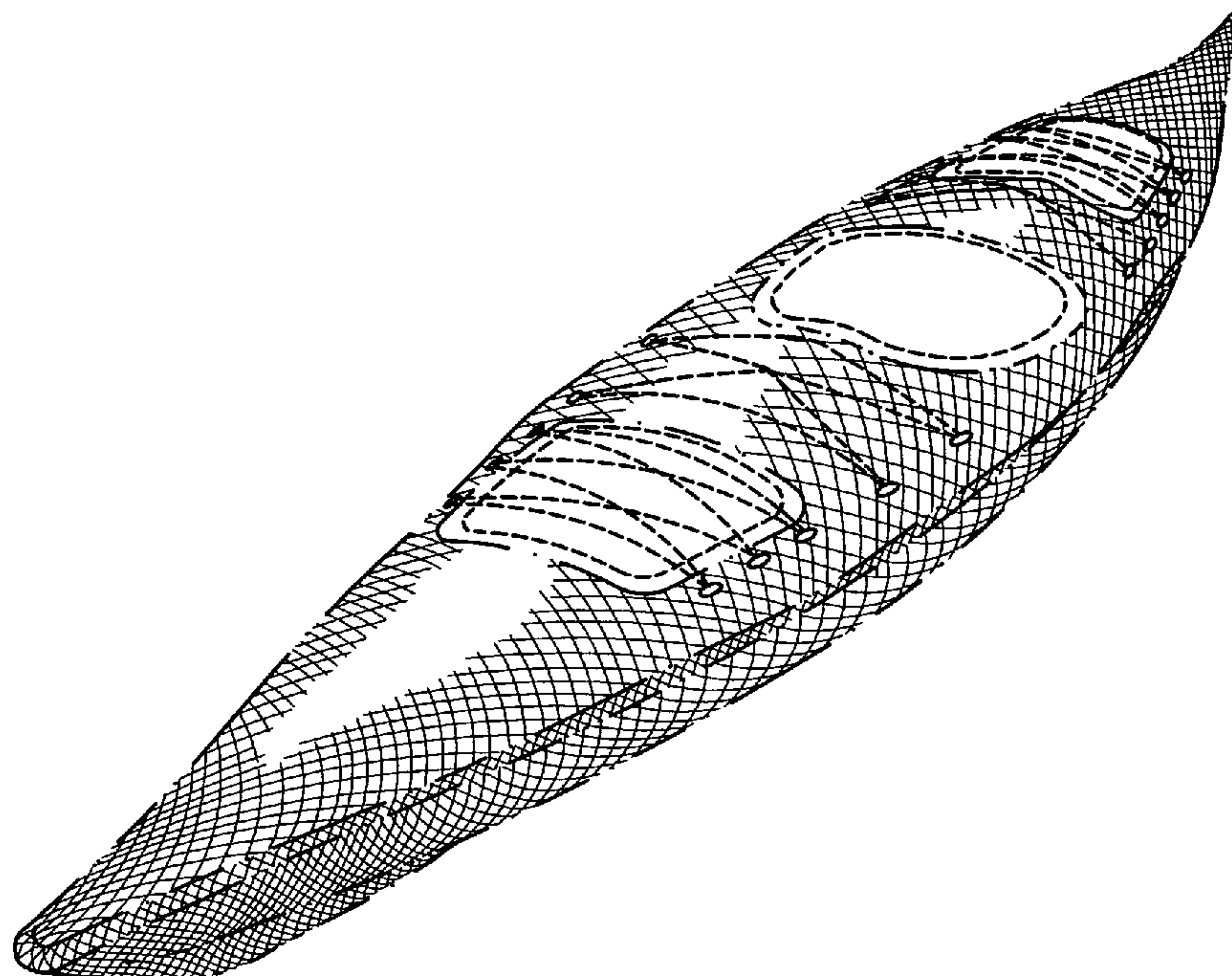
FIG. 7 is a greatly enlarged partial view showing the configuration of the surface of the moldable fabric kayak.

None of the broken lines form a part of the claimed design. The fragmentary depiction of the fabric on the kayak is understood to cover the shaded surfaces of the moldable fabric kayak within the broken line boundaries of the claim.

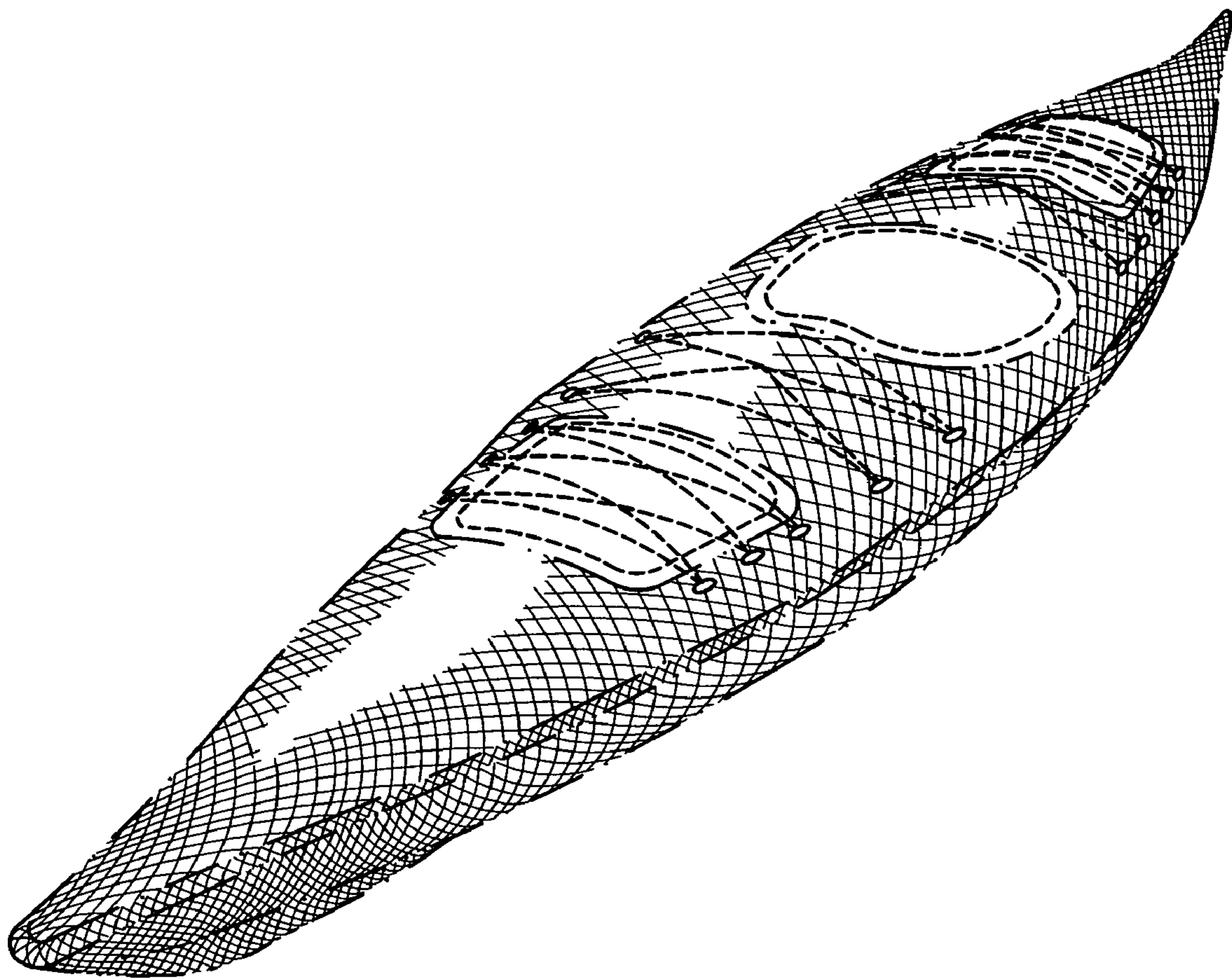

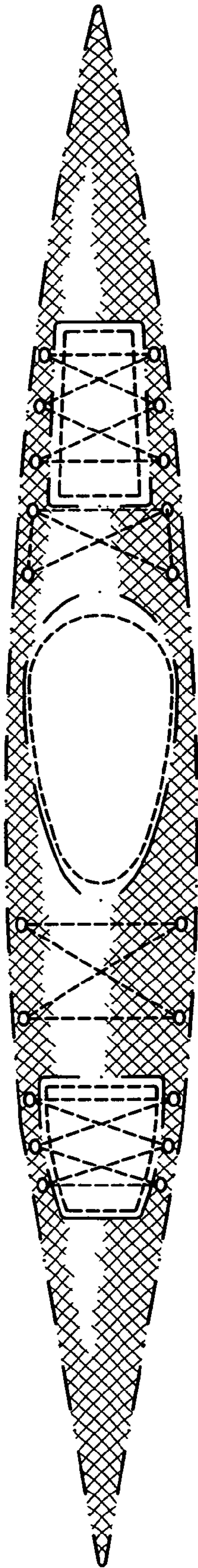

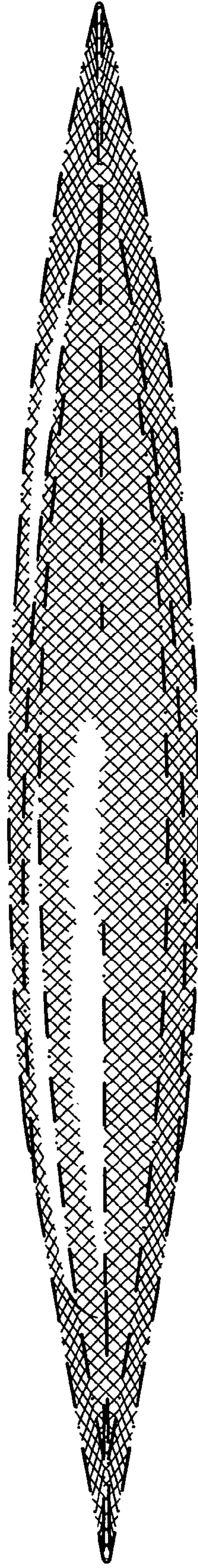

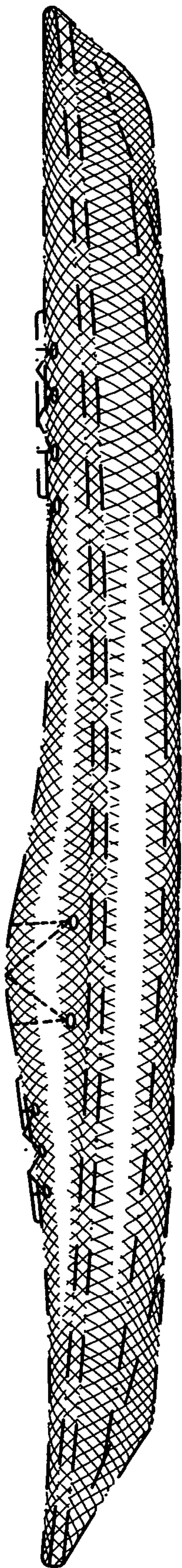

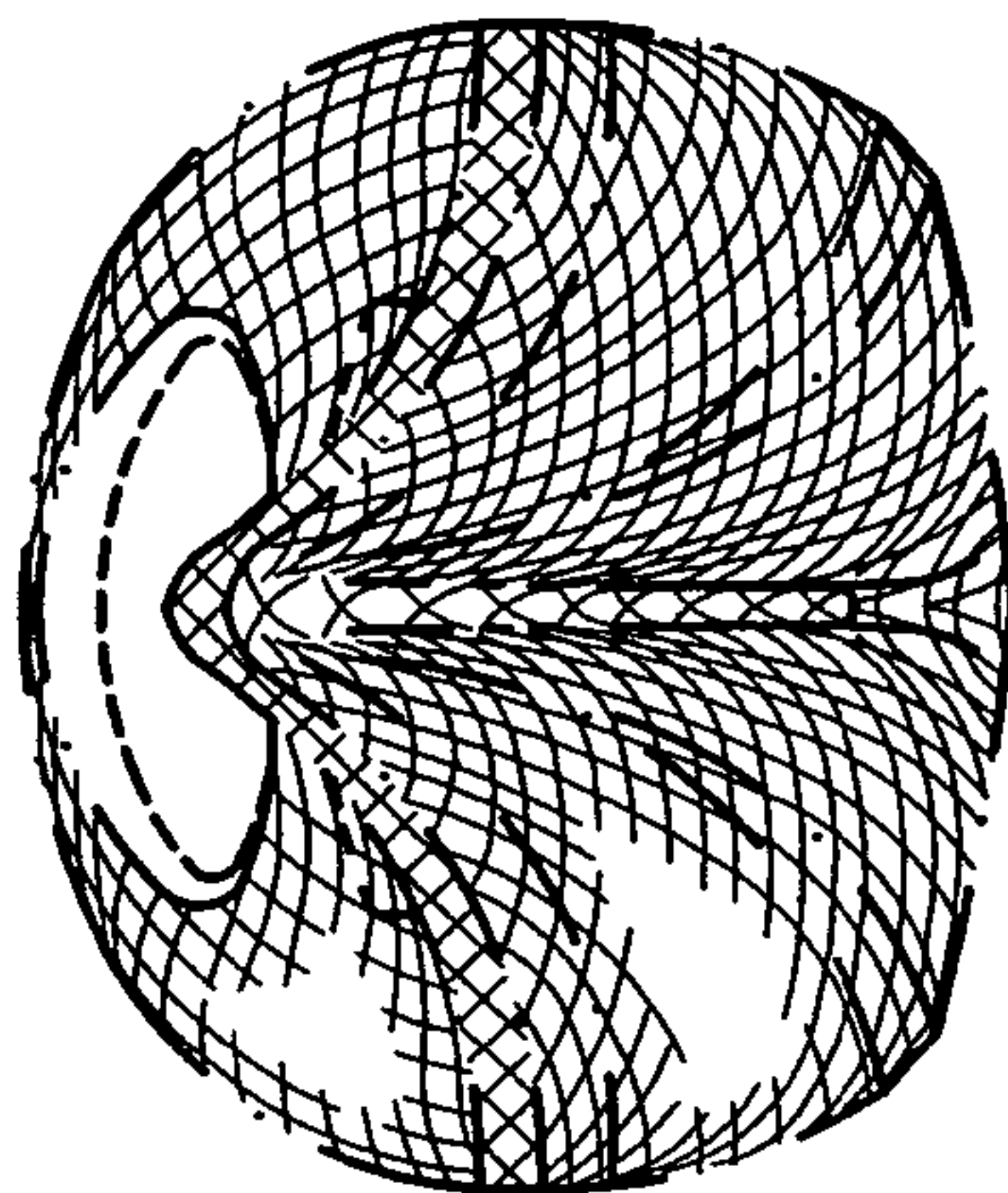

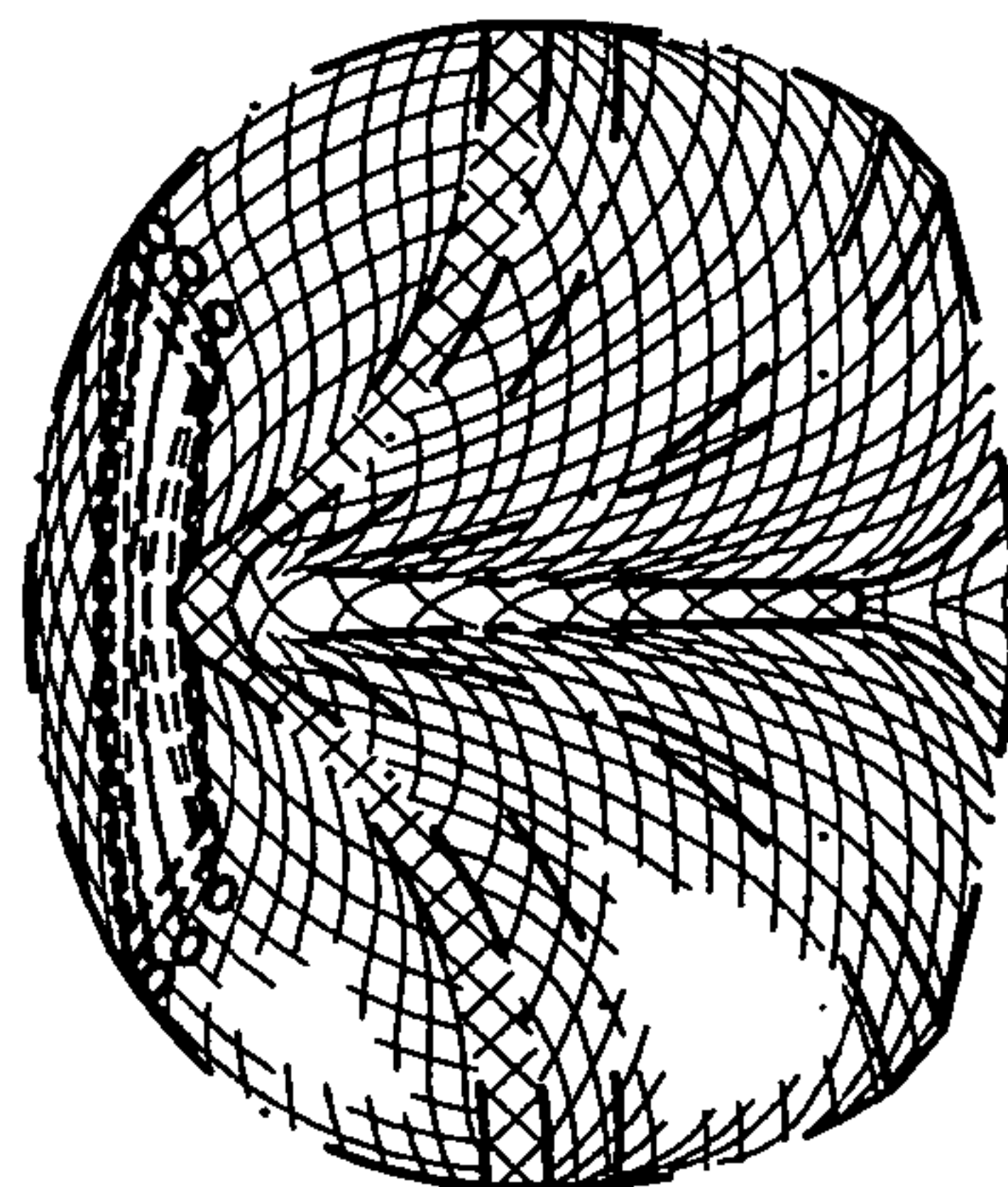

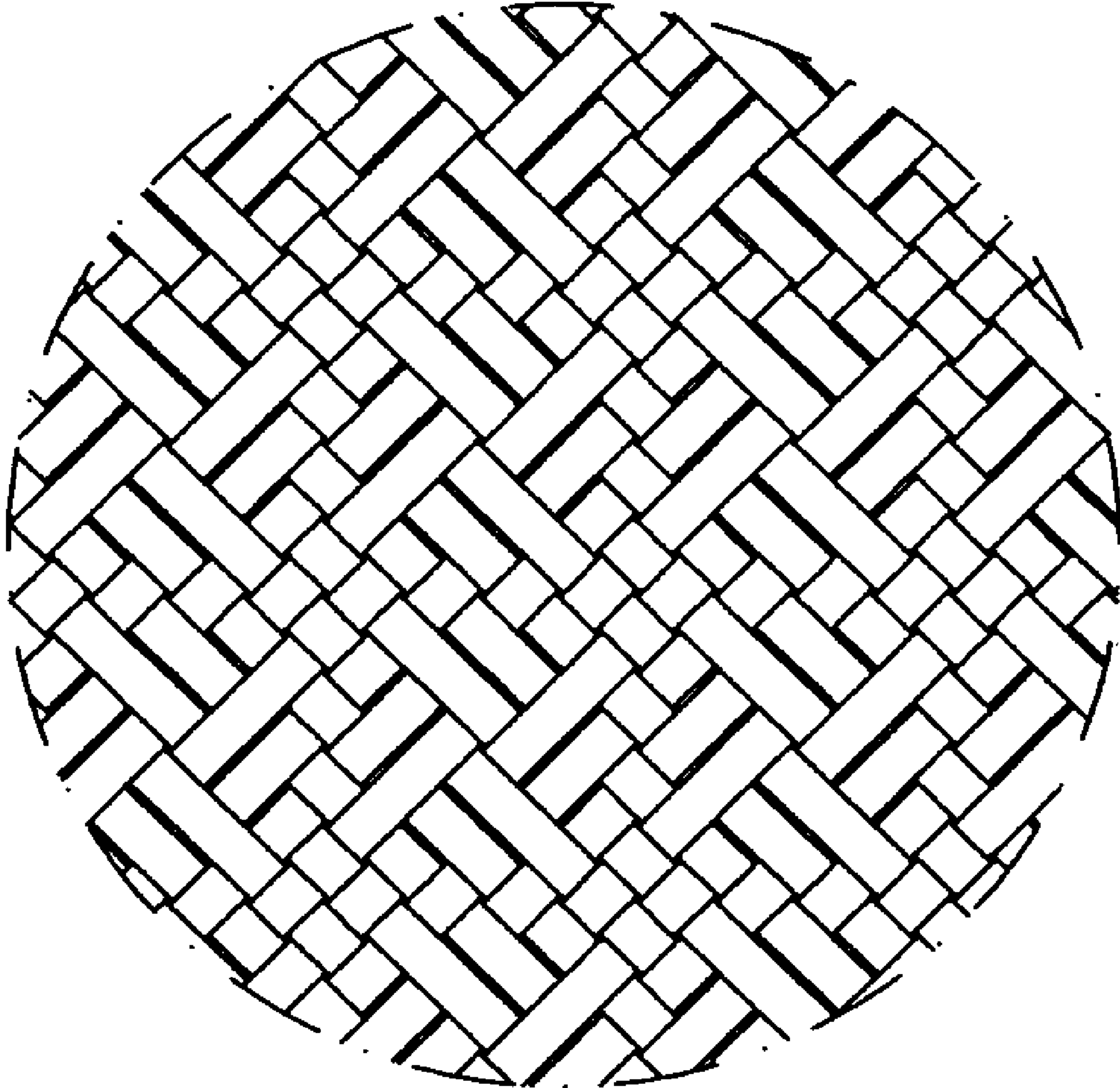
