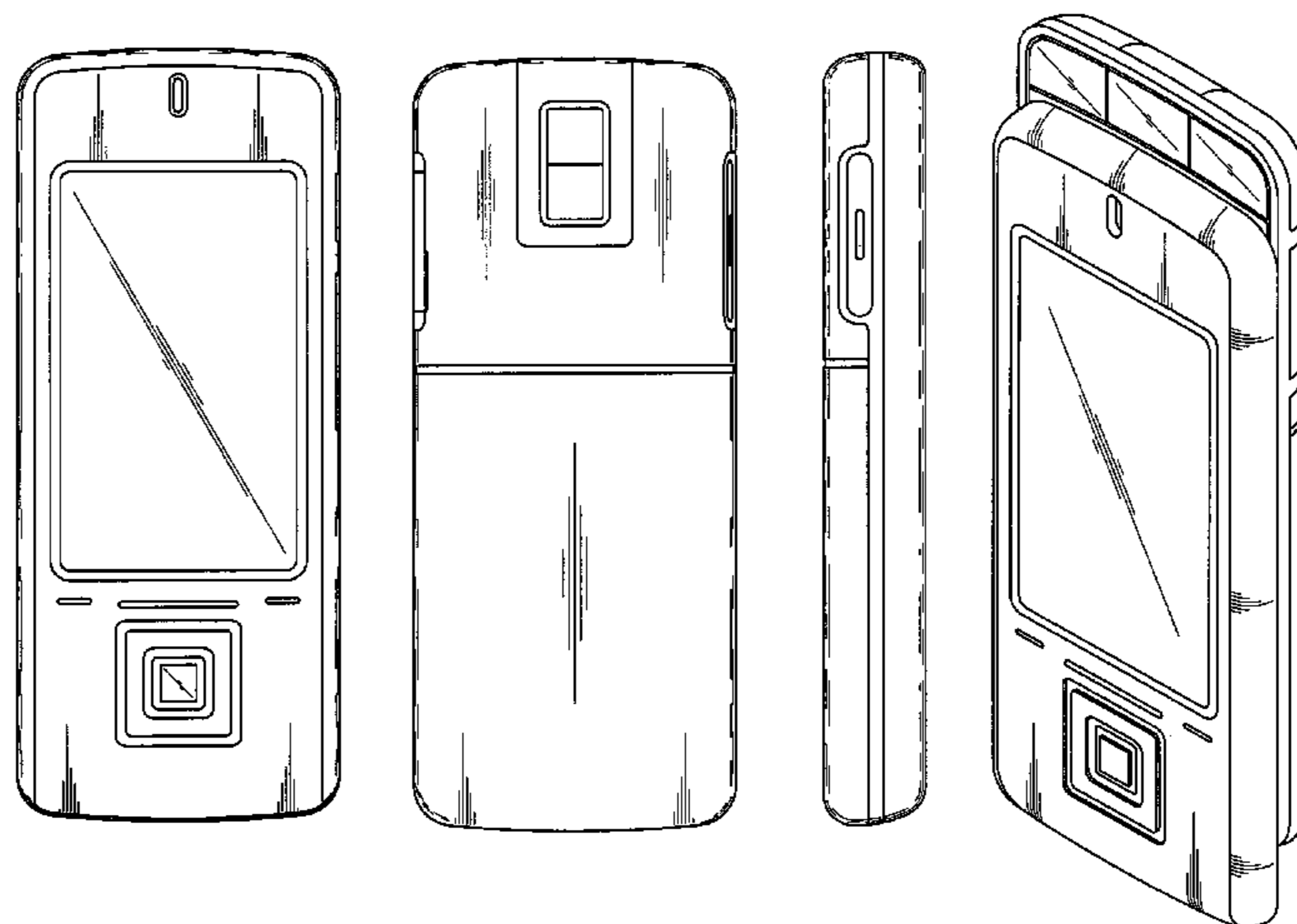
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a cellular phone according to our new design;

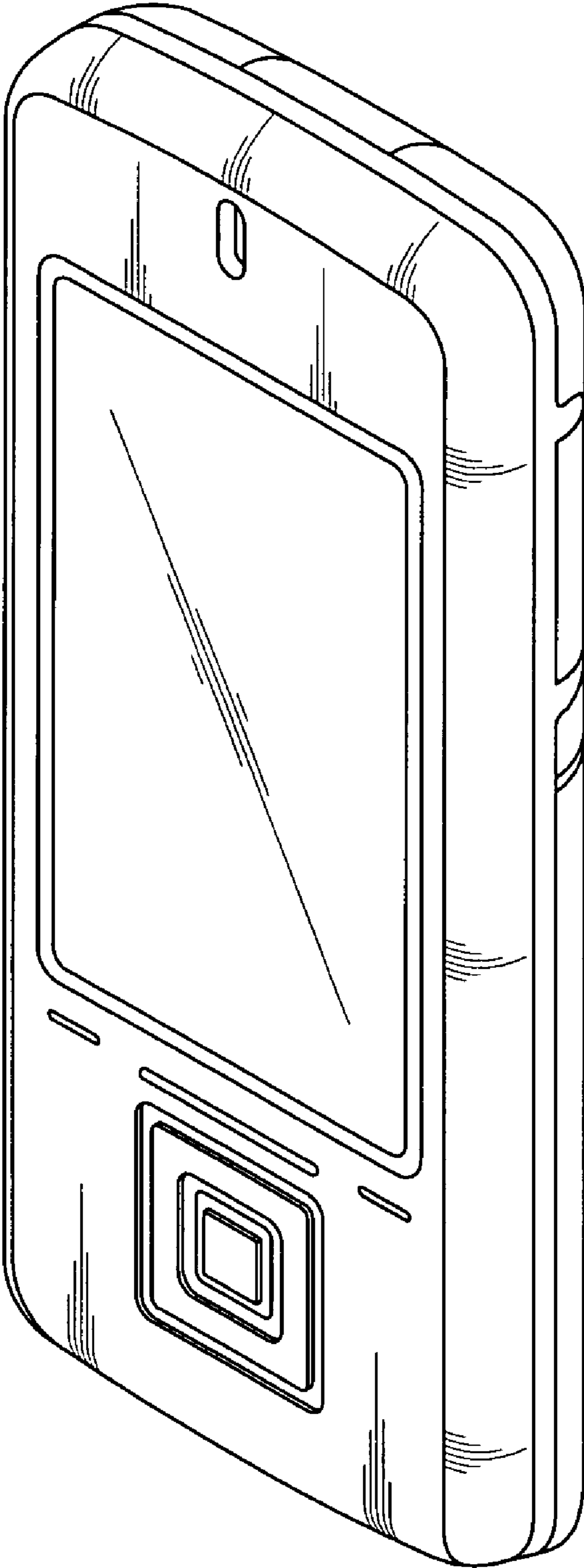

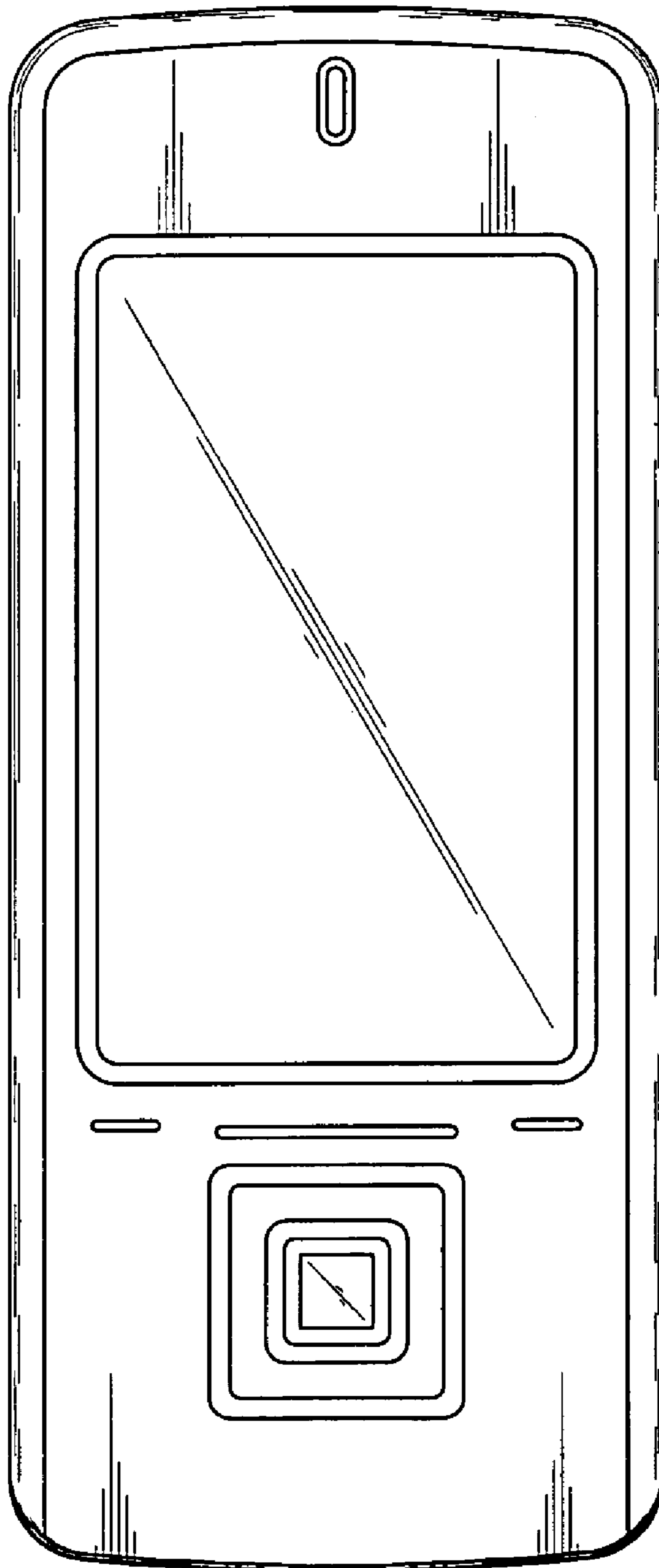

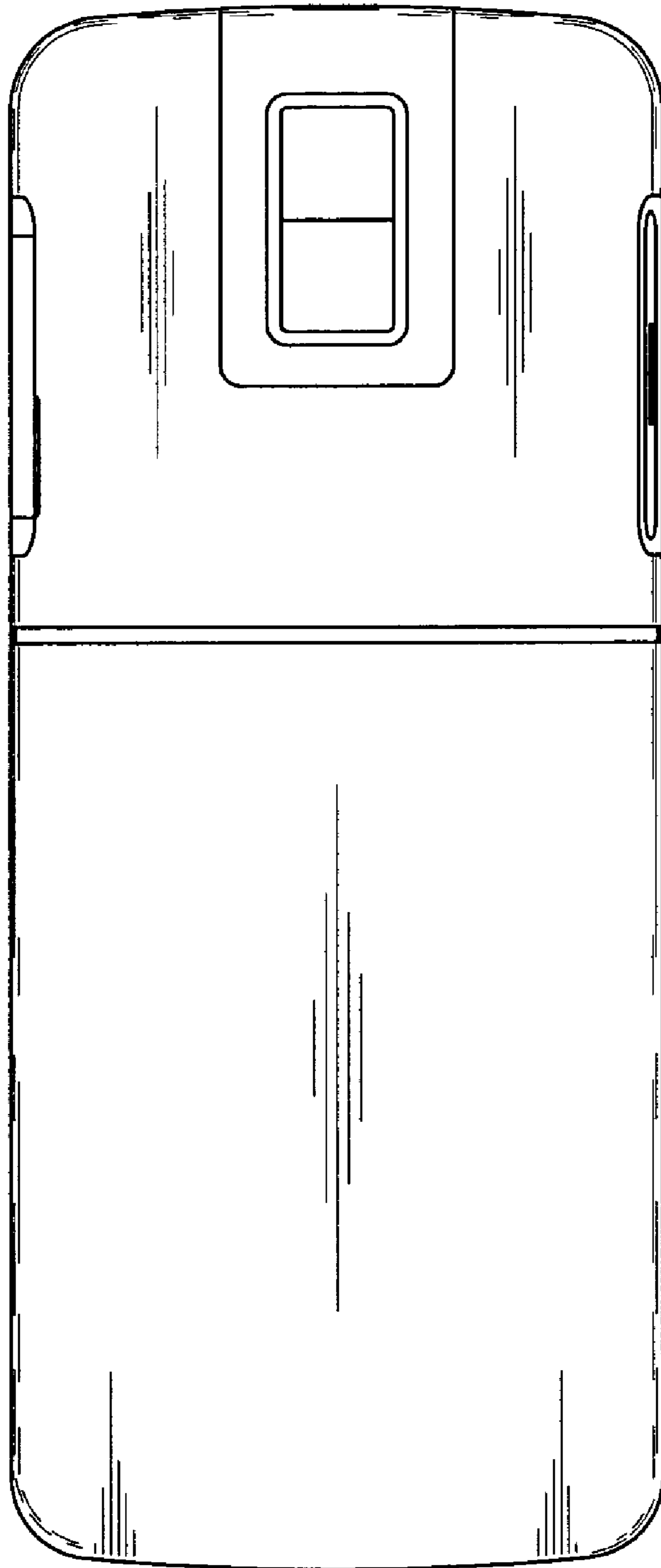

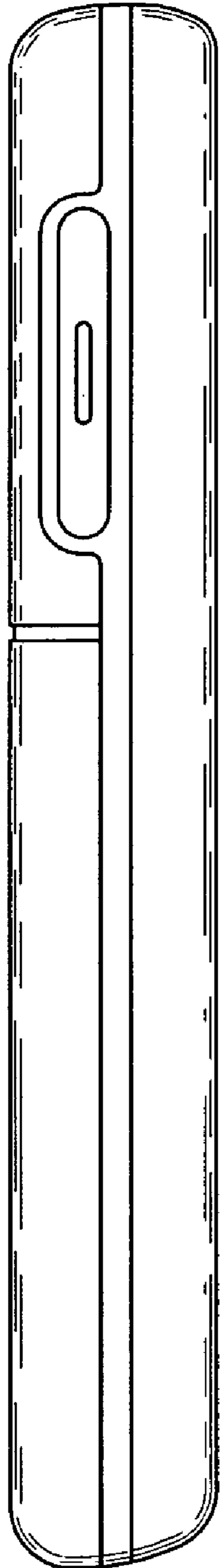

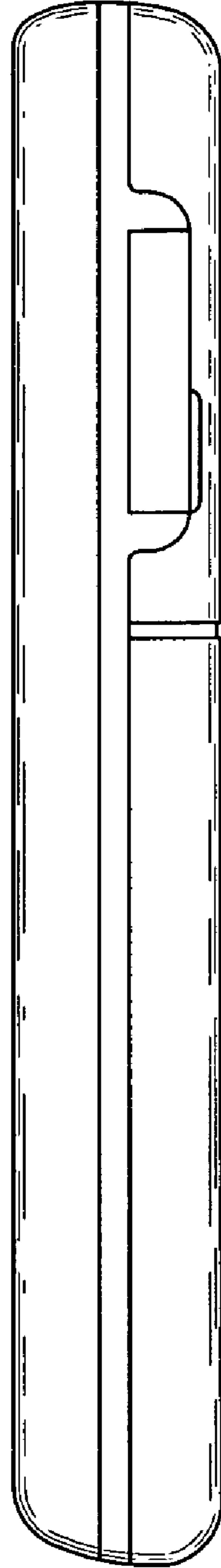

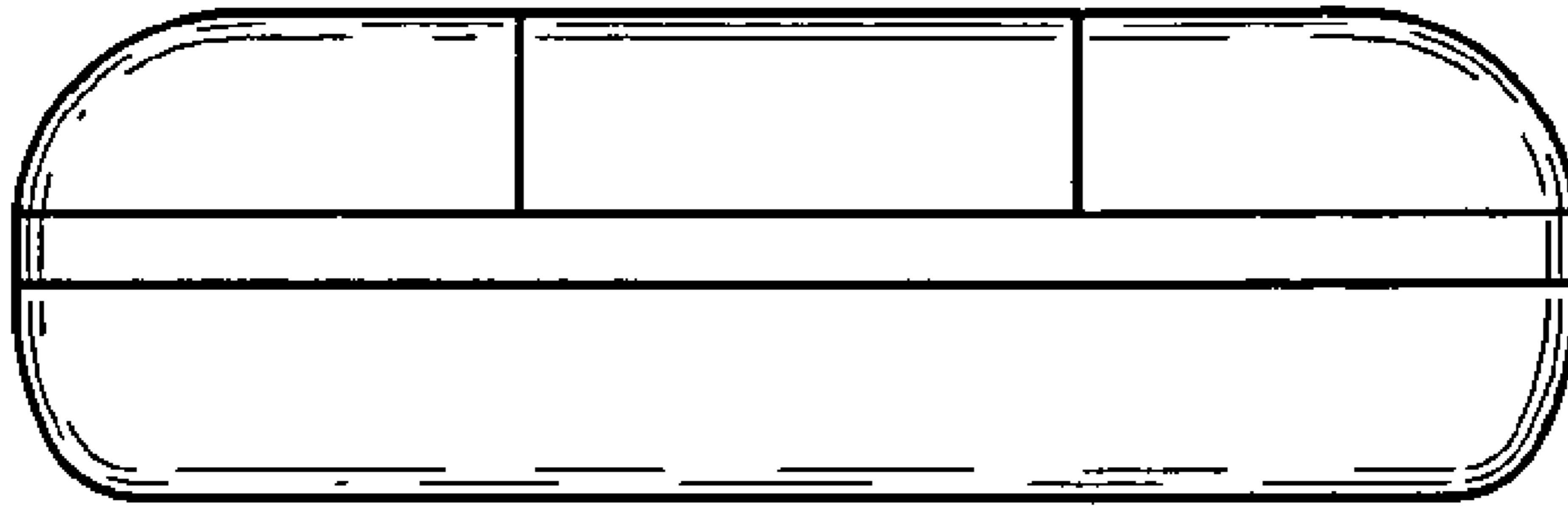

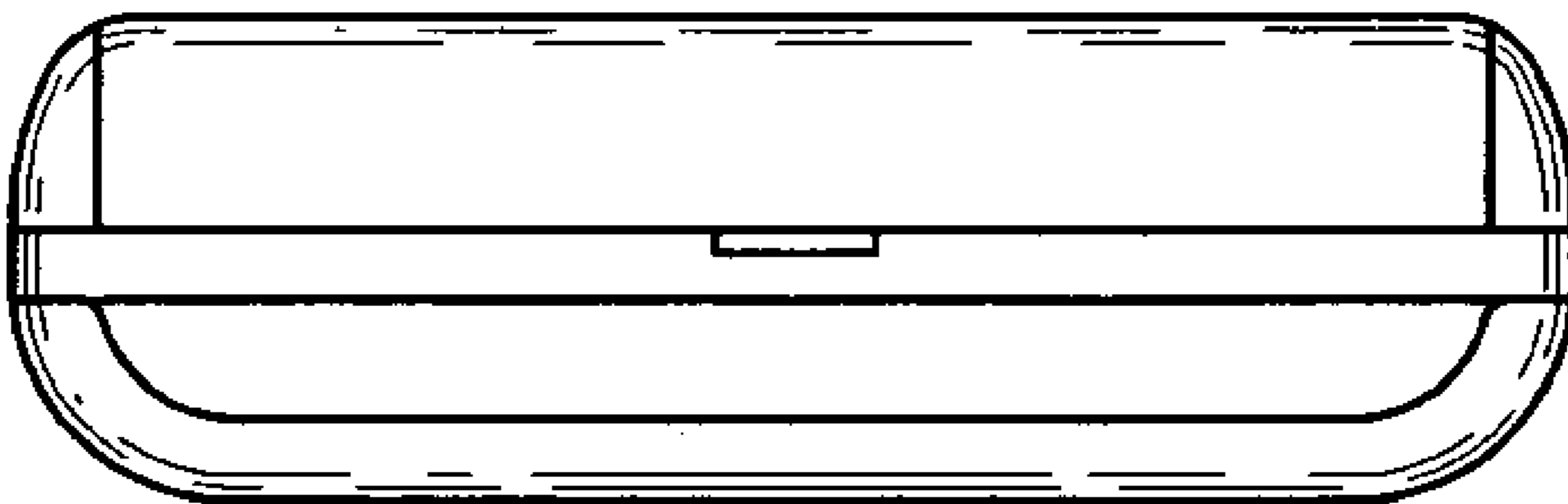
