The ornamental design for action or application buttons for a mobile computing device, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of action or application buttons for a mobile computing device;

FIG. 2 is a first isometric view thereof;

FIG. 3 is a second isometric view thereof;

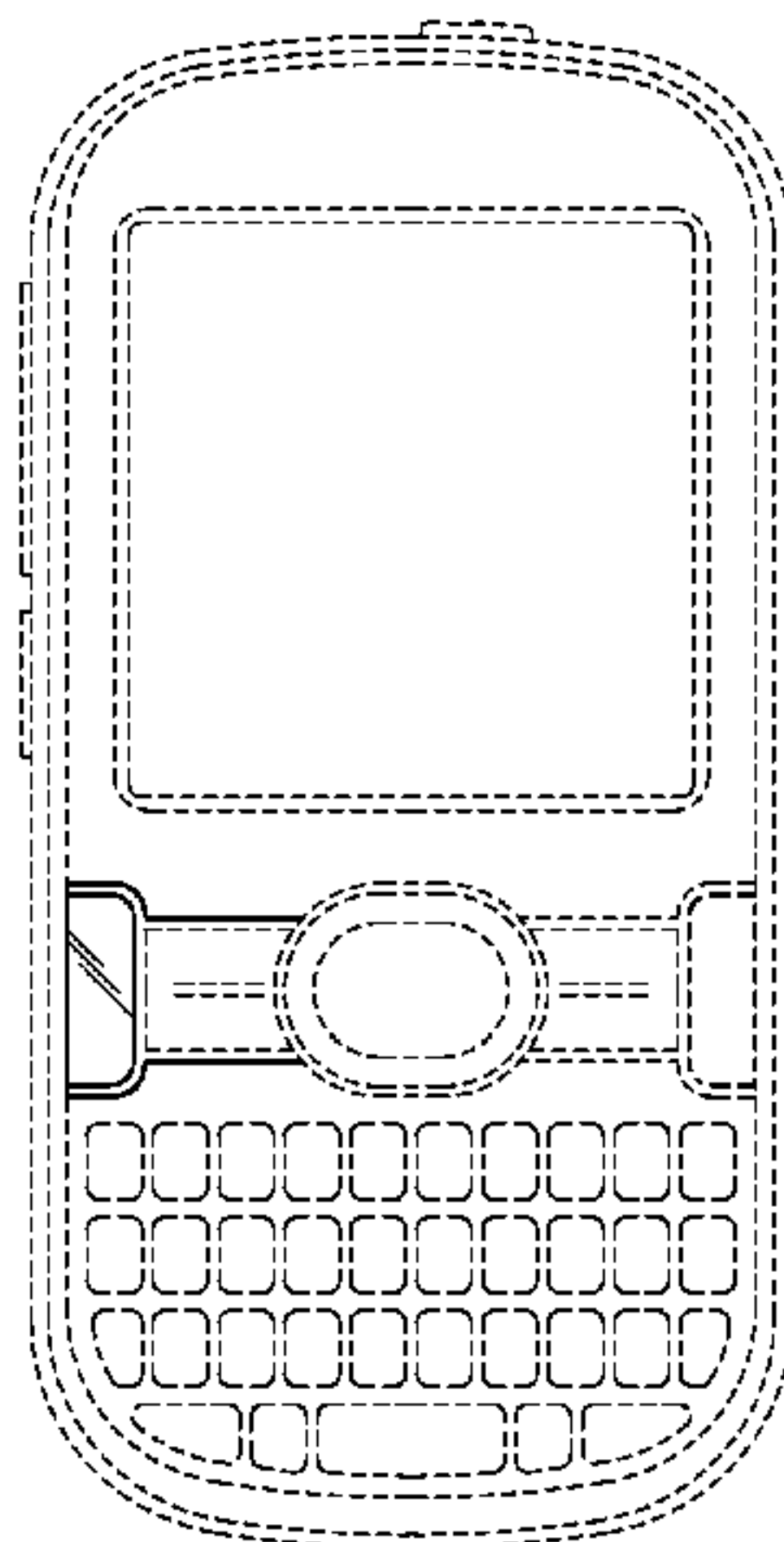
FIG. 4 is a front view of a second embodiment of action or application buttons for a mobile computing device;

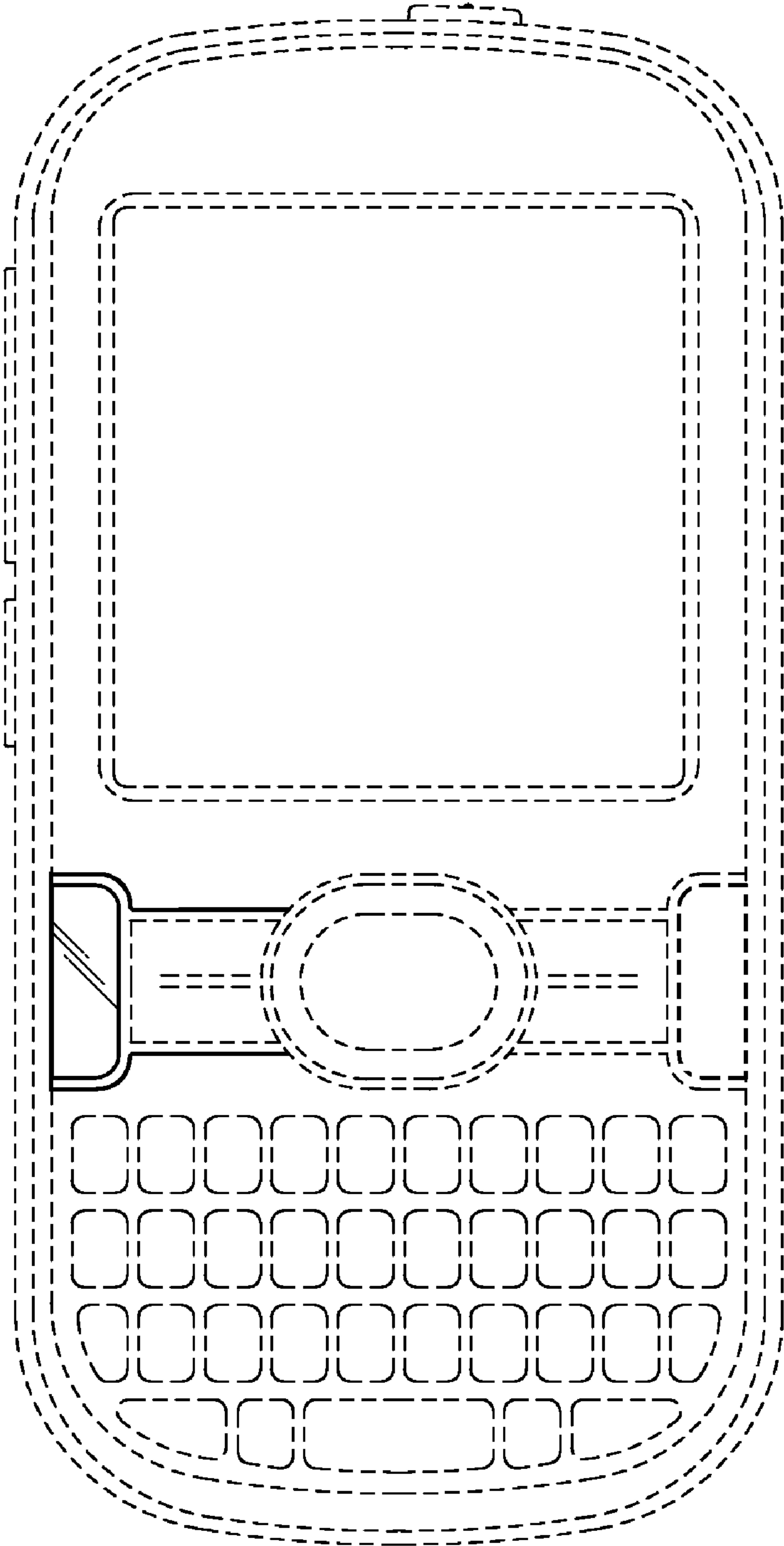

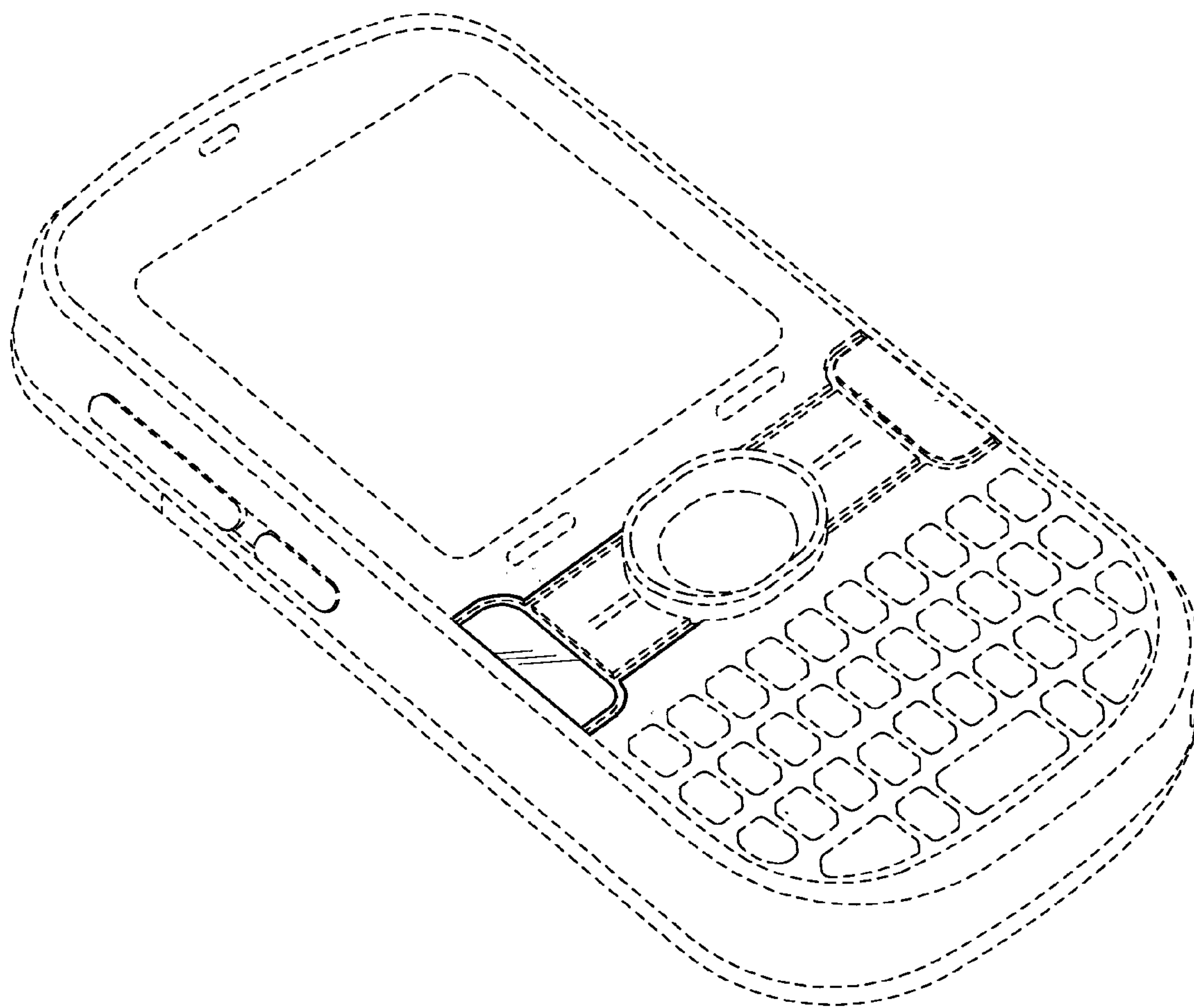

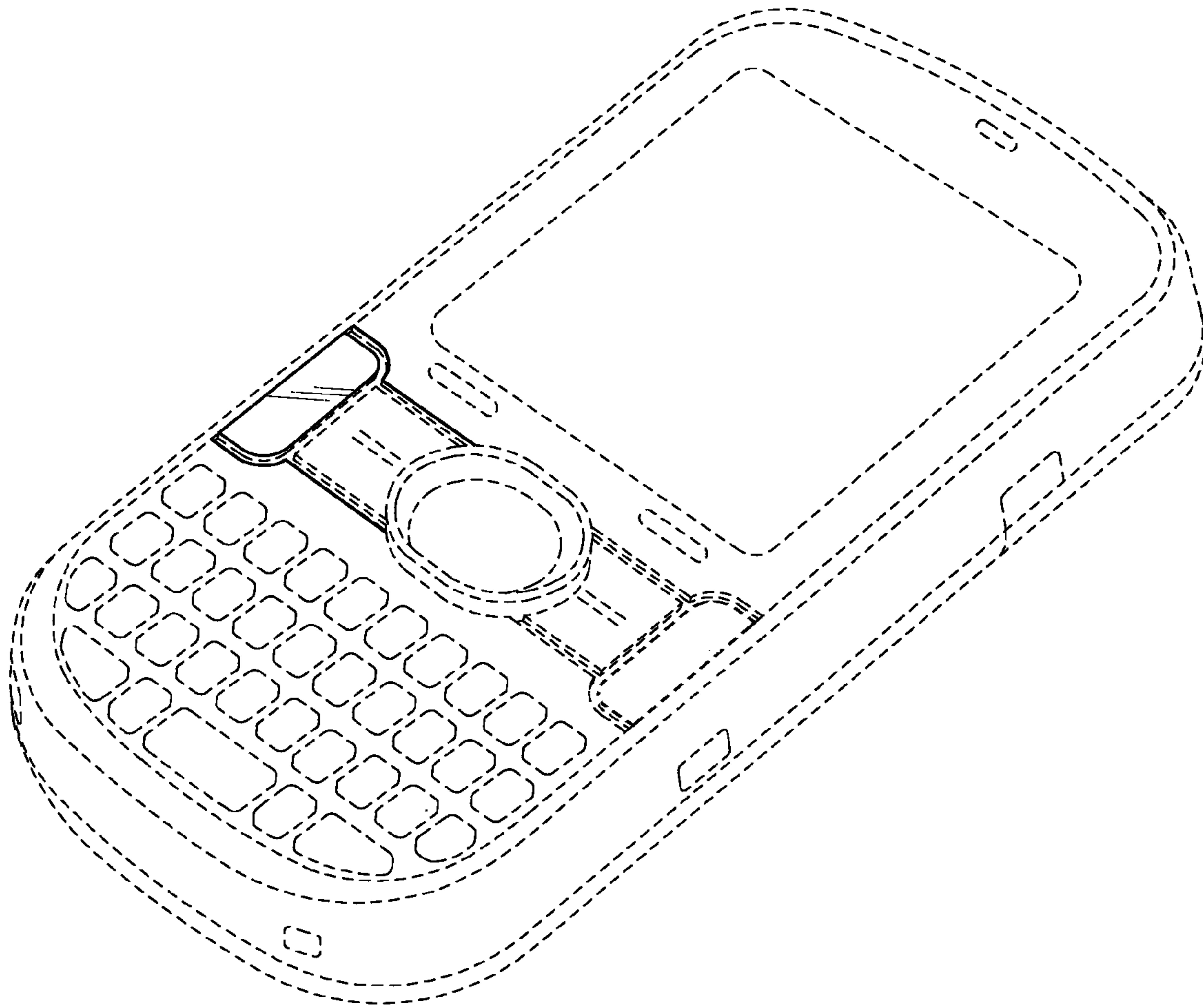

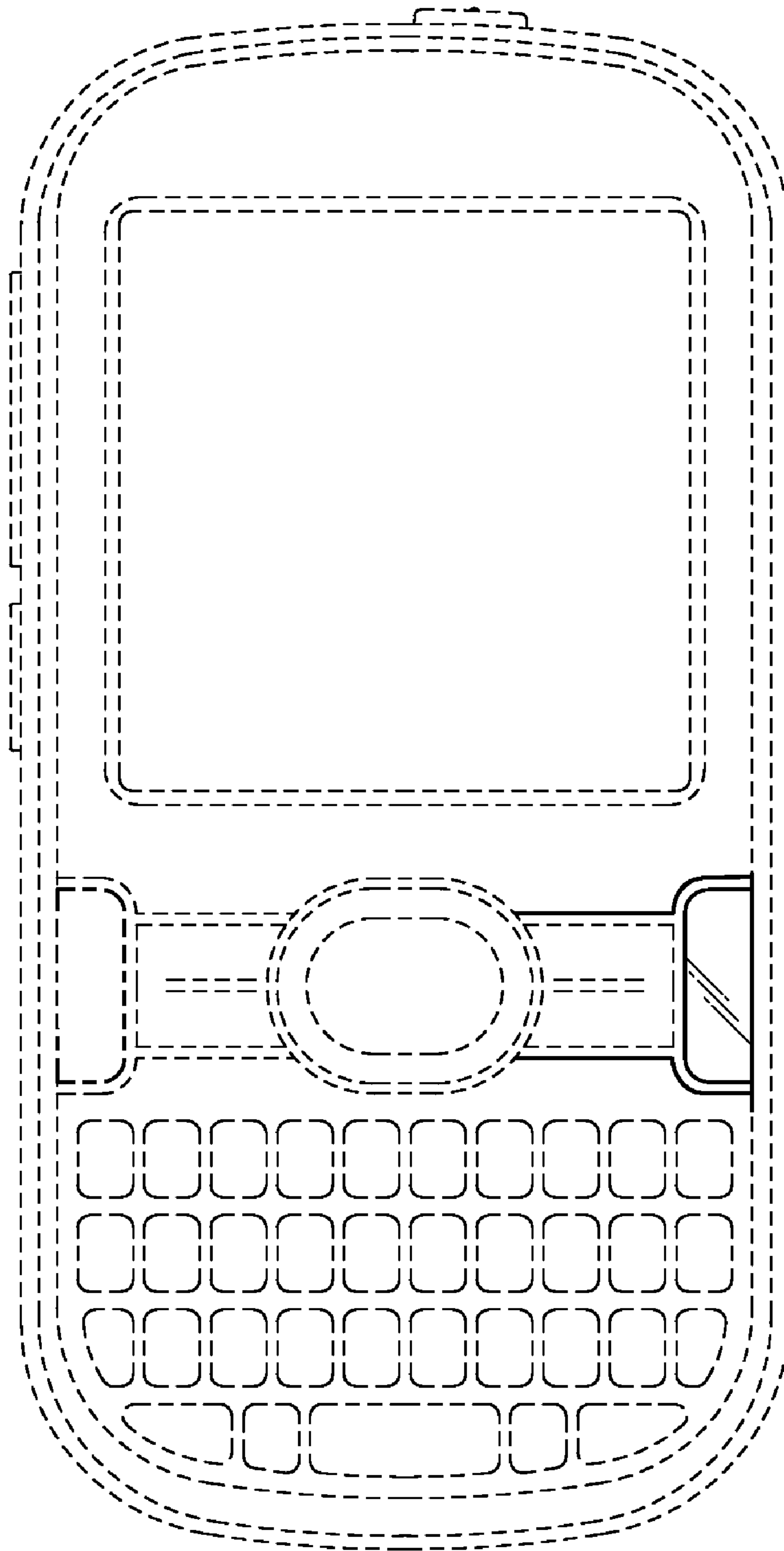

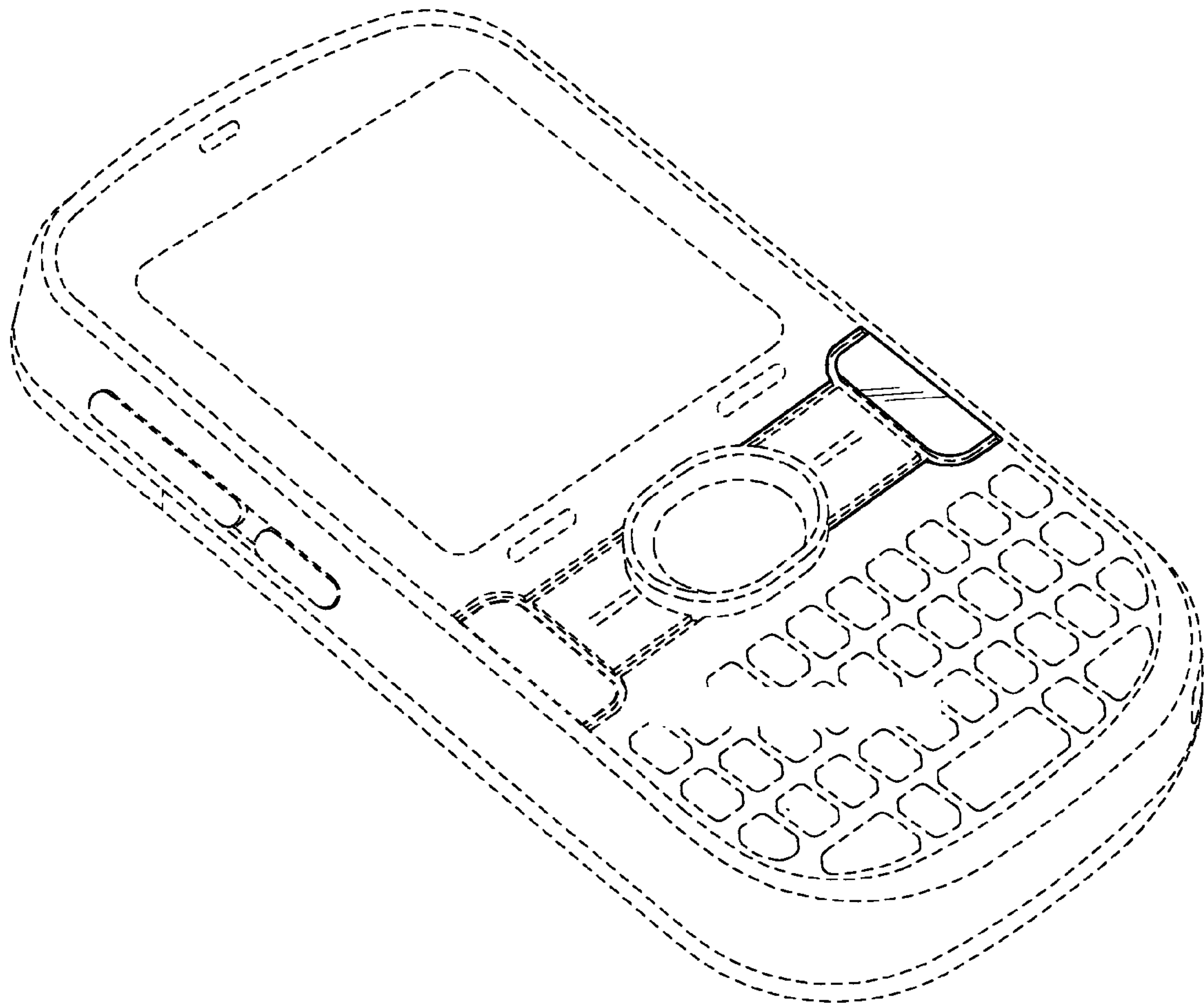

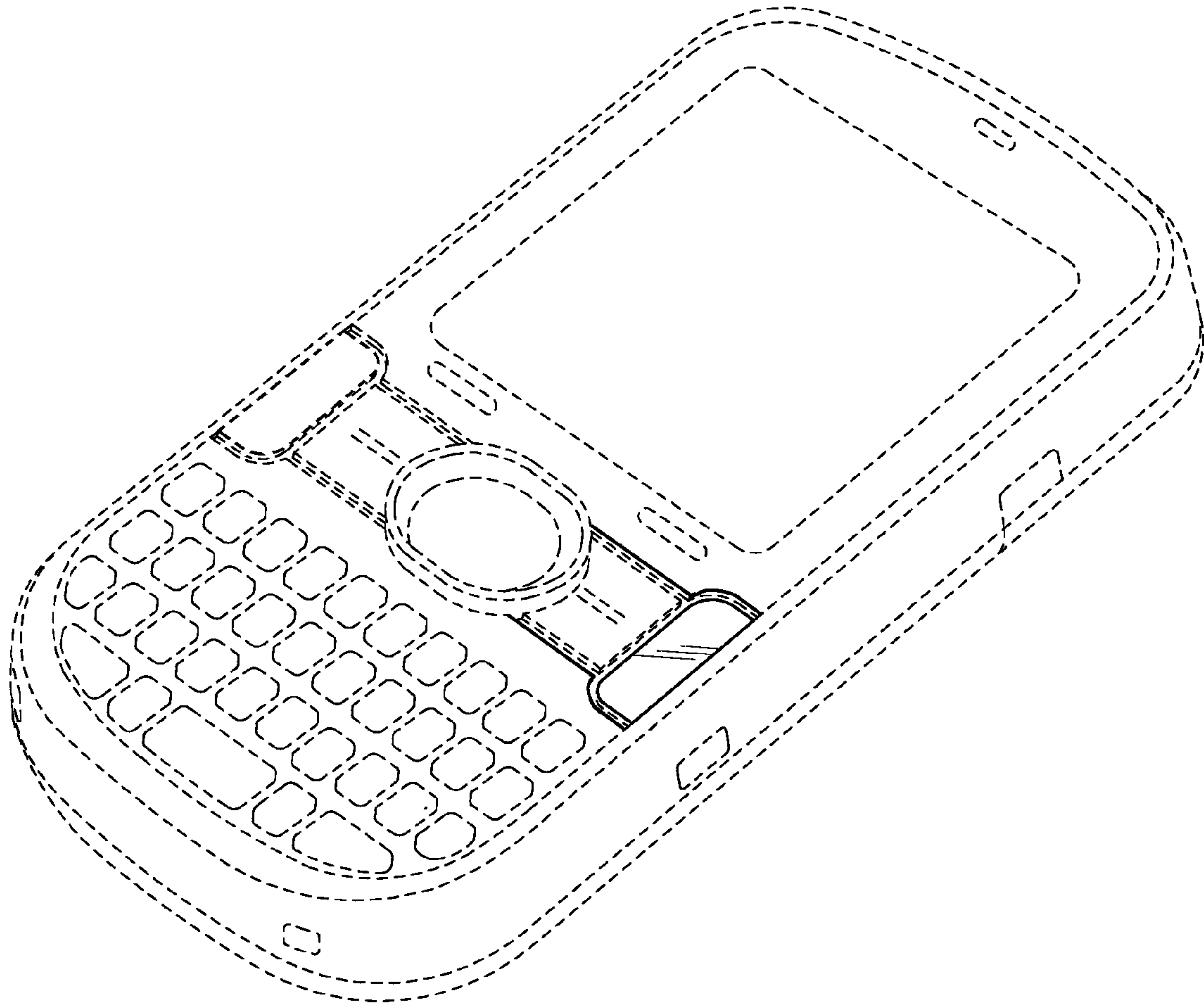
