The ornamental design for a laminator, as shown and
described.

DESCRIPTION

FIG. 1 is a top view of the laminator.
FIG. 2 is a front elevational view of the laminator.
FIG. 3 is a right side view of the laminator. The left side view
is a mirror image thereof.
FIG. 4 is a rear elevational view of the laminator; and,
FIG. 5 is a bottom view of the laminator.

The broken line showing of the laminator is included for the
purpose of illustrating portions of the laminator and forms no
part of the claimed design.

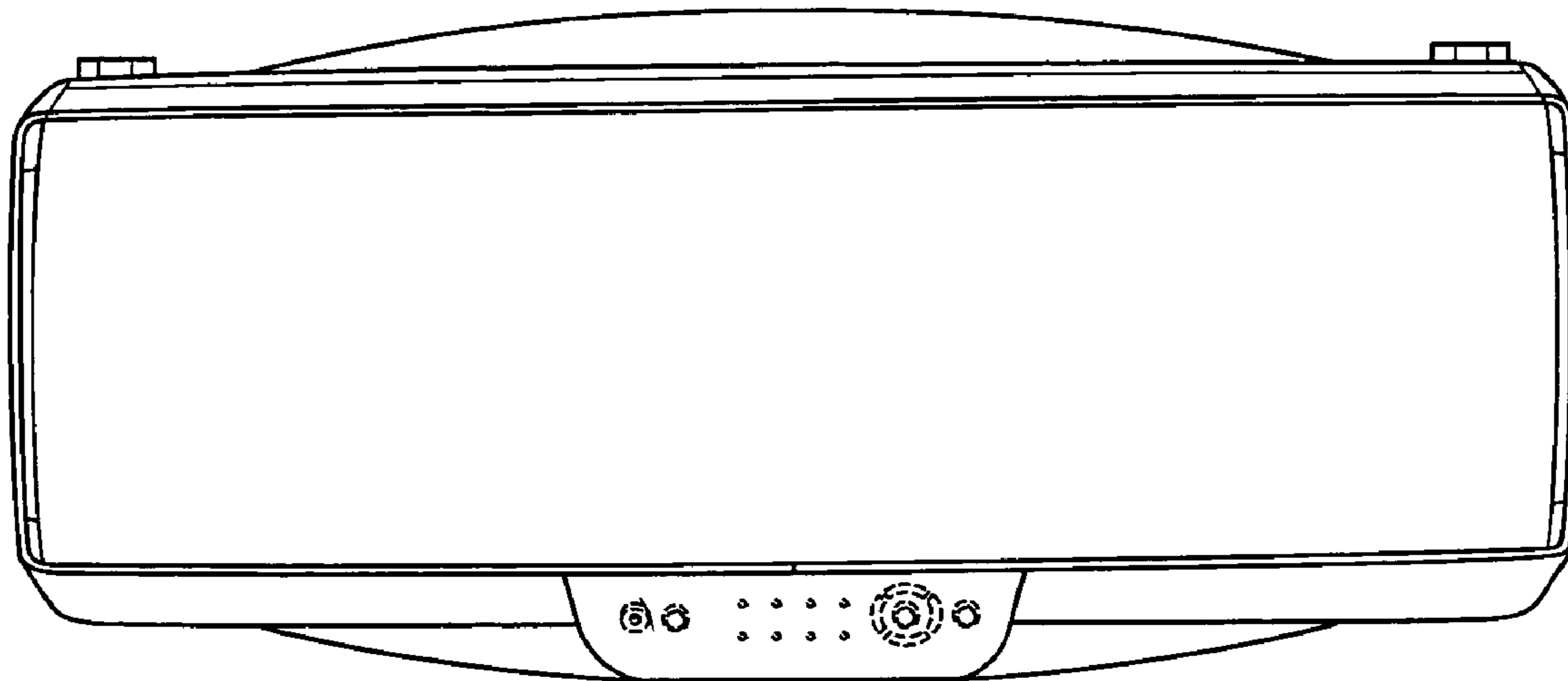

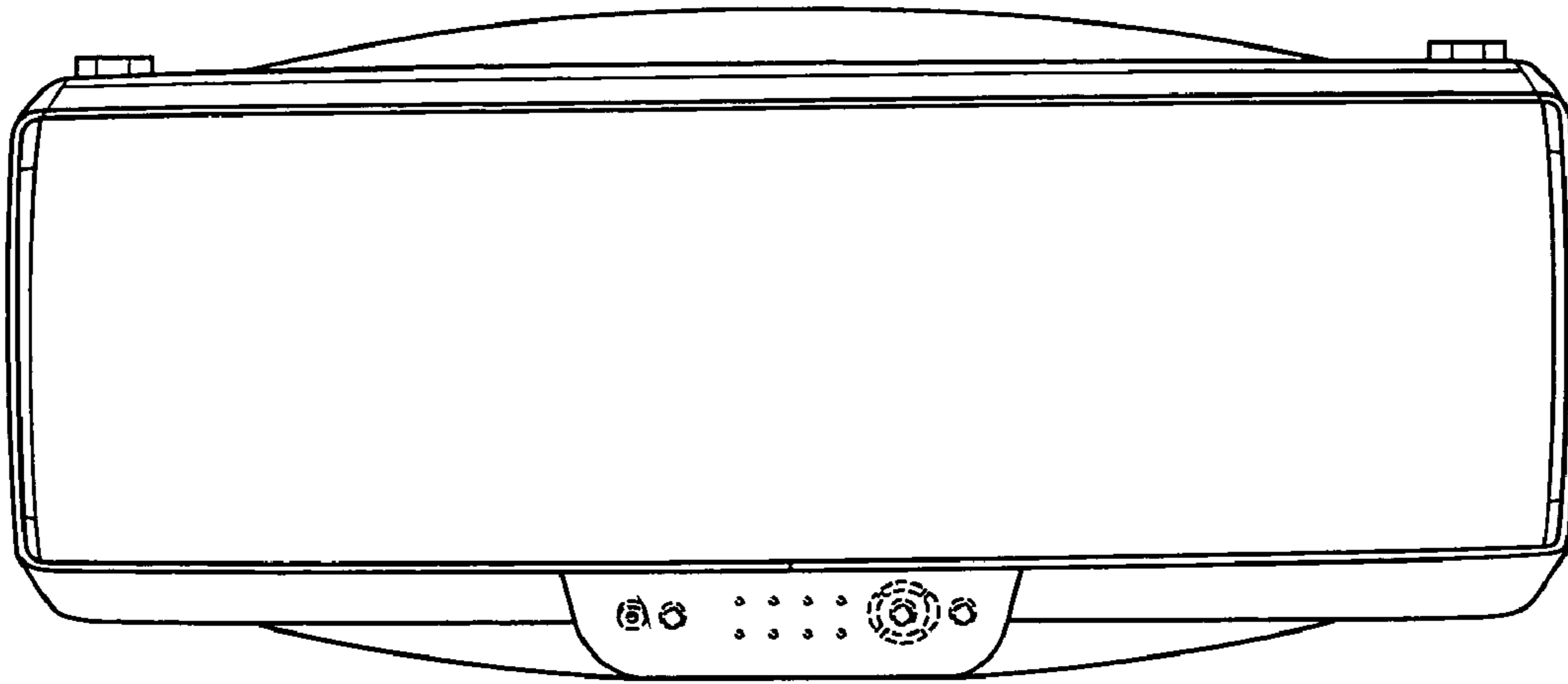

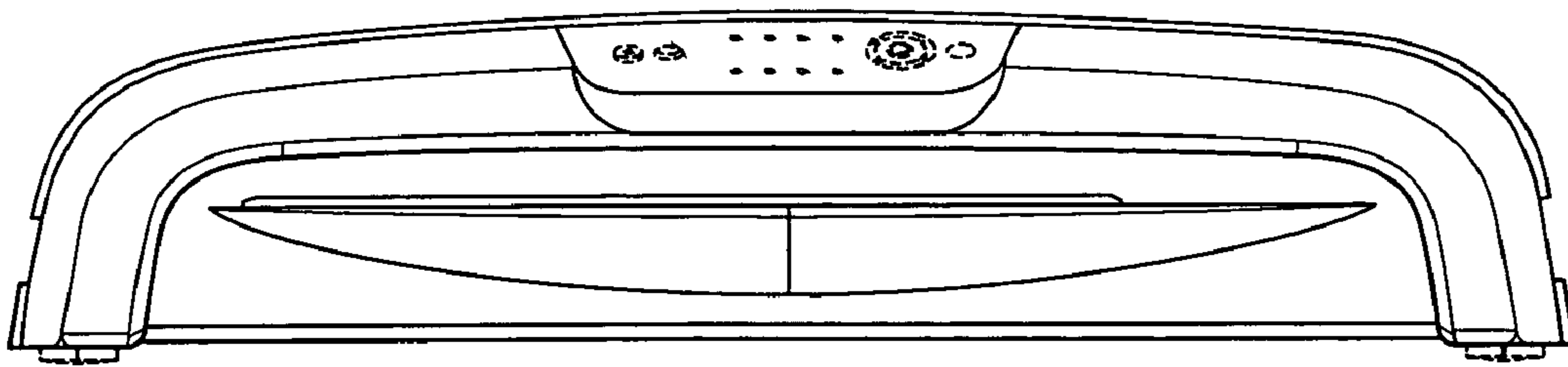

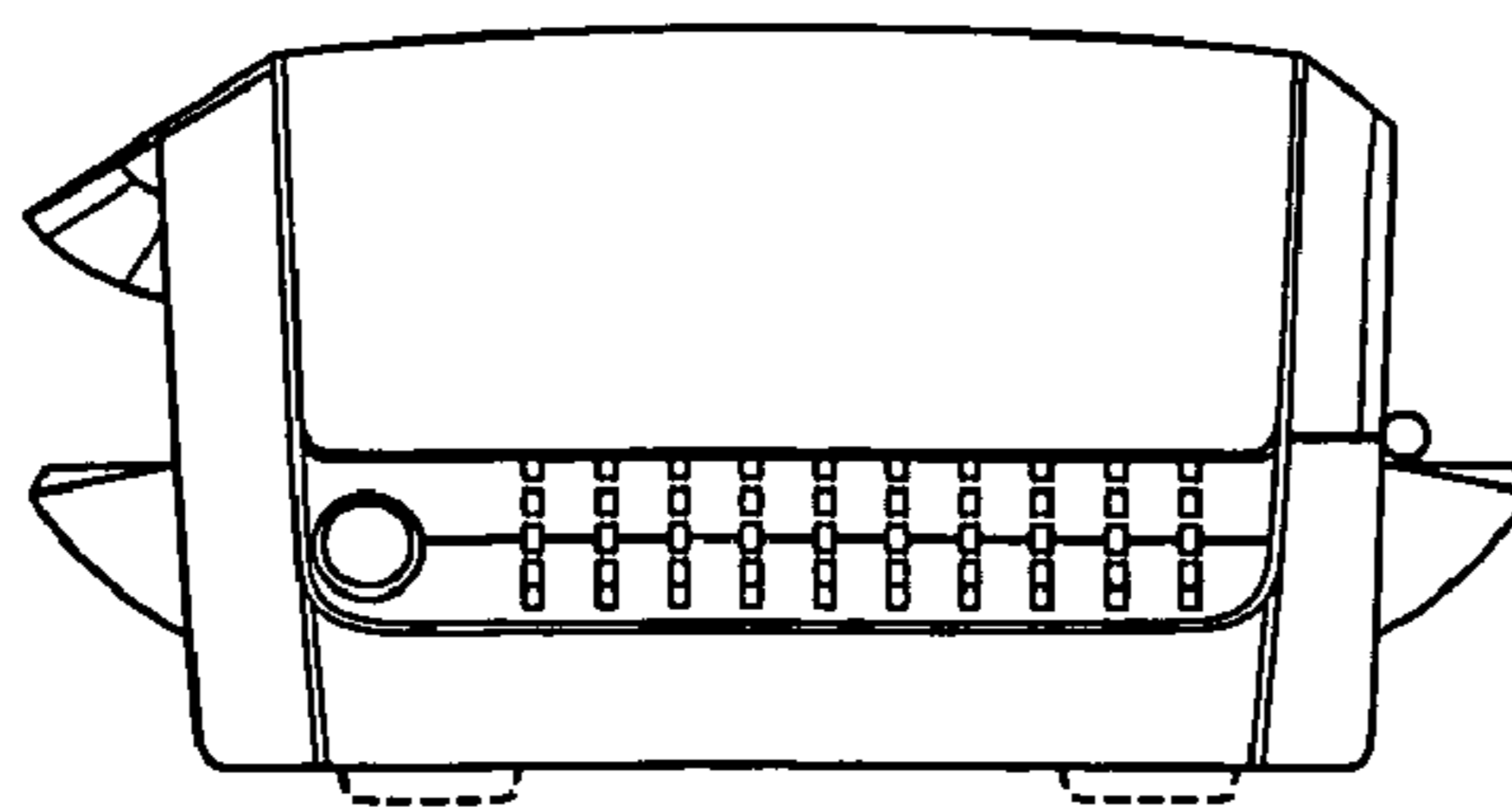

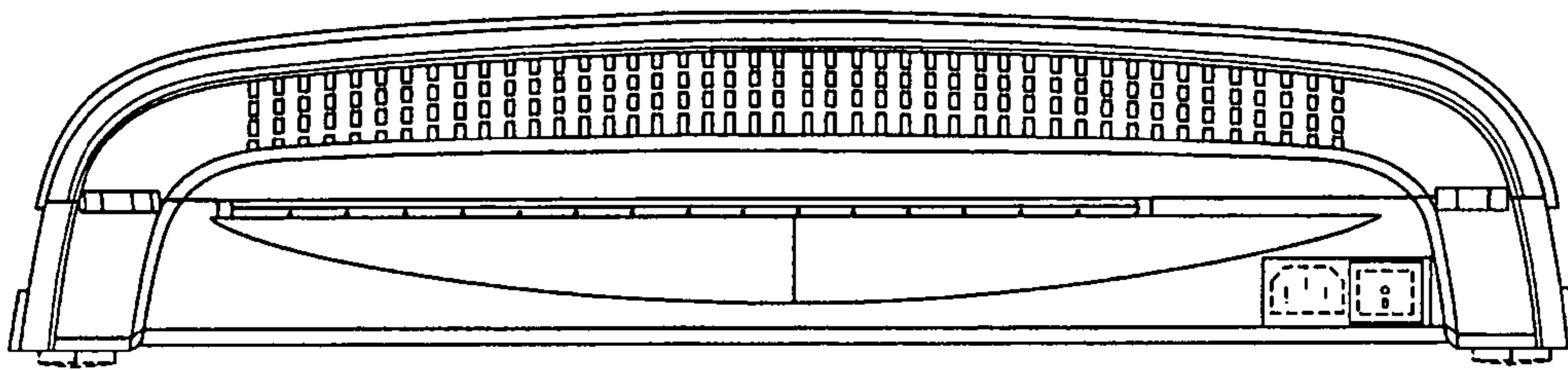
