FIG. 5 is a right side elevation view thereof;

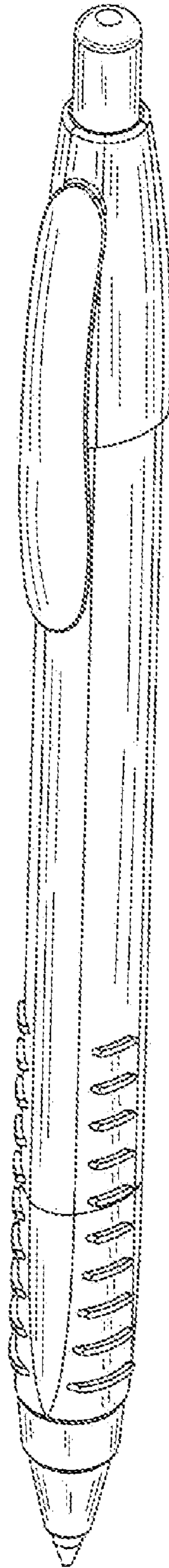
FIG. 6 is a bottom plan view thereof; and,

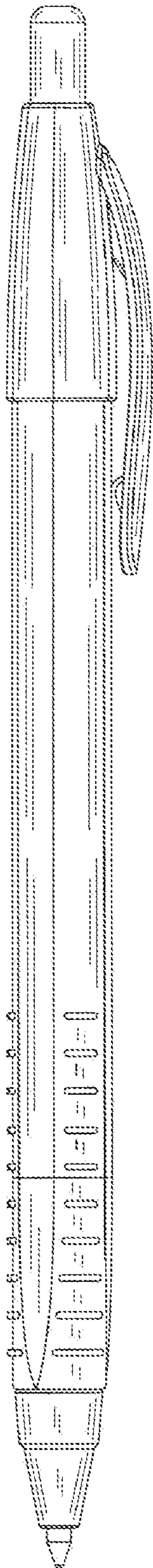

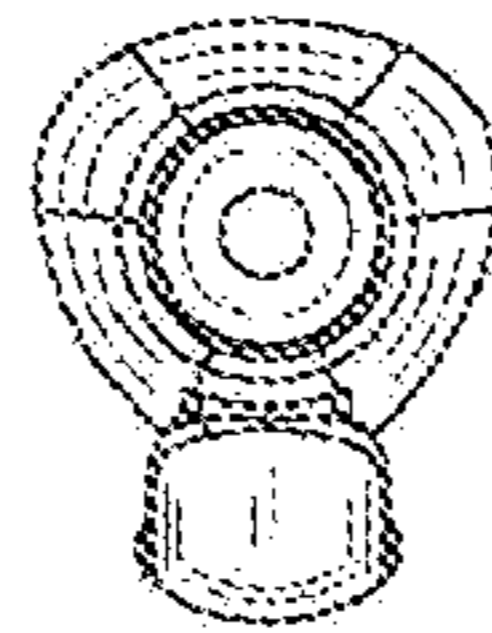

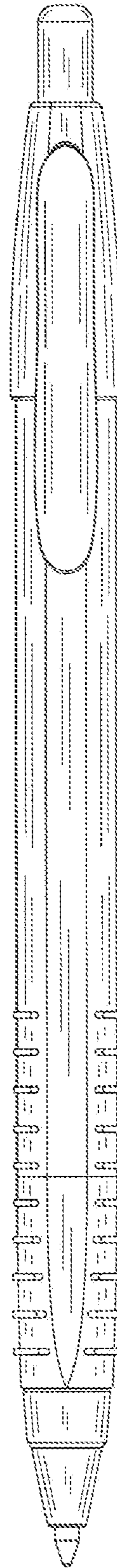

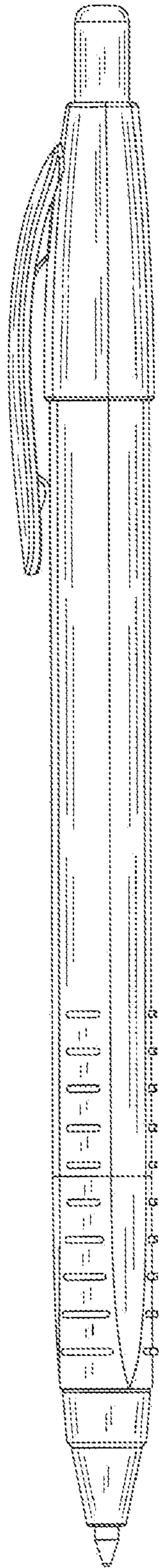

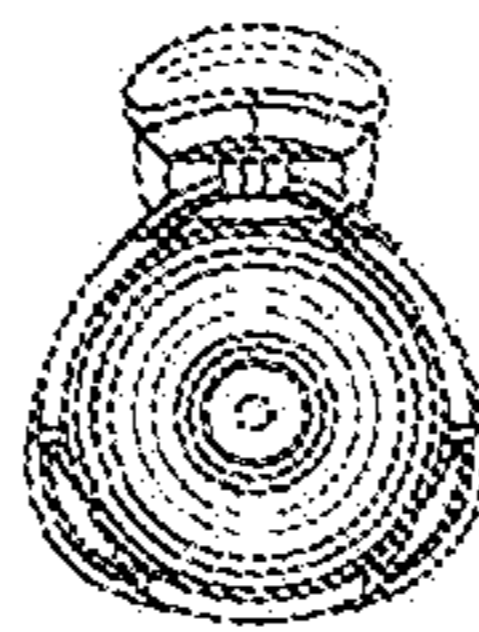

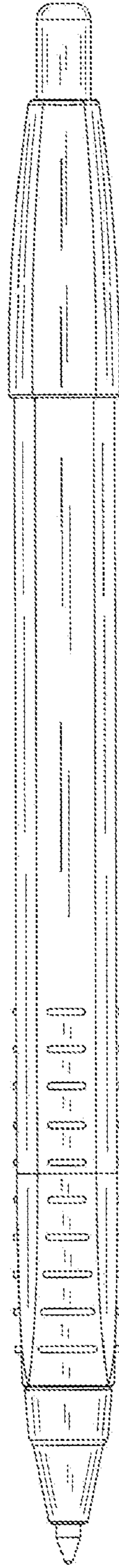
