The ornamental design for an exerciser, as shown and described.

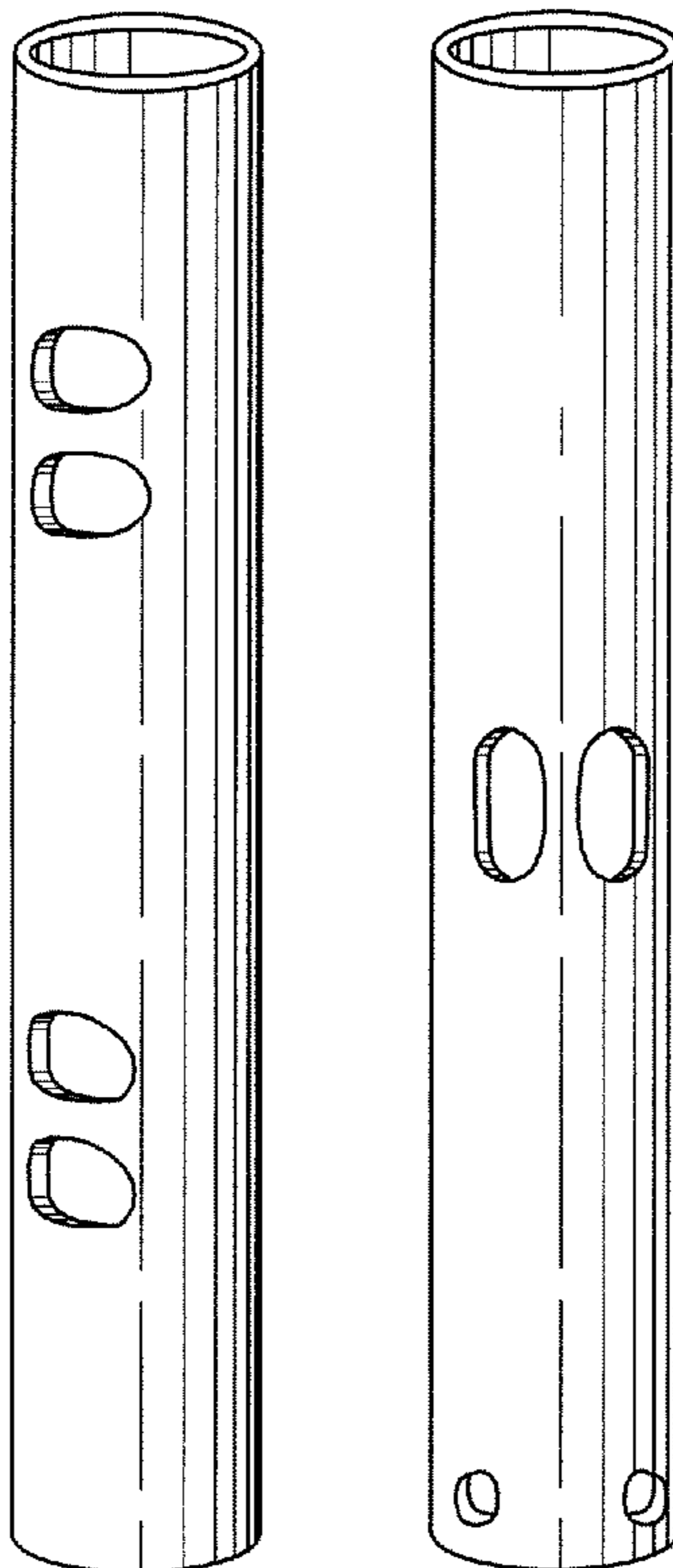
DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of the exerciser;

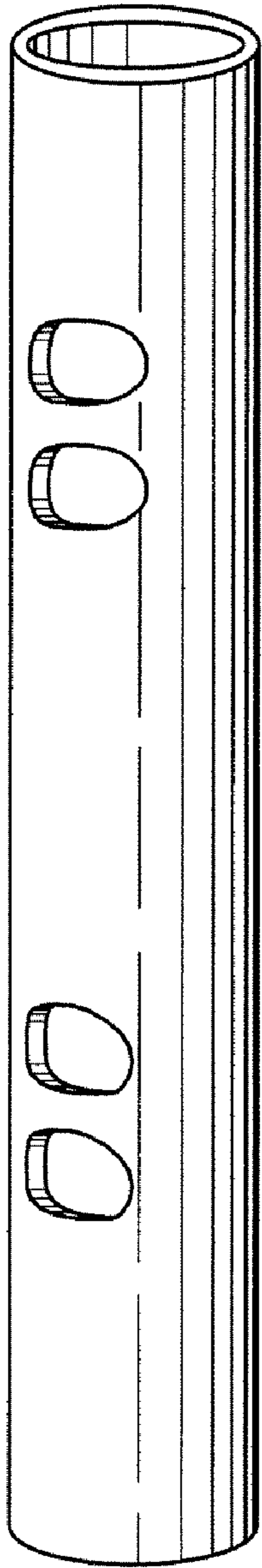

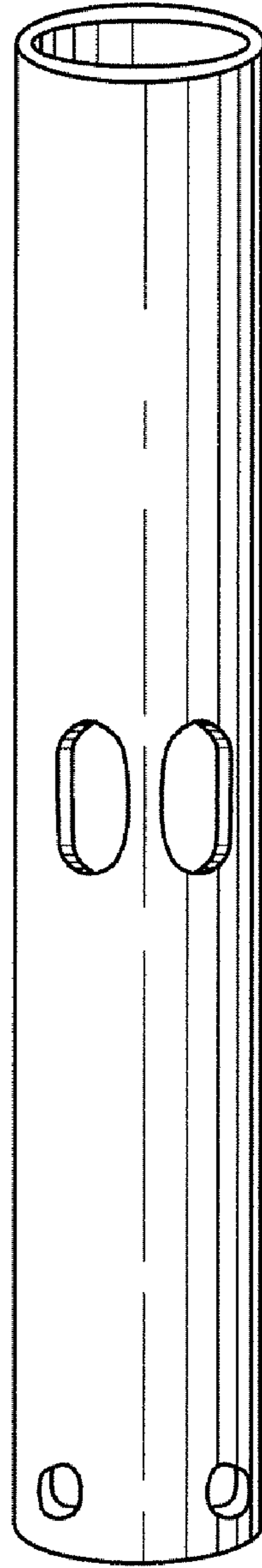

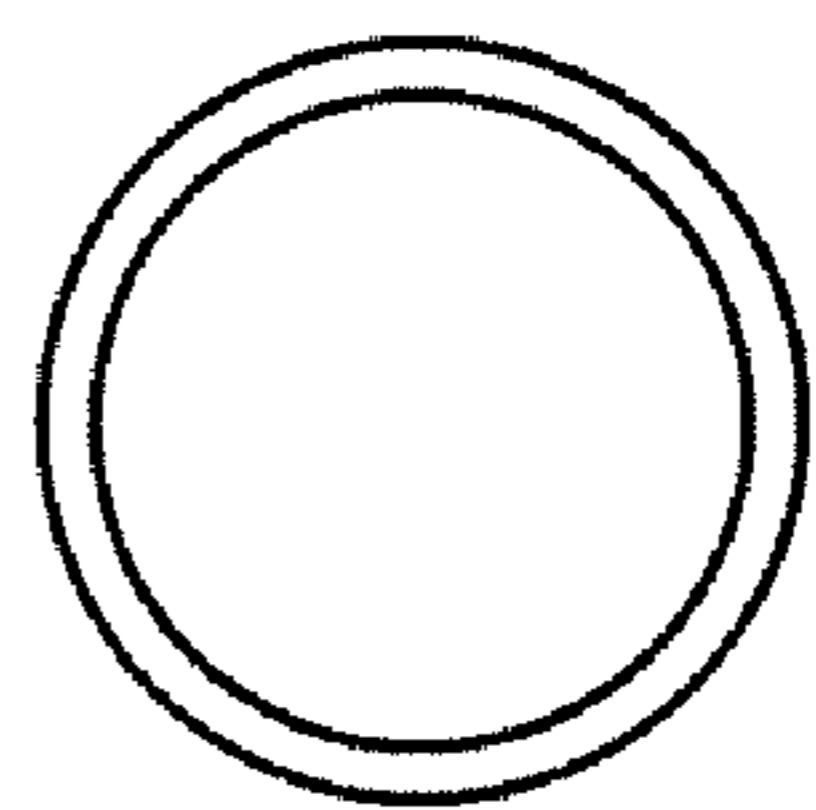
