(57) **CLAIM**

The ornamental design for a basketball shooting aid, and described.

**DESCRIPTION**

FIG. 1 is a top view showing my new design, the opposite side being a mirror image thereof;

FIG. 2 is a perspective view thereof:

FIG. 3 is an end view thereof; the opposite end view being the same; and,

FIG. 4 is a side view thereof; the only difference between the opposing sides being that one follows the slightly concave curvature and the other the slightly convex curvature shown in the profiles of FIGS. 1 and 2.

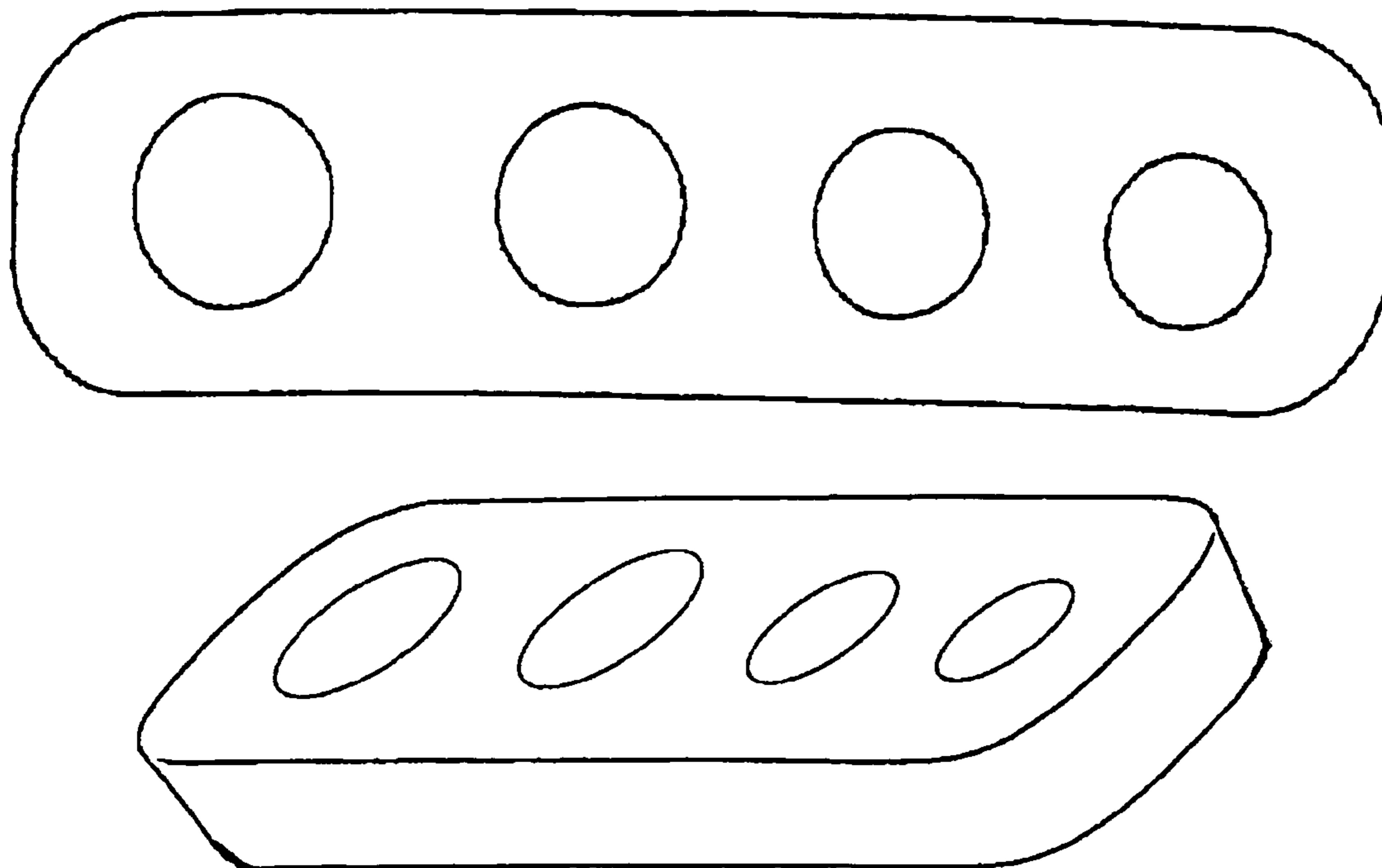

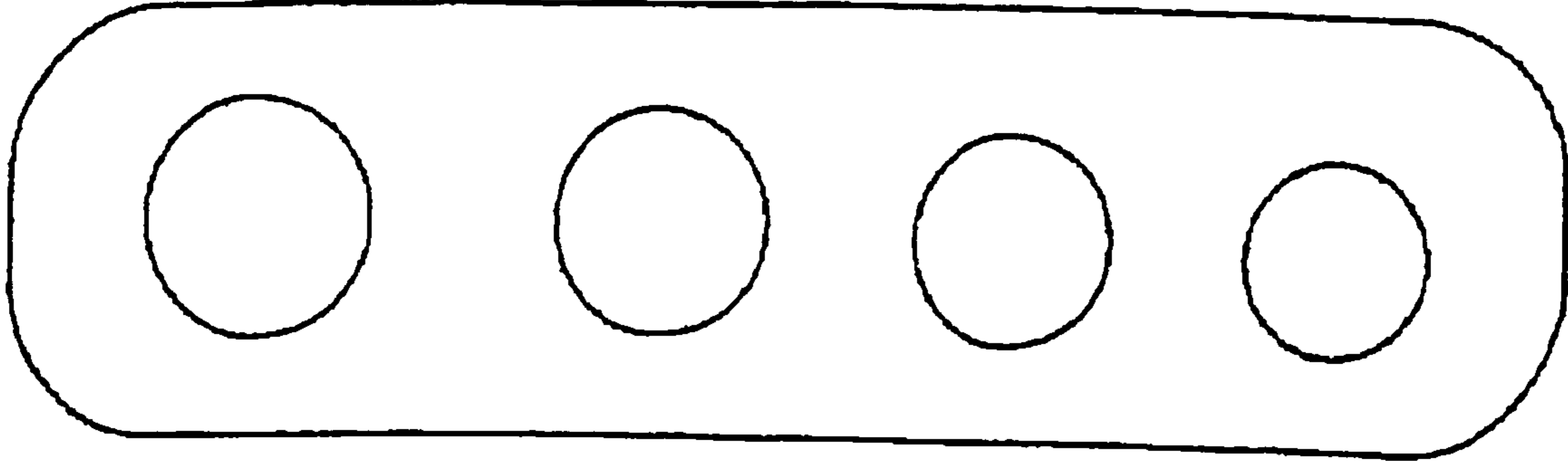

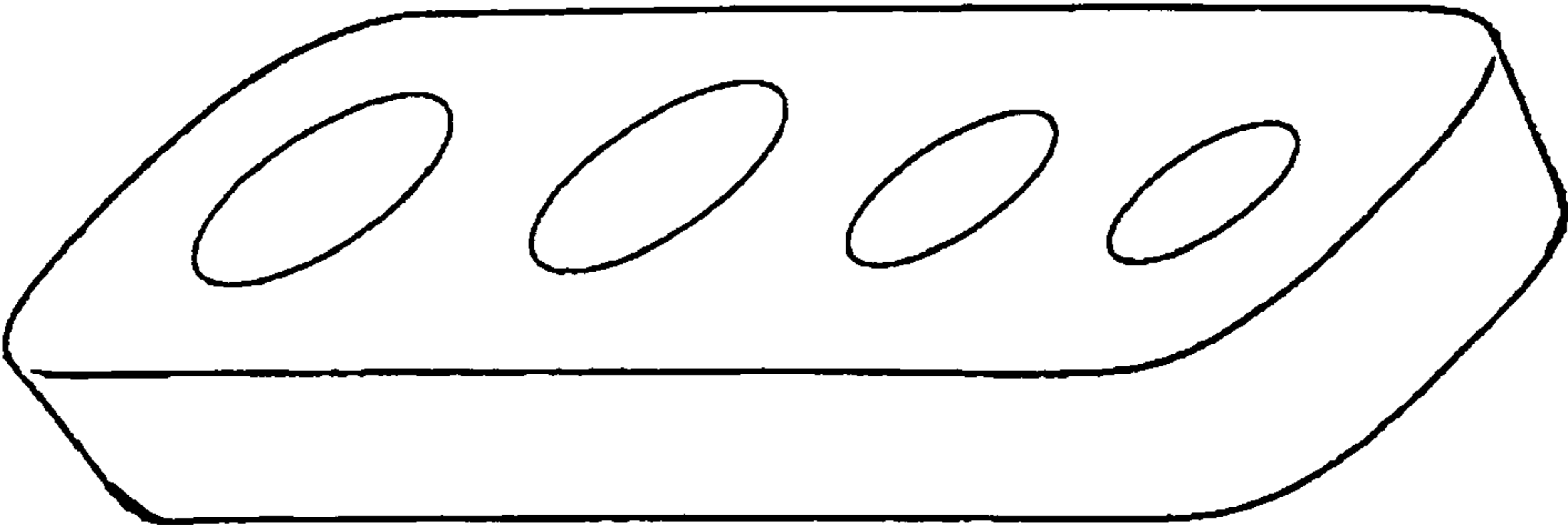
