I claim the ornamental design for a range hood, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a range hood, showing my new design;

FIG. 2 is a bottom plan view of the embodiment of FIG. 1;

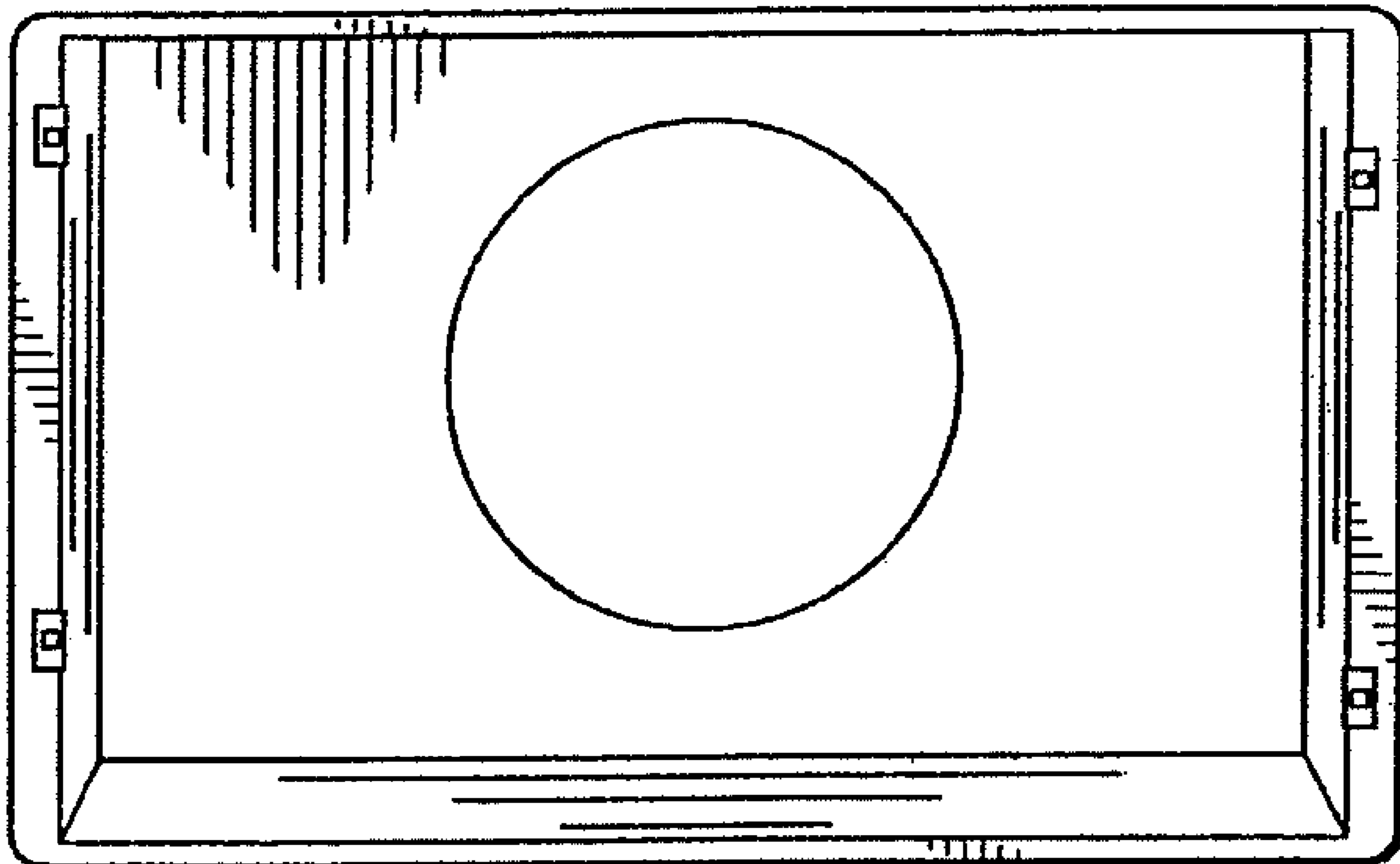
FIG. 3 is a left side elevational view of the embodiment of FIG. 1, the right side being a mirror image of the left side;

FIG. 4 is a front elevational view of the embodiment of FIG. 1;

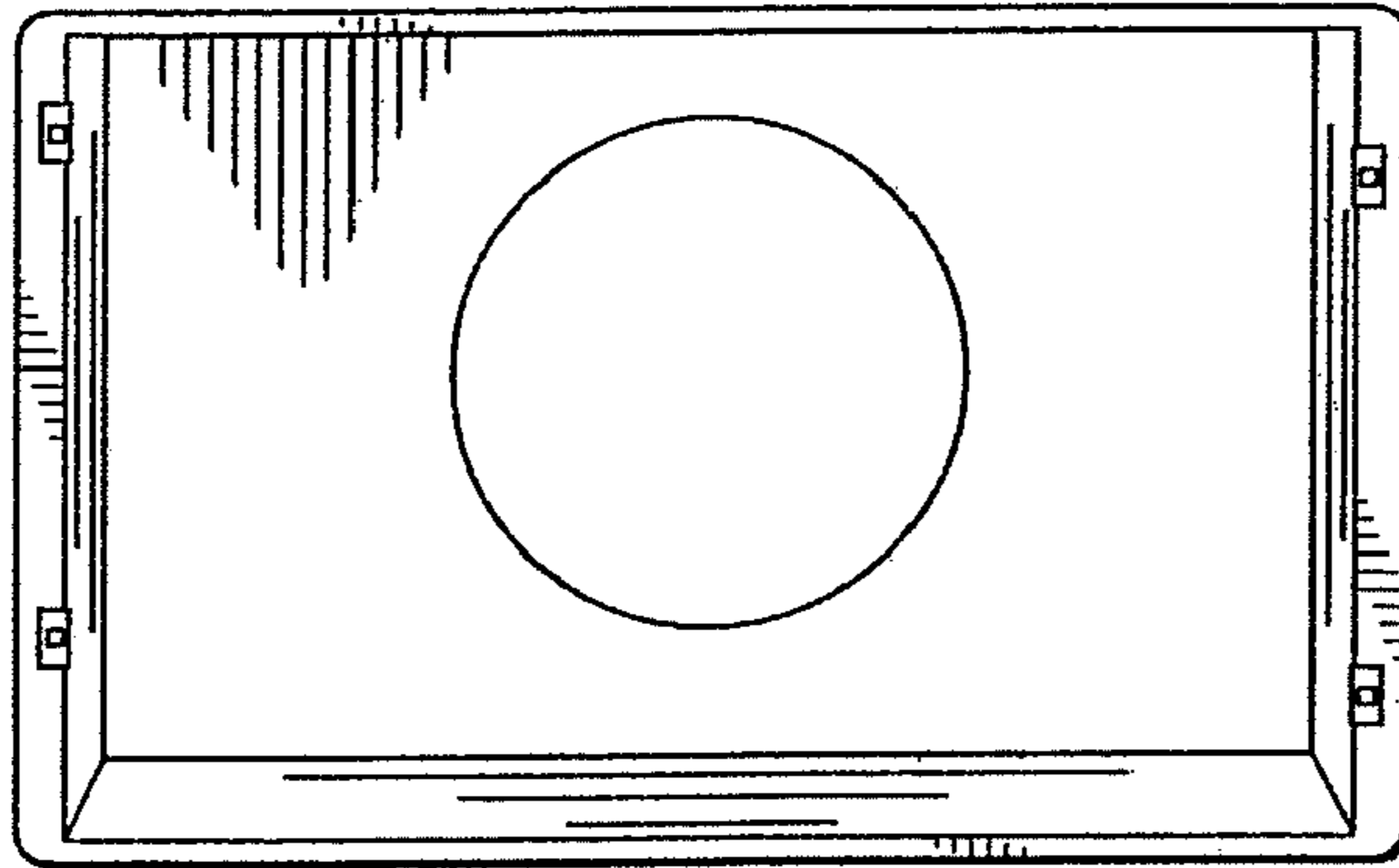

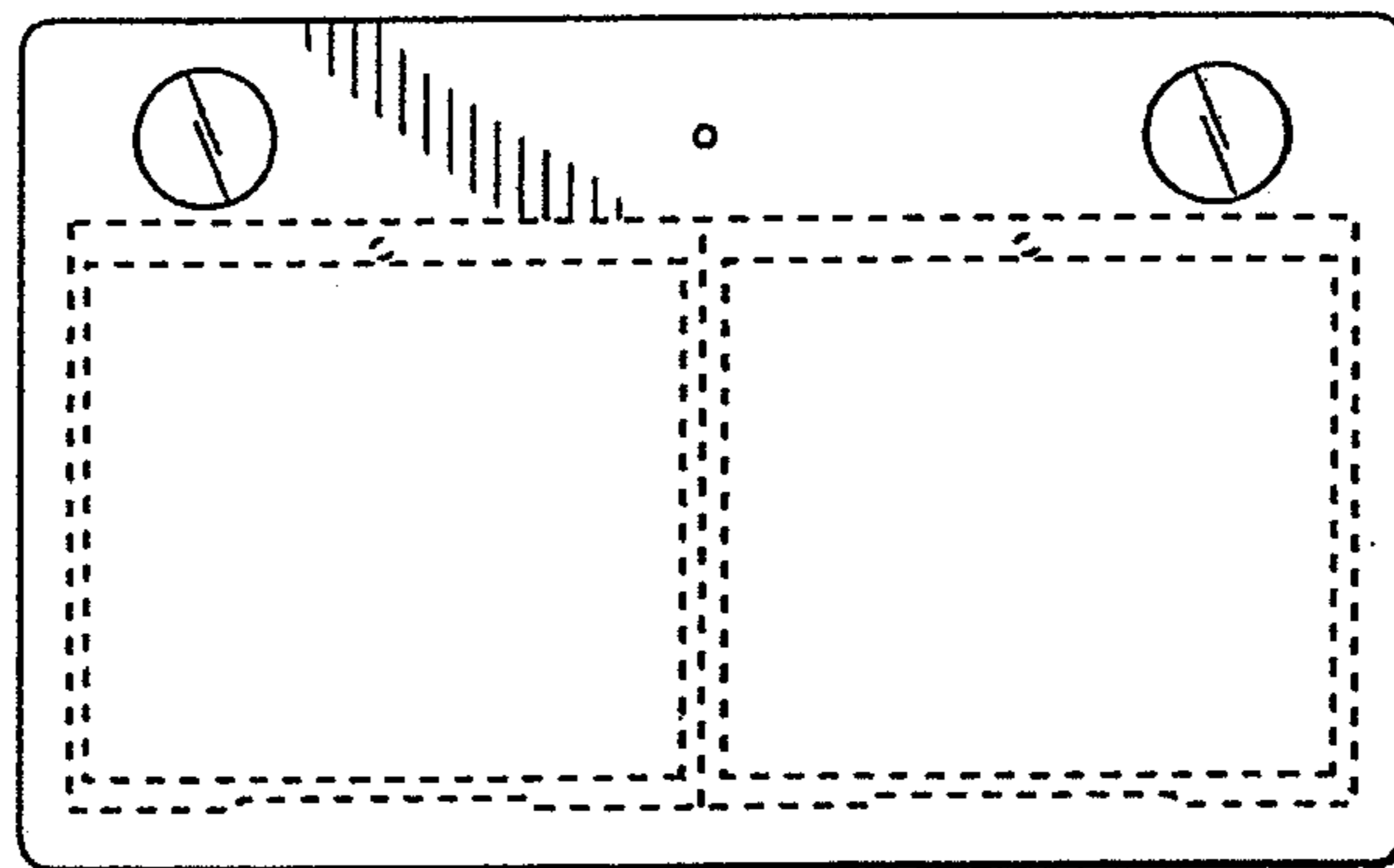

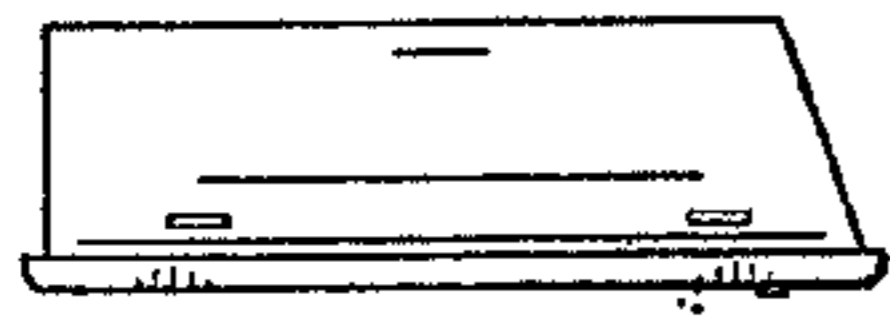

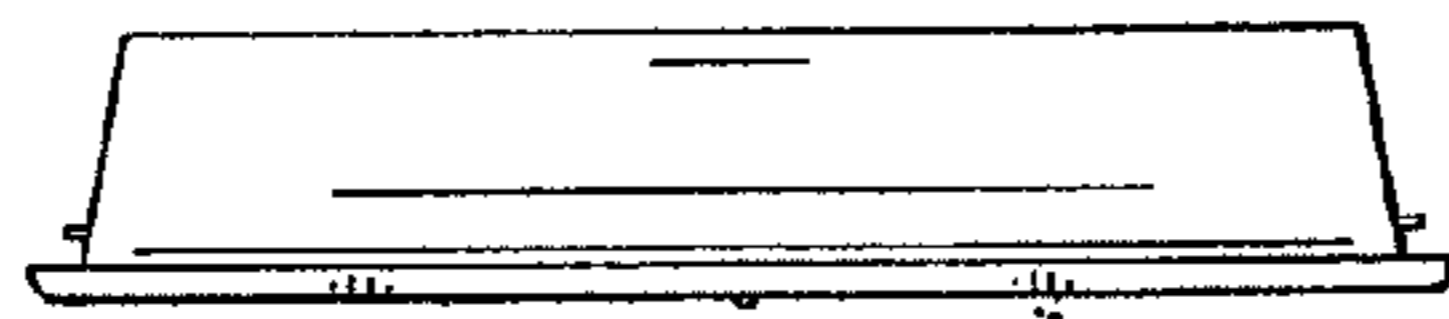

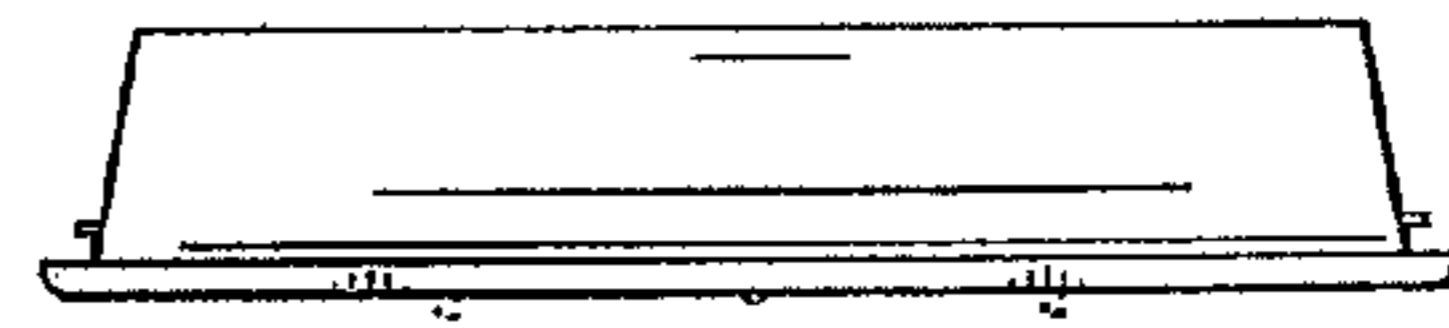

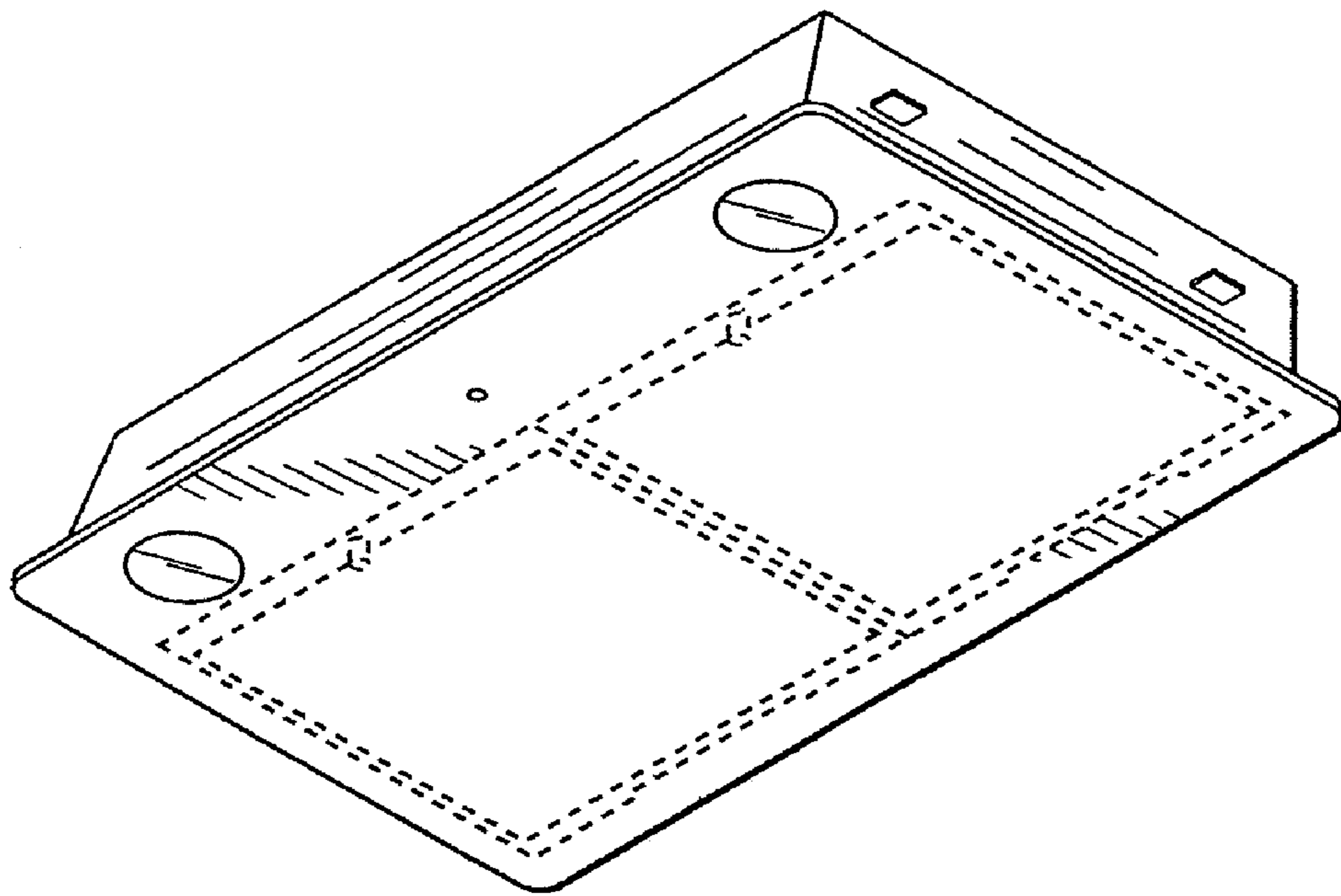
