The ornamental design for an orthopaedic implant, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an orthopaedic implant showing my new design;

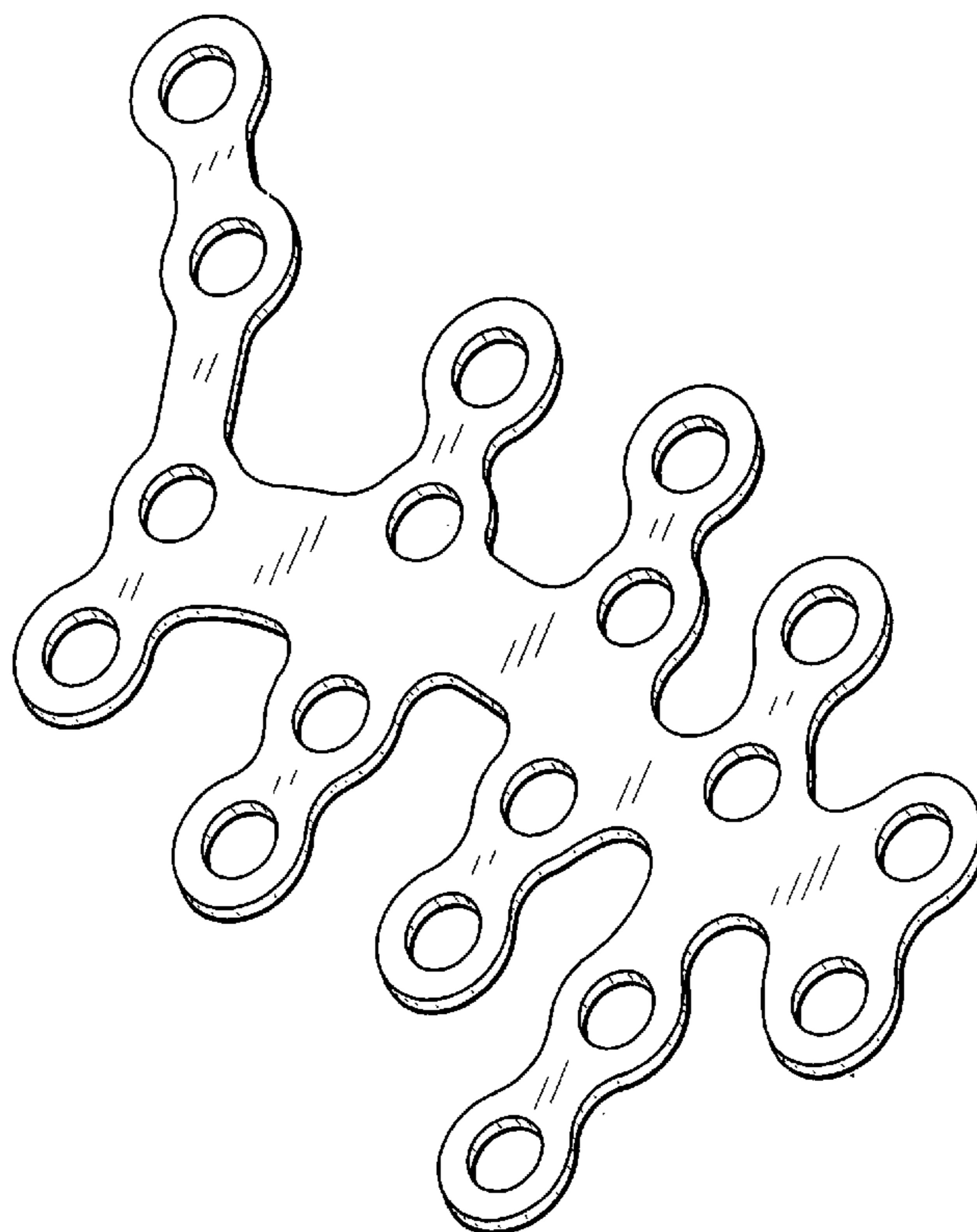

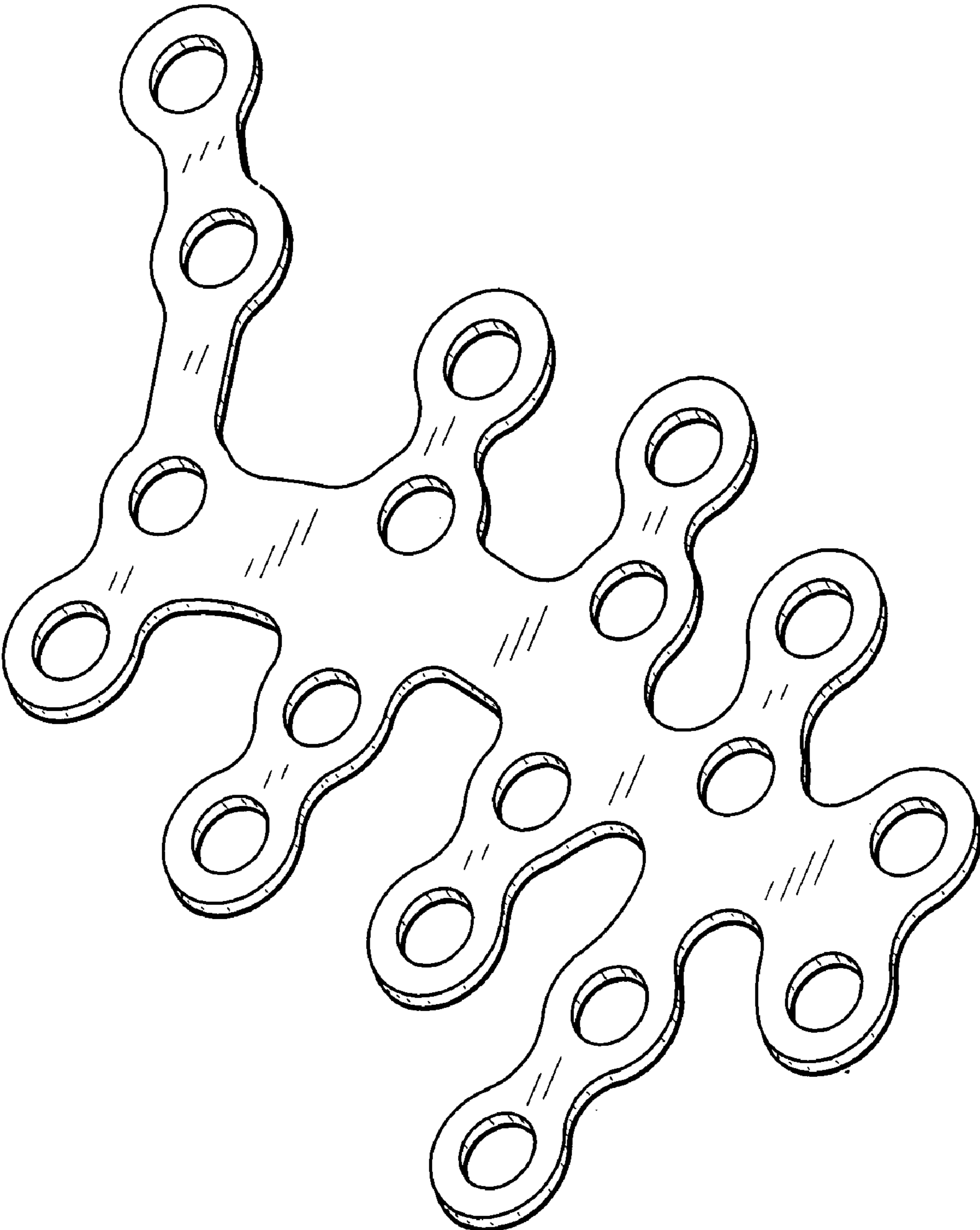

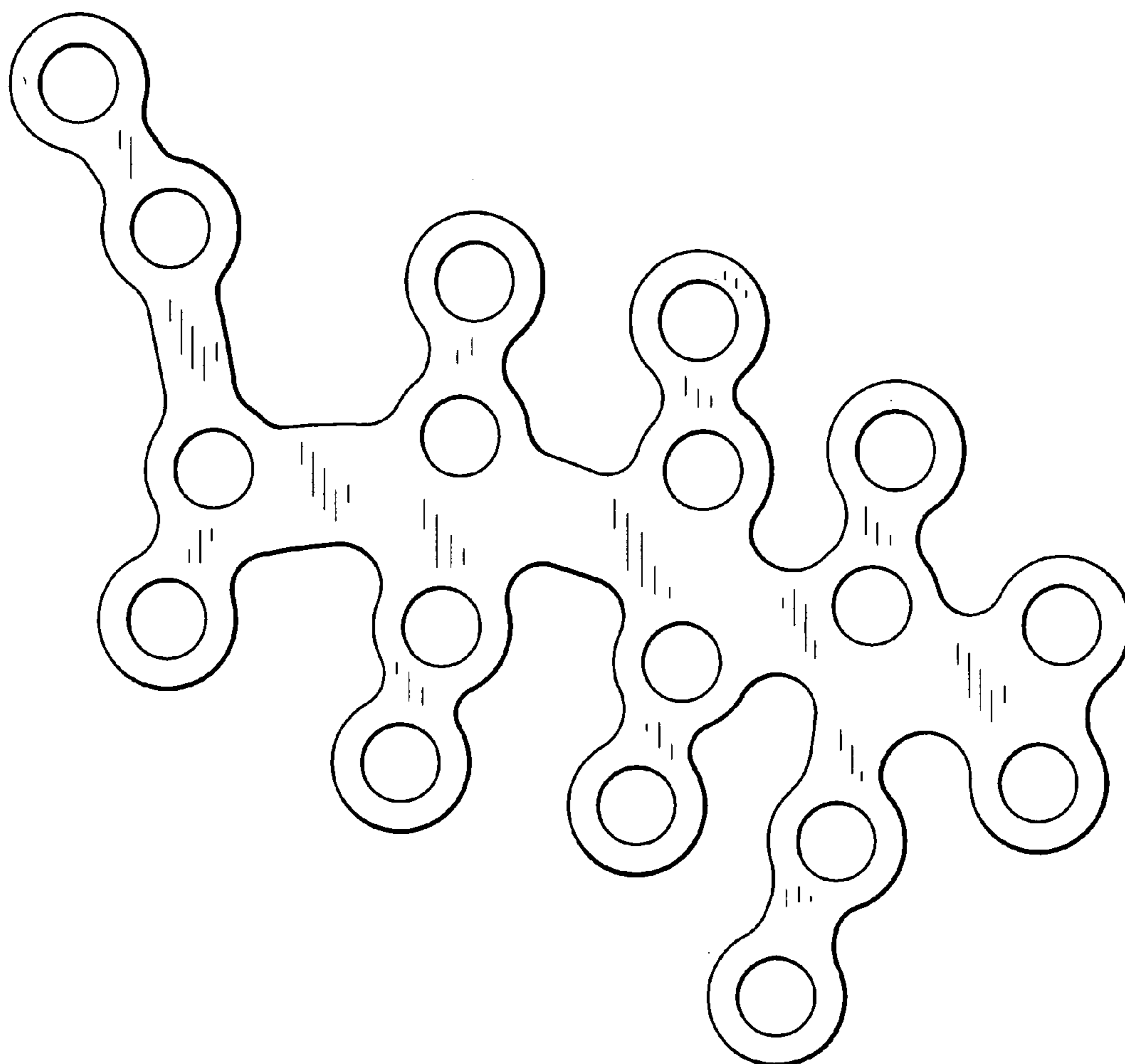
