FIG. 1 is a front view of an ice cream kiosk trailer showing our new design;

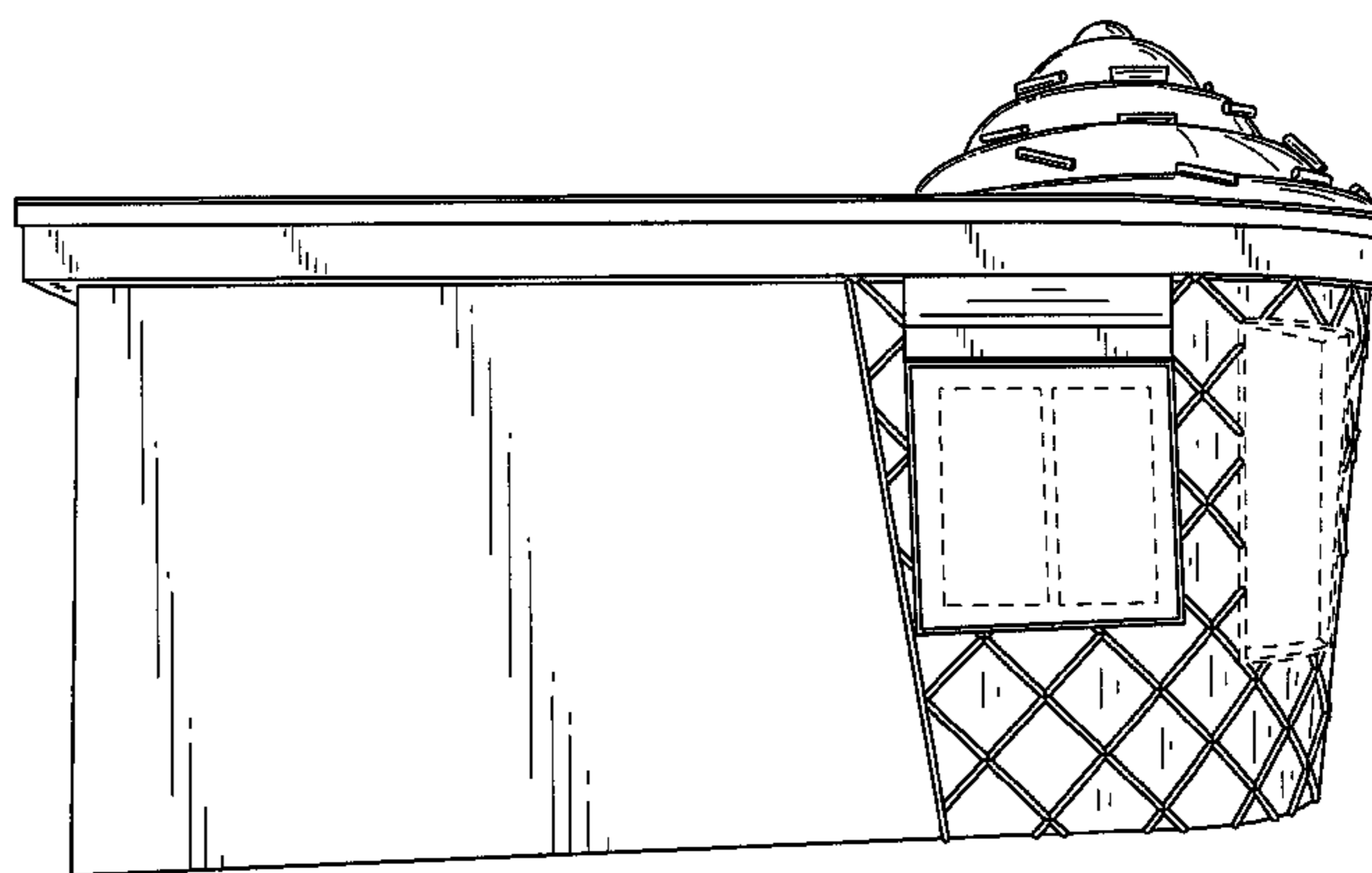
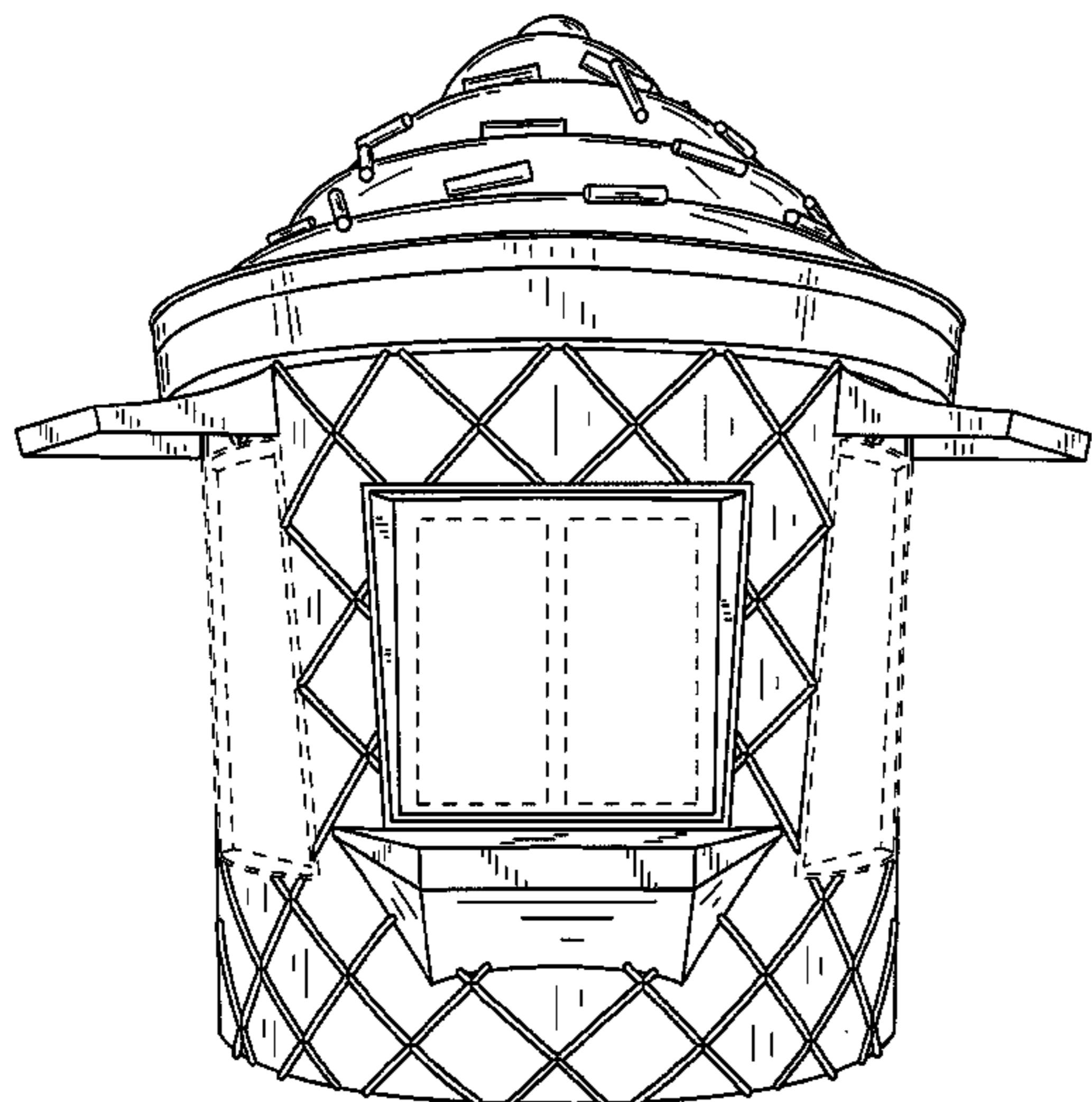
FIG. 2 is a side view thereof;

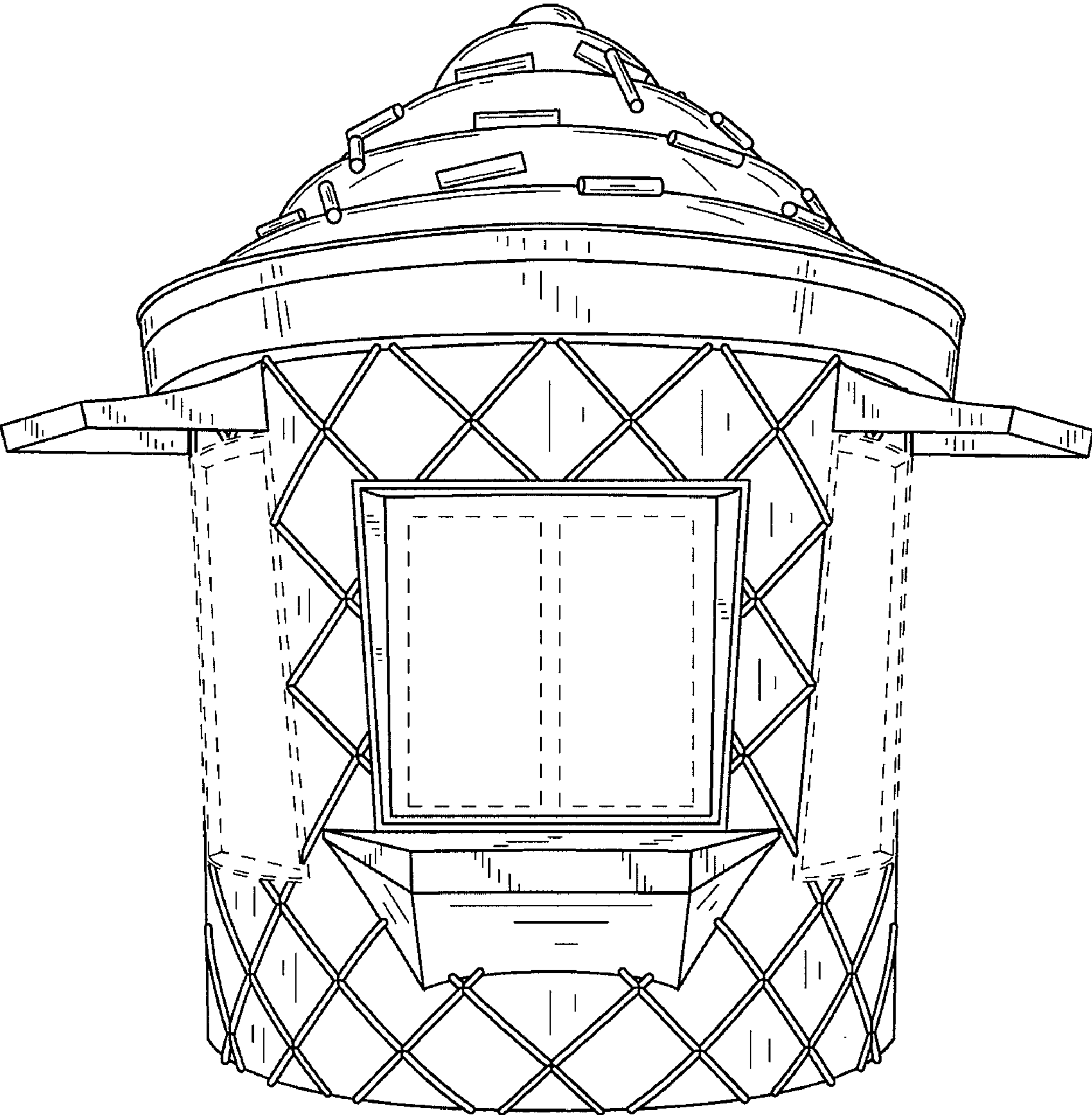

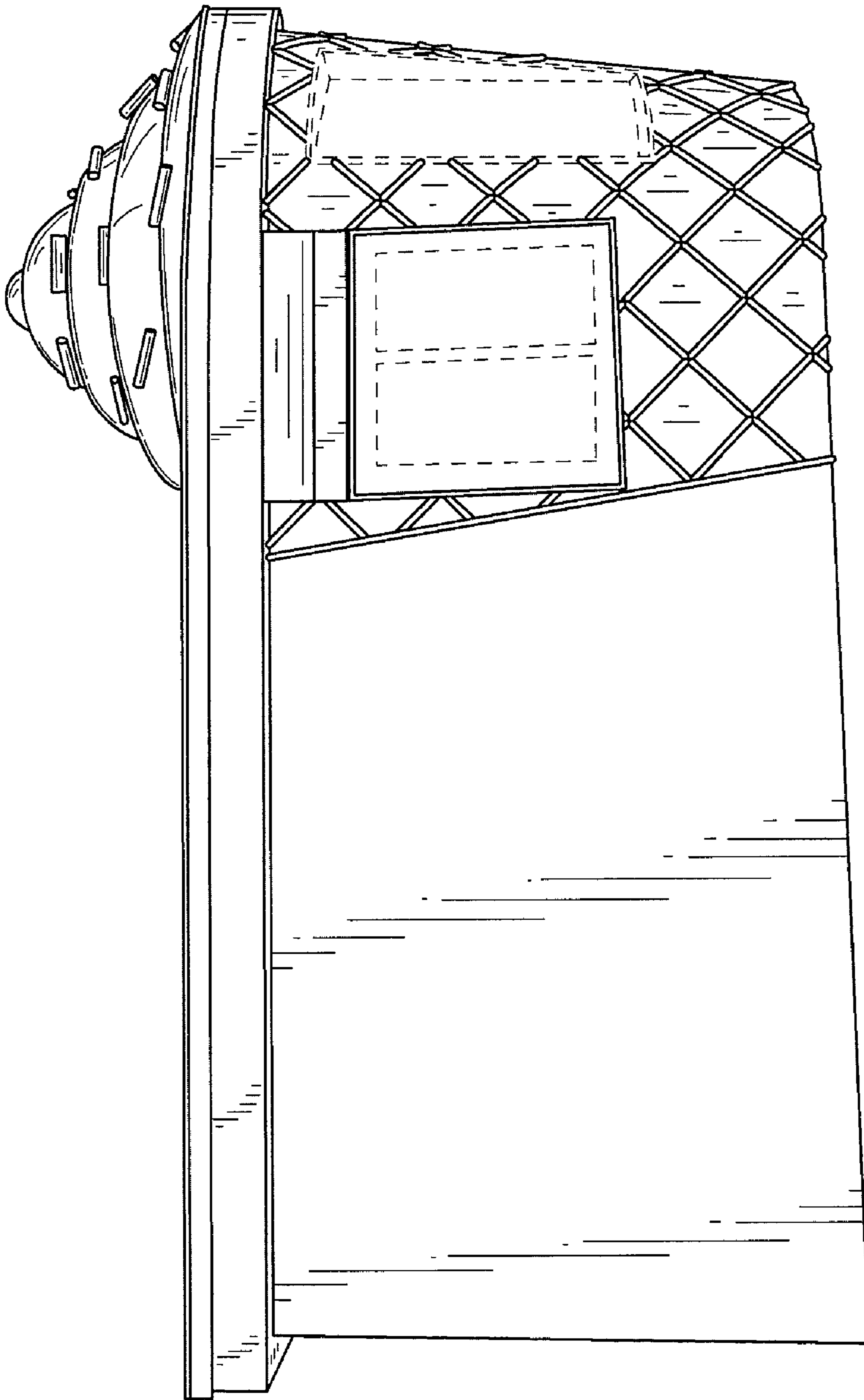

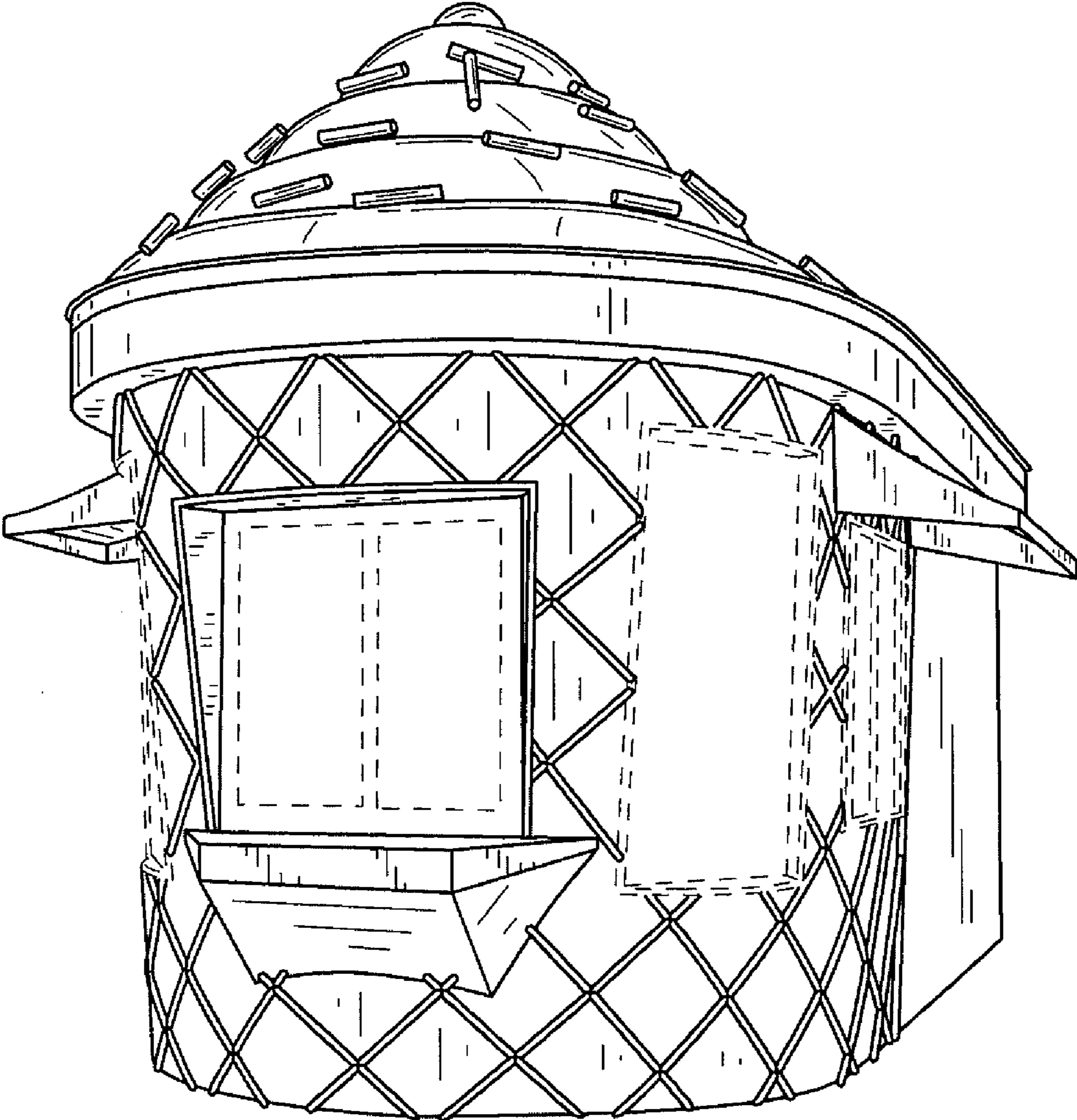

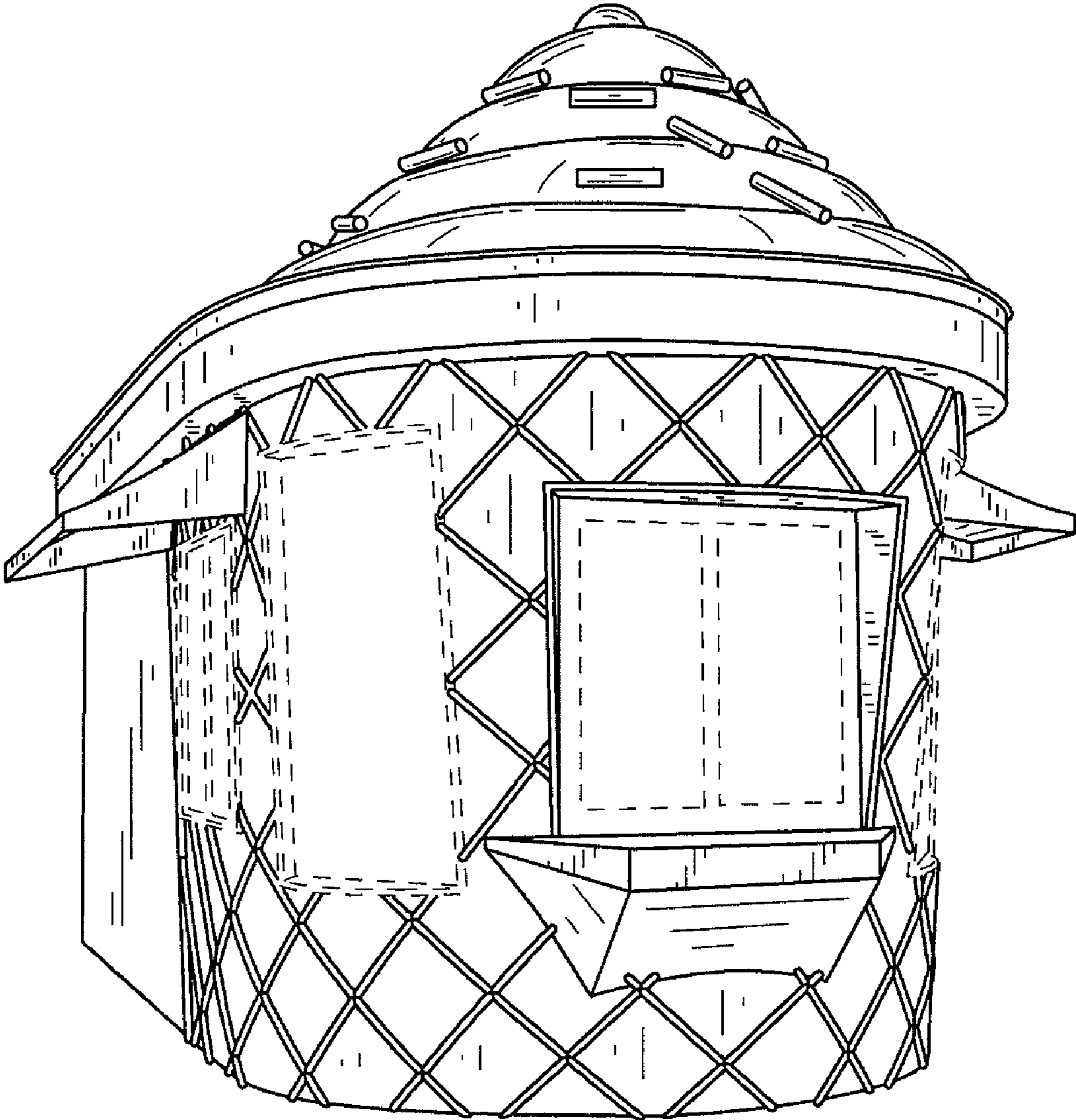
