The ornamental design for a lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lamp from below the lamp shade;

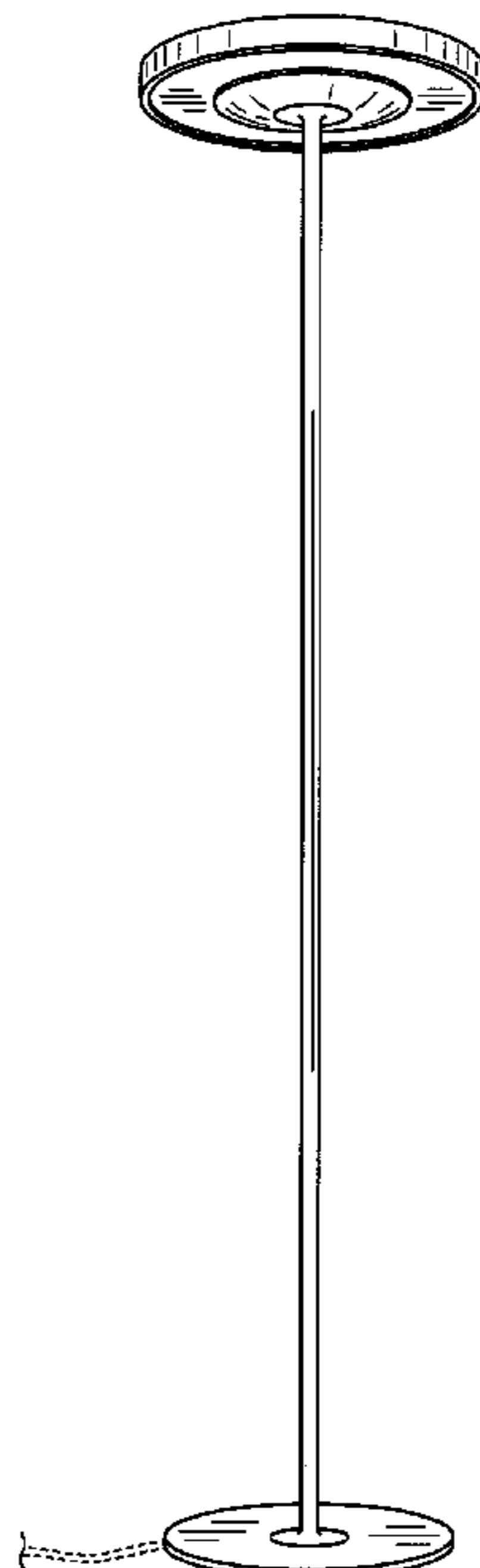
FIG. 2 is a perspective view of the lamp from above the lamp shade;

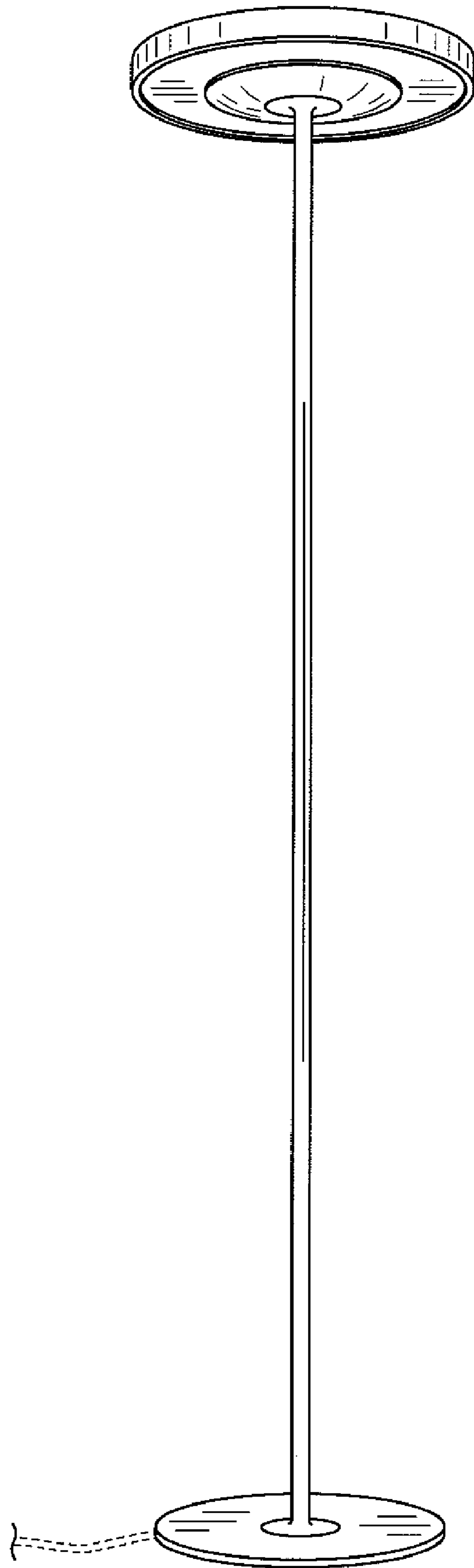

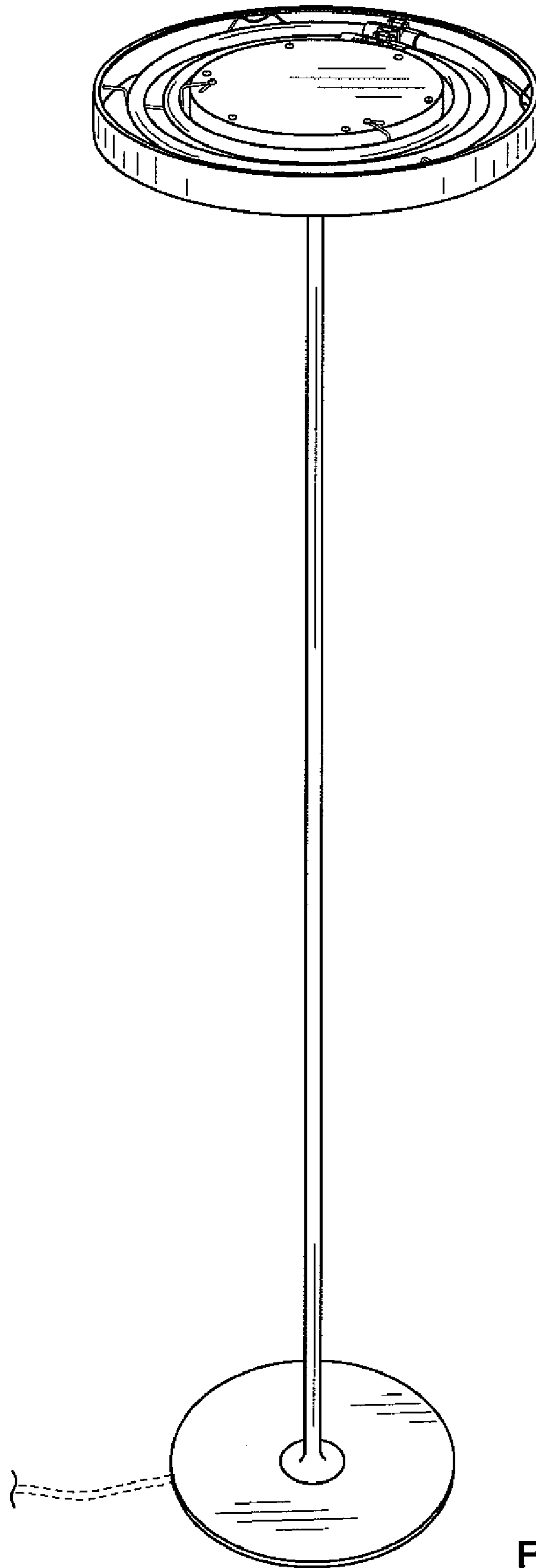

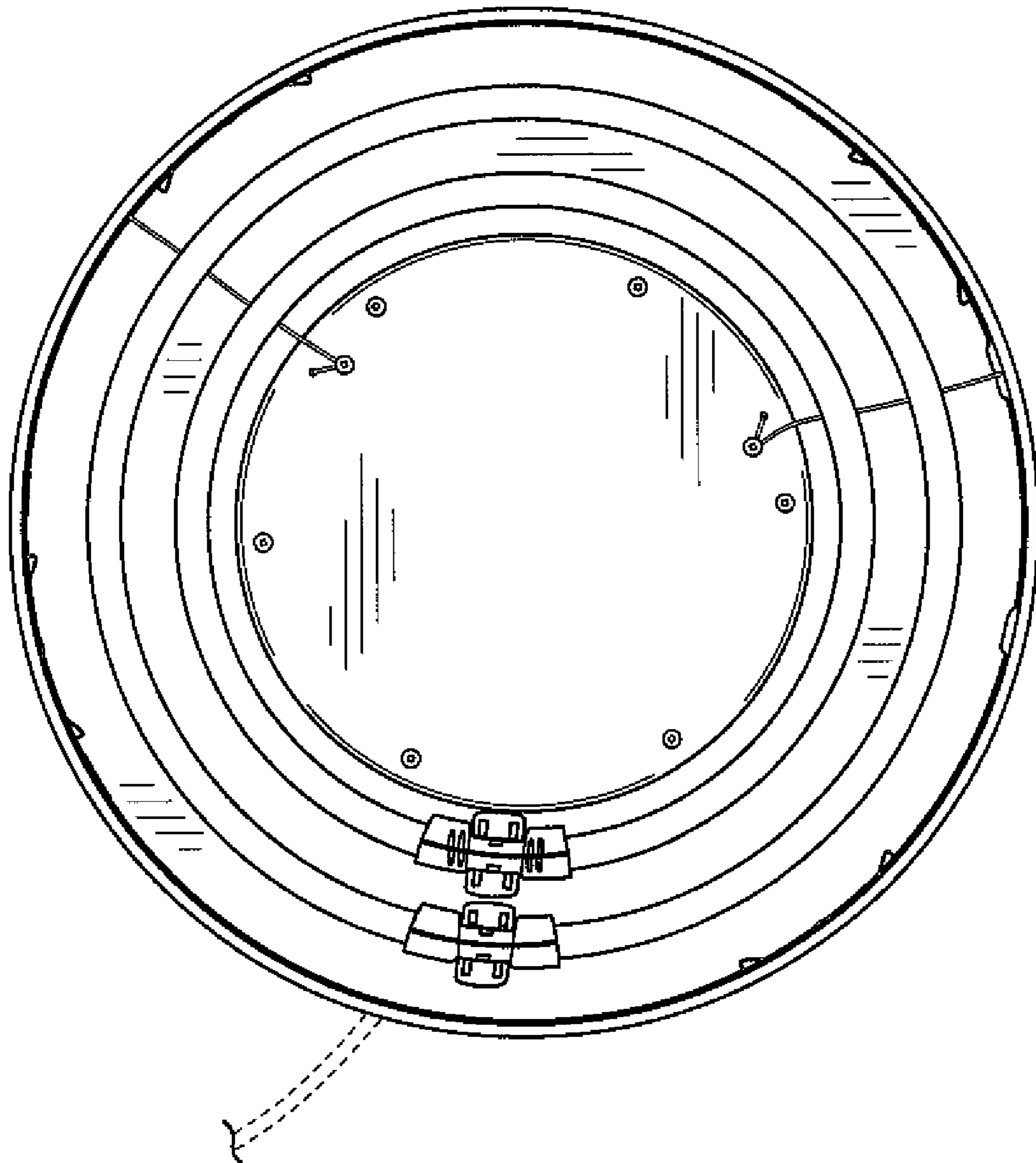

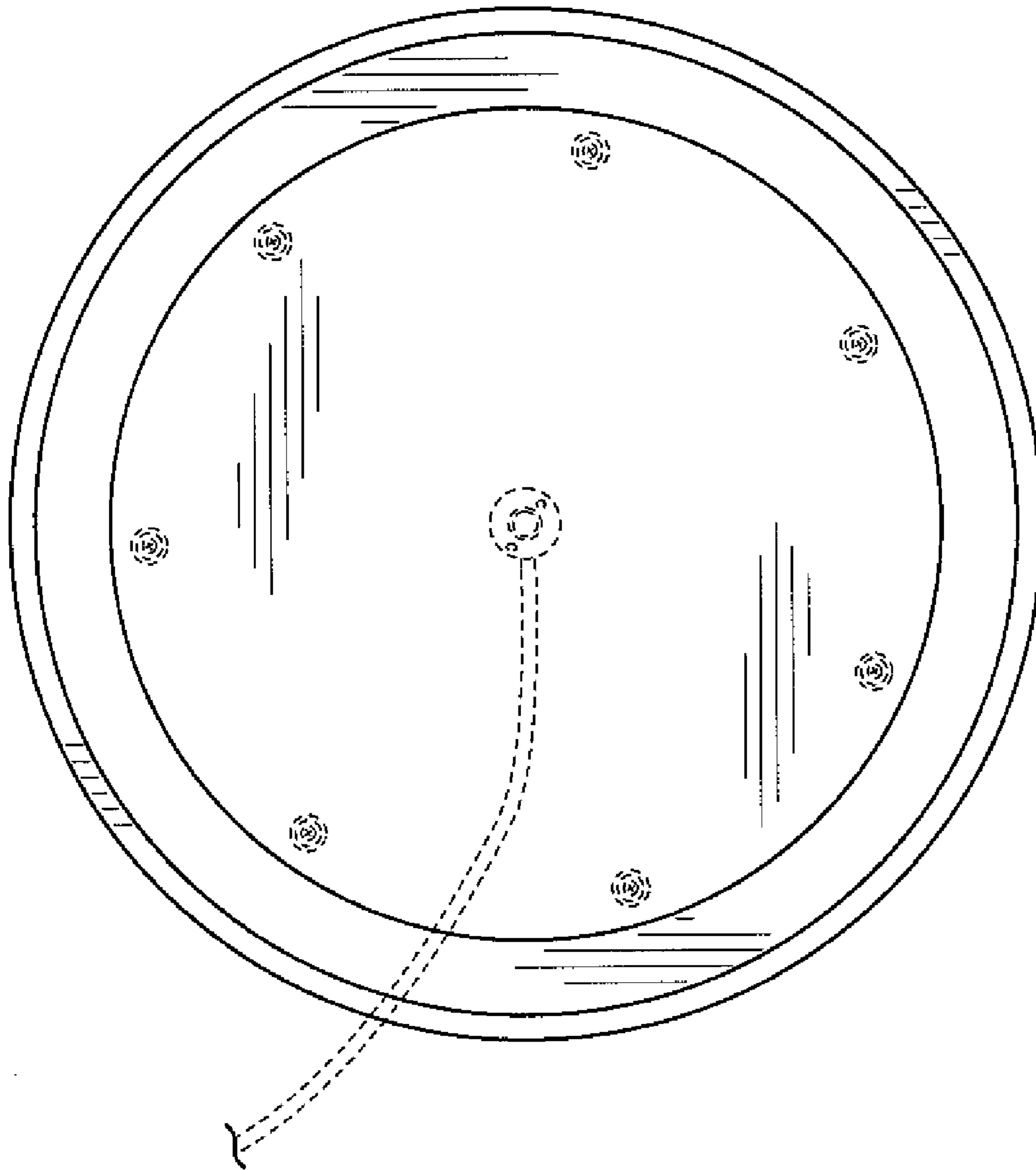
