(57) **CLAIM**

I claim the ornamental design for a women's stocking hat, as shown and described.

**DESCRIPTION**

FIG. 1 is a first side perspective view of the women's stocking hat illustrating an outline of a wearer's head and face as exemplary environmental structure, which is shown in broken lines and forms no part of the claimed design;

FIG. 2 is a second side view of the hat;

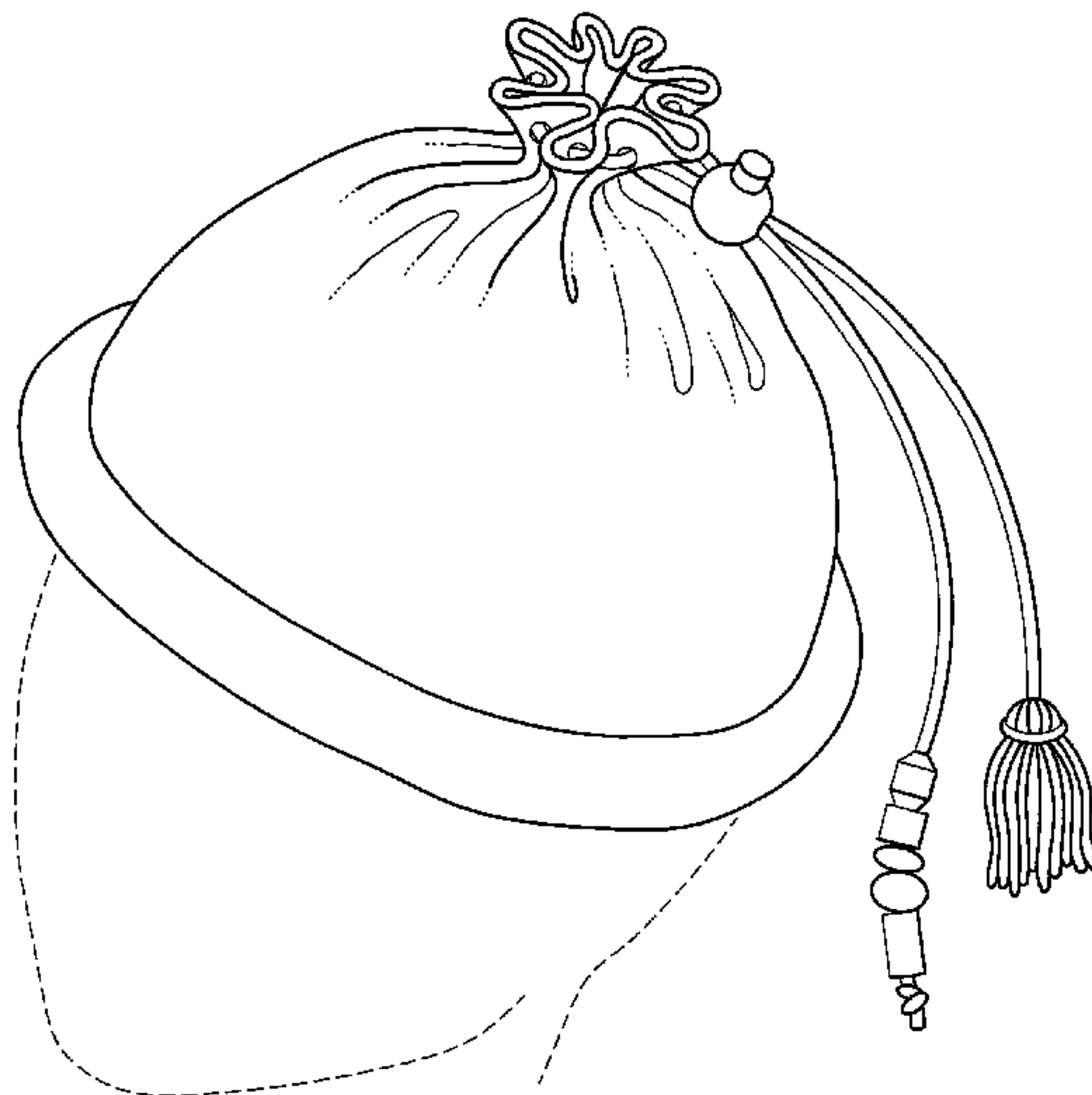
FIG. 3 is a rear elevational view of the hat;

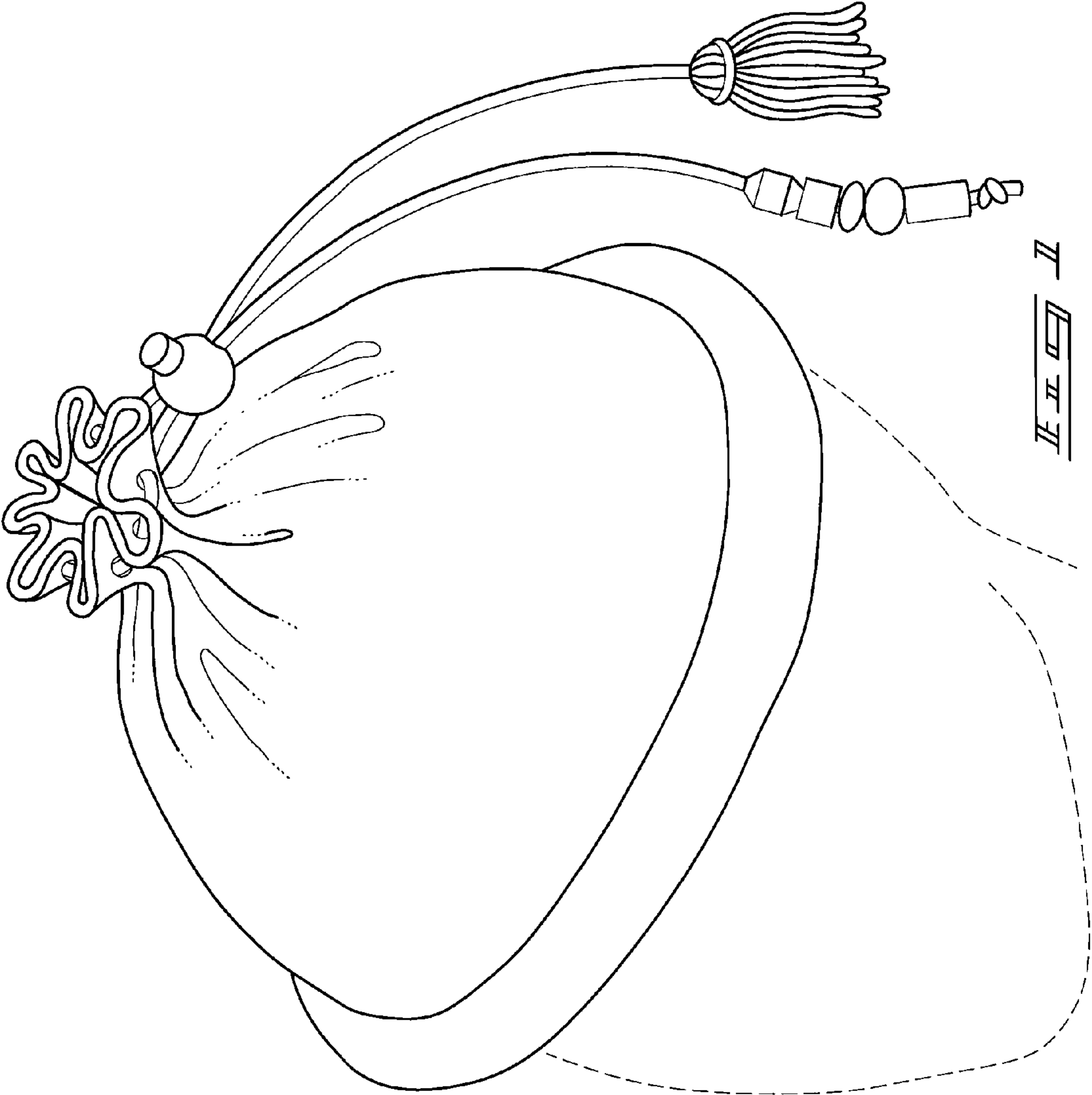

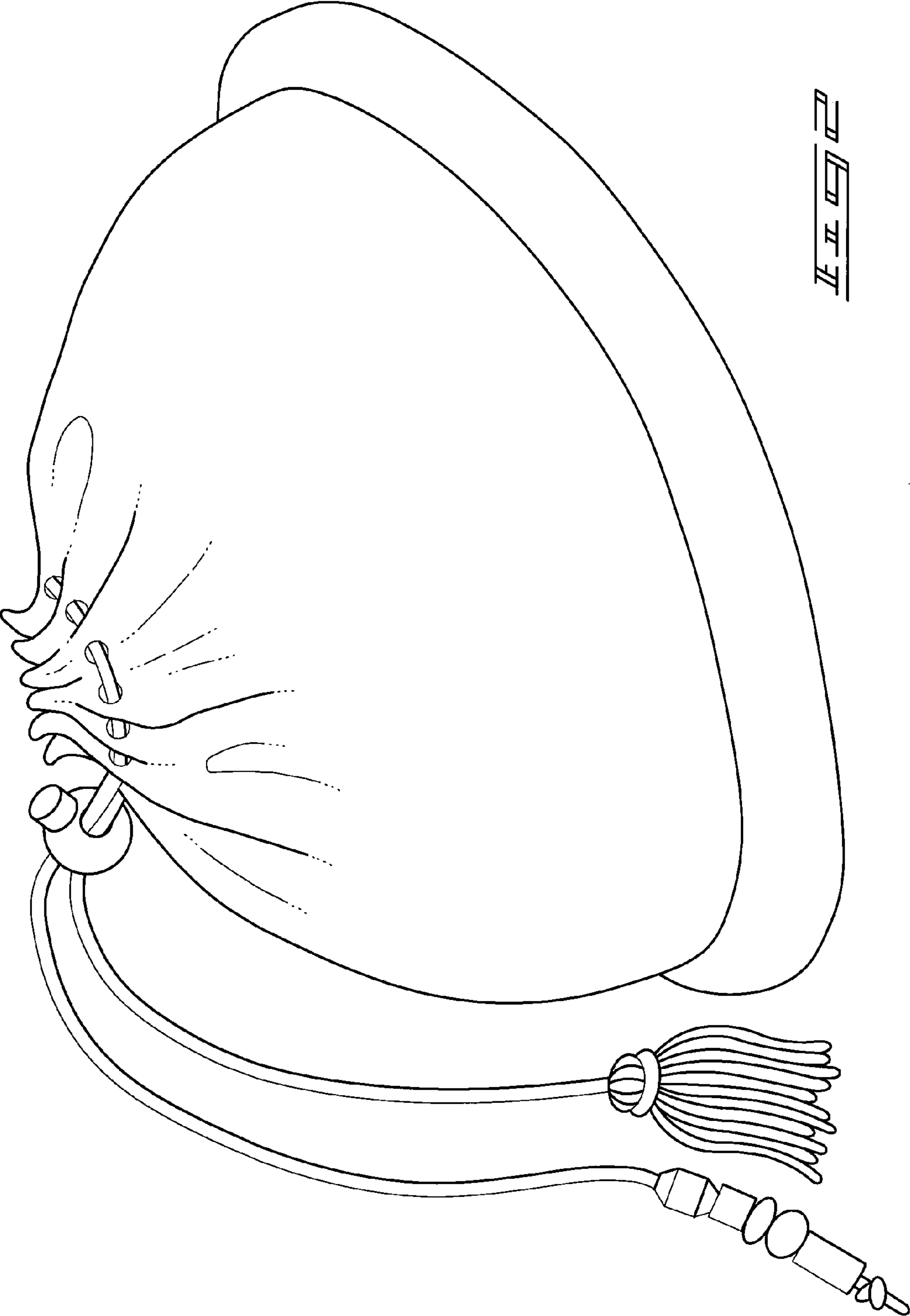

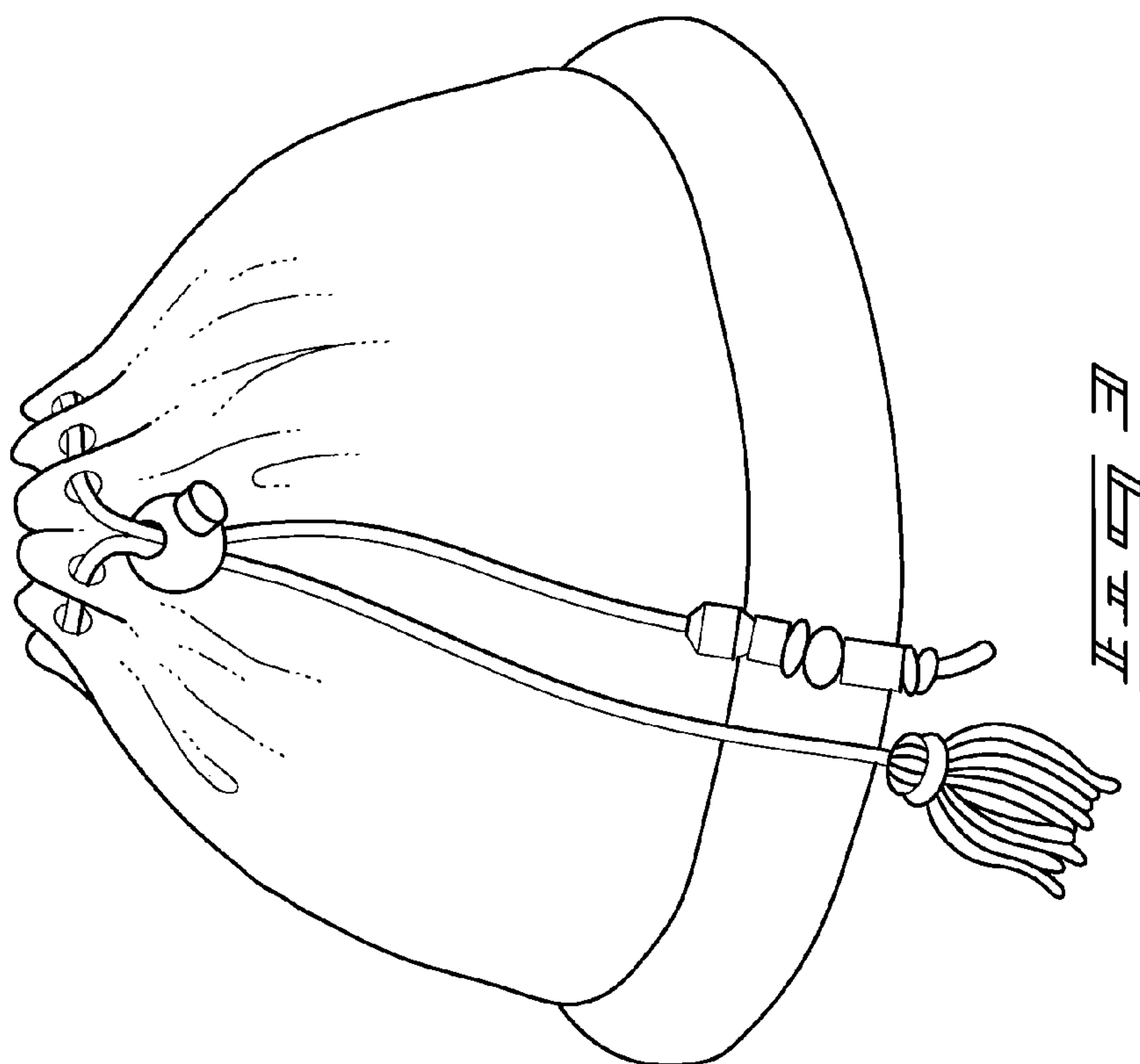
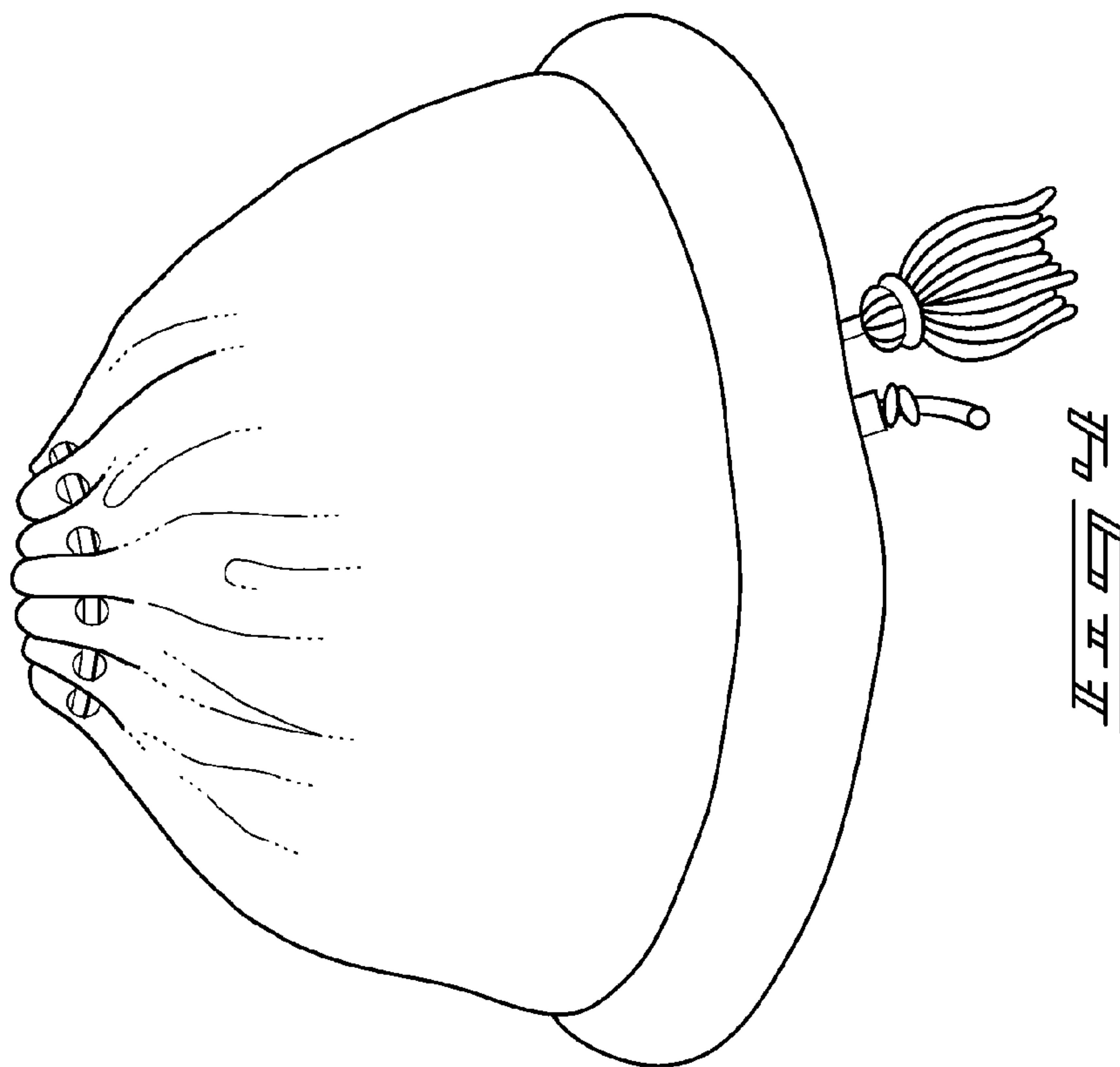

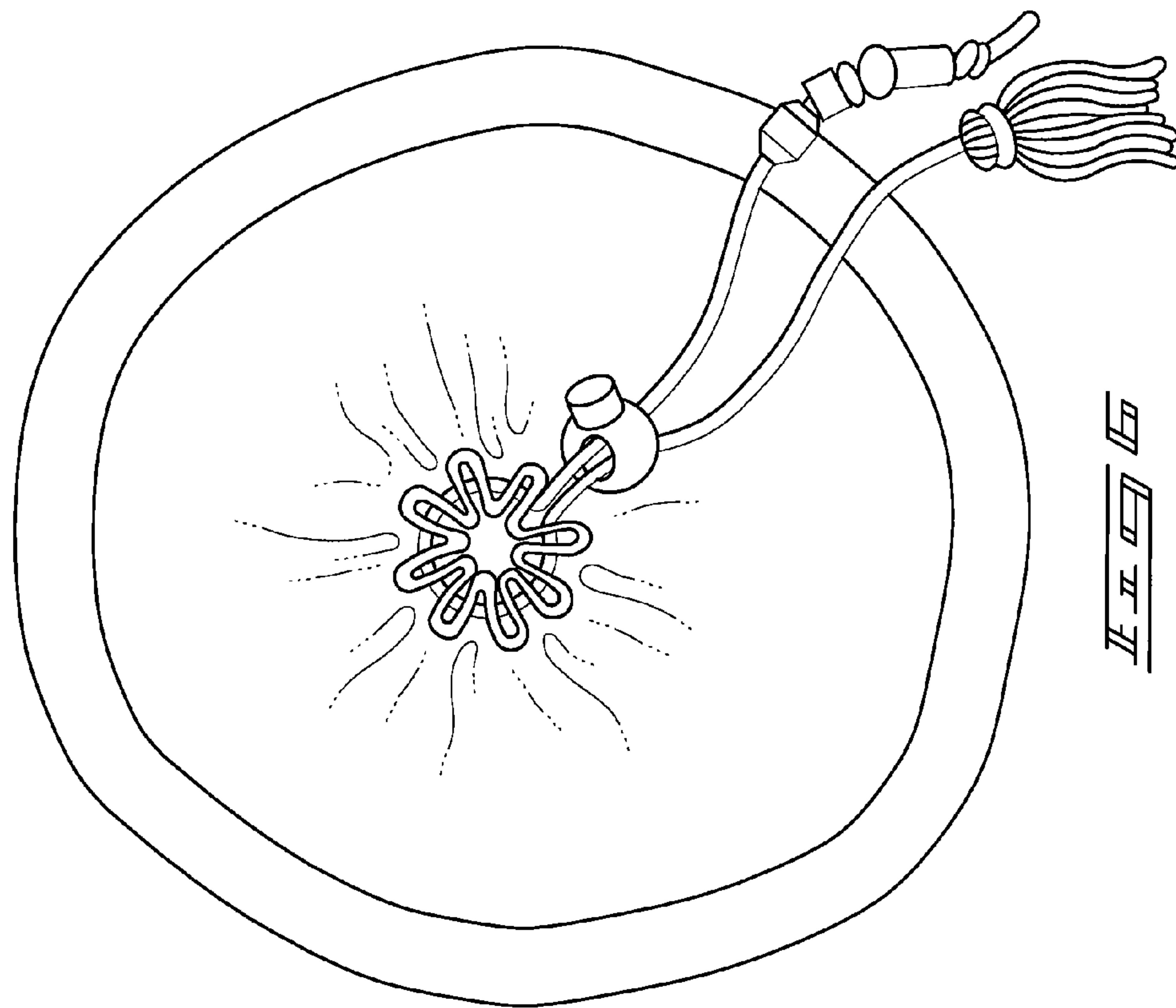

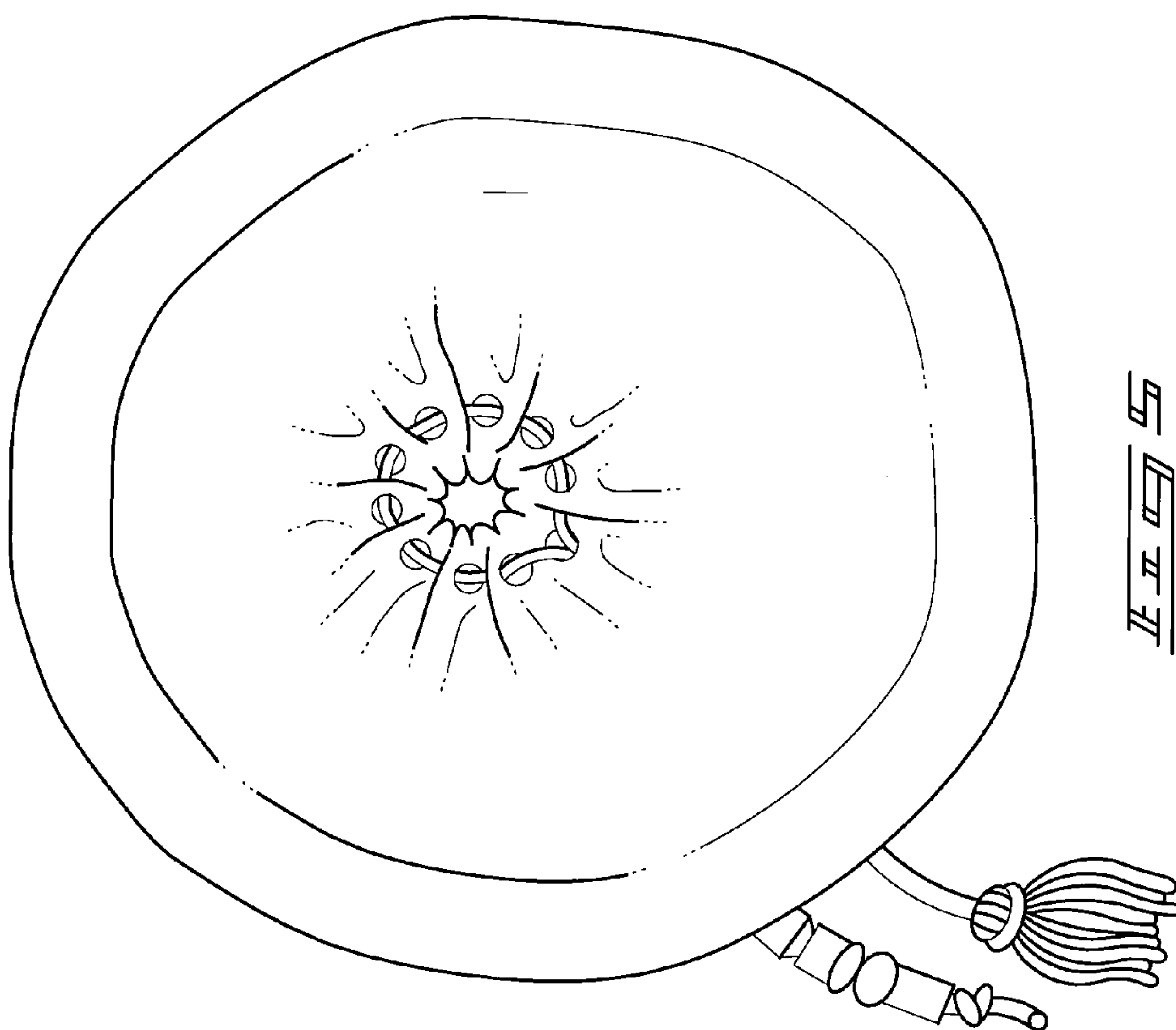
