FIG. 3 is a rear elevational view thereof;

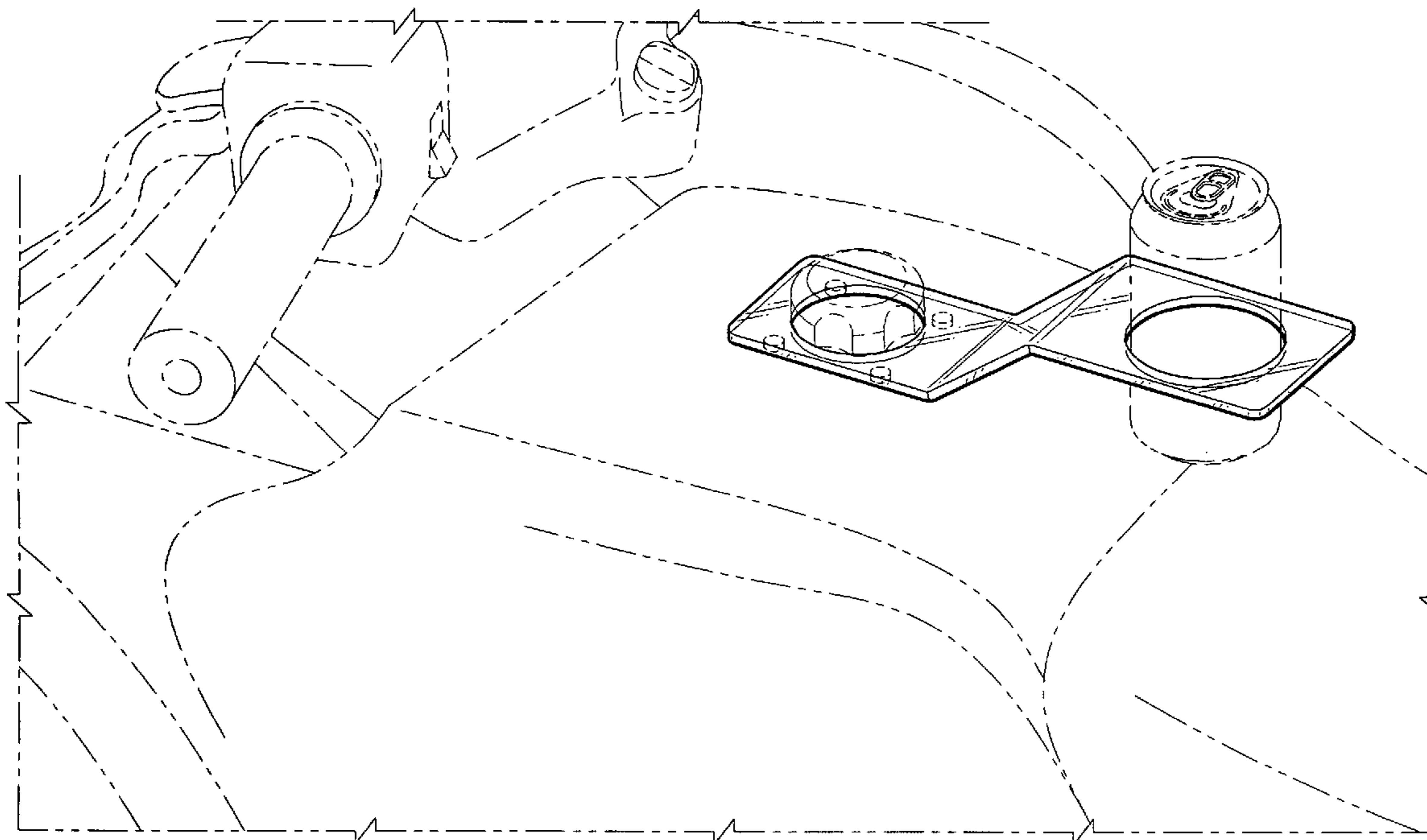
FIG. 4 is a right side elevational view with the left side being a mirror image thereof;

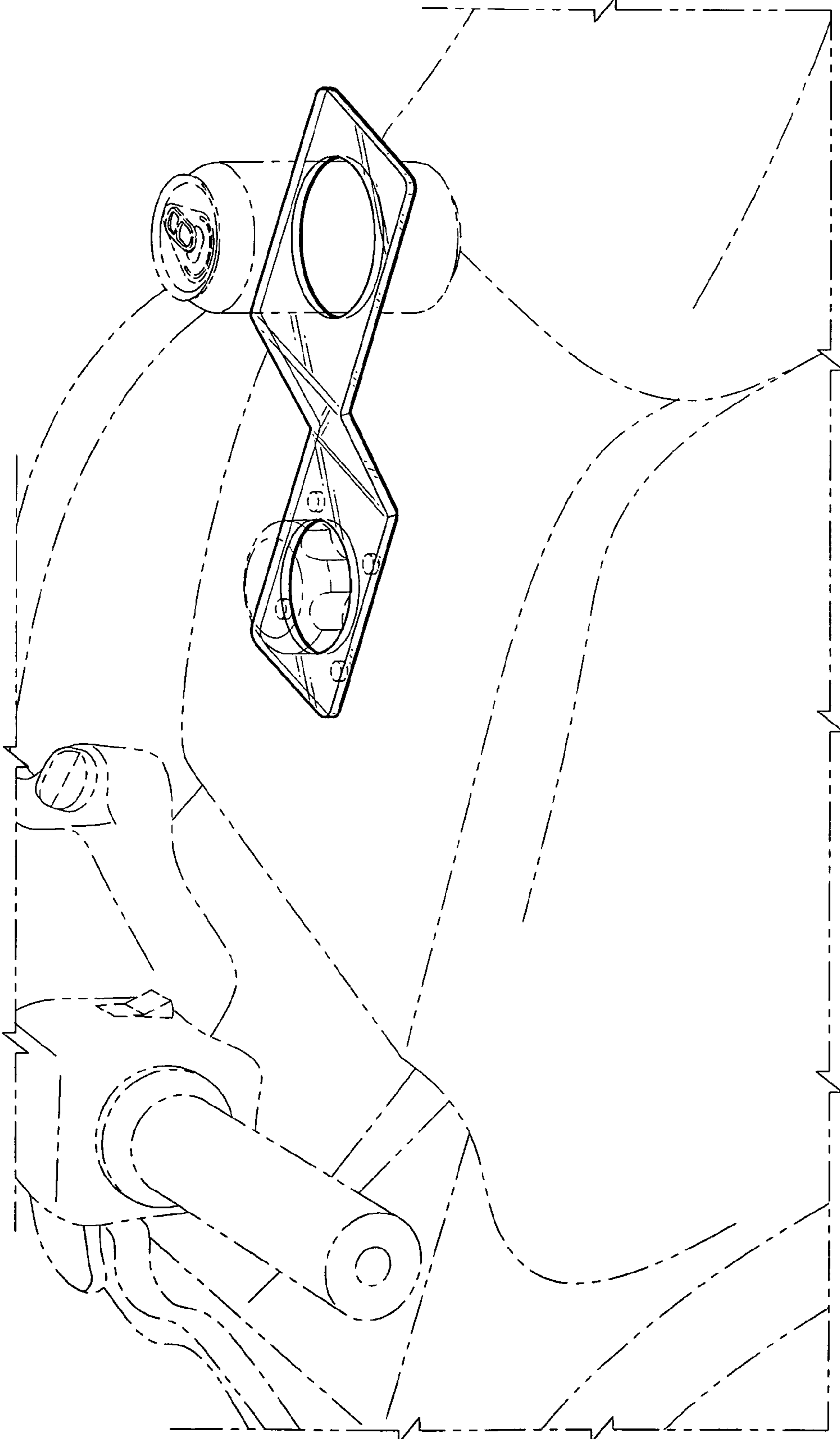
FIG. 5 is a top view thereof; and,

FIG. 6 is a bottom view thereof.

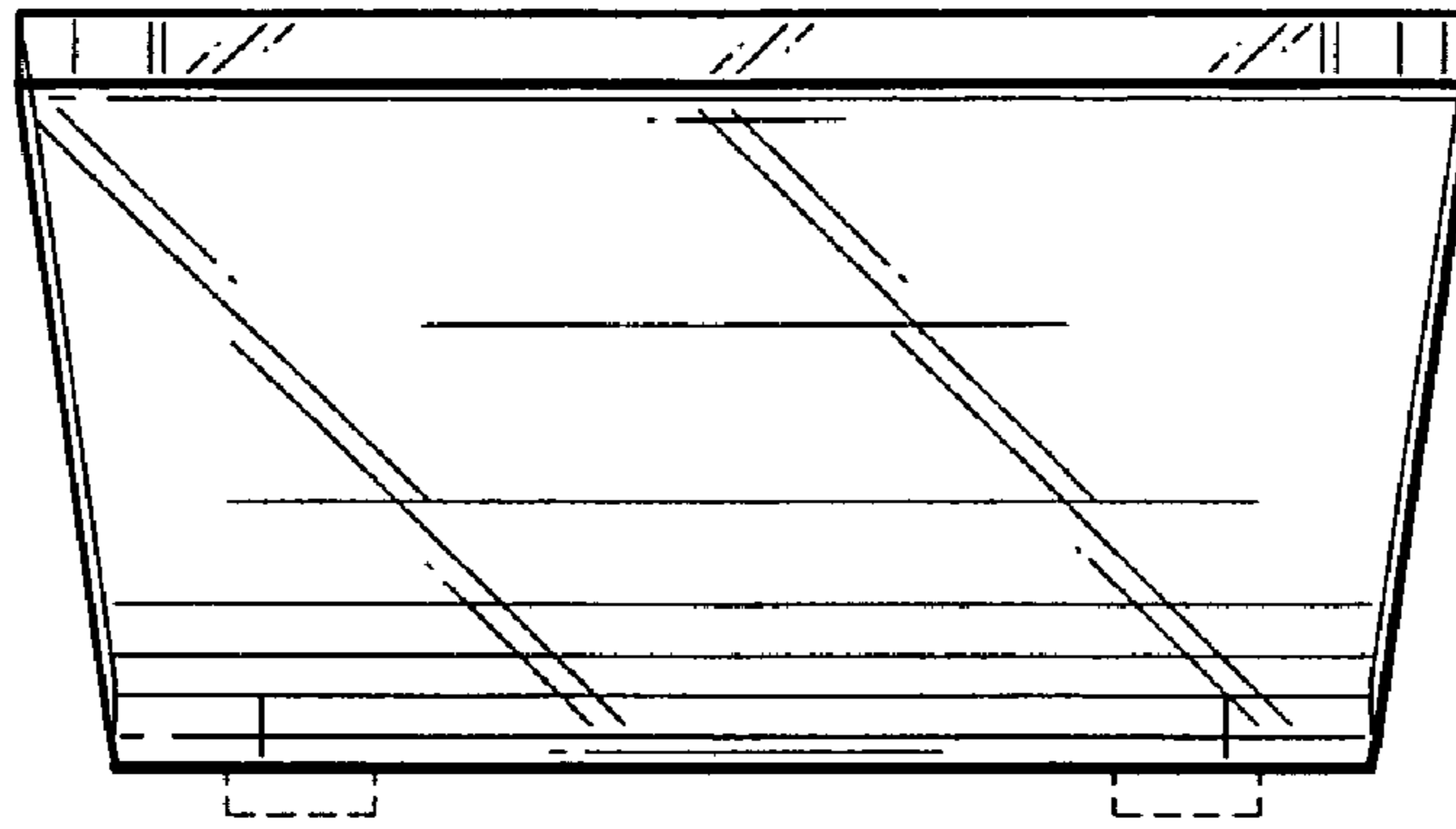

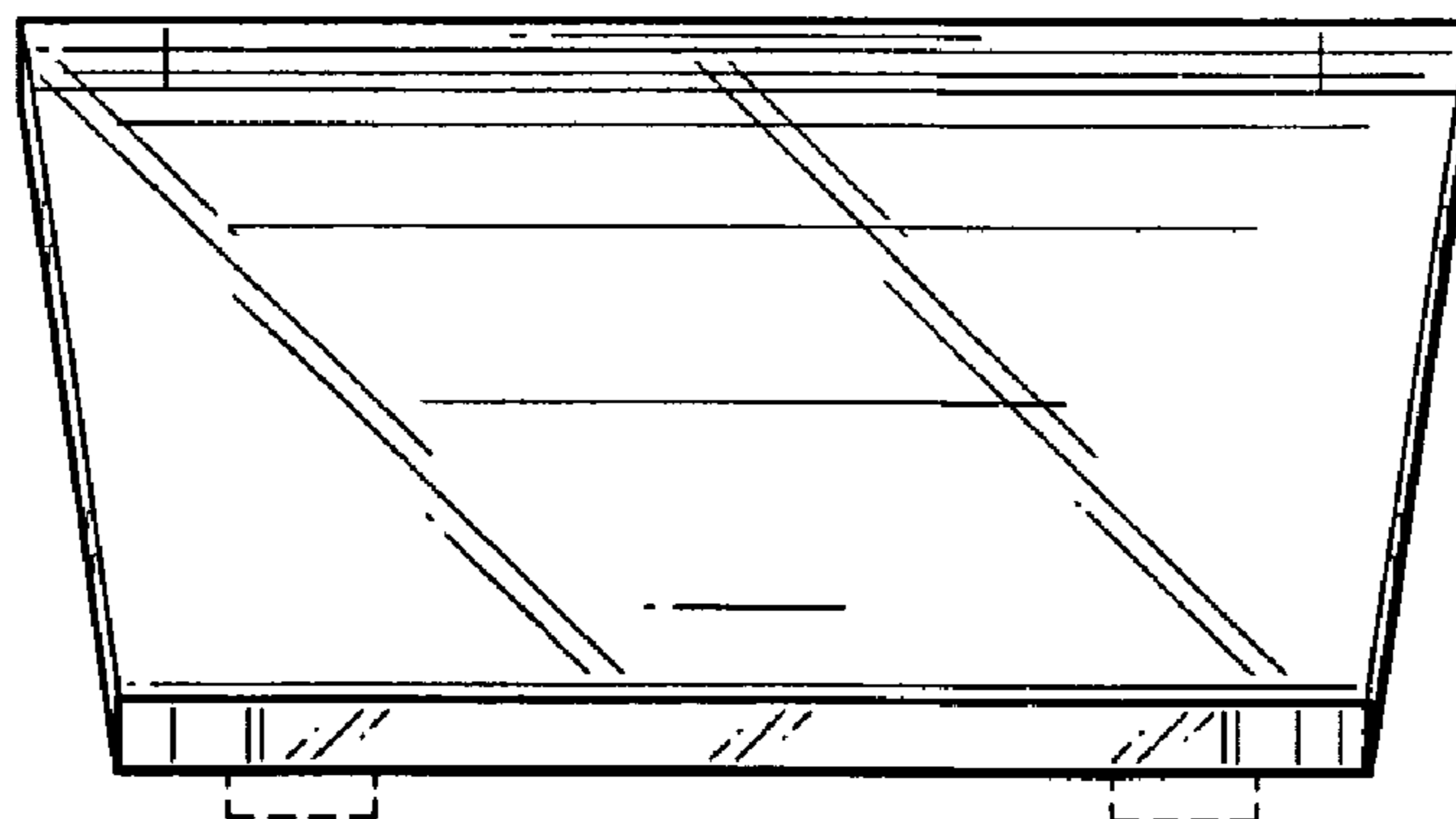




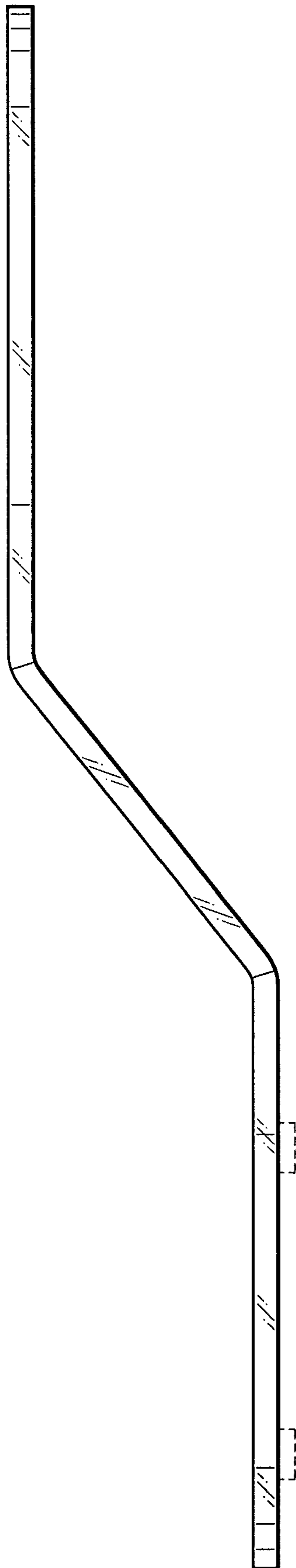

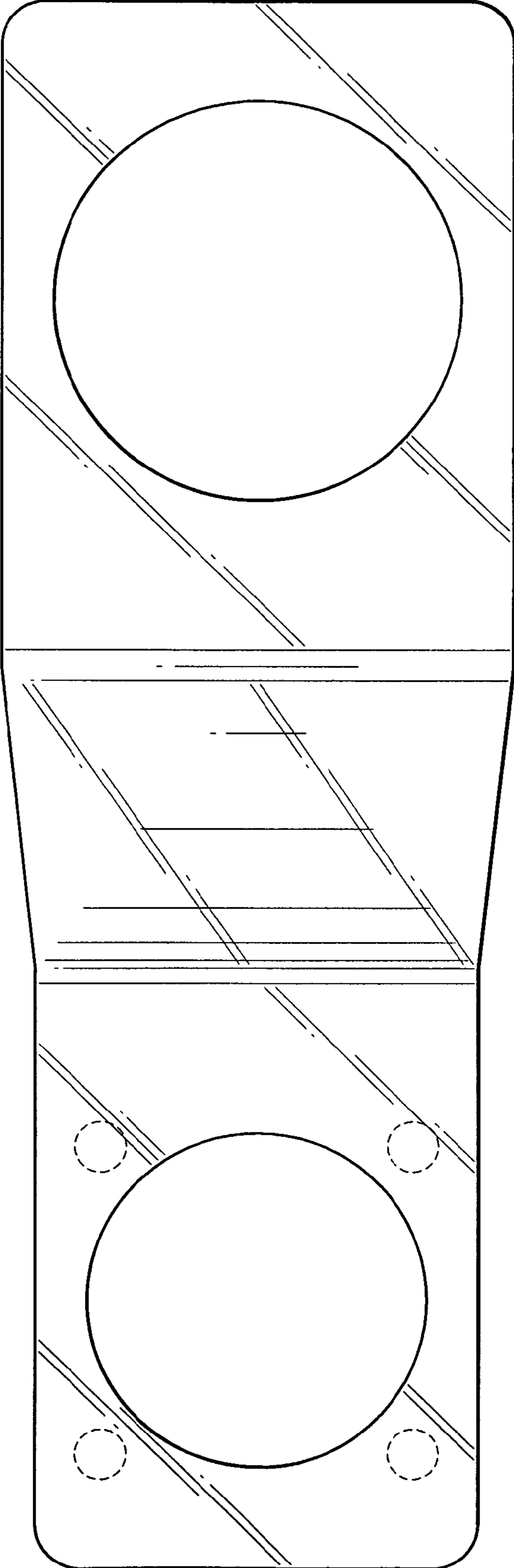

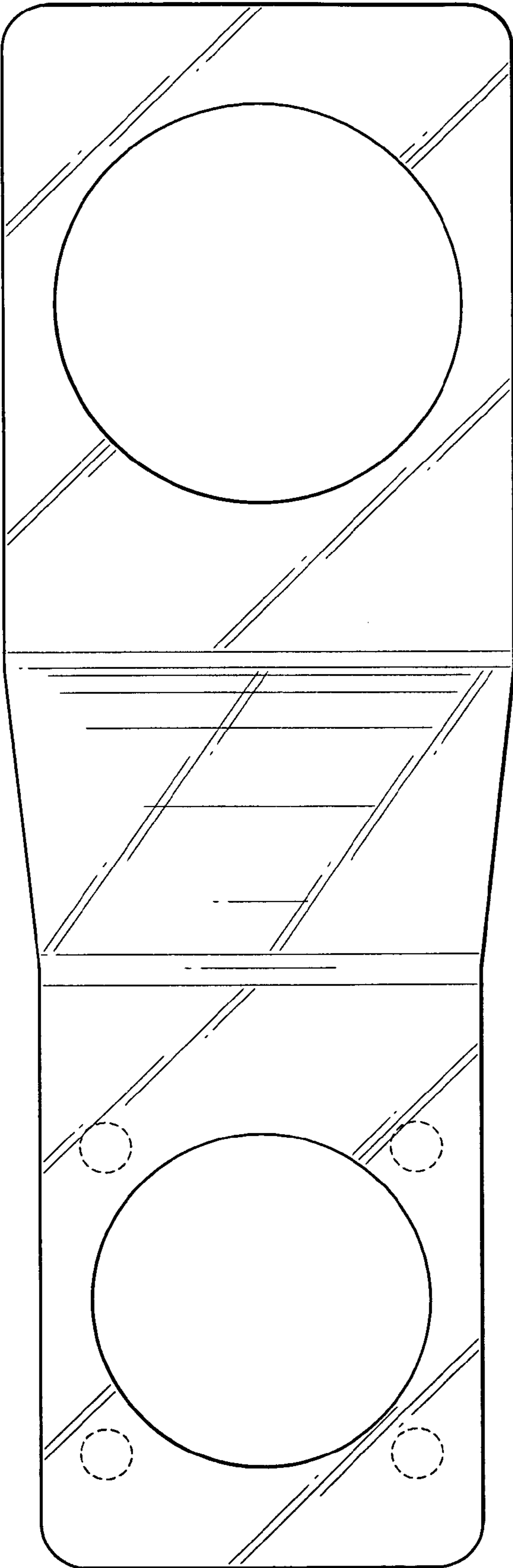
