FIG. 3 is a rear view of the design;

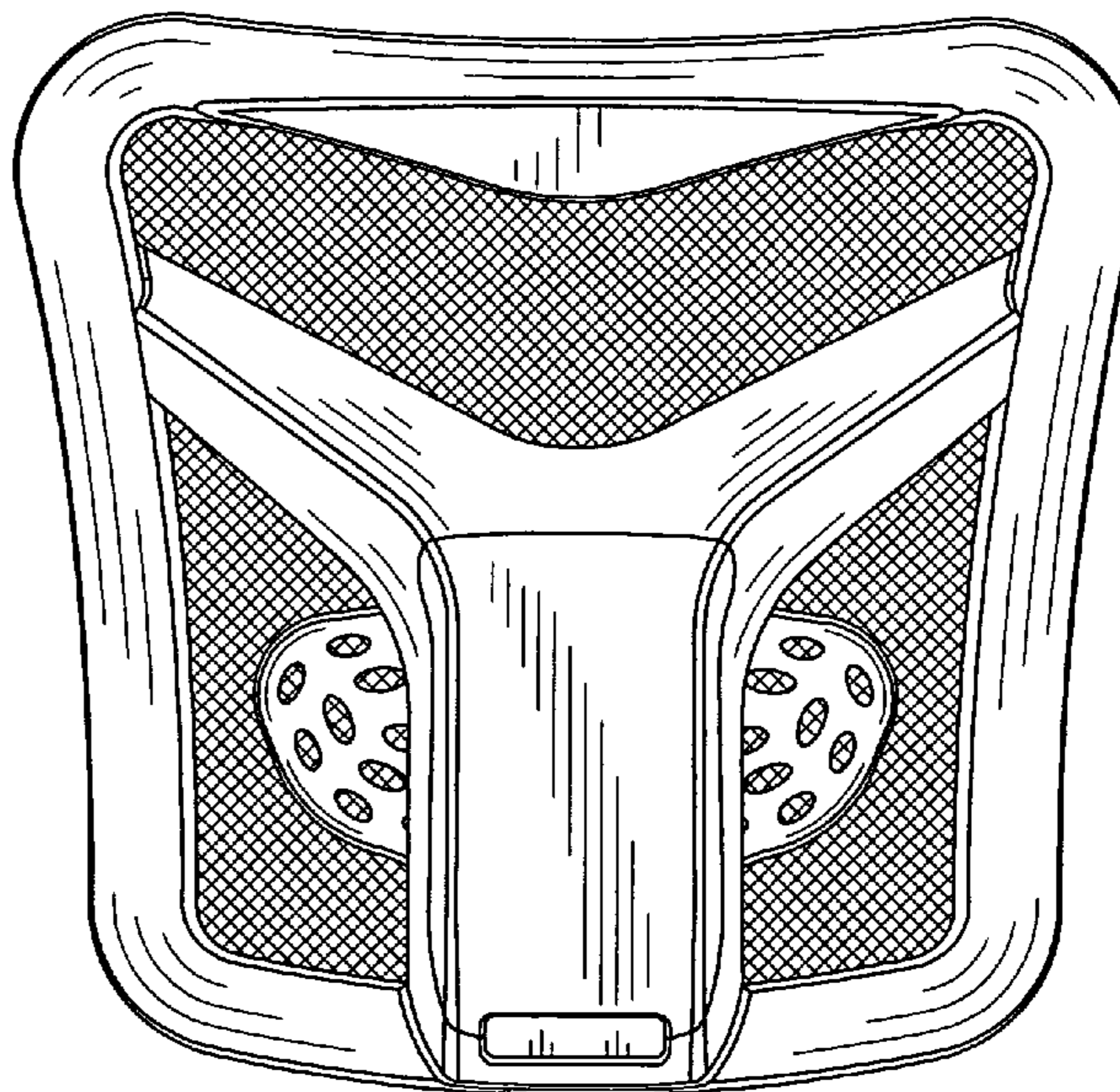
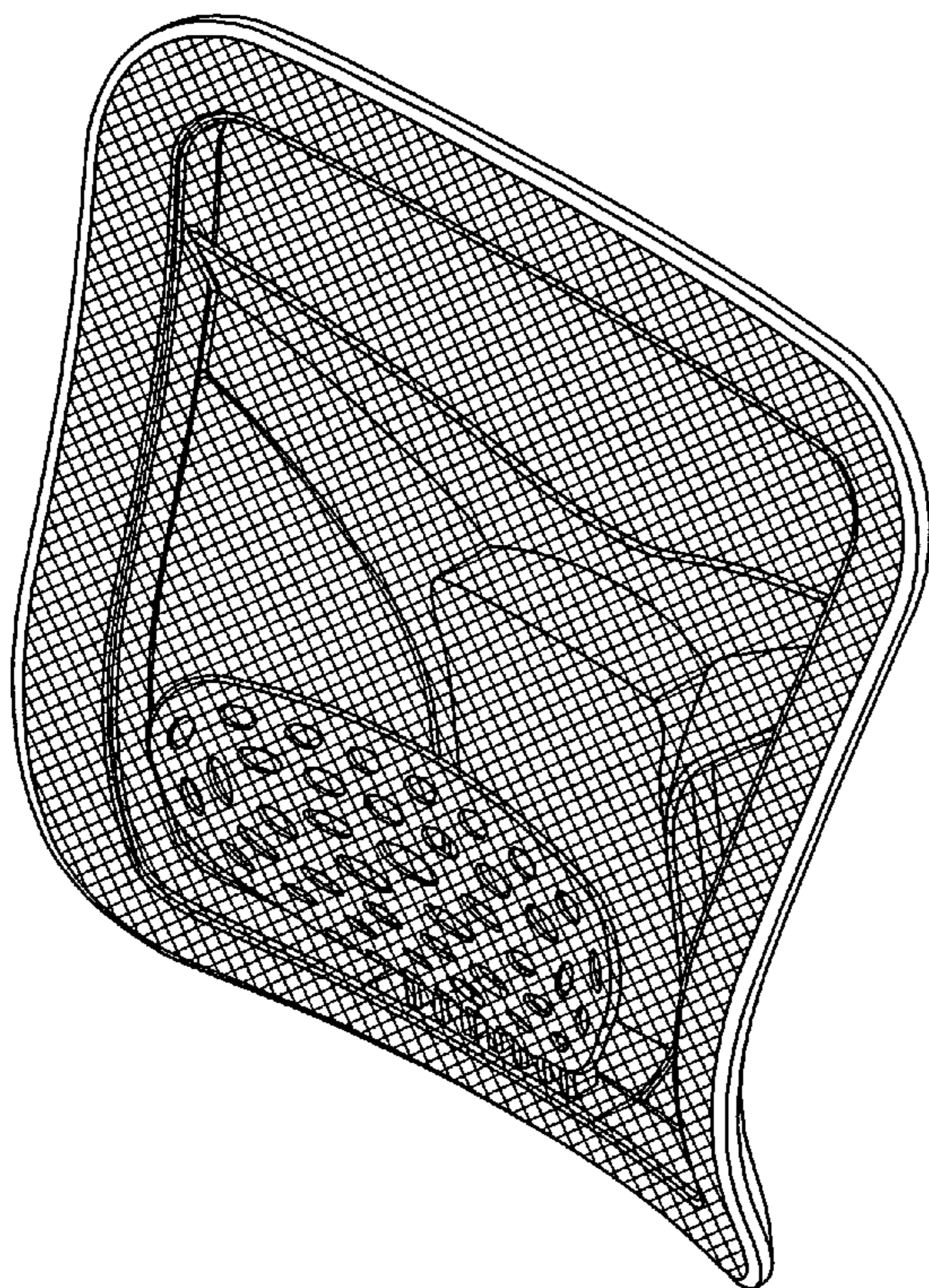
FIG. 4 is a left side view of the design;

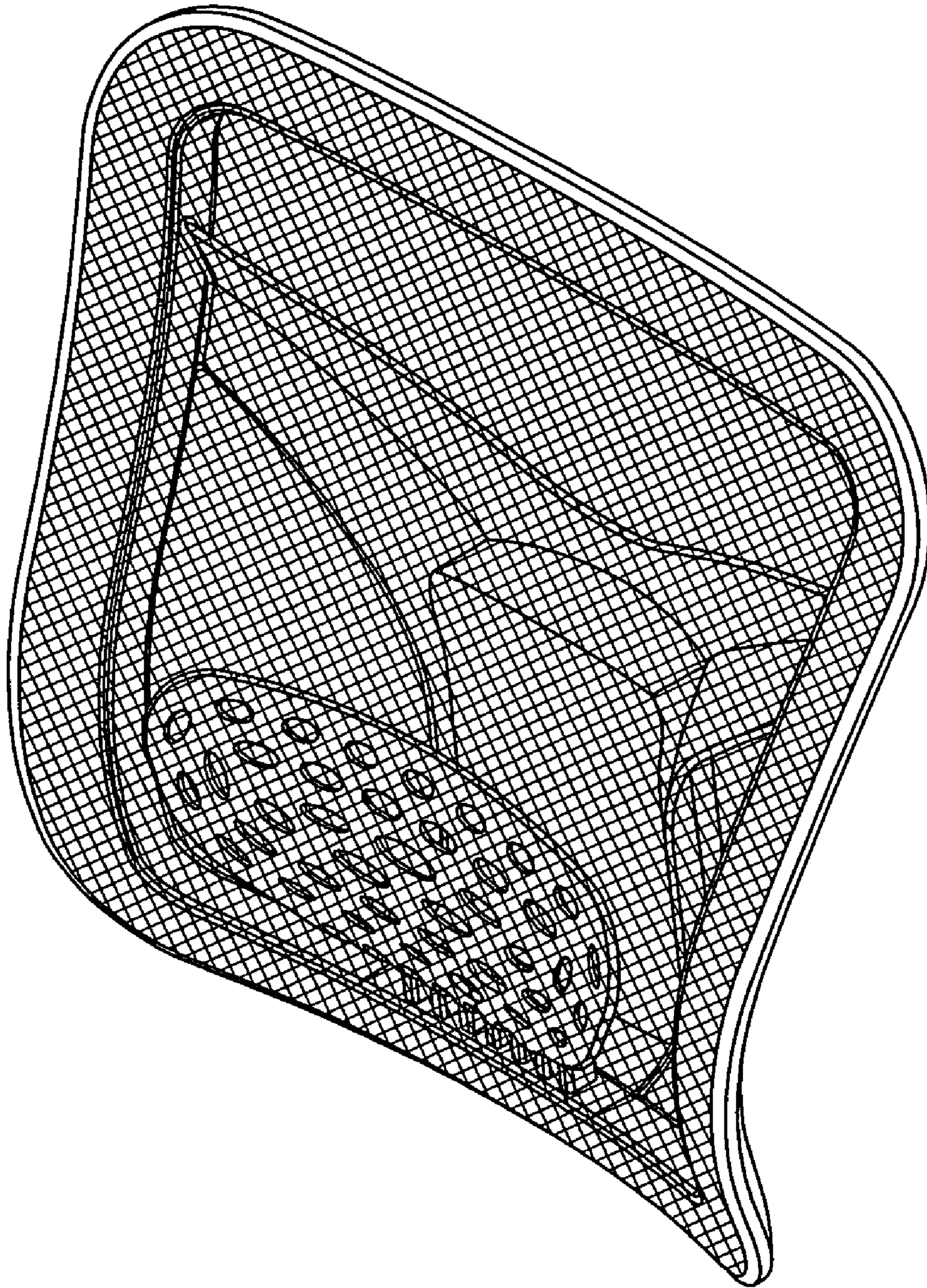

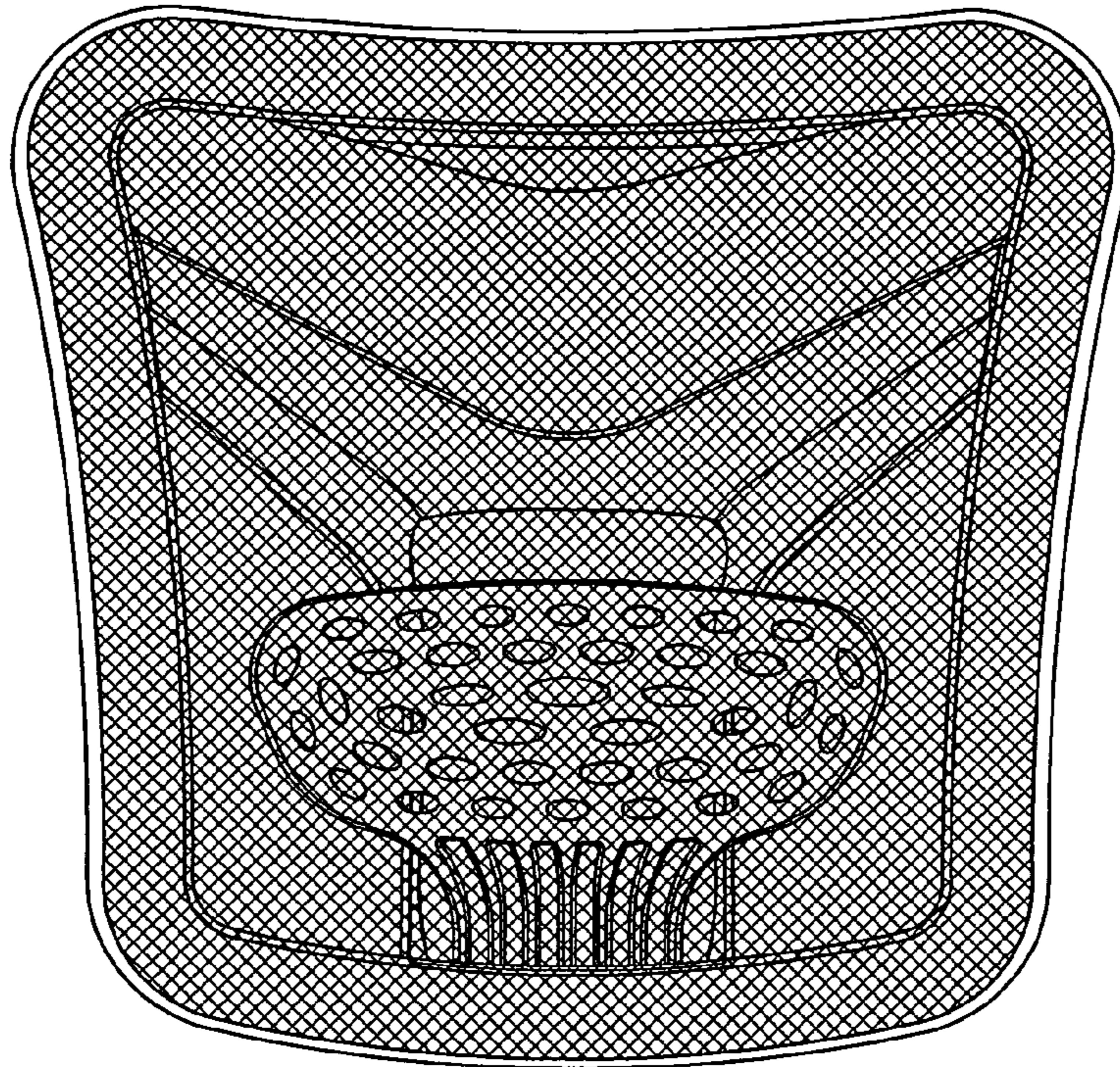

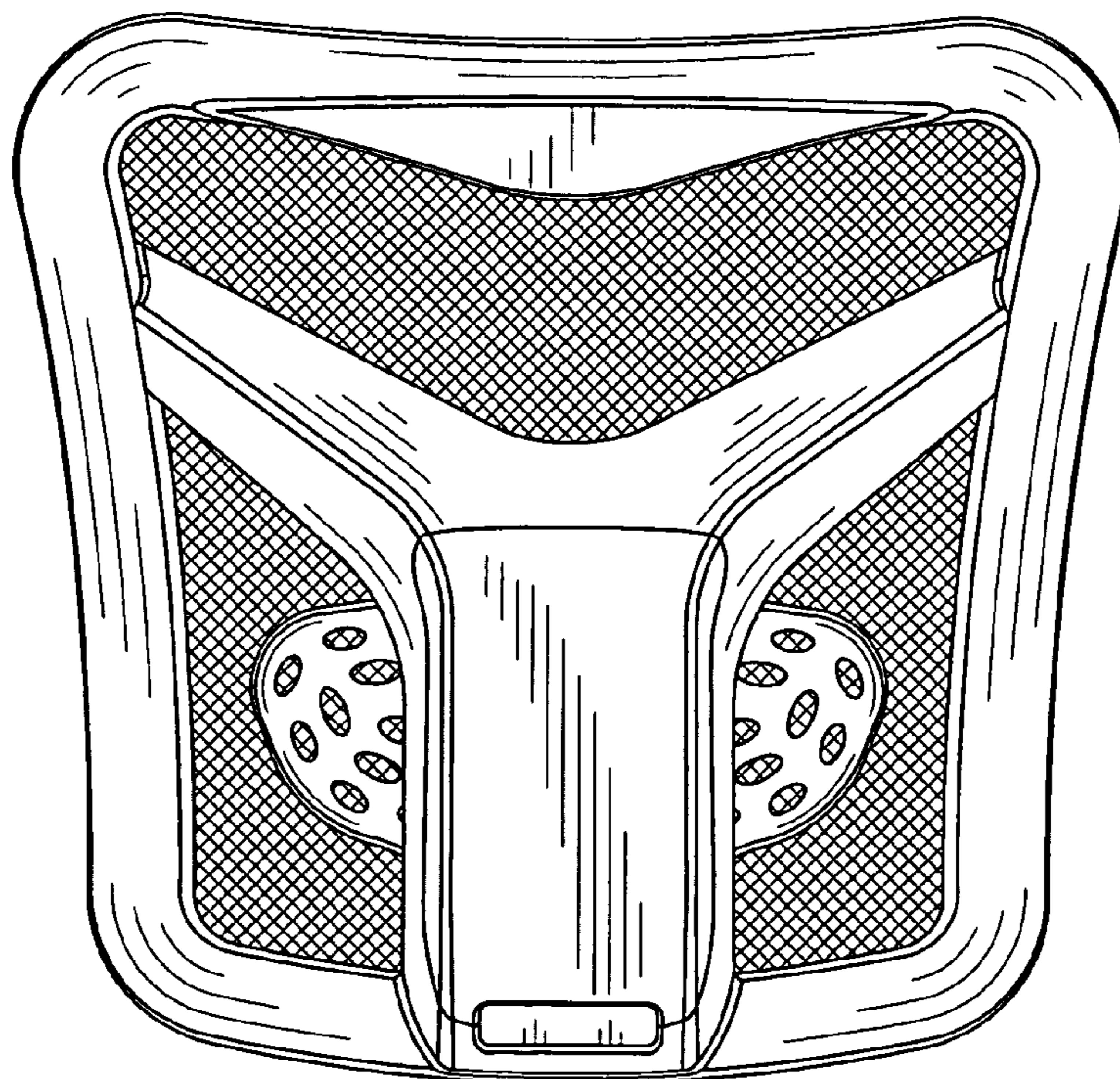

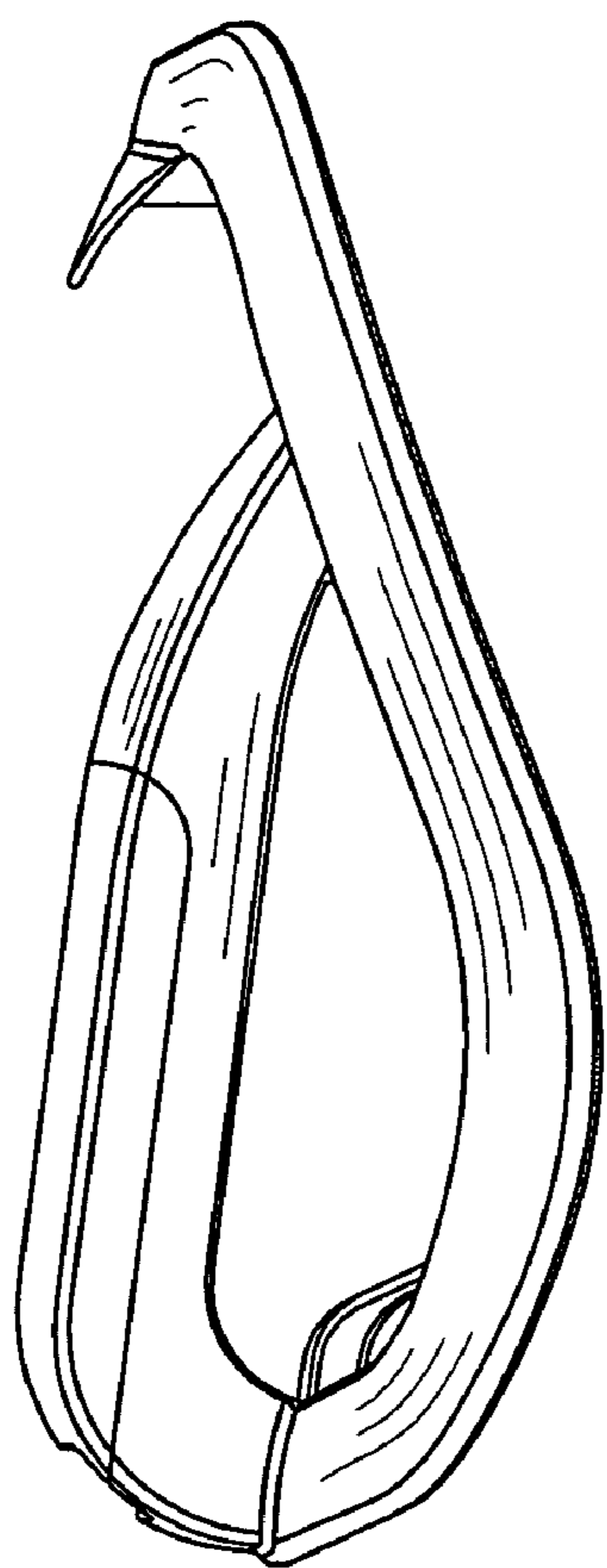

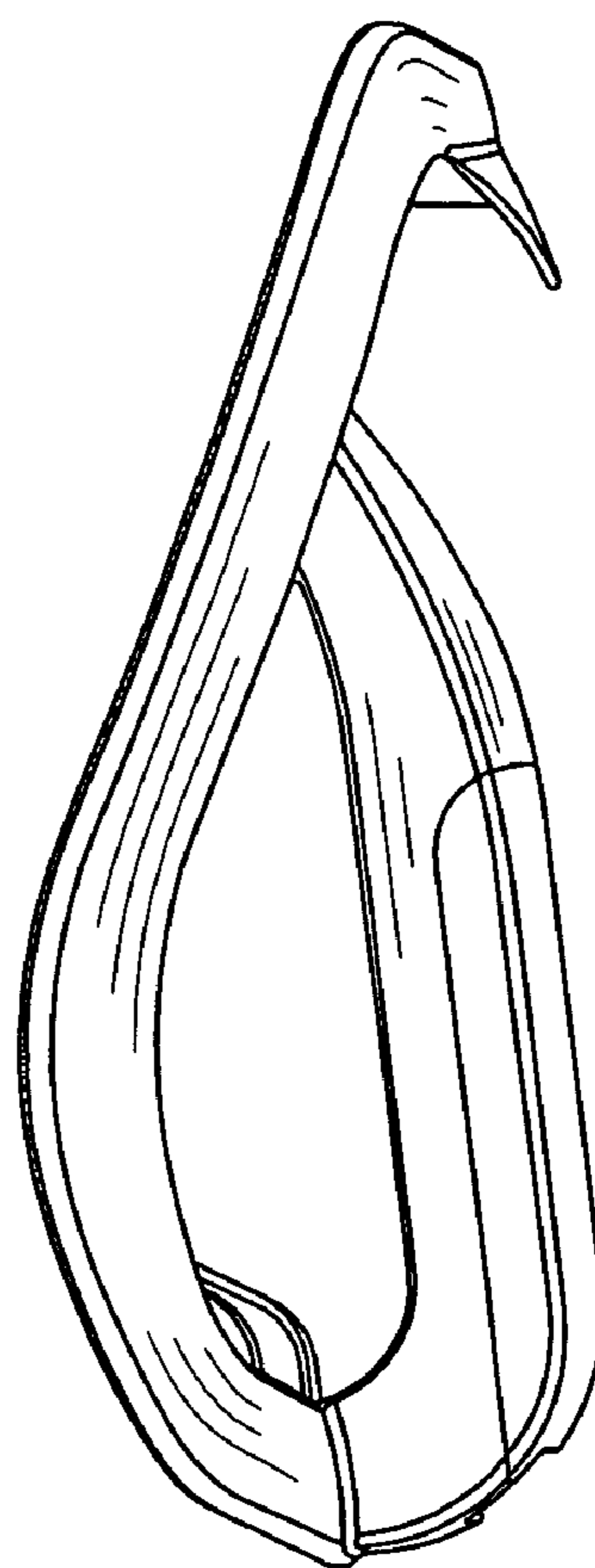

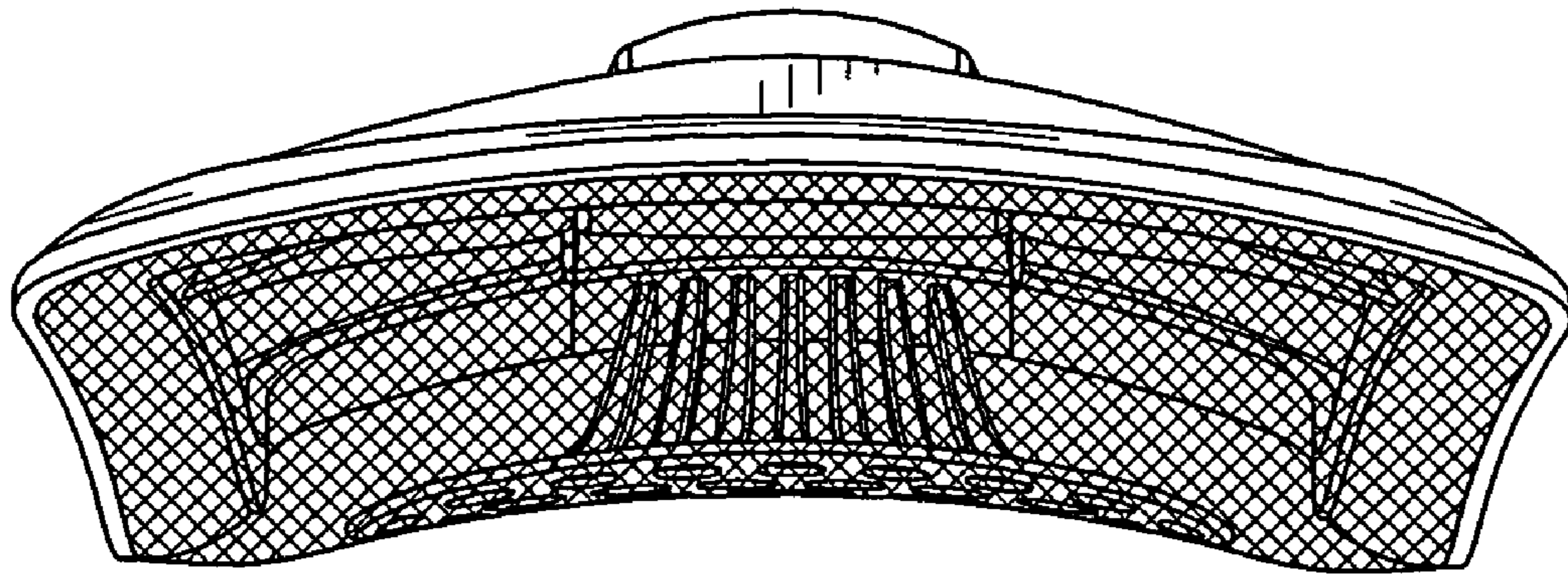

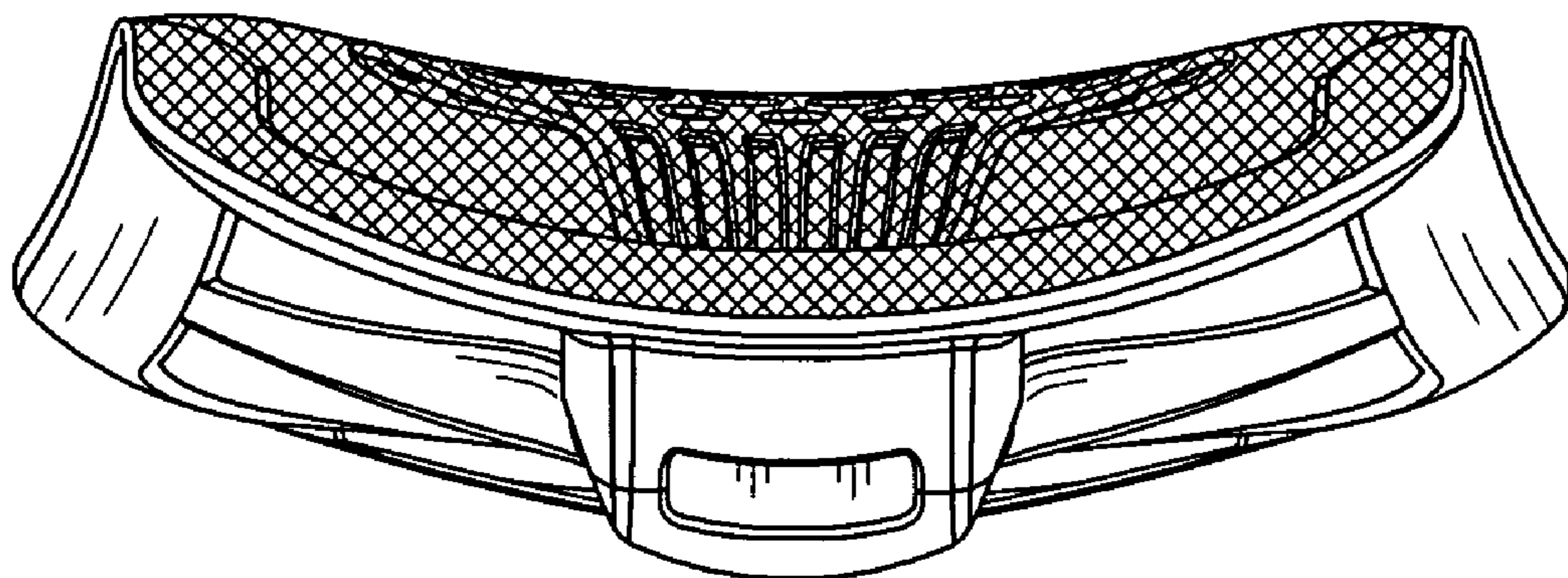
