The ornamental design for a bed covering, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a second embodiment of a bed covering.

FIG. 2 is a bottom view of the bed covering seen in FIG. 1.

FIG. 3 is a front view of the bed covering seen in FIG. 1.

FIG. 4 is a rear view of the bed covering seen in FIG. 1.

FIG. 5 is a right side view of the bed covering seen in FIG. 1; and,

FIG. 6 is a left side view of the bed covering seen in FIG. 1.

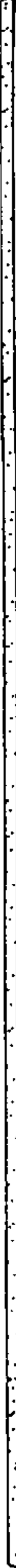
