(57) **CLAIM**

The ornamental design for a reversible beverage cup, as shown and described.

DESCRIPTION

FIG. 1 is a top elevational view of a reversible beverage cup, showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a side elevational view thereof. All side elevational views of the reversible beverage cup being the same;

FIG. 4 is a sectional view thereof, taken along line 4—4 in FIG. 1;

FIG. 5 is a perspective view thereof, as viewed from one end; and,

FIG. 6 is a perspective view thereof, as viewed from an opposite end.

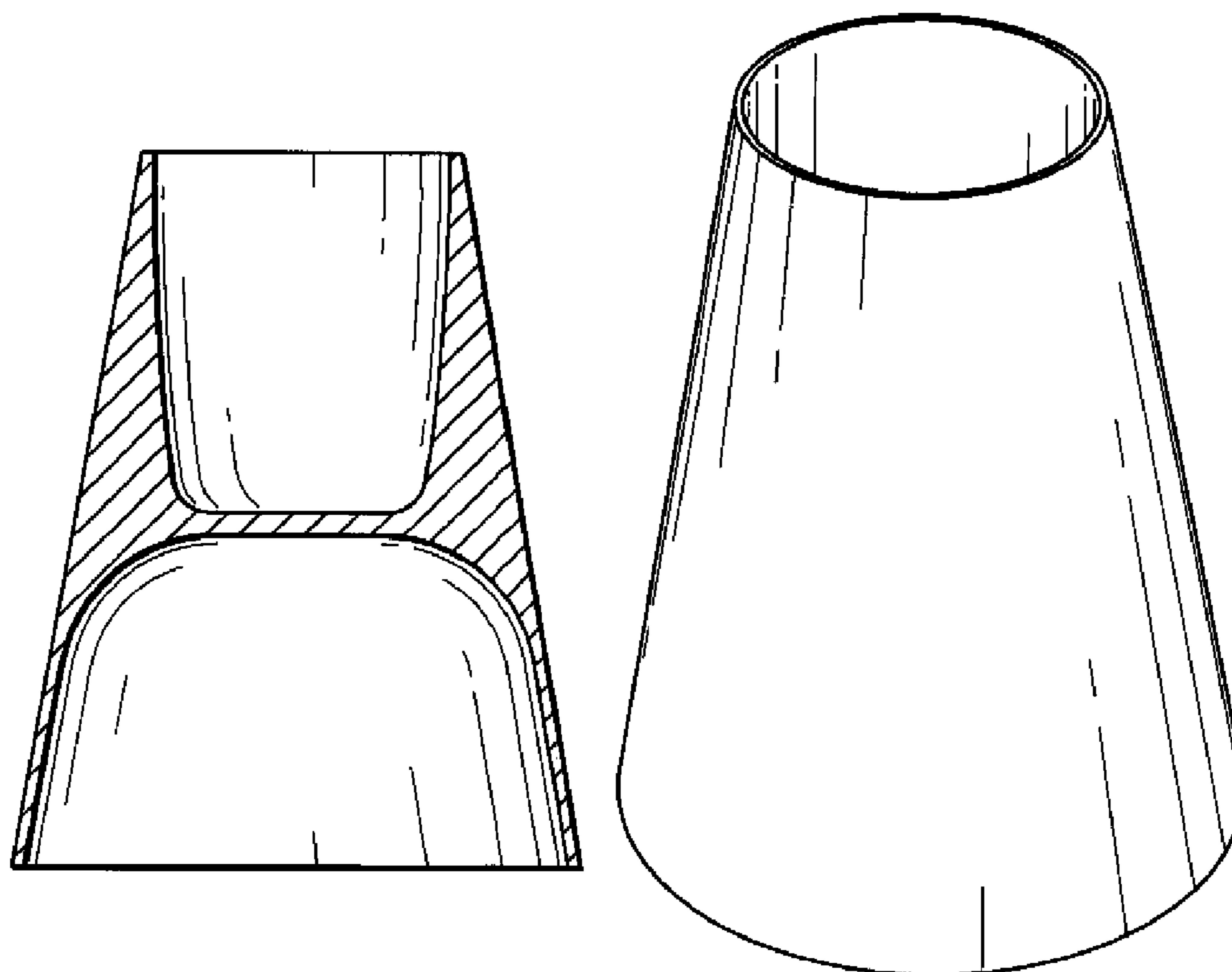

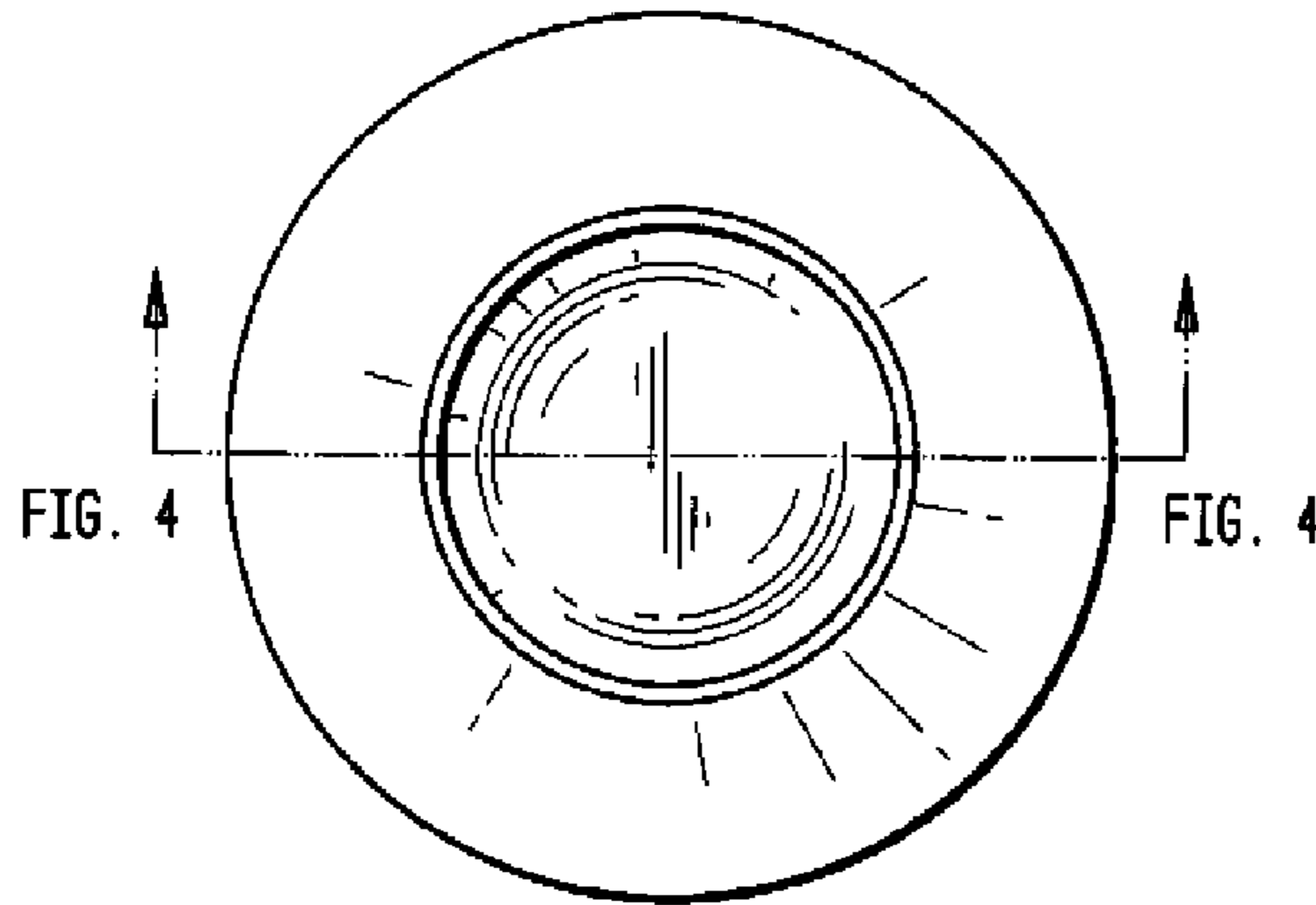

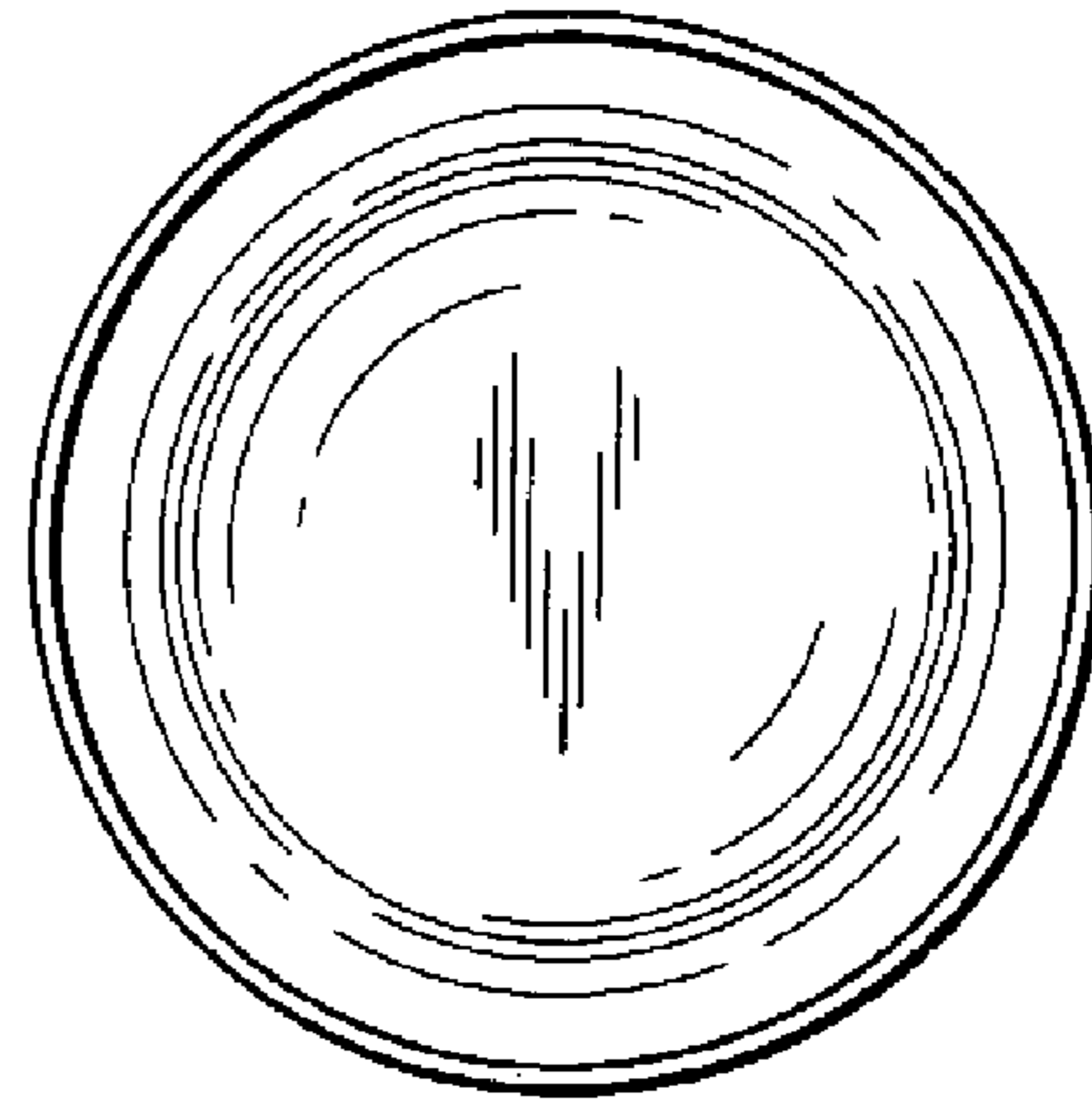

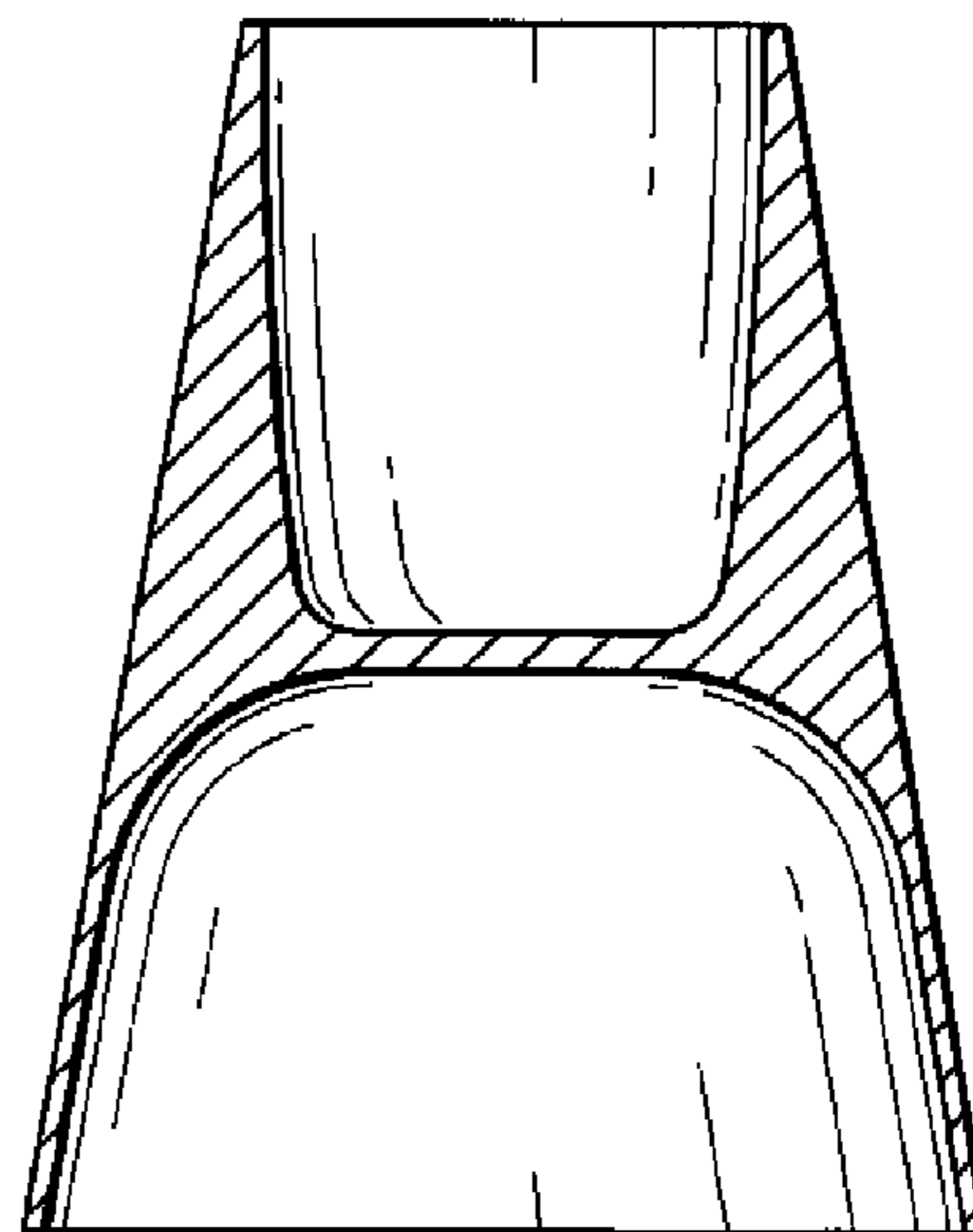

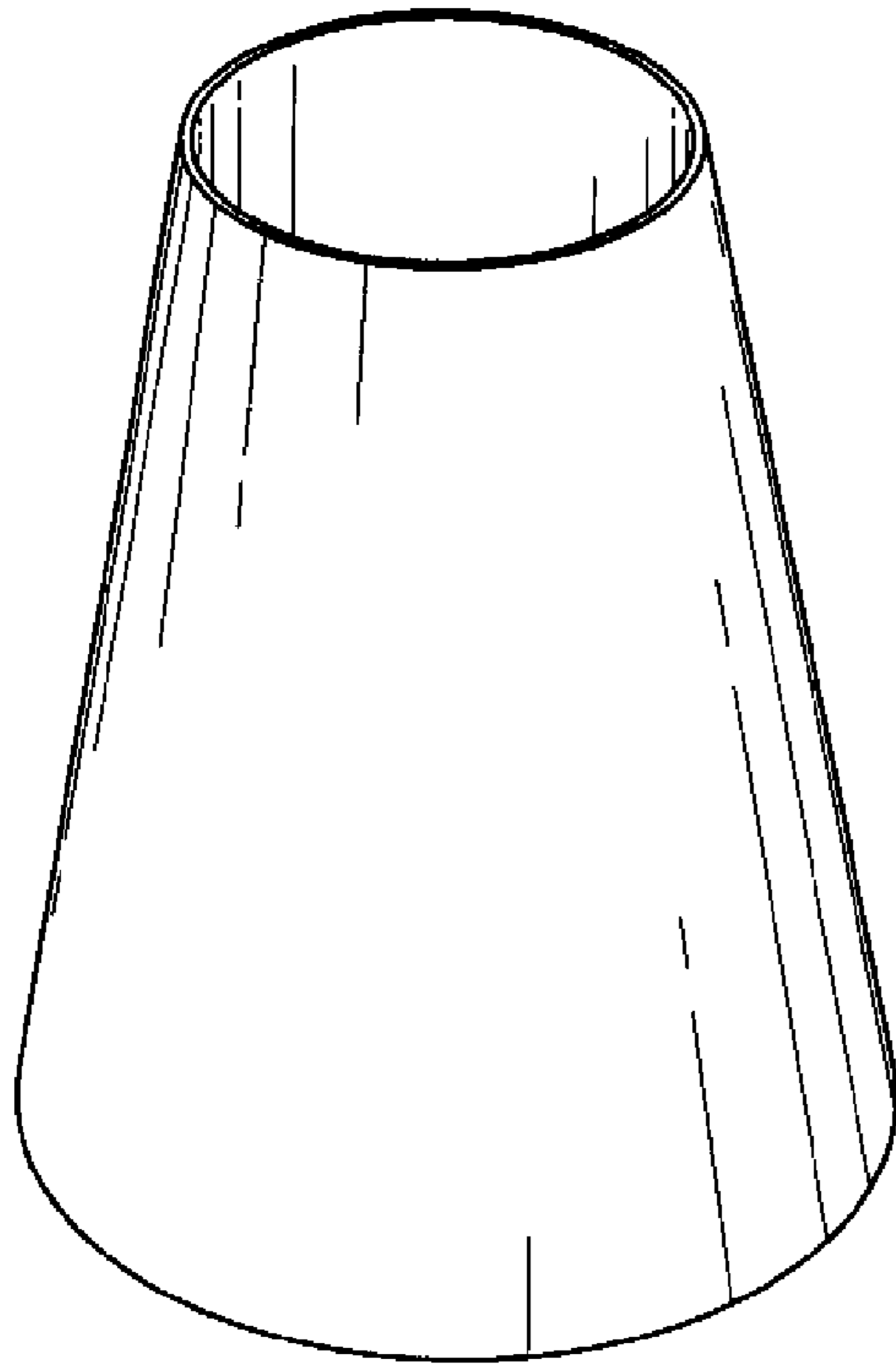
