(57) **CLAIM**

The ornamental design for a timepiece dial, as shown and described.

DESCRIPTION

The sole FIGURE is a top plan view of a timepiece dial, showing my new design.

The appearance of the side opposite that shown in the figure, and of the edges, is not claimed.

The claimed portion of the timepiece dial is flat and solid.
