(57) **CLAIM**

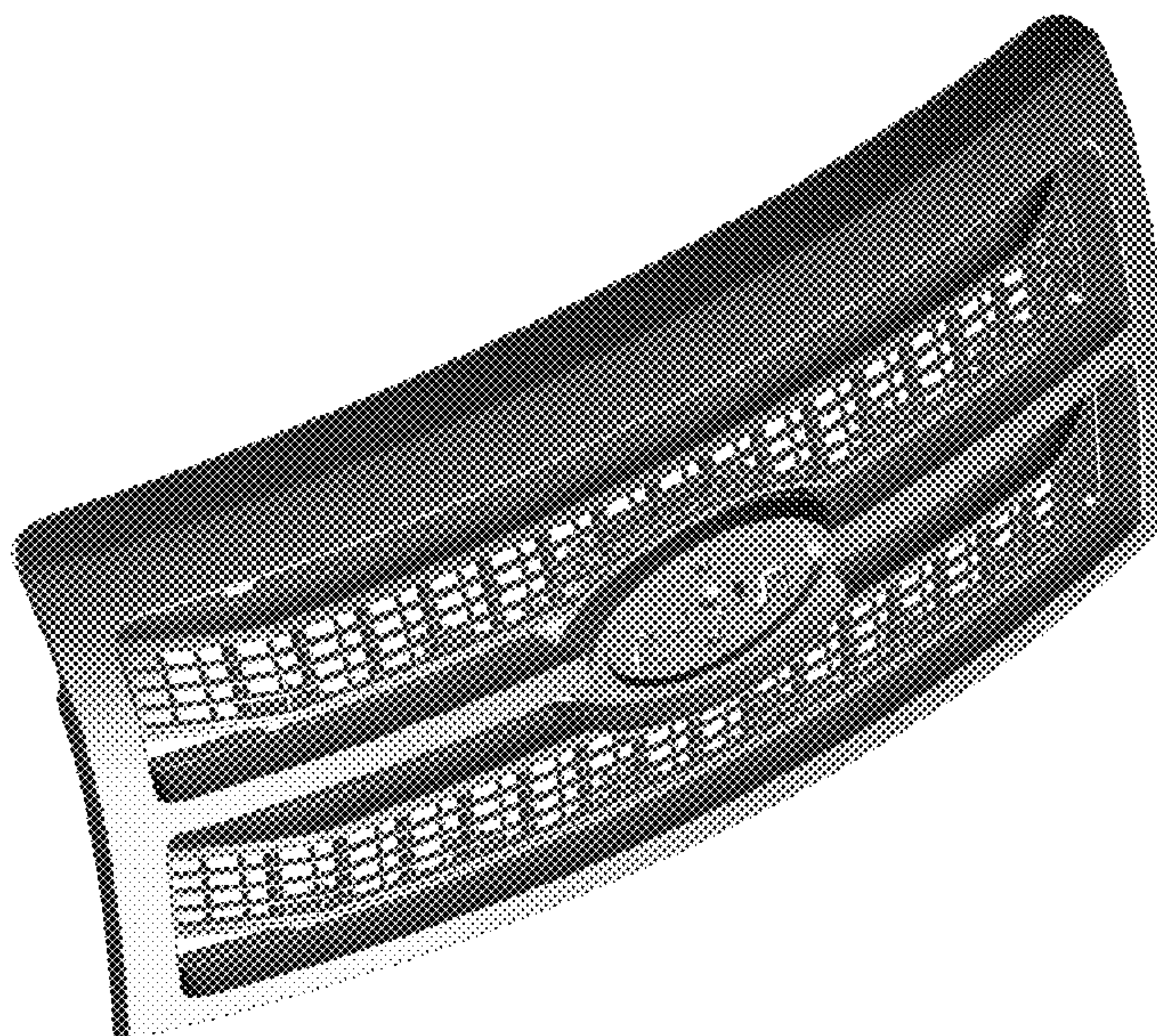
The ornamental design for a vehicle grille, as shown and described.

DESCRIPTION

To the extent that any feature lines are illustrated, they are intended to illustrate the crest and valley of the feature and are not necessarily sharp bends in the part. Shading is used to illustrate the curvature of the part and not color. Views are orthogonal projections unless otherwise noted. The various views are not necessarily to scale in order to better illustrate the design.

FIG. 1 is a right, front perspective view of the vehicle grille;
FIG. 2 is a left, front perspective view of the vehicle grille;
FIG. 3 is a front elevational view of the vehicle grille;
FIG. 4 is a left side elevational view of the vehicle grille;
FIG. 5 is a right side elevational view of the vehicle grille;
FIG. 6 is a top plan view of the vehicle grille;
FIG. 7 is bottom plan view of the vehicle grille; and,
FIG. 8 is a rear elevational view of the vehicle grille.

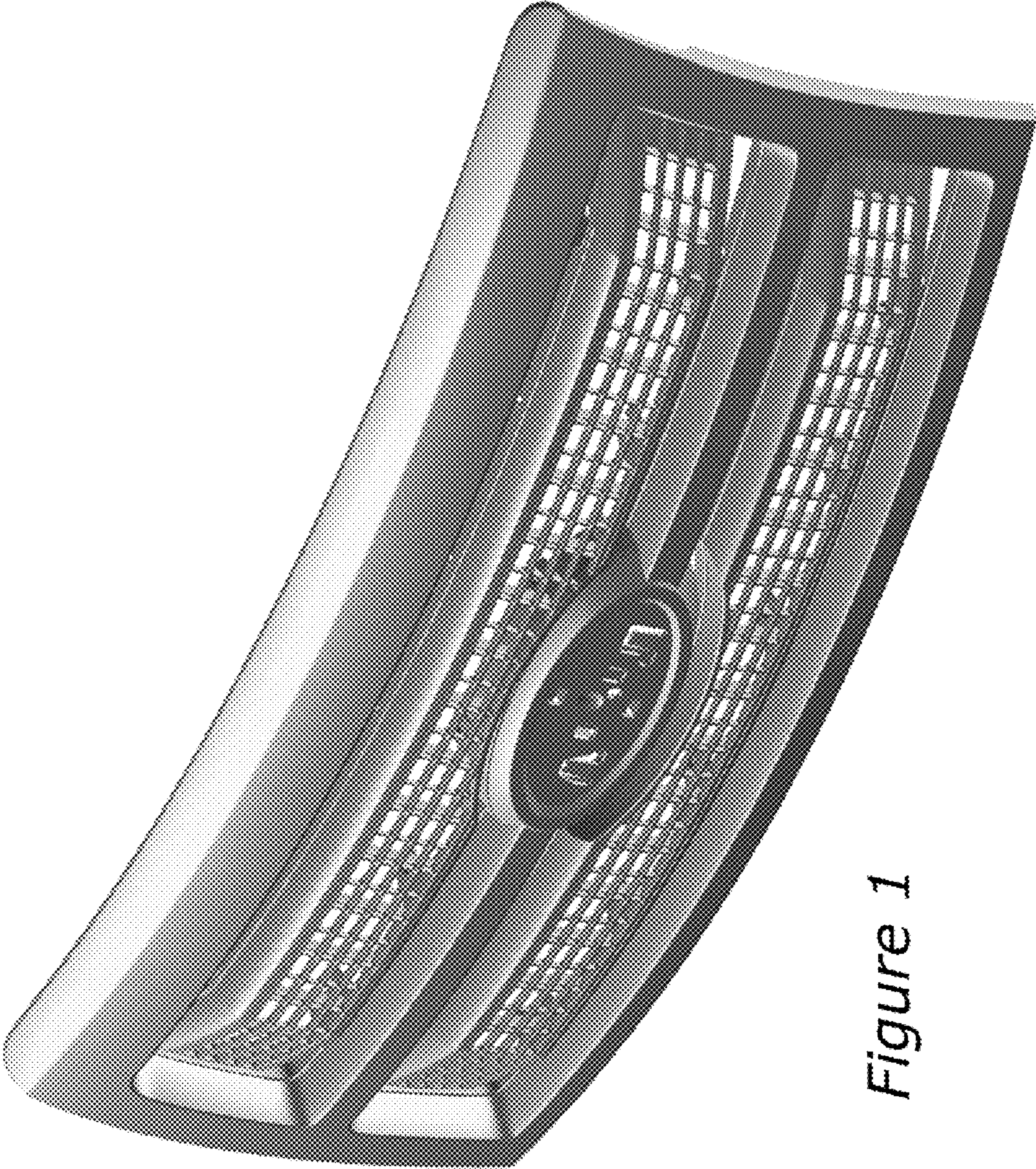

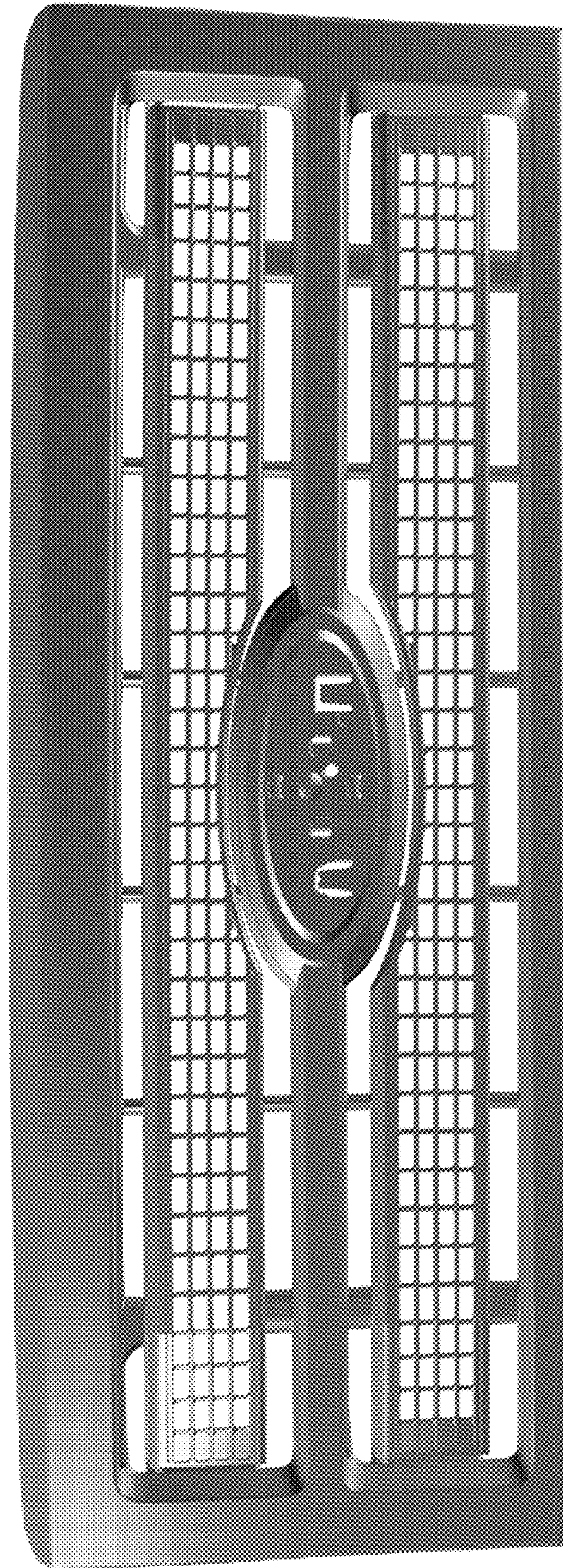

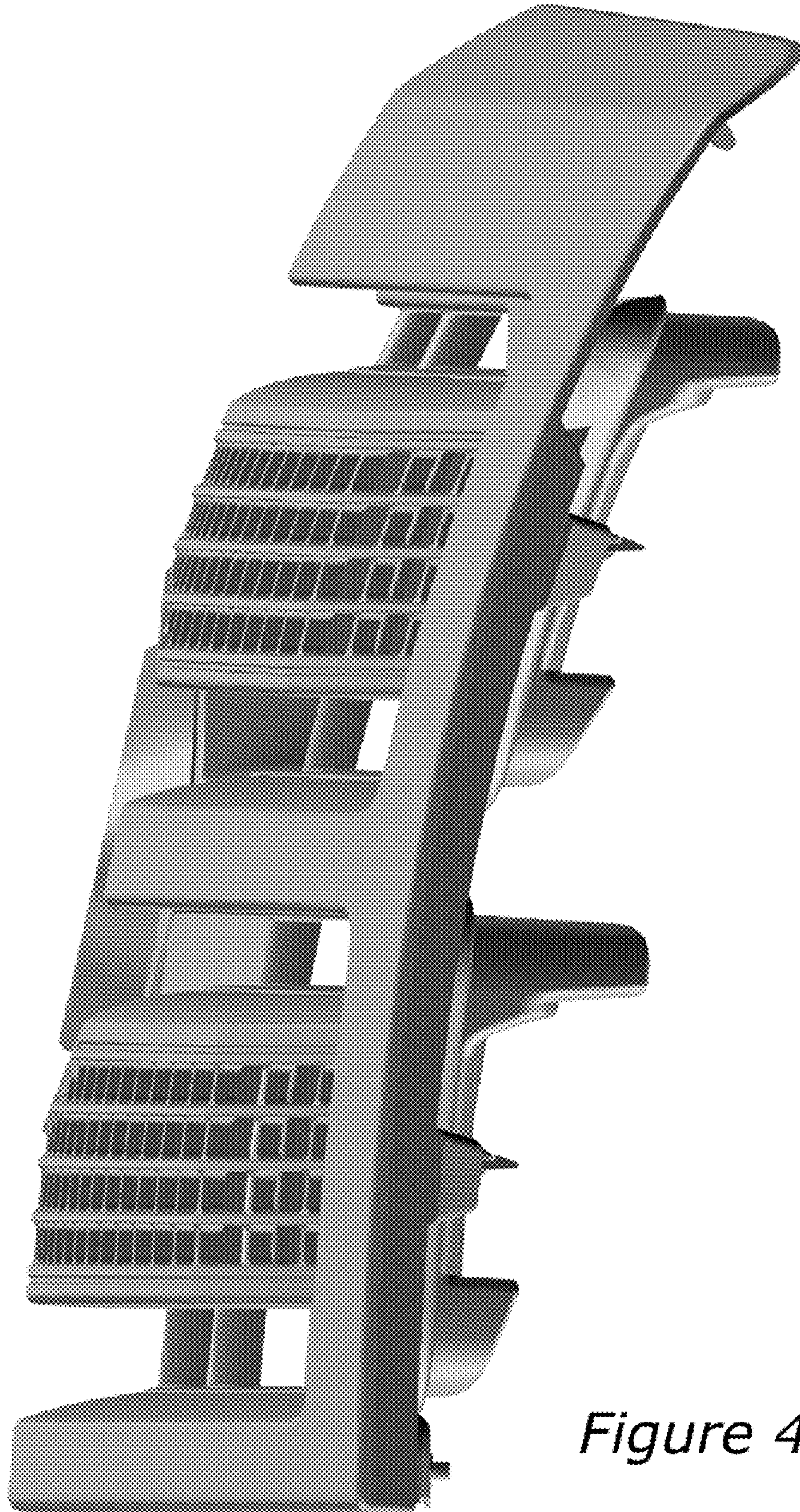

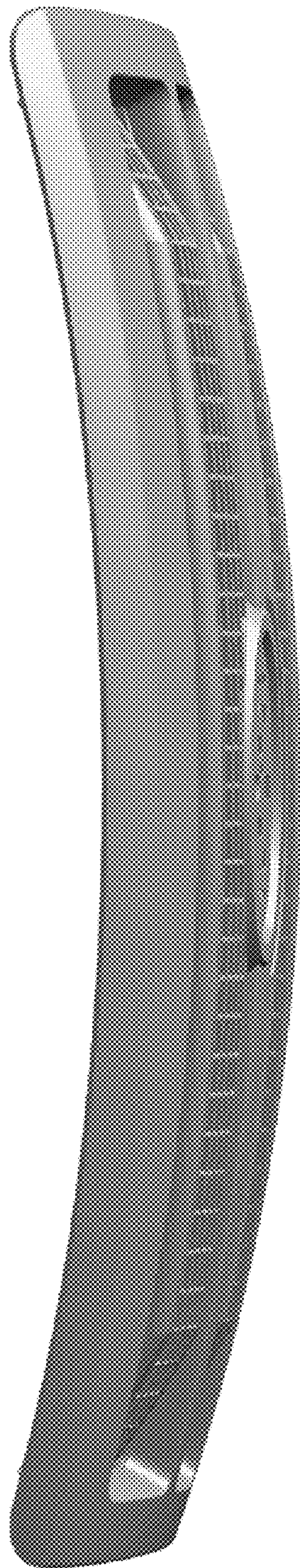

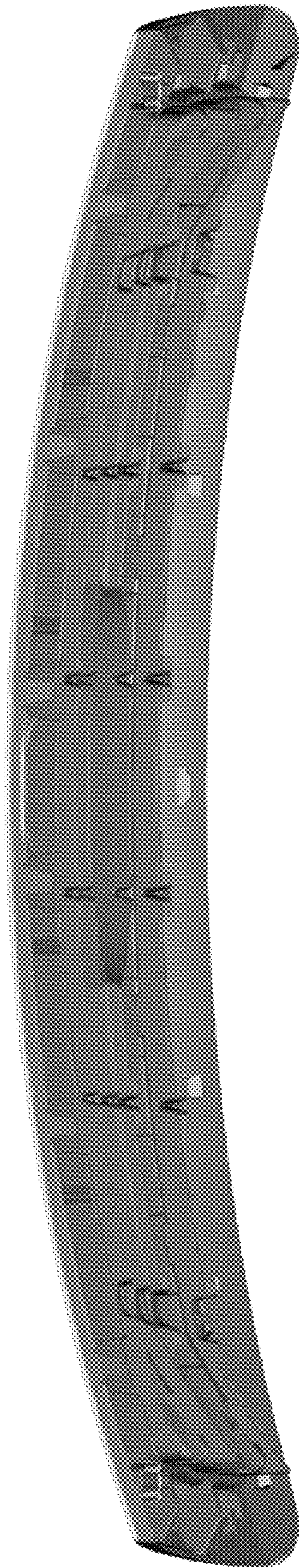

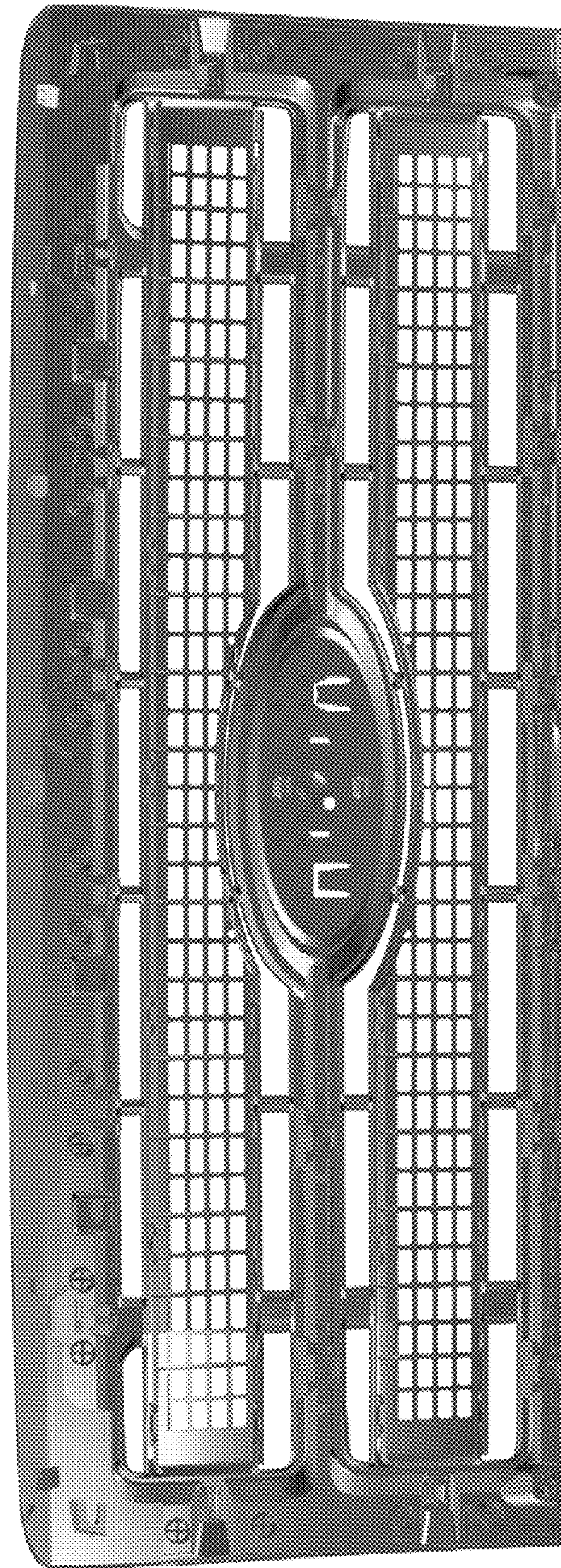
