We claim the ornamental design for cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of cellular phone showing the new design:

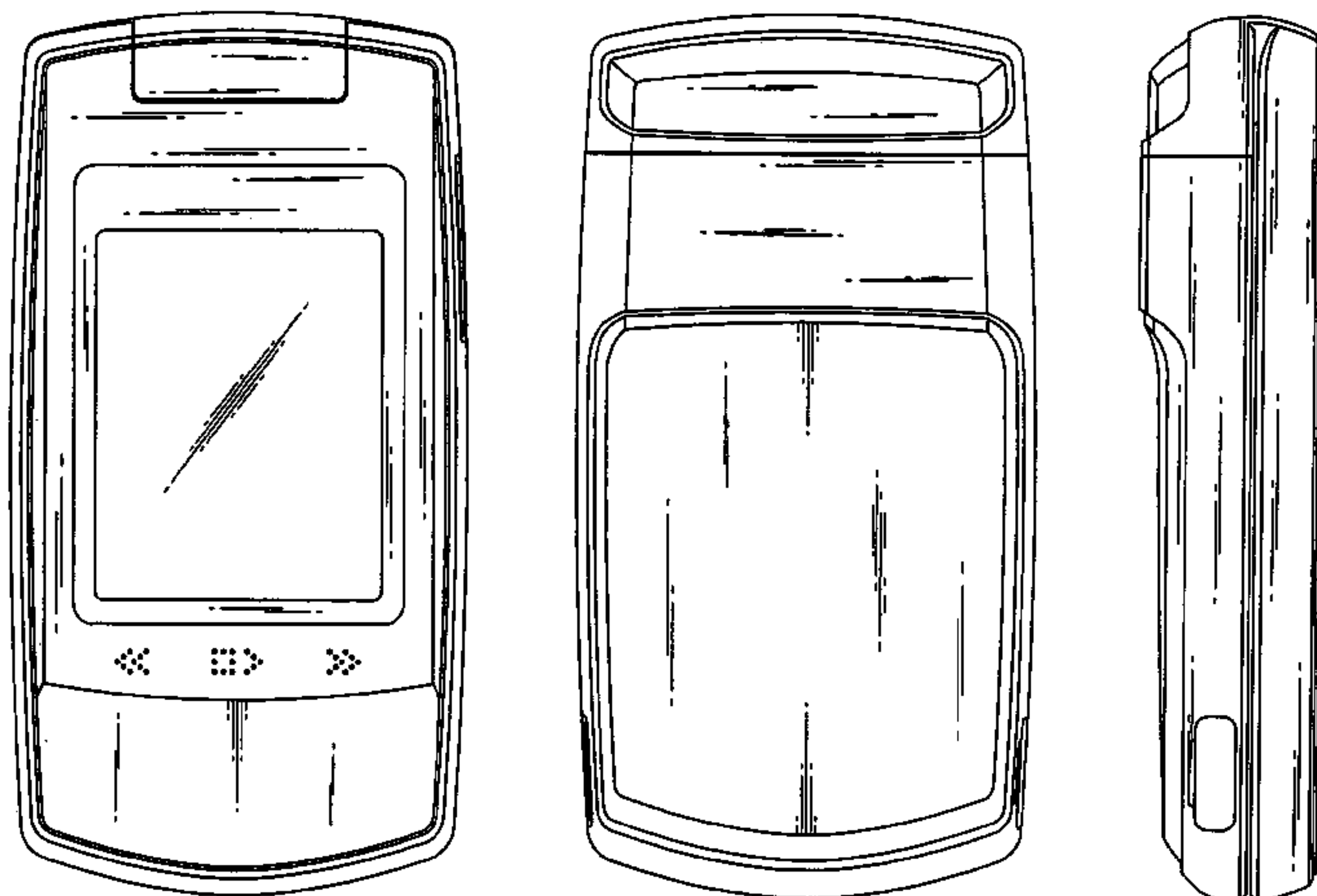

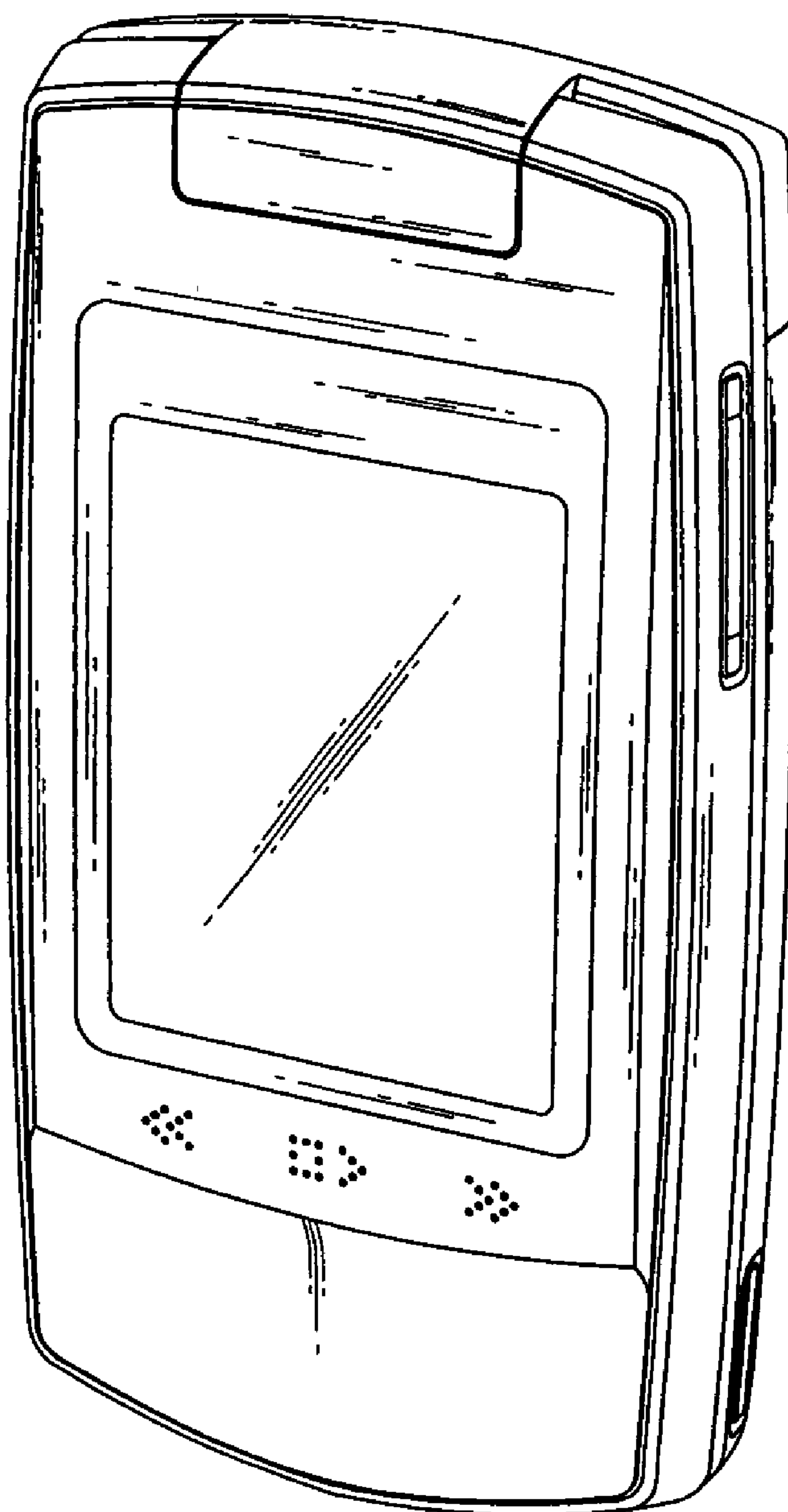

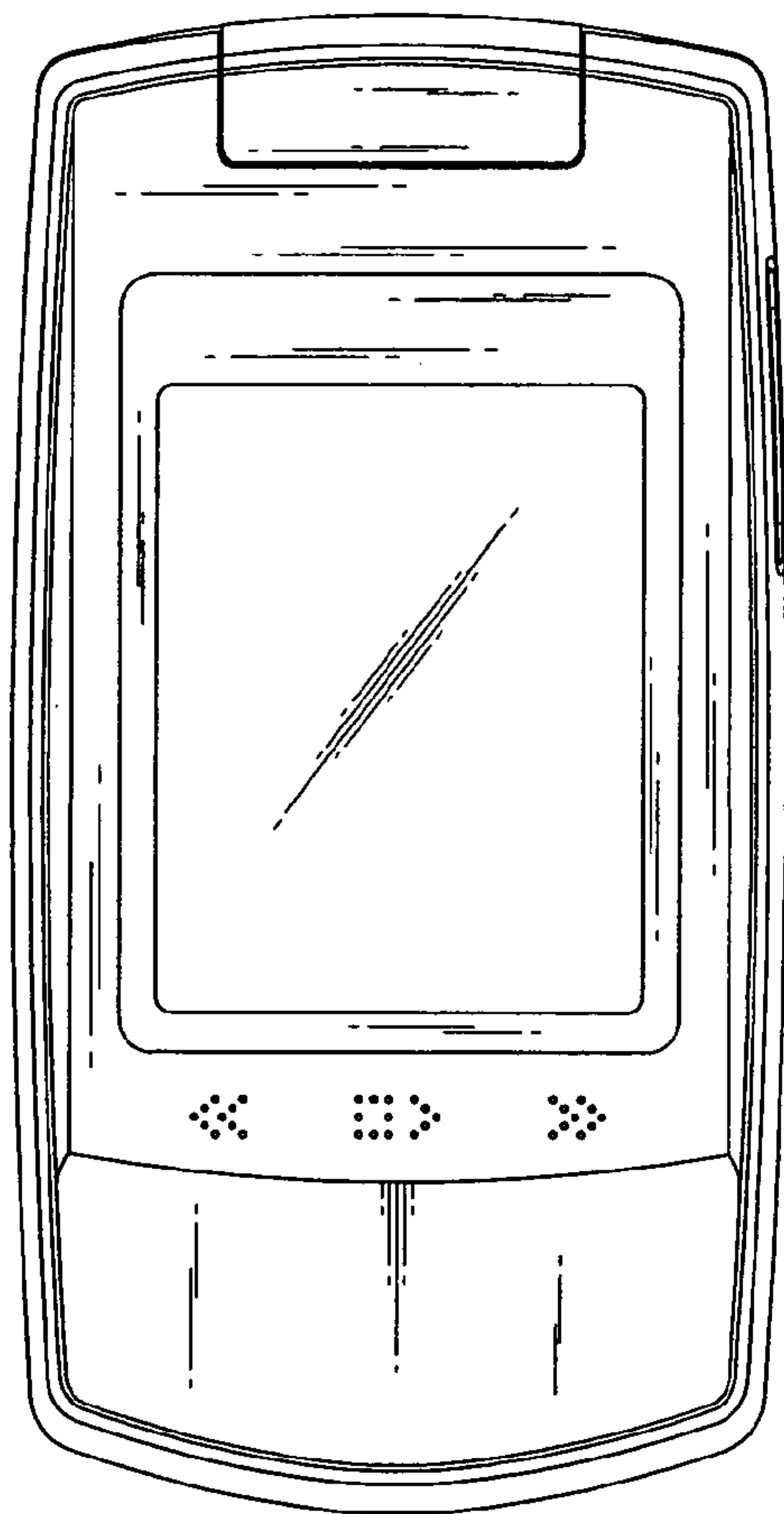

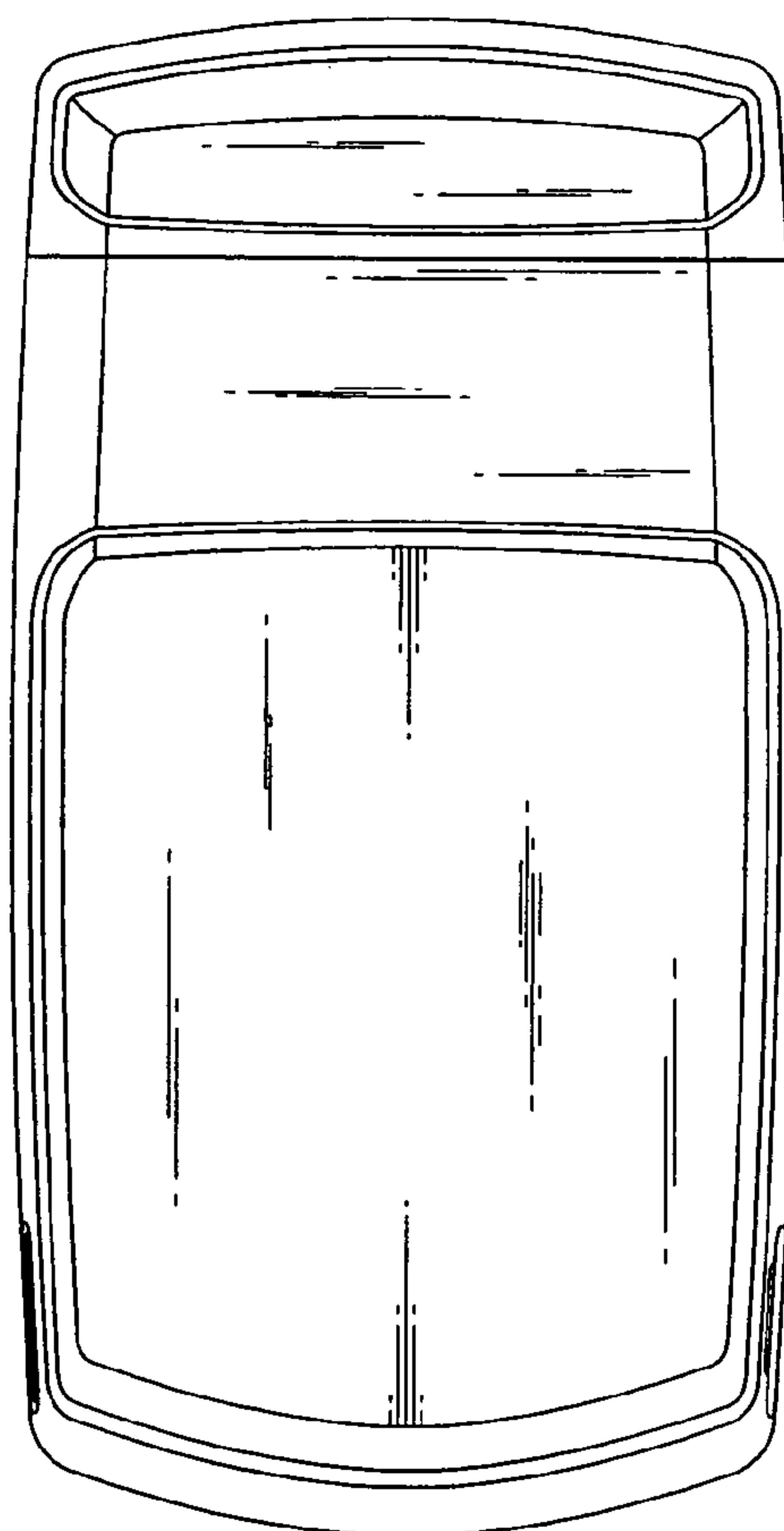

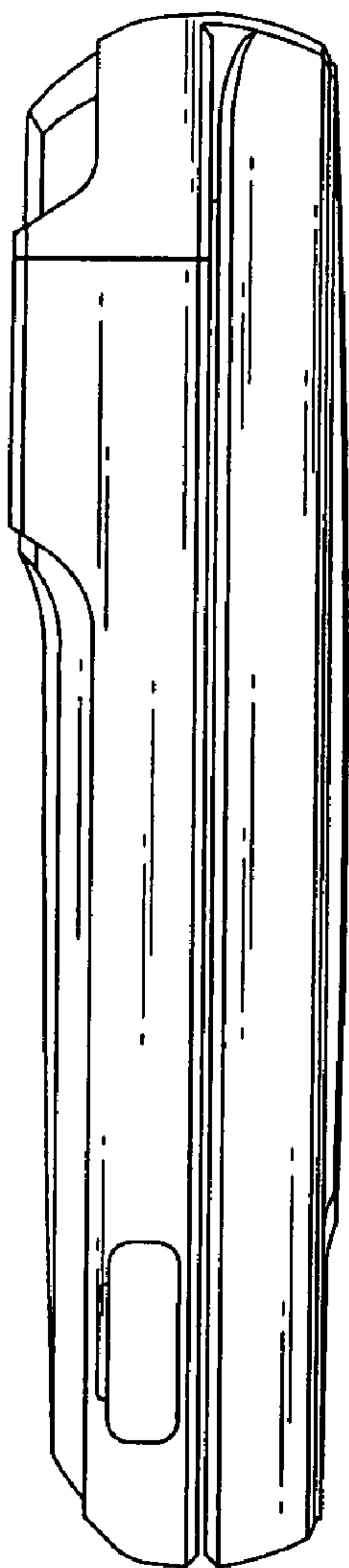

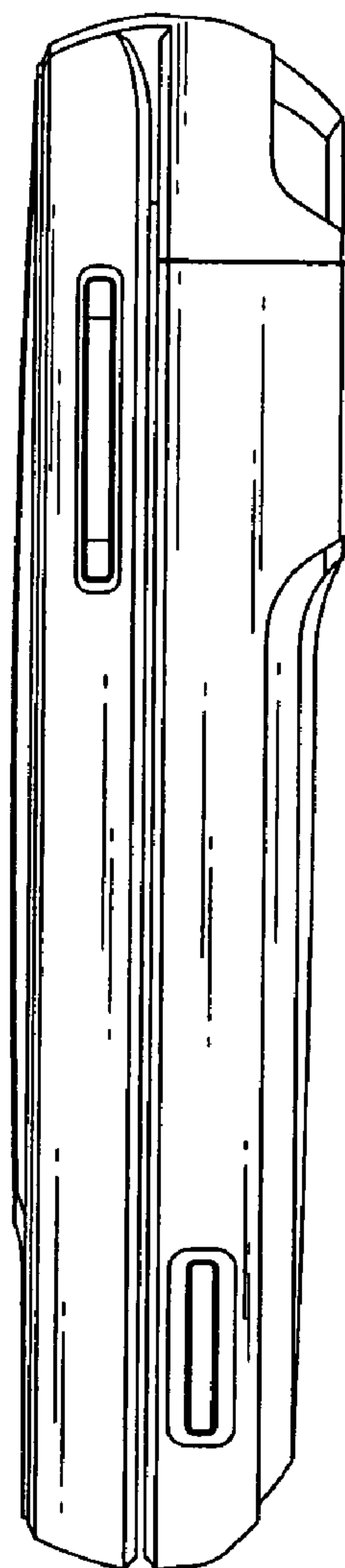

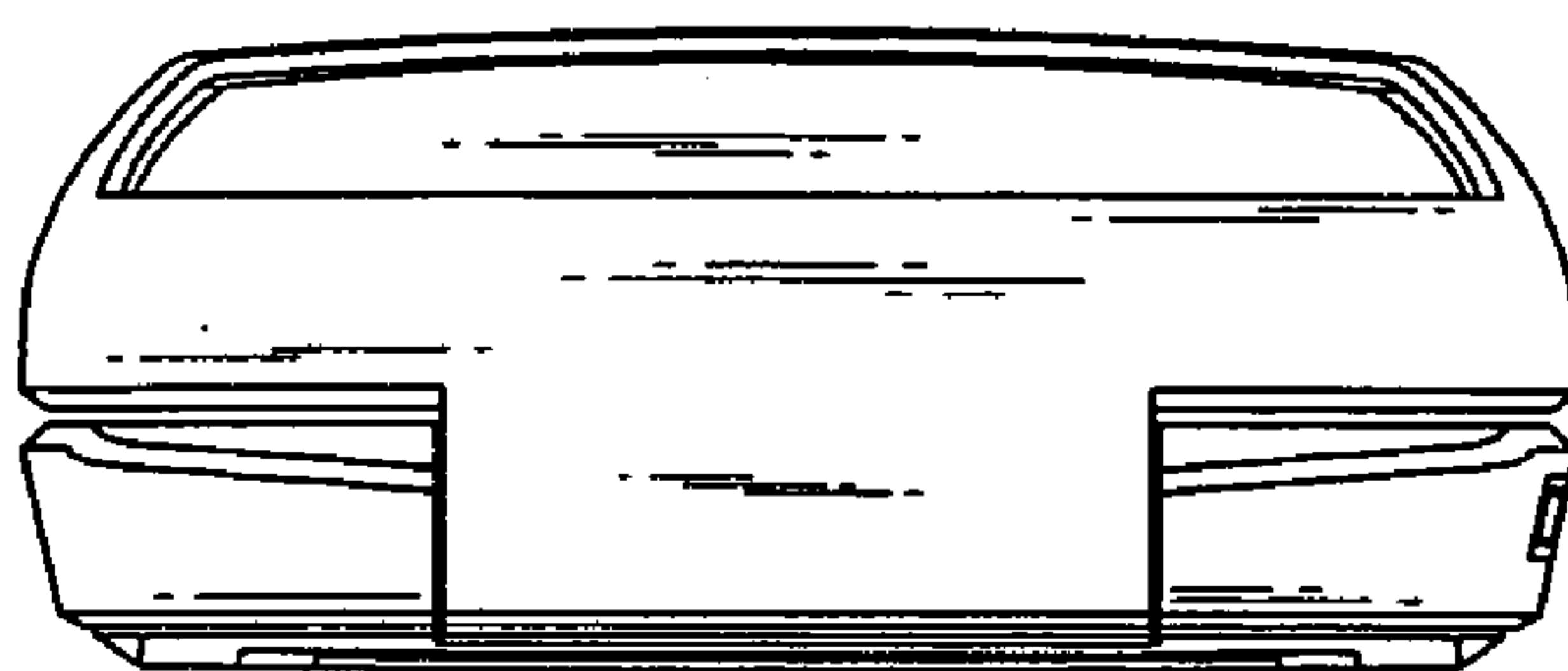
