**DESCRIPTION**

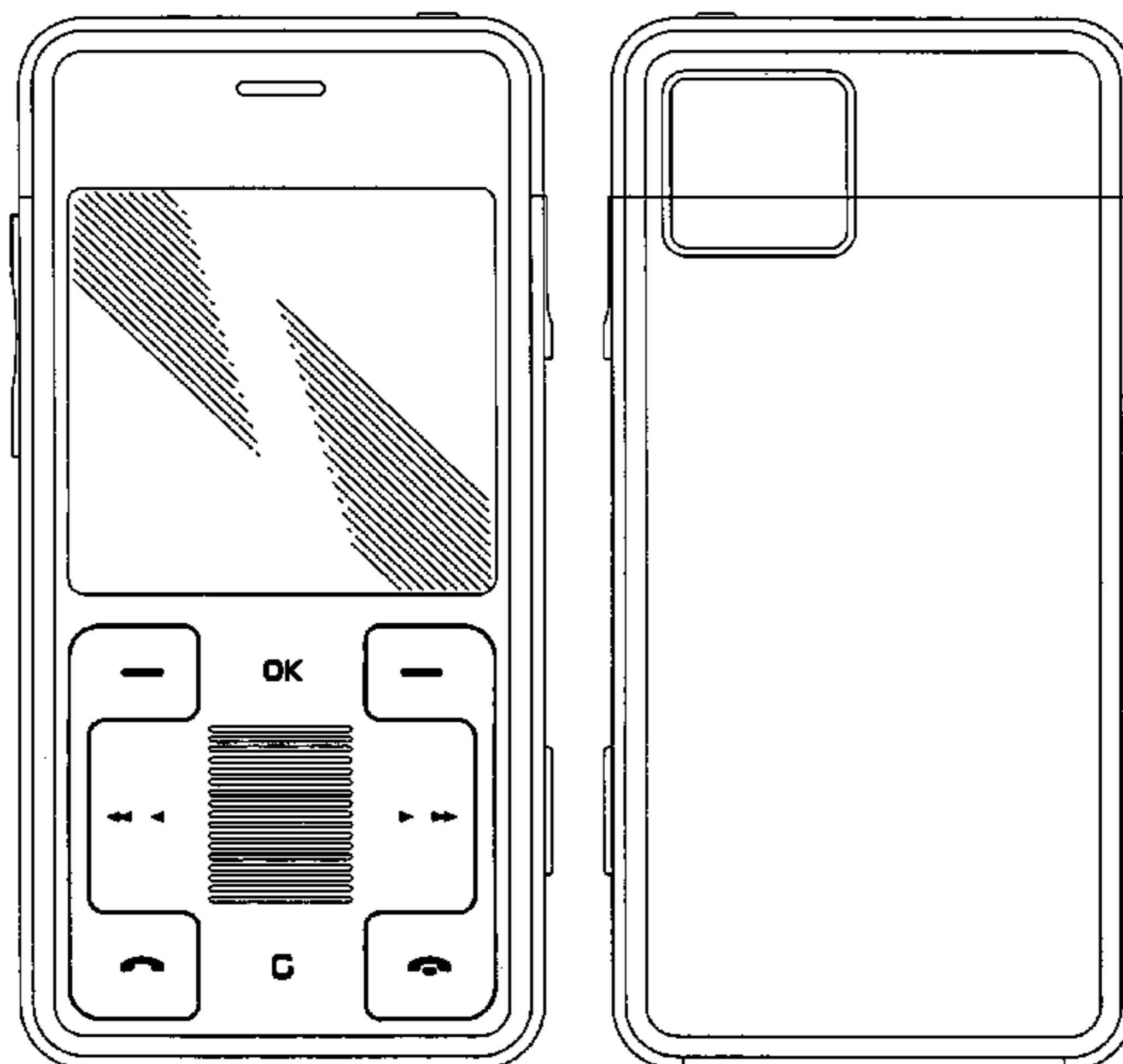

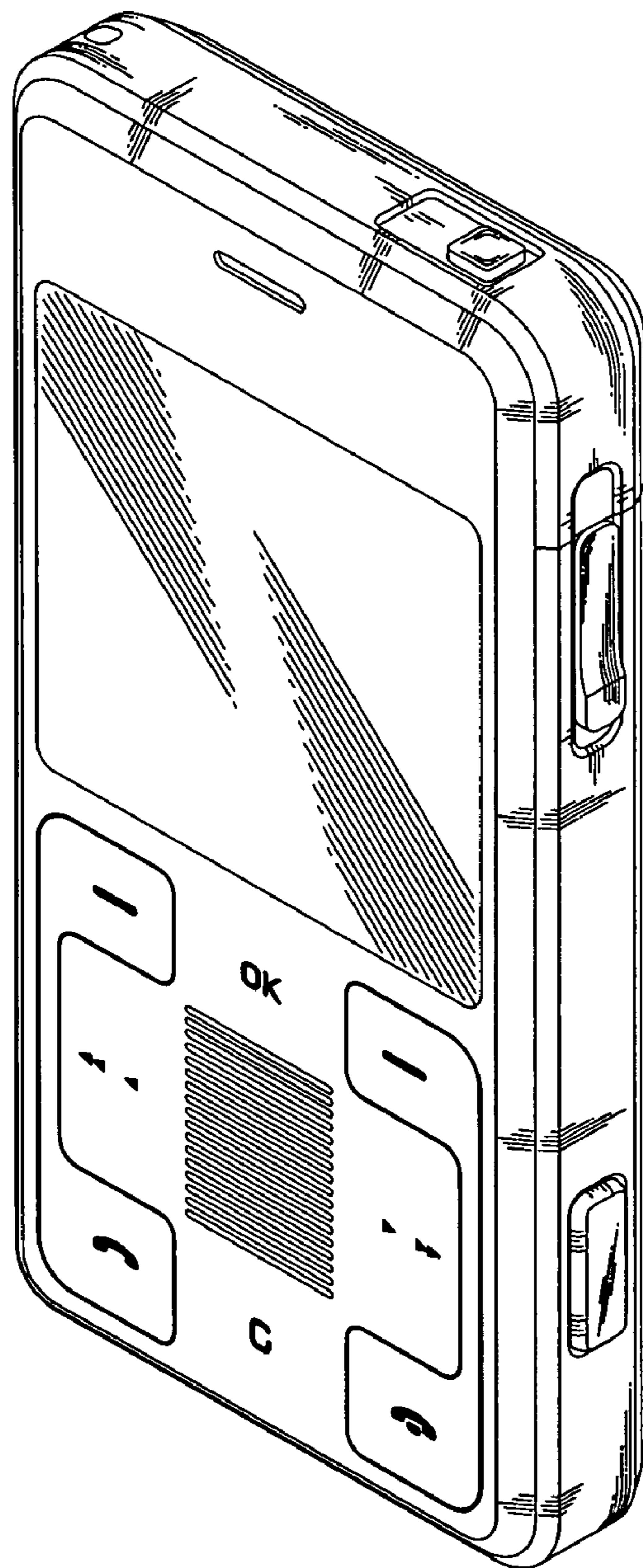

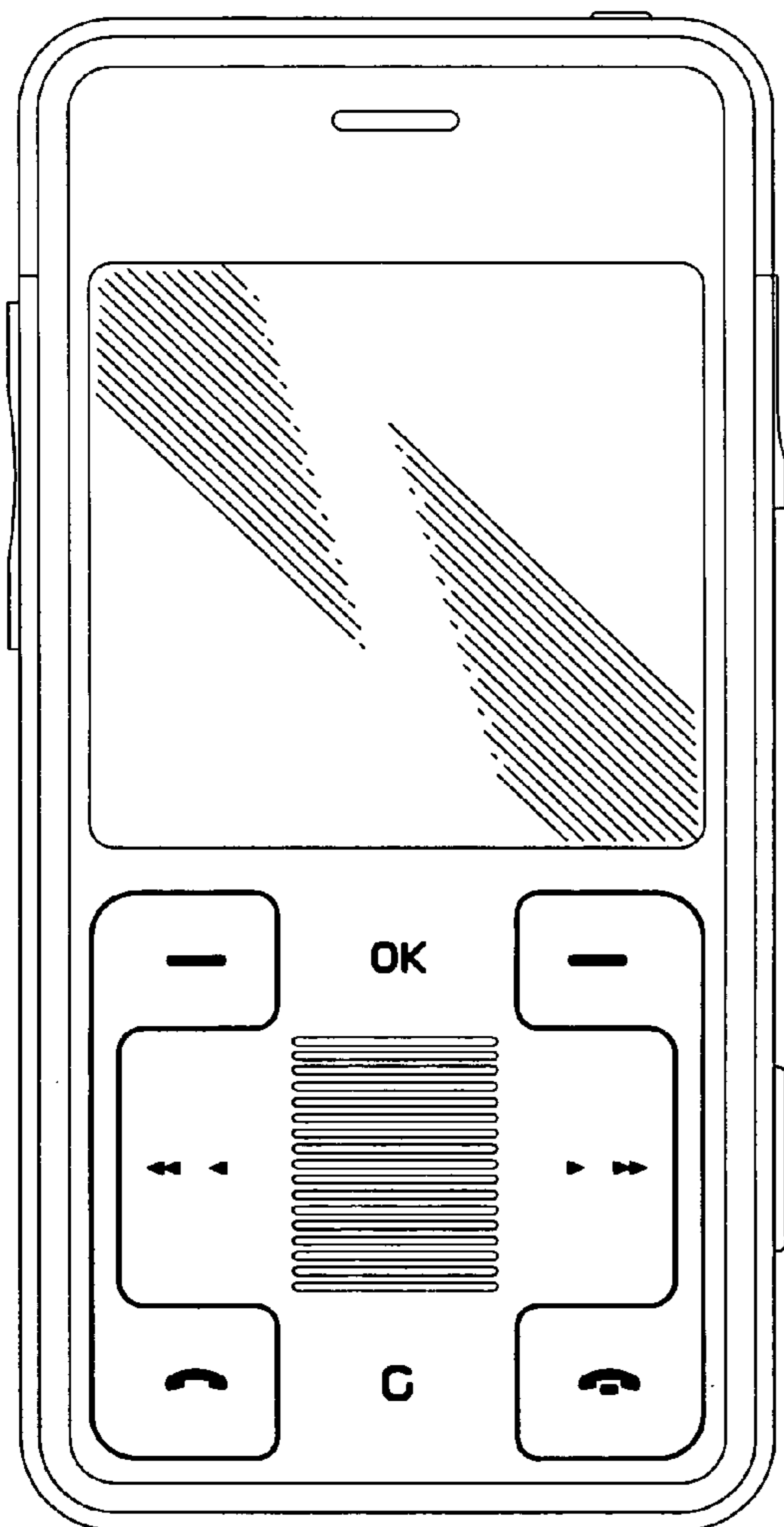

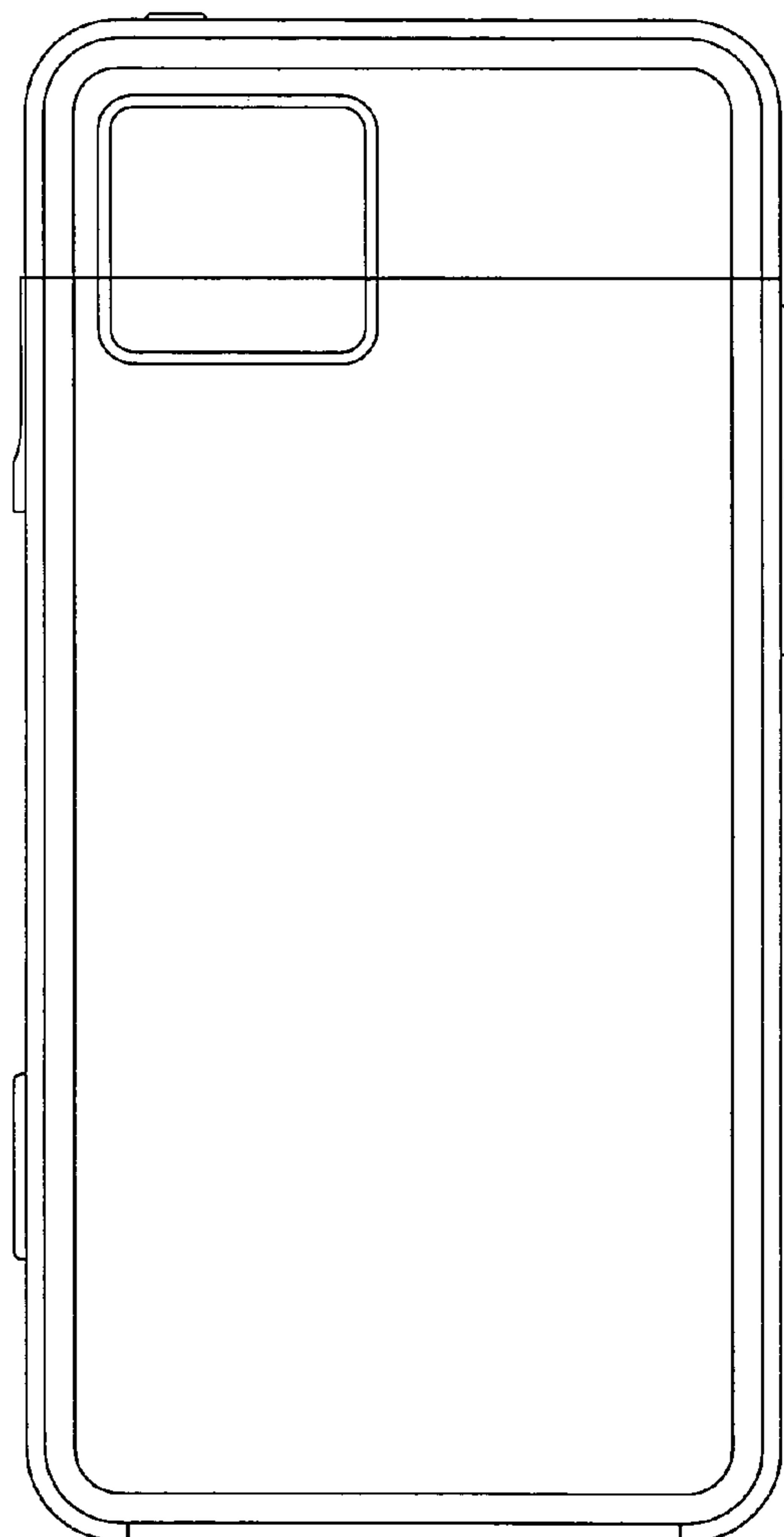

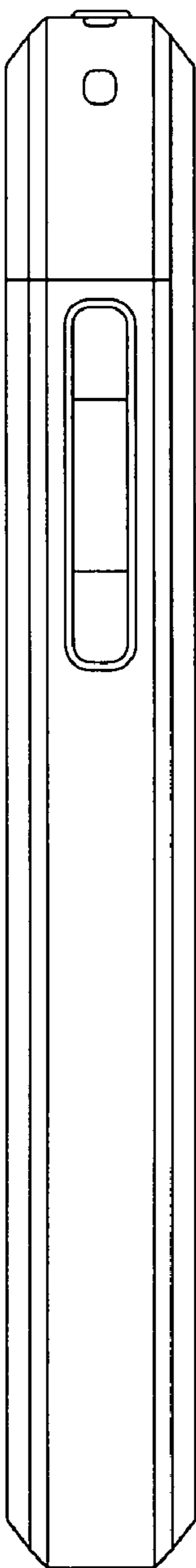

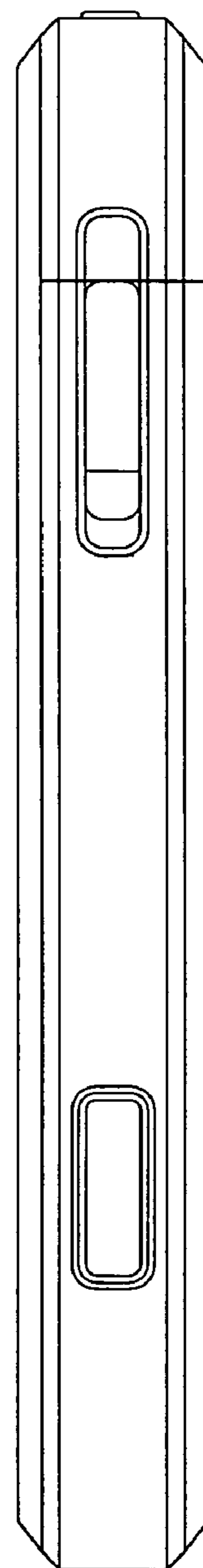

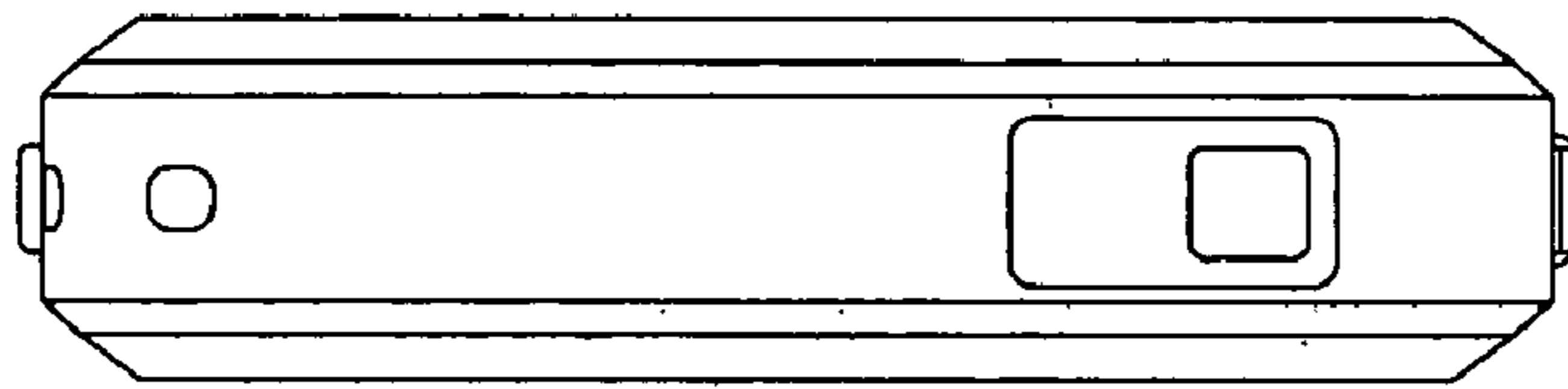

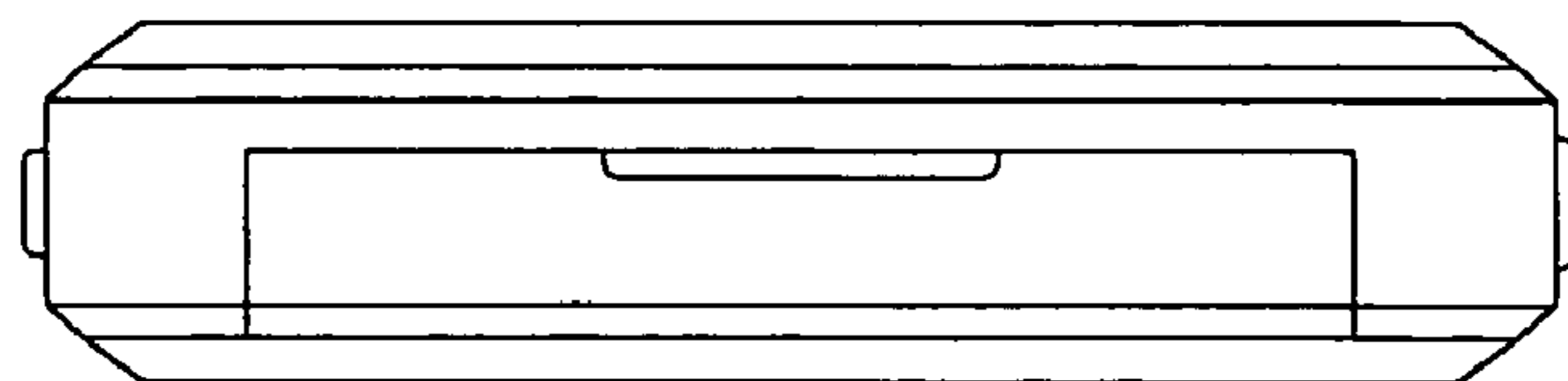
