FIG. 4 is a front elevation thereof;

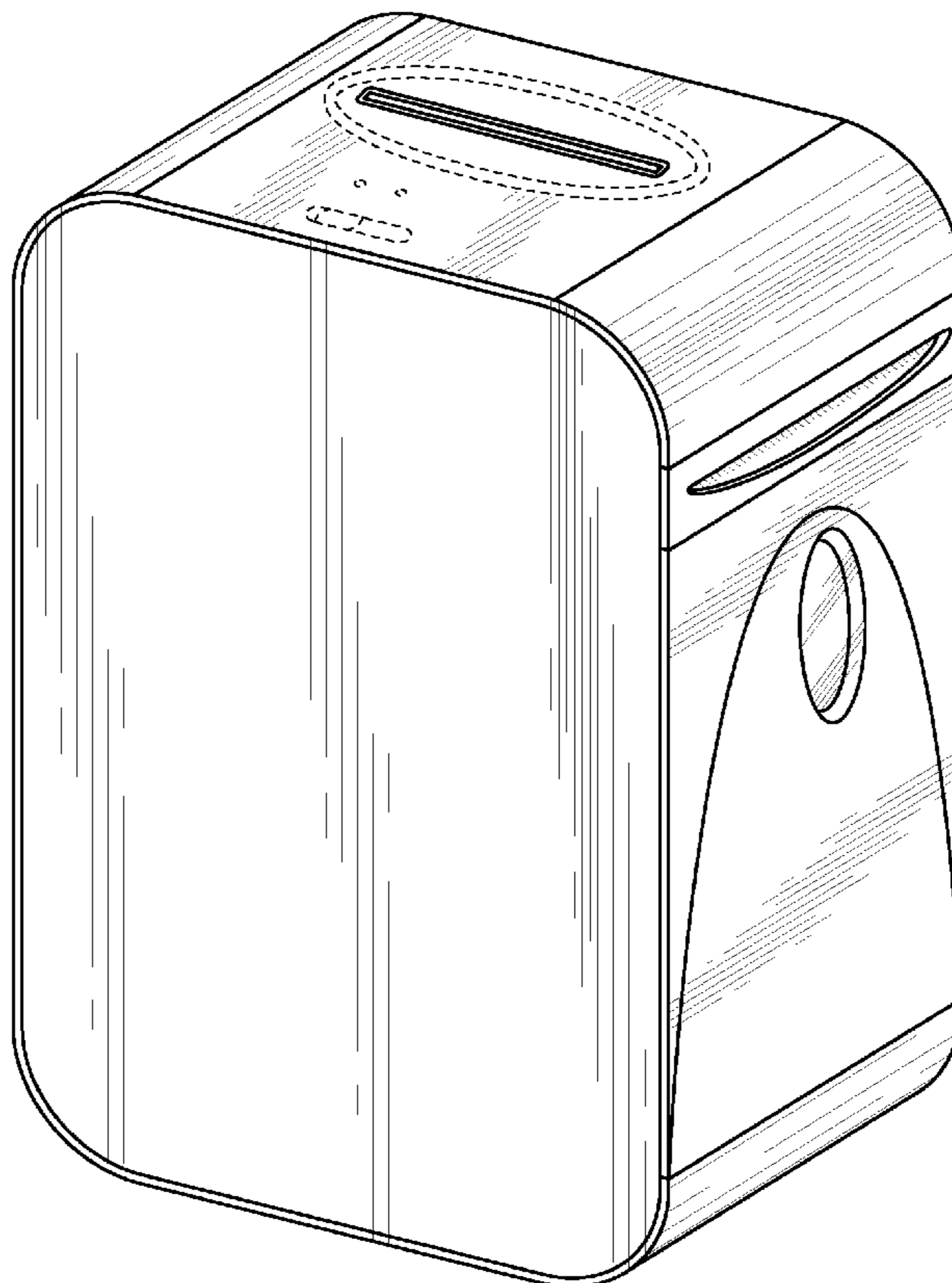
FIG. 5 is a rear elevation thereof;

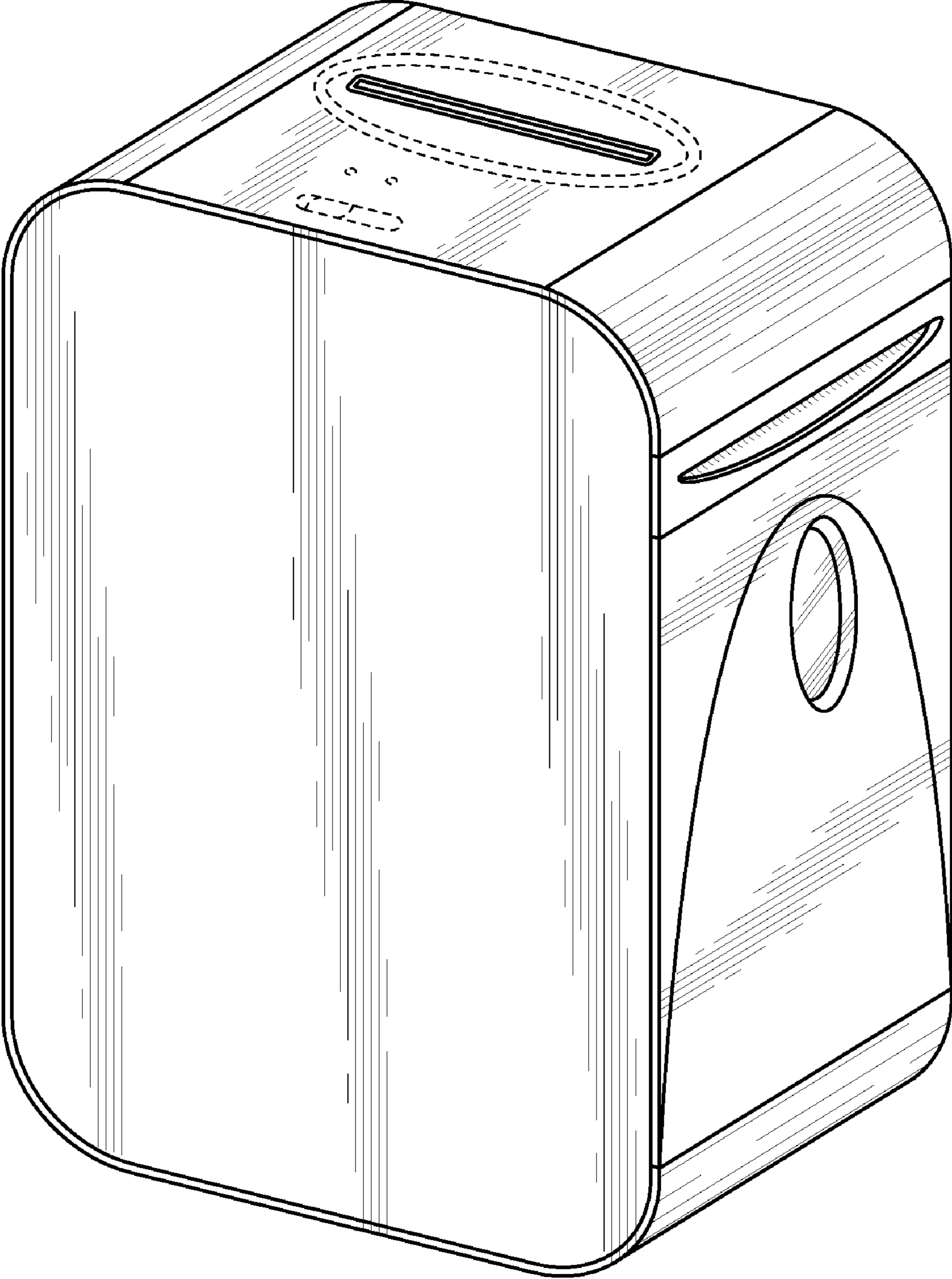

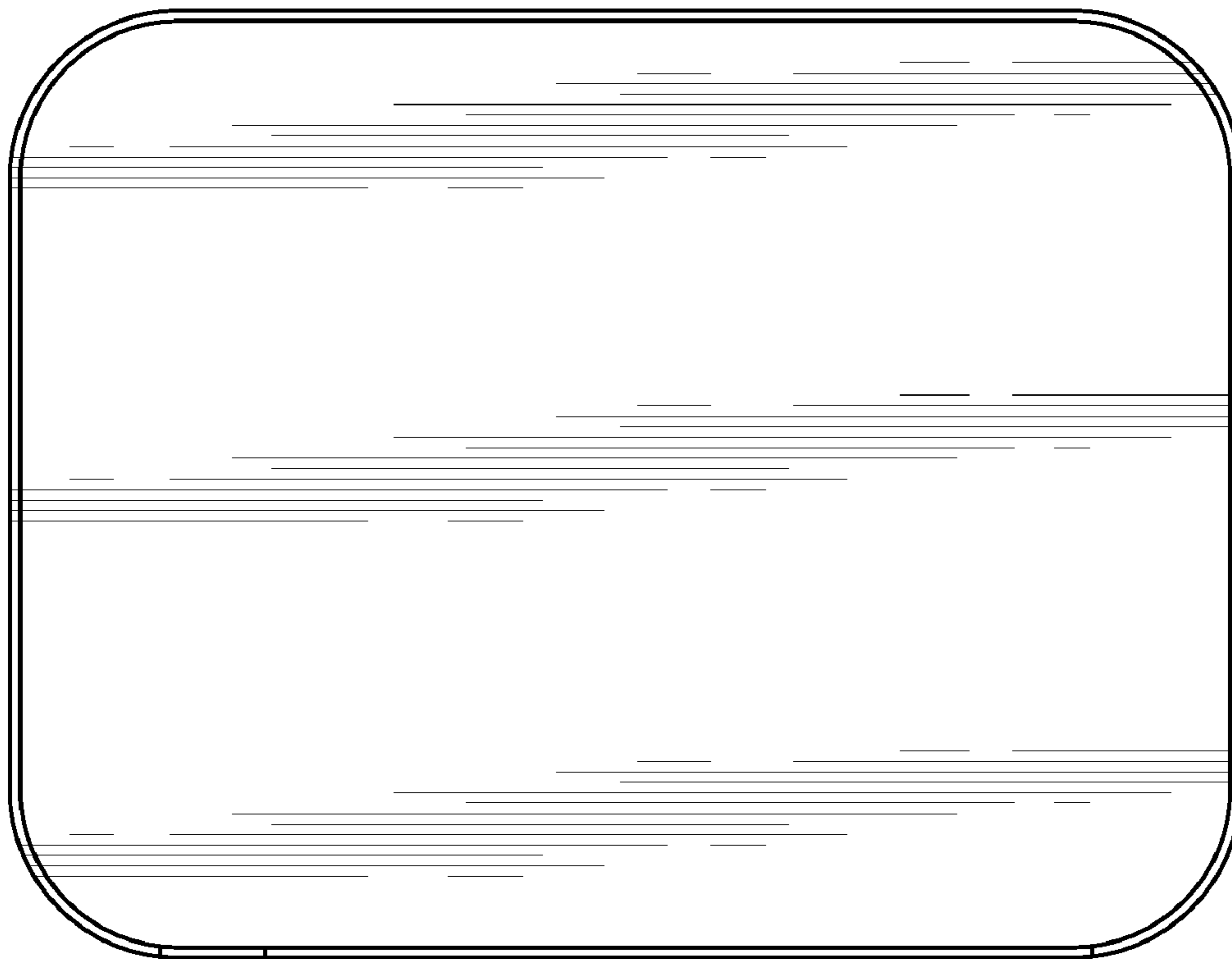

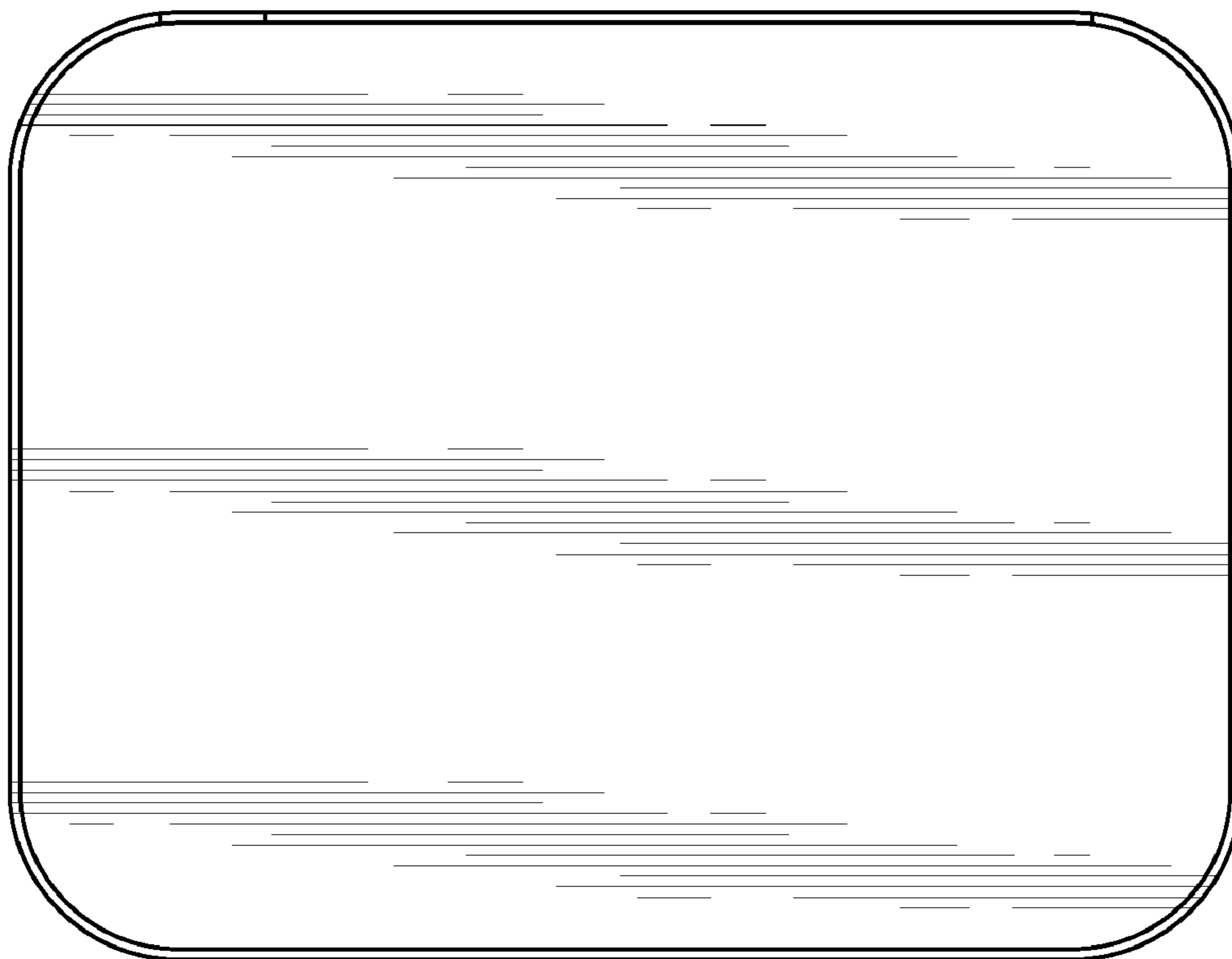

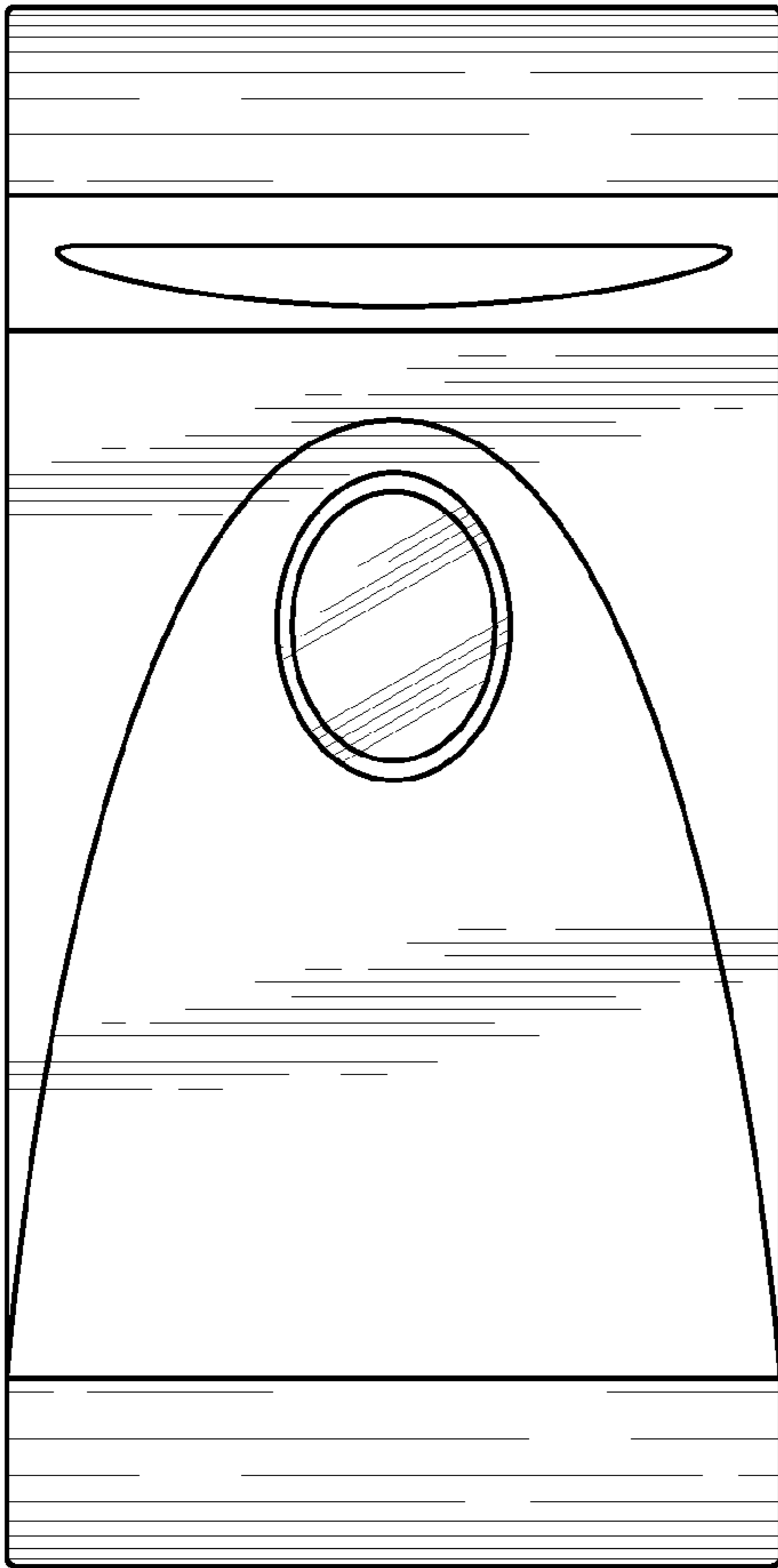

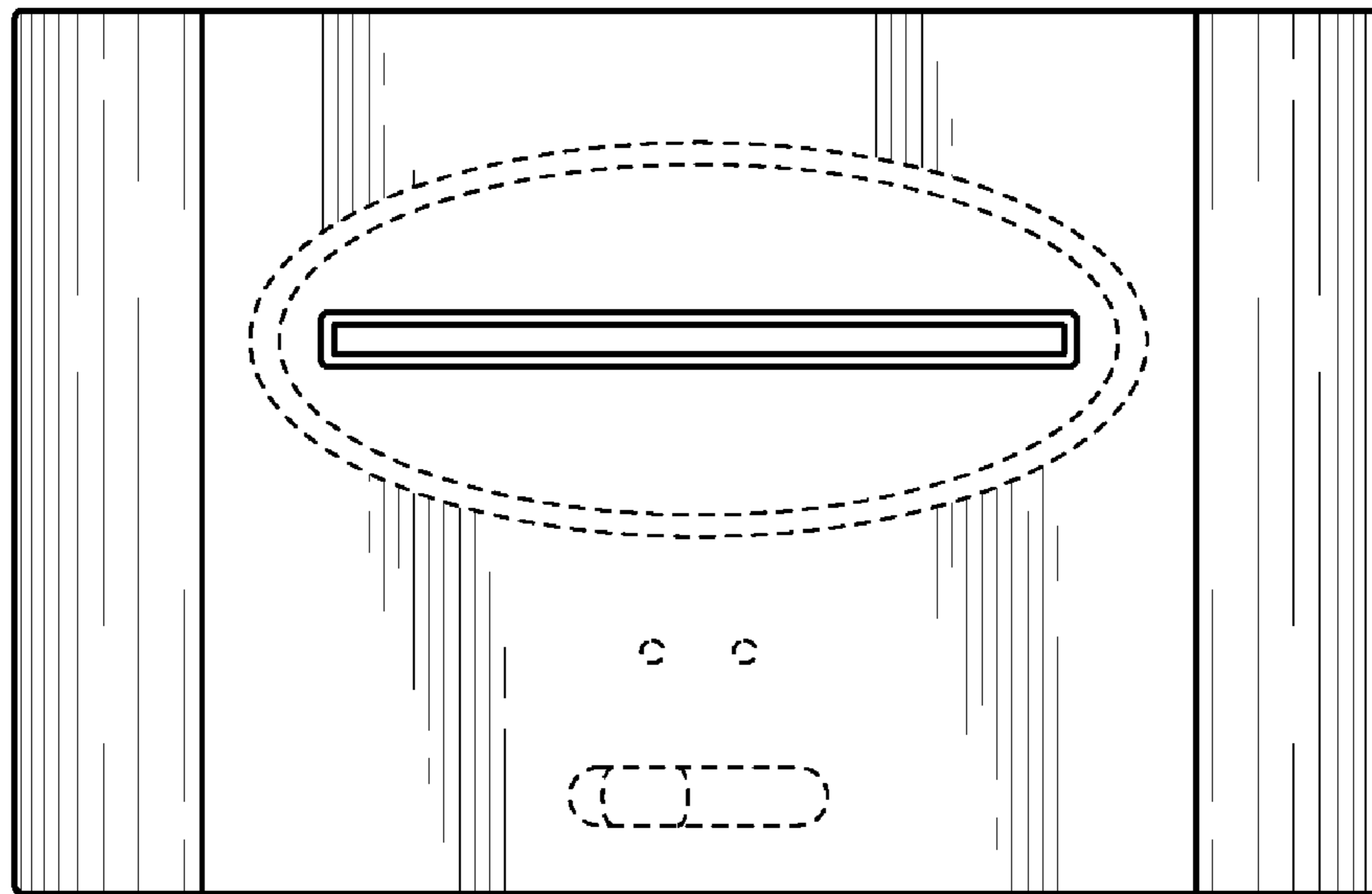

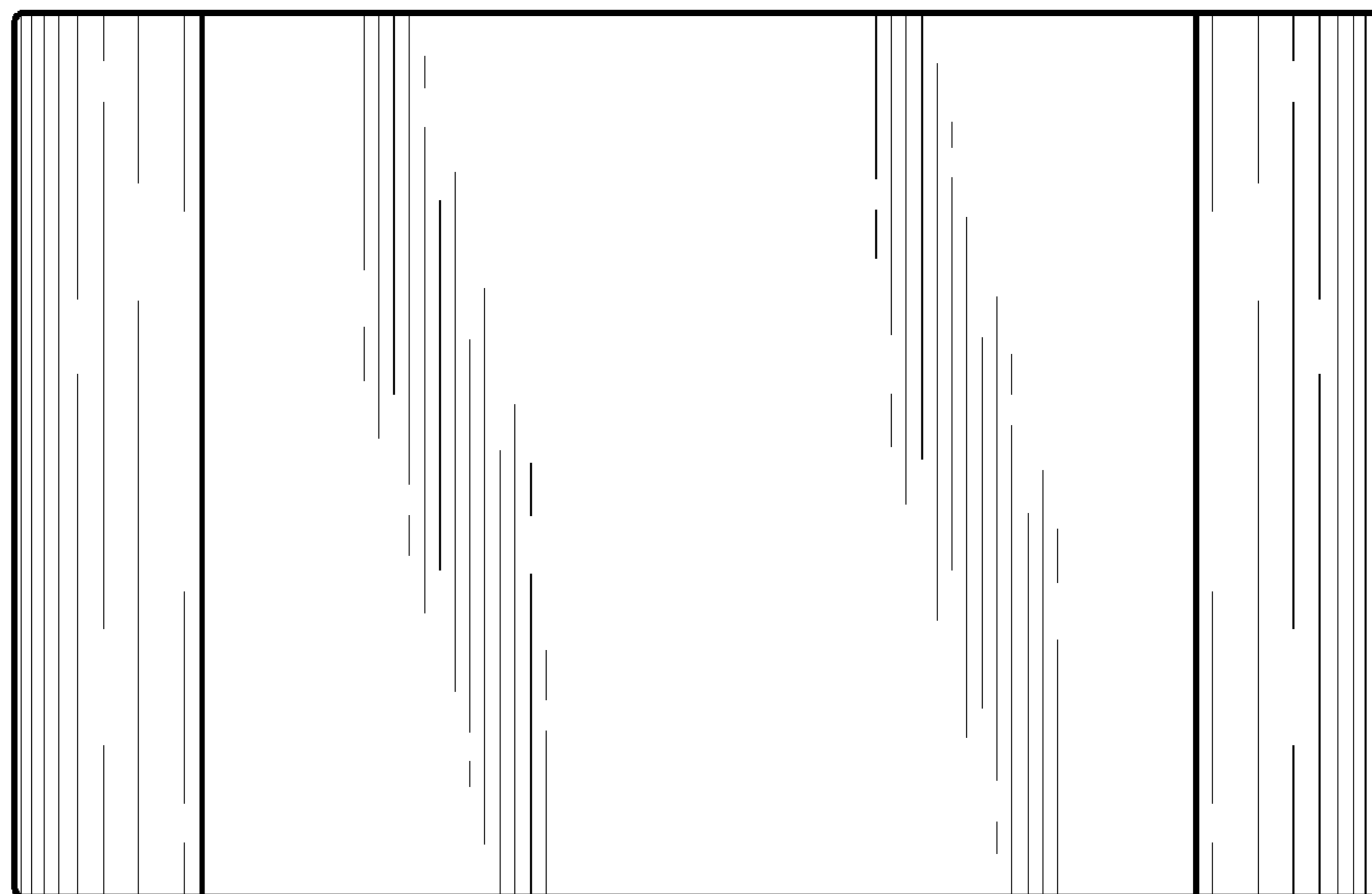
