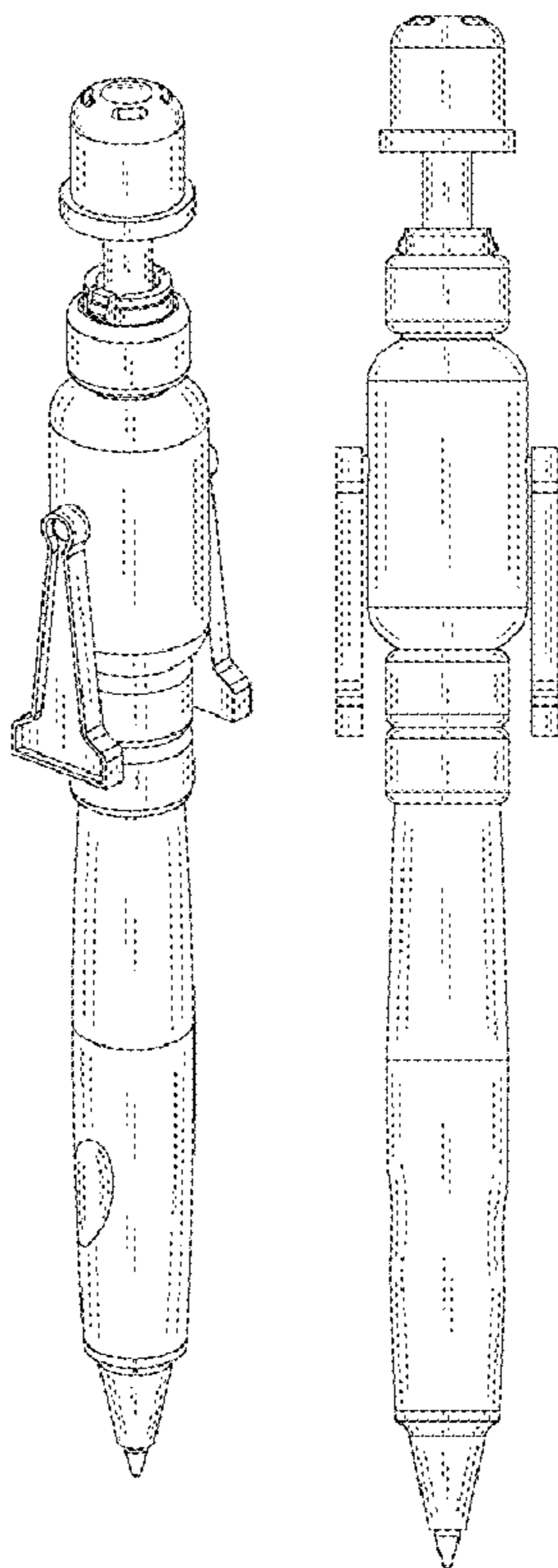
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper front left perspective view of a pen showing our new design;

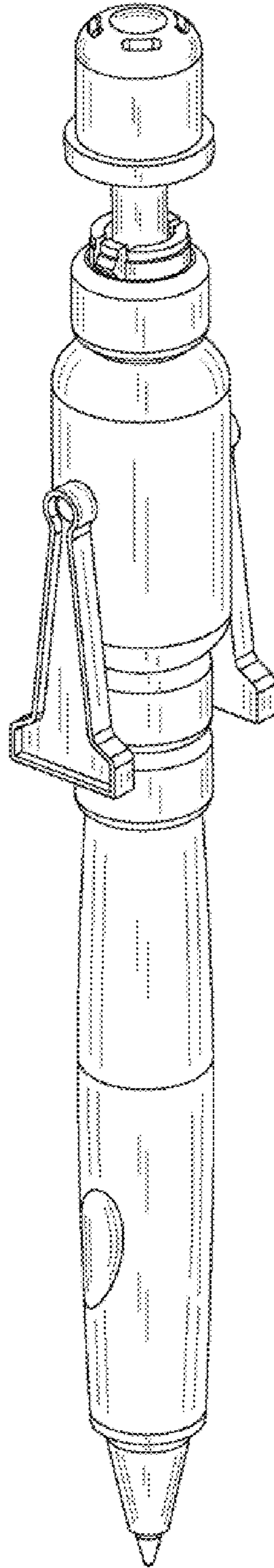

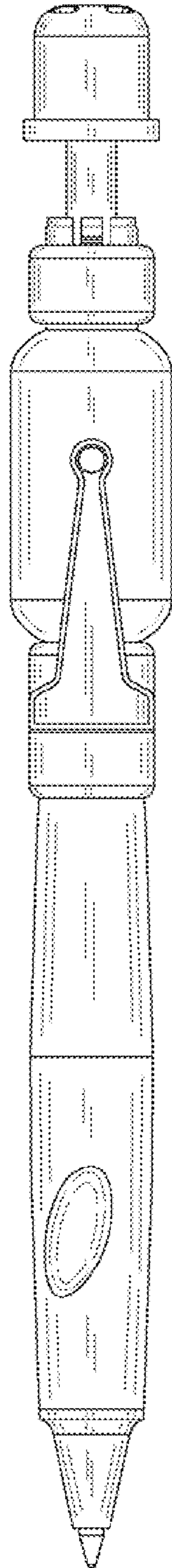

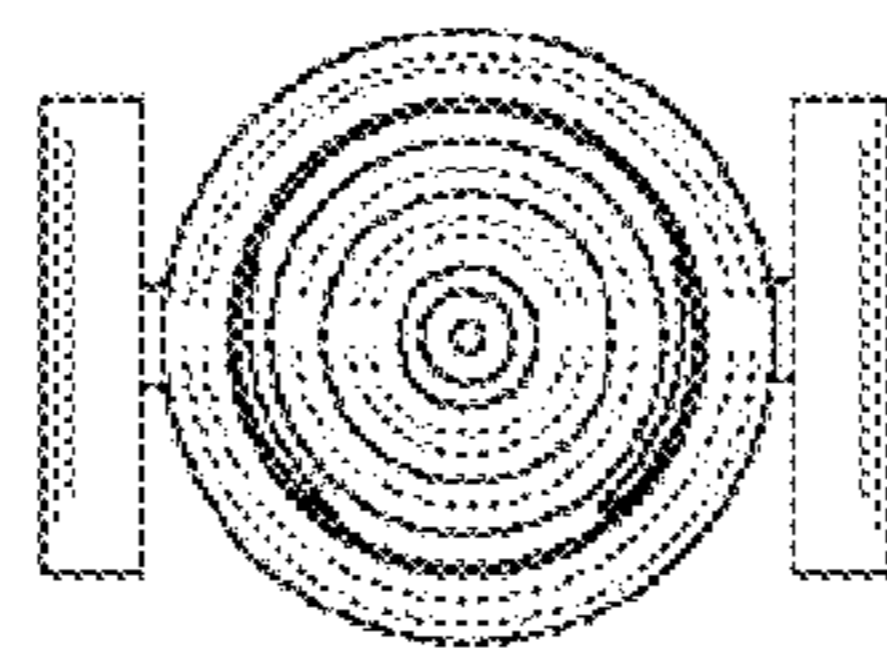

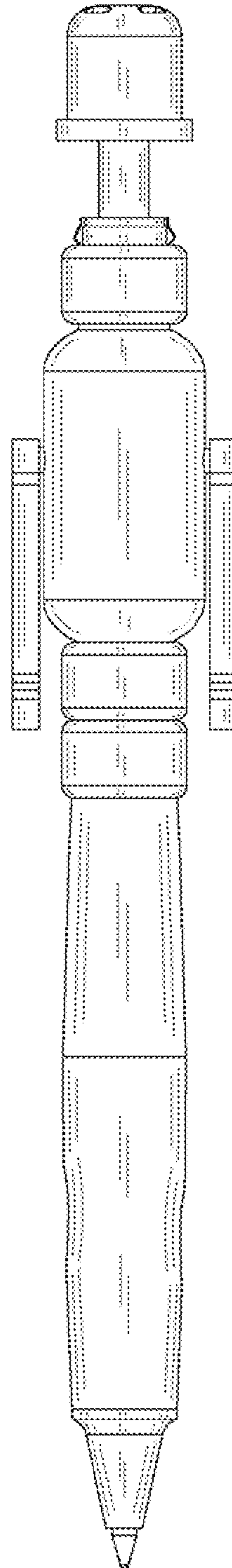

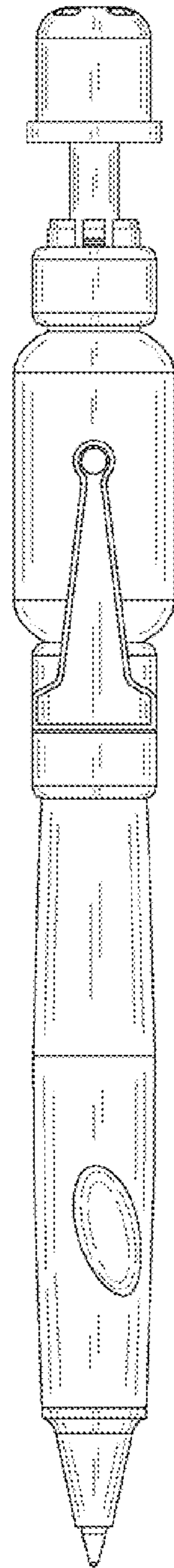

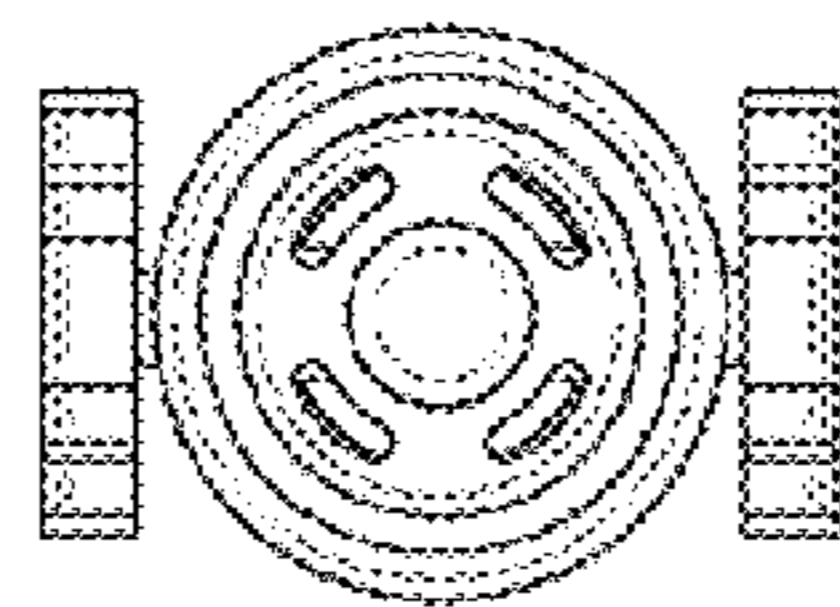

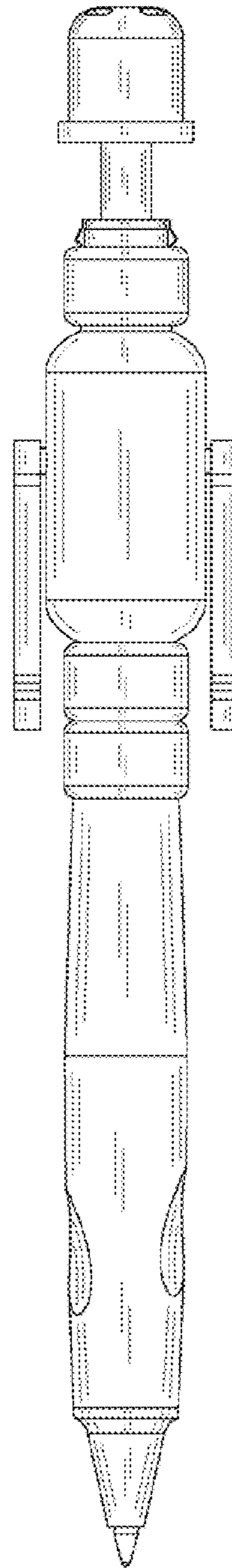
