DESCRIPTION

FIG. 1 is a front/right-side/top perspective view of an air conditioner showing our new design;

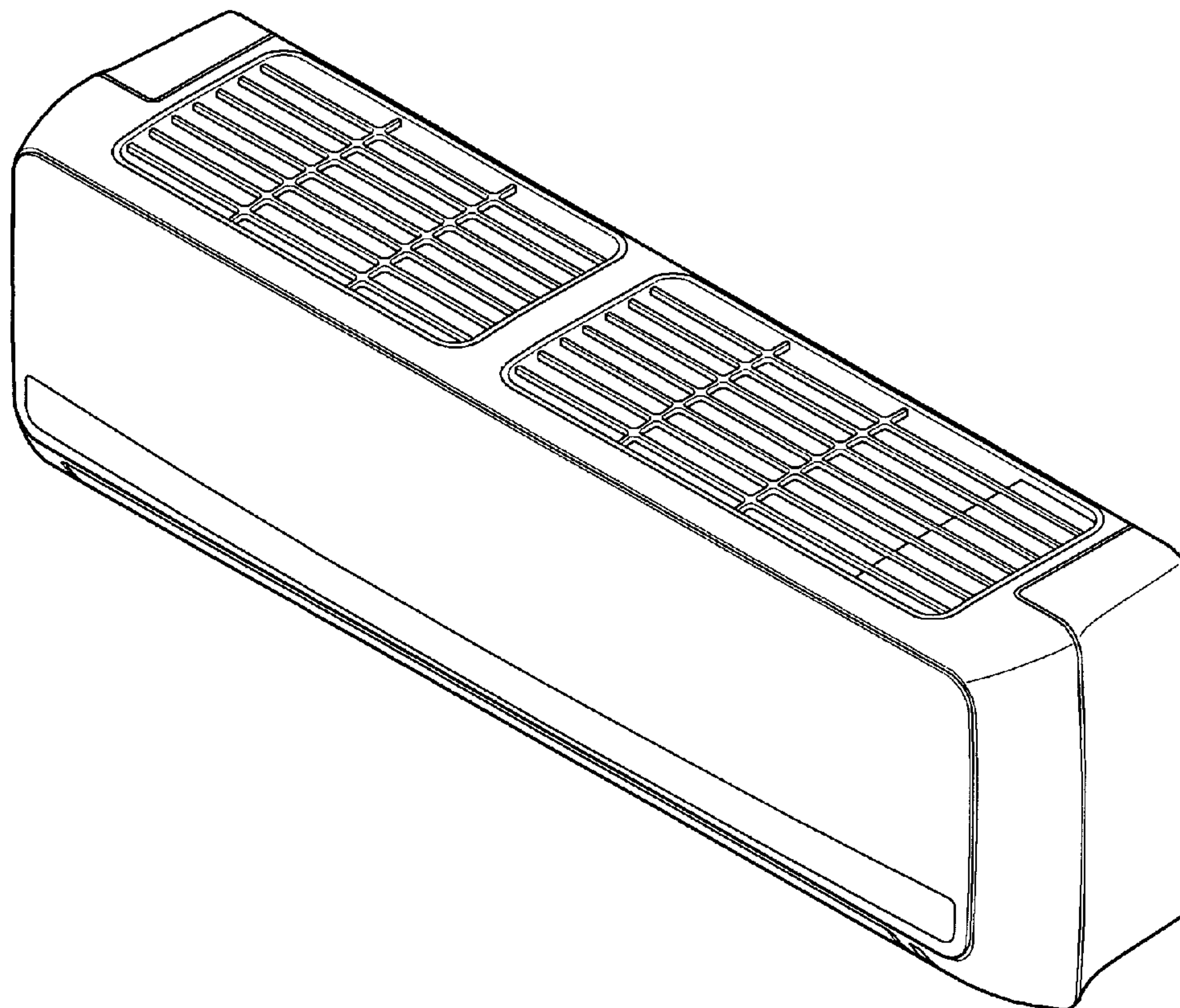

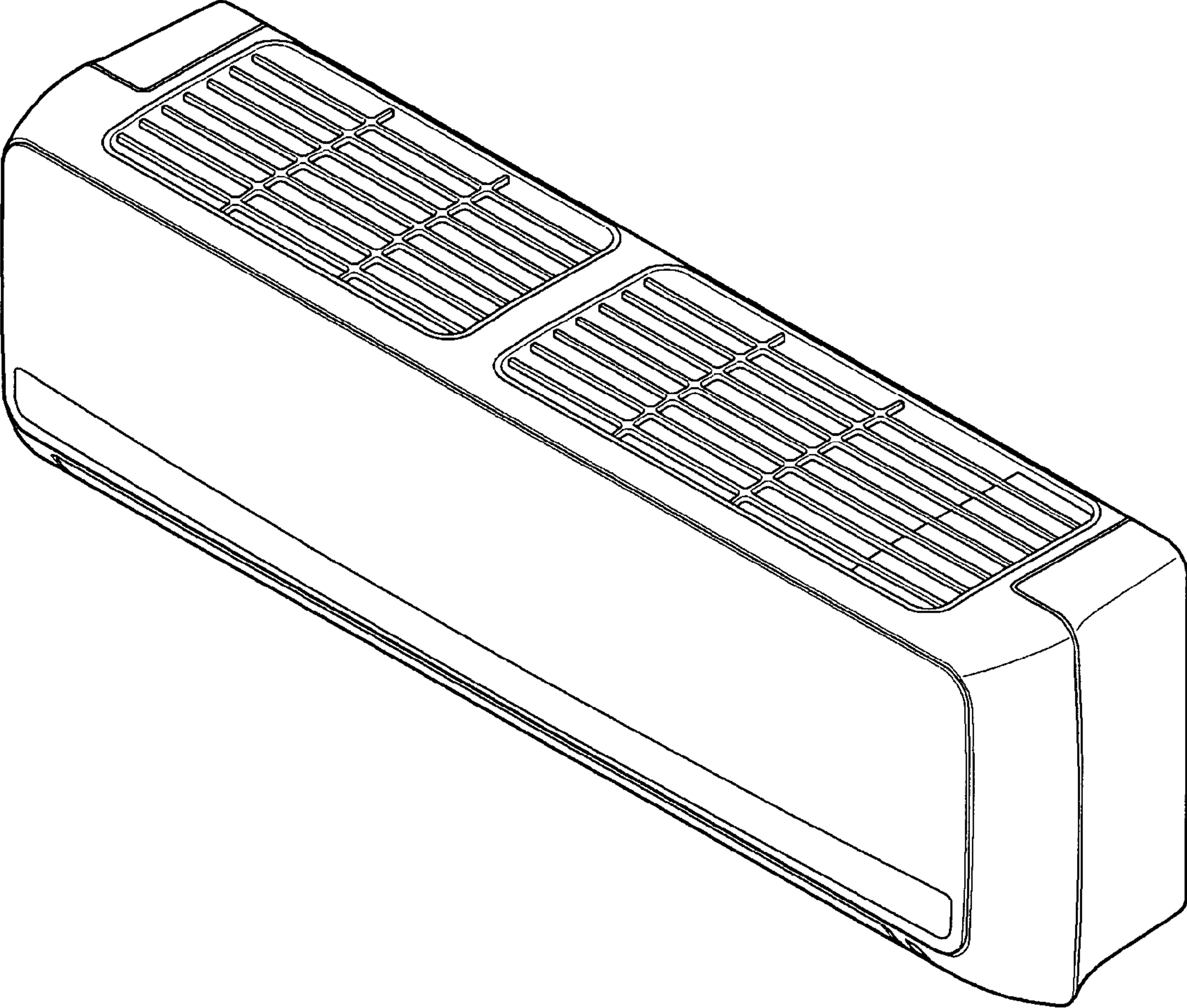

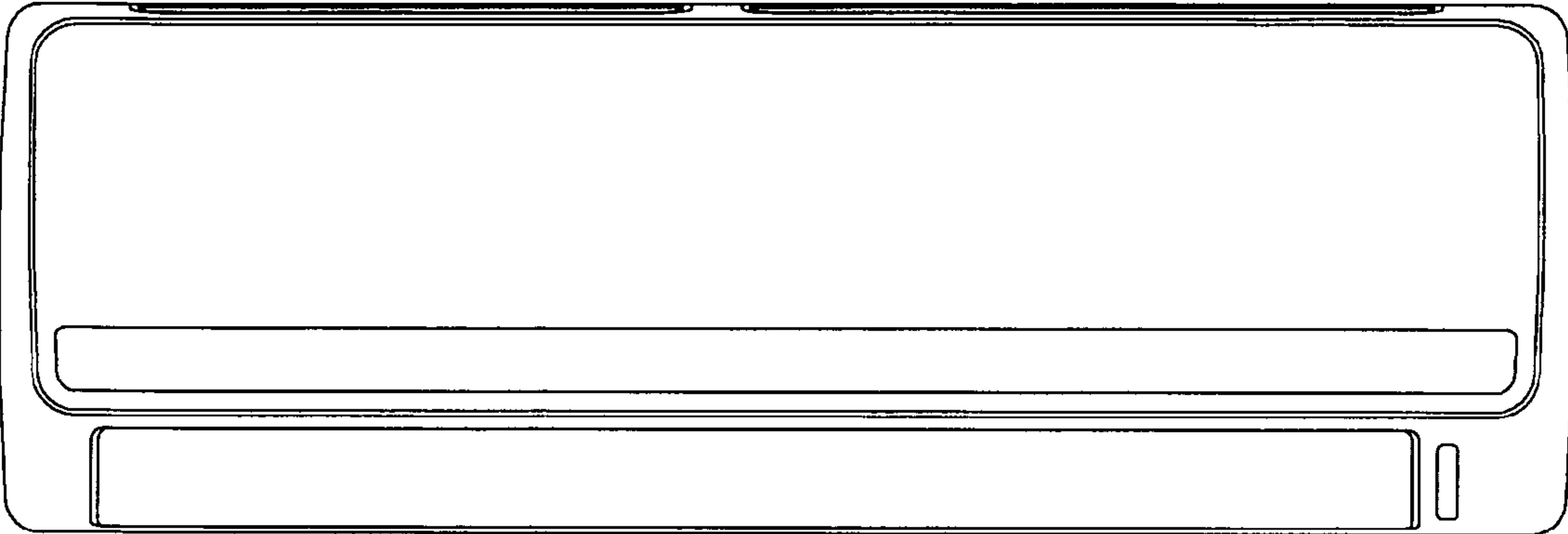

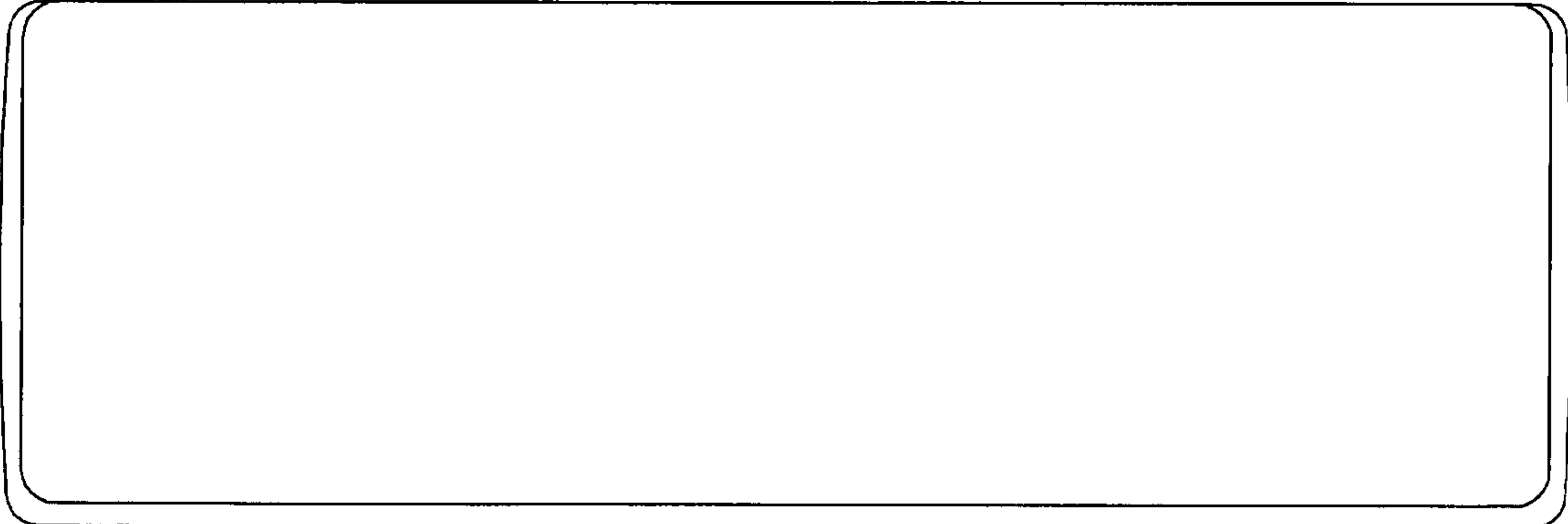

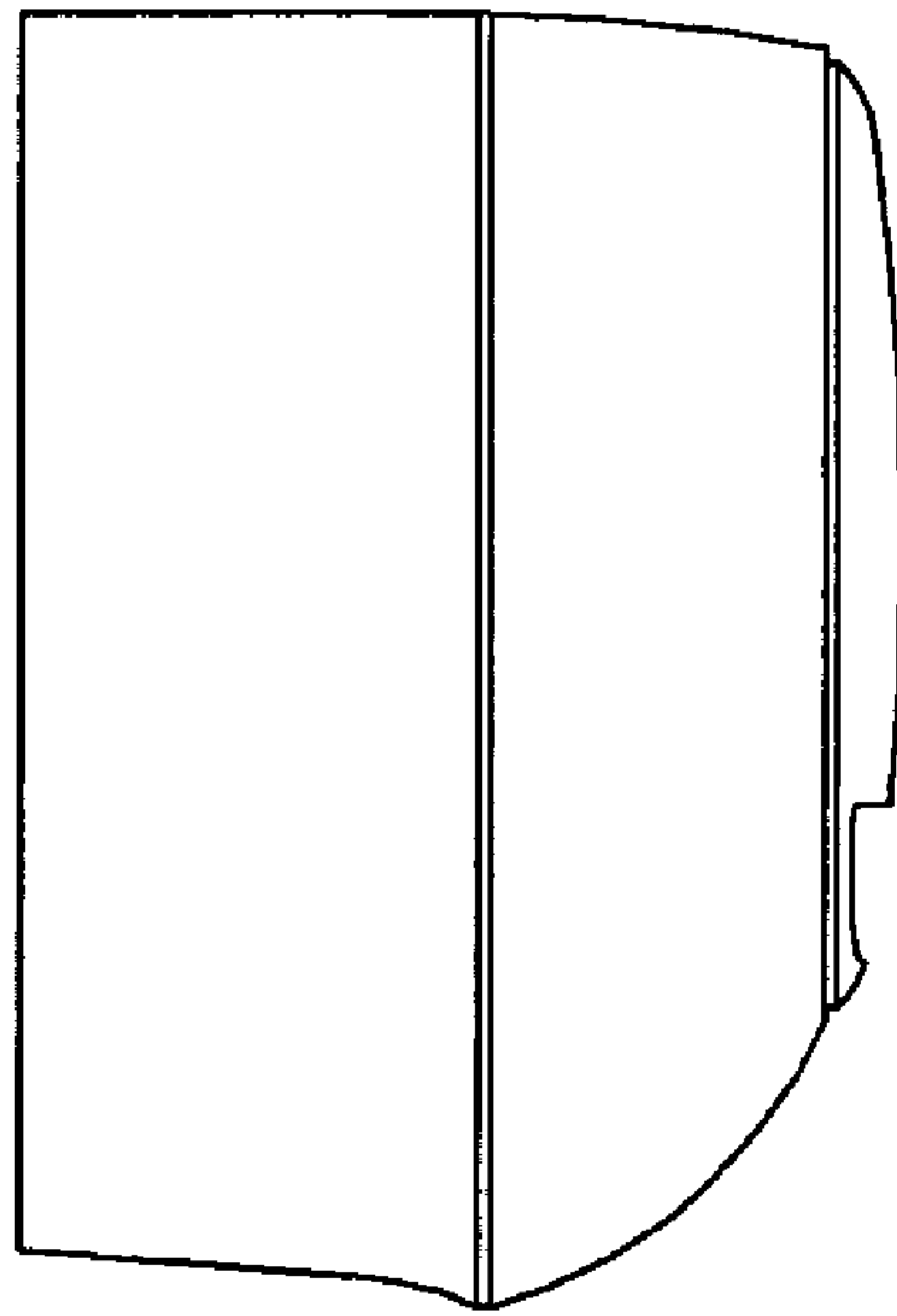

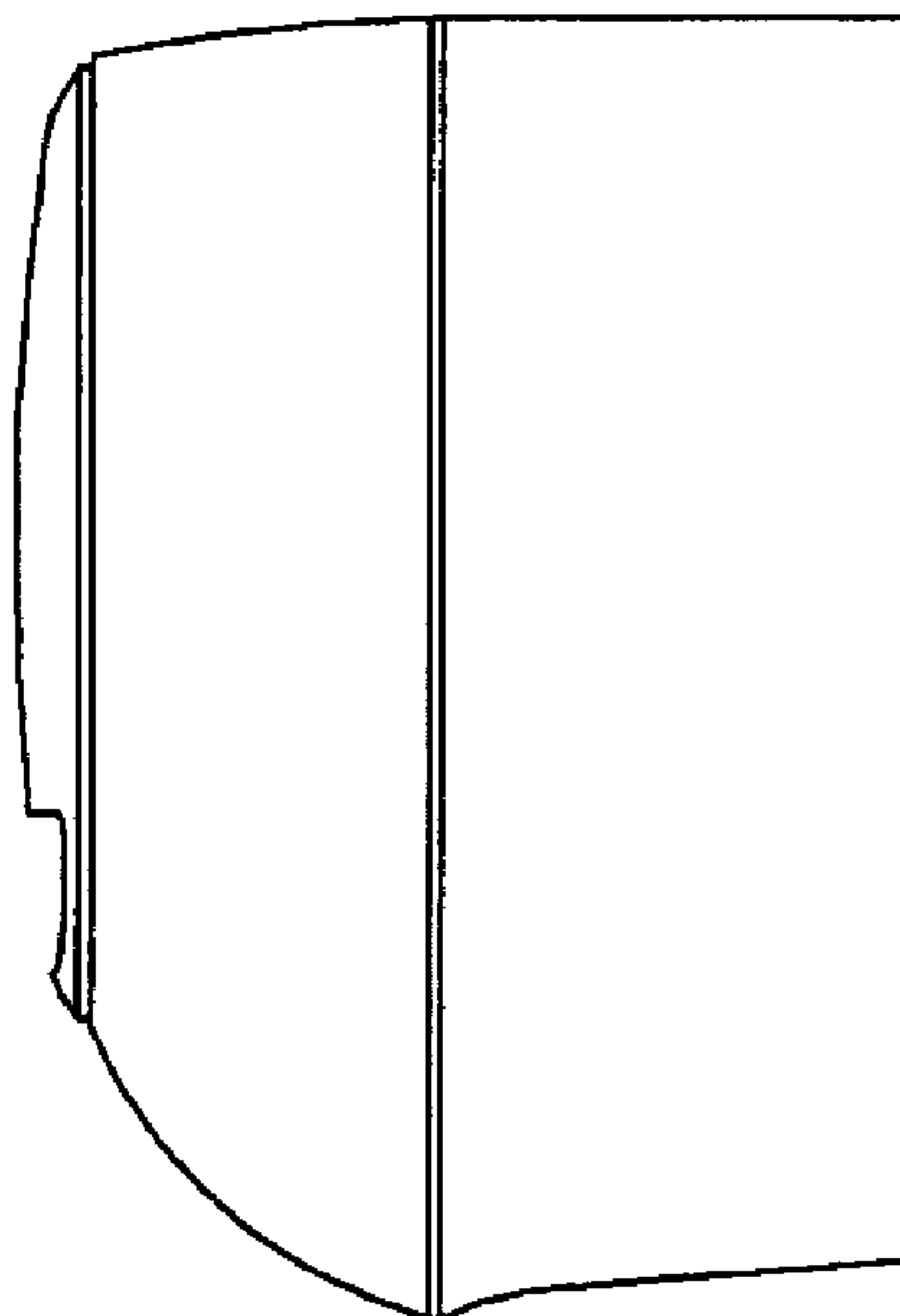

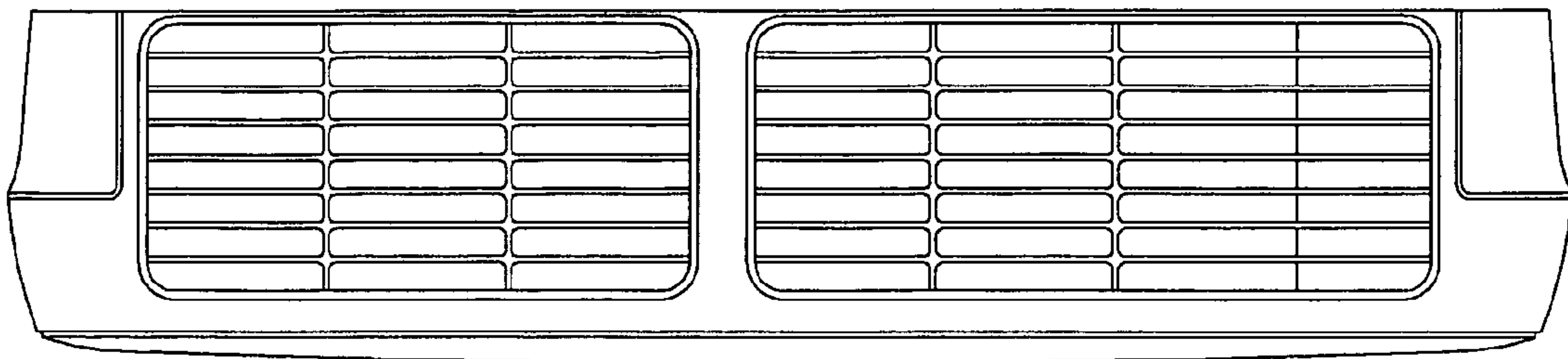
