(57) **CLAIM**

The ornamental design for a floor fan tower, as shown and described.

DESCRIPTION

FIG. 1 a left front side perspective view of the novel floor fan tower.

FIG. 2 is right front side perspective view of the novel floor fan tower design of FIG. 1.

FIG. 3 is a front side view of the novel floor fan tower design of FIG. 1.

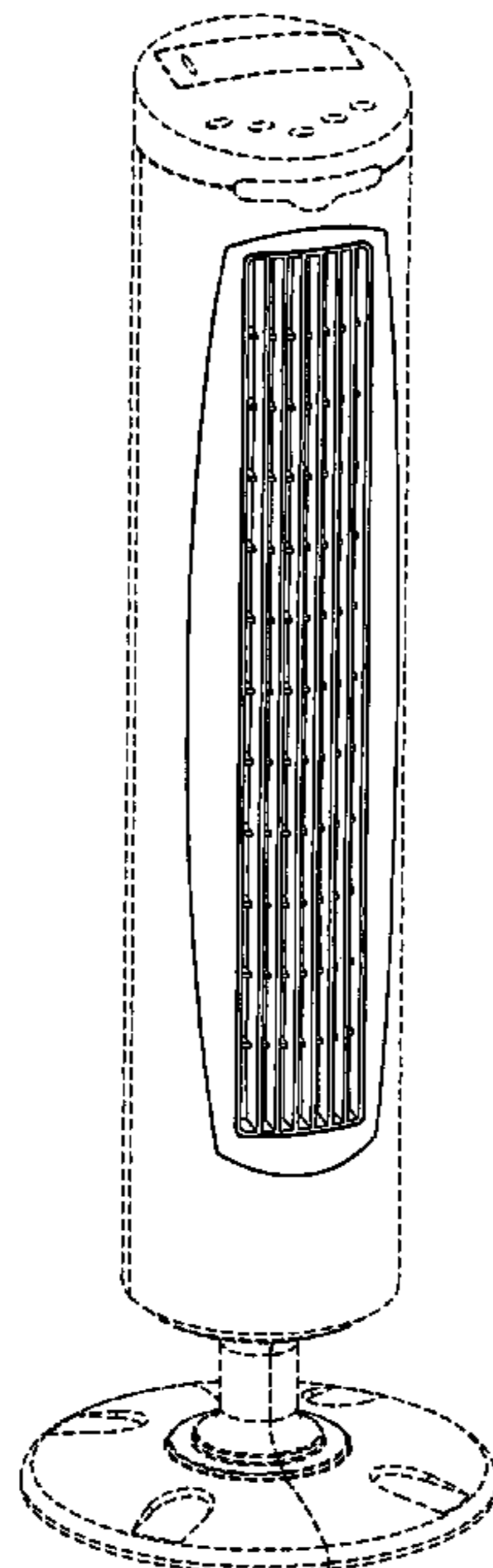
FIG. 4 is a left side view of the novel floor fan tower design of FIG. 1.

FIG. 5 is a right side view of the novel floor fan tower design of FIG. 1; and,

FIG. 6 is an enlarged cross-sectional view of the novel floor fan tower taken along lines 6—6 of FIG. 3.

The broken line showing of the floor fan tower, rear grill, top buttons and bottom stand is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

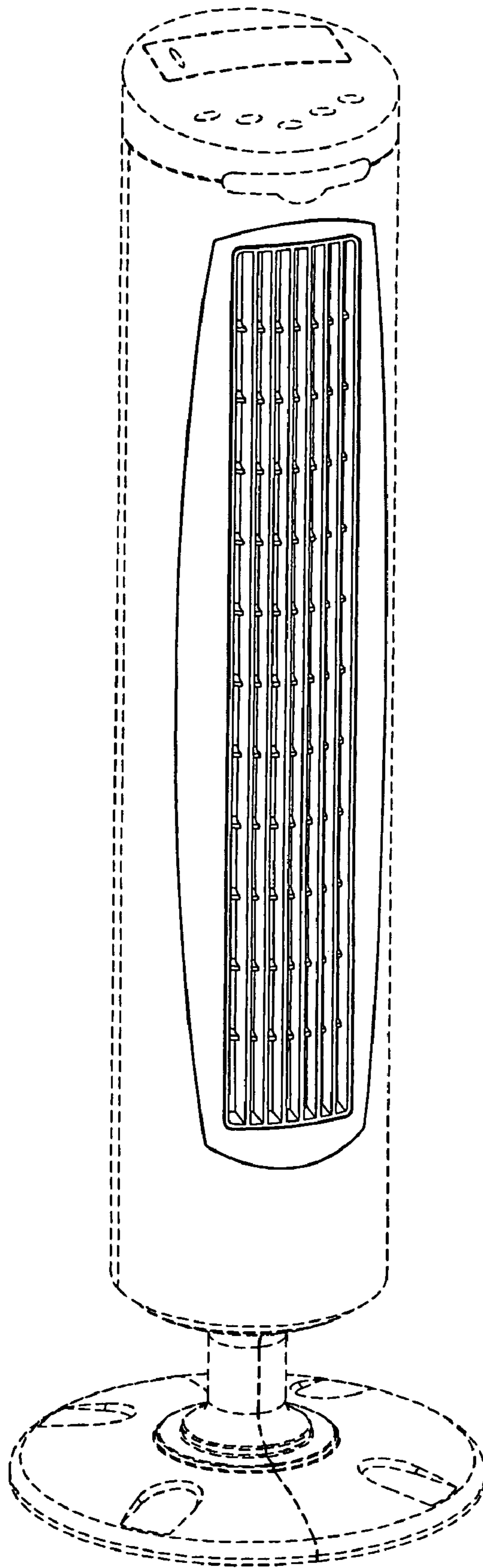

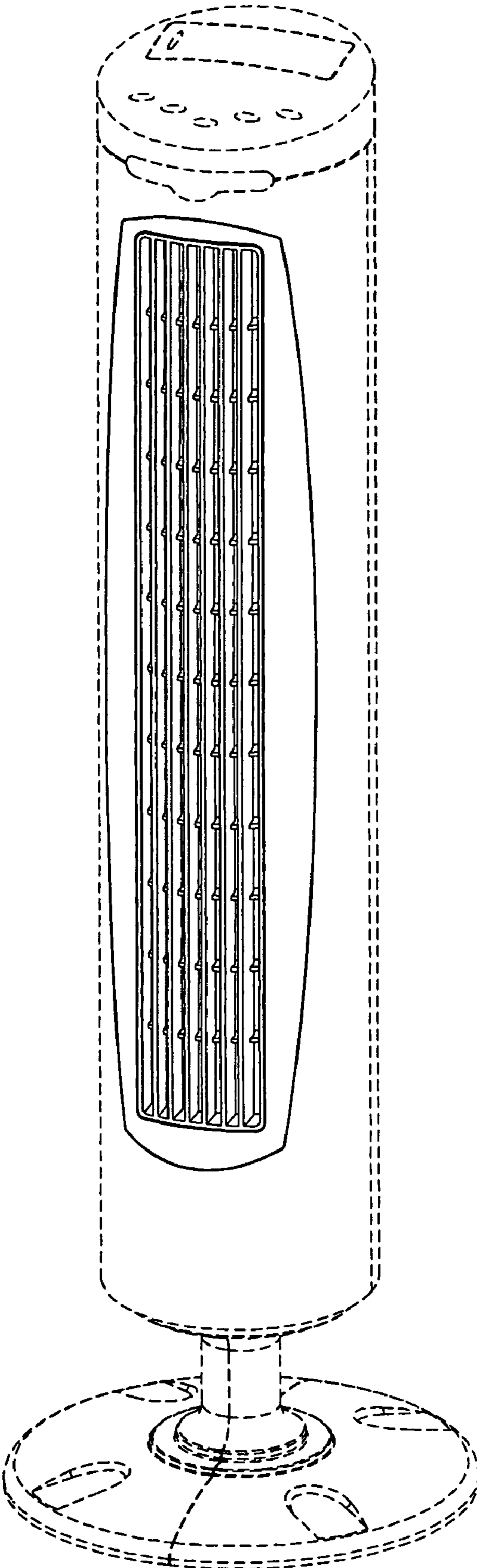

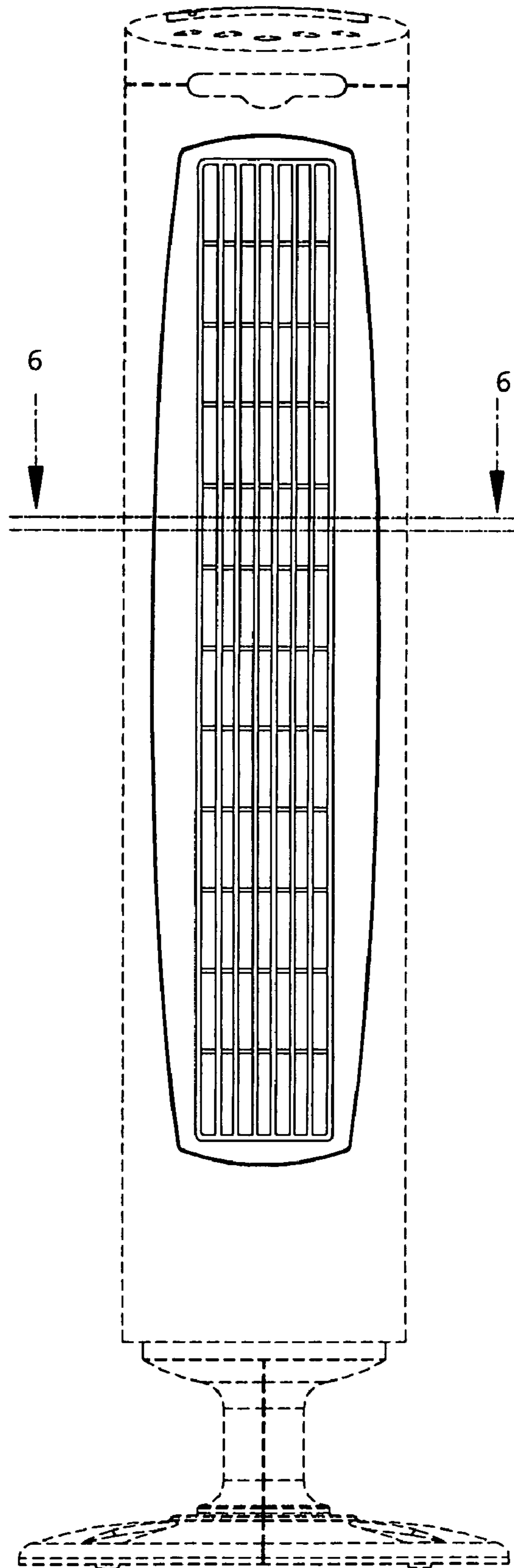

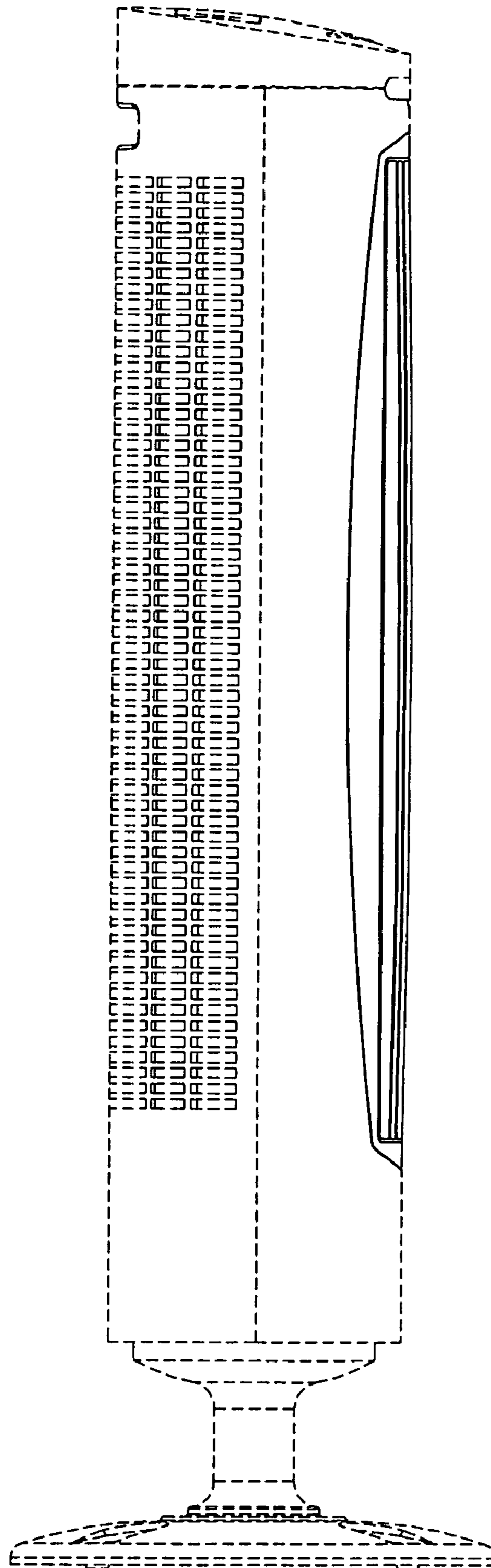

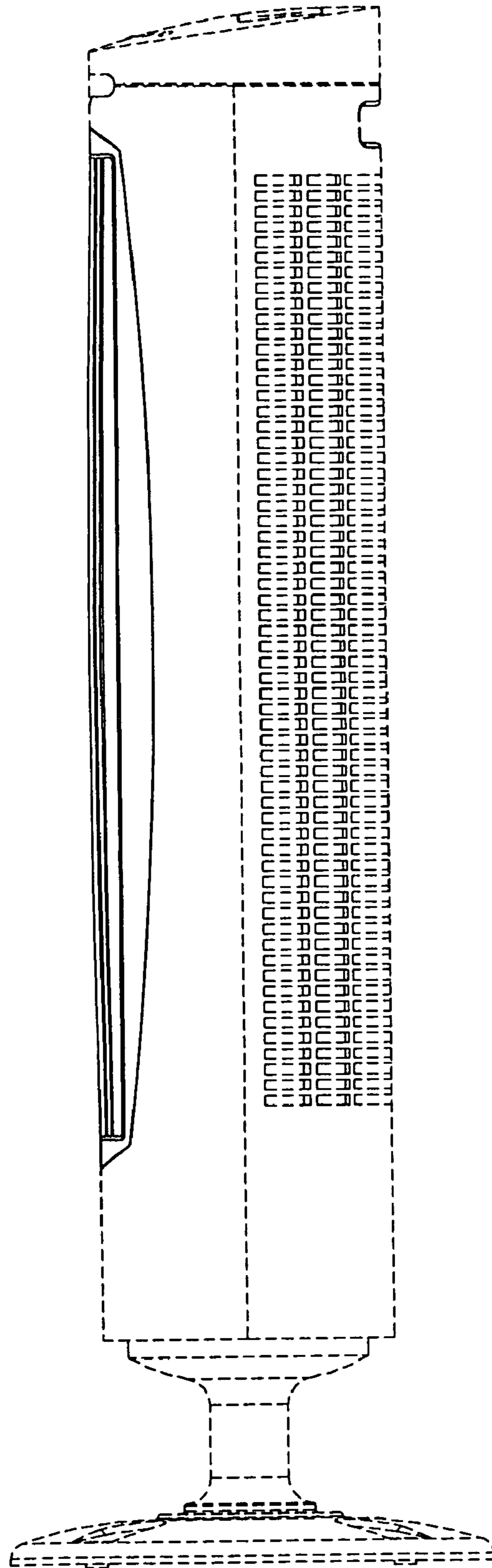

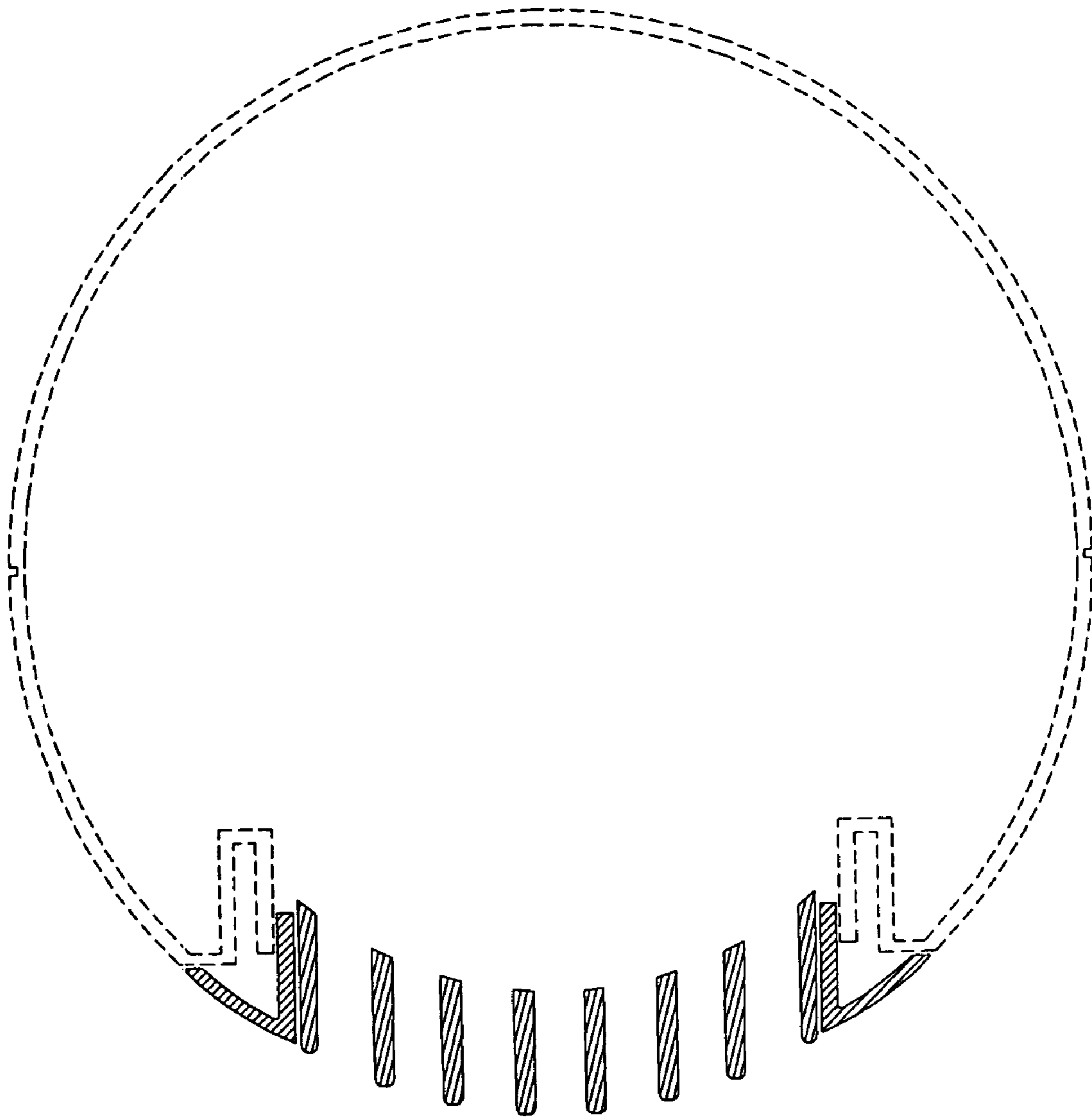
