FIG. 1 is a front elevation view of the hand guard in accordance with my invention;

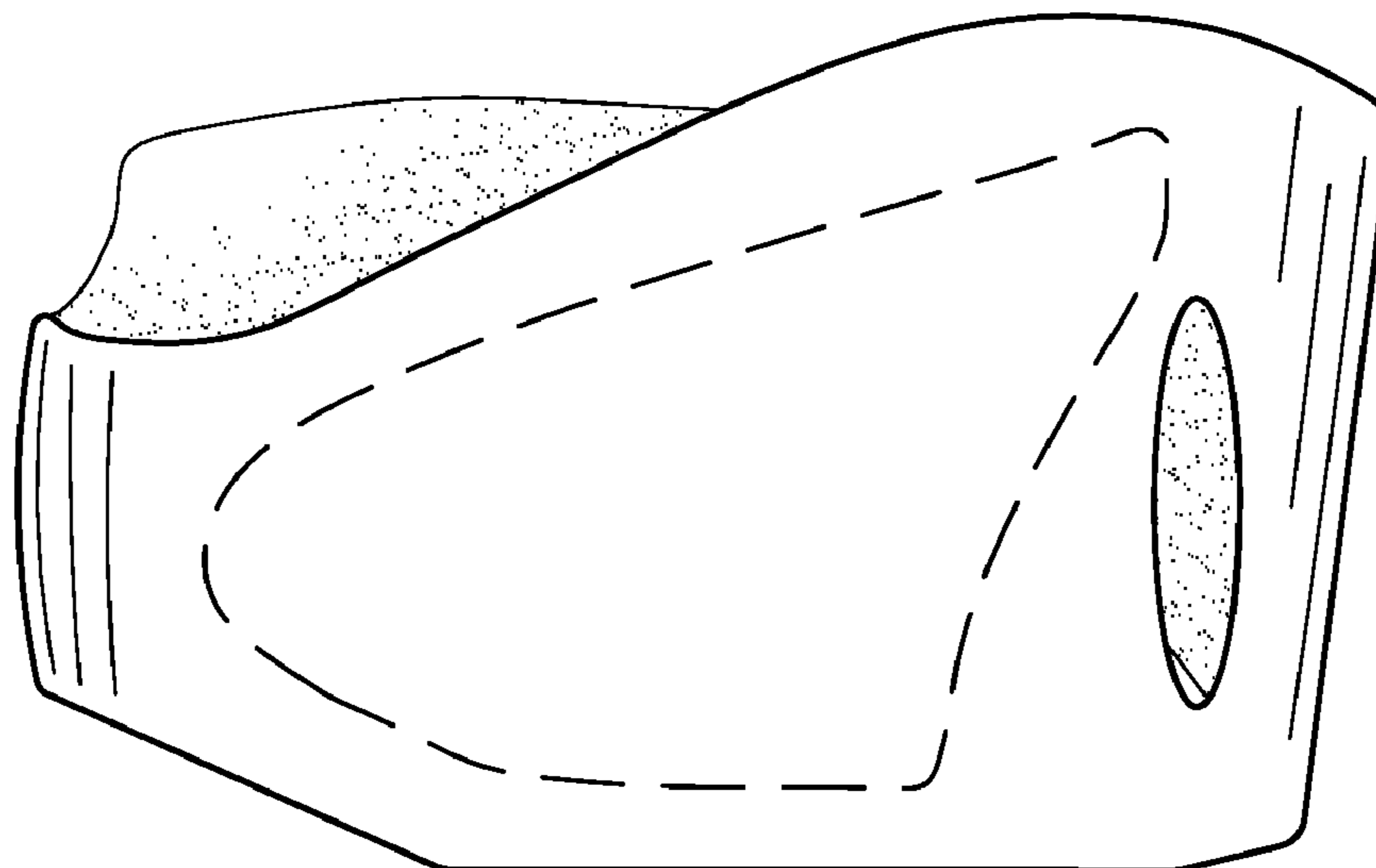
FIG. 2 is a back elevation view of FIG. 1;

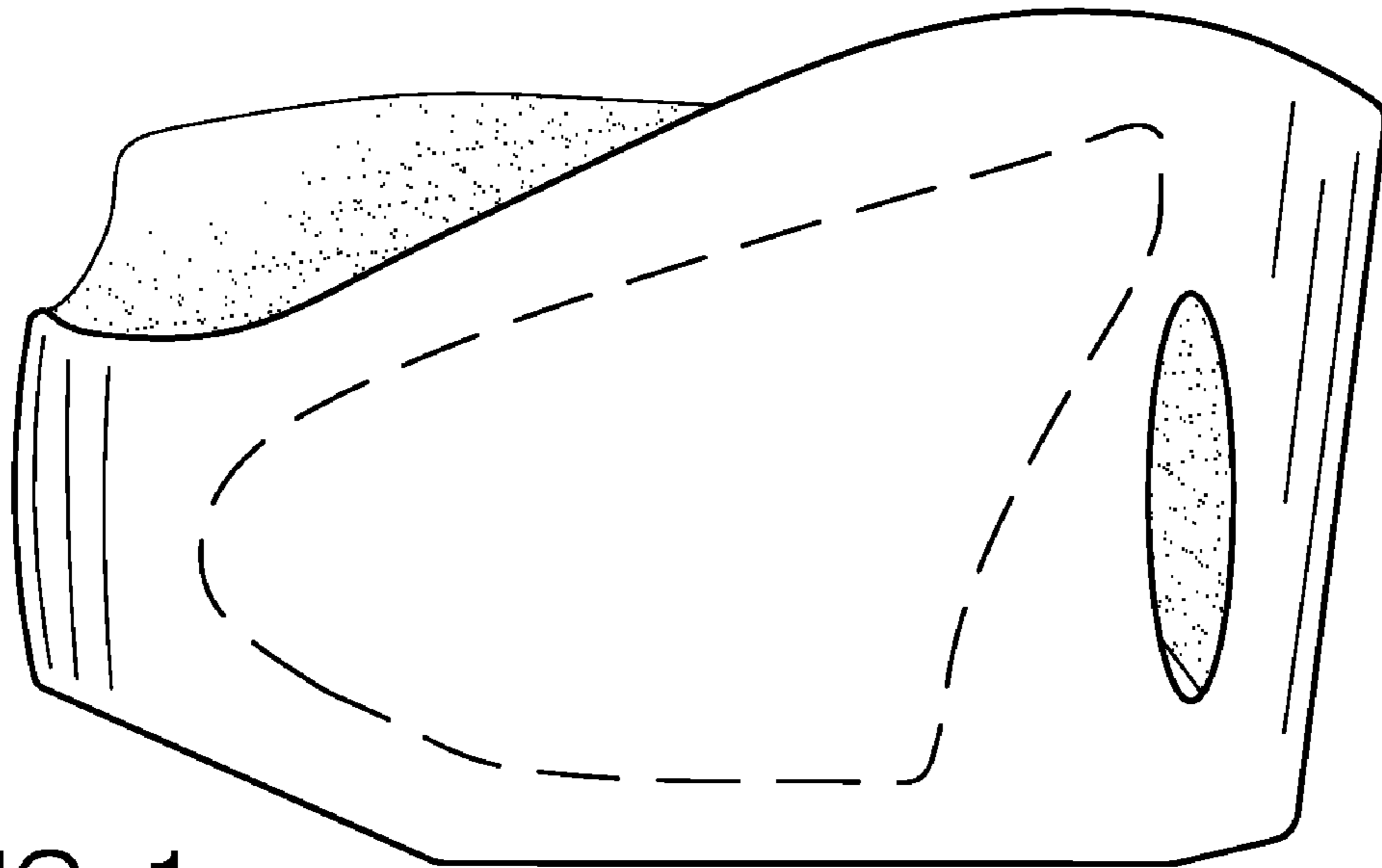

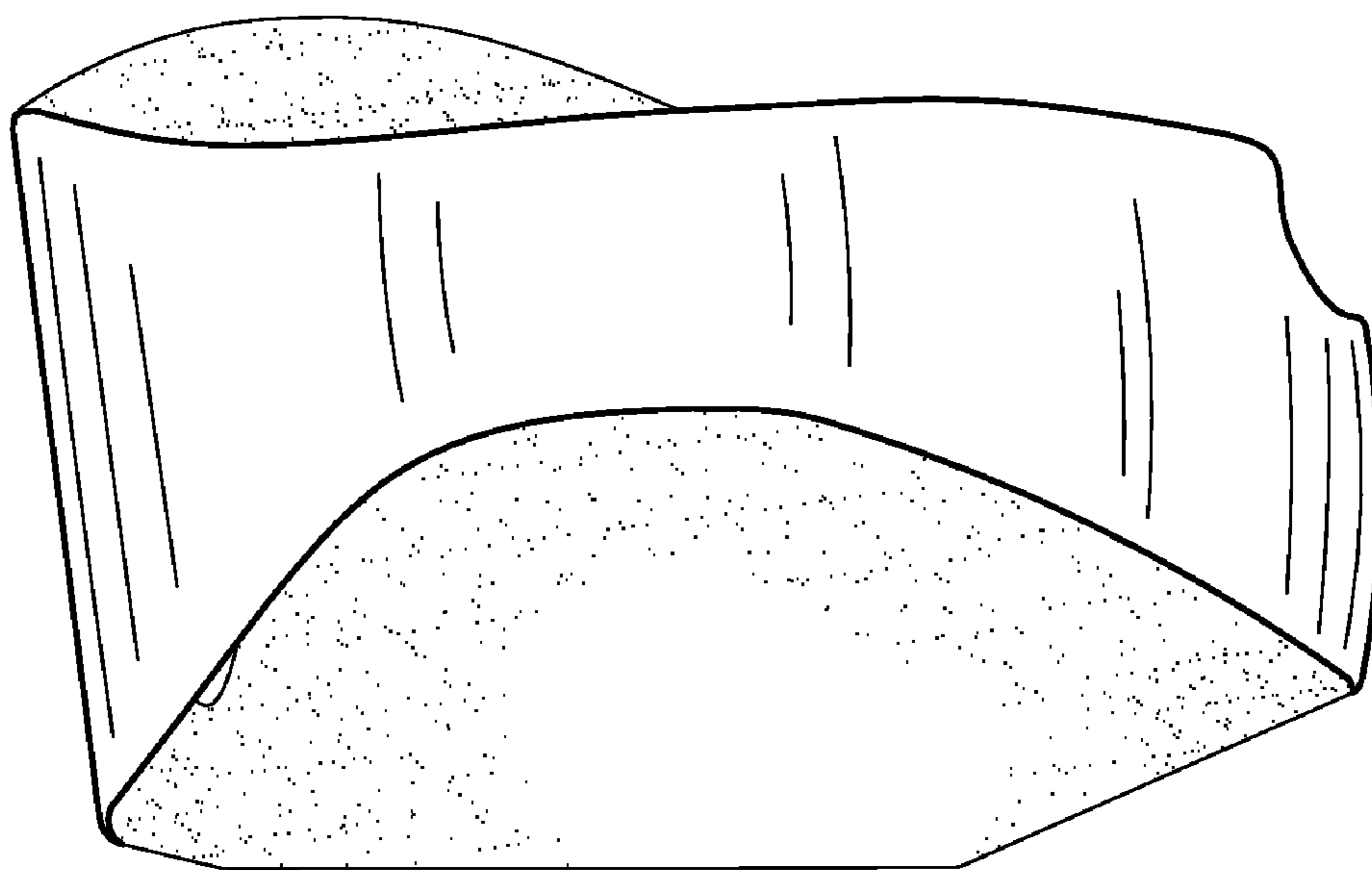

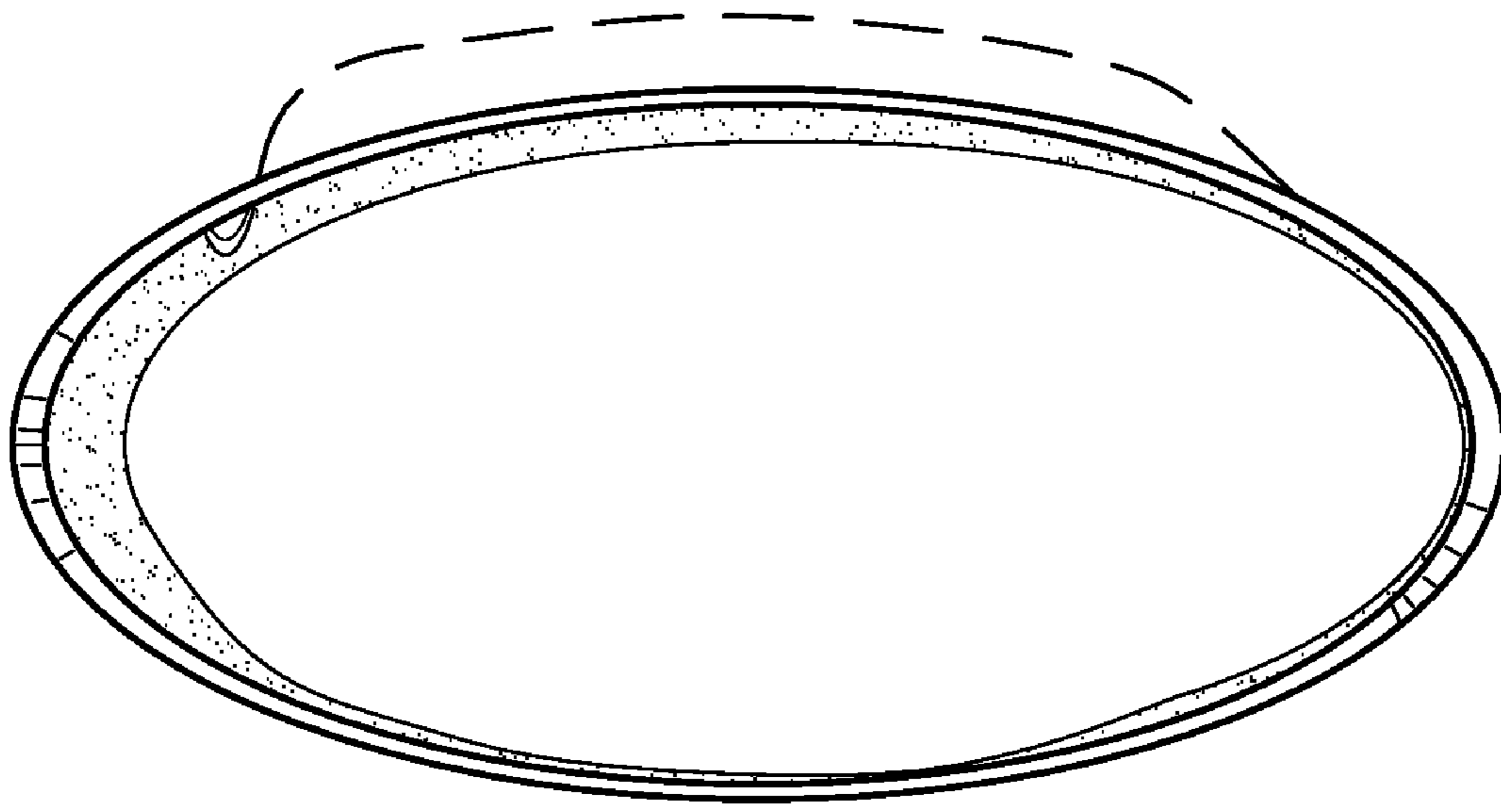

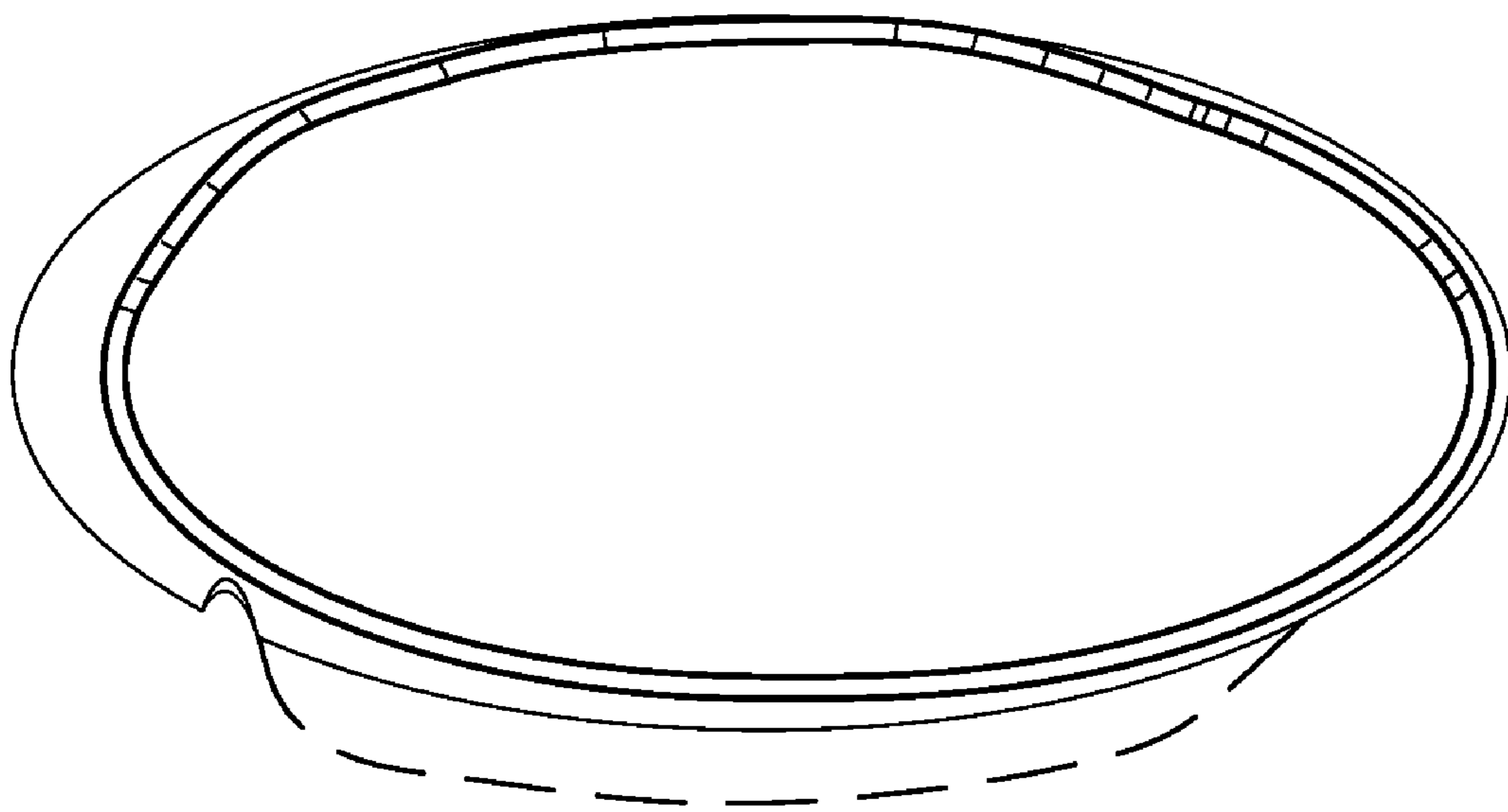
