(57) **CLAIM**

The ornamental design for a pet bed, as shown and described herein.

DESCRIPTION

FIG. 9 is a perspective view of the pillow insert, shown separately for ease of illustration;

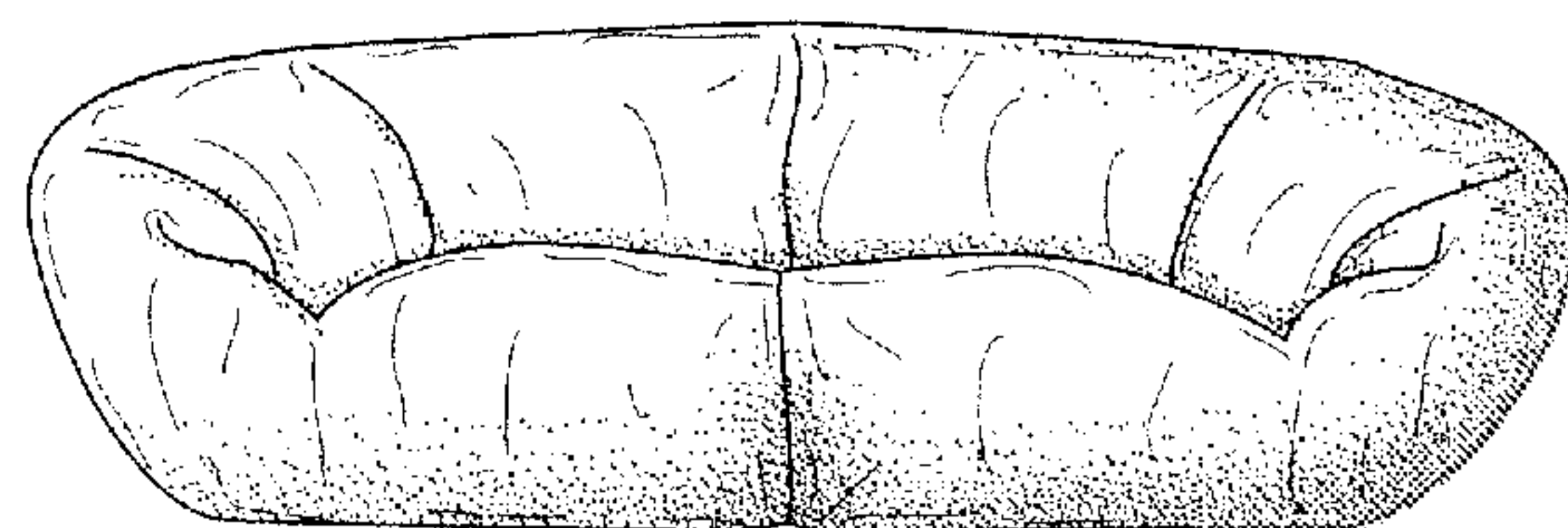
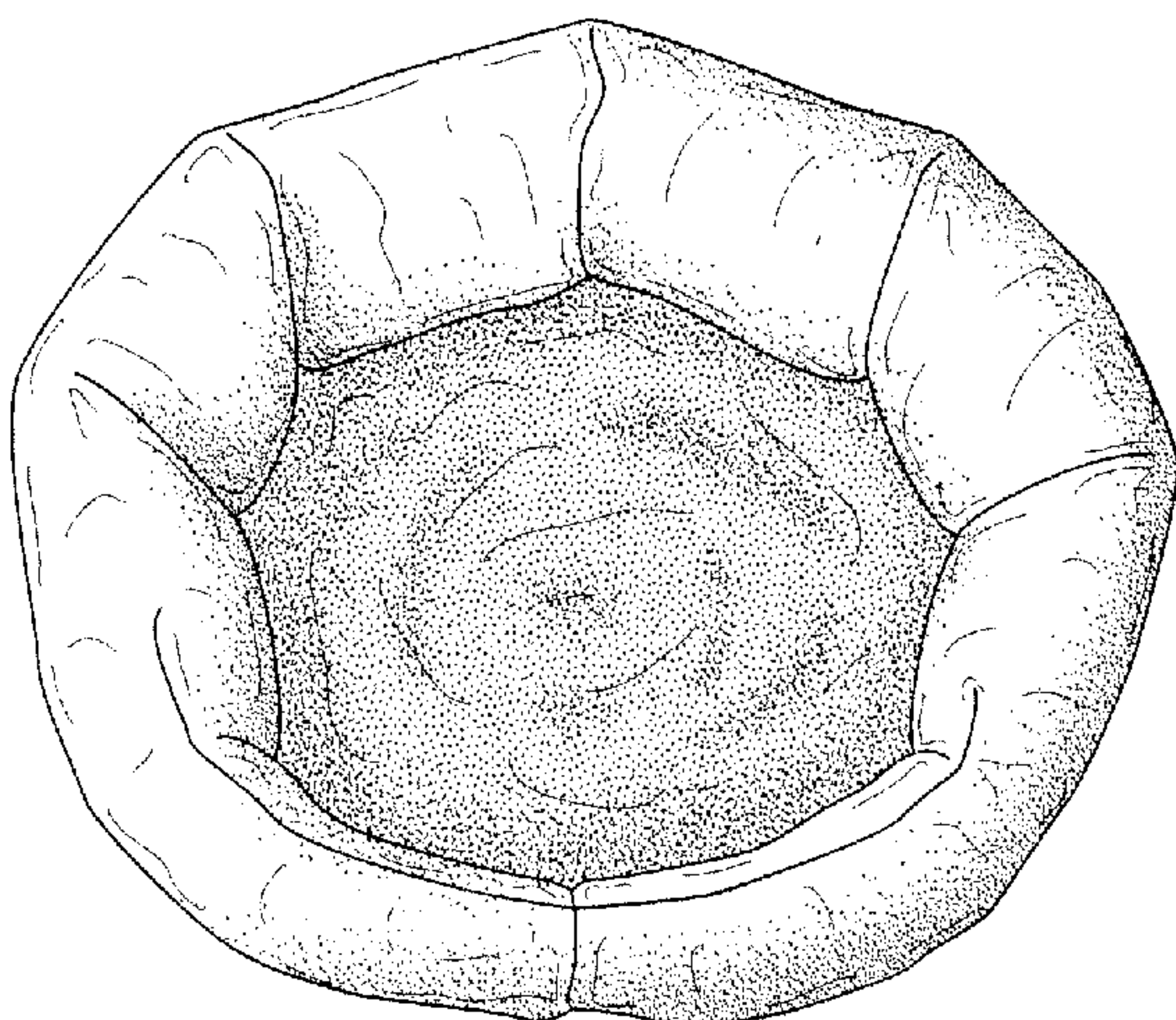
FIG. 10 is a left side view of FIG. 9;

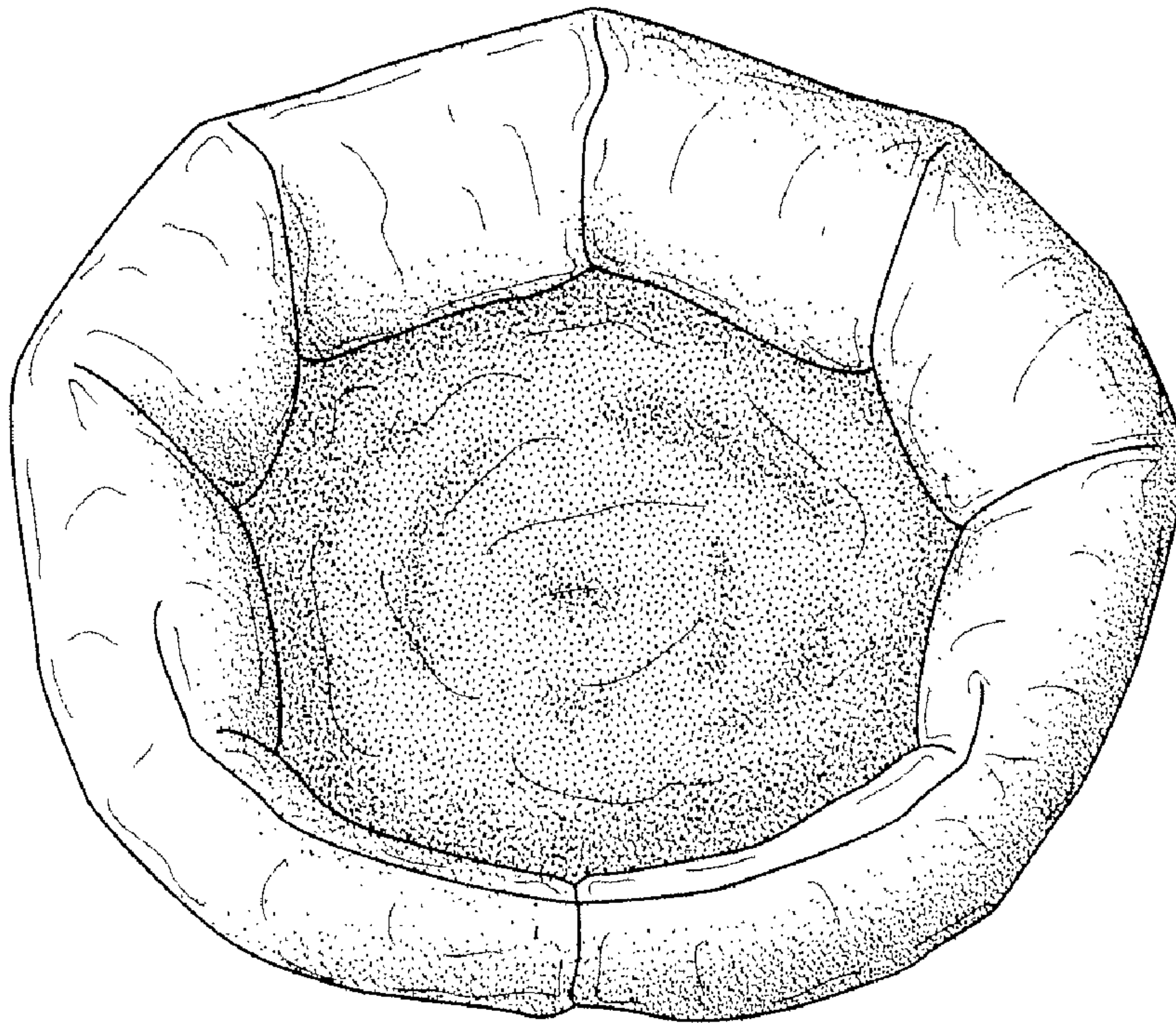

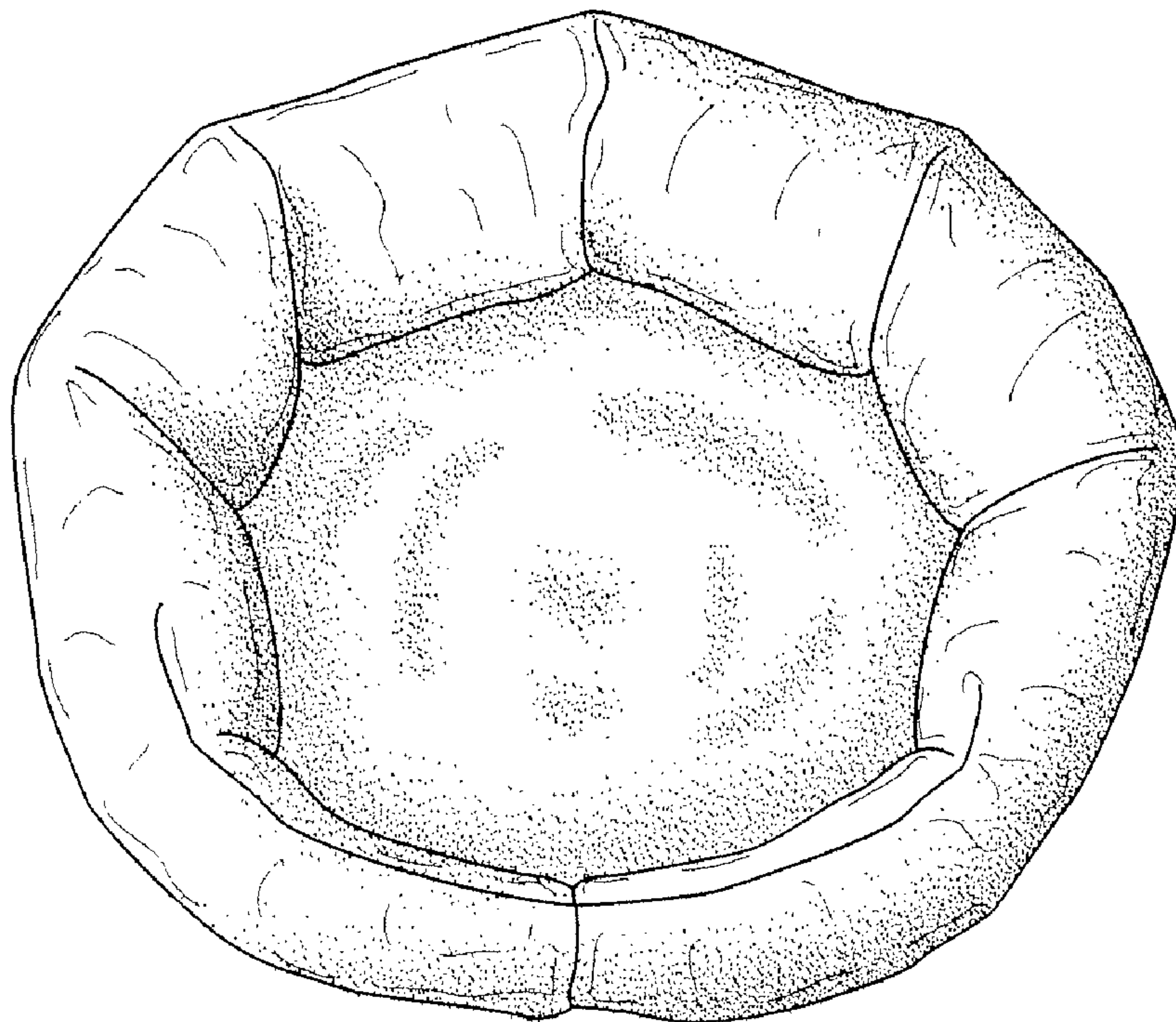

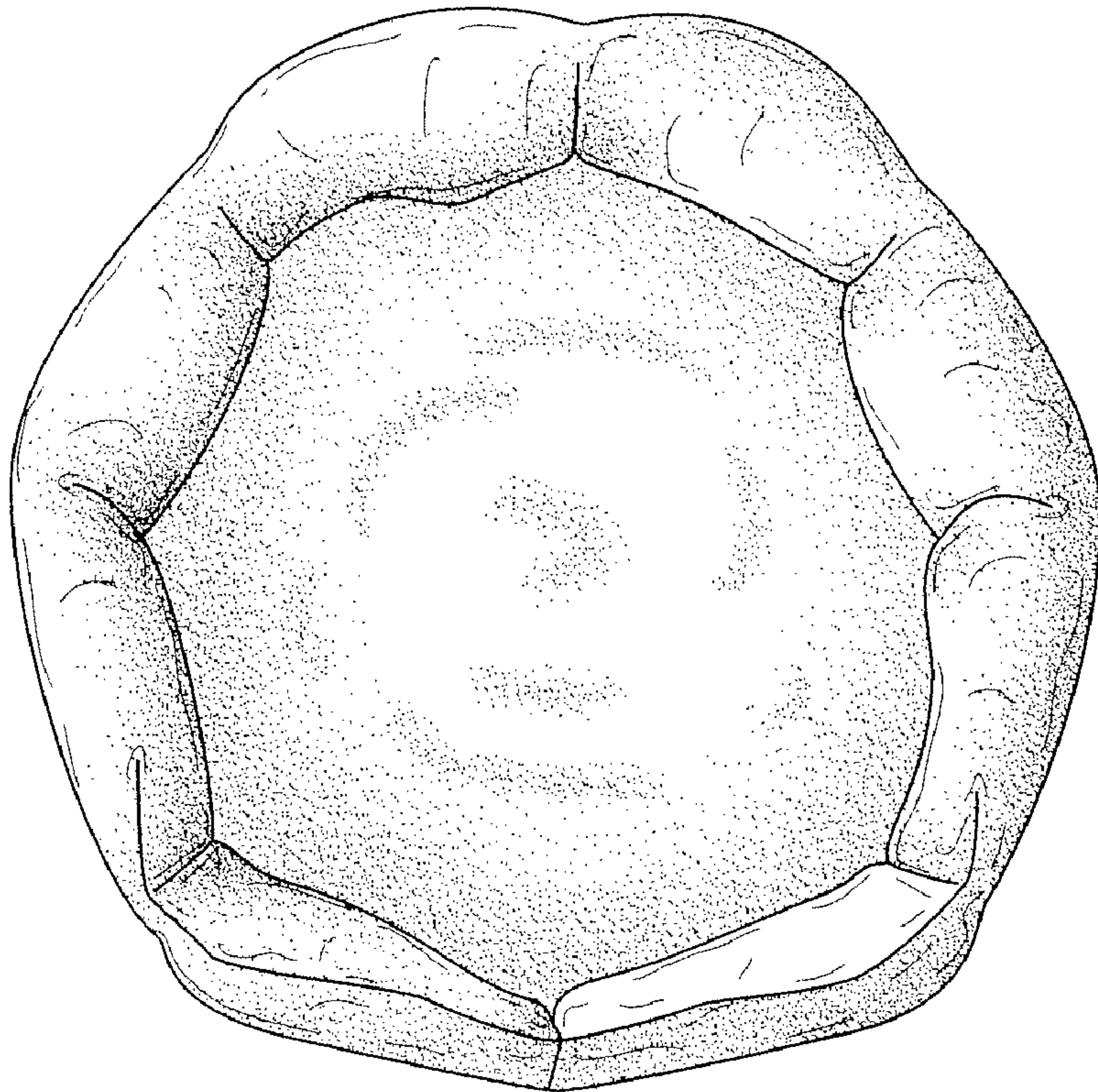

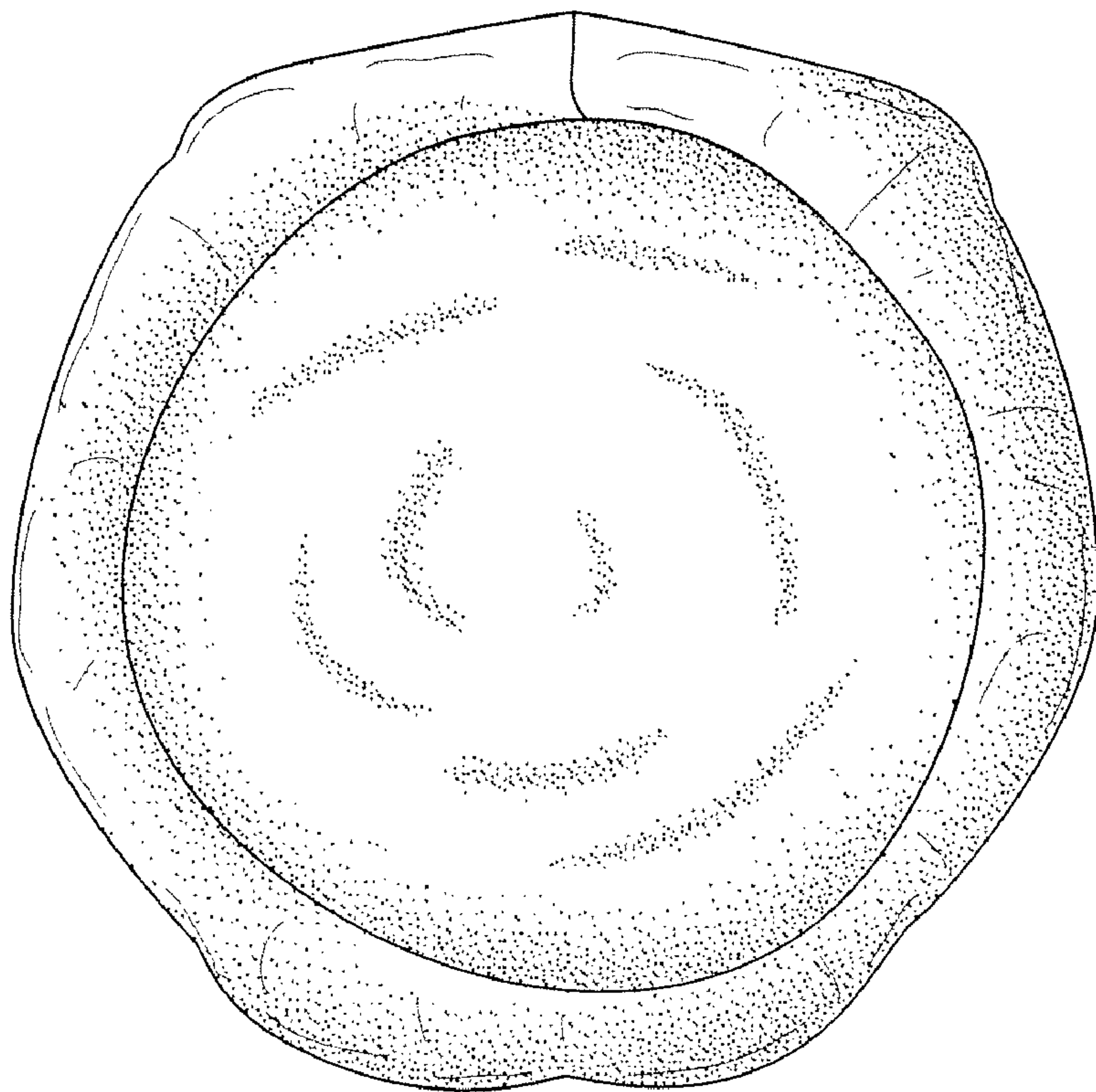

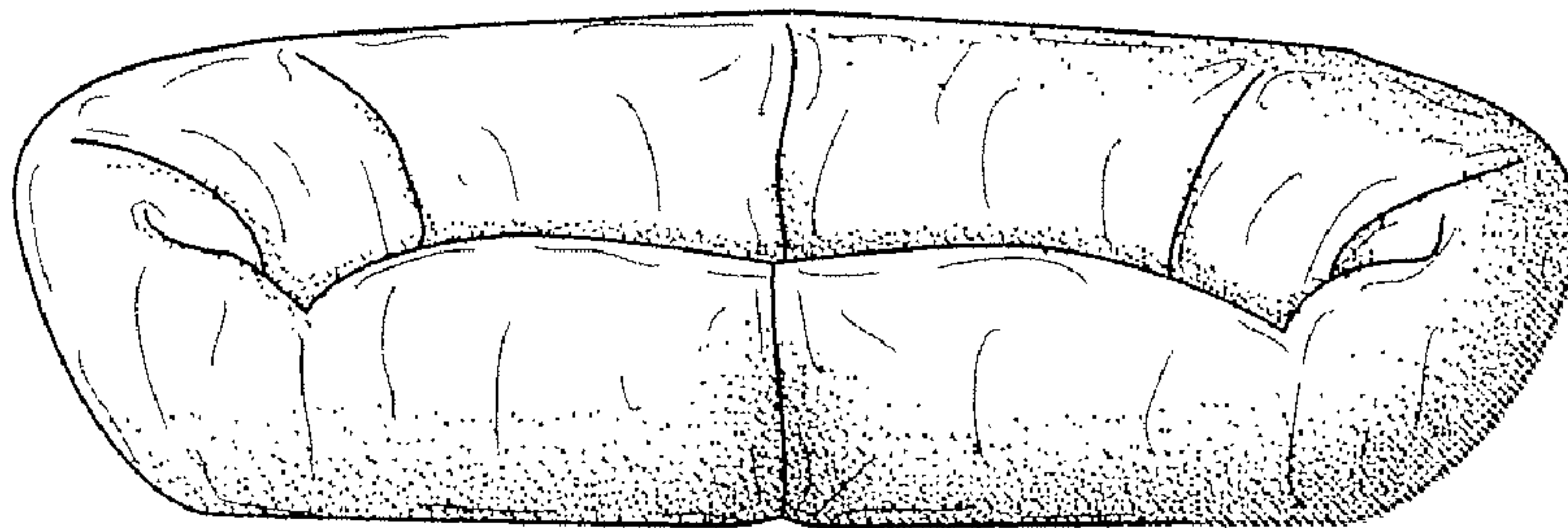

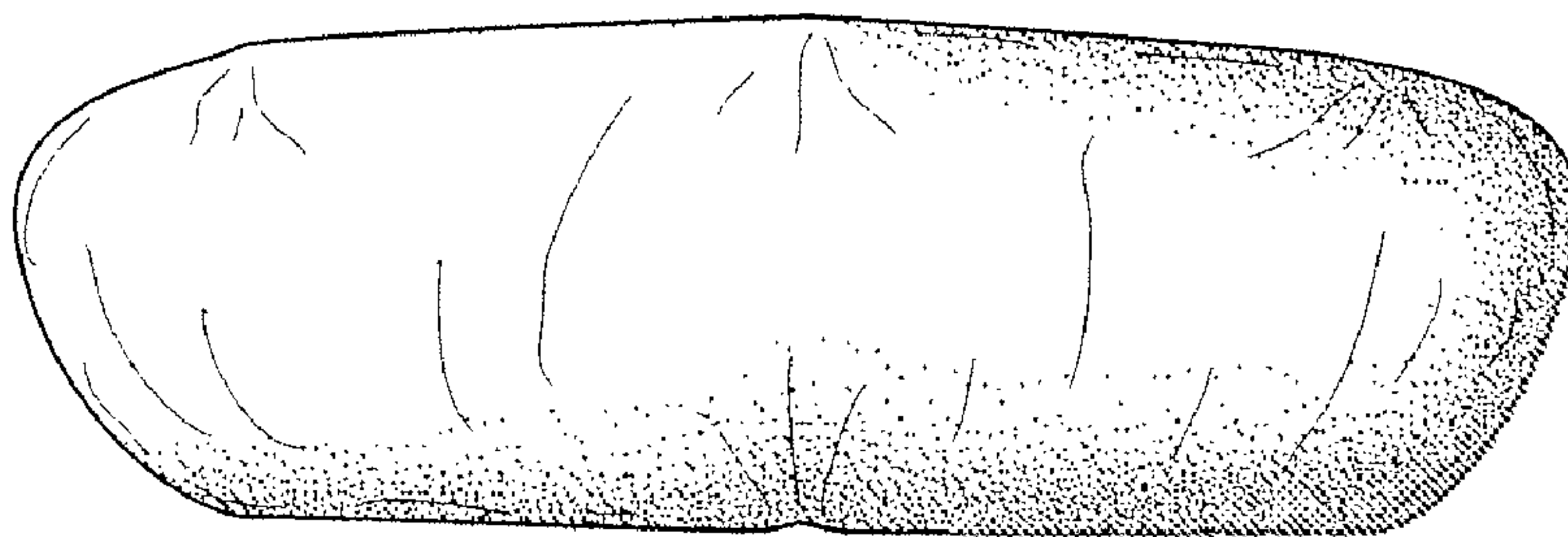

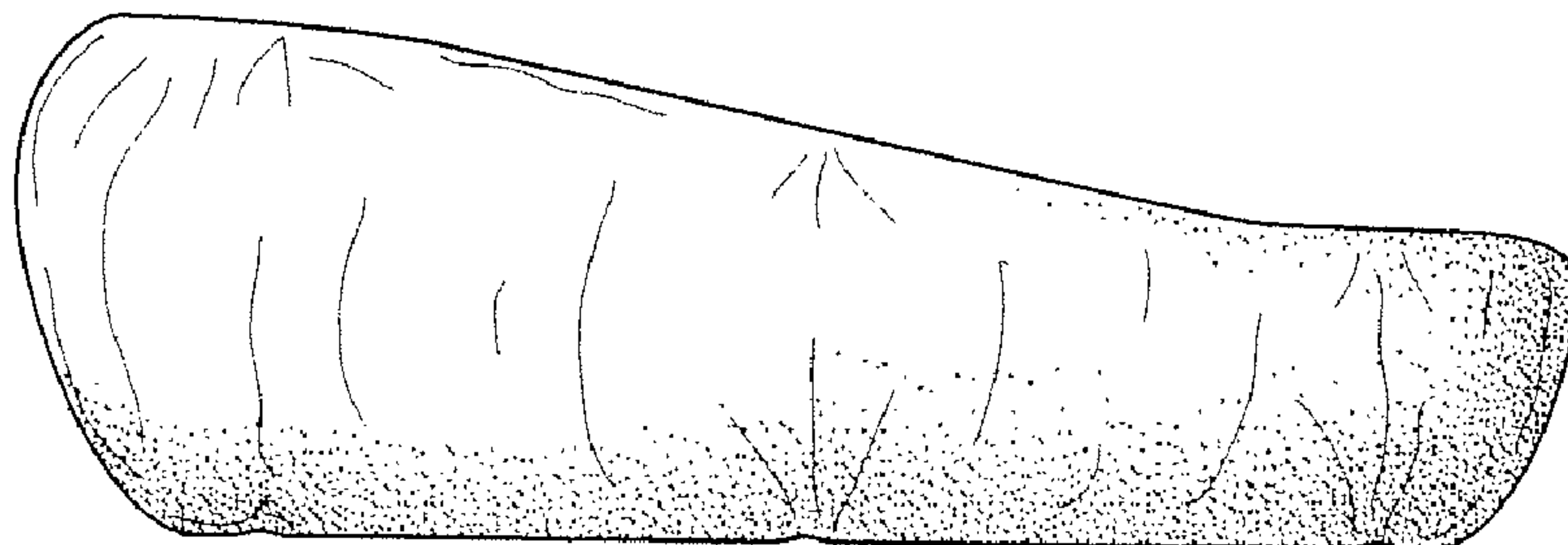

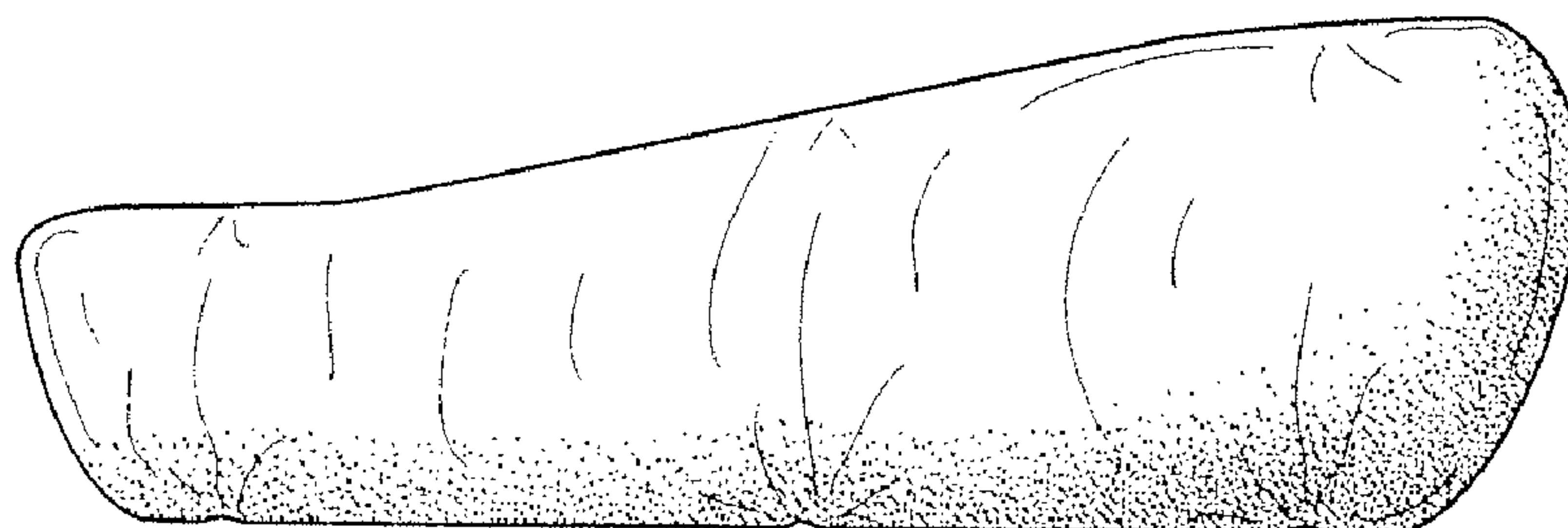

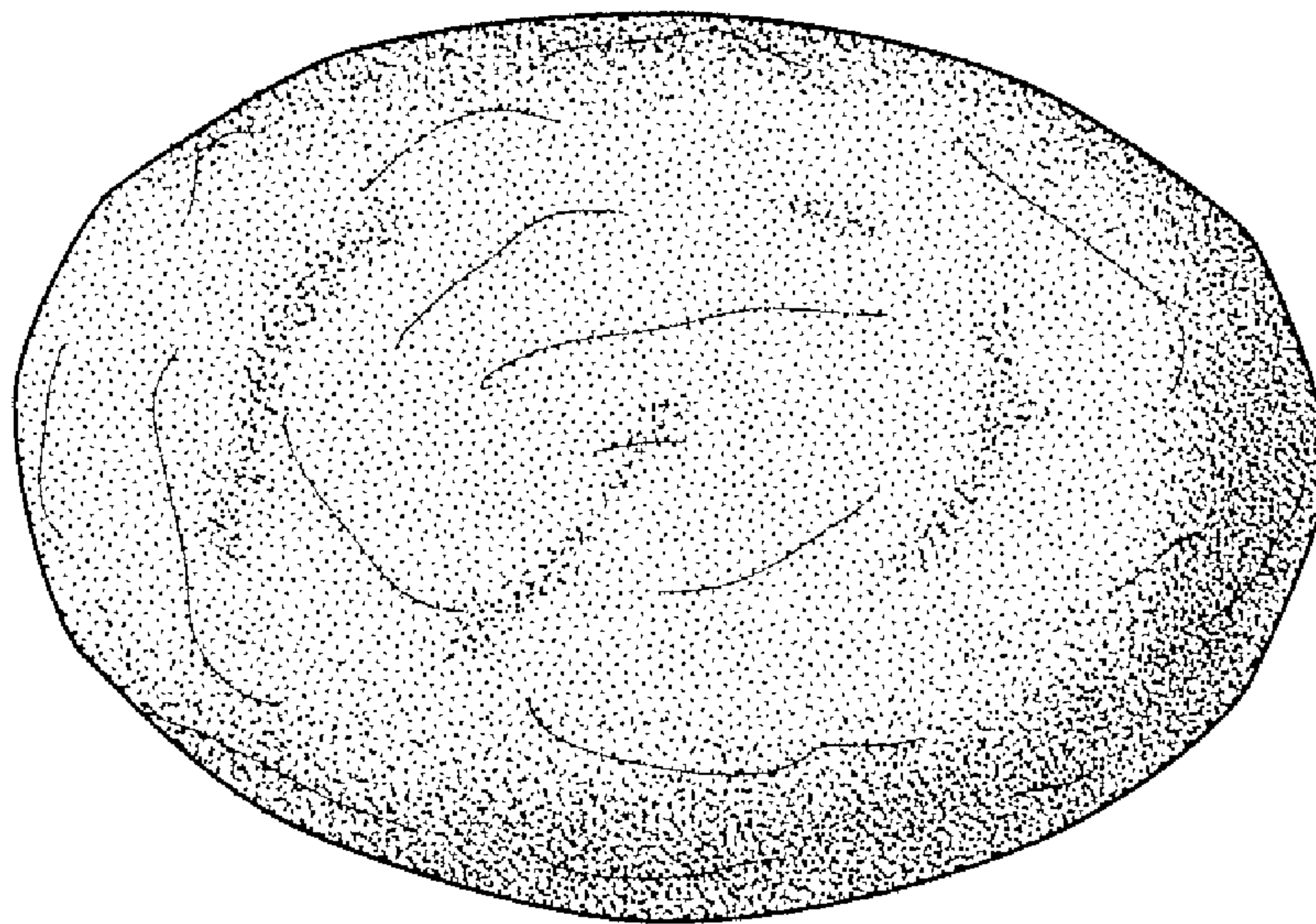

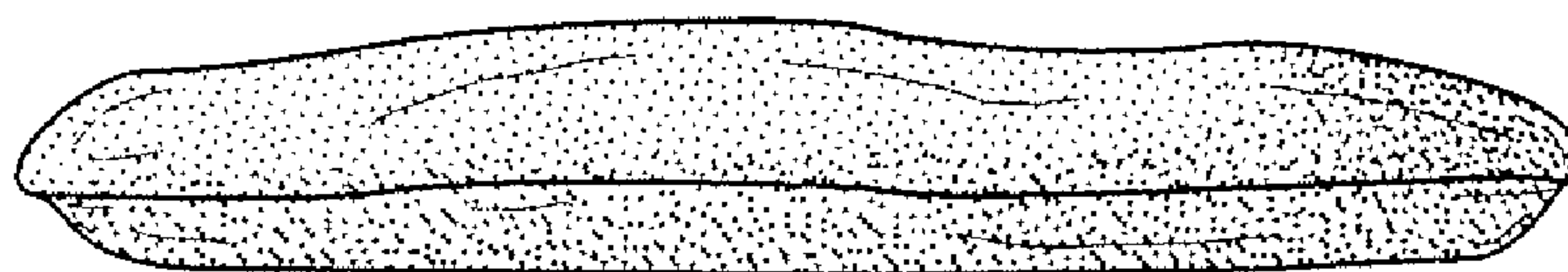

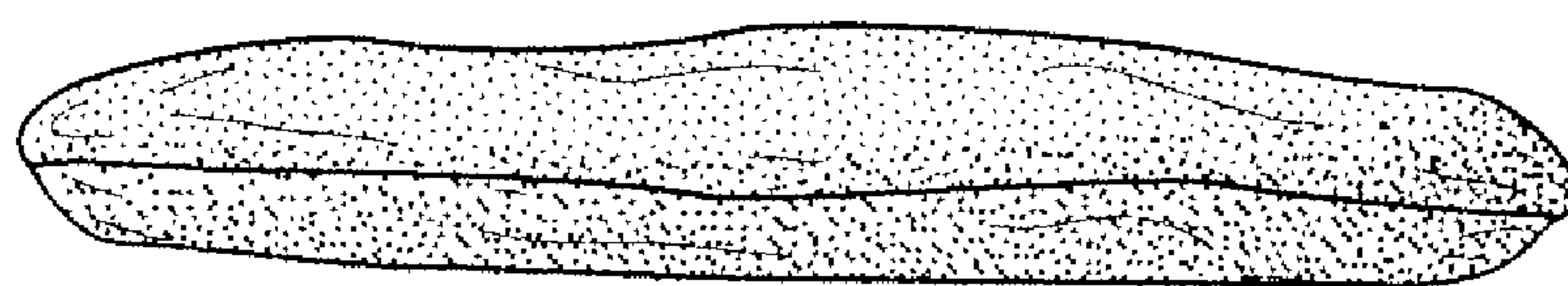

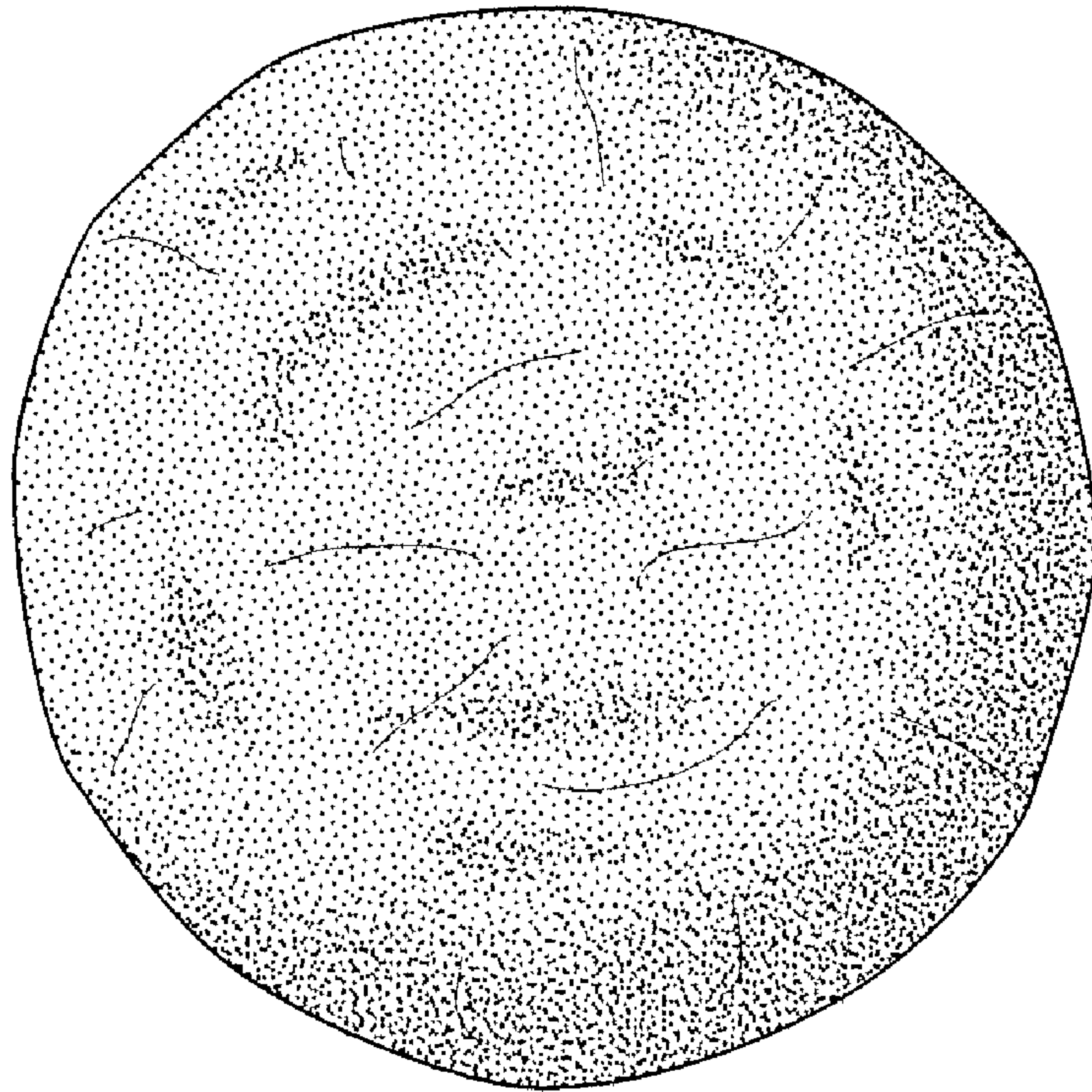

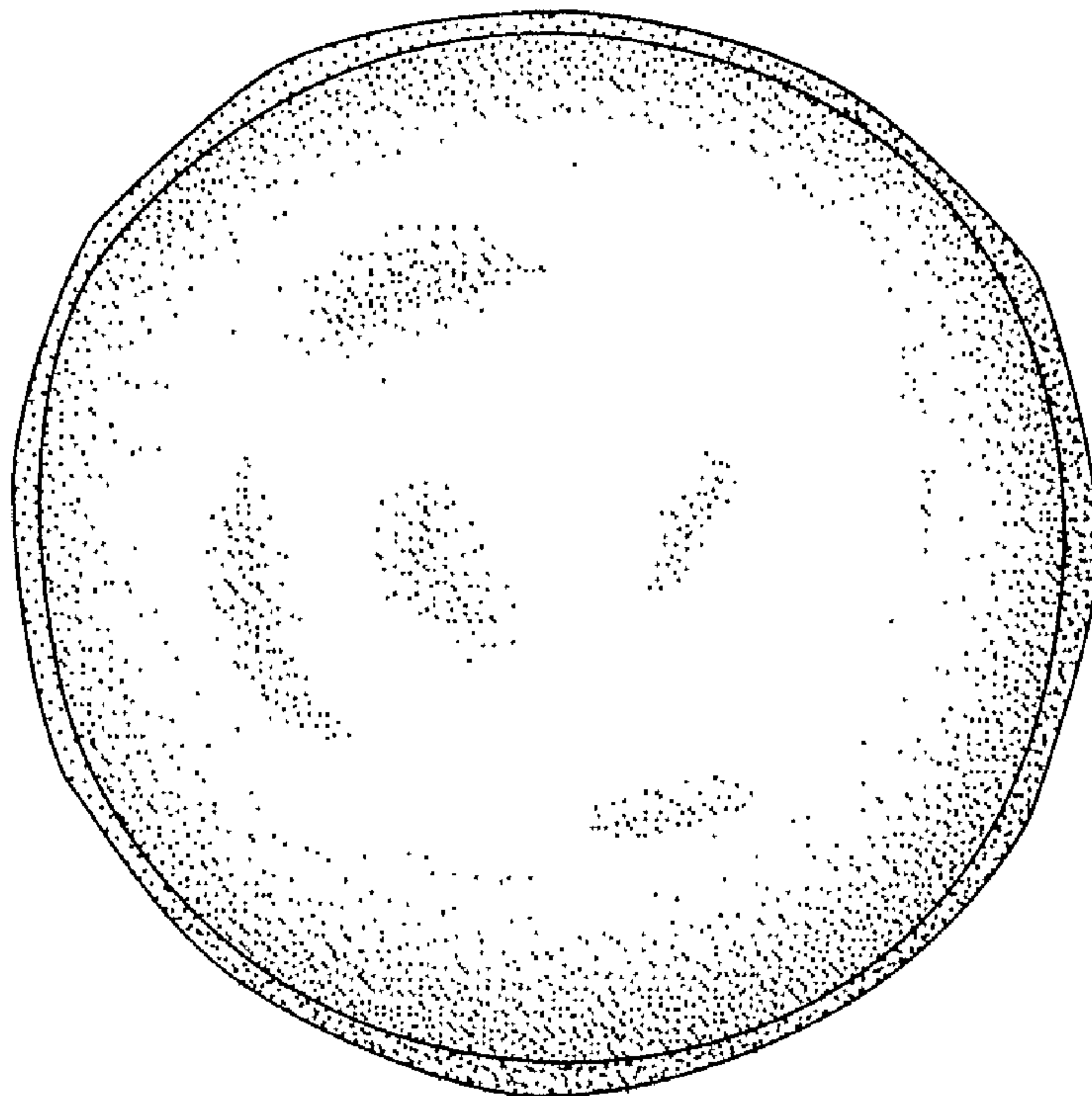
