The ornamental design for furniture, as shown and described.

**DESCRIPTION**

FIG. 2 is a top view thereof;

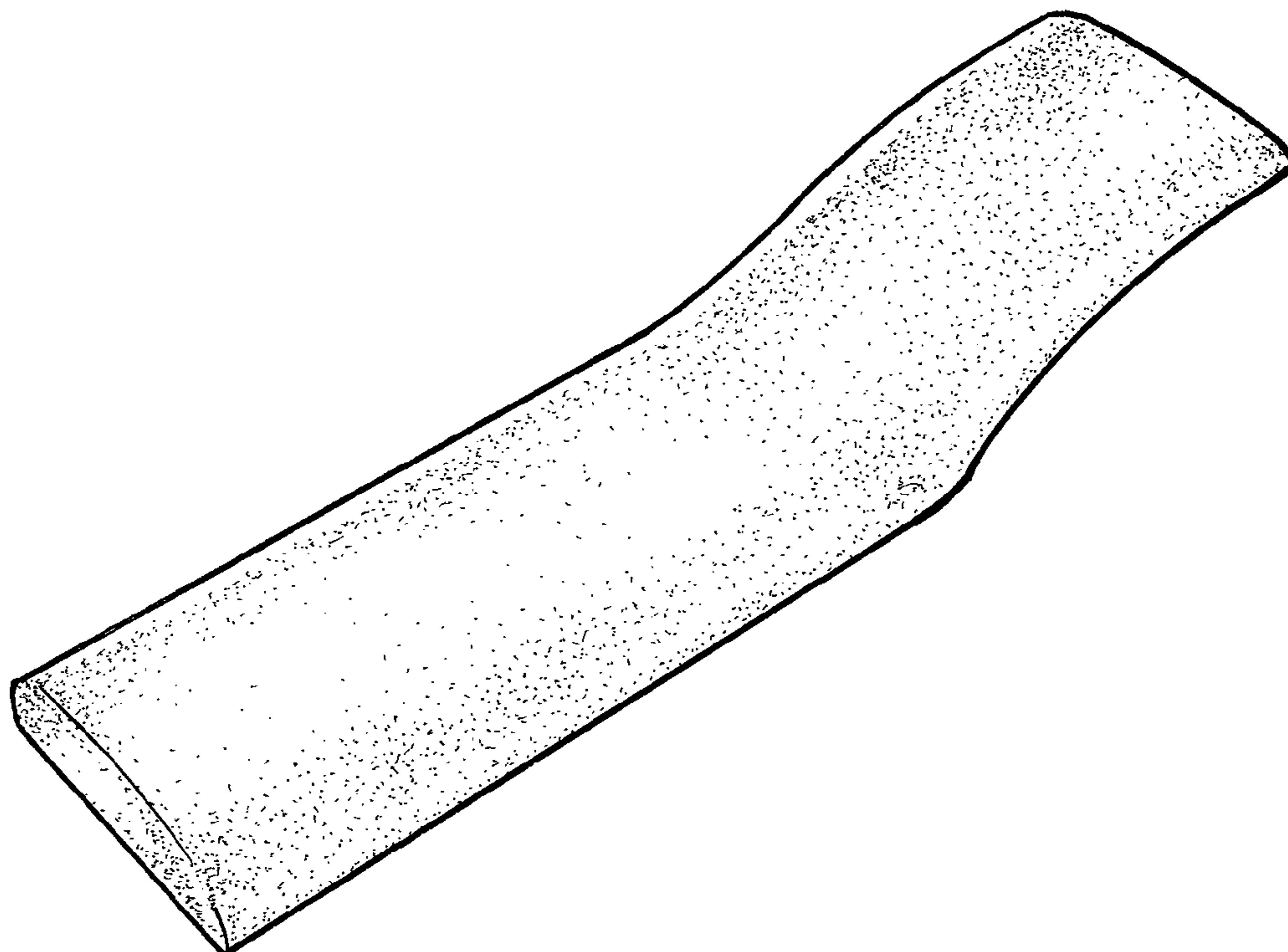
FIG. 3 is a front view thereof;

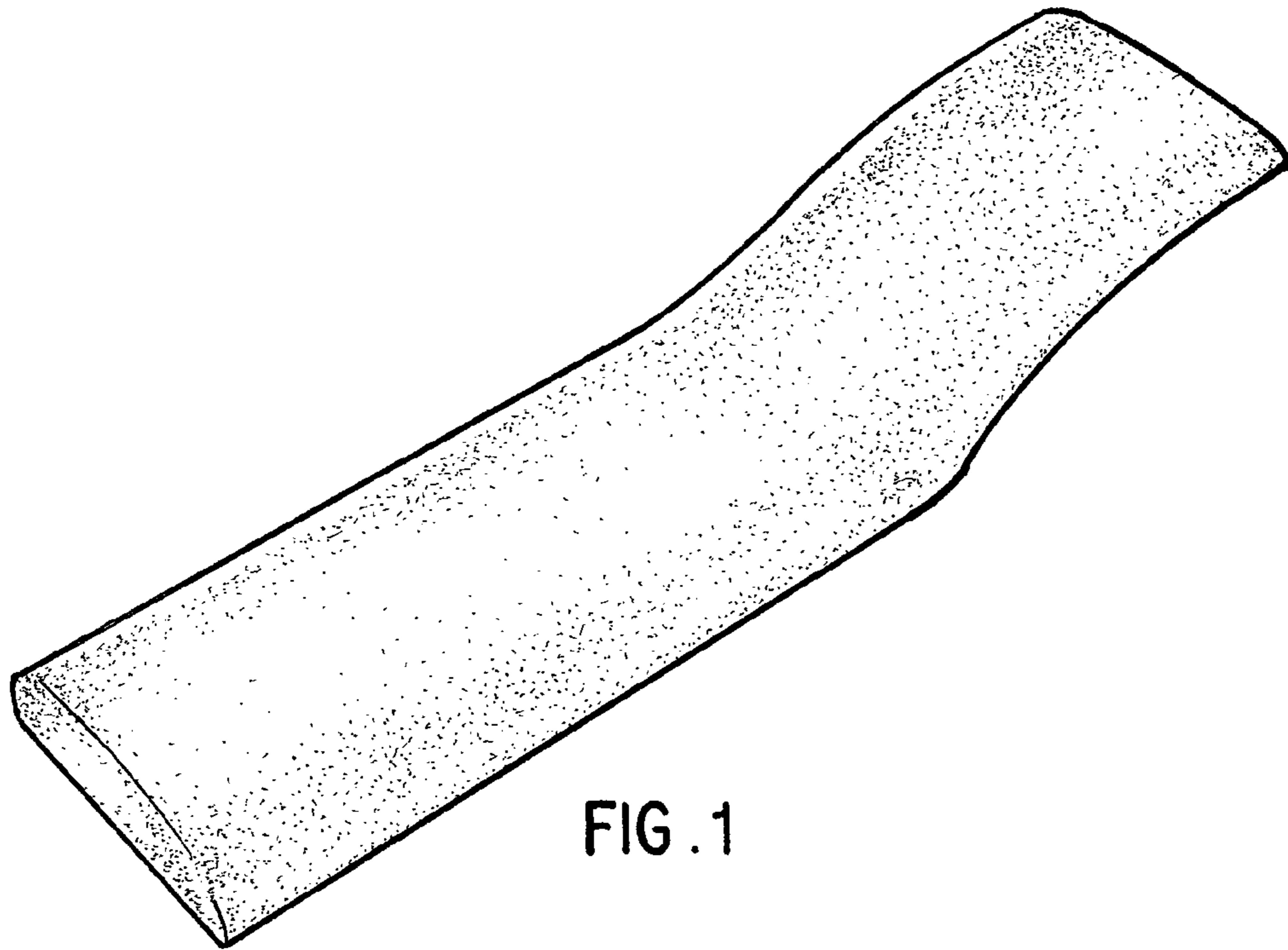

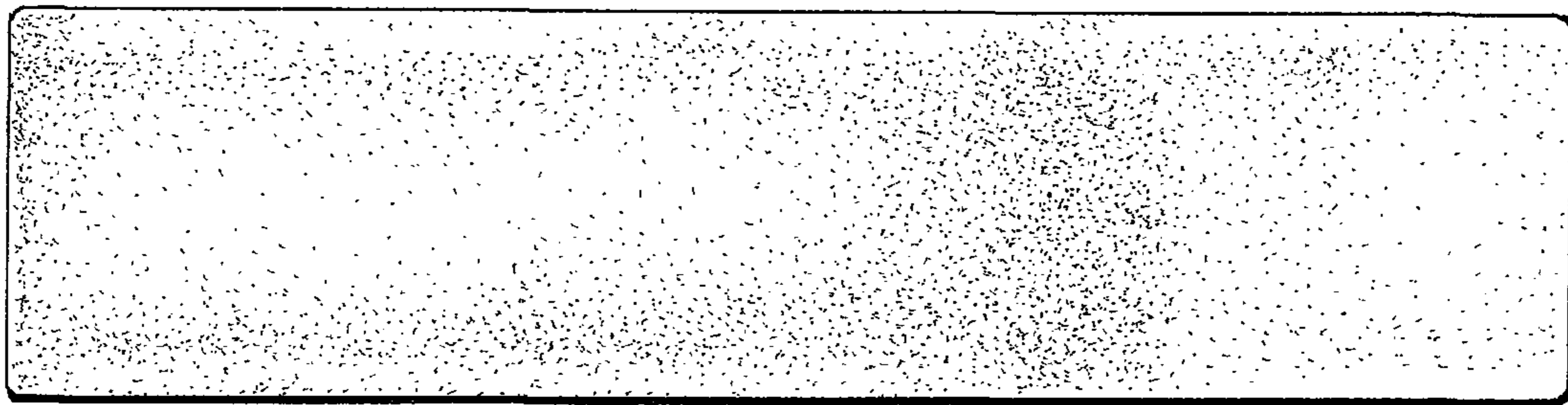

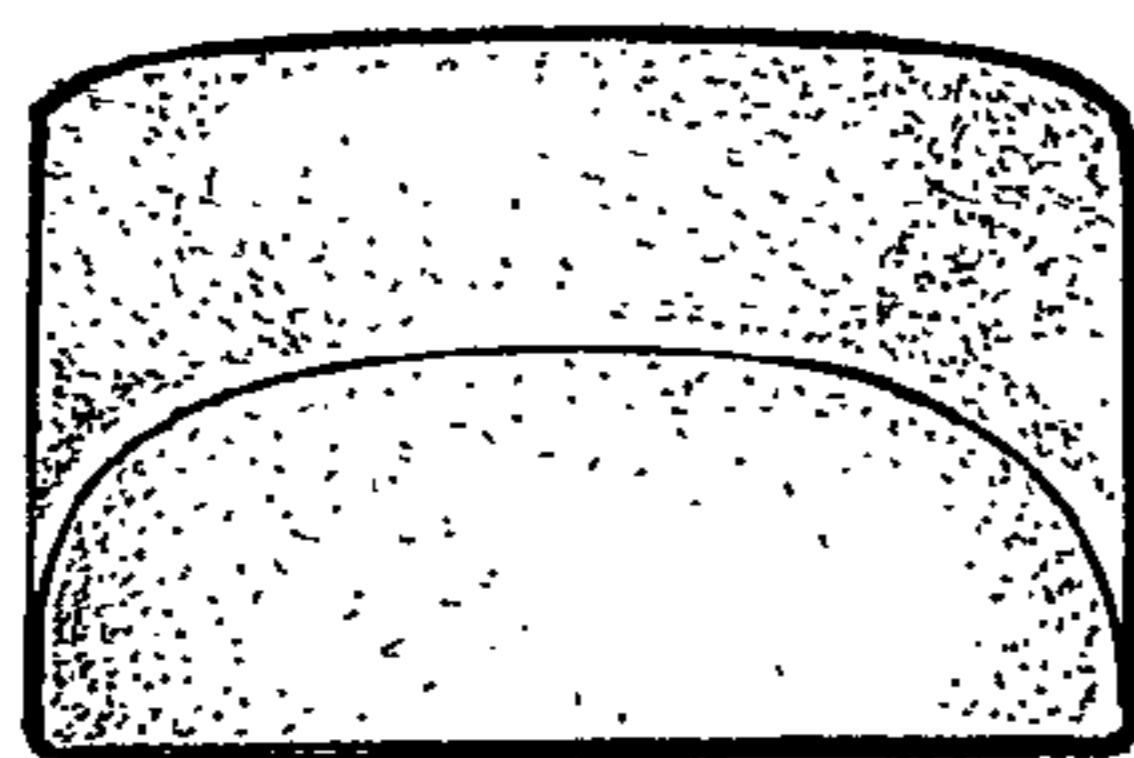

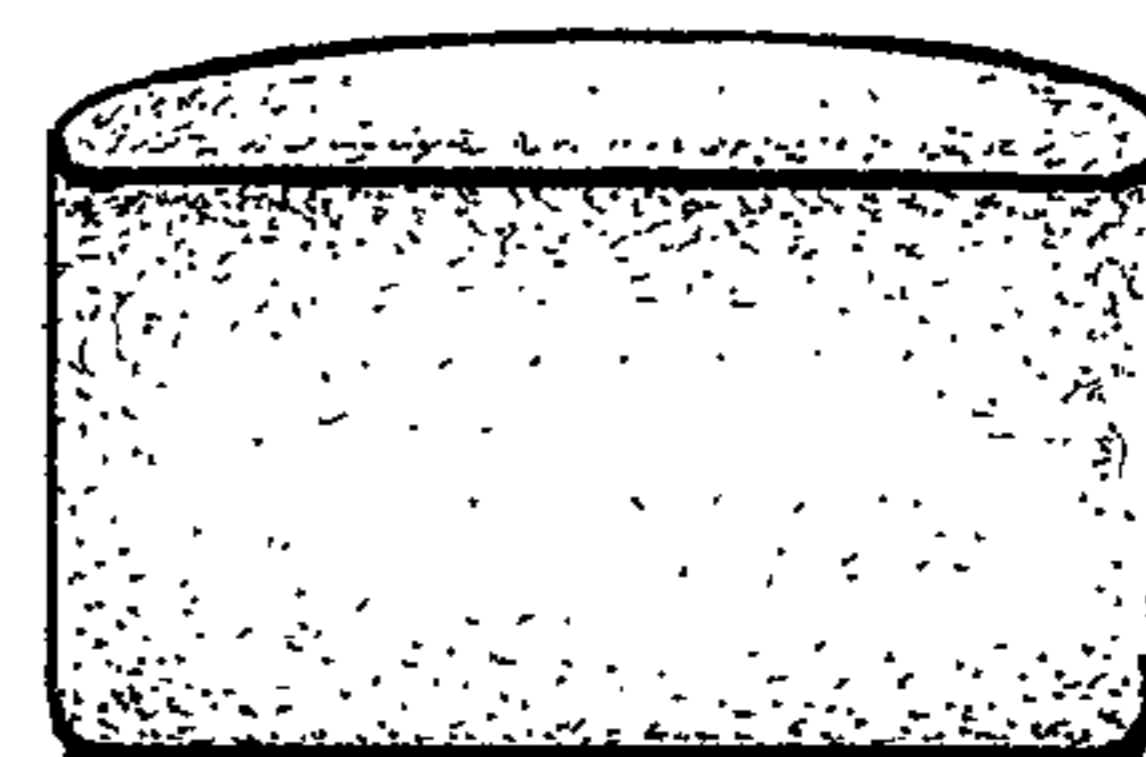

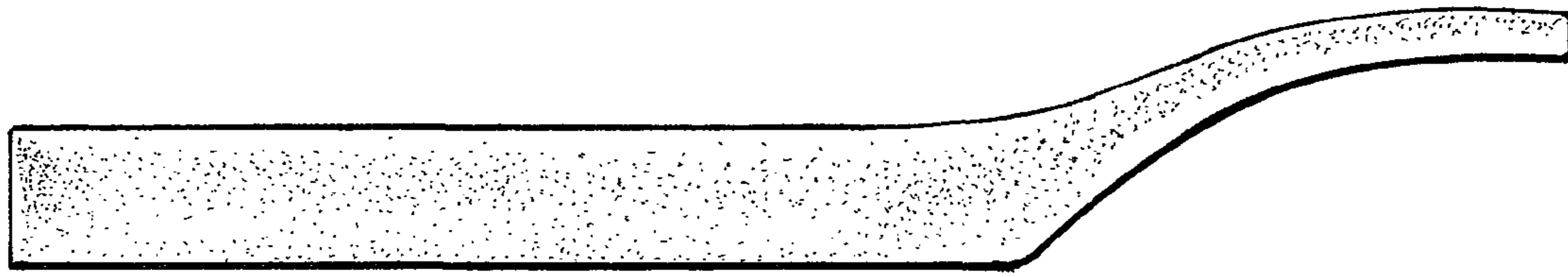

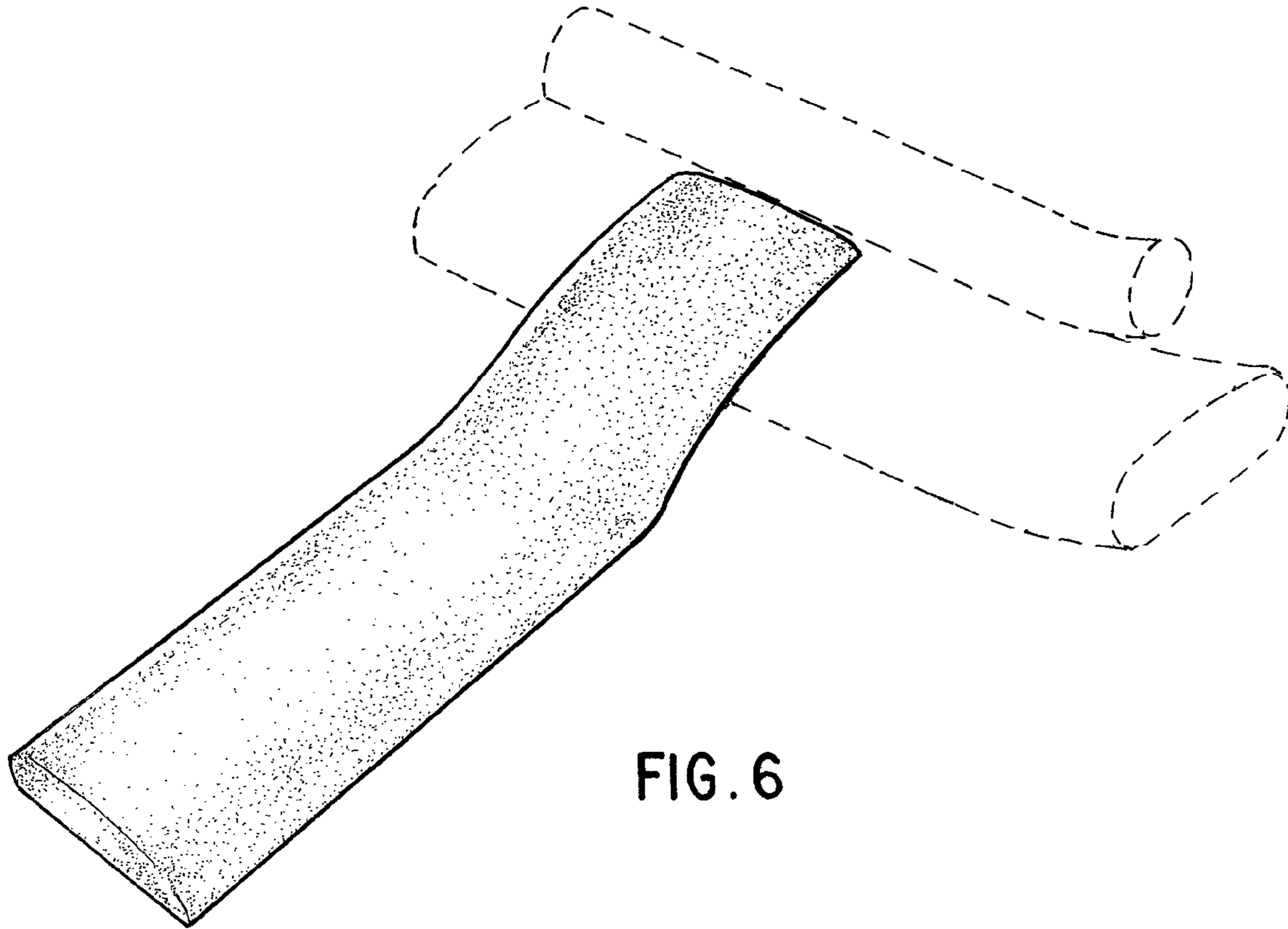
