DESCRIPTION

FIG. 7 is a top front perspective view of the shelf organizer in an opened position;

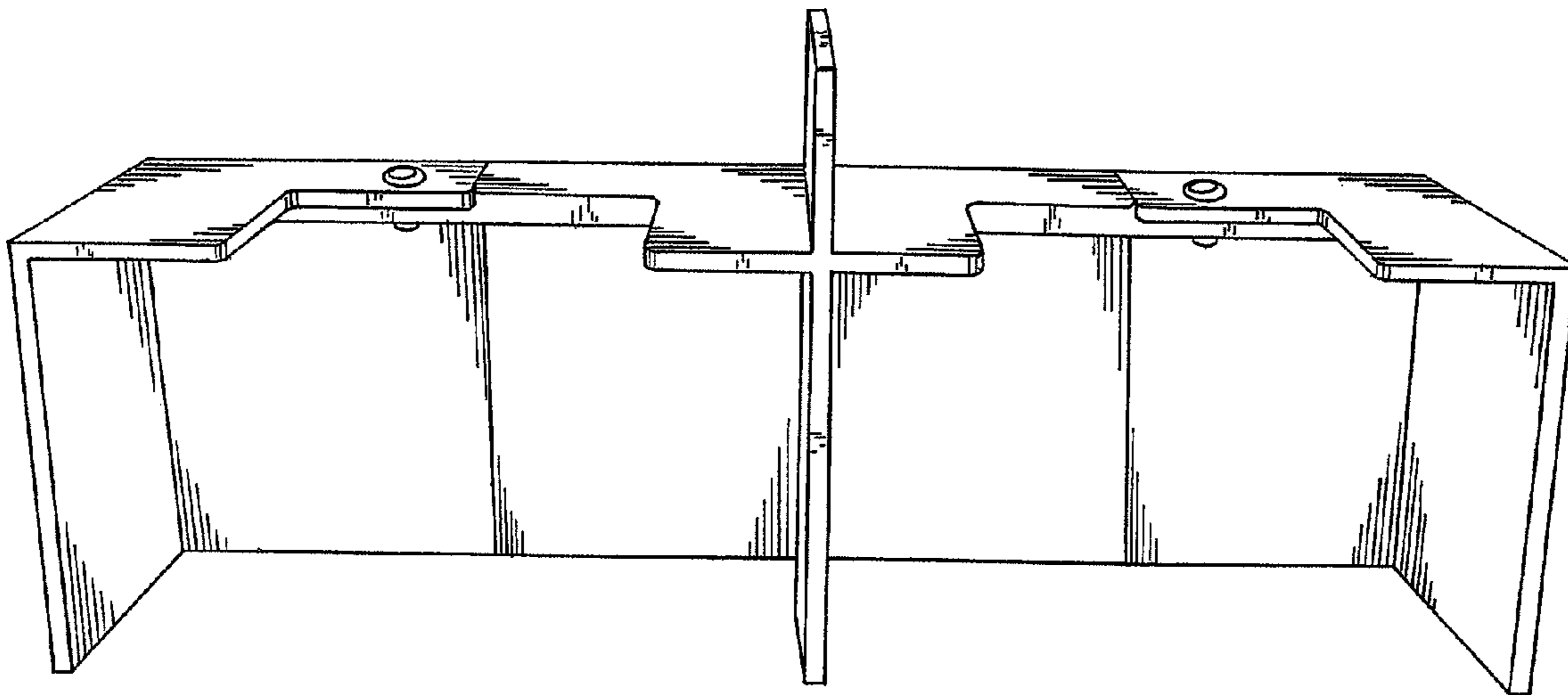
FIG. 8 is a top view of FIG. 7;

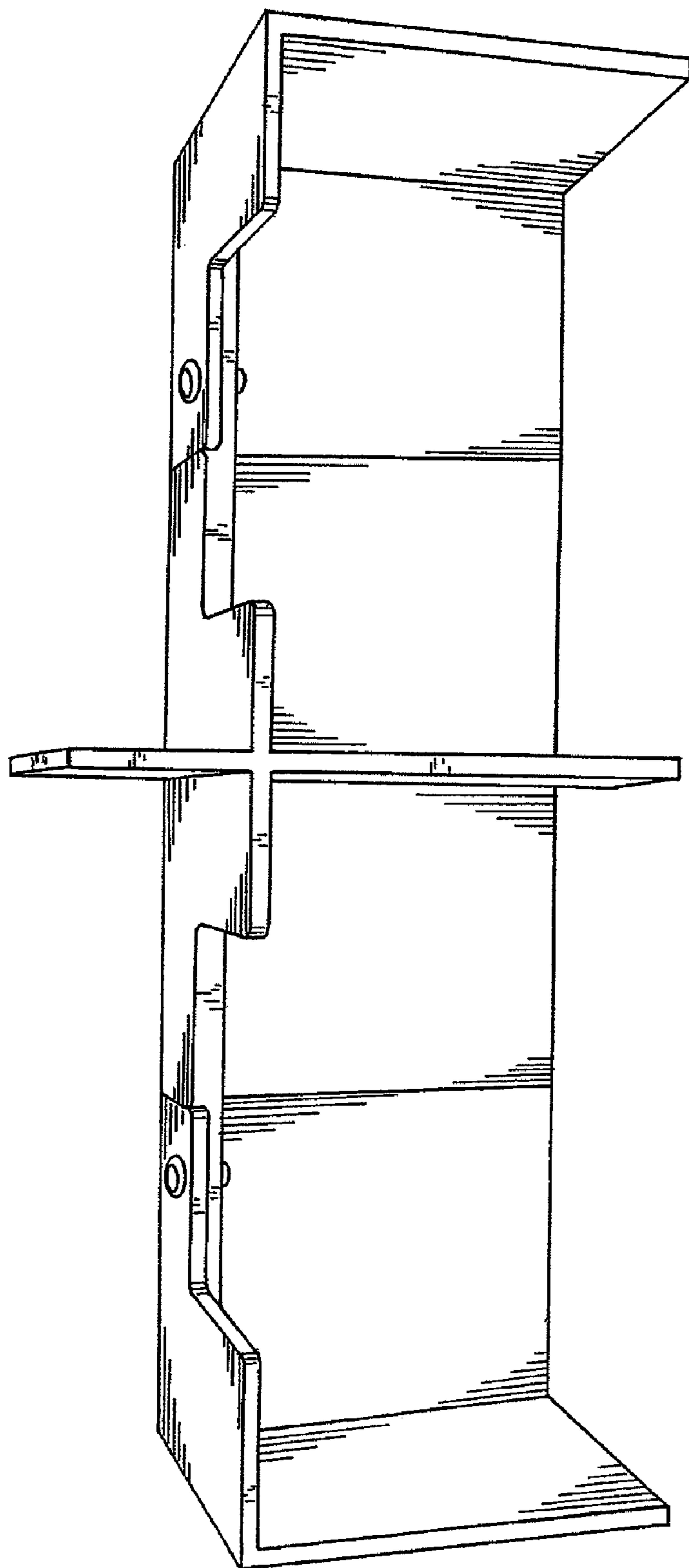

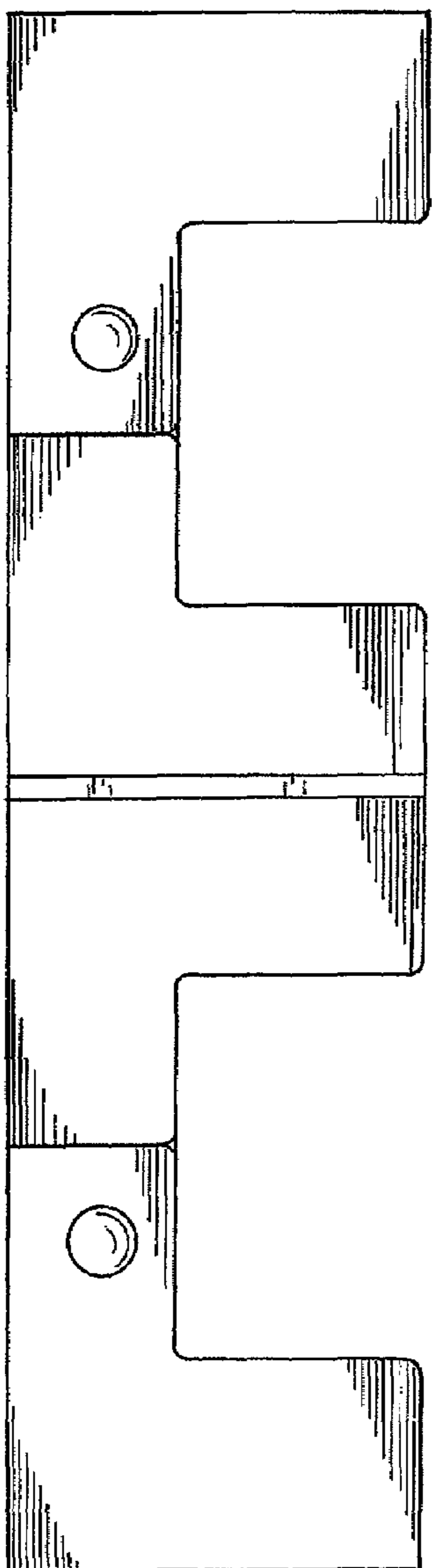

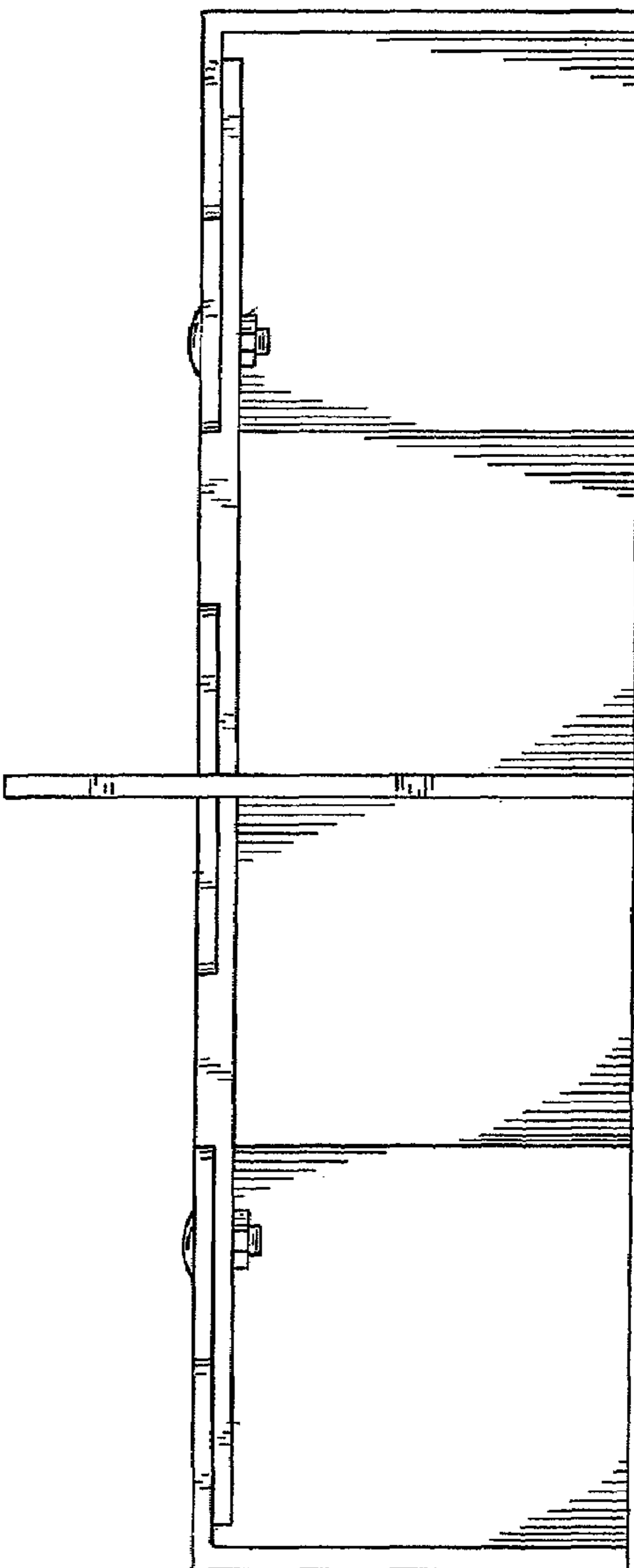

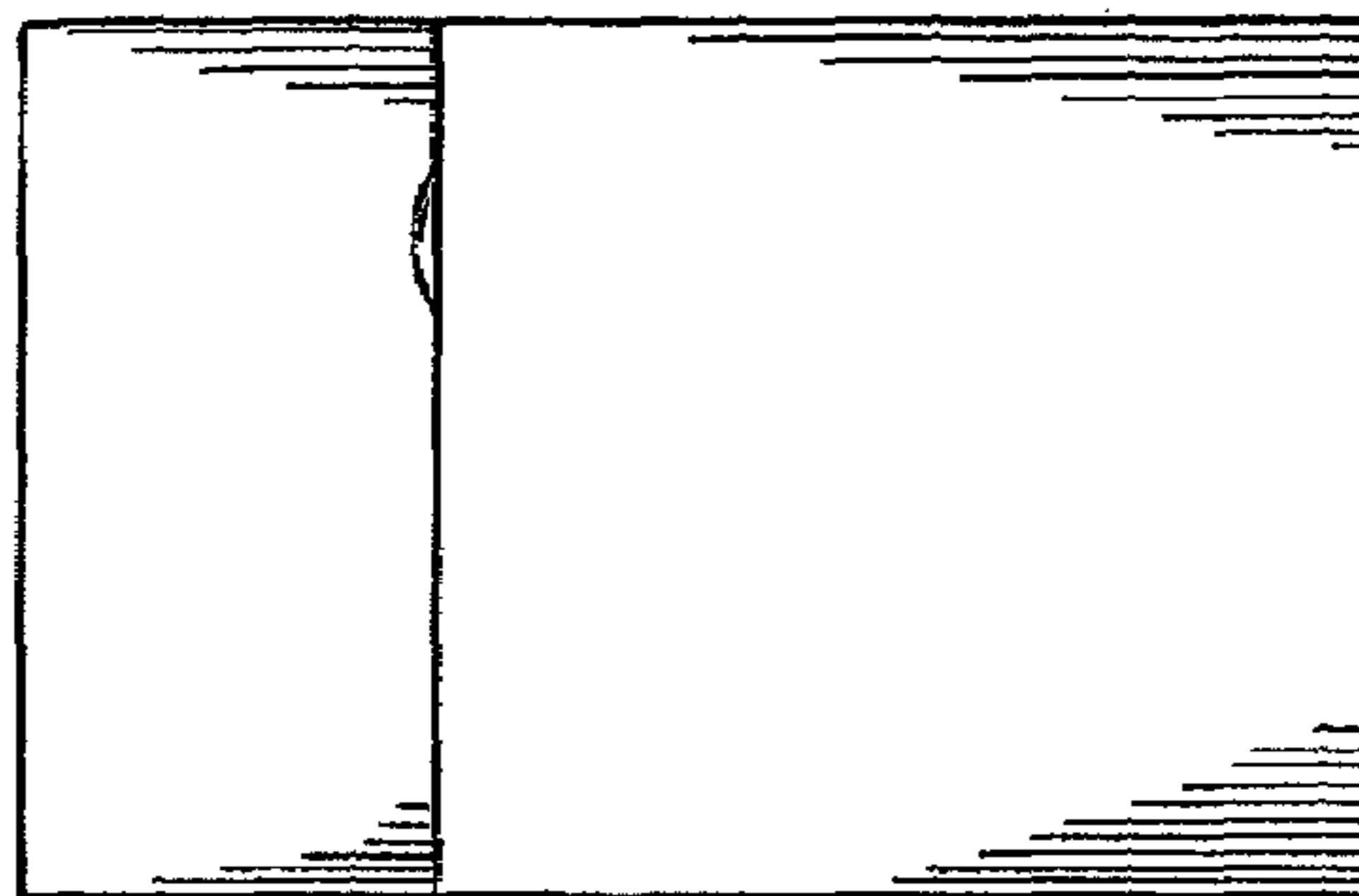

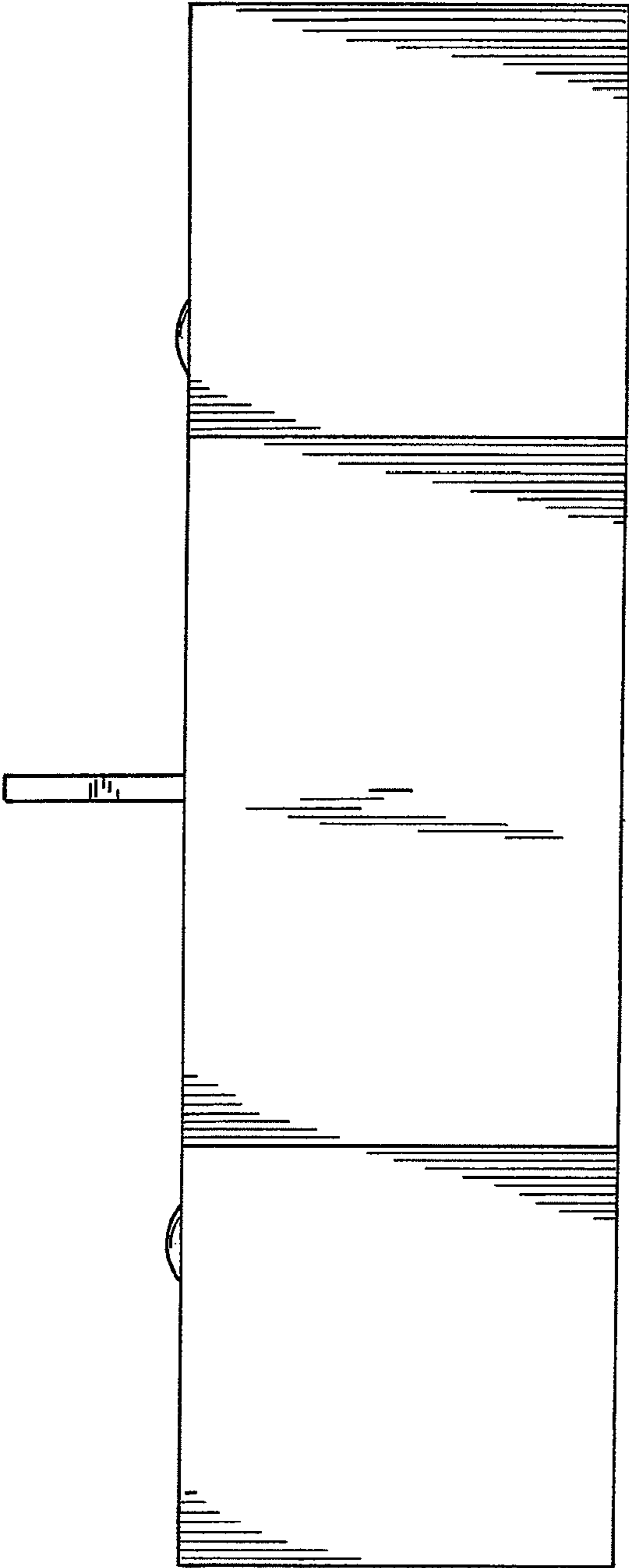

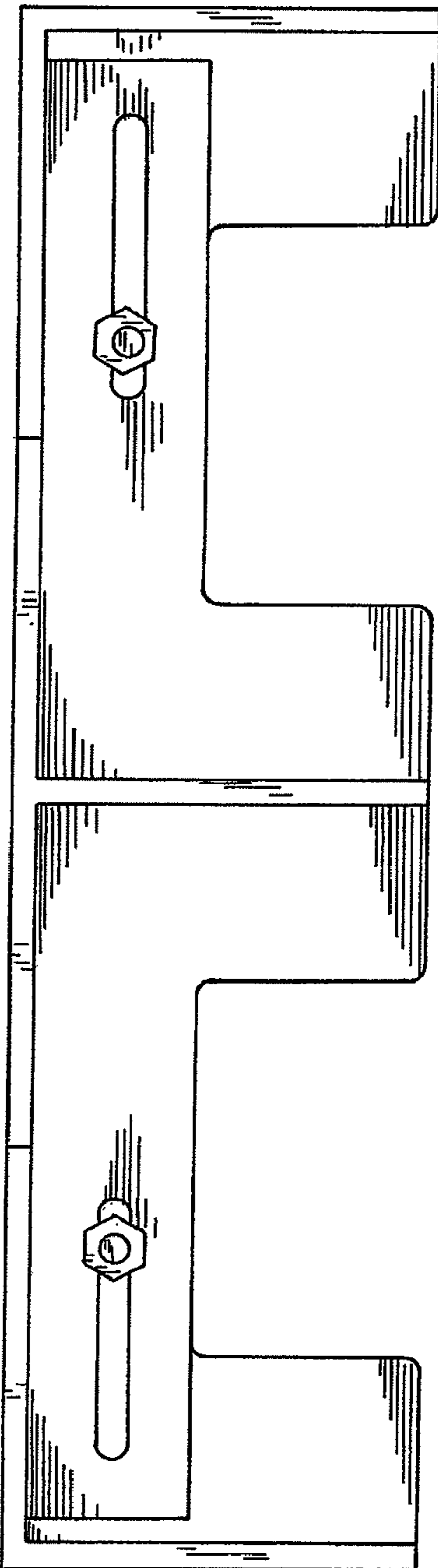

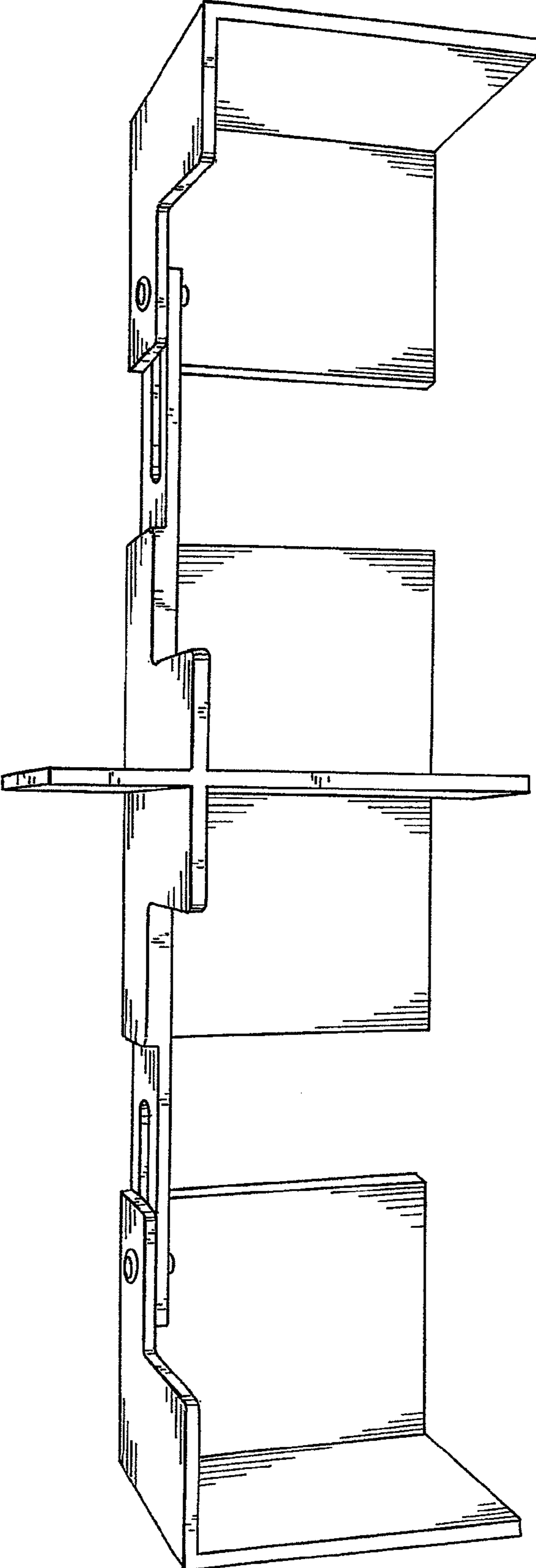

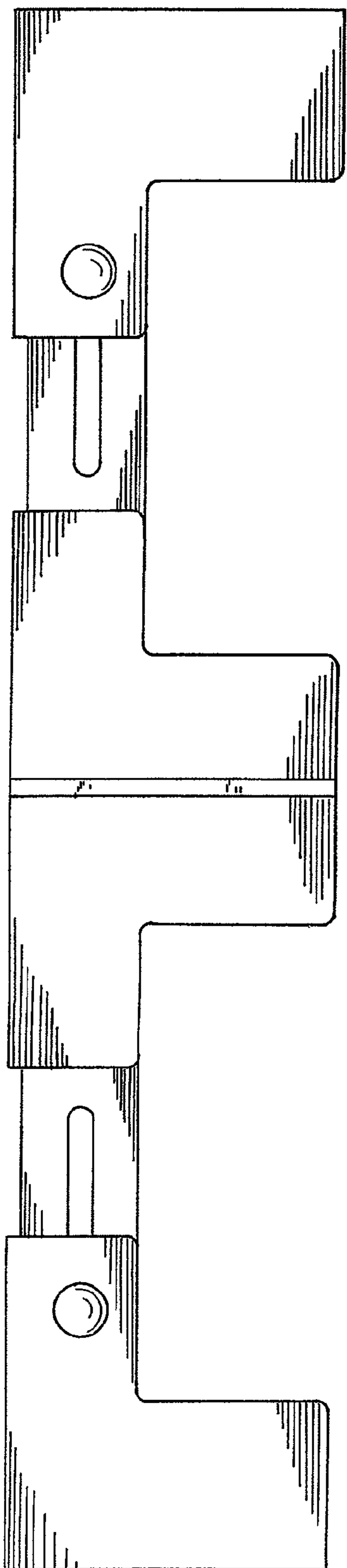

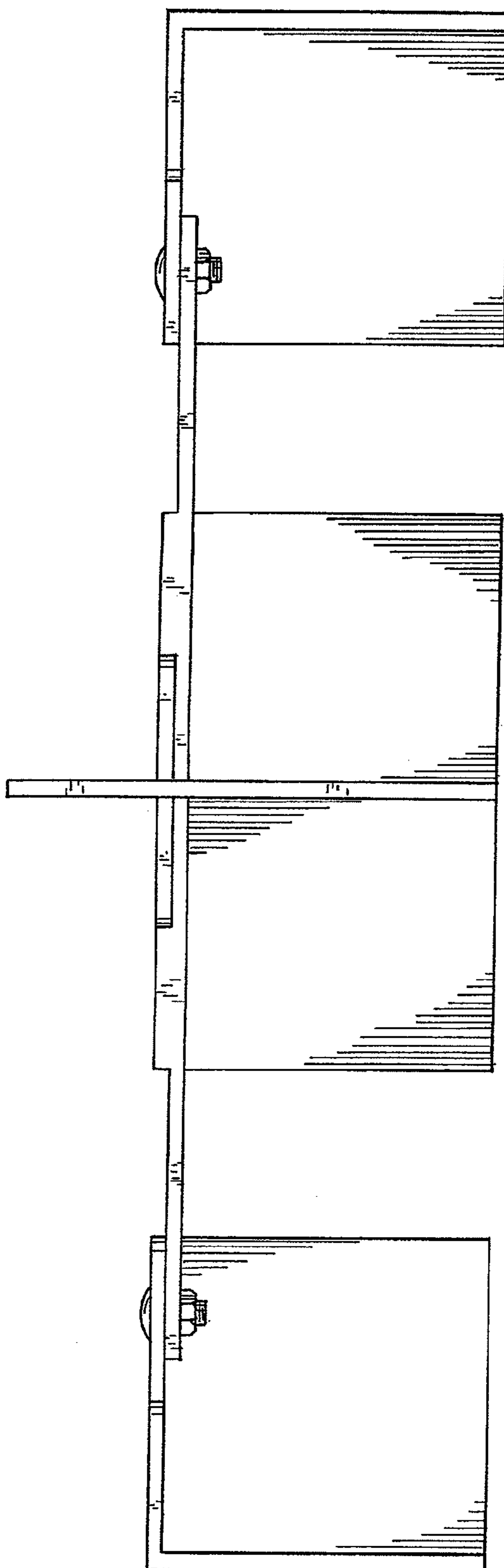

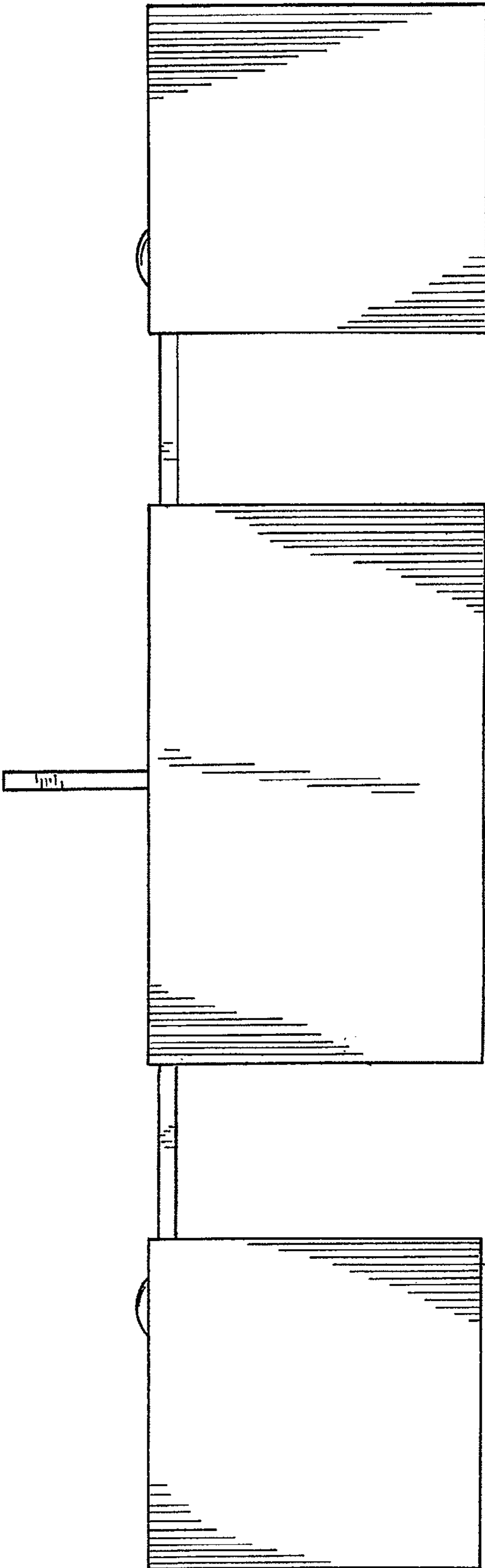

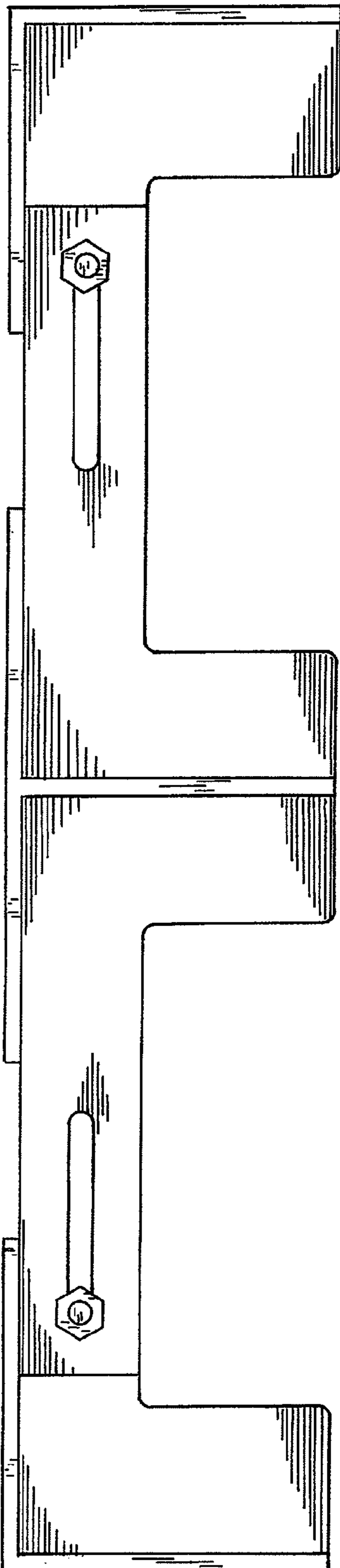
