The ornamental design for a handle for cooking utensil, as shown.

**DESCRIPTION**

FIG. 1 is a front elevational view of a handle for cooking utensil, showing my new design;

FIG. 4 is a side elevational view thereof from the right of FIG. 1;

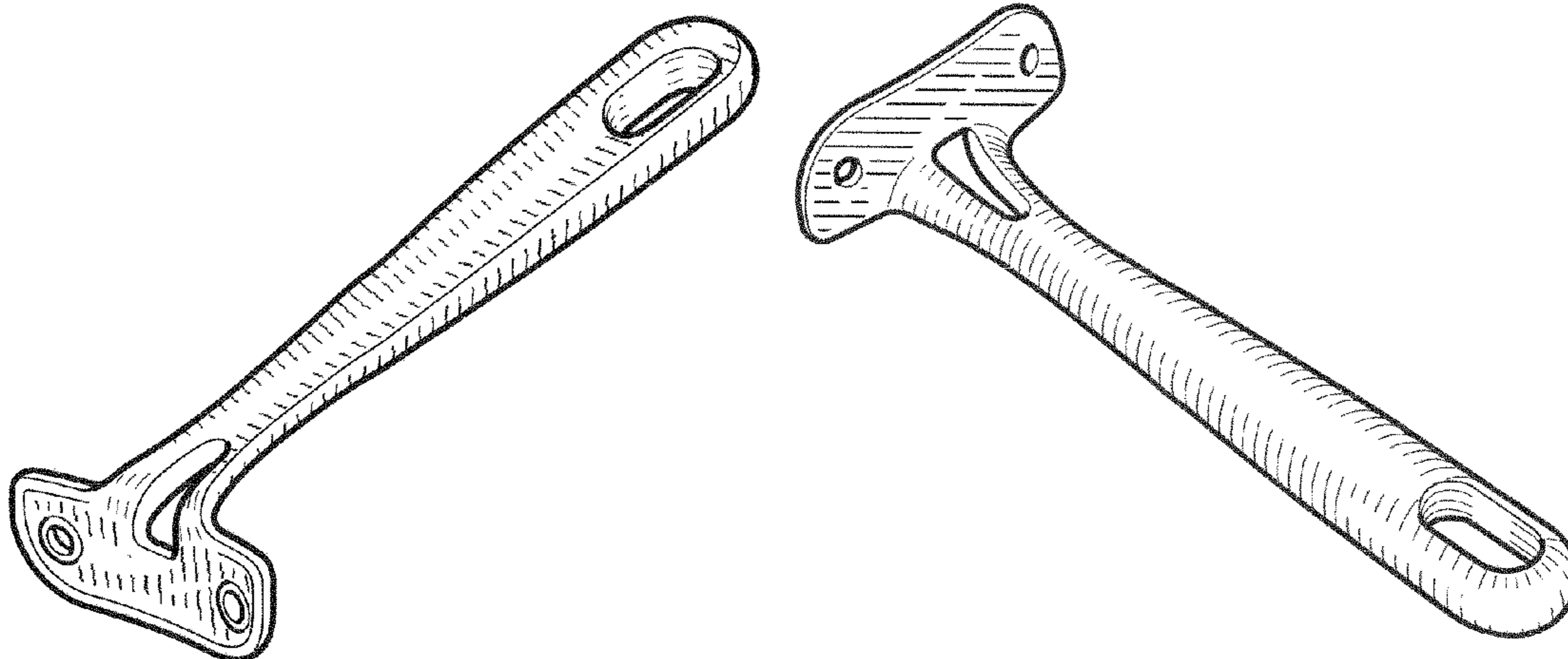
FIG. 5 is a side elevational view thereof from the left of FIG. 1;

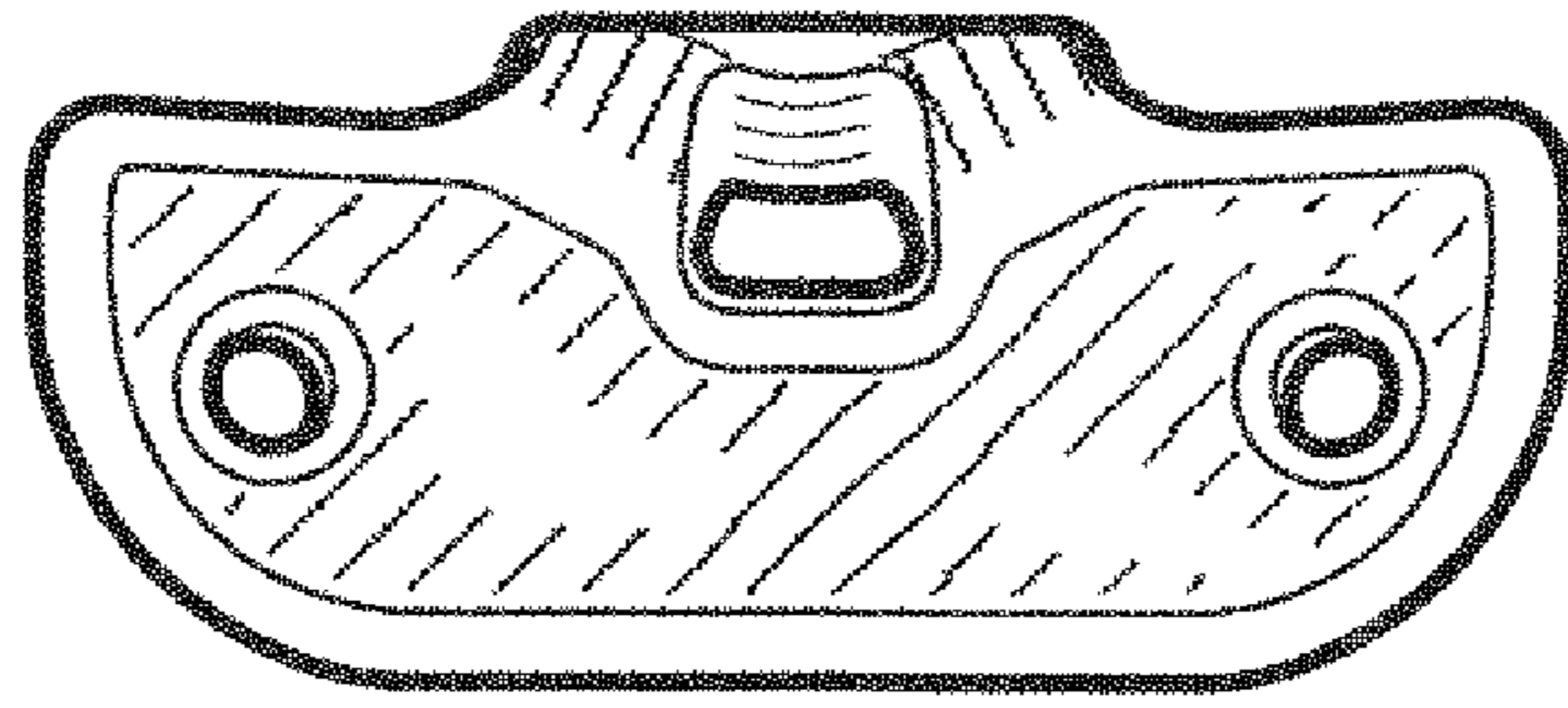

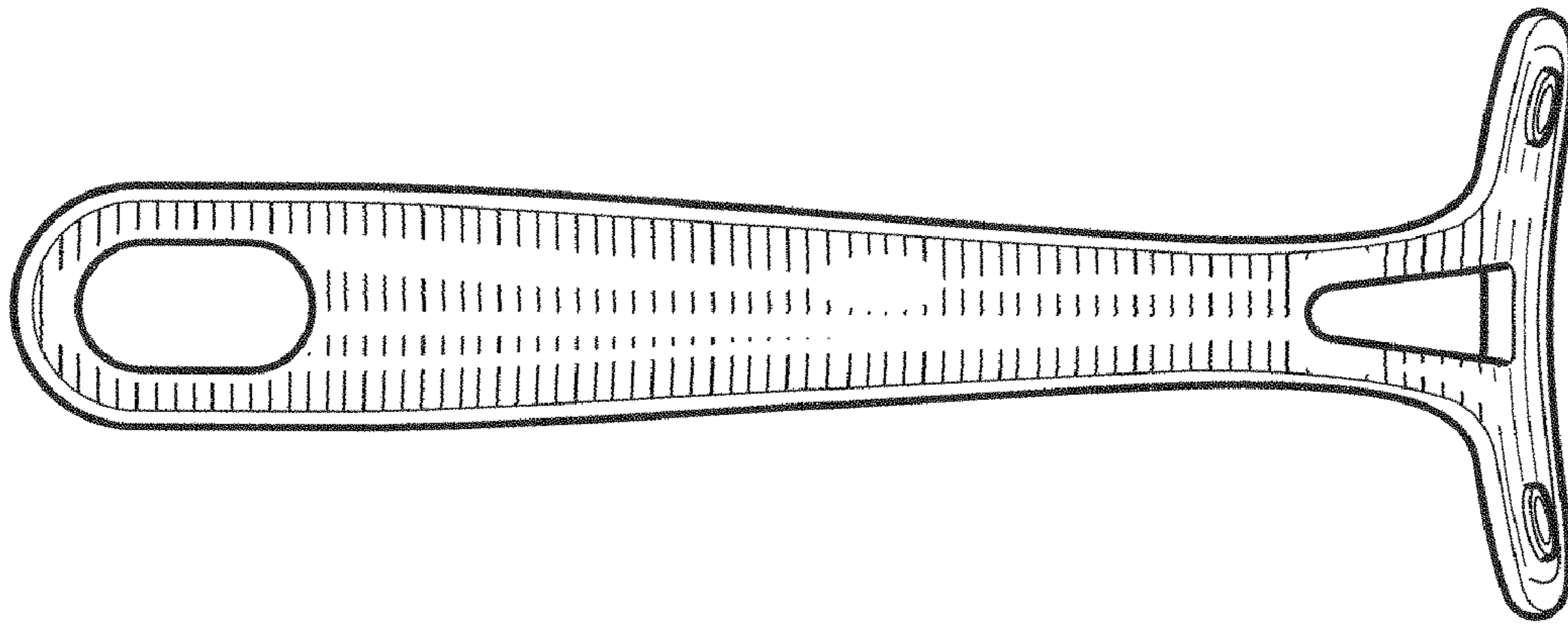

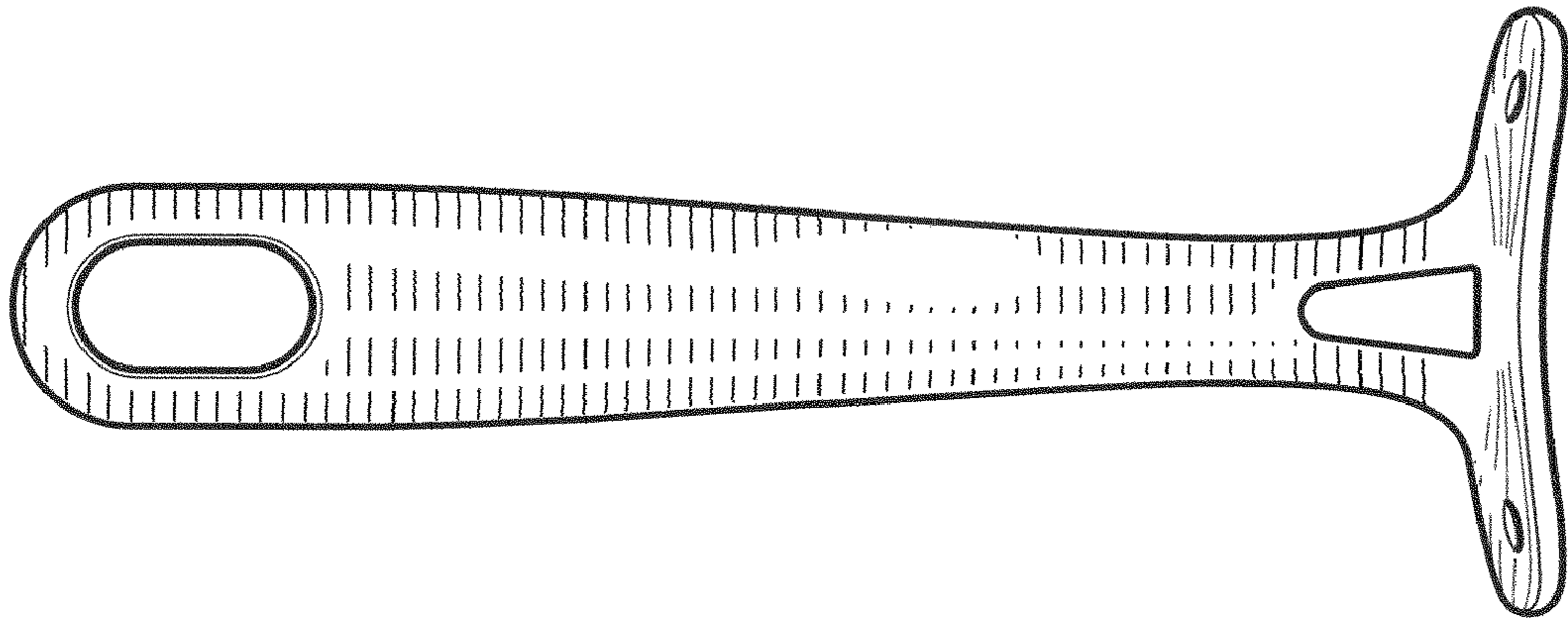

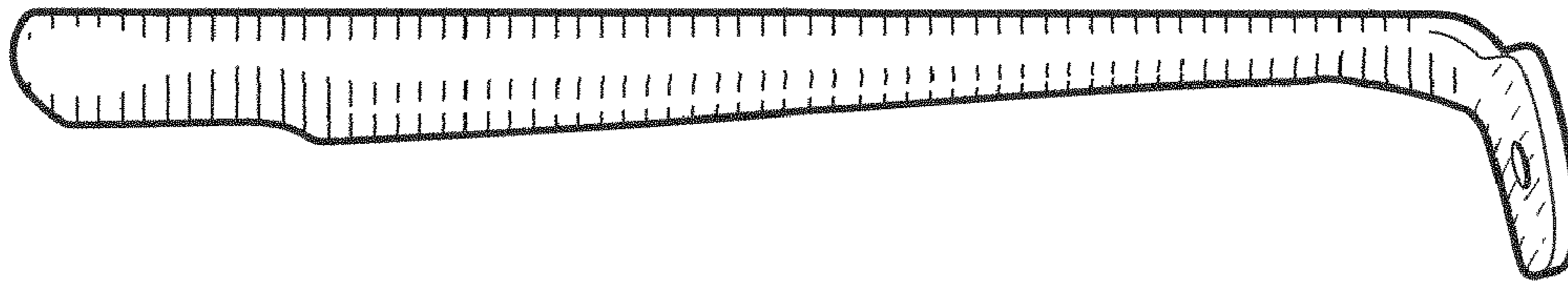

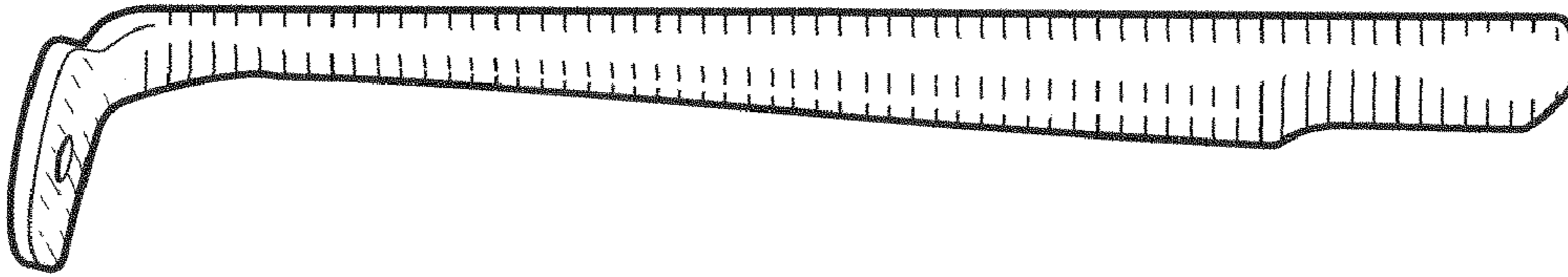
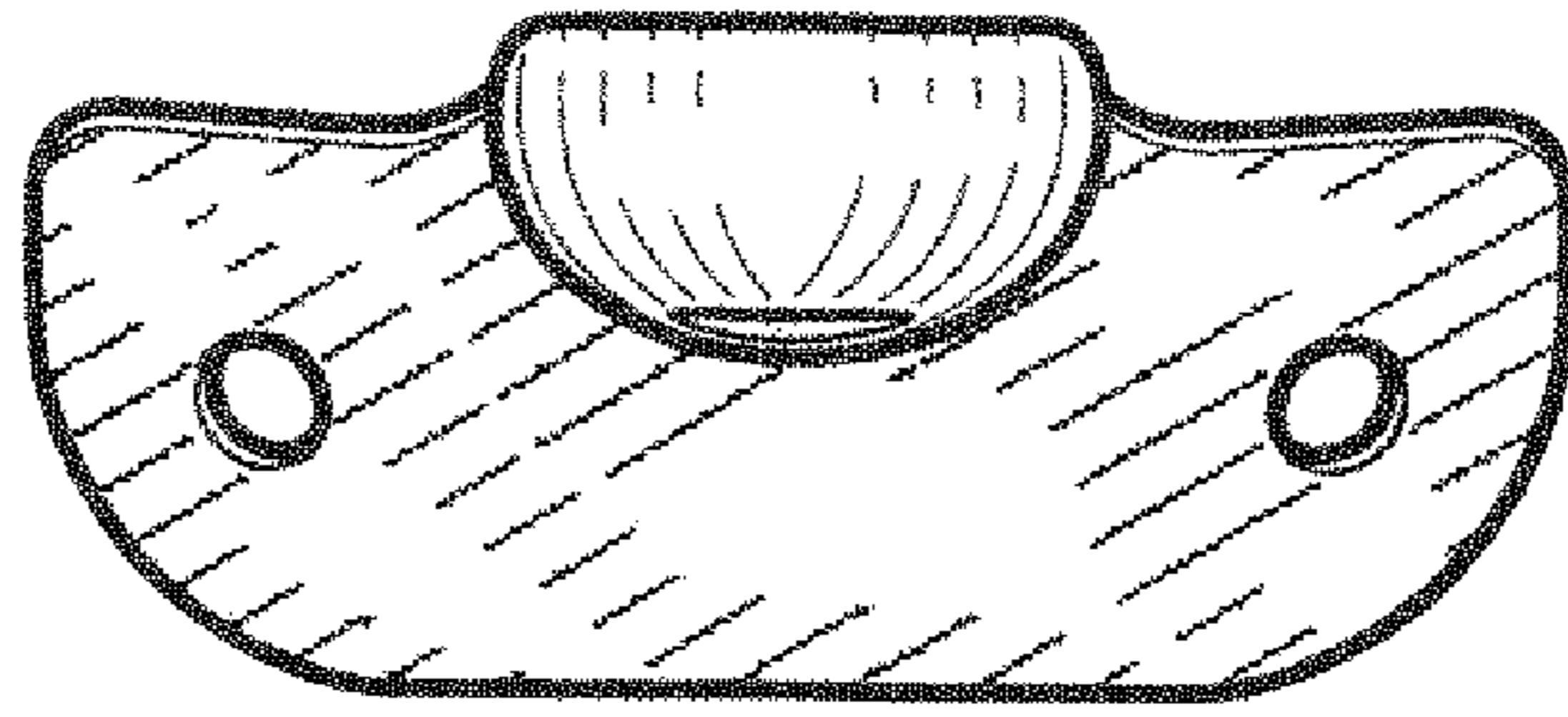

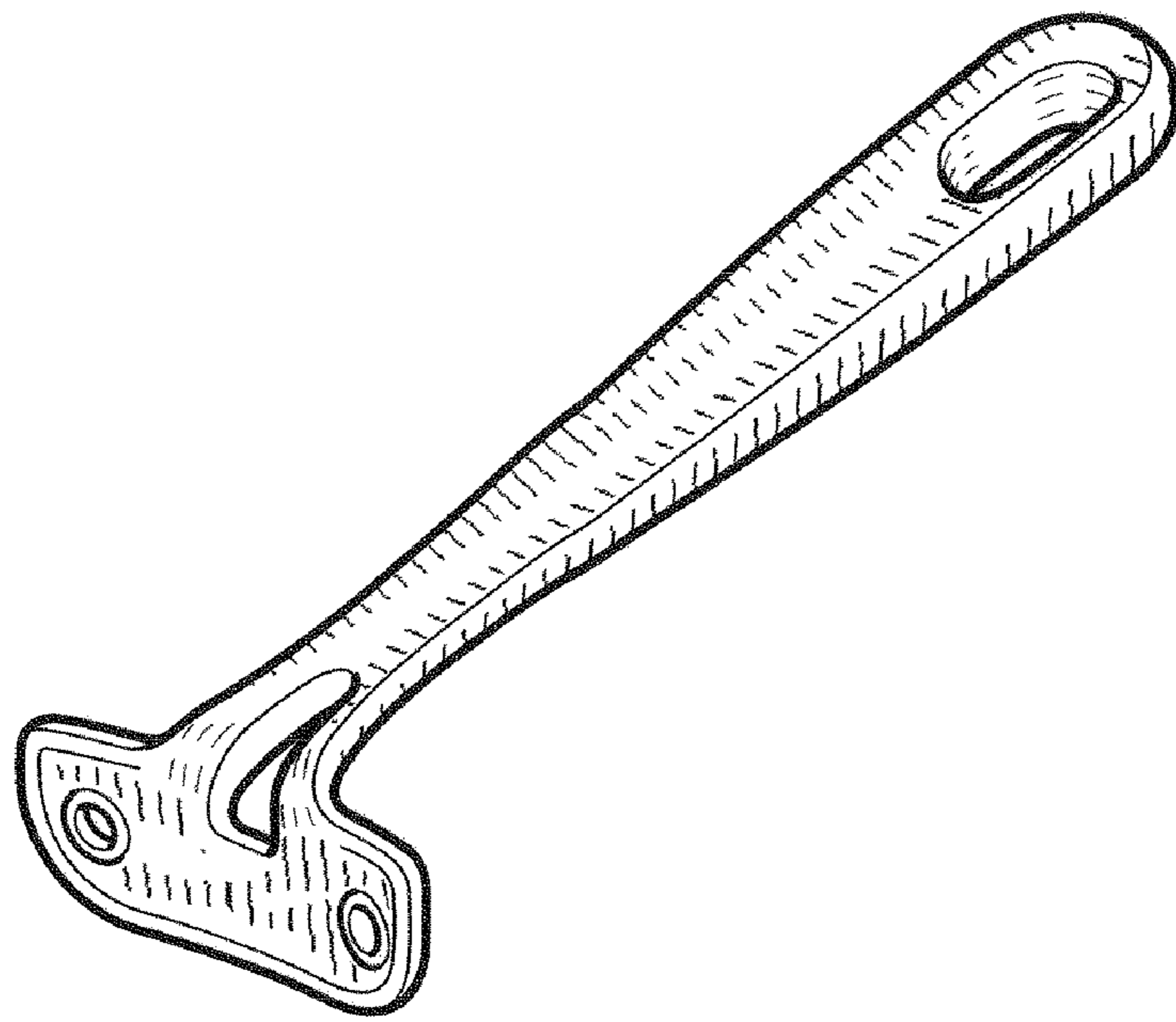

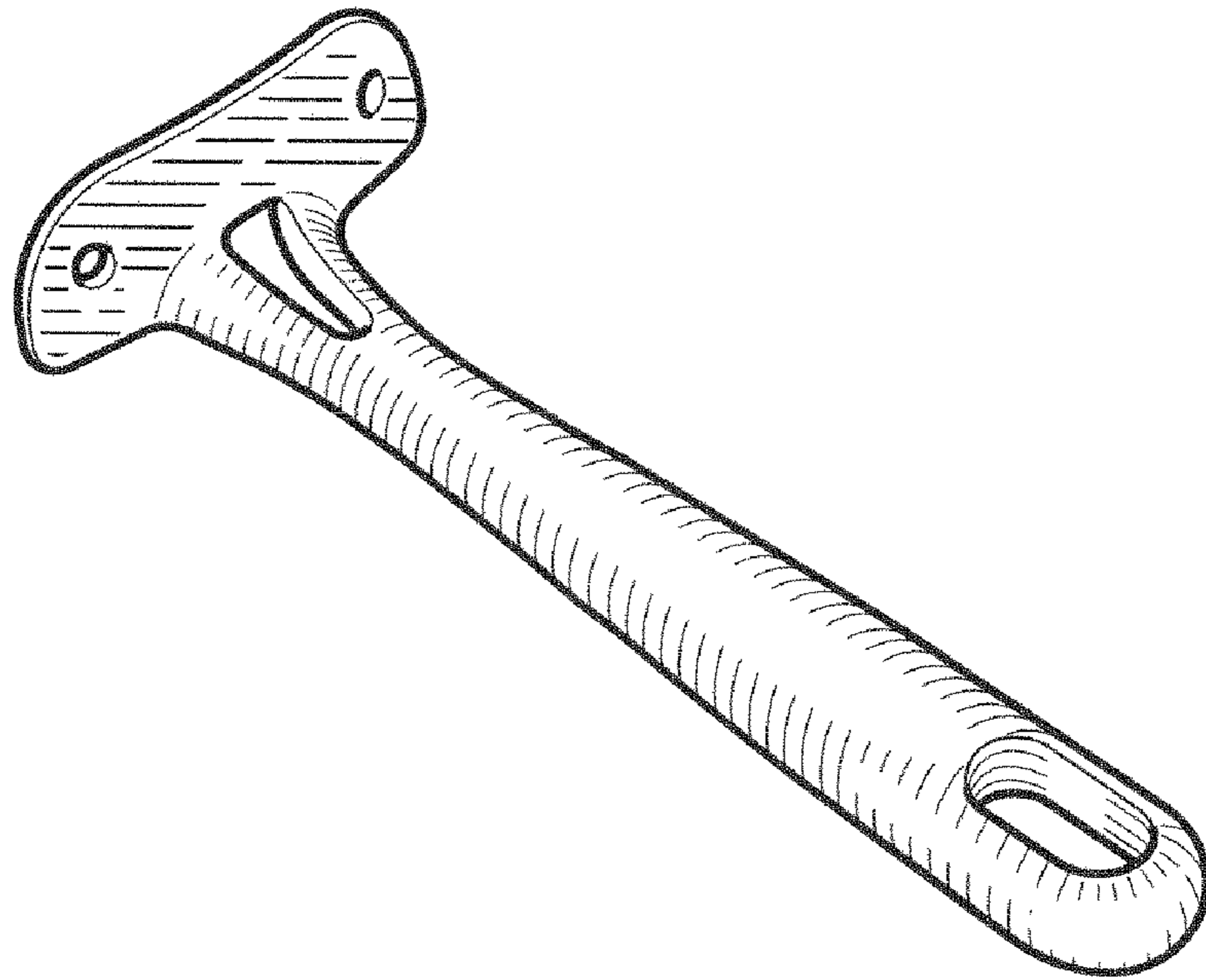
