(57) **CLAIM**

The ornamental design for a handle for a cooking utensil, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and side perspective view of a handle for a cooking utensil, showing my new design;

FIG. 2 is a the bottom and side perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a side elevational view thereof, the opposite side elevational view being identical thereto;

FIG. 5 is the bottom view plan thereof; and,

FIG. 6 is an enlarged end elevational view thereof; the opposite end view being identical.

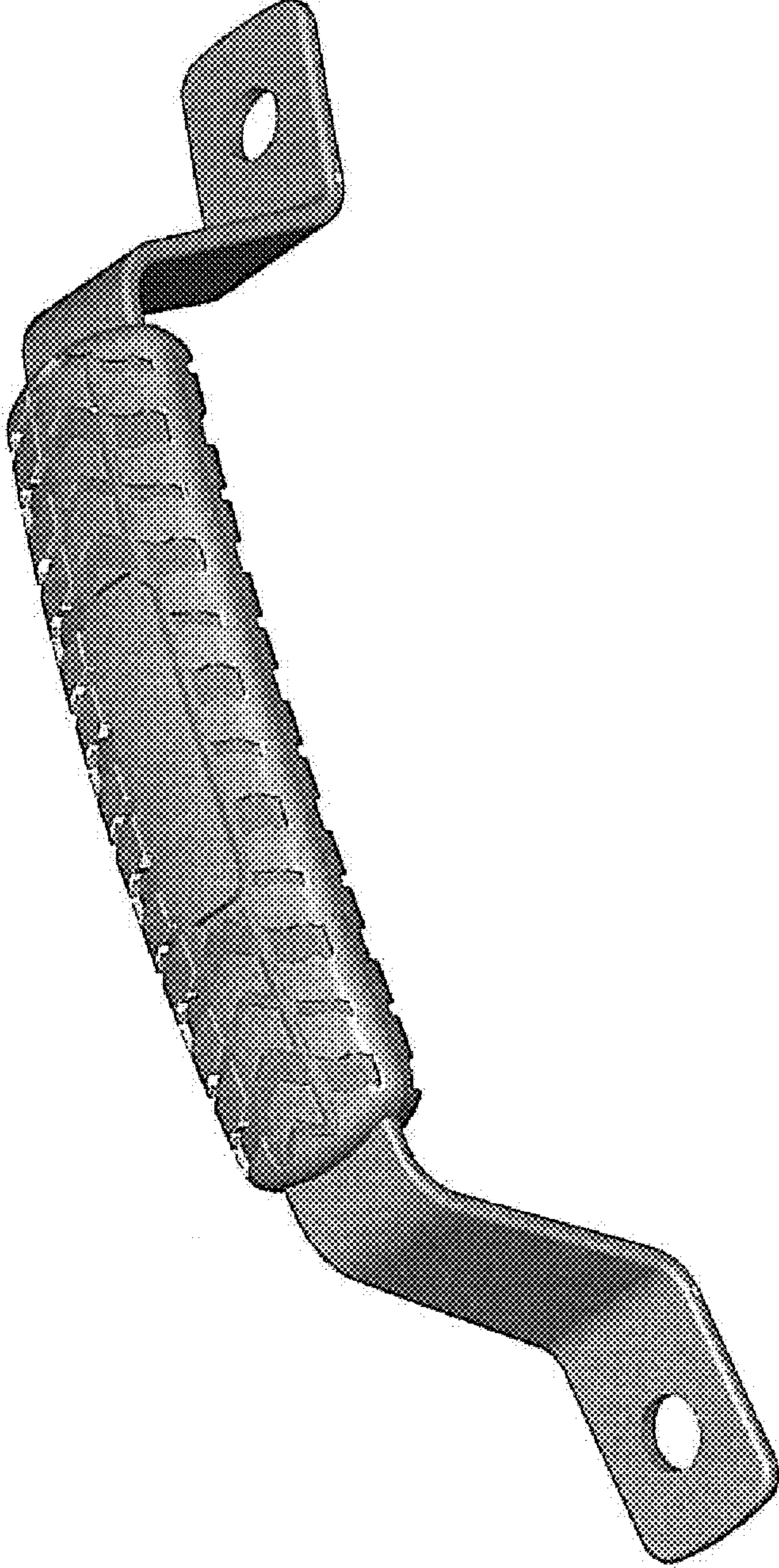

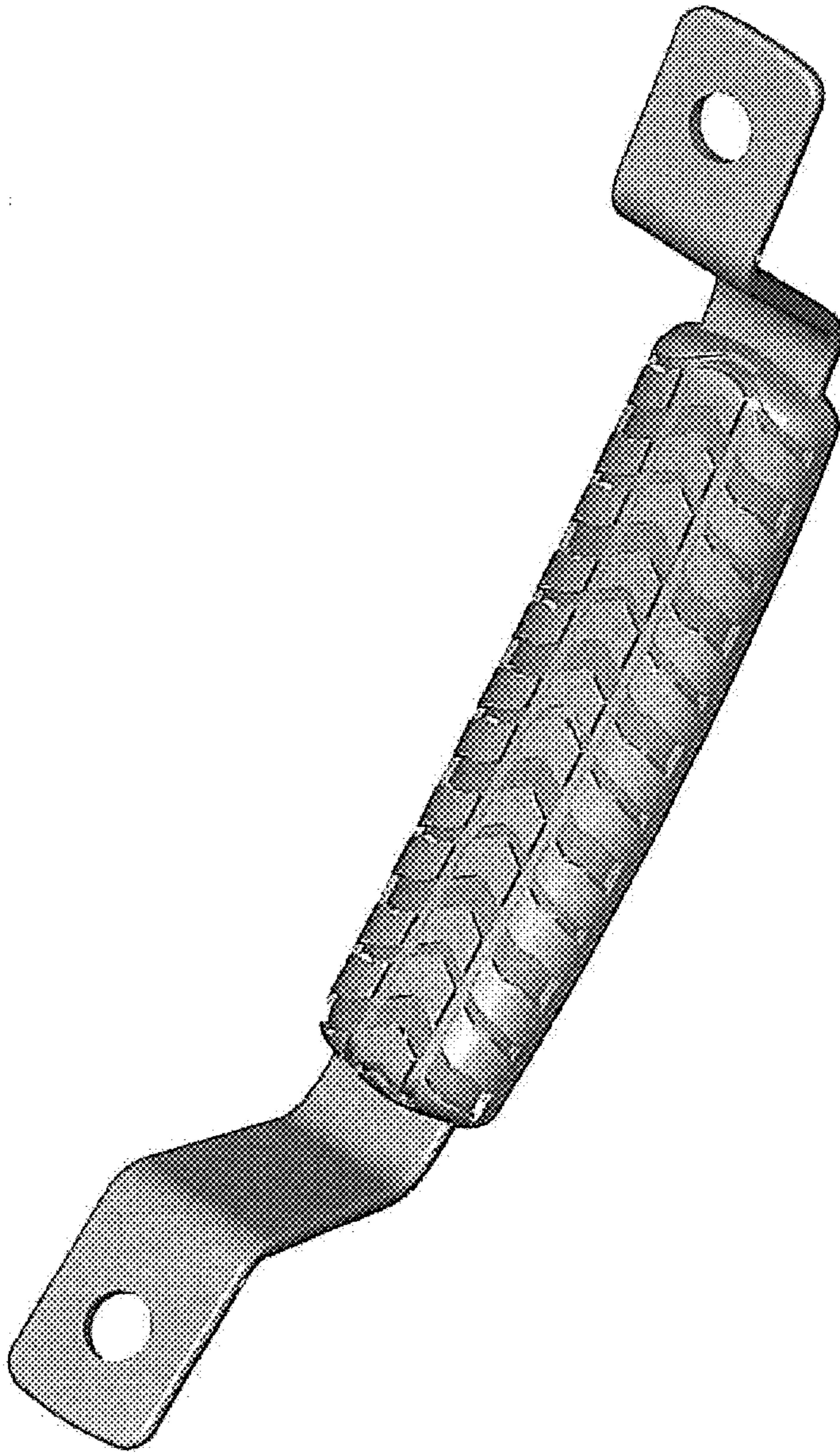

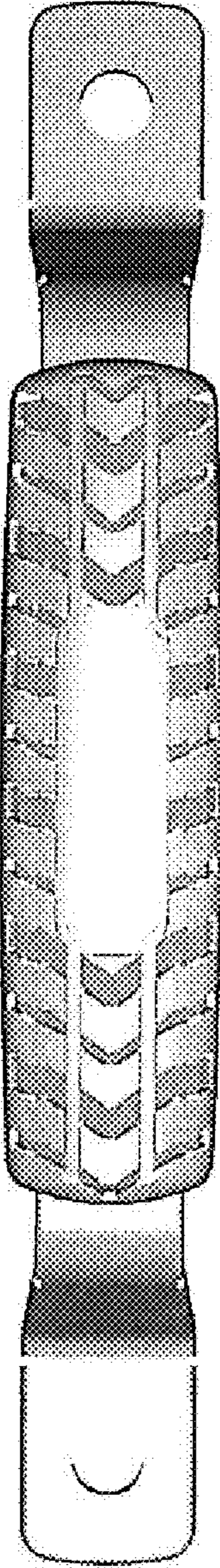

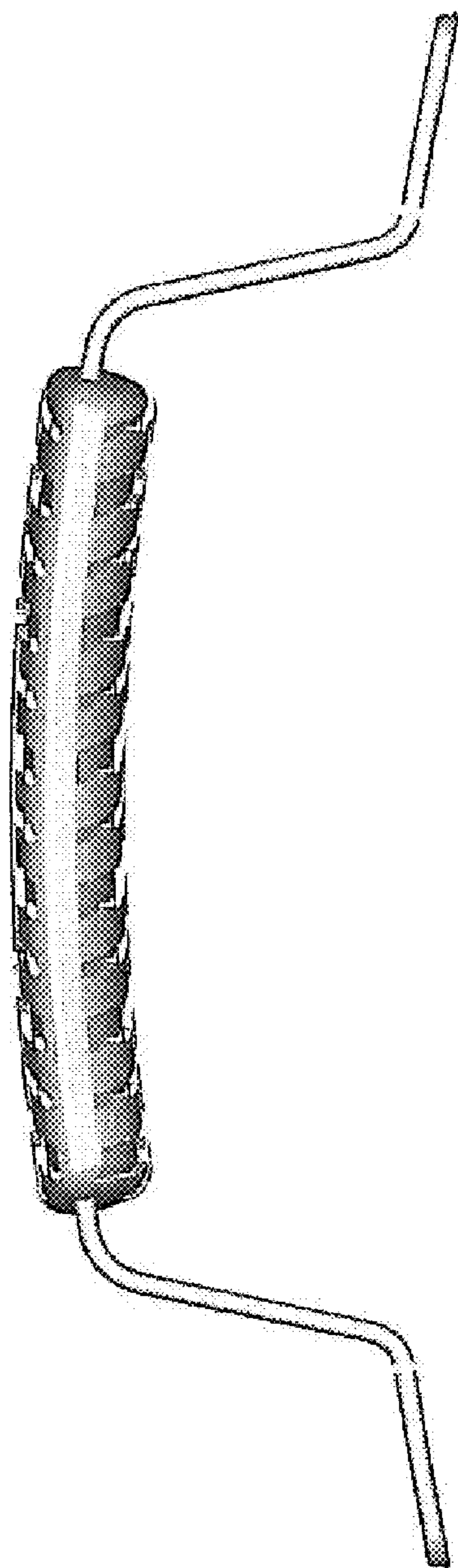

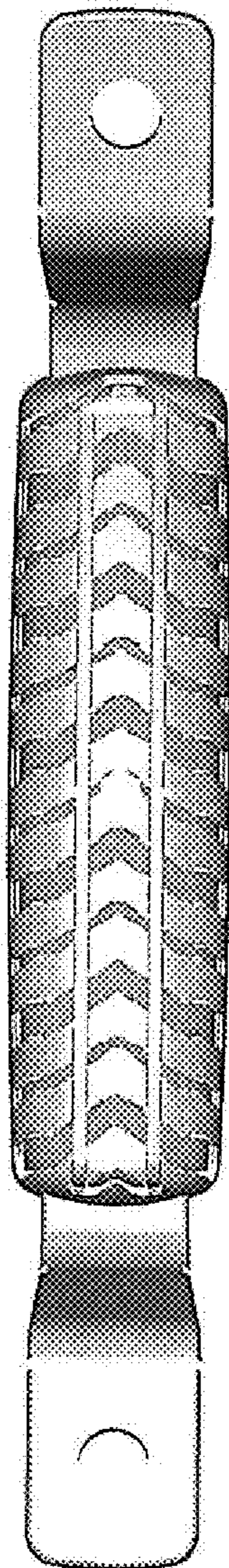
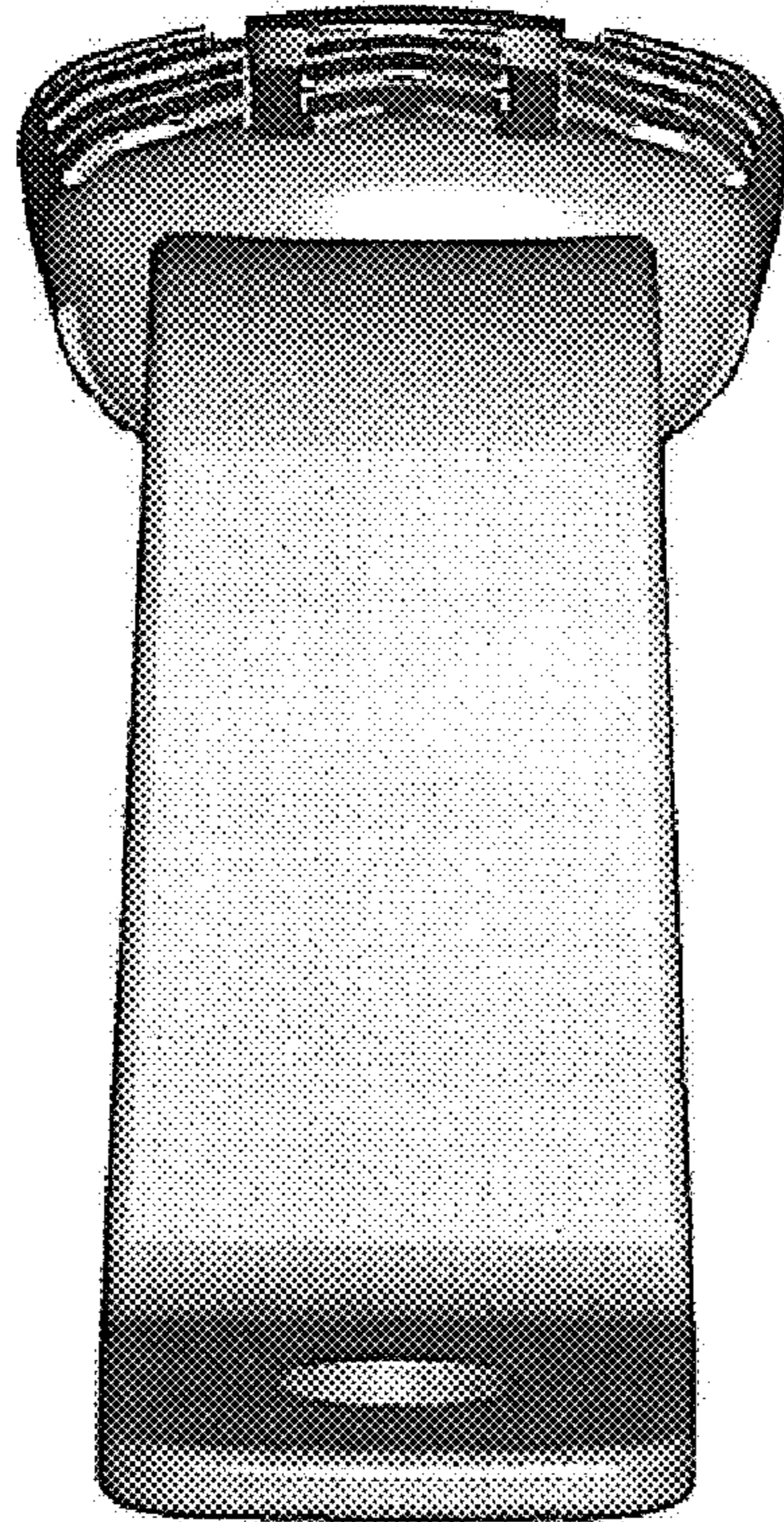
